US Supreme Court Accepts Case of Public Funds for Private Use-Buffalo Bills Stadium

Case Filed by Westchester Resident Tony Futia and Three Other New Yorkers; \$850 Million of Public Funds to Build New Stadium in Jeopardy

The United States Supreme Court has accepted a case filed against the State of New York by Four NY Residents, objecting to the use of public, taxpayer funds to help pay for a new football stadium for the Buffalo Bills.

The lawsuit, filed by Westchester resident Tony Futia, attorney Bob Schulz and two other New Yorkers, argues, whether the State of New York (\$600 Million) and Erie County (\$250 Million) violated the NYS Constitution, in the use of public funds for the stadium.

Article VII-Section 8.1 and Article VIII, Section 1, of the New York State Constitution, which "prohibits the giving or lending of State and County money "in aid of any... private corporation ... or private undertaking", is the key argument in the case.



Yonkers City Council: Deal With Deficits Not Ceasefires

The Yonkers City Council is currently dealing with an \$86 million deficit in the proposed 2004-2005 City Budget. The deficit is caused by the evaporation of Pandemic funds and other one time budget gimmicks.

The budget gimmicks are nothing new. Every year a 'Mighty Mouse' from somewhere comes in to save the day and the poor Yonkers employees who get threatened with layoff notices keep their jobs. This, after they and their families are humiliated by the whole situation. It's truly pathetic.

Tech Leaders Share Intel on Leveraging AI at Fordham REI, BCW Forum

Artificial intelligence, or AI, is impacting virtually every industry, offering opportunities to transform business as usual. Understanding the technology and how best to leverage its potential in real estate was the topic of an in-depth forum last week hosted by Fordham University's School of Professional and Continuing Studies and The Business Council of Westchester.

"Revolutionizing Real Estate: The Smart Solutions of AI" was presented virtually April 4 and featured Nikki Greenberg, founder and Chief Innovation Officer, Real Estate of the Future; Ravi Bhatia, Business Development Manager, Skanska USA Civil, and adjunct professor, Fordham Real Estate Institute (REI); Sanjay Gandhi, Senior Managing Director, Property Management, Besen Partners; and Serge Reda, co-founder, AlphaRithm AI, and adjunct professor at Fordham REI and Chair of its Technology Committee. The discussion was moderated by Dr. Joshua Harris, executive director of Fordham REI and managing partner of Magnolia Hill Partners.

Greenberg set the stage by presenting an overview of AI's rapid evolution—including generative AI and the rise of ChatGPT—and how business professionals can leverage technological advancements. "We're at a turning point in terms of where technology is and the impact it is going to have. Is AI revolutionary? I believe it is. But, while the technology is getting better, human beings should not be flatlining – we all have to evolve along with this," she cautioned

"AI is math, not magic," Greenberg said. "There's an algorithm behind the scenes, a set of instructions. It relies on information it's given to make an analysis. If you give it wrong information, it's going to give you a wrong outcome. We need to be thinking about the quality of data we give to AI to enable it to give us a quality outcome."

Harris asked the panel what will be AI's single, most consequential impact on the real estate world.

"I see great opportunities to improve efficiencies and reduce risk," said Bhatia. "We've all gone through the supply-chain shocks of a post-Covid world. As information becomes more readily available, there's going to be more transparency in pricing, in terms and conditions, and in streamlining contracts. That's huge. If we can reduce transaction costs, improve safety and improve efficiencies in the supply chain, it is going to be game-changing."

Gandhi agreed. "The advantages we see are in automating the mundane, repetitive tasks we do in our industry. A lot of the research tools can be automated, and, if we can reduce transaction costs – that's great. These are exciting times. But, real estate has been traditionally a hand-shake industry and that is going to be one of the challenges."

Reda pointed to real estate investing and development as an area where AI could have a significant impact, in terms of identifying opportunities and reducing risks. "Investing in real estate is an enormous investment so it requires a lot of information and analysis. AI could be extremely impactful in the incorporation of data that humans are just not capable of analyzing on their own. Those who can leverage that kind of capability will have an advantage in the market."

The panel also addressed one of the most common concerns related to AI: potential job loss. "Jobs are going to evolve," said Greenberg. "We're going to learn to use new tools. Some will lean in, others won't. What we're going to see with AI is a combination. AI is great at crunching numbers, analysis very quickly. Humans are great at relationships, trust, and ambiguity. Combine them, and you're super-charged."

"AI can do the back-office work you need to better communicate with your clients, partners and tenants, but it's not going to replace the human interaction," Gandhi said. "You still need to be on top of the game.

LETTER TO THE EDITOR – WESTCHESTER RISING

Yes, New York's recent Presidential primaries were a disaster, and there are many ways to fix them in time for 2028

April 9, 2024

To the Editor:

I read with great interest Dan Murphy's Op-Ed column in the April 5, 2024 edition of Westchester Rising. Indeed, the recently concluded Presidential primaries left a lot to be desired, even after taking into account that the presumptive nominees of both parties had effectively secured their respective nominations several months before this summer's conventions.

Here's what I suggest can be done to make the 2028 Presidential primaries more competitive and cost effective:

- Move the date of the New York Presidential primary earlier in the calendar to say February or early March. For example, the 2008 Presidential primary was held on February 5, 2008 as part of the "Super Tuesday" primaries. This would make New Yorkers' votes more pivotal in the nominating contests;
- Combine the Presidential primary with state Federal and legislative primary contests; this was done for many years during the 1960s and 1970s. While it might dilute the effect of the New York primary on the nominating conventions (then again, with a competitive contest, it wouldn't), the taxpayers would be saved substantial amounts of money by holding only one primary, and not two, as will be the case later this year;
- Some states this year, for example, North Dakota, Wyoming, Nevada, Iowa and Missouri, are holding caucuses to select their candidates. In previous years, Maine, Texas and Arizona also used a caucus system, (as a matter of fact most states used a caucus/convention method prior to 1972). A caucus would be ideal if a party is nominating an incumbent President; and likely reduce the cost of holding statewide primaries.


To make this work, the reapportionment of Congressional and state legislative district lines (mandated every 10 years due to the census) would have to be accomplished without litigation and on a truly fair basis.

But it is worth trying and needs to begin now.

New York Courts have rejected this argument, with a lower court dismissing the case and NY Appeals Courts denying the motion to

The USSC asked for a rebuttal to Schulz and Futia's filing to the State of New York. Barbara Underwood, the Solicitor General for NY, filed a document waiving New York's right to submit a response.

While this is good news for Futia and Schulz, it is still not clear whether or not the Nine Justices on the US Supreme Court will hear oral arguments on this case, and when that would be if they agree to hear the case.

"In my 45 years of working on these types of cases, I have never felt so confident. The USSC only hears cases that are unique, where important Constitutional rights and arguments have not yet been made. I feel very confident that they are going to hear the case," said

The USSC has put the case on a docket with court #-231058. Now they must decide whether to hear arguments and when. If they decide to hear the case, they will ask for briefs from both sides and then an oral argument before the court. Nobody knows when that might happen. If time is of the essence, the Justices might hear the case before their summer recess. Or they could decide to hear it next year or decline to move forward.

The case may have some urgency because work has already begun to build the new stadium for the Bills in Orchard Park. "Any public funds that have gone into the new stadium may have to be replaced. This will require a shifting of resources, to the owners of the Bills. They may have to cut back," said Schulz.

One theory has the Justices interested in hearing a case that involves the overreaching by government. And the current makeup of

> the court has a conservative majority more inclined to believe in strict adherence to the Constitution and opposed to the unlawful overspending or misuse of taxpayer funds.

> What is also noteworthy is that many New Yorkers of different political views oppose this use of public funds for private use. Schulz and Futia are conservatives, but progressives also do not want their tax dollars going to subsidize the billionaire owner of the Bills, Terry Pegula.

New York Unions have also objected to the giveaway to the Bills, instead preferring the money be used for state employees.

Bills fans are also outraged after hearing that they will have to pay between \$15,000 to \$50,000 for a personal seat license fee. This gives you the right to purchase your Bills home game tickets, and nothing else.

So, if you are a longtime Bills fan, with season tickets in your family for generations, and you have 4 good ticket locations, at \$50,000 per PSL, that's \$200,000. We wonder how many Bills fans will be able to afford this.

And why are they charging PSL's after the State allocated \$600 Million and Erie County \$250 Million?

The State funding for the new stadium was included in last year's state budget.

Futia, who we have featured in our newspapers and online during his ongoing battle with the IRS, said most New Yorkers do not understand that the public financing for stadiums used for private use is illegal in our state.

New Rochelle Man Gets 21 Years for Sex Offenses With Children

Defendant preyed upon victims, with whom he engaged in repeated sexual acts that he filmed over a four-year period; he threatened to publish the videos on social media DA's Office investigation began after state police identified suspect from national reporting center's alert of child sex abuse material uploaded online in Westchester

On April 4, Westchester County District Attorney Miriam E. Rocah announced that a New Rochelle man was sentenced to 21 years in state prison for sexual acts involving three children in Westchester County, as well as for the possession and creation of images and videos of children engaged in sexual acts, between 2019 and 2023.

DA Rocah said: "After years of preying upon children and inflicting unspeakable trauma on his victims, this defendant has been brought to justice and removed from our community. I thank the brave survivors for their courage in working with our Office, and the multiple agencies who partnered with us on this case to secure this conviction. We will continue to support the victims throughout their healing and offer further assistance in any way possible."

The defendant, Jason Ricketts, 23, pleaded guilty on Jan. 29 to two counts of Course of Sexual Conduct Against a Child in the First Degree, Criminal Sexual Act in the Second Degree, and Promoting an Obscene Sexual Performance by a Child, all felonies.

The defendant appeared before New York State Supreme Court Judge James McCarty and was also sentenced to 20 years of post-release supervision. He is also required to register as a sex offender.

The defendant first met his victims in person at locations where children gather and befriended them by deceiving the children and their parents into believing that he was younger than he was. The defendant methodically gained the trust of his victims, even using substances with them before engaging in sexual acts with his victims, which he filmed. When the victims tried to leave or stop engaging, the defendant indicated that he would post the videos and images to social media accounts.

The sexual abuse began in 2019, when the victims were 12 years old, and continued

The DA's Office Cyber Crimes Bureau and High Technology Crimes Unit launched an investigation in October 2022 after Dropbox Inc., a file hosting service, filed a Cyber-Tipline Report with the National Center for Missing & Exploited Children (NCMEC) about an uploaded video file containing minors engaged in sexual acts.

Upon receiving NCMEC's notification, the New York State Police developed a suspect in Westchester County and the DA's Office obtained a search warrant in January 2023 for the defendant's residence in New Rochelle.

With assistance from the New Rochelle Police Department, the DA's Office investigators seized multiple devices from the defendant's home. The defendant admitted to using Dropbox.

Subsequent forensic analysis of the defendant's phone revealed a photo vault disguised as a calculator app containing dozens of videos and photos of the defendant performing sexual acts on children, which led investigators to identify three child victims in Westchester County.

The Child Abuse Bureau and the Special Prosecutions Unit located the three minors and their families, who agreed to work with the DA's Office.

The DA's Office arrested the defendant on Feb. 2, 2023, and seized an additional device, which revealed internet searches regarding how to remotely wipe devices, whether a person's age can be determined through a video, and attorneys who specialize in defending individuals charged with sex offenses.

The defendant has remained in custody at the Westchester County Jail since his arrest. John Shehan, Senior Vice President of the National Center for Missing & Exploited Children (NCMEC) Exploited Children Division & International Engagement said: "In 2023, NCMEC received more than 36 million reports of suspected child sexual exploitation and made them available to law enforcement. The staggering volume of reports underscores the pressing need for ongoing collaboration in a shared mission to safeguard children and ensure a safer online environment. NCMEC applauds the relentless efforts of the Westchester County District Attorney's Office and collaborating law enforcement agencies for their hard work on this case and commends the bravery of the survivors who have courageously come forward."

Steven G. James, New York State Police Superintendent said: "Mr. Ricketts had no regard for the wellbeing of the victims in this case. The evidence gathered, and work done by the New York State Police and our law enforcement partners, ensures the defendant will serve time for his deplorable acts. We have zero tolerance for those who prey on innocent children. This sentencing reflects the severity of the crimes committed and our commitment to finding justice for our most vulnerable victims."

Robert Gazzola, New Rochelle Police Department Commissioner said: "The collaborative efforts between multiple agencies in Westchester County have culminated in the successful arrest and prosecution of Jason Ricketts, who has been sentenced to 21 years in prison. This outcome reflects the dedication and synergy of our law enforcement community in upholding justice and safeguarding our neighborhoods."

In a statement to the court, one victim stated: "I met you when I was 8 years old, and then you became a constant in my life when I was 11 years old.... You stole years of my life from me.... Not only did your actions affect me, but you affected others who once called you their friend; but you weren't really a true friend, you were a wolf in sheep's clothing...a predator. You deserve all the time in prison you're getting; you need to be far away from kids."

Addressing the defendant, a second victim added, "You are a disgusting human being. You took away years of my life that I can't get back. I wish every day that I never met you...I was 12 years old...I would walk around afraid all the time.... Every time I tried to make a new friend, you would blackmail me and try to scare me.... I am not afraid of you anymore. After today, I hope I never see you again."

Anyone who may have been victimized or may have information about other possible victims of the defendant can contact the DA's Office Special Prosecutions Division directly at (914) 995-3000. Language assistance is available.

The District Attorney thanked the National Center for Missing & Exploited Children's CyberTipline Reporting team, the New York State Police, the New Rochelle Police Department, and the Internet Crimes Against Children (ICAC) Task Force Program—a statewide coalition of law enforcement investigators, analysts, and prosecutors.

who may be removing them.

Jann Mirchandani, the democratic candidate for Yorktown Supervisor, had her sign removed from outside her house by a Town of Yorktown employee, Jason Zeif. But Mirchandani had GPS on a few of her signs, and one she realized that her sign outside her home was moving, she took the photo of Zeif caught in the act.

The sign was later retrieved – along with 5 additional signs – by using a GPS tracking device. A police report was filed, and the response will only result in more questions.

When Zeif was questioned by Yorktown Police, the report states that Zeif "stated that the campaign sign was located on Town right of way property, and Zeif explained that campaign signs cannot be on Town property."

Zeif also claimed that the sign was in the grass on the edge of the roadway and not obviously associated with any residence" and that "he was performing an act in his official role as Yorktown Code Enforcement officer. He added that he has taken thousands of signs off town property over the years, and that he has taken signs from both side of the campaign. Recently Zeif has been placing signs next to the dumpster at Town Hall.

There are no reports to verify that Zeif has taken signs from other candidates

Mirchandani went to the dumpster at Town Hall and found a few of her signs, and other signs for professional services.

"I asked to have the report amended to include trespass as part of the original complaint; Mr. Zeif came onto my property to remove the sign. The town code does not authorize him to take my property, even if a violation were to take place," said Mirchandani.

"I am also including photos of my signs in the dumpster that belie Mr. Zeif's assertion that he is applying town codes in an unbiased manner. You can clearly see that there are no Ed Lachterman signs.


"Additionally, where it indicates that "no further action taken or requested" – I want to pursue this. Mr. Zeif came on my property and took a sign which he had no right to do. He is improperly applying town codes and is doing so in a biased manner."

Mirchandani got the idea to use a tracking device for her signs from the story of Town of Fishkill Councilman John Forman. Forman was the Republican candidate for town supervisor in 2023 and had been charged after collecting 30 signs that opposed his campaign. One of the signs was equipped with a tracking device.

"I will stay focused on the issues and leave the politics as usual to the politicians."

Mirchandani spoke to an attorney about this matter. Richard Abbate wrote that in his opinion, a "Vote for Jann Mirchandani sign is clearly a temporary opinion sign, and is therefore authorized by the Town Code. Therefore, the Town Code Enforcement Officer (Zeif) did not have the authority to remove a temporary opinion sign."

Mirchandani does not live on a heavily trafficked road. She lives in a residential area of Yorktown, and the sign had no imact on vehicle safety. Which makes the so called explanation by Zeif less believable.





Feds Charge Convicted Sex Offender Who Fled to Mexico with Sexploitation of a 12-Year Old

On March 22, SDNY US Attorney Damian Williams announced that Kennedy Carter, a convicted sex offender who had fled to Mexico from probation in Oregon following a conviction for encouraging child sexual abuse in the first degree in that state, was arrested and charged with sexual exploitation of a child and other child sex offenses. On March 21, 2024, CARTER was deported from Mexico by Mexican immigration authorities and arrived at San Francisco International Airport, where he was arrested by the FBI upon arrival. CARTER was presented in San Francisco federal court before U.S. Magistrate Judge Laurel Beeler.

U.S. ATTORNEY DAMIAN WILLIAMS SAID: "THE CHARGES UNSEALED TODAY REFLECT THE TENACITY OF THE CAREER PROSECUTORS OF THIS OFFICE AND OUR LAW ENFORCEMENT PARTNERS WHO TRACKED DOWN THIS ALLEGED RECIDIVIST SEX OFFENDER TO MEXICO AFTER HE FLED FROM PROBATION IN OREGON. THE DEFENDANT WENT TO GREAT LENGTHS TO AVOID RESPONSIBILITY FOR HIS ALLEGED UNCONSCIONABLE ACTIONS, BUT WE RELENTLESSLY PURSUE JUSTICE FOR VICTIMS OF CHILD SEXUAL ABUSE, AND THOSE RESPONSIBLE WILL FACE THE FULL WEIGHT OF THE LAW, NO MATTER WHERE THEY MAY HIDE."

As alleged in the Complaint: From at least on or about May 20, 2023, through at least on or about May 29, 2023, CARTER knowingly induced, enticed, and coerced a 12-year-old female minor located in Putnam County ("Victim-1") to engage in sexually explicit conduct, to take sexually explicit photos and videos of herself engaging in such conduct, and to transmit them over the internet to CARTER. In addition, from at least on or about May 20, 2023, through at least on or about May 29, 2023, CARTER knowingly distributed material that contained child pornography, including photographs and videos of another minor female ("Victim-2") to Victim-1 over the Internet. Finally, because CARTER is required by federal or any other law to register as a sex offender, and is so registered, and has committed a felony offense involving a minor in engaging in sexual exploitation of a minor, he is also subject to an enhanced penalty as charged in the Complaint.

CARTER, 27, previously of Corvallis, Oregon, is charged with one count of sexual exploitation of a child, which, because of his prior state conviction in Oregon for encouraging child sexual abuse in the first degree, carries an enhanced mandatory minimum sentence of 25 years in prison and a maximum sentence of 50 years in prison; one count of receipt and distribution of child pornography, which, again due to his prior conviction, carries an enhanced mandatory minimum sentence of 15 years in prison and a maximum sentence of 40 years in prison; and one count of penalties for registered sex offenders, which carries a mandatory minimum sentence of 10 years in prison to run consecutive to any sentence imposed for the underlying offense of sexual exploitation of a child.

Mr. Williams praised the outstanding investigative work of the FBI's Westchester Safe Streets Task Force and the Putnam County Sheriff's Office. Mr. Williams also thanked law enforcement partners in Mexico, the Benton County Probation Office in Benton County, Oregon, the Department of Justice's Office of International Affairs, and the U.S. Attorney's Office for the Northern District of California for their assistance.

This case is being handled by the Office's White Plains Division. Assistant U.S. Attorney Margaret N. Vasu is in charge of the prosecution.

Latimer Leads Bowman by 17, continued from pg 1-

to defeat incumbent Congressman Jamaal Bowman in the June 2024 Democratic primary race. Conducted by The Mellman Group, this survey offers important insights into the perspectives of voters in New York's 16th Congressional District

"To put it plainly, Congressman Bowman's constituents are very unhappy with him but very impressed with County Executive Latimer. The combination of Latimer's sterling image and voters' distinctly negative assessments of Bowman may cost the incumbent congressman his seat. Bowman's constituents are even divided on whether he even cares about them, but the vast majority believe Latimer meets that central test," said DMFI PAC Chairman Mark Mellman. "It's simple: George Latimer is highly regarded, while Jamaal Bowman is widely unpopular.

"On Israel issues, the data are clear – Congressman Bowman is out of touch with his constituents. A majority of primary voters in his district approve of the job President Biden is doing handling the war between Israel and Hamas and want the U.S. to support Israel.

"With a robust campaign, George Latimer is in strong position to unseat the now unpopular Congressman Bowman."

This analysis represents the findings of a survey of 400 voters in New York's 16th Congressional District representing the likely June 2024 Democratic primary electorate. The survey uses a registration-based sample, with interviews conducted via landline, cell, and text-to-online from March 26-30, 2024. The margin of error for the sample as a whole is +/- 4.9% at the 95% level of confidence (higher for subgroups).

Key Highlights from the Poll:

Latimer has a 17-point lead in the horse race, with 52% of the Democratic primary vote, compared to 35% for Bowman, 0% for Farber, and 13% undecided.

Among those who vote most often in primaries (3 or 4 of the last 4), Latimer is even stronger, leading Bowman by 56% to 35%.

Latimer's double-digit lead results from his substantial image advantage. For example, while voters are quite positive about Latimer's performance in office (68% positive, 18% negative) they judge Bowman's performance quite negatively (36% positive, 55% negative)

Bowman is out of touch with is constituents on Israel issues. By 59% to 28%, Democratic primary voters approve of the job Joe Biden is doing handling the war between Israel and Hamas. In addition, 62% of Democratic primary voters want the U.S. to support Israel in the current conflict while a mere 5% want the U.S. to back Hamas.

One of Latimer's democratic supporters in the Sound Shore said, "After finding out about this poll, George (Latimer) went out and campaigned with us at 8 events. There is no complancency in George Latimer and in those of us supporting his election to Congress."



These remarkable young women are the founders of A Bear and A Book Project, initiated in fall 2023, aimed at nurturing a love and confidence for reading among young children. Their approach involves visiting Pre-K to 2nd grade classrooms, sharing stories, and encouraging kids to read aloud to their peers, adults, and even their teddy bears. To make this experience lasting, they conclude their visits by gifting each child a new book and a teddy bear. The cost of each gift bag is \$6, typically for classes of around 28 students. This wonderful initiative is supported by local businesses sponsoring classrooms and generous donations from individuals. Those interested in sponsoring a classroom or donating to the project can do so by sending an Amazon gift card to bearandbookproject@gmail.com," writes Collins-Bellamy.

We wanted to learn more and share their story with our readers. Peyton and Lauren have been friends since the 4th grade. Both attended Paideia School 15, and now attend Ursuline High School.

The idea behind A Bear and a Book Project is that for those students who don't have someone to read to at home, can read to the Bear that they are given along with a book.

"This idea started when we were studying. We were taking a break and were just talking. Since we've met, in fourth grade, we have always wanted to make a difference together. We have always shared a common interest in reading and writing, therefore, we wanted to incorporate those passions into our project. So, we began brain-storming and came up with the idea of reading to children, then giving them a bear and a book so that they can practice reading if they do not have anyone else to read to. And then a Bear and a Book was born," said Peyton

"So far, we have visited 28 classrooms and 15 different schools, reaching over 600 children. We have read to schools in Yonkers, the Bronx, Queens, Mahopac, Mamaroneck, and Cheshire, Connecticut.

"For school visits, we begin by introducing ourselves, explaining a little bit about our project, and asking if anyone already likes to read. Then, we read them a story that is age appropriate, while we hold our own teddy bears, named Candy Bear and Sprinkles named by two previous pre-k classes. We ask them questions regarding the book to keep them engaged throughout the activity. At the end of the book, we reflect on the lessons and the main idea throughout the story. We finish off by distributing the goody bags that include a bear, a book, and a flier, containing information regarding the project. We walk around, talking to the students, and reinforce the importance behind reading their book to the bear," said Lauren

The cost of the Bears, Books and Bags have been paid for through generous donations from local businesses in Yonkers. "We have been very fortunate with donations from small, local businesses. If they want to donate, we give them a specific amount that will cover the fees of one class; therefore, each company sponsors one or more classes. Also, we have been fortunate to receive donations from generous individuals, such as teachers from prior classes, friends, and our school."

While the Bear and the Book Project is only 5 months old, the response has been positive. "Most importantly, the children have been engaged and appear to have been very receptive and excited about the project so far," said Pevton

Both Peyton and Lauren are proud Yonkers residents and "feel very lucky to have received a Yonkers Public School education. Not only did it help us become friends, but it helped to inspire our project as well.

"We both attended Paideia School 15, Peyton from Pre-k through 7th grade and Lauren from 4th grade to 6th. We always had very encouraging teachers that helped set us up for future success, and always cheered us on.

"We would both say that our 5th grade teacher, Mrs. Tiffany Soares, is 15's best example of this. She always cared about helping us grow, and she very much stressed the importance of reading and being well educated. She always told us, 'use it or lose it' to encourage us to keep up our skills, and her focus on Shakespeare through putting on a play really helped make the stories come to life.

"Another very important inspiration to us is another Yonkers native, our freshman English teacher at Ursuline, Ms. Tonianne Bellomo. She was always helping us to improve our writing, which we both love, and helping us to get a very deep and profound understanding of the texts we were reading in class. Most importantly, she really cared for us and helped fuel our drive and ambition to improve our literacy skills.

"Something that has been important to us from the start is getting to read in School 15, and on April 2 we were able to make this come true. It was really important to us to give back to such an amazing school that was very good to us. We also have been fortunate enough to have been welcomed into two more Yonkers Schools, and we hope to get into many more in the future. We will be in the Yonkers Public Library in the 2nd week of April," said both Lauren and Peyton.

What is their ultimate goal? "Something very important to both of us, is dreaming big and making those dreams come true. With our hard work and dedication towards this project, comes aspirations. We hope to reach 2500 bears and books distributed by June of our Senior Year in high school. However, high school is not where this project ends; we plan on continuing Bear and a Book all throughout college, and even bring it to our college towns. We hope to bring this project to the national and international level, specifically Ireland, where both of Lauren's parents and her relatives are from. One day, we wish to fulfill our dream of writing a children's book of our own, revolving around how we met at school 15, and tying in key ideas from a Bear and a Book Project. Lastly, we hope that one day we will be invited to share our project and read at the New York Public Library. Our dreams and aspirations are fueled by the support of our community and continue to grow alongside our service project. "

Who taught you to give back to others in this way?

"Giving back to our community is something that has been instilled in both of us since a very young age. The importance of looking out for one another has always been emphasized by our parents throughout our lives. Both of our families have always fostered this.

Peyton's mom helped her to organize a laptop drive during the coronavirus outbreak so that children in her school community whose families could not afford laptops could still attend online lessons and get their assignments.

Lauren fostered these ideas of generosity for the community by running a toy drive for the Primera Hispana Church in downtown Yonkers to show support for struggling families during the holiday season. She has been operating this toy drive since the 7th grade.

Some of the schools that the girls have visited have young students who are living in shelters, or do not have a parent in their lives. And those are exactly the kids that both Lauren and Peyton want to impact with A Bear and a Book Project.

"I remembered hearing about how using toys and reading to toys can help young students read, so why not give them a teddy bear and a book. If they don't have a family member, they can read to the bear.

"That was the idea, they can always count on their bear to be there and listen to them read. That way they always have someone to read to

The girls give out age-appropriate books to all students, in consultation with the teachers. The hope is to give out several different books to each class and maybe the students can trade with each other after reading.

"It feels really good to see their reactions. In some classes, they begin reading right away," said Peyton

"It makes us feel grateful. Even though it's a small bag and a book, it means a lot to them. The bear isn't just some toy, they can go home and read to the bear for support," said Lauren

Peyton attends St. Eugene's Church and Lauren attends St. Barnabas. Peyton hopes to be an entertainment lawyer in the future, and Lauren is interested in a career in finance or law.

court before U.S. District Judge Denise L. Cote, who imposed today's sentence.

U.S. ATTORNEY DAMIAN WILLIAMS SAID: "GINA MESTRE BETRAYED AND ABUSED THE TRUST PLACED IN HER BY THE NYPD AND THE PEOPLE OF NEW YORK. SHE SWORE TO PROTECT THE PUBLIC FROM CRIMINAL ACTIVITY, BUT INSTEAD PARTICIPATED IN SIGNIFICANT CRIMES OF HER OWN BY PASSING CONFIDENTIAL INFORMATION TO A GANG LEADER AND HELPING HIM EVADE CAPTURE FOR THE MURDER OF A RIVAL GANG MEMBER. FOR VIOLATING HER OATH TO THE CITIZENS OF NEW YORK CITY AND HER FELLOW POLICE OFFICERS, MESTRE HAS BEEN SENTENCED TO SPEND MORE THAN FIVE YEARS IN FEDERAL PRISON."

According to the allegations in the Indictment and other documents filed in federal court and based on statements made in public court proceedings:

MESTRE was an NYPD Officer assigned to the 52nd Precinct's Public Safety Unit. In the summer of 2020, a major focus of both the precinct and the Public Safety Unit was the reduction of gun violence in the area. Much of that violence was attributed to members of the Shooting Boys, a violent street gang based in the University Heights section of the Bronx.

In or about June 2020, MESTRE began communicating with Andrew Done, a/k/a "Caballo," the leader of the Shooting Boys. MESTRE and Done communicated through secret social media accounts and phone numbers and eventually began an intimate relationship, during which MESTRE provided Done and other gang members with confidential, non-public law enforcement information about the federal grand jury investigation into the Shooting Boys.

MESTRE warned Done, and other gang members, that federal investigators were preparing to bring a federal indictment against the Shooting Boys. MESTRE also warned Done about impending law enforcement operations, which enabled Done and other gang members to dispose of weapons and conceal other criminal activity before law enforcement arrived on scene. In addition, MESTRE disclosed the identity of a cooperating witness who provided information about the gang to law enforcement. Armed with this information, Done and other Shooting Boys assaulted the witness to prevent the witness from further cooperation and to send a clear message within the gang that the punishment for cooperation would be severe.

On or about November 5, 2020, Done shot and killed a rival gang member ("Victim-1") as Victim-1 sat in his car on Cromwell Avenue in the Bronx. NYPD Detectives investigating the murder recovered security camera video (the "Video") capturing Done's commission of the murder. Several members of the 52nd Precinct, including MESTRE, were tasked with identifying the shooter in the video. In fact, MESTRE was ultimately one of several officers who actually identified Done as the perpetrator.

Despite identifying Done as the shooter and ostensibly participating in the NYPD's efforts to apprehend him, MESTRE sent Done a copy of the Video to his phone and secretly communicated with Done the day of the murder and in the weeks afterwards. Specifically, MESTRE warned Done about law enforcement's efforts to capture him, allowing Done to eventually flee from the United States.

In March 2022, 10 members of the Shooting Boys were charged in a 15-count indictment with various federal crimes, including racketeering conspiracy and murder. Done was charged with the murder of Victim-1 and was apprehended in the Domini-
