Speaker of the House Johnson Visits Westchester to Support Lawler

The new Speaker of the House, republican Mike Johnson, came to West-chester last week to attend a fund raiser, and lend his support to the reelection of Congressman Mike Lawler. Rep. Lawler, who represents the 17th district, which includes all of Northern Westchester, joined supporters, contributors, and republican elected officials at the home of Tony and Maria Sayegh. Tony Sayegh served in the Trump administration as a Public Affairs official in the US Treasury Department.

"Thank you to Speaker Mike Johnson for visiting the Hudson Valley today for an event in support of my re-election campaign. Throughout my time in Congress, I have been focused on addressing the issues that matter to our district and the families that live in it — tacking the affordability crisis and lifting the cap on SALT; ending the reckless spending and addressing our national debt; securing our border and fixing the immigration system; increasing domestic production of energy; restoring public safety; improving our education system; and supporting allies like Israel while taking on the malign influence of China, Russia, and Iran.

Lawler said, "While we have a lot of work ahead of us, I look forward to working with Speaker Johnson to address these important issues and more. While the Speaker and I do not agree on everything — as Ed Koch famously said, if you agree with me on 12 of 12 issues, go see a shrink — we do agree about the importance of tackling the big issues impacting our country. I will always fight for our communities here in the Hudson Valley."

Outside of the fund raiser, democrats including former Congressman Mondaire Jones, protested Johnson's appearance in Westchester. Jones, who will be the **continued on pg 7-**

Latimer Talks Congressional Run With Westchester Rising

Westchester County Executive and now official candidate for Congress George Latimer spent some time with Rising Media to discuss his campaign to unseat Congressman Jamaal Bowman next year. Latimer and Bowman are both democrats and will compete in a democratic primary in the 16th Congressional district, which includes most of lower-mid Westchester next June.

"Democrats in the district are getting a choice between two progressives. I am running on all the progressive things we have done in Westchester County government," said Latimer who highlighted increases in health funding for lower income residents, free bus service, and completing capital projects in the county including Memorial Field in Mt. Vernon and Sprain Ridge Pool in Yonkers.

"We have also managed the migrants with no crime issues. I have done all of this in a reasonable way."

"Their game plan (Bowman campaign) is to say that they are progressive, and they are running against someone on the right. But when you have someone who has a progressive record to run on, and who has actually accomplished things and is deeply rooted in the Westchester communities that make up the 16th district, it's a problem for their narrative. They are apoplectic because they can't frame me in the way they want to," said Latimer.

Supporters of Bowman have aggressively pushed back against Latimer's candidacy. Congresswoman Alexandra Ocasio-Cortez (AOC) Tweeted about Latimer's use of Dr. King's famous words, "don't judge me by the color of my skin, judge me by the content of my character," in an interview with Gothamist.

"Quoting MLK to justify a cynical effort to unseat the only Black man representing Westchester & one of the few in Congress who stand for the human rights of Palestinians is repulsive. It's time to organize with electoral force," tweeted AOC.

Latimer's MLK reference made Politico's quote of the day, and Westchester progressives hoped to pounce on what they called Latimer's shaky rollout of his congressional campaign. "Instead of the strong announcement he wanted, he went viral for his MLK comments, POLITICO has him as the quote of the day this AM (for unfavorable reasons), and he admitted to speaking with his second-in-command Ken Jenkins around redistricting in his Gothamist piece (contradicting an earlier interview). Latimer's been a formidable campaigner at





North Caslte Supervisor Schiliro & Clerk Simon Asked to Resign Over Absentee Ballot Scheme

The race for Town Supervisor in North Caslte on November 7 was so close that they are still recounting the ballots. Currently, Democrat Joe Rende holds a 5 vote lead, and after two recounts it appears that his lead will hold over Republican Barbara DiGiacinto, who is also a Town Councilwoman.

When the vote totals are this close, just a 5 vote lead out of 3,137 votes cast, the absentee ballots that are mailed in are thoroughly examined. And in the case of this election, 4 absentee ballots were examined in court, and eventually were not couned or included.

Here's where it gets a bit complicated. Schiliro, a democrat, endorsed DiGiacinto, the republican for Supervisor. So any absentee ballots coming in from friends and relavites of Schiliro would have been cast for DiGiacinto.

In the end, the absentee ballots in question were not counted, and Rende

has been delcared the winner.

But North Castle resident Robert Greene will not let this rest. "The worst thing they can do is try to steal my vote. I'm outraged. They committed a crime against the people. I play by the rules and campaigned for Rende. But the fact that Schiliro gets his daughter to put in a vote that cancels out my vote is terrible."

Greene sent us this Letter Opinion based on his analysis of the vote count and court hearing. He includes comparative signatures on ballots and of board of elections voter cards that do not appear to be the same.

"In my opinion, North Castle Supervisor Mike Schiliro, North Castle Town Clerk Alison Simon, and Town Council member Barbara DiGiacinto (a candidate for Supervisor endorsed by Schiliro) were involved in an effort to inflate the vote count in favor of DiGiacinto by encouraging and enabling illegal votes to

On December 6, 2023, Josephine Spano, 89, of Yonkers passed away peacefully at home with her children by her side. Born on January 6, 1934, Josephine grew up in Yonkers and attended Commerce High School. She met and fell in love with her teenage sweetheart, Leonard Spano. They married on July 12, 1952. She followed him into the desert in California, where he was stationed as a U.S. Marine entering the Korean Conflict. Their adoration for each other deepened with every decade, and through his years of public service as a longtime County Legislator, Westchester County Clerk, and business owner, she remained a supportive force. They were happily married for 67 years.

The matriarch of the Spano family, Josephine's life overflowed with love, devotion, and an unyielding spirit. Many touching moments could be written about the profound impact she had on each life she touched. When you walked into the Spano home on Christmas morning, you would see a crowd of family members and only the angel peeking from the top of the Christmas tree. That's because hiding the rest of the tree were wrapped presents piled a mountain high and reaching nearly to the ceiling. Josephine showered her family with gifts; those came in many forms, most notably the gift of love.

From the beginning, she instilled the gift of unwavering faith in her family. When their first child Nicholas was born, they celebrated the gift of parenthood, but a year later after losing twin boys shortly after birth, she was told another child would not be in her future. On that day her prayers for intervention to Saint Gerard, the patron saint of motherhood, began and Josephine and Leonard were blessed with 15 more children. For more than fifty years, she hosted a mass asking Saint Gerard for his intercession in helping women faced with the same challenge.

To her children, she offered the gift of her guidance, support, and dedication, whether it was sharing a hug or a special private moment. She is survived by her children, Senator Nicholas Spano (Linda), John (Evelyn), Maria Elena, Eleanore (John Kolmer), Leonard (Christine), Joanne (Vincent Finnegan), Rosemarie (Christopher Gannon), Camille (John Zajac), Mayor Michael Spano (Mary), Victoria (Thomas Smith), Anthony (Eva), Dolores (Richard Wilson), Loretta (Luis Eleutice), Gerard (Karly), Joseph (Rosalie), and City Clerk Vincent Spano (Jaime).

Her legacy carries on in her 42 grandchildren and 28 great-grandchildren. When asked what they'll remember most, her children said her gift of inner strength, her ability to carry a family through a crisis, and her hospitality in welcoming everyone into her home. Her gift of generosity began as a young mom when she served as the President of the PTA at Saint Peter's School and Mount Carmel School, member of the St. Ann Society, head of the lunch program at Sacred Heart, supporter of special needs children, and a volunteer for many charitable

A keeper of traditions, whether it be summers by the bay in Mastic Beach with the whole family, a weekend away with her girls, an afternoon of bingo, Easter morning with baskets for each of her grown-up children, a talk over a cup of tea or a glass of red wine, she always put others first. As a young girl, Maria Elena may have said it best when she wrote, "Thank you, Mom, for always being there and being you. If I had a chance to pick my mom, I would have picked you." To her children, Josephine will forever be their guiding light, their cherished friend, and their angel.

Yonkers Mayor Mike Spano said, "Our beloved mother, Josephine Spano, went to be with the Lord this morning. She is the strongest woman I have ever known. She always made each of her 16 children feel loved, valued and cherished. We all just wanted to make her so proud.

She inspired us. She educated us. She dedicated her life to us. For that, we are eternally grateful. She was the matriarch of our family, placing her foundation in faith. St. Gerard, the patron saint of childbirth, was whom she turned to for prayer.

Notably, he said, "Who except God can give you peace?" You are at peace now, Mom. What gives me comfort is you now are reunited with dad – forever our guardian angels. We will always strive to make you proud and keep you in our heart always."





New Yorkers Split on Whether to Combine Local Elections Year with Even Year Elections

Governor Katrhy Hochul has on her desk a bill which would change when the County Executive an town officials run for office. The bill calls for these offices to be on the ballot at the same time as a Presidential or Gubernatorial election, which are held on even year elections.

Opinions are mixed over whether this is a good idea and she should sign it into law, or a bad idea that warrants a veto.

Greenburgh Supervisor Paul Feiner, writes, "Within the next few weeks Governor Hochul will have to decide whether to sign or veto legislation that would change the years when the County Executive, town officials run for office. I urge her to veto the legislation. Currently these elections are held in off years- not when the President or Governor runs for office. The legislation the Governor will be considering signing would change the election for county officials and town officials to the years when the President and Governor are on the ballot. The law does not apply to city or village elections, and for races for county clerk, sheriff, district attorneys, local judges.

Although more people will vote in town and county elections if the elections for these offices are held the same time as Presidential/Governor elections, there are big negatives to the law. Local elections will be nationalized. Many of the voters who cast their ballots when there are national elections vote the straight party line. They are not paying attention to local issues.

There will be much less media attention given to local races. That means that local officials who are unresponsive to the community will stand a better chance of getting re-elected. If there is a heated race for President, Governor, US Senator, US Congressional representative, State Senator, State Assemblyman, County Executive, County Legislator and town officials the same year how many people will focus on the local races? In an off year election the media has the air time or print space to cover local issues. During a national election year I think there will be very limited media attention given to the local town races. It will be very hard for candidates who are critical of policies of their opponents to get people to focus attention.

I believe that the legislation, if signed, will reduce the influence of neighborhood associations. If local officials disregard public opinion on land use matters (as an example)- it will be much harder to organize successful campaigns to defeat incumbents who were endorsed by the party. It will also make it almost impossible for independent candidates to win election against party supported candidates--resulting in even fewer contested elections.

Finally, why did our State Legislators decide to change the election years for only town & county offices but not for village, city, fire district or school votes? I urge the Governor to veto the legislation," writes Feiner.

The watchdog group Reinvent Albany supports the Election Alignment Bill. In a letter to Gov. Hochul, they write, The undersigned organizations encourage you to sign Assembly Bill A4282B/Senate Bill S3505B (the "Election Alignment Bill"), which would move the timing of many local elections across the state to even-numbered years, on the same cycle as federal and state elections.

New York State's current practice of holding local elections "off-cycle" in odd years is both racially discriminatory and discriminatory against young voters. Off-cycle elections exacerbate racial and age disparities in political participation and lead to under-representation of voters of color and young voters in local governments across the state. The Election Alignment Bill provides a critical opportunity to shift many of the off-cycle elections that produce these discriminatory effects to even years, yielding more representative turnout.

Pursuant to existing New York law, towns and counties hold primary elections in June of odd-numbered years and general elections in November of odd-numbered years, which is "off-cycle" from federal and state elections held in even-numbered years. The Election Alignment Bill would shift these local contests to even-numbered years so they are "on-cycle" with federal and state elections. This measure would reduce burdens on voters, facilitate more accessible public education surrounding elections, and increase participation in elections.

Off-Cycle Elections Can Exacerbate Racial Discrimination in Voting a. Off-cycle elections have been shown to contribute to significant racial and age-based disparities in political participation Studies have consistently shown that off-cycle elections significantly depress voter turnout, and in doing so disproportionately suppress participation in the democratic process by young people and people of color. Aligning local elections with state and national elections "greatly reduces [that] cost of participation" for these voters to engage in local democracy, without reducing other voters' opportunities to participate.

The impact of off-cycle elections is starkly demonstrated in the disparity between younger and older voter turnout. In fact, one study examining election timing and voter turnout for school districts noted that one of the "most substantial difference[s]" in voter share between on-cycle and off-cycle elections was based on voters' age. While younger Americans are vastly underrepresented in off-cycle contests (with older voters sometimes representing "more than 2 times as many voters as they do . . . residents"), younger Americans are "substantially better represented in on-cycle contests" to create a more representative voting population. Westchester Board of Legislators Passes, Latimer Yonkers Mayor & Council: We're In The Money Signs 2024 Budget: No Tax Levy Increase for Fifth Straight Year; 14-2 BOL Vote

On Dec. 11, the Westchester County Board of Legislators passed the 2024 Westchester County Budget. The \$ 2.7 billion budget includes additions approved by the Budget & Appropriations Committee. It reflects key priorities and investments in advocacy for youth, domestic violence, mental health, support for community centers and services, arts and culture, and environmental sustainability to make Westchester more affordable, livable, and safer.

BOL Chairman Vedat Gashi said, "As a Westchester resident with a family, I recognize that each dollar counts. As Chairman of the County Board of Legislators, I am proud that we have maintained our commitment to keeping the tax burden in mind while making great strides to achieve an upgraded Bond Rating to AAA. We have done this by carefully managing resources to revive mediumterm growth for County residents while improving public safety, transforming our mental health care system, protecting our environment, and investing in our children's future."

The Operating Budget allocates \$8.8 million to the many non-profits that provide essential services for Westchester County residents. Areas of focus reflect the priorities of the Budget and Appropriations Committee and include over \$4 million for community centers and community-based services, \$550,000 for cultural organizations, over \$2.5 million for youth programming and services, \$620,500 for organizations combatting food insecurity, and over \$1 million for domestic violence.

No Borrowing for Tax Certioraris

No Borrowing for Pensions

No Use of Fund Balance

No Borrowing for Cash Flow

The 2024 budget has No Borrowing or One-Shots and No Increase in Property Tax Levy, for the fifth straight year.

The budget signing comes on the heels of Westchester County being recognized by Fitch Ratings with a prestigious "AAA" credit rating. The "AAA" credit rating is the highest designation possible and underscores the County's commitment to maintaining a solid financial foundation. This recognition not only reflects the County's current financial standing but also positions it favorably for future economic challenges and opportunities. The "AAA" credit rating is expected to have a positive impact on Westchester County's ability to secure favorable interest rates when issuing bonds, ultimately benefiting taxpayers and supporting continued investment in critical infrastructure and community initiatives.



The vote on the budget was 14-2, with Legislators Damon Maher and Catherine Parker voting no.

There they go again! By the time you read this article, the Yonkers City Council will probably approve raises for themselves and the Mayor that could be as high as 46%. Yes friends, 46%. Didn't you get a 46% increase the last time your boss raised your salary. And in the case of the Mayor, the raise will include 'retroactive' pay of some \$72,400. You can't make this stuff up.

When did the Council announce they would be voting on raising their salaries and that of the Mayor? After Primary Day and Election Day which was just a month ago. If they announced it before then, do you think the outcome of the election might have been different. Is the Council required to have a public hearing on this? You guessed it, nope!

This speaks to the problem with these proposed raises. The Council vote on the raises was first announced in the meeting call for the City Council Meeting on December 12, Tuesday of this week via the distribution of the City Council Agenda last Friday. So you have a full 5 days to make your voice heard Yonkers. Not enough time.

It's these last minute announcements that get people crazy and fed up with the Yonkers City Council. The money for the raises was included in the budget for Fiscal year 2023-2024 which was approved last year in June. 7 months ago! And the Council just so happened to put it on the agenda in the middle of the holiday season when people aren't paying much attention to what's going on in

Folks are busy making gingerbread houses or potato latkes (pancakes) or preparing for Kwanza Karamu, the most important meal of the holiday which takes place on the sixth night. The affairs of Yonkers City government Right now are not on peoples minds.

The then City Council played a game like this when they increased term limits with little notice from 3 to 4. Could the term limits vote have been a quid pro quo or deal for the salary increases? Why does it look strangely like that. And may I remind you that together with an increasing salary the City Council and Mayor get full health benefits paid for by the city as well as a city gassed up and maintained vehicle for their use. Take it from me, the free health benefits they get are better than those most people in Yonkers get, and after working a certain number of years they are eligible for a pension together with those health benefits

As the song brothers Ira and George Gershwin composed for the the Broadway musical film 'A Damsel in Distress' in 1937 says, it's 'Nice Work if You Can Get It!

Some proposed numbers. The salary for the Mayor will increase 46% to \$228,500. He will get over \$72,000 in retroactive pay. The City Council President's pay will increase 30%, 38% increase for City Councilpersons, 40% increase for Majority and Minority Leaders and Committee Chairs will receive an additional \$15,000 for their work. Pretty much everybody gets an increase over

The Mayor's retroactive pay seemed a bit odd as taxpayers get nothing for this. A City spokeswoman told my colleague Journal News Tax Watch columnist David McKay Wilson that the Mayor's retroactive pay is in line with the 1 time checks issued to union members when a contract is settled. She said the State Legislature approved retroactive raises for the Governor and Lt. Governor in 2016.

We need to learn in Yonkers that just because some other party in government does something like retroactive raises doesn't mean Yonkers has to do it to. It's like the \$15,000 stipend given to the School Board President because other districts give their School Board Presidents \$15,000, a move by the Board of Education Mayor Spano agreed with me was wrong. This was the first time in the history of the Yonkers Board of Education that a trustee got paid for his work, hundreds of people volunteering without pay to do the job since the district was created. Like the \$15,000 and retroactive pay, you have to watch these things cause they can spread like wildfires!

Councilman John Rubbo told my colleague Wilson that the Council 'delayed approving Raises to avoid disruption of negotiations with municipal unions before settling contracts.' One has nothing to do with the other. If Yonkers can't it's act together settling union contracts before the old ones expire, then maybe it needs someone fresh to negotiate contracts and a new way of thinking taking the election cycle out of the process.



County Legislator Damon Maher Changes Parties, from Democrat to Working Families

County Legislator Damon Maher announced on Dec. 6 that he has changed his voter registration from democrat to the Working Families Party. For the final three weeks of his term, Maher will be the only member of the Working Families Party elected to office in Westchester. Maher declined to run for reelection, opting to run for Mayor of New Rochelle.

Maher writes, in an email to his constituents, "Dear friends, I will submit a voter registration form this morning changing my political party affiliation to the Working Families Party.

"First, please know that my switch to WFP is certainly NOT based on its national organization's foreign policy positions. Rather, I am much more closely aligned with the WFP's domestic agenda, which in fact is more in line with the stated Biden agenda than with that of many Democratic officials in our region. Over the past two years especially, I have grown continually more alienated from suburban New York Democratic politicians, who are mostly good people but, in my view are often captive to a more cautious, corporate mindset.

"My term in office at the County Legislature ends on Dec. 31, but there are still important days and hours of review and, I hope, some revision of the County Executive's proposed budget for 2024. During this time, and in the long term as I continue as an activist looking forward with a progressive and anti-racist lens, I think the WFP will be a better space from which to advocate for....

Fair, affordable and integrated housing.... more aggressively pushing out the \$200 Million we have appropriated in 2023-24 for Affordable Housing throughout the County.... expediting implementation of our Tenant Right to Counsel law and the promised amendment eliminating the sunset provision that the County Executive's office inserted into the bill at the last moment.

Police Accountability.... insitutionalizing meaningful civilian oversight.... reducing rarely questioned increases in salaries, overtime and infrastructure for policing, punitive prosecuting and punishment.

Reducing income inequality and extreme wealth disparities with fair, progressive taxation.

More funding of academic or vocational education for 1-2 years beyond high school (e.g., free Westchester Community College and forgiving of debts owed to WCC).

More money for community-based nonprofits tackling the social and economic problems that harm our communities.

REAL environment initiatives encouraging less reliance of the private, one-person-commuting private car.... permanently lower or free county bus fares, true pedestrian and bicycle safety.... long-term strategy for car storage (aka parking) that encourages less, not more, private car use.

Stronger campaign finance laws.... putting serious funding into our Ethics Board or create an independent office of Inspector General or Comptroller.... curtailing big money from big real estate developers whose project are dependent on favorable actions by the various levels of government.

I look forward to working with you, my friends, on these and other crucial matters, now and after my term in office ends," writes Maher.

INDEPENDENT REDISTRICTING COMMISSION BACK TO WORK

Tuesday afternoon, right before press time the New York Court of Appeals ordered the Independent Redistricting Commission back to work to redraw its Congressional map to return control of the states 26 Congressional districts to the New York State Legislature. The new map must be completed by February 28 of next year. The court said the neutral lines imposed for last years election were a temporary fix.

Though Democrats liked the decision, how fair is it to someone who wants to run for Congress and with legal battles won't know the district lines for months. Like County Executive George Latimer who was going to battle Congressman Jamaal Bowman based on the current lines. Will a set of approved Congressional lines be in place far enough in advance to complete all that is necessary for the Congressional primaries next year (I.e petitions) allowing time for candidates to campaign and debate the impact?

PAC Supporting RFK Jr. for President to Spend \$15 Million for Ballot Access in 10 States, Including New York

American Values 2024 (AV24), the Super PAC supporting Robert F. Kennedy, Jr.'s presidential candidacy, announced its intent to pursue ballot access in pivotal states independent of the campaign. The targeted states include Arizona, California, Colorado, Georgia, Illinois, Indiana, Michigan, Nevada, New York, and Texas. These ten states represent approximately half of the required signatures nationwide. AV24 is embarking on an independent ballot access campaign and stands ready to address all requisite tasks that it may undertake independently and within the bounds of the law, which further solidifies the organization's commitment to ensure Robert F. Kennedy Jr.'s path to the White House. This list may change upon additional legal review.

AV24 is expecting to spend between \$10M-\$15M to tackle this monumental task in these ten states with the legal expertise to analyze each state's requirements, process, and implementation.

"We have chosen to pursue these critical states, some of them battlegrounds, due to the complexity of the state election codes and the volume of signatures necessary to achieve ballot access. A successful ballot access initiative ensures Robert F. Kennedy, Jr as an option for president of the United States," said Deirdre Goldfarb, Special Counsel Ballot Access.

Tony Lyons, co-founder of AV24 and President of Skyhorse Publishing, said, "The Super PAC is also preparing for inevitable attacks from both sides of the aisle. Democrats and Republicans are panicked about Bobby's surging popularity among black voters, Hispanic voters, all voters under 45, and anyone concerned with ending DC corruption. Kennedy's numbers have shocked the uniparty elites to their core. They will work overtime in a futile attempt to keep Bobby off both the ballot and the debate stage. They clearly don't understand what people worldwide have realized—that we are in the middle of a revolution and the will of the people, their desire for politicians who will fight for the middle class against the greed and corruption of oligarchs, is unstoppable. Bobby is a populist polling at 24%, which equates to 40 million people who would vote for him if the election were held today, and it's just the very beginning."

Ballot access in New York State is difficult without the support of either the Democratic or Republican party. 45,000 valid signatures are required in order to run for statewide office (Governor, Attorney General, Comptroller), or for President.

A few NYS minor parties and organizations have recently attempted to get on the ballot, but were unsucessful last year. Statewide ballot access in New York became more difficult after then Governor Andrew Cuomo convinced the state legislature to change the Election Law and required minor parties to secure 100,000 votes on their line in order to continue to keep their automatic ballot access.

The changes came at the time that actress-activist Cynthia Nixon was challenging Cuomo for Governor on the Working Families Party line. Minor political parties in New York including the Libertarian Party and Green Party did not meet the threshhold and lost their automatic ballot access.

A combination of volunteers and paid staff are required to collect enough signatures for RFK Jr. or any independent Presidential candidate. 45,000 valid signature are required, but as many as 750,000 signatures are needed to avoid a petition challenge.



be cast in the 11/7/2023 North Castle town board election.

"The effort among supporters of DiGiacinto to overturn opposition candidate Joe Rende's legitimate win would have worked if it were not for a challenge to several absentee ballots commenced in Westchester County Supreme Court on November 14, 2023. Investigation into alleged ballot fraud is continuing. Here is a summary of 6 flawed votes that have been discovered so far:

"Vote 1: An absentee ballot was submitted in the name of Supervisor Schiliro's adult daughter, Paulina Schiliro, 28 years old, who left her full-time residence in North Castle in 2017. Paulina worked and lived in Colorado for four years and then moved to New Haven, CT, where she now lives in an apartment with her fiancé and plans to be married in June. Mike Schiliro picked up an absentee ballot form for her which was signed and submitted to be counted as a legitimate vote. However, as copies below clearly show, her signature on the ballot differs vastly from her signature on file at the BOE, calling into question not only her eligibility to vote in North Castle – but also whether she personally signed her absentee ballot. The top signature is a copy of Paulina's BOE voter registration card. The bottom signature is copied from her 2023 absentee ballot. The two signatures are vastly different. When asked in court to identify the absentee ballot signature, Mike Schiliro testified, "That is my daughter Paulina's signature." (See Testimony page 62, line 11).

Mike Schiliro offered questionable sworn court testimony concerning the circumstances surrounding the signing of Paulina's ballot and the legitimacy of her North Castle residency. (See Schiliro testimony beginning on page 53), including that Mike Schiliro both picked up and dropped off Paulina's absentee ballot. Paulina Schiliro was subpoenaed to testify in Westchester County Supreme Court as to the validity of her ballot. However, under a settlement agreement by attorneys for Schiliro, Paulina was not required to testify under oath because Schiliro agreed to withdraw the ballot before it could be counted.

Votes 2 and 3: Absentee ballots were submitted in the names of 2 adult children of Town Clerk Alison Simon: Andie Simon, 27 years old, and Joseph Simon, 30 years old. Both Simon children live predominantly in NYC apartments and work full-time there, which would make it illegal for either of them to vote in North Castle. Furthermore, there are obvious signature discrepancies on the absentee ballots allegedly completed in-person by Joseph and Andie. Signatures of Joe and Andie Simon found on their BOE registration cards were compared with signatures on their 2023 absentee ballots. As shown below, the handwriting styles are vastly different – calling into question the identity of who signed the 2023 ballot.

When Joe was asked about his ballot in court, he testified, "No one touched it but me." (See Testimony page 106, line 3) When Alison Simon was asked about the handwriting on the date of Andie's ballot, she testified, "That's mine." (Testimony Page 84, line 18). When asked if she also dated Joe's ballot she testified, "I don't think so." (Testimony Page 89, line 7). Judge Koba was skeptical, not just because of evasive and conflicting testimony, but also because the error in the position of the written date (circled above), nearly identical handwriting style, and ink pen type appeared to be the same on both Andie's and Joe's ballots. A handwriting expert was retained to analyze the validity of Andie and Joe Simon's ballots. But before further investigation could begin, attorneys for Simon negotiated a settlement under which both questionable Simon ballots were withdrawn. As a result, the two ballots were not opened and therefore not counted.

Vote 4: An absentee ballot was submitted in the name of Giana Poppo, a 24-year-old likely Schiliro family acquaintance. Poppo Lives and works in Los Angeles, California which would make it illegal for her to vote in North Castle. Poppo was subpoenaed to appear in court, but she was able to avoid the process service. The judge disqualified her ballot. Poppo's ballot is one of 4 that were withdrawn, not opened, and therefore not counted which begs the question, "Why would one agree to withdraw a legitimate ballot?" Since all 4 withdrawn ballots were submitted by DiGiacinto supporters, it therefore seems certain that the votes, if opened, would be for DiGiacinto. Had these questionable ballots not been set aside by agreement of the parties – the attempt to flip the election result would have succeeded.

Vote 5: An absentee ballot was submitted in the name of Kevin Decker, a 35-year-old first cousin and close friend of Barbara DiGiacinto. Decker, 35 years old, is the offensive coordinator at ODU in Virginia. Decker lives in Virginia and therefore voted illegally in North Castle. Decker's vote was counted because it was opened before the investigation of absentee ballots began – but Kevin's signature and the legality of his residency will undoubtedly be challenged. The top signature (below) is from Kevin's 2010 registration card on file at the BOE. The bottom is from his 1/24/2023 absentee ballot. As with the Schiliro and Simon ballots – the signature styles are vastly different – calling into question the identify of who signed the ballot.

Vote 6: Larry Ruisi was a candidate for North Castle Town Council, a running mate of Barbara DiGiacinto, and endorsed by Mike Schiliro. He is also a member of the North Castle Planning Board. Larry's 40-year-old son, Jonathan Ruisi, has lived in White Plains for over 10 years. Nevertheless, Johnathan illegally cast his vote in North Castle, in person, which was counted in this election. There is little doubt that an attempt to steal North Castle's election for the office of Supervisor was made using multiple ineligible or fraudulent absentee ballots. Those involved have trampled on one of our most basic constitutional rights – the right to a fair and free election – and they very nearly got away with it. We find it disheartening that disregard for election integrity could happen in our small town, particularly involving senior elected officials who have the power and responsibility to protect the public interest. But in this case, the evidence of wrongdoing is overwhelming and impossible to ignore. Bad acts have consequences.

We are asking Mike Schiliro and Alison Simon to resign immediately. By their own court testimony and review of public records, we believe both have violated their oath of office and lost public trust by acting in disregard of our election laws. North Castle taxpayers should no longer be expected to honor their elected positions or pay their salaries.

Mike Schiliro: Setting aside the questionable signature on your daughter's absentee ballot, by your own sworn court testimony you admit to collaborating with Paulina to submit an absentee ballot even though you knew she was not qualified to vote as a North Castle resident because she moved out of your house in 2017. Making things worse, when confronted with clear evidence that absentee ballots bearing the name of your daughter and of Allison's son and daughter were irreparably flawed, you doubled down. Rather than accepting the suggestion to have the ballots simply tossed out, you insisted on a court hearing in an attempt to have all 4 obviously illegal votes counted – all the while knowing that those 4 votes, if counted, would fraudulently change the election results in favor of your endorsed candidate, Barbara DiGiacinto. You should resign from your position as Supervisor.

Allison Simon: Your office is the Town's liaison to the Westchester County Board of Elections. One of your main responsibilities as Town Clerk is to oversee the integrity and validity of our elections. Based on your own court-sworn admissions, taken together with your children's conflicting testimony and available public information, there is sufficient evidence that you have abetted the submission of invalid and perhaps fraudulent absentee ballots. It is appropriate for you to resign.

Barbara DiGiacinto: We know of no evidence that you manipulated ballot signatures or encouraged ineligible votes to be cast. However, we also doubt that there has ever been a conspiracy to inflate a vote count wherein the beneficiary of the conspiracy was unaware of what was going on. So – If you had any knowledge of the events detailed above, and took no action to stop it, you are also guilty of subverting North Castle election laws and should also resign.

Larry Ruisi: We are wondering why your son would drive from his residence in White Plains to vote in North Castle unless he was prompted to do so. If you were not involved – great. What you decide to do next will be governed by your own conscience," writes Greene.

democratic challenger to Lawler, called Johnson "a wolf in sheep's clothing," by appearing at the fundraiser.

Jones' primary democratic opponent, Katonah school board member Liz Gereghty, announced last week that she was ending her campaign and endorsing Jones. "Uniting our party and focusing our resources on taking back the House is critical to fighting back against the radical extremism plaguing our politics. In that spirit, I endorse Mondaire Jones' campaign for Congress."

Gereghty, whose political claim to fame was that she is the sister of Michigan Governor Gretchen Whitmer, had been critical of Jones far-left progressive views, which she said Congressman Lawler would use against him in the upcoming 2024 campaign.

Lawler commented on Gereghty's withdrawal, saying the fact that "Liz did not find traction in today's Democratic party speaks volumes. Its clear New York Democrats would rather support a "defund the police" and open the borders radical, with one of the most extreme, partisan voting records in Congress and proudly referred to himself as a socialist."

Two years ago, Lawler defeated democrat Sean Patrick Maloney by 1,820 votes out of 285,220 total votes cast.

the city and county level. But how many times he's already stepped in it--in just a single week--raises questions s about whether he's ready for a high-profile primary like this," said one leader in the NY Working Families Party, who has already endorsed Bowman's reelection.

Latimer shook off the critiques and said, "I have not heard any of this from

the people in the district-the people of Westchester who know me and see me in their communities. "I want to offer progressive policies with results -but also to work across the aisle and respect the other side. We don't have to vilify each other. Its how you choose to do your job. That is what I am hearing from my democratic friends in the 16th District." What this comes down to is who can be effective in congress for the people. Let the people make their own choice-

Latimer challenged the notion that Bowman, a sitting two-term incumbent Congressman, should not be challenged. "Four years ago he made the decision to run against Eliot Engel, a sitting Congressman. The people were given a choice then, and to say they can't have a choice now is divisive.

Latimer also pushed back against the belief by some that he cannot or should not

run against an incumbent, black member of Congress. "I'm not black, but I have a record of opening doors for black leadership. I supported Loiz Bronz for Chair of the County Board, and I supported Andrea Stewart-Cousins for State Senate when she first ran. I also picked Ken Jenkins to be my Deputy County Executive."

Some in the media called Latimer's congressional campaign an attempted

"Crucifixion" of Bowman. "As a Catholic, I find it outrageous to use the word Crucifixion about a political campaign. Nobody is being forced to support Latimer and people can make their own decision if they endorse him or me. A lot of Westchester democrats have worked with me for years and I am in most of the Westchester towns and cities in the district 5-10 times a month."

"I plan on campaigning everywhere. I'm not writing off anything and I cede nothing. I represented Yonkers in the State Senate for four years. The question that voters need to ask is who will accomplish more in Congress?"

Latimer recently visited Israel and received a letter from 26 Westchester Rabbis urging him to challenge Bowman. Latimer said that support from the Jewish community is only one part of his coalition. "The idea that I'm someone's puppet is nonsense. I have never been that over my career in public service."

When asked about support for his campaign coming from AIPAC, (American Israel Public Affairs Committee), Latimer pointed out that NY members of Congress, including Rep. Hakeem Jeffries, Gregory Meeks and Grace Meng have all received support from AIPAC. "The majority of my fundraising and support will come from Westchester. His money will come from outside Westchester, from a nationwide network."

Why is the Latimer-Bowman contest the talk of the town in Westchester political circles? "Because they are trying to create a narrative that isn't credible, and they are afraid that someone from "The Squad" might lose a primary. Maybe I'm the guy with the grass roots support from Westchester democrats. He makes great speeches, but what has he done to represent his community? Let us both run on our records."

One more political fact about George Latimer—He hasn't lost an election since 1987. from the Rye City Council -to the Westchester County Board of Legislators-to the NYS Assembly-NYS Senate and two terms as County Executive.

New York State Senator Pete Harckham honored Alex Mandara for his induction into the 2023 New York State Senate Veterans Hall of Fame and commemorated his military service at a special ceremony held on Saturday, Dec. 2, here at the Bedford Hills Community Center, with nearly 50 veterans and several local officials in attendance.

At the ceremony, which preceded a meeting of the Veterans Advisory Council that Harckham hosts semi-annually, Mandara was presented with a special Senate plaque regarding his Hall of Fame induction.

"Alex served his country with distinction and is a respected leader in the Yorktown community, where he continues to make an impact on the lives of his neighbors and fellow veterans," said Harckham. "Through his role at the Yorktown VFW, Alex is a tireless advocate for veterans and their families, coordinating programs and services for them, and ensuring they get the help they may require. It was my distinct honor to nominate Alex for induction as the 40th Senate District's 2023 selection to the New York State Senate Veterans Hall of Fame."

Mandara serves as the Commander of the Veterans of Foreign Wars Post 8328 in

Yorktown Heights, an essential gathering space for the community, allowing veterans to connect with other veterans. He was born on September 11, 1972, in the Bronx, the oldest of 5 siblings, and attended Yonkers public schools. After graduating from Roosevelt High School at 17, he decided to serve his country and enlisted in the U.S. Navy, following in the footsteps of a grandfather who had served in the U.S. Army.

After completing boot camp at Naval Station Great Lakes north of Chicago, Mandara

studied to become a hull maintenance technician, and in 1991 began his service on USS Enterprise, the U.S. Navy's first nuclear-powered aircraft carrier, during the Gulf War. Mandara continued his service on the USS Enterprise for the next five years, finally being stationed out of Norfolk, Virginia. As a member of the U.S. Navy Reserve, Mandara spent 22 years serving on the USS Ogden, an Austin-class amphibious transport dock, and traveled around the world.

After the September 11th attacks, Mandara spent many long days searching through rubble of the World Trade Center's Twin Towers until he was called to active duty.

Mandara and his wife Annamaria moved to Yorktown in 2005, and three years later their daughter Gianna Maria Mandara was born. Mandara retired from the U.S. Navy Reserve in November 2012 and started working for Entergy Nuclear at the Indian Point Energy Center, where he remains a part of the security operations at the site. He also works as an umpire for Westchester's Section 1 High School Baseball and regional travel leagues.

"As I noted in my retirement speech (from the Navy), we retire but we never get out," said Mandara after accepting his award from Harckham. "My wife and I enjoy working and helping out other veterans. It's a natural progression to serve in the military and then continue to look for other ways to serve."
