Con Edison Lifts Natural Gas Moratorium Increased Supply Ends 4 1/2 Year Ban

In a letter to the NYS Public Service Commission, Con Edison announced that as of Dec. 1, their natural gas moratorium for new development connections in Westchester has ended. Con Ed began the moratorium more than four years ago, on March 15, 2019, to "address a supply-demand imbalance and support reliability of service to customers in the affected area," according to the letter, continued below.

"As of November 16, 2023, a combination of lower peak demand forecast and increased supply resulting from the Tennessee East 300 Project coming online resolves the Westchester supply-demand gap, eliminates the need for any delivered services in later years, including near-term elimination of the need for compressed natural gas to support the moratorium region's peak demand, and generally supports reliability of gas service throughout our service territory.

"Con Edison's support for the Climate Leadership and Community Protection Act's clean energy goals remains steadfast, as outlined in our Company's Clean Energy Commitment. In alignment with our Commitment, the Company has been actively promoting non-fossil alternatives (i.e., electrification) through various marketing communications/channels and will continue to do so even though the moratorium is being lifted.

"We provide electrification education and solutions for customers in which we encourage them to consider full-electrification options. We also give them information about subsidies and incentives, rate options, contractors who perform relevant work, and other programs that will enable them to adopt electric heating technologies, like heat pumps, before they submit a gas service application.

Latimer Visits Israel & Will Announce Run for Congress Against Bowman

Westchester County Executive George Latimer recently returned from a three-day trip to Israel with several other Westchester elected officials to view the aftermath of the October 7 attacks by Hamas. The trip was sponsored by the Westchester Jewish Council and UJA.

During the trip, Latimer met with Israeli President Isaac Herzog, and Israeli families waiting for their relatives held hostage to come home. Latimer and the delegation, which included Assemblywoman Amy Paulin, BOL Chair Vedat Gashi, County Legislator Margaret Cunzio, and New Rochelle Mayor-elect Yadira Ramos-Herbert. also visited a hospital and a kibbutz.


Latimer was clearly moved by the trip and the plight of the Israeli people. But he also pointed to the right of every American to protest their own country.

Latimer spoke about the crisis in the middle east and how lucky we are in the United States. His lengthy comments during his weekly address about the history of antisemitism and the Nazis only underscored the belief of many, that he is planning a run for Congress against Congressman Jamaal Bowman.

"President Biden has a policy towards Israel and I am well aware of the protests. I don't have a George Latimer plan for peace, but history will repeat itself if we do not understand the lessons that it teaches us," said Latimer who made no comments about a possible run against Bowman, except to say, "I've got a lot to think about."

Putnam County Executive Byrne Puts Taxpayers Before Politics

Cuts Taxes in Budget for first time in 25 years; Property tax rate lowest in 15 years-with no borrowing

Also Vetoed County Board Pay Hike and Eliminates Sales Tas on Clothing Under \$110 for Two Years

Putnam County Executive Kevin Byrne has taken measures to reduce costs to the taxpayers of Putnam County by cutting the budget for 2024 which reduces property taxes, and without any borrowing.

Byrne has also vetoed a salary increase for Putnam County Legislators and eliminated the Sales tax on clothing and footwear under \$110 for two years.

"At a time when our residents are still struggling because of rampant inflation, county government must do its part to help out," said County Executive Byrne. "Sales tax on needed goods like these are inherently regressive, disproportionately harming those most economically vulnerable. To many residents, that 4% tax on a new pair of shoes doesn't seem like much, but to the single mom it could mean being able to afford an extra onesie for her child."

The two-year sales tax exemption will begin on March 1, 2024 and is expected to equate to a \$3 million per year tax cut. During that period, Putnam County will evaluate the exact fiscal impact to the county and will have the option to renew the tax cut in 2026.

Byrne continued, "New York State already doesn't charge sales tax on these items under \$110. So, with absolutely no sales tax being charged, this is

Mamaroneck HS Senior Daniella Maresca Named Con Edison's Scholar-Athlete of the Week

Local artist Brian Arditi's successful showcase in the Yeager Community Room in the Bronxville Library has been extended through December, showcasing his multi-disciplined works. This was Arditi's first solo show in 15 years. Brian's father, also an artist, passed away in 2022. At the time of his father's death, he was confined to his bed due to COVID-19 and unable to grieve with his family.

In addition to the actual pieces in this debut, Brian has also included written and displayed insight into the specific inspirations behind each work, which essentially serves as a poetic tour guide throughout the exhibit and, according to many, leaves them feeling inspired.

Arditi developed new techniques in animal sculptures and explored primary colors and their beautiful possibilities. This extended flurry of inspiration also led to a fascinating approach involving acrylic embellished nature photography, all taken on Brian's many trips to our country's National Parks.

Nature has always been a muse for Brian, and he loves finding new ways to be inspired by and represent it in an artistic arena. The response to Random Wonder has been impressive, with more than 20 pieces sold, to be replaced by new work. The artist hopes to parlay this massive show into "who knows what?"

Free Bee Line Bus Fares in Westchester for Holiday Season Through Jan. 1

Following two summers of free fares, Latimer announces the second

consecutive holiday season of suspended Bee-Line Bus fares

Westchester County Executive George Latimer once again taking action to ease the burden on Westchester residents' wallets this holiday season as Bee-Line Bus fares will be suspended from December 16 until January 1, 2024. The fare suspension will also apply to the County's ParaTransit system. This is the fourth time – and second consecutive holiday season – that Latimer has taken this action

Latimer said: "In the spirit of the season, we are once again easing the financial strain on Westchester residents. Suspending Bee-Line Bus fares during the holidays is a testament to our commitment to enhancing the lives of those we serve, made possible through responsible fiscal management."

During the Summer 2023 fare free program, average weekday ridership increased by about 22% compared to the weeks before that, while average ridership on weekends was closer to a 40% increase.

Commissioner of Public Works and Transportation Hugh Greechan said: "County Executive Latimer's strategic fiscal management has paved the way for initiatives that directly benefit our community. Suspending Bee-Line Bus fares is not just a seasonal gesture but rather a testament to our commitment to improving accessibility for our riders."

The Bee-Line is Westchester County's bus system, with convenient service connecting residents to jobs, recreation, shopping and other regional transportation services. It is the second largest transit bus fleet in New York State, operated by the County's Department of Public Works and Transportation (DPW&T).

Over 65% of all Westchester County residents are within walking distance of a Bee-Line bus route, making the bus both close and convenient. The system has over 3,300 bus stops and almost 60 routes. All Bee-Line buses are accessible, and designed with many accessibility features including "kneeling" buses, ramps and lifts.

Westchester County Health Department Offers Residents Free Flu Shots in December

Flu Vaccine Clinics Open to All Ages December 13 and 20

With flu season officially under way, the Westchester County Department of Health will offer free flu shots by appointment this month to encourage residents to stay healthy.

Flu shots will be given for ages three and up on Wednesday, December 13 and Wednesday, December 20 from 2:30 to 6:30 p.m. in the Community Room at the Yonkers Riverfront Library, 1 Larkin Center. Appointments are highly encouraged and can be made at www.westchestergov.com/health. Walk-ins will be accepted while supplies last.

Flu shots also will be given to residents ages six months and older at Health Department clinics by appointment, on Thursdays in Yonkers and on Fridays in White Plains, from 8:30 a.m. to 4:30 p.m., while supplies last. For appointments, go to https://health.westchestergov.com/. You also can find a flu shot near you at https://www.vaccines.gov.

Flu and other vaccines are also available at no charge for uninsured and underinsured adults and children through the Vaccines for Adults and Vaccines for Children programs at Health Department clinics. Call 914-995-5800 weekdays before 4:30 p.m. to discuss eligibility. To reach residents who have difficulty accessing flu shots, the Health Department is giving flu vaccines at some soup kitchens and homeless shelters.

Health Commissioner Sherlita Amler, MD, said: "As the holidays rapidly approach, now is the best time for everyone six months and older to get an annual flu shot. Fully effective after two weeks, the vaccine will protect you and all your vulnerable family members and friends. With new variants circulating, it is prudent to schedule both flu vaccines and COVID-19 vaccines for your whole family. Vaccination protects those around you who are more vulnerable to complications, such as infants too young to be vaccinated, seniors and people with chronic health conditions."

In the U.S., there are usually more flu cases between December and February, but flu can linger into May. One flu vaccine now provides protection all season long and can prevent illness or reduce the severity of flu symptoms.



We continue to adjust our offerings to accelerate adoption of clean heating solutions. Currently, homeowners are eligible for rebates of \$10,000 for air-source heatpumps (a promotional increase from \$8,000 through the end of 2023) and up to \$35,000 for ground-source heat pumps. As of the date of this letter, most ground-source heat pump jobs, and a significant percentage of air-source heatpump jobs, occur in our Westchester service territory. We also are exploring new technology, such as a utility-owned thermal energy network pilot project in Mount Vernon designed to serve up to 76 buildings – a combination of homes, apartment buildings, businesses, and government and community buildings –via a district geothermal network in a disadvantaged community.

Con Edison is actively ushering in the clean energy future. However, the Company has an obligation to serve once sufficient capability to provide reliable gas service becomes available. The Company will communicate with stakeholders and will also contact customers on the gas service interest list."

I read a book last weekend that I started early Saturday morning and read straight through until Sunday at 1:30 a.m. The book is A VIEW FROM THE MOUNTAINS-A Catskills Memoir by Patti Posner published by Hotel Brickman Publishing in Weaverville, North Carolina 2023.

I wrote a review of the book and it was on Facebook Monday night. When I awoke Tuesday morning the response by people throughout the United States was phenomenal. One of those who wrote me suggested that as there is so much trash published today, the book is quite unique and a perfect gift for the holidays, a time of year when we are all running around looking for gifts for those we love and having a hard time finding something special.

Amazon has the book for \$14.65 with an E-book version for \$10. Perfect stocking stuffer or to put with gifts next to your menorah or Kinara. A quick but enticing read. And you don't have to be a 'Catskills Kid' to enjoy it.

So I thought I would share my review with our Rising Media Group WESTCHESTER readers. Many of you spent time enjoying the beauty of the Catskill Mountains and stayed at the myriad of hotels that ran the gamut from Resorts like Hotel Brickman to 'cook-a-lanes' (not sure of the spelling) which consisted of nothing more than a hut with rooms, no amenities of the big hotels where you would 'cook' your own meals for your family.

First I will share with you a brief description of the book and topic for those who don't know what a 'fa-La-ta' danish is (a danish taken from the resort breakfast table 'for later.' Then I will share my review and comments on the resort (think the movie Dirty Dancing and the hotel where it took place) that I shared with the author and on Facebook. I'll conclude with some memories I think you will enjoy.

THE BOOK: Much has been written about the Catskill Mountains resort experience as enjoyed by untold numbers of first- and second-generation Jews who, in the early part of the 20th century, had been shut out of many other resorts because of anti-Semitism. While the hotels were indeed as wonderful as many novels and histories describe them, this book is different. It tells a sometimes piercingly honest story of the family that ran the Brickman, one of the most successful Catskills resorts. It is a tale of blood ties as strained by a sometimes ruthless business, explosive secrets, sex and drugs. But this story also is about a deep familial love, hard work, commitment and a winding path to self-knowledge. Patti Posner, daughter of one of the two brothers who ran the hotel, reveals (and thus preserves) the day-to-day life and inner workings of this now vanished world of hospitality, along with the human story behind it all.

MY REVIEW AND COMMENTS: Patti Posner Daboosh it's rare that I wake up in the morning, start reading a book and finish it and look at my watch and it's 1:30 a.m. the next day! I truly enjoyed your book and it brought back beautiful memories and tears to my eyes.

My parents, my sister and I spent a wonderful week every summer at Brickman. We got to the hotel as one summer we thought we had reservations at one hotel but they had overbooked. Dad's friends who spent dawn to dusk on the golf course always raved about the Brickman. We pulled up, you had a room, we took it but my sister was not happy that we were not going to our original hotel and would not leave the room. Dad spoke to Larry Strickler (Director of Activities) who sent a teen counselor to talk with her. She came down for dinner, got immersed in activities and as they say the rest is history!

I spent the days with my parents even though they had heard of your wonderful day camp. I had just spent 8 weeks at home at day camp and wanted no part of more. We participated in the wonderful activities outlined on a sheet every day, but as for dad, mom and their little boy, me give us that fresh country air, sunshine, a chaise lounge and the big Brickman outdoor pool and we were content, even the last week in August when the pool at times could be chilly.

Dad told me One of the Posner brothers (the owners) told him it was cheaper to feed non-Jews than Jews as non Jews didn't realize you could have as much from the menu as you wanted. Was the linguini in perch sauce really perch sauce or was it clam sauce. Two things til this day I wonder about!

We truly had the time of our lives at Hotel Brickman. Thanks for the memories and again, great job on the book. I learned through it that there is much more to operating a hotel than herring and cream sauce!

Westchester Jews for Jamaal Letter Sufaces Asks Latimer Not to Run for Congress

A letter from several Westchester Jewish residents in support of Congressman Jamaal Bowman asks County Executive George Latimer not to challenge Bowman in a democratic primary next year. Latimer has made no official announcement but a recent trip to Israel and a "premature" FEC filing indicate that Bowman-Latimer '24 is coming.

The two-month-old letter, which we first read in Black Westchester on Dec. 1, link – https://blackwestchester.com/jews-for-jamaal-send-letter-to-george-latimer/ was in

response to a letter from several Westchester Rabbis urging Latimer to run against Bowman.

The letter states- "Dear Mr. Latimer: We are Jewish residents of Westchester living in the towns and cities of New York's 16thCongressional district. While many of us are active in a variety of political and civic organizations, including the Democratic Party, the Working Families Party, Indivisible, and a range of Jewish groups and synagogues, we are writing to you today in our personal capacities, to urge that you NOT run for Congress.

For over three decades, our district (though in slightly different form) was

represented by a Democrat (Rep. Eliot Engel) who grew out of touch with its changing demographics and who took increasingly right-wing positions on a range of topics—supporting the "war on crime," voting to deregulate the banks, and backing George Bush's mistaken invasion of Iraq.

As Israel's governments became more and more rightwing, he stood by them unquestioningly, failing again to notice the changing attitudes of many in his district, including among Jews. Three years ago, Jamaal Bowman defeated Eliot Engel in the Democratic primary by 55.4% to40.6%, demonstrating that his progressive approach was more in tune with the values of the district's voters. In 2022, he again won the primary by a similar margin, showing that he is quite popular with our district.

We are aware that a group of rabbis in our district have called on you to run against Congressman Bowman in next year's primary. While we have great respect for the role that all our rabbis play as spiritual guides and community stewards, we question their political judgment

As Jews active in the civic life of our district, we have been and remain tremendously supportive of Congressman Bowman. He is, as you are, a champion of the core Democratic values of prioritizing the needs of the weakest and most downtrodden, a fighter for public education, health care, labor and the environment, and a strong advocate for the communities of Westchester. He is a constant presence in the district and open to dialogue with all.

We also support Congressman Bowman for his honesty and consistency in supporting global human rights and for his clear support for Israel as a Jewish and democratic homeland. He is not "anti-Israel." and to refer to him that way is to deliberately distort his record, which includes many votes in favor of military and economic aid to Israel. He has also supported appropriate and fair efforts to oppose Israeli settlement expansion, annexation, and violations of Palestinian human rights, all in pursuit of peace and security for all Israelis and Palestinians.

Westchester Jewish community which is not at all monolithic. Congressman Bowman's comments on the current conflict merely echo comments in Israel and the U.S. by many leading Jewish commentators and scholars as well as many American rabbis, none of whom are "anti-Israel."

The rabbis urging you to challenge him represent only one segment of the

We are dismayed to see these rabbis, who are usually so careful with their words, not only distort his past record but also twist his clear condemnation of the October 7 Hamas terrorist attack into a false assertion that he blames Israel for it.

Here's what he actually said on October 7 in the wake of Hamas's attack: "I strongly condemn the horrific attacks by Hamas and am saddened by the loss of precious lives, especially on the holy day of Simchat Torah. We need a way to end this deadly violence that is killing and traumatizing generations of Israelis and Palestinians alike including the blockade of Gaza. I have been to the Gaza border and know that Israelis and Palestinians are constantly living in fear. We must work harder to ensure peace in the region."

The brutal attack of October 7 has shocked and traumatized all of us in the Jewish community, and we appreciate the statements of support that have come from across the political spectrum, including from you. You have been a Democratic champion throughout your career and as our *c*ounty executive. But we urge you to resist any temptation to primary Congressman Bowman, who is also a popular Democrat who is clearly aligned with the voters on so many issues, a great representative for all of us and particularly the Black and Brown communities that make up a majority of our district. A primary between the two of you would be needlessly wasteful and terribly divisive, especially at a time when all Democrats need to stand united against the rise of MAGA demagogues and authoritarianism.

Former NRPD Cop Gets 1 Year Probation for Stealing \$24K from Autistic Non-Profit



On Dec. 1, Westchester County District Attorney Miriam E. Rocah announced today that the co-founder of Christopher's Voice, Inc., a New Rochelle-based charity for autistic children, was sentenced after pleading guilty to stealing approximately \$24,000 from the not-for-profit organization named after his son.

DA Rocah said: "After stealing money for more than five years from a charity he founded, this defendant has admitted his wrongdoing. Thanks to the hard work of our Public Integrity and Law Enforcement Integrity Bureau this defendant is being held accountable for his criminal conduct and betrayal of trust. We were able to secure the return of the stolen funds and insured that they will be used to support a reputable organization that helps children in need."

The defendant, Christopher Greco, 52 of New Rochelle, a 25-year veteran of the New Rochelle Police Department who retired in August 2021, pleaded guilty on Nov. 29 before Judge Eileen Songer McCarthy in New Rochelle City Court to Petit Larceny, a misdemeanor. The defendant was sentenced to a one-year conditional discharge.

Voice, Inc., and was required to transfer the charity's remaining funds of \$49,750, which includes the restitution, to Elizabeth Seton Children's Foundation, a Westchester-based nonprofit that provides long-term care for children with severe medical conditions.

The defendant is also required to file for the dissolution of Christopher's Voice,

As part of his plea agreement, the defendant paid full restitution to Christopher's

Inc., with the New York State Attorney General's Office, and is further prohibited from performing charitable activity and accepting any charitable donations while awaiting final dissolvement of the organization.

The defendant admitted in court that he spent money intended for Christopher's Voice, Inc., on himself and his family for personal purchases made between Jan. 1, 2018

and May 31, 2023 in the form of debit transactions, cash withdrawals and checks written to himself.

The Westelnester County District Atternation Office arrested the defendent on South

US Attorney Charges Perry Freeman with 2021 Fentanyl Death of Brian Cobb in Yorktown

Perry Freeman Charged with fentanyl distribution resulting in death of Brian Cobb in Nov. 2021

On Dec. 4, US Attorney Damian Williams, Frank A. Tarentino III, the Special Agent in Charge of the New York Field Office of the Drug Enforcement Administration ("DEA"), and Robert Noble, Chief of the Yorktown Police Department, announced that PERRY FREEMAN was charged with distributing fentanyl that resulted in the death of a victim and illegally possessing ammunition. FREEMAN was arrested and presented today before U.S. Magistrate Judge Andrew E. Krause.

The arrest of Freeman dates back to Nov. 10, 2021, when Freeman sold Fentanyl to Brian Cobb in Mohegan Lake. Cobb was in his car when, after he took the Fentanyl, he passed out with his foot on the gas pedal. The car caught on fire and Cobb was pronounced dead.

The Westchester County Medical Examiner's Office found the cause of Cobb's death to be acute fentanyl intoxication and accident.

U.S. Attorney Damian Williams said: "As alleged, Perry Freeman sold fentanyl to a victim who died a horrific death shortly after taking the drugs. Investigators concluded that the victim parked his car and, with his foot on the gas, passed out from ingesting lethal levels of the drugs allegedly provided by Freeman. The engine sparked a fire that engulfed the vehicle and burned the victim's body. We also allege that Freeman regularly sold fentanyl to a confidential informant and warned the informant to be careful with the drugs, indicating he knew how unsafe his product was. This Office will not rest until those who peddle this poison have been brought to justice."

DEA Special Agent in Charge Frank A. Tarentino III said: "Data doesn't lie, and law enforcement continues to track fatal fentanyl poisonings to the person responsible. This arrest is an example of DEA and our law enforcement partners' efforts to thwart more drug poisonings and bring to justice those responsible for causing the most harm to our communities. I commend the men and women of the Yorktown Police Department, the DEA's Westchester Resident Office's Tactical Diversion Squad, and the U.S. Attorney's Office for the Southern District of New York for their tenacious work on this investigation."

Yorktown Police Chief Robert Noble said: "It is good for our community to see their local police department request assistance from federal agencies like the DEA and the U.S. Attorney's Office for the Southern District of New York and have it culminate with the arrest of an alleged dangerous drug dealer. I commend the determination, intelligence, and teamwork demonstrated throughout this investigation. Yorktown is a law and order community. We'll continue to work hard, share information, and work shoulder to shoulder on our streets with all of our partners in law enforcement to keep it that way."


The unsealed criminal complaint states that Perry Freeman, aka Perry Darrell, sold Heroin both before and after the death of Cobb to an informant in 2021 and 2022. A search warrant of Darrell's apartment, 3469 Lexington Avenue found drugs and shotgun shells

Due to the fact that Freeman had previously been arrested 5 times for Criminal Possession of a Controlled Substance, attempted robbery, and possession of a weapon, he was not allowed to possess ammunition.

Freeman, 37, of Mohegan Lake, New York, is charged with one count of fentanyl distribution resulting in death, which carries a minimum sentence of 20 years in prison and a maximum sentence of life in prison, and one count of illegally possessing ammunition as a convicted felon, which carries a maximum sentence of 15 years in prison.

Mr. Williams praised the outstanding work of the DEA and the Yorktown Police Department.

significant because for the first time, it's going to be cheaper to shop here for clothes and shoes in Putnam County than it will be to go to neighboring Connecticut.

Byrne opposed pay raises for all politicians in first year, including himself. The Legislature submitted pay raises for themselves prior to budget meetings which shielded their salary adjustments from an executive veto. Byrne vetoed all other pay raises for politicians that had been added by the Legislature, but the Legislature overrode Byrne's veto with the minimum 6 votes required, but Byrne still honored his commitment and did not take a raise in pay in his first budget (2024 Budget).

"This is what happens in a healthy democracy supported by a system of checks and balances. I used my veto power as a check on the Legislature to fulfill a commitment I made to freeze pay raises for elected officials in my first year. The Legislature exercised their check to override my decision as County Executive," said Byrne.

"Residents are still facing real economic hardship whether it be from inflation, high interest rates, or unaffordable housing. Overall, the Legislature and I agreed on over 95% of what this budget should include. We worked together to reduce property and sales taxes, while still delivering services our residents have come to rely on and made record investments in infrastructure improvements and mental health services.

"This Administration's mission remains the same— with a detailed focus on delivering top notch services as we continuously work to make Putnam County Government more affordable, accountable and accessible for our residents. And, I realize we have more work to do.

"We're working to negotiate contracts with the four collective bargaining units that represent our public employees, and I simply find it unfair to grant pay raises to elected officials who negotiate or vote on these same contracts before an agreement is finalized. It's clear six legislators disagree.

"The people of Putnam County should know their County Executive stayed true to his word and did not take a raise," said Byrne.

The Putnam County Budget was reduced to the lowest level in 15 years. "The budget my administration presented is one that represents a concerted effort to better control and prioritize county spending, lower the property tax rate, and reduce the overall tax burden, all with no new borrowing. I thank Chairman Jonke and appreciate the Legislature's efforts toward demonstrating greater fiscal conservatism and discipline. As I've stated numerous times, no savings is too large or too small for our county to take advantage of."

Byrne and legislators were able to give taxpayers a reduced, overall tax burden for the first times in 25 years. "I promised residents that we'd take advantage of every opportunity presented to us. We will continue to seize opportunities that provide for a more affordable, accountable, and accessible county government that serves us all. This budget, as currently being presented, continues to deliver on that promise."

Before Latimer's weekly address, a document from the FEC (Federal Election Commission) circulated in the media in which Latimer signed a statement of candidacy for Congress in the 16th District of NY, currently held by Bowman.

Some called the FEC document premature, while others predicted a Friday Dec. 8 announcement. But the cat was out of the bag, and in a Politico story, Latimer touted his record as County Executive, calling Westchester County government under his leadership "the most progressive" in New York.

"We've cut taxes and reduced crime, but we've also made the buses environmentally friendly," Latimer said. "We've done Black maternal health; we've built recreational communities in the heart of poor communities. I've done a ton of things that represent progressive government"

Latimer, who just turned 70, said to Politico Bowman "has been in Congress for three years, and I've done a bunch of things over the past three decades." "Right now, in Congress, a lot of it is showtime down there. A lot of it is posturing and culture wars."
