Democrats Oppose Hochul's Plan to Allow More Charter Schools and Ban Menthol Cigs,

Governor Kathy Hochul released her budget plan for New York State last week. The \$227 billion spending plan for the 2024 fiscal year is a 2.3% increase from last year. Two items in Hochul's budget plan drawing criticism from NY Democrats are her call to ban Menthol cigarettes in NY State, and her call to revise the Charter School requirements to permit more Charter schools in New York City.

California and Massachusetts are the only other two states to have banned Menthol cigarettes. The Westchester County Board of Legislators passed a ban on Menthol cigarettes last year by a vote of 11–6, but County Executive George Latimer vetoed the ban.

Opposition to Hochul's proposed ban, which also includes all flavored tobacco, is drawing the same opposition, and arguments, heard in the debate in Westchester.

Yonkers Assemblyman Nader Sayegh called it, "harsh legislation," and "Unjust." "It's not equitable to say: 'Stop smoking hookah but you can go smoke pot."

Sayegh, a Jordanian-American, said that Hochul's plan would end many hookah bars in Middle eastern communities in New York City and Yonkers. "I enjoy smoking hookah – I don't abuse it – once in a while. It's very enjoyable. It's a cultural experience."

Supporters of the menthol ban include New York NAACP State president Hazel Dukes, who testified in White Plains last year. "I'm glad Gov. Hochul is taking up the cause. This tobacco ban is on the NAACP's legislative agenda,"

Hochul's spokeswoman Hazel Crampton-Hays said, "With commercial tobacco use the leading cause of preventable deaths, Gov. Hochul is leading the way to a tobacco-free generation to reduce youth smoking and prevent senseless deaths. As with any budget proposal, we will work with the legislature on the final details for the best way to protect public health.,"

No word yet on the opinions of State Senate Majority Leader Andrea Stewrt-Cousins, and Assembly Speaker Carl Heastie on this issue

The other Hochul proposal that has brought even more fervent opposition is

her proposed modification of New Yorks Charter School law. There is currently a cap of 460 Charter Schools in NY, but only around 360 are open and operating.

72 Year Old Charged With Felonies for Stealing Nude Student Art From SUNY Purchase

Last December, we reported about a mystery man sneaking onto the campus of SUNY Purchase and stealing works of student art. Almost all of the art stolen were nude paintings and drawings."

The thefts went on for more than two semesters, with students complaining about their final art projects stolen. We contacted the State Police and the SUNY Purchase Campus safety, and put this man on the front page of our papers and online. Purchase students were also posting photos of this man on Reddit.com

Now we are happy to report that an arrest has been made in this case. This statement from Dayton Tucker, Chief, State University Police Purchase College. "Frank Filippone of Fairfield, Connecticut was arrested by the State University Police as a result of a burglary investigation into several thefts of student artworks and equipment. The thefts began in April of 2022. Filippone was arraigned at Harrison Town Court Yesterday.

"I commend the efforts of our Criminal Investigator, Police Officers, and Communications Officers for bringing this case to resolution. The team spent hours scoring through on and off-campus video and working with surrounding law enforcement agencies to identify the suspect's vehicle in connection with the crimes. Special thanks to the students and staff that cooperated and assisted with the investigation.

"Additionally, I am proud that we will soon be able to reunite students with artworks that have been recovered as a result of this arrest. We felt the pain of the Visual Arts community, and we are happy to bring this closure," said Chief Tucker.

We were able to obtain copies of the legal documents and charges in the matter of People v. Frank Filippone. There are a total of six charges filed against him. Filippone was arraigned on Thursday, 2/2/2023 after business hours by the

150 Cats & Two Dead Found in Yorktown Home

On Jan. 30, Yorktown Police responded to a home at 149 Cordial Road for a welfare check. Before entry, members of the YPD were able to look into a window, where they found 150 cats. Eventually, a man and a woman in the 50's were found dead in the bedroom. Those individuals have not yet been identified, nor the cause of death. Foul play is not being considered.

The Westchester SPCA immediately got involved to assist in the safe removal of some of the cats. It took them a few days to find temporary shelter for the cats, but they got the word out, asking for donations to help in the effort. "This week SPCA Westchester undertook the largest rescue in our history. The SPCA's Humane Law Enforcement (HLE) received an urgent call from Yorktown Heights police to assist at a horrific scene where 150 cats were discovered living in filth and squalor and being hoarded inside a small dilapidated home.

"When police were asked to perform a wellness check on the homeowners, they were found deceased inside the residence. Officials were unable to clear the scene until the SPCA's rescue team members removed a majority of the cats, who were found trapped in every room of the home, including the walls and ceilings. The conditions were absolutely horrific.

"After years of neglect, all of the cats, who appear to be Abyssinian mixes, are sick and suffering with upper respiratory, eye and skin infections, malnutrition, dehydration, and sadly, some have more severe injuries that require immediate medical attention. Due to the stress of the situation, one of the cats actually gave birth while in transit from the residence to the SPCA's Rescue Center, and many others appear to be pregnant. All of the cats were starving upon rescue and had likely not eaten or had access to water in many days.

"Our newest rescues desperately need your support. Even after all that they've been through, the cats are incredibly sweet and just want to be loved. A gift at any level will support their veterinary care and rehabilitation, which we anticipate will cost well over \$40,000.

The Courts, Not the Politicians, Will Decide the Future of Par 3 Course

As the Yorktown Town Board moves forward with a plan to award an RFP to a new contractor to finish the work that was 90% completed by RC Recreation Development LLC, a new injunction has been filed against the town moving forward with anything until the courts and a judge rules on whether RC are entitled to damages, or they are entitled to complete the work and open the golf course to the public.

"There has to be a court hearing between RC and Yorktown before anyone plays golf at the course that I invested millions in, and years of my time. This golf course will not be open this year, or in 2024. It will take years to litigate all of the breaches of contract, due process violations, and individual NYS constitutional violations to RC, the illegal eviction, and all of the individual suits. And there are other suits against individuals coming," said RC President Larry Nussbarren

Before the recently filed injunction, RC has filed individual lawsuits against former Supervisor Matt Slater, Town councilman Sergio Esposito, and Building Commissioner James Landi, which also must be ruled on by a judge.

Any decision made by the Town Board is premature, or wishful thinking for all of us who want to play golf at the redesigned 9- hole layout, which golfers who have walked the grounds call "a masterpiece."

"Matt Slater promised the residents of Yorktown that his strategy was the fastest way to get the golf course open. The courts will decide when this course opens and when the residents will be allowed to play," said Nussbaum.

In a nationally released statement, Nussbaum and RC announced their injunction against the Town. RC Recreation Development, LLC filed an order to show cause bringing on its motion for the appointment of a third-party Receiver and for a preliminary injunction seeking to protect the substantial value of the structures, fixtures, and equipment RC Recreation paid for and installed at the Valley Fields Golf Course. On January 25, 2023, RC Recreation filed its First Amended Combined Verified Petition and Complaint against the Town, former Supervisor Matt Slater, and Town Board member Sergio Esposito, asserting some



At first everyone thought it was a joke. Nova, a 25-pound clouded leopard was taken or allowed to escape through a hole cut in the heavy metal mesh of her enclosure at the Dallas Zoo. A police SWAT team was dispatched to the scene. Police drones were flown overhead. Within hours Nova was found and reunited with her sister, Luna.

Police noticed a similar cut to an enclosure that held langur monkeys, but none of them were missing.

Next it was Pin, an endangered lappet faced vulture who turned up dead, apparently by an injury described by the authorities as a 'wound.' As these are exotic, rare animals Federal agents joined the case.

Theories flew left, right, backwards and forwards. Was it a disgruntled zoo-keeper? International exotic animal traffickers? A mysterious looking man was scene on zoo security cameras eating Doritos. The Dallas Police installed it's own camera towers to keep watch.

Nothing stopped the person or those involved from continuing their escapades. Next it was two emperor tamarin monkeys, escaped or removed through a hole in the mesh. The pair were found boarded up in a home next to a church 15 miles south of the zoo.

Who was involved? Who was playing games endangering the lives of these animals? The man eating Doritos was observed in a Dallas aquarium three miles north of the zoo. Was he an 'International Animal Trafficker?' Nope, a man with a crazy obsession.

Texas is known as among the top states in the country for exotic animal ownership. The state also has vast undercover trade in these exotic animals, most of which are barred by law from being bought or sold.

New App Saves ConEd Customers Money and Helps the Environment



Meltek.io/ -- A Brooklyn-based climate tech startup called Meltek has launched a free mobile phone app that ConEd customers can use to save money and reduce pollution. ConEd and Meltek will pay New York City and Westchester County residents and small businesses to save electricity during peak demand hours, such as on the hottest days of summer.

For many years, large commercial and industrial electricity customers have been able to participate in Consolidated Edison's "demand response" program, through which ConEd pays them for reducing electricity usage during a set of hours that they are alerted to, often a day in advance. But today, Meltek, a demand response "aggregator," is changing that by providing these ConEd incentive payments to area residents and small businesses through a new iPhone® and Android™ app. ConEd funds the reward payments because the payments save money for the utility compared to the cost of providing peak-demand electricity, and the reduced load improves the electrical grid's reliability.

All 3.3 million Con Edison customers (residences and businesses) are eligible to sign up for Meltek's free service by downloading the *Meltek app in the Apple App Store® or on Google Play or by visiting app.meltek.io.*

Once a user signs up with Meltek and connects their ConEd account number, Meltek can send easy-to-follow text or email alerts, letting them know when they can earn money by postponing large appliance usage, such as washing machines and dishwashers, adjusting thermostats (including pre-cooling their home/business before the demand response window), switching off lights, or unplugging electrical devices. The exact ways of saving electricity are up to the customer, and ConEd and Meltek have structured the demand response program so that no customer can lose money by signing up (for free) with Meltek. Signing up with Meltek does not change a customer's electric service provider or otherwise alter the relationship with Con Edison.

The electricity produced during peak hours by so-called "peaker" power plants is often the most polluting and carbon-intensive, so the energy savings also reduce air pollution in local communities and combat climate change.

Peaker plants, which are expensive to maintain and typically emit a lot of pollution due to their age and use of fossil fuels, have a detrimental impact on environmental and air quality in New York. Using these power plants on hot summer days to meet air conditioning demand can exacerbate poor air quality conditions in nearby communities. Within ConEd territory, there are fifteen oil- or gas-fired peaker plants, stretched across all five boroughs of New York City.



DiNapoli: Thruway Authority Toll Increases Should be a Last Option

NYS Comptroller Tom DiNapoli issued a report and the following release about proposed toll increases for the NYS Thruway Authority.

The New York State Thruway Authority (Thruway) has proposed a multi-year schedule of systemwide toll increases to begin in 2024, but a new report from State Comptroller Thomas P. DiNapoli identifies concerns with the proposal and urges the Thruway to first improve its operations and maximize non-toll revenues. DiNapoli's office reviewed a decade of the Thruway's finances and the toll hike proposal and found gaps in essential information necessary to evaluate the proposal.

"The Thruway Authority's toll increase proposal comes at a time of extraordinary challenges for New Yorkers who are faced with rising costs for everything from food to shelter to gas," DiNapoli said. "The Thruway should be more transparent with the public and disclose critical information, and identify and put in place all possible cost-savings and alternative revenue actions to minimize costs to drivers. Raising tolls should be the last option, and the Thruway has more work to do."

In December 2022, the Thruway's Board of Directors began the process of implementing a multi-year schedule of systemwide toll increases. The proposal calls for higher toll rates that would take effect on Jan. 1, 2024, and again on Jan. 1, 2027, for the highway system and barriers, and annually over four years beginning in 2024 for the Governor Mario M. Cuomo (Cuomo) Bridge. It also expands the rate differential between New York-issued E-ZPass users and all others. The toll increases are expected to grow toll revenue by 28.4%, or \$1.9 billion, through 2031. The last toll hikes occurred in January 2021, when tolls were increased for the Cuomo Bridge, those paying through the mail and drivers from out-of-state, and again in January 2022 for the Cuomo Bridge.

DiNapoli's report found that the Thruway's finances and operations have been influenced by five key factors over the last decade:

Implementation of cashless tolling and problems with Tolls by Mail (TBM) system. The Thruway's implementation of cashless tolling was completed in November 2020. In 2022, Thruway leadership reported this modernization effort had not yet produced cost savings or efficiencies. In addition, problems including erroneous bills and significant fines and penalties prompted calls from state officials and the public for the Thruway to make sure the system was functioning as intended. An audit of the Thruway's cashless tolls program was engaged by DiNapoli in April 2022 and is in progress.

Sharp declines in traffic and toll revenues due to the COVID-19 pandemic. The COVID-19 pandemic saw a significant drop in traffic which caused toll revenues to decline 16.8% in 2020 before rebounding in 2021.

Construction of the Cuomo Bridge. Between 2012 and 2021, \$3.8 billion was spent on the bridge – more than half of the Thruway's capital spending – with an additional \$254 million budgeted through 2024. The state contributed \$2.3 billion toward the cost of the Cuomo Bridge and other projects, but remaining capital costs associated with the bridge have been financed with Thruway debt.

Debt management practices. Annual debt service on the Thruway's currently outstanding debt is projected to grow to over \$419 million by 2031, up 36.1% from 2022. This debt, along with additional borrowings proposed under the Thruway's new 2023 to 2027 Capital Plan would cause debt service to grow nearly 61% by 2031.

Shifting financial obligations. While the Thruway was intended to be mostly self-financing, it benefited from \$2.3 billion in support from the state during the construction of the Cuomo Bridge. At the same time, however, the Executive pushed forth a toll freeze through 2020.

DiNapoli urged that before any tolls are increased, the Thruway address the following concerns:

Resolve systemwide cashless tolling and TBM issues. Before asking system users to pay more, the Thruway should address its implementation problems and ensure that it has a clear and accurate forecast upon which to base its revenue estimates. The Thruway should also provide better documentation and disclosure of the assumptions used to develop the revenue and traffic projections that support its proposal

Perform a comprehensive assessment of operating needs and expenses to identify costs that may no longer be necessary. Since 2012, there has been a significant decline in the number of Thruway staff, while its reliance on procurements has increased. Reporting of key performance indicators is essential to identify opportunities to improve efficiency and transparency.

Maximize non-toll revenue sources, including federal funding as well as revenue streams that could be generated from its assets and infrastructure. As shown by recent major increases in revenue from its fiber optic system, the Thruway should pursue alternative revenue streams from its service areas and gasoline stations, special permits, and other property.

Note: We received the following response to DiNapoli's report from Jennifer Givner, Thruway Authority spokesperson, who wrote "New Yorkers have two ways to pay for their highways – tax dollars or toll dollars. The Thruway Authority is operated and maintained solely as a user-fee system, and is not supported by any federal, state or local taxpayer funding. Thruway toll revenues are projected to decline \$240 million [over 2020- 2025] from levels prior to COVID. The Authority did not receive any portion of the funds New Yorkreceived as part of the federal Infrastructure Investment and Jobs Act nor any funds from other COVID Relief programs. The annual growth rate for Thruway operating budgets averaged less than two percent increases over the 2010 – 2022 period. Our toll revenue continues to go directly toward making the Thruway one of the safest highways in the nation. The toll adjustment proposal announced in December [when it takes effect] would be the first in 14 years for NY E-ZPass customers outside of the Mario Cuomo Bridge and toll rates on the Thruway will continue to be some of the lowest in the nation. We believe this modest proposal will begin to raise additional revenue to support the long-term financial needs of New York's main transportation corridor and engine for economic activity. We would be happy to discuss this with the Office of the State Comptroller at any time."





New York State Trooper Arrested For Issuing 30+ Falsified Traffic Tix

On Jan. Westchester County District Attorney Miriam E. Rocah announced that a New York State Police Trooper, responsible for patrolling the Sprain Brook and Taconic State Parkways in Westchester County, was arrested and charged with issuing more than 30 falsified traffic tickets and supporting depositions to multiple individuals, who were never subjected to a traffic stop, including one person who died prior to the issuance of the tickets.

DA Rocah said: "Integrity in law enforcement is paramount. I commend our partners at the New York State Police for referring this case to our Office and demonstrating their commitment to accountability and transparency."

Edward Longo, 34, of Yorktown, is charged with 32 counts of Offering a False Instrument for Filing in the First Degree, a felony, and eight counts of Official Misconduct, a misdemeanor. In collaboration with the New York State Police, the Public Integrity and Law Enforcement Integrity Bureau of the Westchester County District Attorney's Office conducted an investigation and arrested the defendant on January 31, 2023.

The defendant is scheduled to be arraigned in Mount Pleasant Justice Court on February 16, 2023.

The defendant, while on duty and employed as a New York State Police Trooper, allegedly issued 32 tickets and supporting depositions containing false statements and false information without having performed a traffic stop or observing a traffic violation on eight different occasions between May 10, 2021 and October 2, 2022. The falsified tickets and supporting depositions were then submitted to the New York State Police Troop K Hawthorne barracks in Mount Pleasant, where the defendant was assigned.

The New York State Police placed the defendant on administrative leave in November 2022. The case is being prosecuted by Public Integrity and Law Enforcement Integrity Bureau Assistant District Attorney Renee Hassel, under the supervision of Deputy Bureau Chief Jennifer Sculco, both of the Trials and Investigations Division.

The charges against the defendant are merely an accusation, and the defendant is presumed innocent unless and until proven guilty.

Honorable Daniel D. Angiolillo, a Justice of the Harrison Town Court. Defense Counsel from the Legal Aid Society of Westchester was present at the arraignment and the Legal Aid Society was assigned to represent the Defendant in the instant matters. Defendant was released on his own recognizance [pursuant to "bail reform," none of the charges pending before this Court are "qualifying offenses" for monetary bail to be set. He was ordered to appear back before Judge Angiolillo in the Harrison Town Court on 2/14/2023.

Filippone,72, is charged with three felonies and three misdemeanors from incidents that occurred on April 30, 2022, May 9, 2022, and December 3, 2022. On 4/9,22, at 818AM, Filippone entered the Visual Arts Academy building and stole two art palette knives.

On 5/9/22, he is charged with stealing a portrait of a male student's upper body which was displayed on the wall. And on 12/3/22, he is charged with stealing a painting of a female's vagina and a painting of a female bending over exposing her genitals, as well as a student painting on a cardboard box of a male bending over and exposing his genitals.

In each of the three instances, Filippone is charged with three counts of Burglary in the 3rd degree, a felony, and three countys of misdemeanor petty larceny.

Part of the existing law also restricts the number of Charter's in each region of the state. In New York City, around 275 Charter Schools are open and operational. Under Hochul's plan, more than 80 Charters would be allowed to open in NYC. This legislature approved 460 charter slots in New York state. That number has not been achieved."

That plan has been met with early, stiff opposition from NY Senate Democrats. Westchester State Senator Shelley Mayer, chair of the senate education committee, joined with other democratic senators in opposing Hochul's plan.

In a letter – As of October 5, 2022, the State Education Department recognized 357 Charter Schools operating across the state, of which 287 are located in New York City. By removing the geographic restrictions on for charter authorization, NYC could see an increase of more than 100 new charter schools. This will further increase the financial burden on NYC traditional public schools, taking much needed resources away from schools serving the vast majority of our children.... Governor Hochul decision will leave students in our public schools with less," writes Sen. Mayer, Sen. John Liu, Sen. Robert Jackson.

Westchester Congressman Jamaal Bowman said, "As a life-long educator and former middle school principal in the Bronx for over a decade.. I am extremely disappointed by her proposal to remove the regional cap on charter schools which will dramatically divert critical resources from traditional public schools, especially for the almost 90% of minority children who are currently enrolled in public schools."

Charter school supporters praised Hochul's plan. "Governor Hochul has set the table, and we must ensure the legislature listens to parents and delivers a much-needed win for New York City families," says Crystal McQueen-Taylor, Executive Director of @StudentsFirstNY,

Success Academy founder and chief executive officer Eva Moskowitz said, "Now Albany needs to get behind this common sense solution and ensure it becomes law — that kids win over politics."

The final decision on these two budget items, and the entire state budget, will be made by the "three people in the room," Governor Hochul, and State Senate Majority Leader Andrea Stewart-Cousins and Assembly Speaker Carl Heastie. Stewart-Cousins and Hochul have been clashing over Hochul's nomination of Hector LaSalle to be the Chief Judge in NY. Stewart-Cousins, and a majority of

Last week, reports said that Hochul and Stewart-Cousins had not spoken for two weeks since the State Senate Judiciary Committee rejected the nomination, and the full senate has yet to vote on LaSalle's appointment.

State Senate democrats, who must confirm the appointment, oppose LaSalle.

twelve (12) separate causes of action and seeking money damages based on what RC Recreation alleges is the Town's wrongful termination of its contract with RC Recreation, its forceful but unlawful ouster of RC Recreation from the premises, for abuse of process against RC (and its principals), and other claims. This combined pleading also names "John/Jane Doe," meant as a placeholder for any future awardee of RC Recreation's illegally terminated concession.

By today's filing, RC Recreation merely seeks to hold the status quo at the golf course, pending a full and complete valuation of RC Recreation's years-long investment into structures, fixtures, and equipment at the facility.

A ruling by the courts on all of the litigation filed against Slater and the Town is expected to begin in the spring.


