County Executive Jenkins Proposes Expanded Property Tax Break for Volunteer Firefighters & EMS



Westchester County Executive Ken Jenkins is proposing legislation that would expand the County's tax exemption for volunteer firefighters and ambulance service members. This initiative would ensure that all volunteer firefighters and ambulance workers residing in Westchester are eligible for a 10% County property tax exemption, regardless of the location of their volunteer service.

Jenkins said: "Volunteer firefighters and ambulance workers are the backbone of our emergency services, selflessly dedicating their time and energy to keeping our communities safe. We deeply value and appreciate their bravery and commitment every single day. By expanding the tax exemption to include those serving anywhere within Westchester County, we aim to support their efforts, enhance recruitment, and retain these essential volunteers."

Under the current law, volunteer firefighters and ambulance workers with at least two years of service are eligible for a 10% County property tax exemption, if they serve in the municipality where they reside. The proposed amendment aligns with recent changes to the New York State Real Property Tax Law, allowing the exemption to extend to volunteers serving in neighboring municipalities within the County.



On January 23, President Donald Trump pardoned two men with ties to Westchester. Fr.

Fidelis Moscinski was pardoned for his arrest and violation of the federal Freedom of Access to Clinics (FACE) Act.

Westchester Congressman George Latimer took to the floor of the House of Representatives to remember Gus Williams, who passed away on Jan. 15 at the age of 71. Williams attended Mt. Vernon High School with Latimer, and is being remembered as the greatest basketball player in Westchester history.

"I rise today to honor the life of Gus Williams. A basketball great and native from Mt. Vernon NY, his talent made him one of the greatest players from my hometown He got the nickname the wizard for his acrobatic style, speed ,and mid-range jump shots.

"Gus led the Mt. Vernon High School basketball team to the state championship in 1971. He went on to USC and an NBA career with the Seattle Supersonics. He led the Supersonics to the NBA Championship in 1979, and they retired his #1 jersey.

"I'm grateful that I got to go to high school with Gus Williams and to have seen his magic before the rest of the world got that opportunity. He will be deeply missed in the Mt. Vernon community but his memory will live on," said

Asylum Seekers Vacate Ramada Hotel, Yonkers for Alternative Housing: City Collects \$515k Fine

Disgraced Top Officials at School Arraigned on Public Corruption Charges

On Jan. 24, Yonkers Mayor Mike Spano today announced over 100 families seeking asylum who were housed at the Ramada by Wyndam in Yonkers since 2023 have vacated the hotel and are transitioning to permanent housing or to shelters operated by New York City Department of Homeless Services (DHS). The vacancy comes after the City of Yonkers successfully sued the hotel for violations of the Yonkers City Code and its Certificate of Occupancy.

"While the City of Yonkers was not initially notified by New York City of the asylum seekers' arrival two years ago, we have since supported these families," said Mayor Spano. "Their transition to alternate housing is the result of the hotel's irresponsible refusal to adhere to Yonkers' local zoning, housing and fire ordinances, which placed many of the hotel's residents in danger."

Mayor Spano continued, "As a result, we decided to take legal action against the hotel to pay for lost revenue and violations against our local laws. Through a settlement with Ramada, the residents have now vacated without disruption. I am pleased that through our partnerships with local non-for-profits and social services, these families now can continue their journey in seeking asylum in our country."

Despite claiming the housing at the Ramada would be temporary, the hotel boarded the asylum seekers for nearly two years, violating the Yonkers City Code and the hotel's certificate of occupancy, which prohibits non-transient residences. Subsequently, the Ramada has paid the City of Yonkers \$515,000 in penalties, an amount which exceeds the City's estimated loss of hotel tax revenue for the 20-month occupancy.

In May 2023, New York City transported 100 families to the Ramada, located at 125 Tuckahoe Road, in response to the surge of asylum seekers brought to the New York area.

There are two other locations in Westchester that have been housing migrants since 2023, at the Ardsley Acres Motel and at the Central Motel in White Plains.

Westchester County District Attorney Susan Cacace and New York State Comptroller Thomas P. DiNapoli announced that two former officials at the Greenburgh-Graham Union Free School District, which serves at-risk students from kindergarten to 12th grade, were arraigned today on an indictment charging them with multiple public corruption offenses.

Oliver Levy, the district's former superintendent, and Surendra Kumar, a former security system specialist, were arraigned Wednesday morning before Westchester County Court Judge Anne Bianchi on the charges of Second-Degree and Third-Degree Grand Larceny as Crimes of Public Corruption, Second-Degree and Third-Degree Grand Larceny, and Corrupting the Government in the Second and Third Degrees.

Both defendants pleaded not guilty to the charges.

D.A. Cacace said: "Any theft of public funds represents a fundamental breach of public trust. That breach is amplified when the allegations concern an institution serving our most vulnerable. The funds in this case that were allegedly diverted to the defendants could have been used for student achievement. My office will work diligently to ensure that the students and parents at Greenburgh-Graham are made whole."

Comptroller DiNapoli said: "School administrators allegedly stealing from students they are supposed to serve is reprehensible. My thanks to the Westchester County District Attorney's office for partnering with my office and continuing to pursue justice in this case and holding these individuals accountable."

As alleged in the felony complaint, Mr. Levy, who began as a teaching assistant in 2008 and was promoted to superintendent in 2018, aided, abetted, and acted in concert with Mr. Kumar, then a security system specialist, to purchase 168 gift cards between July 2018 and June 2022.

Instead of spending the full sum of these funds on school-related expenses, the defendants are accused of diverting over \$50,000 from the gift cards to personal expenses, such as jewelry, luxury handbags, private school fees for relatives, and veterinary services.

Mr. Levy, 55, of Stony Point, and Mr. Kumar, 48, of Yonkers, were arrested in May 2024 by the Westchester County District Attorney's Office. They have been released on their own recognizance. None of the charges are bail-eligible.

The top charge, Second-Degree Grand Larceny as a Crime of Public Corruption, carries a maximum potential sentence of 8 1/3 to 25 years in prison.

The investigation was conducted by the Office of the New York State Comptroller and the Economic Crimes and Public Integrity Units of the Westchester District Attorney's Criminal Investigators Squad.

The case is being prosecuted by Assistant District Attorney Sheila Horgan.

County Executive Jenkins: Westchester County Plans to Open Playland for 2025 Season



Westchester County Executive Ken Jenkins announced that the County intends to open Playland for the 2025 season, despite ongoing legal challenges with Standard Amusements.

Jenkins said: "We have long said that Playland is the crown jewel of this County. Since 2018, the County has made every effort to ensure this beloved park thrives for future generations and today that commitment continues."

At this point, the County is in the early stages of what is expected to be a complex legal battle. Jenkins also said that it is untrue that the County had prior knowledge of the termination in November, noting that the County had a conversation with Standard Amusements where they expressed an interest in potentially negotiating a settlement, but nothing came from that conversation.

Jenkins said: "The bottom line is this: Standard Amusements was losing money. They couldn't make Playland work, and now they are trying to place the blame on the County for their failure – after the County has spent close to \$150 million pursuant to the PMA."

The agreement between the County and Standard Amusements was originally established during the Astorino administration, under a public-private partnership model. This arrangement required the County to reimburse Standard for their investments into Playland and expenses.

Jenkins said: "While the original contract was flawed, we managed to renegotiate it to implement a cap on reimbursements, protecting taxpayers from an even greater financial burden. Despite our efforts, we were ultimately blocked from fully walking away from the deal due to a bankruptcy court ruling that sided with Standard Amusements."

The County has invested \$150 million dollars to upgrade and restore Playland, while Standard Amusements has repeatedly neglected its responsibilities and mismanaged the Park.

Standard Amusements' poor performance is evident through the following failures:

• Inadequate Ride Operation: Numerous rides were closed throughout the seasons, a violation of industry standards.

• Insufficient Maintenance Staff: The lack of adequate staffing affected both daily operations and preventative maintenance.

• Unresolved Maintenance Issues: Several repairs identified in the October 2024 safety audit remain unfinished.

• Withholding Money from County: Standard Amusements is withholding money from the County citing delays in project completion. Despite the County providing proof that all projects, including the Switchgear, were completed.

Republican County Executive candidate Christine Sculti warned the taxpayers of Westchester over the recent developments at Playland.

"The recent news that Standard Amusements is terminating its management agreement for Playland is shocking enough," said Sculti, "What's totally unacceptable is that Ken Jenkins has kept this information secret since Thanksgiving of last year when it should have been openly discussed during the budget process, particularly since there may be an enormous \$57 million hit to the taxpayers for this monumental screw-up."

Dinapoli: Numbers of Homeless Population doubled in New York



Homelessness in New York state has grown sharply, more than doubling between January 2022 and January 2024, according to a report released today by New York State Comptroller Thomas P. DiNapoli. Homelessness grew by 53.1% from January 2023 to January 2024, more than four times the rest of the nation. The large spike was driven by New York City and the influx of asylum seekers, but the rest of the state also had double- and triple-digit rate increases, led by Glens Falls, Saratoga and the surrounding counties.

The number of homeless children increased from 20,299 in 2022 to 50,773 in 2024. Almost one in three of New York's homeless are children, one of the highest shares in the nation.

"New York has long had a housing affordability crisis, and more families are running out of options and ending up on the street or in shelters," DiNapoli said. "Many of the tens of thousands of asylum seekers that came to New York had no place to stay and drove up spending and a large portion of the growth of the homeless population. But let's be clear, this isn't just a New York City problem, it is impacting communities all over the state. New York needs to examine how it's using current housing resources while taking more action to address this urgent situation."

Measuring homelessness is difficult as individuals are mobile and their situations can be temporary or hidden. The U.S. Department of Housing and Urban Development (HUD) uses a single day, point in time count of the homeless population. The most recent count was done in January 2024, the same month the number of asylum seekers in city shelters peaked.

HUD found homelessness reached a new peak with 771,480 people nationwide experiencing homelessness in 2024. There were more than 158,000 homeless New Yorkers in 2024 – about one in five of the nation's homeless. New York's rate of homelessness, at about 8 per 1,000 people, was higher than all states except Hawaii and the District of Columbia. According to HUD, homelessness in New York increased because of eviction proceedings, lack of affordable housing, increased rents, and the influx of asylum seekers, among other factors.

New York City accounted for 93% of the increase in the state's total homeless population. In January 2022, there were 45,343 people in New York City shelters run by the city Department of Homeless Services (DHS). By January 2024, there were 89,119 people in DHS shelters, 34,057 of whom were asylum seekers. New York City housed approximately 68,000 asylum seekers in total at that time.

Other findings in the report:

Homelessness decreased in New York between 2020 and 2022, but since 2022 and the end of pandemic eviction moratoriums, it has increased faster than the rest of the nation, more than doubling between 2022 and 2024 compared to only 20.7% growth in the rest of the nation. Only Illinois had a higher increase at 180%.

People who were homeless were disproportionately Hispanic or Black, and 10% suffered from severe mental illness or chronic substance abuse.

Homelessness among veterans remains low, at less than 1%. New York also had among the lowest shares of senior homelessness (2.5%) and chronically homeless (3.6%) among other states.



"Menace to Society" Who Beat Ex-Girlfriend Gets 10 Years



Also Robbed Good Samaritan Who Tried to Stop Attack in Yonkers

Paul Price repeatedly attacked his ex-girlfriend and robbed a Good Samaritan who sought to intervene.

Westchester County District Attorney Susan Cacace announced that a Connecticut man was sentenced yesterday to 10 years in prison on robbery charges following an August 2023 incident where he repeatedly attacked his ex-girlfriend, at one point causing her to lose consciousness.

D.A. Cacace said: "This merciless assault against a former partner highlights the everyday danger of domestic violence. Yesterday's sentence is a sobering reminder that this type of violence can affect anyone, regardless of circumstance. Anyone experiencing violence from a current or former partner should reach out to my office or their local police department for assistance. We are committed to protecting the safety and privacy of domestic violence survivors."

Paul Price, 41, of Torrington, Conn., pleaded guilty in December to Robbery in the Second Degree, for robbing a Good Samaritan, and Assault in the Second Degree, for attacking his ex-girlfriend in her apartment.

On Thursday, Westchester County Court Judge James McCarty sentenced Price to 10 years in prison on the robbery charge and seven years in prison on the assault charge, to run concurrently with the robbery charge.

In August 2023, Price went to his ex-girlfriend's Yonkers workplace and directed her into her car. During the ride back to her apartment, Price struck her and then pulled her out of the car by her hair and slammed her to the concrete. At her apartment, he continued to strike her repeatedly and then choked her to unconsciousness.

The victim eventually managed to flee to a nearby mechanic. Price pursued her there and assaulted and robbed a Good Samaritan seeking to intervene.

During sentencing, prosecutors read aloud a victim impact statement from the domestic violence victim where she described the incident as "one of the worst days of my life."

"I was physically, verbally, emotionally, and mentally assaulted by a menace to society," the victim said.

DA Cacace commends the Yonkers Police Department and the DA's High-Tech Unit for their thorough investigation of this incident and Assistant District Attorney Daniela Parra of the Domestic Violence Bureau for her effective prosecution of this case.



Westchester County to Offer Police Civil Service Exams in May -Deadline to file is Feb. 24

Westchester County will be holding police officer civil service examinations for the first time in four years. Tests for Police Officer and Police Officer (Spanish Speaking) will be given on May 3 or May 4. The deadline to file to take the exams is Feb. 24.

County Executive Ken Jenkins said the Department of Public Safety and the Department of Human Resources will be sharing information with a variety of organizations to help ensure a diverse pool of applicants. These include community-based groups, houses of worship, non-profit agencies, local colleges, libraries and employment centers.

Jenkins said, "The ongoing effort to increase diversity in our police departments begins with ensuring that a diverse applicant pool takes these exams. Police departments are more effective when they reflect the communities they serve. My dad was a police officer and I know from his experience how rewarding this career can be."

The exams, to be administered by the Department of Human Resources, will result in a list of eligible police officer candidates for the Westchester County Department of Public Safety, the cities of Rye and Peekskill, and all towns and villages in the County.

Among the requirements to take the test

All candidates must be a legal resident of Westchester County at the time of their test and for at least one month prior to it. Candidates will be required to submit proof of residency when requested. Candidates who cannot provide proof of Westchester County residency will be disqualified

Applicants must not have reached their 35th birthday by their test date; exceptions are made for persons with military service;

A high school diploma or equivalent is required;

U.S. citizenship is required to be appointed as a police officer. It is not required to take the civil service exam.

The exam applications and more details about requirements are available at www. westchestergov.com/hr. A link to a study guide can also be found in the exam announcements.

"I urge any Westchester resident interested in a police career to take advantage of this opportunity," Public Safety Commissioner Terrance Raynor said. "These exams only come around once every four years. Don't miss out on the chance to have a fulfilling career where you can make a difference every day in the community where you serve."

Westchester County only accepts applications for civil service exams online. Candidates can apply through the website or by scanning the QR code in the exam announcement. Applicants seeking to take both Examination # 60-012780, Police Officer, and examination # 60-012790, Police Officer (Spanish Speaking) must submit a separate application and application fee for each examination number. That is the only way to appear on both eligible lists resulting from these examinations.



TAX SEASON IS OPEN: DON'T MISS OUT ON VALUABLE CREDITS

Eligible New Yorkers Can Qualify for Up To \$12,528 in Earned Income Tax Credits

On National Earned Income Tax Credit Awareness Day, January 31, the New York State Department of Taxation and Finance urges New Yorkers to take advantage of valuable tax credits. This year marks the 50th anniversary of Earned Income Tax Credits providing a financial boost to working taxpayers.

The Earned Income Tax Credit is a refundable credit for eligible taxpayers who earn less than \$66,819. Taxpayers can get a refund if the credit amount is more than what they owe in taxes.

Earned Income Tax Credit amounts depend on a taxpayer's income and number of children – and single New Yorkers can also qualify. Combined federal, New York State, and New York City Earned Income Tax Credits can be worth up to \$12,528 for a family with three or more qualifying children.

Every year, many New Yorkers qualify for the Earned Income Tax Credit for the first time because of changes to their financial situation, filing status, or personal life. Black History Month 2025: Group Economics VS. DEI Rollbacks

As Black History Month unfolds, a crucial question emerges: How can Black Americans secure economic empowerment in an era of diversity, equity, and inclusion (DEI) rollbacks? With major corporations scaling back DEI initiatives and President Donald Trump vowing to eliminate them entirely, the Black community must revisit a time-tested strategy-group economics.

In November 2023, during a campaign speech in Iowa, Trump declared that on "day one," he would dismantle what he called "woke" DEI programs, stating, "We will restore merit-based education, hiring, and advancement in America." This rhetoric has been echoed by several corporations, including Target, which quietly pulled back its DEI commitments in late 2023 after facing conservative backlash. Now, Target is in the spotlight. Other companies have followed suit, adjusting or eliminating DEI efforts in response to legal challenges and political pressure.

For Black Americans, economic self-sufficiency is not a new concept. History proves that collective financial action can be a powerful tool for justice. One of the most famous examples is the Montgomery Bus Boycott (1955-1956). After Rosa Parks' arrest for refusing to give up her seat to a white passenger, Black residents of Montgomery, Alabama, organized a year-long boycott of the city's bus system. Their refusal to spend money on segregated buses ultimately forced the transit system to desegregate, proving that Black spending power-when strategically wielded-can bring about systemic change.

Another pivotal moment was the rise of Black Wall Street in Tulsa, Oklahoma. In the early 20th century, the Greenwood District was a thriving Black economic hub, home to Black-owned businesses, banks, and professionals. Tragically, in 1921, white mobs destroyed the community in one of the worst race massacres in American history. While Black Wall Street was burned down, its legacy underscores the power of Black economic cooperation and the threat it poses to systemic racism.

Today, as DEI policies face political opposition, Black communities must look inward and support one another financially. Investing in Black-owned businesses, banking with Black financial institutions, and creating community-based funding initiatives can ensure long-term economic resilience.

The rollback of DEI should serve as a wake-up call. While corporate diversity programs can provide opportunities, true economic empowerment comes from within. As Black History Month reminds us, our history is rich with examples of economic solidarity. Whether through local investment, cooperative economics, or strategic boycotts, Black Americans must reclaim the power of their collective dollar.

The time is now to take control of our financial destiny-just as our ancestors did.





"Standard's basis for the termination is that the county did not "substantially complete" 70% of the capital improvements by the April 30, 2024 deadline," Sculti continued. "Shockingly, the county apparently acknowledged its failure to Standard and then covered up the news until this week that Standard was terminating the deal."

Sculti noted that the county and Standard entered into a management agreement in 2015 that was unanimously approved by the Board of Legislators. It required both Standard and the county to invest millions in capital improvements, new rides and attractions, and a profit-sharing arrangement. The Latimer-Jenkins administration immediately reneged on the deal, spent more than \$5 million in legal fees and lost in federal court. They then negotiated the current agreement with Standard in 2022 while Jenkins was Deputy County Executive and chaired the County's Capital Projects committee in the absence of the county executive.

"Jenkins knew what the deal required the county to do and then sat by and did nothing while the county failed to meet the benchmarks in the agreement," Sculti said. "He either wanted the deal to fail at any cost or was grossly incompetent. Both disqualify him from being the next county executive."

Playland is a significant contributor to the Westchester economy. It directly employs 40 full-time, 50 part-time and 850 seasonal employees. Indirectly, it contributes to almost all slices of the job market from construction to manufacturing to trades to professional services.

"The agreement with Standard Amusements and needed capital investments by the county government were supposed to bring Playland back as a waterfront destination for all to enjoy," Sculti said. "Instead, Playland's future is more uncertain than ever, taxpayers may be on the hook for more than \$57 million, may be disappointed. If elected, I will make it a priority to fix the Jenkins' mess and get Playland back on track."

The rest of the state's regions had increases ranging from 11% in Poughkeepsie/Dutchess County to 138% in Glens Falls, Saratoga Springs and surrounding counties. Outside of New York City, Long Island had the largest number of homeless in 2024 followed by Westchester County and counties around Buffalo and Niagara Falls.

New York has the lowest share of unsheltered people at 3.6% in stark contrast to 43.8% in the rest of the nation. New York has the largest number of year-round emergency housing beds at 127,759, far surpassing second place California (76,000 beds), according to HUD. This number is mostly beds in emergency shelters (122,091), which is largely a result of shelter mandates in New York City.

New York is second to California in the number of permanent supportive housing units (52,462 vs. 78,758) and permanent housing beds (21,672 vs. 26,059), but lags other large states in the number of year-round beds for rapid rehousing - 4,887. California has more than 28,000, Texas almost 11,000 and Florida 7,500.

Gov. Hochul and New York City Mayor Adams both announced affordable housing proposals in their recent 2025 policy addresses. The report also notes that New York state is currently implementing a five-year \$25 billion housing plan "to create or preserve 100,000 affordable homes," including making multi-year investments for homeless housing and assistance and for affordable housing. However, there is little information available to track goals, accomplishments and amount spent on

DiNapoli said more needs to be done to keep people in their homes and provide housing assistance, particularly to families with children. The state should carefully monitor and enhance reporting on the effectiveness of current programs and determine where additional resources may be needed, particularly for expanding rental assistance, and continue funding legal representation for low-income households facing eviction.

For Westchester County, according to the report the Homeless population has risen by 19% from 2022-2024, with 17% of the homeless under age 18, and 22% people in families.

For the Long Island case, Moscinski was charged by the US Atwith a Federal crime: violating the FACE Act. He torney was found guilty in 2023 and served 90 days in 2024. A member of The Proud Boys who was arrested by the FBI in White Plains for his action on January 6, 2021, at the US Capitol was also pardoned by President Trump. was convicted last year and was Williams Joseph Pepe, 35, sent to be sentenced on March 11, but has now been pardoned.


According to evidence presented during the trial, on the morning of January 6, 2021, Pepe met a group of approximately one hundred Proud Boys members in Washington, D.C., near the Washington Monument at approximately 10:00 a.m. Shortly after, the group marched away from the rally near the monument toward the US Capitol building. Pepe and the group arrived at the Peace Circle, at the edge of the restricted portion of Capitol grounds, at approximately 12:50 p.m.

There, members of the crowd violently disassembled and trampled the metal bike rack barriers blocking further entry into Capitol grounds. The crowd, with Pepe at the front, charged over the fallen bike rack barriers and advanced toward the West Plaza of the Capitol. As they advanced, Pepe and the crowd encountered another set of metal bike rack barriers at the West Plaza, behind which was a line of police officers. Behind the officers was a waist-high black metal fence. Pepe dragged away a segment of the metal bike rack barriers, as did other rioters.

The police line then reformed behind the black metal fence. As Pepe and rioters approached the black metal fence, Pepe looked directly into a nearby camera and yelled, "Let's go! This is what we came for, yeah!" Officers began to deploy pepper spray and other crowd control measures to get the crowd to disperse. Pepe was pepper sprayed, and he posted a selfiestyle video in which he declared, "Yo, the cops pepper sprayed me and Hooks. Me and Hooks got f-ing maced. Storming that Capitol, baby!"

Follow the lives of William and Benjamin Frank, men of color who joined the Second Rhode Island Regiment during the American Revolution, as they navigate the challenges of war, ultimately ending up on opposite sides of the conflict. Join Dr. Shirley Green for this fascinating talk based on her book, Revolutionary Blacks: Discovering the Frank Brothers, Freeborn Men of Color, Soldiers of Independence.

The narrative follows the lives of William and Benjamin Frank during the American Revolution. Putting together the pieces of this puzzle through archival research, interviews, and DNA evidence, the author authenticates and expands the family's oral history.

William and Benjamin Frank joined the Second Rhode Island Regiment in the spring of 1777, following the tradition of military service established by their father, a veteran of the French and Indian War. The brothers became part of a cohort of free Black soldiers serving in an integrated Continental Army. Following the brutal winter of 1777–1778 and the pivotal Battle of Monmouth, New Jersey, in June 1778, veteran soldiers of color from the Second Rhode Island, including the Frank brothers, were transferred to the newly segregated First Rhode Island Regiment. This unit was composed of Black and Native American soldiers, including enslaved men who were promised their freedom in exchange for service.

Dr. Shirley Green is the Director of the Toledo Police Museum and Adjunct Professor of History at Bowling Green State University in Bowling Green, OH and the University of Toledo in Toledo, OH.

At 2:16 p.m., Pepe entered the Capitol through the Senate Wing Door. While in the Capitol, he recorded a video and sent it to fellow Proud Boys, where Pepe stated, "We did it." Pepe was inside the building for approximately 38 minutes, exiting at 2:54 p.m. through a broken window beside the Senate Wing Door.

The FBI arrested Pepe on January 12, 2021, in White Plains. He worked for the MTA but called in sick on January 6. The MTA later fired him.

Pepe's trial was not concluded until October 2024, when he was found guilty of a felony charge of tampering with records, documents, or objects, obstructing, impeding, or interfering with law enforcement during a civil disorder, and misdemeanor charges of entering and remaining in a restricted building or grounds, disorderly and disruptive conduct in a restricted building or grounds, and tampering with records, documents, or other objects. He was to be sentenced on March 11, 2025, but has now been pardoned.

of a recycling facility (the "Recycling Facility") The Property is located on Route 6 in the Town's I-1 (Light Industrial) District, which has long permitted recycling facilities as a principal use.

The suit makes serious allegations against town employees and officials, although none are specifically named. Plaintiff 76 Route 6 Holdings, Inc. is suing the Town of Yorktown and all five members of the Yorktown Town Board, the Planning Board, and the Zoning Board of Appeals.

Also named are 20 John and Jane Doe's, "are unidentified persons who are employees, board members, agents, and attorneys or others who may have participated in or conspired with the named Defendants regarding the actions set forth in this Complaint and will be appropriately added as named Defendants later."

The suit also alleges that "Defendants needlessly and unlawfully delayed Plaintiff's Land Use Application while racing to enact zoning code legislation aimed at effectively barring Plaintiff's development of the Property altogether. Plaintiff endured a myriad of artificial and pretextual concerns and a stream of extra-procedural requirements by Defendants, only to be advised that its Property would now be subject to a newly enacted zoning code—legislation that was specifically targeted at Plaintiff to ensure Plaintiff could not utilize the Property for the use that was "as of right" at the time Plaintiff purchased the Property and filed its Land Use.

On July 28, 2023, 76 ROUTE 6 HOLDINGS INC purchased the Property located one mile north of the JV Mall "with the expectation that Defendants would lawfully act pursuant to the law on the Land Use Application and with such reasonable investment backed expectations that the Property could be profitably developed as a recycling facility so Plaintiff could realize a reasonable return on its investment."

76 Route 6 Holdings submitted its plans for a Land Use Application to build a Recycling Facility at the Property, consisting of a forty thousand (40,000) square foot indoor processing building, entranceway and weight station, outdoor storage, and parking areas.

In Jan. 2024, 76 Route 6 Holdings Inc., after submitting a Land Use Application, received a determination from the Yorktown Building Inspector's office that the Building could be constructed as-of-right as proposed in the Application and did not raise any objection to the proposed location of the Building.

After that, according to the lawsuit, "Town officials attempted to compel the Building Inspector to change his Determination so that a larger setback was required on the easterly property line that would result in the need for Plaintiff to obtain a variance and not permit the Recycling Facility to be expeditiously approved in an "asof-right" land use context.

But The Town Building Inspector, in a profile of lawful courage, refused to change his Determination that would have violated the rights of the Plaintiff. This unlawful attempt by Defendants to change the official act of a public official violated the law.

After a series of Planning Board meetings and Zoning Board meetings in the summer, the Determination for approval of the Land Use Application was delayed until the Town Board, according to the suit, "Given the reasonable likelihood that Plaintiff's Application to build the Recycling Facility would be approved, Defendants undertook the unlawful steps to repeal Chapter 300 of the Town Code regarding recycling facilities such as the one for which Plaintiff had been seeking approval.

Prior to purchasing this Property on July 28, 2023, Plaintiff engaged in a thorough due diligence process to determine if this Property and the Project was properly zoned and otherwise situated for construction of its proposed Recycling Facility.

On October 1, 2024, the Town Board unanimously passed a resolution amending the Zoning Code to eliminate recycling facilities as a primary use. The Town Board then referred the matter to the Planning Board, who ruled that the Land Use Application was denied based on the change to the zoning ordinance.

Town Supervisor Ed Lachterman wrote to the Town Board about the project: "I do not feel that the new proposed transfer station is what was intended in the law. Our hearing today is to remove it as an allowed use so it could be looked at later down the line."

In December 2024, the Town Board again placed the same zoning amendment in question back on the agenda for a second vote. "At that December 10, 2024 meeting, the Town Board attempted to retroactively correct the October 1, 2024, unlawful vote by making references to certain SEQRA documents and other considerations that were not actually before the Town Board at its October 1, 2024, aforesaid vote.

"Plaintiff acquired the Property in excess of \$2,000,000 and incurred substantial costs and expenses for, among other things, engineering and professional fees, in preparation of the Application and traffic studies, amongst other items.

Upon information and belief, the reason for the Town's actions was because Plaintiff was owned by the same owners as AAA Carting, against whom certain members of the Town harbored animus as a result of the prior litigation and public expression.

The lawsuit also reviews the troubles between the Town and AAA Carting. "AAA

Laws- Sends letter to Mayor Eric Adams



Putnam County Executive Kevin Byrne

Putnam County Executive Kevin Byrne sent a formal correspondence to New York City Mayor Eric Adams, urging the mayor to take emergency executive action and roll back New York City's sanctuary city policies as a means of addressing the ongoing migrant crisis and improving public safety. The letter highlights the impact of illegal immigration on communities across the region, including Putnam County, and calls for greater collaboration between local and federal immigration-enforcement agencies.

In the letter, Byrne acknowledged the challenges faced by New York City and commended Mayor Adams for his recent remarks supporting stronger border security and accountability for criminal illegal migrants. Byrne's request focuses on the mayor's ability to exercise his authority under a declared emergency to suspend restrictive sanctuary laws in New York City that prohibit cooperation with U.S. Immigration and Customs Enforcement (ICE).

"New York City's policies have consequences that ripple far beyond its borders," said County Executive Byrne. "The sanctuary laws adopted in recent years have created a haven for criminals, undermining public safety and straining resources not just in the city but in neighboring counties like ours. Mayor Adams has an opportunity to take decisive action, and I am asking him to exercise his power as Mayor to roll back these sanctuary policies for the benefit of all New Yorkers."

Byrne highlighted Putnam County's proactive measures to address the issue, including a 2023 state of emergency declaration that formalized cooperation with federal immigration authorities. While that declaration was later rescinded after new local legislation was enacted, Byrne noted that the county remains committed to protecting its residents and supporting policies that promote public safety.

Legislator Erin Lee Crowley praised Byrne's leadership on the issue and joined him in urging New York City to reconsider its sanctuary designation. "Putnam County has worked hard to ensure the safety of our residents, and I applaud County Executive Byrne for taking a stand," said Crowley. "It's time for New York City to rethink its policies and prioritize the safety of all communities, not just its own. Cooperation with federal agencies is a critical step forward."

In the letter, Byrne proposed suspending sanctuary city policies, in whole or in part, to allow New York City law enforcement and federal immigrationenforcement agencies to better target violent criminals and gang members who benefit from the current status quo. He also emphasized that such cooperation would help distinguish between immediate threats to public safety and individuals with minor infractions, reducing unnecessary federal enforcement actions against non-violent individuals.

Carting submitted competitive bids to obtain Town municipal contracts regarding refuse and recycling services. In late 2022, the Town did not award the municipal contract to AAA Carting, and AAA Carting was required to seek redress of grievances by means of New York State Court litigation regarding the Town's conduct in awarding the contract to another party, which lacked the experience, resources, and assets to service the contract.

"The Town's decision to award the contract to the other entity turned out to be ill advised in that less than a year after awarding the contract to the other party, the Town had to declare an "emergency" and re-bid the contract because, according to the Town, the hauler that was awarded the contract had its trucks repossessed, was not paying employees, and was otherwise breaching the contract such that the party could not properly and adequately service the contract.

"Defendant's unlawful animus towards AAA Carting and its principals was evident and confirmed when the Town later awarded the "emergency" contract to another entity despite AAA Carting being the lowest responsible bidder for that second contract."

"Those Town Representatives, including but not limited to the named Defendants herein, have acted in a punitive and illegal manner to violate Plaintiff's rights as a result of its rights of free expression and to seek redress of grievances or otherwise interact with the Town," states the lawsuit.

Several questions stem from the lawsuit:Who orchestrated the roadblocking of 76 Route 6 Holdings and AAA and their recycling plant proposal in Yorktown government? While Supervisor Lachterman is the leader of the town government, nobody knows who made this call. And who is one of the 20 John and Jan Doe's in Town government who orchestrated the roadblocks to put before the Recycling plant plan? Upgrade to better organization, more space and easy access

County Executive Jenkins & Westchester County Announce \$4.6M Grant to Palisades Towers Residents

County Executive Ken Jenkins joined Yonkers Mayor Mike Spano, the Yonkers Housing Authority and residents of Palisade Towers to announce a \$4.6 million grant from Westchester County's Landlord Tenant Assistance Program. The funding will help convert the 415-unit complex from gas to electric following a major gas leak that left more than 1,000 residents without service since August. This collaborative effort highlights the County's commitment to preserving affordable housing and improving living conditions for families across Westchester

Jenkins said: "Westchester County is proud to join forces with The City of Yonkers and the Yonkers Housing Authority to address the challenges faced by the residents of Palisade Towers. Through our Landlord Tenant Assistance Program, we contribute to this collaborative effort to make critical upgrades and improve living conditions for the families here. This project reflects our shared commitment to preserving affordable housing and supporting the wellbeing of residents across Westchester County."

Temporary boilers and cooking appliances have been provided during repairs to support residents while the work is underway.

Mayor Mike Spano said, "Thank you Westchester County Government and County Executive Ken Jenkins for partnering with us and Municipal Housing Authority for the City of Yonkers to assist residents of Palisade Towers who have been impacted by last summer's gas leak. The County pledged \$4.6M to help navigate the conversion to electricity for the residents living there. This funding will help with repairs needed to convert these homes to electricity. Over 380 families (or over 1000 people) including children, seniors & disabled tenants have been impacted. The CITY & MHACY's #1 priority is restoring stoves since the domestic hot water is currently supplied by temporary boilers.

"In August, more than 800 people living in Palisade Towers were left without gas. But together, our business owners, restaurants and neighbors stepped up to help. This week, Westchester County financially committed their support as the residents continue to navigate this ongoing challenge. In times of adversity, we show what Yonkers is all about — a community that comes together to support one another.We remain committed to securing additional state and federal support to complete the project and ensure sustainable, comfortable housing for all residents," said Spano.

Congressman Latmer. A GoFundMe page has been set up to help the family with expenses by his NBA teammate James Donaldson.

"I'm James Donaldson, Gus Williams' former Seattle Supersonic teammate and friend for over 40 years. I've been working closely with Gus' family over the last 2-3 years. I have been in touch with Gus throughout most of this terrible journey and did a FaceTime with him every couple of months or so.

"His family asked me to be their spokesperson on the West Coast and in the Pacific Northwest. They also asked me to create and administer this GoFundMe. I'm more than happy to do so.

"Gus (10/10/1953 - 01-15-2025) became seriously ill 5 years ago after suffering a stroke and then being beset with pneumonia and meningitis. He has spent the last 5 years flat on his back and bravely battling this terrible misfortune. He fought a good fight, but it became too much to overcome.

"He was one of the very best and one of the most beloved NBA players of his time and an NBA World Champion with the Seattle Supersonics in 1979.

"No one will ever forget "The Wizard" and his unique way of tying his shoe laces on the back of his ankles instead of the front.

"He was gregarious, funny, always upbeat, and very charitable with his time and money. Plus, he was always friendly with the fans, and they loved him in return.

"Super fast and super quick on the court. Could stop on a dime and outrun everyone out there. With a deadly jump shop to boot. Gus was one of a kind!

"Gus spent his last years in a skilled nursing home in Maryland, and the family wants to transport his body from Maryland back to Mt. Vernon. NY, Gus' hometown, so that he can have a decent funeral and his 100-year-old mother and other family members can visit his gravesite.

"Gus' brother, Ray Williams, was also an NBA player and passed of prostate cancer on March 22, 2013, and Gus will be buried next to him in Mt. Vernon. Their mother and the rest of the family would like nothing better than to be able to visit the sites of their dearly departed loved ones.

"Gus was just nominated for the NBA Hall of Fame in December 2024, and hopefully will garner enough votes to be posthumously inducted in the fall of 2025. What a guy! What a life! What a player and what a very special person!
