

# Did the Son of Sam Do It Alone? Yonkers at The Center of Netflix Doc

Did David Berkowitz, aka the 'Son of Sam', act alone when he shot 13 young couples, killing 6, from 1976 and 1977 in New York City? Or was Berkowitz part of a satanic cult in Yonkers, where he lived, and did two other men from Yonkers play a role in the shootings that terrorized millions of New

A new Netflix True Crime documentary, The Sons of Sam: A Descent into Darkness, makes the case that two young men from Yonkers who lived close to Berkowitz's apartment on 42 Pine Street ,were not only involved in some of the shootings, but one was the real Son of Sam.

I was 10 years old when The Son of Sam, or the 44 Caliber Killer, began his rampage, always shooting couples in a car very late at night. Usually at Lovers Lane locations across New York City, the shooter would walk

The Vietnam Veterans of America (VVoA) honored the sacrifice and memory of Westchester's 217 soldiers and 8 nurses who made the ultimate sacrifice for their country, losing their lives and never returning home alive from the Vietnam conflict, at Monday's annual Memorial Day observance at Lasdon Park's Trail of Honor.

"It is said that a person dies twice. Once when you stop breathing, and the second time, when your name is no longer mentioned," declared VVoA Director Dan Griffin. "We are here to make sure that ever happens. We will always be here, every year, to make sure that our fallen heroes are remem-

New this year to the annual memorial was Jenna Scanlan, 16, a member of Girl Scouts Troop 1376 in Yorktown Heights, who has been in scouting since kindergarten. Last summer, Jenna visited the Trail of Honor for the first time, and "saw so many opportunities for cleanup and trail enhancements", that she "asked Lasdon Park if she could take on a project to improve the Trail of Honor", to which they agreed.

Jenna was not inspired to her chosen project by any military in her family. Jenna has volunteered with United for the Troops, and is very aware of the importance of respecting and honoring our military, and was inspired to want to improve the Trail of Tears and make it more attractive and interesting. Jenna started working on improving the Trail of Honor in September 2020, asking Lasdon Park to construct flag holders, and with the help of


"Perverted Principal Sued" in Yonkers; City of Mt. Vernon Car Spotted at 230AM 'Hanging Out'

There is always a concern from the taxpayers of Westchester when it appears that there tax dollars are not being used wisely. Two cases, one in Mt. Vernon and the other in Yonkers, point to public employees being sued and accused of improper, and erratic behavior.

The case in Yonkers is now national news, because it includes nudity, texting, sexting and workplace chatter that is unacceptable and out of control, especially in an Elementary School.

A federal lawsuit has been filed by Gisselle Vasquez, a 35-year-old single mom, who worked as a spanish secretary at the Dodson School in Yonkers under Principal Evelina Medina.

Medina is accused in the lawsuit of sharing naked pictures of her lovers with Vasquez and of making Vasquez take semi naked pictures of herself. We have several semi-naked photos of Medina, and we printed a cleaned up version of one. Go to YonkersTimes.com for more clarity if you wish.

One photo was texed by Medina to Vaszquez of a man in bed holding his penis. On another day at the school Medina told Vaszquez to close the

door and then removed her pants, according to the lawsuit.

Vaszquez told the NY Post "To this day I don't understand what would make her so comfortable to ask me to do that for her," Vasquez told The Post, explaining that the women were not friends. Medina is accused of then texting the images of her to Vaszquez. "Medina used my client as her own personal drop-box to keep the sexy pictures away from her [Medina's] husband," said attorney Christopher Berlingieri. "Due to the serious nature of the sexual harassment here, we felt that there was no other option but to bring a civil action.'

Westchester Residents Eligible to Apply for \$20 M State Emergency Rental Assistance Program



As of June ,1 Westchester County residents are now eligible to apply for the New York State Emergency Rental Assistance Program (ERAP). Under ERAP, \$20 million has been earmarked for Westchester County households at risk of eviction due to their inability to pay rent and utilities because of

the COVID-19 pandemic. To Apply for the Emergency Rental Assistance Program visit

https://otda.ny.gov/programs/emergency-rental-assistance/#apply. ERAP is providing financial assistance for up to 12 months of past-due rent, 3 months of prospective rental assistance and 12 months of utility arrears payments to eligible tenants, regardless of immigration status. Payments will be made directly to a tenant's landlord or property owner, and utility company. Westchester will be assisting applicants throughout the County, except in Yonkers, where tenants and landlords will work directly with the municipality and its nonprofit partners.

Westchester County Executive George Latimer said: "The COVID-19 pandemic has brought a tremendous amount of financial hardship to many of our most vulnerable residents, and we want them to know that help is available. ERAP can provide a significant amount of economic relief to our low- and moderate-income households at risk of housing instability, and if

you meet the appropriate criteria, I encourage you to apply."

Commissioner of the Department of Planning Norma Drummond said: "Many Westchester County residents were devastated by the COVID-19 pandemic, and some are still struggling to get back on their feet again. This critical funding from New York State will help to ensure that those who experienced financial hardship will not become homeless and bring them the peace of mind they need to feel secure in their homes."



# Help Feeding Westchester Serve Those Who Are Food Insecure This Summer

At the end of a school year that looked and felt like no other, children across the country are eagerly awaiting summer recess. For millions of youth, however, summer too often means missing meals that they would have otherwise received at school. Feeding Westchester, the county's largest nonprofit hunger-relief organization, is gearing up for an increase in demand among families with school-aged children and challenges the community to get involved by participating in its Summer Help From Home Bags program.

Hunger affects the human body in countless ways, including making it hard to think straight and increasing the risk for chronic diseases. In children, growling stomachs result in a higher risk of behavioral and cognitive issues, mental disor-

ders, as well as long-term health threats like asthma.

"Proper nutrition is crucial for a child's mental, emotional and physical development," said Kelly Pearson, RD, CDN, nutrition resource manager at Feeding Westchester. "In addition to children who don't get enough to eat, low nutrient dense diets can also lead to poor health outcomes, such as nutrient deficiencies, malnutrition, anemia and risk for developing obesity." During the school year, 22 million U.S. children have access to free or re-

duced-cost meals at school. Surprisingly, fewer than four million kids nationally receive similar meals through USDA Summer Food Service programs, leaving a gap of 18 million children.

To help meet the increased summertime need, Feeding Westchester will continue to assemble and deliver free meals and food through organizations like the United Way of Westchester & Putnam, Boys & Girls Club of Mount Vernon and the Ossining and Elmsford school districts.

"Last summer, Feeding Westchester provided more than 5.6 million meals to children and families facing hunger," said Karen C. Erren, the nonprofit's president and CEO. "This summer, we continue on our commitment to ensure that youth in every corner of Westchester have access to the meals they need to thrive during and out of school. We are looking to the community to join us in our fight against hunger."

While in person opportunities continue to be limited due to the pandemic, Feeding Westchester has several Meals 4 Neighbors virtual volunteering projects on feedingwestchester.org. Designed to try at home, with co-workers or a local community group, these projects include packing Help From Home breakfast or lunch bags for school-aged children. # A Diverse Workforce for a Diverse County



Dr. Dial Hewitt and his colleagues in the Westchester County Department of Health have been on the front lines of the Covid-19 pandemic for the past year, working exhausting hours and putting their own health and safety on the line to serve others.

Despite the risks and the challenges they face, the Department's doctors, nurse practitioners, public health nurses, lab techs and support staff remain firmly committed to their mission: protecting the health and safety of the people of Westchester.

"You go into this field because you care about people and you get gratification from helping them," said Hewlett, who is board certified in Internal Medicine and in the sub specialty of Infectious Diseases.

"I am fortunate and blessed to work with such dedicated professionals," he said of his colleagues at WCDOH. Most recently, he has been helping oversee the County's vaccination clinic on Court Street in White Plains.

Hewlett noted that Westchester was ground zero for the Covid-19 pandemic, where an outbreak occurred in New Rochelle.

The virus spread through houses of worship, congregate care settings and other locations – and the Health Department staff mobilized swiftly to respond.

"They were willing to put their lives on the line when we didn't know very much about this disease," Hewlett said of the entire Health Department team. "Whatever we have asked of them, they do it."

Dr. Hewlett has also been involved in outreach to Westchester's minority communities to provide "accurate, scientific information" and encourage people of color to get vaccinated. He said he hopes to alleviate the hesitation of some Black and Latino residents to get the vaccine.

The executive team at the Health Department has been praised for its leadership during the pandemic, including: Dr. Sherlita Amler, commissioner; Renee Recchia, first deputy commissioner; Dr. Hewlett; Dr. Marisa Montecalvo, Dr. Ada Huang and Lori Smittle, PhD (doctor of nursing).

# Westchester County Hosts First Household Recycling Day June 12 at FDR Park - Yorktown

Westchester County's Department of Environmental Facilities (DEF) will be conducting a Household Recycling Day (HRD) Event on Saturday, June 12 from 9a.m. to 3p.m. at FDR Park, 2957 Crompound Rd., Rte 202, Yorktown. COVID-19 precautions are in place to allow DEF to once again host these events for County residents. Residents are should place items in their trunk or backseat, remain in their vehicles, and must wear masks while in the drop-off area.

In 2020, DEF hosted two HRD Events and residents delivered nearly 275,000 pounds of household waste and approximately 37,000 pounds of

documents for shredding.

In addition to properly labelled household chemicals, tires, scrap metal, electronics, appliances, and other special wastes found in a typical household, residents can bring documents for shredding and expired or unwanted medications for disposal to the May 8 HRD Event.

Generally, the following items are accepted for safe disposal or recy-

Properly labelled household chemicals, such as household cleaning products, most automotive fluids (antifreeze, brake fluid, gasoline, but not motor oil),flammable liquids (kerosene, butane, lighter fluid, turpentine) metal, jewelry, and furniture polishes and waxes; wood preservatives, fertilizers, pesticides, insecticides, herbicides, photographic and swimming pool chemicals, batteries - only vehicle, rechargeable, or button cell, fluorescent light bulbs & CFLs, fire extinguishers, BBQ propane tanks (up to 20 lbs.),mercury containing devices (thermometers and thermostats), electronic waste (TVs, computer monitors and towers), expired or unwanted medications, both OTC and prescription, personal documents for shredding (limit of four (4) file-size boxes per household), tires.

Items that will not be accepted and should not be brought to the Household Recycling Day include paint (both latex and oil), non-rechargeable alkaline and carbon zinc batteries (they can be safely discarded in the trash), motor oil, smoke detectors, cell phones, explosives (flares, fireworks, ammunition), construction debris and hypodermic needles. Also, waste from

businesses, schools, or other institutions will not be accepted.

If you are unable to attend the HRD Event, you can still dispose of your hard-to-get-rid-of household waste by making a convenient appointment for the County's Household-Material Recycling Facility (H-MRF), 15 Woods Road, Valhalla. #### Fighting for Equity for Special Education Students

#### Op-Ed from the 835 Schools Coalition

The New York State budget, which was approved in April 2021, increased Foundation Aid to public schools by more than 7% for public schools. Foundation Aid is the main source of state funding to local school districts to support a "sound basic education," for every student, as required by the state constitution.

Each year, driven by a complex formula – including the level of students' need - the Foundation Aid is determined for each school district. However, last week the New York State Division of Budget approved only a 4% increase for the 2021-22 school year for schools who serve children with special needs, despite the fact that the New York State Education Department had requested a 7% increase.

The approved increase does not represent equity or parity of investment in supporting students with special needs who have been placed in specialized schools. Local schools for children with special needs are members of the 853 Schools Coalition, which is urging approval of a 7% increase to provide services to these children whose home school districts have determined their needs exceed the capabilities of those public districts.

"It's imperative that we meet the needs of students who require special education services, and equally imperative that we support the programs providing these services," says Dr. Ed Placke, Executive Director of Green Chimneys and Board President of The New York State Coalition of 853 Schools. "The strength of the 853 school model is its provision of a fully integrated experience comprised of necessary academic development and individualized support services and/or mental health treatment. These programs fulfill a critical need for students who cannot access this level of services within the public school system. We must be able to rely on equitable support for all students through consistent State funding, regardless of where they receive their education."

The NYS Coalition of 853 Schools was formed in 1991 by a group of Chapter 853 residential and day schools principally located on the grounds of agencies that provide various child welfare, juvenile justice, and family/community support services. These educational programs are dedicated to improving the opportunities and outcomes for students enrolled in our schools. The Coalition speaks on behalf of a broad spectrum of special education students enrolled in our member agency schools – from those with emotional/behavioral issues to those with developmental challenges – by advocating, assisting, and representing the schools which sup-

port and educate them.

"It is unfortunate that the issue of equitable funding is not being considered for 853 schools. We serve public school students who have not had successful experiences in their district schools and it disappointing that the Division of the Budget only approved 4% when public schools received 7% in the enacted budget," states Dr. Angela White, Superintendent of Schools, Carol and Frank Biondi Education Center at Rising Ground.

The amount an 853 school receives per student/per day is called their tuition rate. The cost of tuition is calculated by the "tuition rate methodology" a methodology recommended by the New York State Education Department annually and approved by the Division of the Budget. The tuition rate methodology is a costbased formula that does not adequately keep pace with the actual real time costs of providing the critical services that are required under a child's Individual Education Plan (IEP).


Westchester State Senator and Sentate Education Chair Shelley B. Mayer said: "All students deserve to be supported and given the tools they need to succeed in the future -- the students in 853 schools are no exception. I stand with Rising Ground, Green Chimneys, Hawthorne Country Day and the many 853 and 4410 schools in their request for a 7 percent increase, as was approved for public schools and requested by the State Education Department. These schools provide critical services to our children who can't be accommodated by their districts while keeping them close to home and out of costly out-of-state schools. These schools deserve parity with the percentage increase provided to traditional public schools in this year's budget. I urge the State Division of the Budget to reconsider

and grant them the additional funds they deserve."

In the words of Ms. Linda Thomas, parent of a special education student: "Funding models for 853 schools is unnecessarily convoluted and it has been difficult to retain teachers under the current calculation for these schools. Our children need consistency, they develop bonds and relationships with staff who understand them and know how to interact with them effectively because they have behavioral issues and learning disabilities. I have seen staff change on a regular basis because the staff that are qualified to work with our children are underpaid. They main reason for underpayment is lack of funding. . . Public schools will be receiving a 7% increase, the highest level of state aid ever. Special Education Schools should be funded equally if not more due to the challenges they face. I believe whatever local school districts are getting, those same localities that teach special needs children should get an equal amount of money. Without proper funding, my son's education will be in jeopardy."

# Harrison Police Arrest Bronx Man on Burglary Charge

Following a month-long investigation, Harrison Police have charged a Bronx man with breaking into a home that was occupied at the time.

Emiljian Drekaj, 27, was charged with Burglary 2nd Degree, a felony. He is currently being held at the Westchester County Jail in lieu of \$25,000 cash bail/\$50,000 bond.

On April 1, 2021, the Harrison Police responded to a report that an unknown male had entered a residence through a rear door while the home was occupied. After being confronted by the nanny, the man fled out the front door and left in a vehicle.

Harrison Police investigators, through the course of the investigation, were able to determine a suspect vehicle. On May 7, 2021, after a monthlong investigation, the Harrison Police, with the assistance of the Westchester County District Attorney's Office and its investigators, and the New York State Police, apprehended Drekaj near his Bronx residence.

Search warrants were executed on the suspect's vehicles and at his residence, where evidence related to the burglary was seized.

up to the car and begin firing, usually at the heads of the unlucky couples. And while the crimes were happening in New York City, In Yonkers and in Westchester, the fear of the shooter was just as great. We were all reading the NY Post and Daily News and listening to the local news every night, and the NYPD couldn't crack the case.

The four part documentary is narrated by Paul Giamatti, directed by Joshua Zeman, and is based on the book by author and Yonkers resident Maury Terry. Terry's book The Ultimate Evil, outlines his theories on the case, which are that Berkowitz was part of a Satanic cult that played a major role in the killings.

Terry became obsessed with the Son of Sam story and began a decade long investigation, in which he penned stories for the Herald Statesment (Journal News today), NY Post and others before publishing the book. Terry believed that David Berkowitz was involved in a satanic cult that met at Untermyer Park and other secluded locations in northwest Yonkes. In the 1970's Untermyer Park was run down and in disrepair and looked nothing like it does today.

Members of the cult aided Berkowitz in the Son of Sam killings, according to The Ultimate Evil. Two Yonkers brothers, Michael and John Carr, fit the description. Both knew Berkowitz and their father was Sam Carr, so his

two sons could indeed be the Sons of Sam.

When Berkowitz was arrested after the NYPD followed up on a traffic tickets issued near one of the shootings, he confessed, explaining that his neighbor Sam Carr sent messaged through his dog. The NYPD and NYC Mayor Abe Beame wanted the Son of Sam case closed after 13 months of fear and front page stories, so no other suspects were considered after Berkowitz confessed.

But several questions remained. Why did none of the police sketches from witnesses and victims look like Berkowitz? Some victims and witnesses insisted that Berkowtiz was not the shooter, yet nobody was charged in the Son of Sam shootings and killings other than Berkowitz, who confessed to them and pled guilty. He continues to serve a lifetime sentence and is said to have become a Christian.

Terry visited Berkowitz before he died in 2015 and told him that his theory about John and Michael Carr was correct and they had done several of the shootings that he had confessed to.

Two familiar faces in the documentary are former Yonkers Mayor Phil Amicone and Kay Amicone, who is the sister of Maury Terry. LoHud recently wrote about the work of two Yonkers police officers, Peter Intervallo Sr. and his partner Thomas Chamberlain, who were convinced that Berkowitz was the Son of Sam 8 months before he was arrested after investigating the shooting of two dogs near Berkowitz's apartment.

Another request came in 2018, when Medina commanded Vasquez to buy a lingerie from the infamous Romantic Depot on Central Avenue.

The lawsuit also includes Dodson Assitant Principals Sandra Guzman and Christopher Cassano. Guzman is alleged to have had sexual discussions with Medina and Vazquez

The allegations in the lawsuit are more serious concenring Dodson Assistant Principal Christopher Cassano, who is accused in the suit of sexually harrassing Vazquez, asking sexually explicit questions and attempting to kiss her on the lips without her consent. Vazquez was eventually trasnfered to the Ceasar Chavez school, where she still works today.

Vazquez began formally complaining about the activity, according to the suit, contacting Human Resources staff and working up the chain to Superintendent Dr. Edwin Quezada, in an alleged email exchange, according to the suit. But nothing was done to try and change or rectify the position that Vasquez was placed in, other than the transfer.

The New York Post reported that Medina is no longer principal at Dodson. No comment from the Yonkers school district on the pending litigation.

In Mt. Vernon a different type of abuse is alleged, against communications director Daniel Terry. According to a report by Mt. Vernon Newscenter, "Mount Vernon NewsCenter received pictures showing Mount Vernon City Hall Communications Director #DanielTerrys take home vehicle driving thru city streets at a high rate of speed. This is a developing story. #Sources are saying that Terry was roaming thru city streets at 2:30 in the morning and appeared to be #intoxicated. We received dozens of pictures and and a statement from the tipster. Terry was allegedly seen inside the city-owned take home vehicle with liquor bottles exposed and friends.

We spoke to one resident in the area who saw the vehicle and said "this is how our TAX DOLLARS are being spent at 2:30 in the am."

The vehicle is a take-home vehicle and an eyewitnesses on the scene say there were people hanging and sitting on the bumper of the city vehicle. Terry was seen allegedly driving up the block, drunk, laying wheels with lights and sirens on. It's unclear if Terry was drinking while behind the wheel, but eyewitnesses say he appeared to be a intoxicated.

This is just another example of how this administration, under the leadership of Shawyn Patterson Howard has failed our community. Terry serves at the pleasure of the mayor, leaving police officers helpless because, if they pulled him over and caught him with those liquor bottles - it will make the mayor look bad. The mayor ignores all communication from MVNC. Will have more on the story later..."

We spoke to the Editor of Mt. Vernon NewsCenter, Atif Coleman, who is trying to see if there are other photos that have a clearer view of the license plate of the car. But sources who took the pictures claim that they saw Terry, "hanging out" at 230 AM on more than one occassion.

No comment from Mayor Shawyn Patterson-Howard, and more important, no denial from anyone at City Hall that Terry was not the driver of the City owned car in question.

We hope that the reports are true that former Principal Medina is no longer serving as the head of the Dodson school, and we also hope that Mr. Terry acknowledges, or explains the photos showing his City car out and about at 230 AM. And thanks to whoever it was that took the photos at 230 AM.

The taxpayers in Yonkers should no longer have to pay for Medina to work in the Yonkers Public Schools, and the taxpayers of Mt. Vernon should not have to pay for a City owned vehicle to be driving around the city at 230 AM, unless it is Mt. Vernon Police or Fire.

Commissioner of the Department of Social Services Leonard Townes said: "The Emergency Rental Assistance Program will deliver desperately-needed help to Westchester landlords and tenants who have incurred financial hardship due to the pandemic. We at the Westchester County Department of Social Services are eager to assist tenants struggling with back rent and utility bills to apply for this lifeline."

New York State residents are eligible for ERAP if they meet all of the

following criteria:

Household gross income is at or below 80 percent of the Area Median Income (AMI). These income limits differ by County and household size. A household may qualify based on current income or calendar year 2020

income that is at or below 80 percent AMI.

On or after March 13, 2020, a member of the household received unemployment benefits or experienced a reduction in income, incurred significant costs or experienced financial hardship, directly or indirectly, due to the COVID-19 pandemic.

The applicant is obligated to pay rent at their primary residence and has rental arrears (rent overdue) at their current residence for rent owed on or after March 13, 2020.

The household must be at risk of experiencing homelessness or housing instability, which can be demonstrated by having rental arrears owed on or after March 13, 2020.

For the first 30 days of the program, the unemployed, those with income at or below 50 percent of area median income and other vulnerable populations will be prioritized for assistance. After this period, applications will be processed on a first-come, first-served basis.

To simplify the application process, and ensure landlords and tenants have the support they need to apply, the County is partnering with 11 local nonprofit agencies to provide free aid to individuals seeking to apply for ERAP. Applicants can also call United Way of Westchester and Putnam's 2-1-1 hotline with any questions and to find a nonprofit partner in their community. Rental counseling is available, in English and Spanish, with guidance for gathering the documents needed and access to computers to complete the application online.

Marlene Zarfes, Executive Director of Westchester Residential Opportunities in White Plains, one of the 11 nonprofits with whom the county is partnering, said: "We know that the pandemic has been challenging for both tenants and landlords, and we want them to take advantage of this great funding resource. Our goal is to simplify the application process so they can get the financial relief they need. We urge applicants to act quickly. Let us help you to ensure you have all of the necessary documents in place to file your application immediately."

The New York State Emergency Rental Assistance Program is being funded by \$100 million from the state and \$2.6 billion in federal aid. West-chester County's application assistance program is being administered by the Westchester County Department of Planning. For more information, visit

Westchester County Police Welcome New K-9, Acorn and Say Goodbye to Retired K-9 Daisy

Acorn, an adorable, black Labrador Retriever, began training for Paws with a Cause, an organization that provides service dogs for people with disabilities. However, his desire to sniff everything got him kicked out of service dog training, but made him a great fit as an Accelerant Detection Canine (ADC).

Acorn and his human partner, Detective John Peters, graduated from the State Farm Arson Dog Program as the Westchester County Police Department's second ever Accelerant Detection Team this past April. The State Farm Arson Dog Program has trained more than 425 canines in 46 states since 1993.


There are currently more than 100 certified teams trained through the program investigating suspicious fires throughout North America. State Farm provides the funding and the teams are trained by Maine Specialty Dogs under the authority of the Maine State Police. ADC Teams are each made up of a human handler and a canine partner trained to work together to locate potential evidence of arson following a fire.

While on a scene, Acorn's job will be to alert Detective Peters to the location of an accelerant, such as gasoline or oil, that may have been used to start the fire. Detective Peters will then collect the evidence and send it to a laboratory for confirmation and identification. Each year, hundreds of lives are lost and billions of dollars' worth of property damage occur as a result of fires set by arsonists.

The goal of the State Farm Arson Dog program is to combat arson and provide law enforcement officials with the tools to combat this deadly, costly crime. Labrador Retrievers are primarily chosen for the program because of their superior ability to discriminate scents at a fire scene. They also typically have good dispositions and outgoing personalities, and are very active.

Acorn became an official ADC on April 30, the same day his predecessor, Daisy, retired. Daisy's well-deserved retirement comes after serving with Detective Peters on Westchester County Police Department's first ever ADC Team since 2012. "During her impressive career, Daisy assisted in more than 700 fire investigations, ranging from multi-million dollars loses to fatal cases, and proved to be one of the most valuable tools in these investigations," said Detective Peters.

"When not investigating suspicious fires, Daisy participated in hundreds of public relations details, visiting groups ranging from pre-school students through senior citizens," adds Detective Peters. "The ADC is an invaluable resource for police and fire agencies in West-chester County," says Westchester County Police Commissioner Thomas A. Gleason. "We are grateful to State Farm for its ongoing partnership and for its support of this important program. I thank Daisy for her service and we welcome Acorn to the Westchester County Police." Daisy will spend retirement simply being the beloved pet of the Peters' family, along with their pit-bull, Toby.
