Solid Waste Commission Fines Competitive Carting \$42,000

Prior Fines Unpaid, Vendors Seeking Payment and Horrible Service to the Customers, the taxpayers of Yorktown

The Westchester Solid Waste Commission, at their meeting on June 14, fined Competitive Carting Co. \$42,000 for failure to pay prior fines and violations. Competitive Carting was hired by the Town of Yorktown last year to take over the garbage and recycling operations for Yorktown residents and homeowners.

According to the Facebook group Yorktown Trash Talk, Competitive Carting has provided a dismal performance, including late pickups, no pickups, and breaking down and leaking trucks.

The Solid Waste Commissioner violation read, that Competitive Carting is fined \$42,000 for failure to pay commission fees, failure to complete license requirements, and a prior violation for failure to pay fines, which were \$21,000.

Reports are coming in that Competitive is not paying its vendors. That includes a gas station and automotive service, and tire company, all in Westchester. We did speak to the owners of these businesses and confirmed the financial trouble they were having with Competitive. One Competitive truck is at the auto shop and will not be leaving until the bill is paid.

Yorktown Trash members have reported on a truck with Duffy's on the side picking up on their street. Duffy's located in Vermont, has no connection to Competitive Carting, other than they sold the truck to them. Apparently, there may be a financial issue with the purchase of the truck. We called Duffy's and left a message. Some on Yorktown Trash claim that the truck still has Vermont plates.

The Duffy's signage and the registration are violations which were not addressed by the Solid Waste Commission.

Some of the recurring themes and comments on Yorktown Trash Talk in-

clude:
-Unmarked truck picking up regular garbage in Shrub Oak. 5:15 pm. They ran

the compactor and left puddle-leaking fluids.

-I'm in Mohegan Lake near Shrub Oak and our garbage wasn't picked up today! It's still out there!!

-At 5:30PM my cardboard recycling got picked up by an orange truck with a handwritten sign that says competitive carting. Five minutes later a plain black truck came to pick up the plastics in the bin. Well at least it wasn't Duffy's truck this week!

And here's the question that more and more people are asking in Yorktown. Our Board at work. They picked the least competent trash collection money could buy. Wonder why?

A lawsuit filed by AAA Carting, the previous garbage company hired by the


Jenkins Endorses Mayor Spano for Reelection in Yonkers; Cappelli Named as New Rochelle Donor

Let's Do Something About Bullying in Memory of Lukas Illescas

Many questions remain surrounding the death of 10-year old Gianlukas "Lukas" Illescas, of Peekskill, who died on May 25. Lukas' parents say that their son committed suicide; the Westchester Medical Examiner determined that Lukas died of accidental asphyxia, or a lack of oxygen.

Lukas was a student at Hillcrest Elementary School in Peekskill. According to his parents, Lukas was the victim of relentless bullying, and that is the reason that he took his own life.

Lukas' father, Christian Illescas, and a number of family members and supporters, attended a Peekskill School Board meeting on June 6 to claim that nothing was done to protect Lukas from the bullying, or to deal with the situation.

"You didn't have time? Five minutes. I don't know how you can sleep. I don't know how. They say they can't help me because they're too busy. I have nothing to lose. My son is gone. So, all I want now is justice for other kids."

Christian Illescas added that his sone was so scared of the bullying that he begged his family to let him stay home, and that the bullying went on for months

Other parents at the meeting said that their children were the victims of bullying and demanded that the school district take action. Negligence was also alleged against the school district.

A GoFundMe account has been set up to help the family with Lukas' funeral costs. The page (gofund.me/69c3accf) reads, "Please let us show a unified front to protect our children from senseless neglect from school administration, and harsh bullying. Our children deserve to feel safe and heard at school!! Bullying is responsible for the death of a 10-year-old child! Lukas was robbed of his future. He will never get to graduate with his friends, make memories alongside his family, and have a life full of choices and adventure! His family and friends are heartbroken and beyond devastated. Please show your support by making a small donation to help with the funeral cost, the family relocating after this tragedy, and anything else the family needs to get back on their feet. Or you can also help by simply sharing Lukas's story. How many more children need to suffer for there to be change?"

Members of the Latino community in Peekskill have been among the most vocal after Lukas' death, and in claiming that nothing was done to prevent his

Pace U Women's Lacrosse Team Wins D2 Championship, Goes to The White House

Congratulations to the Pace University Women's Lacrosse team for winning the 2023 NCAA National Championship with a resounding 19-9 Victory in the final, defeating No. 1 ranked West Chester University (from PA) 19-9 on May 21 in Indianapolis to win the first title in program history.

The 19 goals scored by The Setters were the most-ever scored in a DII Women's Lacrosse championship game, and they are the first NCAA collegiate team in Westchester County to win a National Championship

As a result of winning the D2 National Title, the Setters were invited by President Joe Biden and First Lady Jill Biden to the White House on June 12. The Setters were among many from the NCAA men's and women's national championship teams from across the country being recognized on the South Lawn of the

White House as part of "College Athlete Day."

"We were incredibly honored to receive the invitation to the White House to commemorate our NCAA Championship team," said Head Coach Tricia Molfetta, who is in her sixth year with the team. "This has been a year of so many firsts for our program and this feels like the most fitting ending to our once-inalifetime season. When I first told the team they were invited, they were beyond

Garbage Guy Who Spent \$130k on Strip Clubs He Charged \$40k in One Night!

City Carting Manager Gets Six Months for Filing False Financial Records; Spent \$135k on Strip Clubs

Westchester County District Attorney Miriam E. Rocah announced today that City Carting of Westchester, Inc., and its manager pleaded guilty on June 6, 2023, to submitting false financial records that concealed tens of thousands of dollars in company money spent at strip clubs.

DA Rocah said: "This brazen misuse of taxpayer dollars is an abuse of public trust by a government contractor, and my Office will continue to investigate and prosecute cases of public corruption and seek accountability for this kind of criminal conduct."

City Carting's Manager, Christopher Oxer, 37, of Darien, Connecticut, pleaded guilty to Offering a False Instrument for Filing in the First Degree, a felony, and City Carting of Westchester, Inc., pleaded guilty to Attempted Offering a False Instrument for Filing in the First Degree, a misdemeanor. In accordance with their plea agreements, Oxer will be sentenced on August 2, 2023, to six months in jail, which will run concurrent to his one-year federal prison sentence for tax fraud charges related to his conduct, and the corporation will be required to pay a \$5,000 fine, which is in addition to separate fines levied against City Carting by Westchester County, who terminated their contract.


As part of City Carting's annual \$20 million contract with Westchester County to manage and process waste and recyclables, the corporation was required to file their financial records with Kroll Associates. Kroll was appointed as an independent monitor to ensure City Carting was operating in compliance with all criminal and civil laws and without influence from members or associates of organized crime. The records, received by Kroll and the Solid Waste Commission, a county regulatory agency, were the subject of the Commission's referral to the Westchester County District Attorney's Office.

The District Attorney's Office investigation found that the defendants submitted false financial statements that concealed transactions Oxer made at strip clubs in New York City between 2018 and 2019 totaling \$135,000 on the corporation's American Express credit card. One transaction included \$40,000 that was spent in a single visit at one establishment. Those expenditures were entered into City Carting's accounting records as business expenses for items such as tires, tolls, equipment and maintenance.





Sing Sing Cold Case Murder Solved



Two Men Formerly Incarcerated at Sing Sing Indicted for 1995 Murder

Westchester County District Attorney Miriam E. Rocah and New York State Police Acting Superintendent Steven A. Nigrelli announced today that two men who were incarcerated almost 30 years ago at Sing Sing Correctional Facility in Ossining were indicted for the December 24, 1995 murder of Michael Jones, who was also serving time at the facility. Their arrest was the result of a decades-long investigation—initiated in 1995 and reinvigorated in 2019—by the New York State Police and the Westchester County District Attorney's Office.

DA Rocah said: "After 27 years, we have secured an indictment for the murder of Michael Jones, thanks to the phenomenal investigative work by the New York State Police, who never gave up on this case, and the hard work of our Cold Case and Homicide Bureaus. My Office is committed to working closely with our law enforcement partners to solve the more than 100 open homicide cases in Westchester County."

Acting Superintendent Nigrelli said: "I commend the work of our State Police investigators, the Westchester County District Attorney's Office and all our law enforcement partners for their tenacity and long-term commitment to solving this cold case. It is because of their extraordinary work and dedication that these two men are finally being brought to justice."

A Westchester County Grand Jury indicted Steven Smith, 60, of Salisbury, North Carolina, for two counts of Murder in the First Degree and Murder in the Second Degree, both felonies, and Allah-Son-Allah, 53, of Albany, for Murder in the Second Degree. Allah-Son-Allah was arraigned before Judge Maurice Williams in Westchester County Court on May 16, 2023, and Smith was arraigned before Judge Robert Neary on June 2, 2023. Both defendants were remanded.

After years of traveling to multiple states to interview several witnesses who were incarcerated at Sing Sing, the investigation determined the two defendants and the victim were allegedly members of The Five-Percent Nation, also known as The Nation of Gods and Earths. On December 24, 1995, at approximately 8 p.m., as a result of a feud within the organization, it is alleged that upon Smith's direction, Allah-Son-Allah used a buck knife to stab Jones in the chest, puncturing his heart, causing him to bleed to death.

One parent we spoke to in Peekskill said, "Do they know who the bully is? How is he being disciplined or punished? Did he commit a crime? Is it time to stop coddling those in our society who are abusing us?"

We all know that bullying is a national problem. The Uvalde Foundation for Kids, a national nonprofit organization formed following the May 2022 Robb Elementary School shooting & dedicated to ending school violence, has announced that it has received numerous requests for assistance as well as an independent review of the recent bullying related suicide death of 10 year old student, Lukas Illescas; a former student at Hillcrest Elementary school.

Foundation officials noted in the release that numerous reports have already been documented on bullying incidents at the school. Family membrs, among others, have charged the school with failing to intervene on behalf of the student & others over a period of months and even years.

The foundation noted that it will begin to interview students and parents independently regarding concerns. The foundation noted it is extending resources to the school community; including a 24 hour student bullying support line & mental health resources stating that it hopes to serve as a third party intermediary between school and district administration & the family of the student and those also expressing similar concerns.

About one in five high school students reported being bullied on school property, and more than one in six high school students reported being bullied online in the last year, according to the CDC.

Nearly 14% of public schools report that bullying is a discipline problem oc-

curring daily or at least once a week, the CDC says.

The federal government provided resources for parents, victims and school districts on stopbullying.gov, which is managed by the U.S. Department of Health and Human Services.

"When adults respond quickly and consistently to bullying behavior they send the message that it is not acceptable," the website states. "Research shows this can stop bullying behavior over time. Parents, school staff, and other adults in the community can help kids prevent bullying by talking about it, building a safe school environment, and creating a community-wide bullying prevention strategy."

State of the Art Weapons Detection System at Westchester Department of Corrections

Department of Correction Commissioner Joseph Spano said: "The implementation of this technology was not in response to any specific threat, and is just another proactive measure to enhance overall facility safety for staff, residents and civilian visitors. It aligns with other technological measures that have recently been installed at our complex to combat the introduction of contraband, such as the full body scanner units being used at our intake and visitation centers, and our mail screening units. These security enhancements are made possible because of the support we receive from County Executive Latimer and his Administration. The WDOC workforce greatly appreciates that support and are very pleased to have this additional layer of security in place."

Motorola Solutions-Evolv CWD technology has been used to screen more than 60 million people-second in numbers only to the US Department of Homeland Security's Transportation Security Administration. The system spots concealed weapons and other threats using advanced digital sensors and artificial intelligence and has proven to operate up to 10 times faster than the traditional metal detectors.

Founder, Shepherd Communication and Security Richard Ruzzo said: "We believe that the Westchester Department of Correction is the first New York State jail to leverage sophisticated technology of this nature. Our team worked very closely with WDOC representatives to ensure that the Motorola Solutions – Evolv CWDsystem meets all of their expectations and delivers the intended protections without sacrificing the visitor experience".

Town, has filed a lawsuit alleging that the town selected a company, Competitive, who was not qualified to complete the terms of the contract.

Competitive was the low bidder at \$3.5 Million; AAA bid \$3.8 Million. So, the Town, and Supervisor at the time Matt Slater, could say that they saved taxpayer money by going with Competitive. But at what cost?

Competitive has had to reduce the Bond that it posts to protect the Town and its taxpayers, from a yearly term to monthly. Why? Because they couldn't afford to pay for the yearly insurance bond. So, if Competitive is unable to continue to live up to the terms of the contract, the Town will only have one month of insurance money to find a new garbage company, instead of one year's worth of funding.

All of this points to Competitive financial outlook in severe financial distress. Another interesting part of the violation against Competitive was for Failure to comply with license requirements. The contract between the Town of Yorktown was for five years. Two-year contracts are the term that is approved by the commission, but the applicant can request a five year term. But Competitive never asked

It is also interesting that the Town didn't require Competitive to get permission

for the longer contract.



"Yonkers is on the move and the jobs not done. I'm proud to support Mayor Spano and I ask that you all join me in voting for him on the June 27th Primary day."

Spano is running for reelection in the democratic primary in Yonkers against City Councilwoman Corazon Pineda-Issac, and educator Margaret Fountain-Coleman.

Pineda-Issac also has a job in Westchester County government, so the endorsement from Jenkins, the 2nd ranking official in county government, for Spano is even more noteworthy. Jenkins has been rumored to be the leading candidate for County Executive in 2025.

The race for Mayor in New Rochelle had a question mark in it as questions were raised as to who contributed \$60,000 to the Westchester County Democratic Committee, who then transferred those funds to New Rochelle Democratic Mayoral candidate Yadira Herbert-Ramos

Questioned raised by Maher about the contribution, and from initial reporting by Robert Cox, Talkofthesound. com, resulted in the Westchester County Democratic Committee filing their required financial disclosure reports, and reveal who was the donor.

The answer was Westchester developer Louis Cappelli Jr. And in addition to the \$50k donation from Cappelli, his son Michael gave \$10k to the WCDC as did four other associates of Cappelli, Peter Palazzo, Bruce Berg, Paul Slaney and Andrew Attara.

So, a total of \$100,000 was donated to the WCDC, and \$60,000 (not \$50k as previously reported) went to Herbert-Ramos.

But WCDC VP Karen Pecora: said she was unaware that the party had made a contribution of such magnitude. "I'm really shocked that we would give that much in a Democratic primary."

One Sound Shore Democrat joked, "The Westchester Democratic Committee got a pretty big fee (\$40) for being in the middle of this transaction."



NO DUMPING TOXIC WASTE INTO THE HUDSON RIVER!

Dumping Toxic Waste in the Hudson?

Holtec International, the company in charge of decommissioning the Indian Point Nuclear Plant in Buchanan, NY, wants to dump up to one million gallons of radioactive wants from the plant's spent fuel pools into the Hudson River as early as this summer.

Indian Point's spent fuel includes several contaminants, notably tritium, a highly toxic and radioactive isotope that can lead to higher rates of cancer if ingested, inhaled, or absorbed through the skin.

The dumping of Indian Point's nuclear waste threatens our public health and the environment. The Hudson River is an essential estuary which provides an ecosystem for various fish and marine life. Seven Hudson Valley communities source their drinking water from the River and many residents along the River use these waters for recreation like boating and fishing.

The Hudson River has been a target for big polluters in the past and must be protected. From oil barges being proposed on the River to the construction of a new fracked gas plant up the River in Newburgh, NY, the

Hudson River has a long history of being targeted by big polluters. Thanks to an immense amount of grassroots opposition, these above mentioned proposals were stopped. But the River, its economic benefits and health of residents still remain in danger. We must tap into the same advocacy that has stood up for the Hudson and the communities along that water.

Other options exist for Holtec other than dumping the waste.

Currently, this waste remains on-site, where Holtec could keep it so it can safely break down until the radioactive isotopes become inactive. Holtec, however, wants to put their shareholders over local residents and are willing to treat the Hudson as dumping grounds for their toxic waste.

Several local lawmakers, including Senator Peter Harckham and Assemblywoman Dana Levenberg who represent the region, have called on Holtec to stop this proposal. Now it's time for the Governor to raise her voice and make sure this dumping doesn't move forward.
