Two Recent Disturbing Incidents in the Lakeland School District

My daughter graduated from Lakeland High School, class of 2018. So, the recent bit of bad news coming out of Lakeland is both disturbing and surprising. Our headline comes from the group Lakeland RISE. At a recent home game, Lakeland vs Nyack, the Nyack Cheerleaders reported that they heard racists slurs from someone in the crowd, once during halftime, again at the concession stands, and finally when they were leaving.

Several news reports claim that an investigation is underway by either the Yorktown Police or the Westchester County police. We certainly hope so, and hope that a video can be found of who it was who had the audacity to do this three different times? Without any adults in the crowd hearing them? Or anyone in the crowd who heard it coming to the Police?

Lakeland RISE wrote, "We were dismayed to hear that Nyack cheerleaders at a Lakeland football game were taunted with racial epithets. We feel the district continuously dodges its responsibility to undertake serious, and much-needed, equity work. While improving crowd control and working with local police to secure events are fine measures, they are not a substitute for the district-wide, systemic changes needed to educate students, train staff and increase educator diversity. We're calling on the district to select members of the Equity for All committees that are committed to supporting and implementing substantive, district-wide changes. They should also be able to undertake meaningful building-level initiatives, such as school climate surveys, without ongoing interference from the district administrators or board of education."

We would recommend another way that might also be useful. (We are assuming that a student in the crowd made the slur). Find out who did it and who said it and tell the school district and the Yorktown community.

A few years ago, at a victory celebration for Yorktown Supervisor Matt Slater, one of his supporters called Slater's democratic opponent, Vishnu Patel "A Sand N-word." That person was exposed and was embarrassed by his actions. Let that happen again with this incident.

Most of the students at Lakeland High School don't condone what was said. This is a blemish on them as well, even more reason to find out who did it. Lakeland student Nick Jurado was interviewed by WABC TV-Channel 7 and said, "That's just something we don't want coming in here," Jurado said. "We don't condone that at all. We respect everybody we play, including the cheerleaders."

Another Lakeland student, Nalia James said, "It's upsetting, but it's not surprising at the same time. Because we go through stuff like this on almost a daily basis with people in our schools."

The Westchester Coalition for Legal Abortion, WCLA, recently celebrated its 50th anniversary, with its goal "to keep abortion legal and to ensure that all women, regardless of age, race, class, status, geography or ability to pay, have full, unimpeded access to reproductive health care."

Through the work of the WCLA's PAC, the Westchester County Board of Legislators currently has a 15-2 democratic super majority. And all 15 of those democrats on the county board are pro-choice and have the support of WCLA PAC.

But over the past few months, in dozens of email blasts, WCLA PAC has been warning its supporters that "Anti-choice extremists are on the ballot right here in Westchester, running for NYS Supreme Court and for the County Board of Legislators. 

One Recent poll has Governor Kathy Hochul's approval rating at an all-time low of 33%. Another poll has President Joe Biden ahead in New York state by only 9 points. Mt. Vernon Library Trustee Gets Arrested at Board Meeting; Harrasses Two Female Trustees

First, let us thank BlackWestchester.com for their coverage of this story. Jonathan Davis is a Trustee of the Mt. Vernon Public Library. On September 20, at approximately 7:55 p.m., following the adjournment of a meeting of the MVPL Board of Trustees, Mr. Davis violated the Code of Conduct Policy,

According to a police report and other documents, Davis is reported to have repeatedly shouted the phrase "this bitch, bitch, your fucking lying bitch!" referring to a female trustee, Hope Marable, after being removed from the office of board president by the board, and eventually charging that female Ms. Marable with a clambed first

clenched fist.

Davis continued to harass Marable until the Mount Vernon Police eventually intervened. After this incident, Davis is accused of grabbing Board President Chanese Coleman, while she was leaving. David cursed at Coleman and asked her to get in his vehicle.

Before she could drive off, Davis drove his car and blocked the exit from the parking lot and tried to enter Coleman's car again. An order of protection has now been issued against Davis. There is videotaped evidence of what happened. When Black Westchester first reported this, Davis began posting on social media,

Letter to the Editor: The Harassment & Bullying of Rye Town Employees – Must Be Stopped

With recent news articles regarding various mis-management issues by the Town of Rye Administration – I felt it prudent to inform our communities (Port Chester, Rye Brook, Rye Neck) of the on-going harassment many Town employees, both past and present have experienced over the past few years across various departments.

During the past several months, as an employee of the Town, I have been subjected to an unfounded HR Investigation, personal accusations intended to damage my integrity and credibility as a manager. This pervasive professional abuse was led by the Town Administrator/Debbie Reisner, the Town Attorney/ Jeff Binder, the Director of Grounds & Facilities/Vic Federico, all under the leadership of Town Supervisor/Gary Zuckerman.

Since Debbie Reisner heads up all things HR related and Jeff Binder all things legal, I had no internal support to turn to, so the abusive treatment continued for months.

As a result, last week I was forced to resign my position of almost 4 years as Community Liaison of the Town and Assistant Park Manager at Crawford Park. The primary role of these positions was the sales and management of all events at Crawford – which has successfully generated a considerable revenue stream for the Town.

But this is NOT just about me. Many Town employees are being bullied, treated with disrespect, and frequently scolded in front of their co-workers. They have been silenced on occasion (most recently some were told not to discuss anything about my resignation as it could impact the upcoming election results). Some staffers personally shared with me they tolerate this harassment for fear of losing their job. Other staffers who fought back have been fired for what the town considered non-compliance or lack of qualifications. Then, there are those of us who fought back and reluctantly resigned for reasons rooted in our respective experiences.

Many of the 100+ people employed by the Town are our friends, neighbors, and family members. They are dedicated hard-working people who should be respected and appreciated. Condescending comments and personal humiliation should not be a part of anyone's workday.

It is my opinion that our community should be aware of what is happening inside the Town offices. The management style of the current administration is unacceptable and must be stopped.

With election day around the corner and Town Supervisor Gary Zuckerman running for re-election – I urge you to consider your options. Please think before you vote....

Do you want this treatment of our friends, neighbors, and family members to continue for another 4 years? I certainly don't! What do you think?

Unite NY Poll: Governor Hochul's Approval Rating Drops to 33%

57% Say NY on Wrong Track

A new poll out from nonpartisan Unite NY shows Governor Hochul's approval rating dropping from 50% in March to 33% by last month, with two-thirds of independent voters saying the state is on the wrong track. These stunning numbers come from the latest edition of Unite NY's Voter Empowerment Index (VEI). Support for the state legislature is even lower, at a meager 29%, while voters once again consistently assert politics are so bad in the Empire State, they are considering moving, with a whopping 40% considering packing their bags.

All is not bleak, though as strong majorities voiced their desire to see New York state implement important reforms such as term limits, citizen ballot initiatives, and nonpartisan primaries.

For nearly two years Unite NY has been measuring voter sentiment towards democracy reform via the organization's Voter Empowerment Index. The latest VEI, conducted just prior to Labor Day, found falling ratings for politicians and steady support for reform. Once again, voters identified crime and public safety (42%) as their most important issues, followed by taxes and state spending (30%) and immigration (25%). For New Yorkers aged 18-34, affordable housing (32%) was their largest concern.

Governor Hochul's approval rating has fallen steadily this year following her November 2022 election, starting at 50% in March of 2023, falling to 40% in June and dropping to 33% currently. The state legislature's already low approval rating fell from 36% in March to 29% in this latest poll.

Contrasted with cratering support for elected officials, those surveyed continue to consistently back key reforms that will give more power to voters, including term limits for Governor (75% support), term limits for the State Legislature (75% support), citizen ballot initiatives (71% support), nonpartisan primaries (65% support), and ranked-choice voting (46% support). New Yorkers also recognize New York is behind other states, as only 10% feel that the state is ahead of the curve when it election reforms, while nearly half (47%) believe the state has fallen behind.

Unite NY Executive Director Tim Dunn said, "For two years our Voter Empowerment Index has consistently found that voters support common sense reforms such as term limits and nonpartisan primaries, while approval ratings for elected officials continue to fall. New Yorkers want a government that embraces solutions and not politics and this latest research demonstrates growing voter dissatisfaction with elected officials who do not act on these measures. The good news is the VEI found voters are willing to try and connect with others from across the aisle and we urge lawmakers to embrace reforms that reduce partisanship and increase results."

Among the VEI's positive findings, more than half of those surveyed (53%) said they would attend a cross-partisan event to talk about issues with those who have different opinions and more than a third of New Yorkers (36%) think politics are fixable.

The survey polled 800 likely New York State voters on their attitudes towards present day politics and political reforms. The margin of error is 3.5 percent. The entire survey is available on the Unite NY website at: https://uniteny.org/voter-index/.

claiming that the incident didn't happen.

Black Westchester then obtained additional evidence and reports and witness statements from the Mount Vernon Police Department confirming that Davis's actions did indeed happen.

This is an example of a member of the Journalistic community properly reported a story but was attacked for writing "Fake News."

This type of push back against the media is happening in our country and all over the world. Fortunately, Black Westchester and Editor AJ Woodson was able to back up his story with more facts and a follow up.

Another media colleague in Westchester, the Yonkers Ledger, highlighted the Black Westchester story and wrote, "We would like to highlight this important piece by our colleague, AJ Woodson at Black Westchester Magazine, and stress the importance of civility in civic life."

NYS Independent Redistricting Commission & Chair Ken Jenkins Await Courts Decision on Congressional Boundaries-Nov. 15

Westchester County Deputy County Executive, and New York Independent Redistricting Commission Chair Jenkins, and Commissioners Collado, Cuevas-Molina, Flateau, and Frazier have invited public input on congressional districting while awaiting a decision from the New York Court of Appeals in a case concerning the Commission's constitutional obligation to complete the congressional redistricting process. Argument before the Court of Appeals is scheduled for November 15, 2023.

The public is invited to submit input by emailing submissions@nyirc.gov or by sending mail to 250 Broadway, 22nd Floor, New York, NY 10007 Attention: Submissions, Independent Redistricting Commission. All submissions received will be made available to all Commissioners and staff.

Should the public wish to view the congressional plans the Commission previously submitted to the Legislature, those plans can be found at https://www.nyirc.gov/plans.

Should the public wish to view the congressional plan drawn by the Special Master appointed by the Steuben County Supreme Court and used in the 2022 congressional elections, that plan can be found at https://www.latfor.state.ny.us/maps/?sec=2022_congress.

On June 28, 2022, a group of NY republican voters filed a lawsuit against the New York Independent Redistricting Commission (the "IRC" or "Commission") in Albany County Supreme Court asking for a writ of mandamus that would direct the Commission to prepare and submit to the Legislature a second congressional districting plan and the necessary implementing legislation for such plan.

On July 13, 2023, the New York Appellate Division, Third Judicial Department, granted the writ and directed the New York Independent Redistricting Commission to "commence its duties forthwith." That order is currently on appeal to the New York Court of Appeals, which has scheduled a hearing on the matter for November 15, 2023. The Court of Appeals has held that although the Appellate Division's order is stayed pending appeal, the "stay does not prohibit the IRC or its members from taking any actions."

Accordingly, Chair Jenkins, and Commissioners Collado, Cuevas-Molina, Flateau, and Frazier are taking action to obtain public input in the event the Court of Appeals affirms that the Commission is required to submit a second congressional districting plan to the Legislature. As the Appellate Division held, the "right to participate in the democratic process is the most essential right in our system of governance," and the Commission process is the "means of providing a robust, fair and equitable procedure for the determination of voting districts in New York."

Former NY Congressman John Faso, who has been leading the fight against the congressional lines drawn by the democrat majorities last year, argues that the democrats legal arguments for new lines to be drawn are "absolutely bogus" and accused them of trying to "re-gerrymander the state. It's really unbelievable that they would put the candidates and public through this again," Faso said to USA Today.

The NYS Court of Appeals, the highest court in the state, will begin on Nov. 15 to hear arguments about whether to have the Independent Redistricting Commission attempt again to redraw congressional districts in NY. Democrats are hoping that the court says yes and that the IRC can come up with a new set of congressional lines that are fair to both parties.

The resulting Congressional districts in NY in 2022 helped several House republicans, including Westchester congressman Mike Lawler, win their elections and helped republicans hold a slim, 5 seat majority.

Faso believes that the court of appeals will not grant the IRC another chance at congressional redistricting because, "The constitution is clear that there is no mid-decade redistricting," and that the next time the lines will be redrawn is in 2030.

If the Court decides early next year to allow another attempt at bi-partisan redistricting, the IRC will have another chance to get its members to agree on a new set of maps. If the IRC can come up with an agreeable set of maps, those maps would have to be approved by the democratic majorities in the State Senate and Assembly, with input from Governor Kathy Hochul.

Theoretically, that would give enough time for the congressional lines to be used in the June primaries in 2024.

"Racist and hurtful comments are never acceptable and have no place in our community, and we take reports of this nature very seriously," Lakeland Superintendent Karen Gagliardi said in a statement. "We are working closely with the Superintendent of Nyack Schools, our administrative team, and local police to investigate this matter and ensure all feel welcomed, respected, and safe on our school grounds."

Nyack Superintendent Yom said, "Any incidents of harassment, bullying or discrimination are investigated, so that we can ensure that appropriate action is taken immediately." We wonder what, if any, investigation or video might be found back in Nyack that might be helpful here.

SOMEBODY HAS TO KNOW WHO SAID THIS

The second incident concerns former Lakeland teacher Alejandro Mendoza, who is accused of grooming a 16-year-old student and repeatedly having sexual intercourse with her in his office and classroom at Walter Panas High School, according to a News 12 report.

Medoza resigned from his Lakeland position this year but was recently hired in the Monore-Woodbury school district. Five days after he was hired, a civil lawsuit was filed by his former student in Lakeland, alleging that he had sex with her on numerous occasions, most inside Panas High school. The district was notified by the now-former student's attorney of the allegations last April.

"Lakeland RISE would like to address two recent disturbing incidents in the Lakeland school district. The allegations against a former Walter Panas teacher, and the actions of the Lakeland school district administration, are extremely disturbing. While we don't know many details, we do know that all allegations of sexual abuse need to be thoroughly investigated, and not by the defendants being accused in the case. We ask that an outside, independent investigation be conducted by a respected third-party that can approach this work impartially so that there's an accurate understanding of the district's role in this incident."

The Lakeland School District said that they reported Mendoza to the NYS Education Department in April, yet he was able to get another job this fall and did not have his license revoked. State law prevents the State Education Department from denying employment clearance to teachers or revoking their teaching licenses until a review proceeding is concluded."

State Senator and Education Chair Shelley Mayer said, "I am very troubled that despite being aware of the allegations against Alex Mendoza for 6 months, SED is not able to suspend his teaching certification at this stage of the process. While teachers deserve due process, our highest responsibility is to the children who were put in harm's way when Mendoza returned to the classroom. I have spoken with Commissioner Betty Rosa and look forward to working with the State Education Department and my colleagues to amend existing law to ensure that SED has clear authority to temporarily suspend a teacher's certification in these extreme circumstances."

A lawsuit was filed this summer, July 2023, against Mendoza and the Lakeland School District. The details include: "The abuse began in the beginning of her junior year when she was 16," (2015) and "Walter Panas, staff, teachers and leadership were aware or should have been aware of the sexual abuse."

"He then began to coerce her into performing oral sex," when she was 16. When she was 17, "Mendoza eventually pressured and coerced her into engaging in sexual intercourse," and "sexual activities on and off school grounds," "at least a few times a week, and during some months, almost every day."

"Mendoza made little effort to hide his sex abuse from his colleagues and/ or students at Panas High school." "Many times, faculty and employees would observe Mendoza taking her into his classroom or office for a long period of time."

"Faculty were aware that she was NOT A STUDENT OF MENDOZA'S"

"The principal of Panas, Keith YI, contacted the victim's mother, expressing concern that she was spending too much time with Mendoza after school."

Mendoza and the student then began meeting off school grounds, in his car. The lawsuit also alleges that the student and Mendoza engaged in social media activity including "nictures of his carrielle".

including "pictures of his genitalia."

In 2018, we published a story titled, Resident Claims Misconduct in Lakeland Schools, link https://yonkerstimes.com/resident-claims-misconduct-in-lakeland-schools/

In that story, Westchester resident Anthony Cassone alleged that more than one Lakeland School District teacher was engaged in sex abuse with students.

While Cassone did not name Mendoza at the time, he has now confirmed to us that Mendoza was one of three Lakeland School District teachers having sex with their underage students. And Cassone claims that Mendoza had more than one victim while he

Other media reports have Mendoza, through his attorney, denying the allegations.

When we asked for comment, the Westchster County Police emailed us, "We are aware of the allegations contained in the lawsuit and have opened an investigation in

There are 17 seats on the Westchester BOL. Republicans are running candidates in 10 districts:

District 1- Cortlandt, Peekskill, Yorktown: Republican Joe Torres vs Legislator Colin Smith, democrat. This is a rematch from 2021, when Smith narrowly won, 52%-48%. Torres is a former member of the Peekskill Common Council and is a small business owner. He is running an active campaign, including a campaign video and a good social media effort.

Legislator Smith is also campaigning hard. Two years ago, Smith had George Latimer running for reelection as County Executive on the top of the ticket. This year there are no Big Name races for President, Governor or County Executive on the ballot. There are some local elections that will have an impact on turnout. Torres has a chance to flip.

District 3 – Mount Pleasant, North Castle, Pleasantville: Legislator Margaret Cunzio. Cunzio, a registered Conservative, is serving her fourth, 2-year term. Two years ago, Cunzio defeated democrat David Vinjamuri by a 57%-43% margin. She is running unopposed.

District 4-New Castle, Somers, Yorktown: Republican Dan Branda vs Democratic

Chair of the Board, Legislator Vedat Gashi. Gashi is well known in Westchester and his political star is on the rise. But Branda is making a contest of it, and has been active in the media opposing democrats on crime statistics and other hot-button issues. Yorktown has a contested race for Supervisor and Town Board, which could increase turnout in this race. If Branda wins, look for a good night for republicans countywide.

District 7 – Harrison, Larchmont, Mamaroneck, New Rochelle, Rye: Republican Katie Manger vs Legislator Catherine Parker, democrat. Manger is an attorney who has lived in the Sound Shore for 18 years. Parker is a well known and popular legislator. Tough one for the republicans to flip.

District 9- Briarcliff Manor, Cortlandt, Croton-on-Hudson, Ossining, Peekskill:

Legislator Catherine Borgia is term limited from running again, making this an open seat. Republican Laurie Abbate-Ryan is on the ballot but not running an active campaign. Democrat Emiljana Ulaj is a Union Organizer and former Staff member to State Senator Shelley Mayer. No republican pick up here.

District 10 –Eastchester, Tuckahoe, New Rochelle: Republican Beth Acocella vs

District 10 –Eastchester, Tuckahoe, New Rochelle: Republican Beth Acocella vs democrat Judah Goldstein. This is an open seat, with Legislator Damon Maher deciding to run for New Rochelle Mayor. This is another race to watch on election night. Republicans need to flip this seat. Both Acocella and Goldstein are actively campaigning.

The district is one of the most evenly divided based on party enrollment. Republican Sheila Marcotte represented the district. Turnout in republican strong Eastchester will be important for Acocella to get enough votes. Democrat rich New Rochelle will be voting for Goldstein, who was born and raised in New Rochelle, and is a software company owner. Acocella is also a lifelong New Rochelle resident, realtor and New Rochelle Library Board Trustee.

District 11 – New Rochelle, Pelham, Pelham Manor: Republican John Hynes vs Legislator Terry Clements, democrat. Not a lot of information on Pelham resident Hynes. Clements won election twice in this heavy democratic district. Another tough one for republican to take.

District 15 – Bronxville, Yonkers: Legislator James Nolan vs democrat Ruth

Walter. This is another rematch; Nolan beat Walter two years ago. Walter, a former legislator, wants her job back, but Nolan will knock on as many doors as possible up to election day. Another very close race to watch.

District 16 – Republican Debbie Kozak vs democrat Shanae Williams. This

is an open seat after Legislator Christopher Johnson resigned. Williams is a Yonkers Councilwoman in a large part of this district. She almost upset County Clerk in a democratic primary two years ago. Kozak is running an active campaign. In a heavy democratic district.

District 17 – Republican Jose Diaz vs Legislator Jose Alvarado. Diaz is running an active campaign as a Latino Republican, in a heavy democratic district. Alvarado serves as the Majority Leader on the county board.

Best case scenario has 5 Republicans winning election on Nov. 7. (Nolan, Cunzio, Torres, Branda, Acocella). If there is some type of republican wave in NY and in Westchester (less likely) than another two seats are possible long shots-maybe an upset win for Diaz over Alvarado, or Hynes over Clements. But that best case get us to 10-7 democrat

We do not agree with the WCLA PAC that the County Board is in play for pro-life republicans. Another interesting fact, in speaking with Branda, we found out that he is a Buddhist, and may not have any interest in overturning the county's clinic access law. And who the last republican Chair of the BOL? Geroge Oros, in 1998.

County Executive Latimer Fight Influenza & COVID-19 By Getting Both Vaccines

County Executive George Latimer rolled up his sleeves for a flu shot and an updated COVID-19 vaccine at the Westchester County Department of Health clinic in White Plains.

Urging residents to follow his lead, Latimer said: "Schedule your flu and COVID-19 shots today, for yourself and your children. The flu can be miserable, and this vaccine offers the best protection we have throughout flu season."

Flu and COVID-19 vaccines are available for a fee for people with insurance at many pharmacists and medical offices. To find a vaccine near you, go to https://www.vaccines.gov.

Vaccines are also available for uninsured and underinsured adults and children through the Vaccines for Adults and Vaccines for Children programs at Health Department clinics by appointment. Call 914-995-5800 weekdays before 4:30 p.m. to discuss eligibility. To reach residents who have difficulty accessing flu shots, the Health Department is holding clinics at some soup kitchens and homeless shelters.

Health Commissioner Sherlita Amler MD, said: "Lurge everyone six months and

Health Commissioner Sherlita Amler, MD, said: "I urge everyone six months and older to get both these vaccines, and the sooner the better. Both flu and COVID-19 cases tick up as it gets colder and we spend more time indoors. Knowing this, I urge you to schedule flu shots for all your children and yourself as soon as possible. Vaccination protects you and it protects those around you who are more vulnerable to complications, such as infants too young to be vaccinated, seniors and people with chronic health conditions."

In the U.S., there are usually more flu cases between December and February, but flu can linger into May. One flu vaccine now provides protection all season long and can prevent illness or reduce the severity of flu symptoms. The vaccine becomes fully effective after about two weeks. Dr. Amler said that anyone who does get a respiratory infection should consider COVID/influenza testing. To avoid spreading germs to others, the CDC recommends residents wear a mask; cough or sneeze into their elbow; wash their hands frequently with soap and water.

Those with flu should stay home for 24 hours after their fever subsides. Those who test positive for COVID should stay home for five days to avoid spreading germs and then wear a mask in public for another five days; clean surfaces they touch frequently, such as doorknobs, water faucets, refrigerator handles and telephones; and get plenty of rest.
