State Senate candidate Gina Arena (SD-40) today announced that her campaign has released "Pro-Women, Pro-Girl, and Pro-Choice", a :40 digital ad outlining her advocacy for women and girls of every age.

"Pro-Women, Pro-Girl, and Pro-Choice" highlights Ms. Arena's efforts to save Girls Sports from the State Board of Regents push to merge Girls and Boys Sports in New York, and from strident progressive ideologues advocating for biological males on girls' and women's sports teams. Ms. Arena argues that's not fair to girls, who have worked hard to win places on teams and, potentially, to earn college scholarships.

"To be pro-women you also have to be pro-girl," Ms. Arena, a mother of eight (six girls), said. "There's a major threat to Girls Sports coming down in New York and I urge women throughout the state to join me in speaking out about it. Girls have every right to have sports of their own, and after 50 years of feminist progress in this area, I'm downright shocked at how little Albany thinks of these girls' dreams and efforts."

In another digital ad, Arena touches on several of the issues affecting New York families, including high taxes, broken promises, crime, government corruption, education challenges, and the \$15 congestion pricing tax.

"It's both heartwarming and revealing to see how many friends and neighbors want to appear in these ads," Ms. Arena said. "People know that New York is failing them, and they want to tell their stories. But even more than that, they want a representative in the state senate with common sense again, and I'm humbled that they're putting their confidence in me. New Yorkers are not being well

Another important ballot proposition on the ballot in Westchester County on Nov. 5 would extend the term of county legislators from 2 years to 4 years. County legislators currently serve 2 year terms, and there are mixed opinions on whether the extension is a good or a bad idea.

First is the surprise that this reporter had when I realized that the item would be on the ballot on Nov. 5 and I had not heard nor read anything about it until a Sept. 26 release from the BOL, which read,

"In a collaborative and bipartisan effort, the Westchester County Board of Legislators is proposing an amendment to Chapter 107 of the Laws of Westchester County, known as Westchester County Proposition No. 2024-1, that will extend the terms of County Legislators from two to four years, while keeping existing term limits in place. This change would allow legislators to concentrate more fully on the needs of their constituents, focus on policy proposals rather than

# The Welcome Home Westchester Campaign Unveils "5 in 25" Agenda,

Urges Local Governments to Take Housing Action This Year

On September 23, 2024, the Welcome Home Westchester campaign launched an opening salvo and sought to reignite the debate around building the housing we need in advance of the 2025 legislative session in Albany.

In a press conference held in Yonkers steps from the Ludlow Metro North Station, campaign speakers challenged all city, town, and village elected officials throughout Westchester to not wait for state action but instead to commit to taking specific actions to address the housing shortage and an affordability crisis which threatens the health of the local economy and the vibrancy of Westchester County's communities. They further called on residents and activists in every city, town, and village to insist that their communities be part of the housing solution, and neither to wait for action from Governor Kathy Hochul and the State Legislature, nor to let only a dozen or so communities monopolize the economic benefits, the possibilities of infrastructure funding, and the moral imperative to make Westchester a welcoming community for all who wish to live and work here.

The campaign also unveiled its "5 in 2025" Agenda, highlighting 5 actions that municipalities can take on their own to remove barriers to building the housing needed

Those five options include:

- 1-Produce a Housing Action Plan
- 2-Create a fast-track environmental review for sustainable, energy efficient housing and transit-oriented development
- 3-Promote Accessory Dwelling Units, (ADU) and Transit Oriented Development, (TOD)
- 4-Establish a Core Curriculum for Volunteer Land Use Board Member Training
- 5-Use the new State provided tools and become a pro-housing community Read the 5 in 2025 agenda at welcomehomewestchester.org/five-in-25-policy-agenda/

Assemblywoman Dana Levenberg (95th Assembly District), who herself had led efforts to carefully and thoughtfully increase the supply of badly needed housing as Town Supervisor for Ossining and has proven to be a leader on the Assembly Committee on Housing, joined campaign speakers to offer her thoughts on what progress is possible in Albany.

Other speakers emphasized that, given the size and dire effects of the housing shortage, every community had a responsibility to choose one of the five elements of the policy agenda and determine what would work for their own community. The other speakers included Michael Romita of Westchester County Association (WCA), Nance Shatzkin of Croton Housing Network, Dr. Kevin Middleton of Acts Church in Yonkers, and Tim Foley of the Building & Realty Institute (BRI).

Michael Romita, President and CEO of Westchester County Association said: "New York's housing crisis, particularly acute in our suburbs, continues to undermine the health of our economy and the vibrancy of our communities. It will not

Paying Homage to the Real Meaning of Baseball: Mr. Peter Edward Rose Sr.

I grew up in Wagner Houses in East Harlem. 54 years ago living there at the age of nine I became a fan of the Cincinnati Reds( The Big Red Machine). The most dominant team in Major League Baseball during the 1970's winning six division titles 4 national league championships and two World Series championships in 1975 and 1976. The main reason why the Big Red Machine was so successful was Pete Rose. He was the heart and soul of that team and he was what baseball should be all about. He played hard and he played for the love of the game. That was shown with every hit and and his thunderous and aggressive play. That was demonstrated in the 1970

All star game and his famous knocking over catcher Ray Fosse at home plate to score for the national league. I remember seeing that with my late father and that certainly had an impression on me. He had a perennial over 300 batting average, most players are not able to do that. His four thousand two hundred and fifty six hits is more than any other player in Major League Baseball history. The term "team player "is like every thing else in this society predicated on a lie a myth, but team player was exactly what Pete Rose was ,playing multiple positions in the outfield and third and first base. From what I can see as a fan back then and in retrospect, for Pete Rose it was never about the money it was indeed a "love of the game"! Very few athletes can say that no matter what sport they are in especially with the perversion of sports during this period

because of George Steinbrenner and his stewarding the genesis of the free agent era that has had a rippling affect across the four major sports in this country. Rose said in a 1975 interview during the World Series in reference to the big red machine "

I woke up Wednesday morning to reports that Iran had attacked Israel with a 200 Ballistic missile barrage. This is the largest barrage to date. The missiles had been shot down and thank god no one was killed or secretly injured.

I woke up Wednesday morning to learn that Canada's immigration policies are letting many terrorists into the United States planning mass killings of Jewish people. And all this going on as we get ready for the first anniversary of the October 7 attacks. God only knows what this may bring.

Happy New Year! Sadly, this is a tough time for Jews in America.

Whether in be on college campuses or grocery stores, Jewish people are subject to a tremendous amount of antisemitism. The Jews, who built this country and its many institutions of higher education are not being shown the respect that we deserve.

The Jewish holidays are late this year. Your cost of traditional foods like brisket, the chickens, the chopped liver have all gone sky high. In the middle we are hit by a shipping strike that will increase prices more because of the ingredients in these these foods And many other foods served this time of year are all ready high in cost!

But wait a minute. Look at the calendar. Rosh Hashanah in October?! Who made that decision? It's pretty late!

Actually, the Jewish holidays fall right on time. The Jewish or Hebrew calendar is a lunisolar calendar created and used by the Hebrew people—it's "lunar" in that every month follows the phases of the moon, and "solar" because the calendar's 12 months follow the earth's orbit around the son. So stop worrying where it falls and start celebrating. You won't see confetti flying but we do use a special device to welcome the New Year. The device is a Shofar.

A shofar is an ancient musical horn typically made of a ram's horn, used for Jewish religious purposes. Like the modern bugle, the shofar lacks control done by varying the player's embouchure. lipping is the use of the lips, facial muscles, tongue, and teeth in playing a wind instrument. This includes shaping the lips to the mouthpiece of a woodwind instrument or the mouthpiece of a brass instrument.

The shofar is blown in synagogue services on Rosh Hashanah and at the end of Yom Kippur; it is also blown every weekday morning in the month of Elul running up to Rosh Hashanah.[2] Shofars come in a variety of sizes and shapes, depending on the choice of animal and level of finish.

I have recently started to learn how to play the shofar. I've had one for over 30 years but my shofar was small and difficult to play. I have the good fortune to be able to use a shofar that was owned by mom's dear friend Claire Simkins.

# Brandeis Center, ADL & Stand With Us Expand Helpline on Antisemitism in NY K-12 Schools

The Louis D. Brandeis Center for Human Rights Under Law, ADL (the Anti-Defamation League), and StandWithUs, along with a coalition of leading law firms, today announced the launch of a helpline in K-12 schools to provide pro bono legal assistance to parents whose children are experiencing antisemitism in Massachusetts and New York. The helpline follows a successful pilot program in California, the first state for which the hotline was launched after a series of troubling antisemitic incidents in the state's K-12 schools.

Antisemitic incidents in elementary, middle and high schools in MA and NY have increased significantly over the last year. Reported incidents in K-12 schools in MA nearly doubled in 2023 — 101 (up from 53 incidents in 2022) while incidents in K-12 schools in NYclimbed to 173 (up from 53 incidents in in 2022).

The alarming rise in both the sheer number and intensity of antisemitic incidents in K-12 schools in New York and Massachusetts have made it clear that parents, students and educators need an option for legal help, said Peggy Shukur, ADL Vice President, East Division. "Particularly in situations where responses to antisemitism are inadequate or worse, access to high-quality legal assistance is a crucial tool to ensure a safe learning environment. By providing these legal efforts, this helpline will empower Jewish students, teachers and parents to take action to fight against antisemitic harassment and bigotry."

"Day after day, students across our state are facing a barrage of antisemitic incidents in K-12 schools," said Scott Richman, ADL NY/NJ Regional Director. "Increasingly, those incidents have required legal assistance. Alongside our impactful anti-hate education programs, this pro bono legal helpline is a welcome addition to the arsenal of tools at our disposal to fight the antisemitic prejudice that we see in our schools."

As a result of the California K-12 pilot program, in February 2024, Brandeis and ADL filed a complaint with the U.S. Department of Education's Office for Civil Rights (OCR) against the Berkeley school district for failing to take action to end the nonstop bullying and harassment of Jewish students by peers and teachers. Since its launch, the CA hotline has received an influx of K-12 incidents. These include a wide variety of antisemitic incident reports including Jewish students being harassed, intimidated, and threatened with violence because of their religion.

"The barrage of antisemitic harassment, intimidation, and attacks against Jewish students is unfortunately not contained within the campus gates," stated Brandeis Center Vice Chair and General Counsel Rachel Lerman. "Coast to coast, Jewish K-12 students have been verbally and physically bullied, threatened, and assaulted by peers who absorb anti-Israel and antisemitic rhetoric from some of their teachers. They have been told they are hated and should all be killed, spat on, called dirty Jew, told to go to the gas chambers, slandered, and threatened with violence. Administrations cannot be allowed to turn a blind eye to the intimidation, bullying and antisemitic rhetoric their students endure within their schools. Our team of lawyers stand ready to use the law to hold schools accountable to enforce their own rules as Jewish students are subjected to a virulently hostile environment. This must stop."

Parents, teachers, and other interested adults in MA and NY can use the Legal Protection K-12 Helpline to report incidents of antisemitic discrimination, intimidation, harassment, vandalism or violence that may necessitate legal action. Lawyers will conduct in-depth information-gathering interviews with persons who file reports. In some instances, they may provide pro bono representation on behalf of victims or provide referrals to organizations that can provide non-legal assistance. The lawyers will also, with permission of the individuals involved, use the reports to better understand the scope of the problem and report it to officials responsible for ensuring the laws are followed. If schools do not take action, they will be held accountable.

"CJP's Center for Combating Antisemitism is excited to support this important hotline as a proactive resource for parents, educators, and students," said Melissa Garlick, Senior Director, Combating Antisemitism and Building Civic Engagement at Combined Jewish Philanthropies (CJP). "This initiative will serve as a valuable tool for our community to help address and prevent antisemitism, offering guidance, support, and solutions to foster safe and respectful learning environments. By working together, we're empowering school communities to not only respond to incidents but to build a culture of inclusion, understanding, and mutual respect."

"Consistent with our longstanding commitment to combating antisemitism in schools, on campus, and within the community, StandWithUs remains proud to be part of this coalition dedicated to protecting K-12 students from antisemitic harassment and discrimination, said Carly Gammill, Director of Legal Policy at the Stand-WithUs Saidoff Legal Department. "The expansion of the initiative into Massachusetts and New York comes at a time when antisemitism continues to plague students in our nation's schools and will help ensure broader access to legal resources for students seeking to address attacks against their Jewish identity.

This expansion builds upon continued efforts to address antisemitism in a variety of educational settings. In November 2023, Brandeis and ADL, along with Hillel International, Gibson, Dunn & Crutcher LLP, and other leading law firms, launched the Campus Antisemitism Legal Line (CALL), a helpline to assist students and faculty experiencing antisemitism on college campuses. More than 650 college students and faculty have used this important resource to report incidents and request assistance.

Title VI of the Civil Rights Act of 1964 prohibits educational institutions that receive federal funding from discriminating against, or allowing others to discriminate against, students on the basis of actual or perceived race, color, and national origin. Title VI protects Jews based on their shared ancestral and ethnic identity. The Department of Education's Office for Civil Rights recognizes that harassing, marginalizing, demonizing, and excluding Jewish students based on the Zionist component of their Jewish identity is unlawful under Title VI.

"While spun as a tax on the rich, the SALT deduction cap has a disproportionate impact on seniors and the middle class in my district, where property values and the cost-of-living rank among the highest in the nation. Working with Kamala Harris and House Democratic leadership to restore the full SALT deduction will be a top priority of mine as a member of Congress." In 2017, with the support of Republican House and Senate majorities, former President Trump signed into law the so called "Tax Cuts and Jobs Act", drastically capping the SALT deduction to \$10,000 for both individual and joint filing taxpayers. Prior to implementing the SALT cap, New York residents were entitled to deduct the full amount of state and local taxes against their federal income tax liability. The cap has a disproportionate impact on New Yorkers subject to local property taxes, where the median home price is ranked 3rd in the nation. While imposing this unfair burden on middle class New Yorkers, Trump and his cronies gave massive tax breaks to billionaires and for corporations moving their profits overseas. In a further slight to New York taxpayers, Congressional Republicans rejected an opportunity to provide some relief by increasing the deduction cap this past February. Restoring the full SALT deduction for his constituents is part and parcel to Latimer's record of fighting for taxpayers while maintaining a high level of essential government services. This includes Latimer's signing of five consecutive county property tax cuts, as well as raising the real property tax exemption for veterans, and providing tax exemptions for volunteer fire and EMS workers who give their time to protect our community.

# Upcoming Debates for Westchester Candidates on the Ballot for November 5 Election

Cacace Declines LWV Debate with Sarcone Should Debates be in Person? Or Still Zoom?

A number of debates have been scheduled in October for almost every elected office on the ballot November 5. The Westchester League of Women Voters, LWV, as usual, has a number of their forums upcoming but some candidates have decided to skip their planned debate.

In a press release, the LWV-Westchester wrote, "The League of Women Voters of Westchester announces that it will not be holding Candidate Forums for the U.S. Congressional District 17 race or for the Westchester District Attorney race.

With respect to the race for U.S. CD 17, Democratic candidate Mondaire Jones had stated that he was available for the proposed October 21, 2024 forum at the Ossining Public Library. However, incumbent Congressman Michael Lawler, Republican candidate, would not commit to any date.

With respect to the race for Westchester County DA, Republican candidate John Sarcone had accepted the invitation for the proposed October 24, 2024 forum at the White Plains Public Library. However, Democratic candidate Susan Cacace declined to participate.

A candidates' meeting with only one candidate present is an "empty chair" meeting, and is not permitted under LWVW rules and its policy of nonpartisanship. LWVW regrets that these important proposed educational events for voters had to be cancelled.

"This is a lost opportunity for the public to hear directly from candidates in person and to address their own questions to them," stated Westchester County League President Kathy Meany. "We strive to run forums in a respectful, non-partisan environment that encourages civil discourse and allows candidates to communicate with the people they are seeking to represent. It is a disappointment that there will be no such in-person opportunity for voters residing in Westchester [for purposes of the U.S. CD 17 and Westchester County DA races]."

Sarcone said, in a statement, that Cacace's decision not to debate was, "a threat to democracy and a slap in the face of Westchester voters..that my opponent refuses to face the voters and defend her radical positions."

Cacace's campaign, through a spokesperson, explained that "Susan has always made herself accessible to people all across Westchester and will continue reaching out to voters to discuss her vision for the office and her plans to keep Westchester safe," adding that "Her opponent, on the other hand, has no credible campaign to speak of. He has failed to raise any money, has not produced a website, has no social media presence, and zero visibility. The voters deserve better."

We could not find a Sarcone for District Attorney website on Facebook as we write this story, nor could we find any donations or filings of any kind on the NY Board of Elections.

Recently, Sarcone issued two releases, send out by republican campaign consultant Chapin Fay. One was regarding the indictment of Eric Adams, and the other was an endorsement from former NYPD detective Bo Dietl.

Sarcone also does not have the Conservative Party line. Last year, Sarcone was the republican candidate for State Supreme Court, and also did not have the Conservative Party line. A lawsuit was filed against the Westchester Conservative Party Chair Hugh Fox, but Fox won in the end, and Conservatives endorsed the democratic candidates for State Supreme Court, who went on to win in November.

This year, Fox and the Westchester Conservative Party have endorsed Cacace for DA, and the democratic candidates for State Supreme Court again. One issue that some conservatives in Westchester have with this decision is that while democrats are running a statewide and national campaign to protect a woman's right to abortion, most conservatives don't agree.

Lawler and Jones have agreed to participate in a debate on News 12 Wednesday, October 16 at 8:30pm, which will be moderated by News 12's Tara Rosenblum.

One thought that we have heard from many candidates is their desire to hold in

well served by their government leaders right now. They need change." Arena explained her pro-choice position in a recent OP-ED in USA Today



Entering a ballroom in New York is like stepping into a dazzling showcase of talent and expression, featuring butch queens, the girls, and maybe even some trade. These terms capture the essence of the LGBTQ+ community thriving in the city's rich ballroom culture—a vibrant form of expression rooted primarily in Black and Latinx communities.

Ballroom culture traces its origins back to the Harlem Renaissance, with influences that can even be seen as far back as the 19th century. Titled "Crystal & Lottie Presents: The 1st Annual House of LaBeija Ball," this event emerged after Crystal faced discrimination at the All-America Beauty Pageant in the late 1960s. It was during this time that she coined the term "house," marking a significant milestone in ballroom history.

Fast forward to 2024, and ballroom culture continues to thrive and evolve. Isaiah Latimer, who works under the moniker Constance Lee Busted, reflects on the importance of pioneers like Crystal and Lottie. He expresses gratitude for their perseverance, stating, "They were pioneers who didn't give up."

In conclusion, the ballroom scene stands as a powerful testament to resilience and creativity, enriching New York's culture. By providing a space for self-expression and connection, it honors the legacy of those who came before while fostering a sense of community that thrives today. As seen in the recent events in Yonkers and Mount Vernon, the spirit of ballroom culture continues to unite and inspire during Pride Month, ensuring that its vibrant essence remains an integral part of the ongoing celebration of diversity and identity in our city.

After nearly 5 years, Irvington Theater — the 122-year-old performing arts venue located inside Irvington, New York's historic Town Hall — is reopening its doors to neighbors throughout Westchester County and the greater New York City metropolitan area.

All fall long, IT will host and present a series of not-to-be-missed events, kicking off Saturday, October 26 from 2-4pm with the Irvington Theater Open House! Be the first to behold the completely refreshed theater space, explore the refurbished lobby and dressing rooms, and see the new color scheme and custom carpet in person! This free event will include light refreshments live music by multi-instrumentalist Miyuki Furtado, providing a wonderful opportunity for neighbors to connect with staff, the theater commission, and the Friends of the Irvington Theater. No registration required; just show up!

On Saturday, November 9 at 7:30pm, the theater will host "Laugh Out Loud: A Night of Comedy to Celebrate Irvington Theater's Grand Reopening!" Leave the kids at home and grab your partner or a group of friends for a riotous night of all-star comedy in Irvington. Headlined by mainstay of the NYC comedy scene, Lenny Marcus (The Late Show with David Letterman, The Daily Show), the lineup also includes Ophira Eisenberg (NPR's Ask Me Another

"I am extremely excited to open our doors up to the public again so they can see all the work that has gone on during our closure," said Theater Manager Gregory Allen in a statement. "The excitement of our staff and theater commission is palpable as we work towards our Open House on October 25 and Grand Reopening on November 9. So many new people have moved to our Village since we've been physically closed, and we can't wait to share with them all that that Irvington Theater has to offer."

Like most arts organizations, Irvington Theater first closed its doors in 2020 due to the pandemic, triggering a multi-year pivot to a series of online and in-person, offsite events known as #IrvingtonAnywhere. When restrictions on in-person gathering began to ease, the doors to Irvington Theater remained closed; an interior facelift was well underway, which included replacing the audio console, upgrading the lighting and sound systems, refreshing the lobby and dressing rooms, and re-gold leafing the entire proscenium arch.

At that point, it had been more than 40 years since the theater had undergone a significant renovation, and the decades-old ventilation system couldn't meet the standards of the moment. In 2021, thanks to the help of the Irvington Village Board, State Senator Andrea Stewart-Cousins, and the NYS Assembly, a plan to install a state-of-the-art HVAC system was approved, kicking off another major construction project that will allow the theater to operate year-round for the first time in its history.

In addition to the grand reopening events, IT will also welcome back its Arts Partners to the venue this fall, with productions like Clocktower Players' The Color Purple in concert and Broadway Training Center's Les Misérables (School Edition). In 2025, Irvington Theater will also host their own beloved offerings like As iFF (All Shorts Irvington Film Festival) and the Arts Incubator Short Play Fest at their historic performing arts space. # Harckham, Bedford Teachers' Association Hold Food Drive in Mount Kisco



1,700 pounds of food and \$1,570 in cash donations for the Mount Kisco Interfaith Food Pantry

New York State Senator Pete Harckham and the Bedford Teachers' Association held a special Hunger Action Month food drive todayat the Mount Kisco Elementary School, collecting more than 1,700 pounds of food and \$1,570 in cash donations for the Mount Kisco Interfaith Food Pantry, which helps to feed some of the neediest members of the community, including many seniors. "Even in today's drizzling rain, residents of Mount Kisco and neighboring communities brought their donations to our food drive, for which we are very grateful," said Harckham. "People know there is food insecurity among our neighbors, and that we all can help as we are able. A big thank you to the Bedford Teachers' Association members and all the volunteers who were here to help." In the 16 prior food drives since March 2020—one each in Sleepy Hollow, Ossining, Mohegan Lake, Bedford, Brewster, Pleasantville, Crotonon-Hudson, Somers, Yorktown Heights and Katonah, and two drives in Carmel, Mount Kisco and Peekskill—Harckham and volunteers have collected about 51,000 pounds of food items and over \$12,000 in cash donations so far.

Now in its 33rd year, the Mount Kisco Interfaith Food Pantry operates out of the United Methodist Church of Mount Kisco. The pantry has fed over 110,000 people in 2024, 26% of which were children and 11% were seniors.

Trina Ward Fontaine, executive director of the Mount Kisco Interfaith Food Pantry, said, "We are building awareness in the northern Westchester community about the existence of food insecurity. As the only weekly choice food pantry in the communities we serve, we see demand continuing to increase. In September, we have fed an average of 730 families a week, an all-time high. We couldn't do it without partners like the Bedford Teachers' Association and Senator Harckham's office."

Tarrytown Lighthouse in Sleepy Hollow was built in 1883 in response to pleas by local steamship companies for assistance in navigating dangerous shoals. It was a critical guide for Hudson River shipping for 68 years before it was decommissioned in 1961 once the Tappan Zee Bridge was built. The Lighthouse is listed on the National Register of Historic Places. The Tarrytown Lighthouse in Sleepy Hollow is located in Kingsland Point Park off Palmer Avenue. The Lighthouse is accessed by a 10 minute walk from the parking lot along the Riverwalk path. Parking fees may apply.

# Gold Star Mothers Honored



Gold Star Mother Hope Hollinsworth-Coaxum of Yonkers

In a solemn ceremony Westchester County honored the sacrifice of the families of military service members who lost their lives in the service of our country.

Westchester County Executive George Latimer and Veterans Service Agency Director Ron Tocci led the County's annual Gold Star Mothers & Families Memorial Tribute Ceremony at Westchester's Memorial Walkway at Kensico Dam Plaza, where 17 County veterans who fell in service since the 9/11 attacks were remembered with hand and rifle salutes and the sounding of "Taps."

Those assembled heard moving works from Gold Star Mother Hope Hollinsworth-Coaxum of Yonkers, whose son, Army Staff Sergeant Courtney Hollinsworth, died in Operation Iraqi Freedom in 2007, and whose sacrifice is commemorated on the Walkway.

Latimer said: "As a county and a nation, we remember everyone who served and fell in the line of duty, and we honor their sacrifice, but it's important to remember that their sacrifice is not theirs alone. There's a family proudly standing behind everyone who goes off to serve. And when a service member falls, there's a family that grieves. We have a duty to our Gold Star Families to support them in their grief, to lift them up, to honor their sacrifice, and to provide them whatever help they need for all they've given for us."

Deputy County Executive Ken Jenkins said: "Most of us have not lost a son or daughter, a spouse or sibling, in military service. We don't live with that intense paradox of pride in their service and grief for their loss. But we do live with a responsibility to our Gold Star Families, not just to support them with services but to make sure they feel our love and respect, to say every day, 'We see you, we are humbled by your sacrifice, and we are here for you."

Tocci said: "As parents, there's nothing more profound than the hopes and dreams we have for our children, including hopes and dreams for a fulfilling life of service. Those hopes and dreams for their service don't end with a folded flag, a rifle salute, a Gold Star, but for families whose loved ones choose a life of military service, the possibility of that ending is very real. Today, and every day, we say to all the Gold Star Moms and Gold Star families, thank you for your service too. We know your sacrifice is indelible, and we promise never to forget it."

The national remembrance of Gold Star Mother's Day began in 1936, marked on the last Sunday in September. Since 2011, commemoration has been amended to be Gold Star Mother's and Family's Day.



be magically wished away. Rather, we need our local towns and villages to see past the NIMBY rhetoric and to work with us. Welcome Home Westchester's 'Five in '25' agenda is positive and straightforward. It asks each community to choose a single action to encourage more housing in a way that makes sense for them. Not everyone can do the same thing, but everyone should do something."

Tim Foley, CEO of the Building & Realty Institute (BRI), said: "In the world of housing, the buck stops at the local level. constant campaigning, reduce the cost of administering elections, and align with the standard set by a majority of New York State county legislative bodies, which already have four-year terms.

"Chairman Vedat Gashi (D-New Castle, Ossining, Somers, Yorktown) said, "By extending the length of Legislators' terms, we're saving taxpayer dollars by allowing us to hold fewer elections and creating a more effective and efficient system to serve the needs of today's voters so that Legislators can focus on the work they were elected to do, rather than constantly campaigning. I've spoken to voters throughout the County from Yorktown to Yonkers, and they've all told me the same thing – they want us to focus on policy, not politics – and this proposal allows us to do that."

Key Benefits of Four-Year Terms

Cost Savings for Taxpayers:

Elections can be costly — for both candidates and taxpayers. And the cost of elections continues to increase. This proposal is expected to significantly reduce the financial burden of administering elections, allowing public funds to be redirected to essential services.

Reduced Campaigning:

A four-year term will enable Legislators to spend less time fundraising and campaigning, resulting in fewer campaign mailings, campaign phone calls, and other messaging to residents. This shift will allow Legislators to dedicate more time to legislative work and community engagement.

Yonkers resident Debbie Kozak, who ran for County Board in District 16 last year, opposes the measure. She writes

"PROP TWO – Don't Let Them Get Away with It: Vote NO! With Westchesterites distracted by vacations and other activities these past few months our County Legislators managed to cook up and quietly push through a 'tri-partisan' plan to double their terms of office from two to four years.

Upon County Exec George Latimer's signature that change to be known as Prop Two, sets up a second outrageous proposal on the Nov. 5 ballot that we citizen-taxpayers have neither asked for nor know very much about. (The first was the even more obnoxious Prop One, or phony Equal Rights Amendment – to which we've already recommended voters deliver a resounding 'HELL NO' and therefore need not address here.)

"Should individuals serving in the position of Westchester County Legislator serve four-year terms instead of two-year terms?" is what Prop Two asks – to which the only logical answer must also be a resounding NO, and here are the reasons why:

The 17-member Board of Legislators maintains that changing term lengths will "substantially decrease taxpayer expenditures on election coordination and administration" and "redirect the funds towards critical priorities such as public safety, infrastructure investments and vital social services."

Sounds great, right? But there's little to no hard projectable evidence that any 'savings' to be had by changing 17 Legislators' term lengths so they don't have to run for office will affect such objectives in any measurable way.

As taxpayers we should expect a thoroughgoing cost-saving analysis to support any such high-minded assertions. None has been done, and it's my belief that if one had, the result wouldn't be nearly as positive as is claimed.

Furthermore, the County Board of Elections would and will, as always, remain open for business during election periods even if and as the Legislator's terms were to be changed, as primary and general elections always have and always will take place year after year after year.

And it's the County Executive, not the Legislators, who administers those funds. Using the description of critical priorities to describe such broad generalizations as "public safety, infrastructure investments and social services" is nothing more than yet another SILLY WORD SALAD to scare readers into thinking that if they vote against this proposal monies for such priorities will decrease.

Yes, as civil rights attorney Bobbie Ann Cox is wont to say, 'They think we're stupid." And yes, they really do. Never has a County Executive, nor a Legislature, to our knowledge, admitted publicly to any 'under-funding' of these or other 'priorities.'

We know this because, dontcha know, they all campaign on how so wonderfully well they always manage to plan, pass and fund their annual budgets.

One claim is that fewer elections would afford voters 'the power to concentrate (on issues) rather than election activities.' Huh? Another is that fewer election/longer terms will somehow "save on the cutting down of trees as paper for posters, palm cards and yard signs."

Really, Legislators should get two additional years to save on campaign literature? Seriously, neither seems to be of credible benefit to taxpayers.

SIMPLE TRUTH 1: Two-year terms keep politicians more accountable and in line with what their constituents want. PERIOD.

Some additional FACTS the BOL hasn't bothered to highlight:

Legislators are not limited to six two-year terms. They're limited to six consecutive two-year terms. What does that mean? If, for example, a Legislator is elected to five two-year terms (10 years), and then takes a term (or multiple) off, and gets reelected— the six consecutive two-year term clock re-starts. No big deal? Wrong!

Once a Legislator works 10 years, he/she qualifies for a county pension, and each year their pension increases by a certain percentage. Their base salary is \$75,000 plus they get additional monies for leadership positions and stipend(s) for being Chairmen of Special and Standing Committees, putting an annual part-time job salary at close to a respectable \$90,000.

Legislators with other county and/or municipal jobs accrue larger pensions – all of which is paid out by the taxpayers as fringe benefits. In 2023 the WC budget for employee fringe benefits exploded from the previous year by \$12 million (12.5%) to over \$192 million.

SIMPLE TRUTH 2: Prop Two does not benefit the citizen-taxpayers, it benefits politicians. Were they truly interested in decreasing expenditures, they could propose doubling the size of their constituency, cutting their number by half, and/or limiting total service to eight years.

FINAL FACT: Elected officials work for taxpayers, not the other way around. CONCLUSION: When you've finished voting for candidates for office on Nov.

5, flip the ballot over and cast a resounding NO vote to both Proposition One AND Proposition Two – because We're Not Stupid.
