Mixed Views in Support and Againt Decision in Westchester

Last week, NY Attorney General Letitia James' Office of Special Investigation (OSI) released its report on the death of Jarrel Garris, who died on July 10, 2023 after an encounter with members of the New Rochelle Police Department (NRPD) that occurred on July 3, 2023 in New Rochelle. Following a thorough investigation, which included review of body-worn camera footage and security camera video, interviews with involved officers, and comprehensive legal analysis, OSI concluded that a prosecutor would not be able to disprove beyond a reasonable doubt at trial that the officer's use of force against Mr. Garris was justified under New York law. On the afternoon of July 3, NRPD officers responded to a complaint of a man who was eating items he had not paid for at a grocery store on Lincoln Avenue in New Rochelle. Two officers arrived and both officers attempted to verbally engage with Mr. Garris. Mr. Garris was not responding to the officers' questions when the third officer got to the scene.

The third officer placed one handcuff on Mr. Garris and a physical struggle ensued. The third officer directed the first officer to use her taser on Mr. Gar

Does Mondaire Have the Momentum? Latest Poll Has it 47% Lawler-45% Jones

A new poll by GBOstrategies.com, a democratic polling firm in Washington, shows the race for Congress between Rep. Mike Lawler and former Rep. Mondaire Jones narrowing to within the margin of error.

"The Sept. 20 poll had Lawler at 47% and Jones at 45%. Last month, Lawler held a 47%-40% lead over Jones.

GBO released their memo on this Congressional race, in the 17th District of NY-which includes most of Northern Westchester, Rockland, and Putnam Counties.

"Recent polling in NY-17 shows Mike Lawler's image deteriorating and the congressional race tightening to within the margin of error after just two weeks of Mondaire Jones's ads contrasting him with Lawler on abortion and healthcare, compared to Lawler's five weeks on air. This proves once again that NY-17 is a critical battleground to determining which party controls the House of Representatives after November.

"The following are key findings from August and September surveys of 500 likely general election voters in New York's 17 th congressional district. Each survey carries a margin of error of +/-4.4 percentage points at the 95 percent confidence interval. The surveys were conducted between August 8-12 and September 15-18 of this year via phone and text-to-web.

"Key Findings

• The congressional race in NY-17 has tightened, with Mondaire Jones closing in on Lawler. In August, Lawler held a 7-point lead over Mondaire Jones (47%)

Brooklyn Man Gets 2-6 Years for Fatal Hit and Run of Hartsdale Community Leader

On Sept. 23, Westchester County District Attorney Miriam E. Rocah announced that a Brooklyn man was sentenced to a term of two to six years in state prison for the August 2023 hit-and-run in Hartsdale that killed 65-year-old Stephanie Kavourias.

DA Rocah said: "The victim was a beloved figure in the Greenburgh community, and her life was senselessly taken when the defendant chose to get behind the wheel of his car and drive while impaired. We hope this prosecution and sentence helps Ms. Kovourias's loved ones begin the process of healing from this tragedy."

The defendant, Antonio Robles Sanchez, 43, pleaded guilty on Aug. 1 to Vehicular Manslaughter in the Second Degree, Leaving the Scene of an Incident Without Reporting and Criminally Negligent Homicide, all felonies, and Driving While Ability Impaired by Drugs, a misdemeanor.

At approximately 11:14 a.m. on Aug. 26, 2023, the defendant, while under the influence of Xanax, drove his Dodge Ram into the victim who was at the intersection of Rockledge Road and East Hartsdale Avenue in Hartsdale, and then left the scene.

The victim was transported to White Plains Hospital where she was pronounced dead.


The Greenburgh Police Department recovered the defendant's license plate at the scene of the incident and, with assistance from White Plains Public Safety, located and arrested the defendant, who was stopped in a lane of traffic while asleep at the wheel of his truck in front of the Westchester County Center in White Plains.

The case was before Judge George Fufidio in Westchester County Court and prosecuted by Senior Trial Counsel Brian Bendish of the Trials and Investigations Division.

Westchester County Pets Can Receive Free

Rabies Vaccines at SPCA of Westchester Sept 28



Call to Make an Appointment for Saturday, September 28

Westchester County residents can schedule free rabies vaccinations for their dogs, cats and ferrets this Saturday, September 28 from 10 a.m. to 3 p.m. at the SPCA of Westchester, 590 North State Road, Briarcliff Manor. Call 914-941-2896 x 1100 for an appointment.

An adult must supervise all pets. Cats and ferrets must be in carriers and dogs must be on a leash. Aggressive dogs must be muzzled. No examinations will be given.

Westchester County Health Commissioner Dr. Sherlita Amler said: "Vaccinating your pet against rabies will protect your pet and your family in case your pet has contact with a rabid or potentially rabid animal."

Additional free rabies clinics will be scheduled and announced in the coming months in other parts of the County. Under New York State law, dogs and cats must receive their first rabies vaccine no later than four months after birth. A second rabies shot must be given within one year of the first vaccine, with additional booster shots given every one or three years after that, depending on the vaccine used. Owners who fail to get their pets vaccinated and keep the vaccinations upto-date may be fined up to \$2,000.

Rabies is a fatal disease that spreads through the bite or saliva of infected animals. Those animals most commonly infected are raccoons, skunks, bats and foxes. However, domestic animals such as cats and dogs are also at risk because they can easily contract rabies from wild or stray animals.

A pet that is up-to-date with its rabies vaccinations would only need a booster dose of vaccine within five days of the pet's exposure to a known or suspect rabid animal. Animals not up-to-date with rabies vaccinations would be quarantined or euthanized following contact with a rabid or suspect-rabid animal.

A change in an animal's behavior is often the first sign of rabies. A rabid animal may become either abnormally aggressive or unusually tame. It may lose fear of people and become docile, or become excited and irritable. Infected animals sometimes stagger, spit and froth at the mouth. Children should be discouraged from touching unfamiliar animals, and to tell an adult right away if they have been bitten or scratched by an animal.

All animal bites or contact with animals suspected of having rabies must be reported to the Westchester County Health Department at (914) 813-5000. After hours, callers should follow instructions in the recorded message for reporting public health emergencies 24 hours a day.

Candidate Spoke at Hearing Against Edgemont Secession, Says Move Would be Immoral, Potentially in Violation of Federal Equal Protection Laws and Only Possible Thanks to Legislation Passed by Democrat Mary-Jane Shimsky

Candidate for New York State Legislature, Alessandro Crocco of Hartsdale recently attended a public hearing and stood in opposition of a potential secession of Edgemont from the Town of Greenburgh, calling it morally wrong and possibly in violation of state and federal equal protection rights. Crocco was one of dozens of Greenburgh residents to rise and speak their minds against such a move.

In his remarks, Crocco –who identified himself as a neighbor and friend to those gathered–said any potential secession would only be possible thanks to legislation passed by current Assemblywoman, Democrat MaryJane Shimsky and subsequent horse trading in Albany.

In addition to the resulting high taxes and strains on public services such as police and fire, Crocco said an unintended casualty of secession would be Greenburgh's parks system including crucial community services due to a major drop in population.

"If Edgemont were to secede, that would be at least 8,000 fewer people using the recreation system and paying taxes to support it. Among this scenario would be the historic Fairview Center, meaning a terribly unfair, cruel impact on hundreds of minority families who rely on the programs and services offered there."

Crocco had particular concerns about the very process by which the ground-work was laid for the Edgemont residents seeking to abandon Greenburgh.

"In terms of the procedural requirements for this ill-conceived endeavor, I believe the merits of the petition to be in grave question...In December of 2023, Governor Hochul signed a new law streamlining village incorporation petitions, a significant improvement over a nearly century-old statute. The new law recognizes the impact of incorporation on both the proposed village and the remaining Town, removing the burden from the Town Supervisor, who previously had to validate petitions, potentially conflicting with community interests. Now, an independent panel appointed by state officials will oversee the process, which includes a required impact study."

Crocco went on, "However, a political deal exempted a small group in Edgemont from this law for 16 years, allowing them to bypass updated impact studies. This exemption disadvantages others affected by incorporation and raises concerns about constitutional fairness."

Crocco's assessment of a post-secession Greenburgh turned even more ominous when he noted the potential violations of Equal Protections provided by the Constitution, a notion of particular sensitivity for the crowd who paid close attention to his words.

"...given the respective demographics of a post-secession Edgemont and unincorporated Greenburgh it is my understanding that once all the due diligence has been performed on the legalities of this movement, the results of a secession by Edgemont could very well be in violation of state and federal civil rights laws," said Crocco. "The result would violate New York's John Lewis voting rights law and the Equal Protection clause of the 14th Amendment of the Constitution. This is just wrong, and I ask our town supervisor to reject the petition."

Op-Ed: Ask your State Rep to End The Congestion Pricing Program

Shortly after Governor Hochul announced the indefinite suspension of Congestion Pricing, the Siena Poll showed New Yorkers supported the Governor's pause by two to one. However, opponents continued to spread false narratives of a MTA doomsday. Instead of finding solutions to fund mass transit, they held publicity stunts by delivering hundreds of toy cars to the Governor's Midtown office. An agency with an \$11.3B budget should have a plan B. In early June, MTA management said they didn't have a Plan B. Three weeks after the Governor's pause, the MTA board passed a resolution supporting the pause.

At the time of the installation of the license plate readers, (the gantries) the Federal Highway Administration (FHWA) had not given the MTA a final approval and eight active outstanding lawsuits existed from both New York State and New Jersey. Regardless, they rushed ahead and the MTA leadership spent over \$500 million to install the gantries. The publicized June 30th start date was nothing but a myth to create the impression of a fait accompli. Congestion Pricing was passed along with the state budget in 2019 with the mandate to implement it no earlier than December 31, 2020-no start date was included. One of the lawsuits, filed by New Yorkers Against Congestion Pricing Tax [NYACPT] includes plaintiffs from New York City, Long Island, small-business owners and a bipartisan group of elected officials. The demand is for a full Environmental Impact Statement (EIS). The Environmental Assessment (EA) was completed using pre-pandemic data and as we are all aware, New York City and the surrounding areas have faced many challenges. This suit is the only one that raises SAPA (NYS Administrative Procedure Act) under which socio-economic impacts and job retention must be evaluated.

Congestion Pricing is a regressive tax that is inequitable, unfair and unsustainable. Its implementation will increase the costs of everyday goods and services for businesses and all New Yorkers. It will hurt small businesses and incentivise workers to spend more time working from home further decreasing the tax base of NYC.

We all wish to improve the quality of the environment but we need to be very respectful of everyone's needs in how we approach this aspiration. It is clear that some neighborhoods outside of the Central Business District would experience increased air pollution and traffic from vehicles by toll shopping seeking to avoid the tax. According to the MTA's own Environmental Assessment, once Congestion Pricing goes into effect, as much as 700 additional trucks will be rerouted to the Cross Bronx Expressway. In that same report, MTA acknowledged that trucks would be diverted to routes on highways in Staten Island, in the South Bronx, along the approaches to the RFK Bridge, George Washington Bridge, and into northern New Jersey. The Lower East Side, an Environmental Justice Community, will also experience increased pollution and traffic in the areas alongside the FDR Drive. The threat of increased suffering from asthma and other respiratory illnesses ought to count. In acknowledgment of the anticipated increase in pollution in the Bronx, the federal government increased its spending on "mitigation" from \$100 million to over \$300 million. Traffic will merely be redistributed.

Many who travel into the district from outside New York City are those who work in essential services and they may seek to look for jobs elsewhere. These include workers in health care, restaurant workers, first responders and those who do not work nine-to-five shifts when mass transit is more reliable. Many workers have been displaced due to skyrocketing rents and are forced to have longer commutes from areas with scarce public transportation. The economic hardship will also be felt by tourist-dependent neighborhoods such as Chinatown, Little Italy and Times Square, which employ predominantly low-wage employees.

According to the re-evaluation, the revenue expected to be raised decreased to \$900 million from the initial estimates of \$1billion -1.5 billion. The state legislation mandates Congestion Pricing to generate \$1B annually but with a projected revenue of \$900,000, the current tax of \$15 will undoubtedly increase. Any change to the original bill must go back to the legislators. If we are to see how this plays out, one can look at the London model where congestion charge was implemented in 2003 at £5. In the two decades since London implemented Congestion Charge, the cost to get into their Central Business District increased by 300%. Using the London example, in 20 years, the Congestion Pricing Tax will cost everyday New Yorkers \$45

Many have requested an independent audit and accountability of how the MTA spends its money and ask what has become of the billions of federal subsidies already assigned to the MTA. Other revenue streams have been suggested that do not impose an additional tax on the working men and women who keep the city and state running. It is anticipated that it will lead to a loss of tax revenue that fuels the whole state. With the high vacancy rate of Manhattan office buildings, we need a solution that does not further harm businesses and the recovery in Manhattan.

It is time to contact your state legislators and tell them to let the pause become permanent. Many suggestions have been made as to how to raise additional revenue to fund the MTA that does not place the burden on the hard working people in the New York City vicinity. Funding for public transit must be considered a priority and funded by all levels of government. The cost must be spread throughout the area as everyone benefits from having a highly functioning public transit system. To place the burden to raise funds on one segment of society is clearly unfair.



Supporters and Opponents of Proposition One Make Their Case Known to Voters

Supporters and opponents of Proposition One, which will be on the ballot November 5, and in early voting, continue to push opposite messages and narratives over the need to pass or reject this measure.

Part A of Prop One would amend Section 11 of Article 1 of the Constitution to add new classes: "No person shall, because of race, color, ethnicity, national origin, age, disability, creed or, religion, or sex, including sexual orientation, gender identity, gender expression, pregnancy, pregnancy outcomes, and reproductive healthcare and autonomy, be subjected to any discrimination in his or her their civil rights ..."

Part B adds a new provision: "Nothing in this section shall invalidate or prevent the adoption of any law, regulation, program, or practice that is designed to prevent or dismantle discrimination on the basis of a characteristic listed in this section, nor shall any characteristic listed in this section be interpreted to interfere with, limit, or deny the civil rights of any person based upon any other characteristic identified in this section."[3]

On Saturday September 28, at the Yonkers Train Station U.S. Senator Kirsten Gillibrand and New York State Attorney General Tish James are headlining a rally organized by Democrats in Support of Prop 1 at 4pm. Also attending will be State Senate Majority Leader Andrea Stewart-Cousins, County Executive and Congressional candidate George Latimer, State Senator Shelley Mayer and Deputy County Executive Ken Jenkins.

The event is designed to increase awareness about the November ballot initiative and to encourage voters to flip their ballot and vote "Yes" to the proposal, formerly known as the New York Equal Rights Amendment.

Why New Yorkers Should Vote "Yes" on Proposal 1

Across the country, politicians are restricting people's rights and freedoms, including the right to abortion and the right for all of us to be who we are.

Since Roe v. Wade was struck down by the Supreme Court, twenty-one states have either banned or restricted abortion care. There's a full-blown assault on trans people's rights, with hundreds of anti-trans bills introduced — and many passed — in state legislatures across the country just this year.

We might like to think we're safe from these attacks here in New York, but the truth is there are dangerous loopholes in our state constitution that leave us vulnerable to the whims of politicians. And though we have strong laws protecting us from discrimination, we know that laws aren't enough, because they can be easily changed, as we've seen time and again in recent years as political winds shift.

When we enshrine a right in the state constitution, we protect it from political attacks. In of becoming our governor. In the State legislature, pro-choice leaders have only controlled both chambers for eight of the past 58 years. In fact, it was only in 2019 that New York finally removed abortion from the homicide code and began to regulate it under health law.

That's why we need Proposal 1, or what has been previously called the New York Equal Rights Amendment, which will protect our rights and reproductive freedoms — including the right to abortion. Proposal 1 will keep New Yorkers — not politicians — in charge of our personal decisions and will enshrine equal rights into our state constitution.

Prop 1 will be a critical tool for all New Yorkers to exercise their rights. That's why powerful, well-funded, anti-abortion forces are working hard to defeat it, even before voters get a chance to pass it. We got good news in June when the New York Appellate Court overruled a baseless attempt by anti-abortion operatives to boot Prop 1 off the ballot.

But our opponents won't stop trying to roll back our rights. They are dead set on doing everything they can to keep Proposal 1 from passing, and they will be back with more at-

This isn't new: anti-abortion extremists are using the same playbook in New York that they are using across the country - using the court system to try to roll back our rights, because they know protecting abortion rights is popular at the ballot box.

Despite these attacks, we're not backing down. In fact, we're working even harder alongside New Yorkers for Equal Rights to make sure every New Yorker knows to vote YES for Prop 1 in November.

We are in the early stages of launching our massive voter contact effort. We will be out in communities across the state knocking on doors, phone banking, texting, emailing, and doing everything we possibly can to get Prop 1 across the finish line in November.

But to do all that, we need your help. Please join our campaign to pass Prop 1 and enshrine equal rights into our state constitution. This November, we must make sure all New Yorkers' rights are protected.

Peekskill Man Gets 30-Life for Murder of Stepfather and Arson

Westchester County District Attorney Miriam E. Rocah announced today that a Peekskill man was sentenced to 30 years to life in state prison for the 2022 stabbing murder of his stepfather and setting fire to his mother's apartment the same day.

DA Rocah said: "This defendant murdered Edward Reeves in cold blood and then lit his own mother's home on fire. Today's sentence holds this defendant fully accountable for his violent and deadly actions."

The defendant, Shane Gilleo, 32, was sentenced to 25 years to life in state prison for Murder in the Second Degree to run consecutively with an indeterminate term of five to 15 years for Arson in the Third Degree.

Following a two-week trial, a jury on Aug. 7 found the defendant guilty of both felony charges.

At approximately 12:30 a.m. Sept. 14, 2022, the defendant stabbed the 48-year-old victim seven times in the arm, abdomen, thigh and chest with a knife in a parking lot outside his grandmother's Peekskill apartment on North James Street. The defendant then fled the scene.

The victim was transported to Westchester Medical Center in Valhalla where he died from his injuries.

As detailed during the trial, the Peekskill Police Department recovered the knife used to kill the victim and the defendant's cell phone at the scene.

The defendant was on federal supervised release from prison and subject to home confinement with an ankle monitor.

Eleven hours later, at approximately 11:30 a.m., the defendant barricaded himself inside his mother's Peekskill apartment on Grant Avenue as Peekskill police surrounded the two-family residence in an attempt to get him to surrender.

The defendant set three separate fires inside the apartment before punching out the windows and jumping out of a second story window. The apartment was rendered uninhabitable.

Following their investigation with assistance from the Westchester County Department of Public Safety, the Peekskill Police Department arrested the defendant

The case was before Judge Robert Prisco in Westchester County Court and prosecuted by Senior Assistant District Attorneys Rachel Ehrhardt and Kevin Jones of the Trials and Investigations Division, with assistance from Criminal Investigator James Ossipov, Senior Crime Analyst Patricia Reed, and Victim Witness Paralegal Jessica Martinez.

Somers Interim Superintendent Harry LeFevre. "His devotion to assuring that all voices are heard makes him an ideal council member to represent his fellow students throughout the state." In the new role, Gallivan will be invited to help run the National Student Council Conference in Chicago in early 2025, Dashner said. In March, the national council will travel to Washington D.C. to meet with members of Congress, the Department of Education, and possibly White House staff. The members will join about 400 principals and assistant principals from across the country that NASSP will send. A key topic is expected to be the need for more mental health services in schools. The NASSP formed the National Student Council, Dashner said, because "we saw an opportunity to leverage the power of our advocacy work with principals and assistant principals and extend that to students." To be eligible for the post, high school students had to have served at least two years on a student council. Gallivan vastly exceeded that criterion, having been a student council member since fifth grade at Somers Intermediate School.

"At the time, I wanted to find a way to have my voice heard to be able to hear other student voices," Gallivan said, adding that he and other student council members wanted to know "what we as students can do to make sure that whatever is going on is helping the school grow and flourish as a community.

Even if a discharge has been obtained, this lawsuit to foreclose the mortgage will continue and we will seek a judgment authorizing the sale of the mortgaged premises.

to 40%), with 6% supporting Working Families Party candidate Anthony Frascone and 8% undecided. Our latest poll shows Jones closing the gap, now trailing Lawler by just 3 points (46% to 43%), with Frascone's support at 5% and undecideds at 7%. The momentum is on Jones's side. In a head-to-head matchup, the race tightens to a slim 2-point difference, 47% Lawler to 45% Jones. Polling often overstates 3rd party support until we get closer to Election Day.

Mike Lawler's worsening image spells trouble for his reelection bid. Back in August, Lawler was +10 on favorability (43% favorable to 33% unfavorable). However, in our most recent poll conducted from September 15-18, his unfavorable rating jumped to 39%, while his favorable rating stalled at 44%, pointing to increasing concerns as voters become more aware of his record

Democrats hold a narrow motivation advantage. On a 0 to 10 scale, where 10 mean extremely motivated and 0 means not at all motivated, 85% of Democrats said they were extremely motivated (10) to vote in this election compared to 83% of Republicans saying the same. Based on party self-identification, Democrats compromise 35% of the electorate and Republicans make up 29% of the electorate.

• Bottom Line: Lawler's record, now under scrutiny, has moved the race to within the margin of error, but Democrats will need to continue the heavy investment we've seen over the last two weeks to keep the momentum going and put Jones in the lead," end of memo.

But there is a third-party candidate in this race. Anthony Frascone is running on the Working Families Party line, and if you include all three candidates (as we should) Frascone gets 5% and the numbers change to 46% for Lawler, 43% for Jones and 5% for Frascone

Frascone won the WFP Primary over Jones in June, with 287 votes to 197 for Jones. Before the primary, the WFP rescinded its endorsement of Jones because Mondale endorsed George Latimer in the 16th CD Dem. primary instead of incumbent Squad member Jamaal Bowman. And, as one Progressive democrat posted, "So, that extremist and irresponsible move could cost the Dems a very valuable House seat."

Usually, support for third party candidates shrinks as we get closer to election day. And if progressive democrats, and members of Indivisible Westchester in the district vote for Jones on Nov. 5, then Lawler could be in trouble.

In 2022, 285,000 voters cast their vote for Lawler or Sean Patrick Maloney. Lawler won by 1820 votes.

If Frascone does get 5% of the vote in November, it could mean up to 14,000 votes. And most of these votes clearly go to Jones, or they stay home, or vote Harris for President and don't vote for Congress.

Republican leaning pollster Larry Sabato views NY-17 differently. Shifting the race in Lawler's favor in his Sabato's Crystal Ball predictions, link (https://centerforpolitics.org/crystalball/five-house-ratings-changes-as-overall-battle-for-majority-remains-tight/)

"Last cycle, Rep. Mike Lawler (R, NY-17) pulled off an impressive upset of then-Democratic Congressional Campaign Committee Chairman Sean Patrick Maloney in a district that extends north from Westchester County and that Joe Biden won 54%-44% in 2020. Lawler has generally won kudos for trying to carve out an independent image—a necessity for a Republican in a blue-leaning seat—and he has benefited from some modest but important developments, such as his Democratic opponent, former Rep. Mondaire Jones, losing the primary for the Working Families Party ballot line, which could cost Jones support that might otherwise have gone to him if he had that ballot line. Lawler is very likely leading in this race, and not just by a couple of points: A publicly released August poll from a Democratic sponsor had Lawler up 5 points, and Lawler may be up more than that. We doubt Lawler would actually win by a substantial margin, but we have seen and heard enough to believe that he's a modest favorite." Writes Sabato.

The Lawler campaign welcomed Sabato's news. "Mondaire Jones' campaign is starting to look a lot like the Titanic - an ill-fated ship doomed to sink in fantastic fashion," said Lawler for Congress spokesman Chris Russell. "The ratings changes from Inside Elections and Sabato's Crystal Ball confirm what everyone in the political world already knows - Mondaire Jones might just be the worst candidate for Congress in the country."

"Between paying himself with small dollar donors' cash, being caught supporting voting rights for imprisoned cop-killers and rapists and failing to be able to produce a single poll that shows him winning, it's clear that Mondaire's campaign is on life support," concluded Russell. "And in just 47 days, Mondaire Jones and his campaign will be relegated to the dust heap of history."

ris, but she could not get a clear shot and did not deploy it. At one point in the struggle, Mr. Garris had his hands on the second officer's gun. The third officer noticed and yelled "gun!" before he discharged his service weapon, striking Mr. Garris. The officers began performing life-saving measures on Mr. Garris until an ambulance arrived. Mr. Garris was taken to a local hospital, where he died from his injuries on July 10, 2023.

Under New York's justification law, a police officer may use deadly physical force when the officer reasonably believes it to be necessary to defend against the use of deadly physical force by another. In this case, Mr. Garris had his hands on one officer's gun while they were attempting to arrest him. Another officer deployed his service weapon because he believed he needed to protect himself, the other officers, and any bystanders. Given the circumstances and based on the law and the evidence, a prosecutor would not be able to disprove beyond a reasonable doubt at trial that the officer's use of deadly force was justified.

The New Rochelle PBA issued the following statement. "The Attorney General's findings confirm what we have known to be true since the days immediately following this tragic encounter: Detective Steven Conn's actions were lawful and justified, that it was Jarrel Garris' who caused this encounter to become deadly, and had Detective Conn not acted swiftly, this incident would have likely ended with the death of several police officers.

"The Attorney General's report establishes the following: while New Rochelle police officers were effecting a lawful arrest, Jarrel Garris, who was high on PCP, violently resisted and fought with the officers. During this struggle, Garris put both his hands on Officer Bird's service weapon and slid the holster's safety hood into the unlocked position. Thankfully, Detective Conn observed Garris pulling the gun from the holster, warned his fellow officers that Garris had control of Officer Bird's handgun, and fired one round preventing Garris from using the gun against them. This entire incident happened within seconds. There is no amount of police training or policy writing that can guarantee positive outcomes when violent criminals continue to refuse lawful orders and resist lawful arrests. It is irresponsible and dangerous for our government and elected officials to ignore this important fact....It is disappointing to hear rhetoric which suggests that Jarell Garris died "over a couple of grapes" or "for committing a low-level crime". That is a terrible misrepresentation of the facts and ignores the life-threatening actions taken by Garris moments before his death... There is only one reason a person would attempt to pull a cop's gun from its holster, and that is because he intends to use it," end of NR PBA statement.

The family of Jarrel Garris, through their attorney William Wagstaff III, said they were "angry and disheartened" Attorney General James' decision. "Police Officer Conn will join the alarmingly long list of police officers who escape accountability when they take the lives of unarmed – typically Black, Brown, and/or poor – civilians. Jarrel Garris is dead because of an encounter over an allegation of eating strawberries he didn't pay for. This is outrageous. The family will continue to fight until there are policy changes and Justice for Jarrel."

The City of New Rochelle statement read, "The fact that NYAG James' office took more than a year to probe an episode that unfolded in seconds demonstrates the depth and thoroughness of the investigation. Whenever a police officer uses deadly force, no matter how straightforward or complex the episode appears, it is a deeply traumatic event for a community such as ours, and it must be scrutinized from every possible angle, no matter how long it takes. We remain confident of the professionalism and integrity of the men and women of the New Rochelle police department."


Damon Jones, Publisher of Blackwestchester.com, wrote, "The use of deadly force requires the presence of an immediate and overwhelming threat. No weapon was visible in control of Mr. Garris in this case, and neither Officer Bird nor Officer Chavarry was in danger of losing their lives. While it is true that Mr. Garris resisted arrest, resistance—especially from someone who appeared disoriented and possibly experiencing a mental health crisis—does not justify escalating to the most extreme measure of lethal force. While the Attorney General's office may have refused to act, the responsibility to correct this injustice now rests with New Rochelle's law enforcement officials and elected representatives. They can address this issue by removing Detective Conn from his duties. Failing to do so would send a dangerous message that unjustified deadly force can go unpunished," writes Jones, (https://blackwestchester.com/nrpd-detective-conn-must-be-fired-ags-report-on-the-shooting-of-mr-garris/).

Jones also wrote as a member of Blacks In Law Enforcement of America (BLEA), a national organization of Black Law Enforcement Professionals, that the group "expresses its profound disappointment and lack of confidence in the New York State Attorney General, Tish James, following her handling of the Jarrell Garris case. The killing of Jarrell Garris, an unarmed Black man experiencing a mental health crisis, by New Rochelle Police officers is a stark reminder of the systemic failures in our law enforcement and justice systems. The Attorney General's office not even finding a bill of manslaughter insults the Garris family and justice itself.

"The Attorney General's recommendation that the New Rochelle Police Department merely "upgrade its policies" is woefully inadequate and deeply problematic... We find it unacceptable that Attorney General Tish James, since the killing of George Floyd in 2020, and after every police department in New York submitted independent reviews to her office per former Gov. Cuomo's Executive Order., has not taken this opportunity to propose sweeping state-wide policies on police use of force and deadly force when encountering individuals with mental illness."

Former County Legislator Damon Maher wrote, "The AG's report apparently fore-closes the possibility of a criminal trial, although I suppose the local DA could pick up the case or the Feds could do so on a civil rights violation theory. But a large monetary judgment or settlement in a civil case against the City, which involves a less onerous burden of proof for the grieving family of the deceased citizen, looms as a distinct possibility. Also, the AG's report is not a determination of any particular officer's ability to continue to perform the role of a police officer in this City, which is likewise governed by a different standard of proof and is currently in the purview of the Police Commissioner alone."

The family of Kenneth Chamberlain Sr., who was killed in an interaction with White Plains police in 2011, said, "The officer's playbook is universal, with rehearsed language designed to justify any act of violence: "I feared for my life," it was a very fluid situation or in this case, Detective Conn's claim that he needed to protect himself and others. But the truth is plain to see the video reveals the detective approaching and escalating the situation, not retreating or de-escalating. This officer was not held to the same standard that we, as citizens, are bound to follow. Year after year, the New York Attorney General has failed to hold law enforcement accountable, and we must remember this failure when she seeks re-election.
