**Democratic & Republican Primaries in** Westchester on June 28 and in Early Voting

Westchester democrats and republicans are heading to the polls, during early voting this week, and for the upcoming primary on June 28 for Governor and Assembly. Due to court cases and the redistricting of congressional lines in NY, another primary will be held in August for Congress and State Senate?

For the first time in decades, both major parties have competitive primaries for Governor. On the democratic side, Governor Kathy Hochul is running for the first time as Governor, after taking the position upon the resignation of Andrew Cuomo.

Hochul's two opponents in the democratic primary are Congressman Tom Suozzi and NYC Public Advocate Jumaane Williams. Suozzi has occupied the moderate lane of the NY democratic party, while Williams occupies the far left, progressive wing. Neither candidate has distinguished himself, nor given a rationale while they should be the NY Dems candidate for Governor.

This is despite a lot of bad news for NY State and for the Country, most notably crime, inflation, and gas prices. Hochul shouldn't be blamed for inflation and gas prices but the problems of the party in charge in Washington DC trickles down to NY.

But Williams and Suozzi have not been able to land a knockout blow to Hochul's campaign on either subject. Suozzi had the campaign cash, and experience, to stand toe to toe with Hochul, but he seems unable to connect with enough NY democrats to get close enough in the polls to stand a chance at victory.

Suozzi's biggest mistake, in our view, was saying that he would accept the endorsement of Andrew Cuomo. Agreeing to accept an endorsement that will never come only annoyed or angered the many NY democrats who called on Cuomo to resign, and his victims of sexual harassment.

The other issue that Suozzi has tried to tarnish Hochul with is her prior support of gun rights and the NRA. We believe that it is OK for elected officials to change their minds, and "evolve" as Governor Hochul has on this issue. We like what we have seen from Governor Hochul and endorse her in the democratic primary June 28.

The republican primary for Governor is more complicated, with four candidates running to face off against the democratic nominee in November. Congressman Lee Zeldin, former Westchester County Executive Rob Astorino, Businessman Harry

# If You Commit the Crime, do the **Time! Especially Sex Abuse**

Last month, Westchester DA Mimi Rocah announced that her office had successfully prosectured the case of Patrick Patierno. Patierno, 54, of Yorktown, had been charged with sex abuse of a young, female employee. We wanted to learn more about this case, so we FOIL'd the records from the Ossining Police Department.

Here are the details: On Jan. 14, 2021, a man walked into the Ossining Police department stating that a co-worker was sexually assaulted at Villarina's in Ossining. According to the witness, Patierno came into his place of business complaining that a young, female employee told him she was going to quit. We later find out why this young woman did quit, but more on that later.

When the victim got to work she texted her co-worker what happened between her at Patierno. "He looked for me and I just thought he wanted to talk to me. Force me, did bad things. cnmg. He is a morbid old man. Forced me, ended up on top of my shorts. He's crazy," according to the police report.

After breaking down what his friend and co-worker had told him, "he realized that Pat had noconsensual sexual contact...and ejaculated on her shorts."

The victims shorts were collected by the OPD, but they had been washed and were inconclusive for DNA. Eventually the victim came into the police department and gave the same statement to the OPD. The following day, Patierno was arrested for Sex Abuse in the First Degree.

According to the police report, "the suspect in this case had again made contact with the victim at her residence.

The victim added that she had been sexually harassed by Patierno for months before this incident, and stated that on two occassions, "Patrick called her into the office and forcibly pressed his body on to her and pinned her against a wall in the office."

The victim, "explicitly and emphatically would refuse Patrick's unwanted advances and tell him no she did not want him to touch her. It got to the point where she told Patrick that she was quitting and leaving as a result of the harassment."

On the date of the incident, at 930 am, "Patrick stopped by her house to drop off a chess set. She allowed him inside at which point Patrick began questioning

# Sayegh Diapers Sales Tax Relief Gets Unanimous Support

Yonkers Assemblyman Nader Sayegh's drive to exempt all diapers from local sales taxes succeeded during the final hours of the Legislative Session when the Assembly voted 146-0 to pass the Sayegh DIAPER Sales Tax Exemption Legislation. Earlier the State Senate approved the legislation 63-0.

Assemblyman Nader Sayegh said: "With inflation impacting family budgets, I passed statewide legislation to exempt diapers from local sales taxes, making them more affordable for families struggling to buy enough diapers for their babies and making incontinence products more affordable for Seniors. Diapers are a necessity and adding a sales tax on top of the purchase price is just wrong. I thank the National Diaper Bank Network and the volunteers from the State's diaper banks including the Junior League of Central Westchester, for coming to the State Capitol to lobby for passage of my Diaper Act."

Senate Sponsor Jamaal. T. Bailey said: "One in three American families struggled to afford diapers even before the pandemic. Diaper need has only increased during the pandemic and New York's diaper banks are struggling to pay for the supplies themselves. This legislation is critical to addressing diaper need and alleviating costs for families and diaper banks across the state by exempting adult and children's diapers from sales and use taxes. Thank you Assemblyman Sayegh for sponsoring and championing in the Assembly, Senate Majority Leader Andrea Stewart-Cousins, Speaker Carl E. Heastie, and the advocates and diaper bank organizations – Every Bottom Covered, the National Diaper Bank Network, CNY Diaper Bank, Junior League of Central Westchester, and Baby Steps Baby Pantry Diaper Bank – for their tireless work on this critically important issue."

Assembly Speaker Carl Heastie said: "Diapers are an item essential to the health and wellbeing of our youngest New Yorkers, yet too many families struggle to afford them," Speaker Carl Heastie said. "By exempting them from local taxes, this legislation will help ease the financial burden on New Yorkers, and make diapers and incontinence products more affordable at a time where we are seeing the cost of necessities rise."

The National Diaper Bank Network's Lacey Gero said: "We applaud New York State Assemblyman Nader Sayegh, the primary sponsor of the DIAPER Act, and Senator Jamaal Bailey who sponsored the DIAPER Act in the Senate for passing legislation that will end local sales taxes on diapers. Eliminating this regressive tax will make diapers, a material basic necessity for all babies, more affordable for New York families. It will also relieve the tax burden on numerous nonprofit diaper banks working to support the 1 in 3 families who struggle with diaper need," said Lacey Gero, policy and coalition coordinator, National Diaper Bank Network. "NDBN member diaper banks throughout the state have worked with elected officials and fellow advocates to make this happen and respectfully request Governor Hochul's signature on this important bill."

Michelle Memolil, President of the Junior League of Central Westchester said: "Through the Westchester County Diaper Bank, JLCW has leveraged our resources to yield sustainable impact for people by combatting diaper deprivation for babies, easing the financial burden for families, and increasing access to a basic need. We are proud to add to that positive impact by supporting Assemblyman Sayegh and Senator Bailey in their successful advocacy efforts to eliminate local sales taxes on diapers."



# **Brooklyn Man Sentenced to 10 Years in Prison for Armed Attack at Greenburgh Bus Depot**

Westchester County District Attorney Mimi Rocah announced that Brooklyn resident Tony Mauro was sentenced to 10 years in state prison for an armed attack on a group of workers, including school bus drivers, employed by Royal Coach Lines at the company's Greenburgh bus depot in 2018.

Mauro, 41, was sentenced as a Second Violent Felony Offender on June 17, 2022, to 10 years in state prison, with five years of post-release supervision. Mauro pled guilty to Criminal Use of a Firearm in the First Degree, a violent felony.

"Gun violence in our community will have consequences," DA Rocah said. "No one should have to face the barrel of a gun while doing their job, let alone our transportation workers. We are grateful to all of the law enforcement who helped ensure the victims were physically unharmed."

On November 16, 2018, at approximately 4 a.m., Mauro ordered three victims at gunpoint onto a bus that was parked at the depot. He then fired a shot that struck the car of a fourth employee whom he had ordered out of the car. During the incident, which occurred during a blizzard, one of the victims was able to send a text for help, and Mauro fled the scene on foot as Greenburgh Police arrived.

The Greenburgh Police Department arrested Mauro following a pursuit and investigation, with assistance from the Greenburgh Towns and Villages SWAT Team and the Westchester County Department of Public Safety.

The case was before Judge Robert Neary in Westchester County Court, and was prosecuted by the Trials and Investigations Division of the Westchester County District Attorney's Office.

## Libby Reading App Available With Your Westchester Library Card



Many Westchester residents may not know that you local library card entitles you to access thousands of books, magazines and other material through an app called Libby. Libby is the Westchester Library Systems biggest and most widelyused digital resource.

Libby is the mobile app for OverDrive– your local libraries main content library for borrowable library E-books and E-audiobooks. You can download the app onto your iPhone, iPad or Android device – or whatever you'd like to use for reading or listening to books. Your local library card gets you access to:

Over 62,000 E-book titles (over 113.000 book copies in total) – ranging from new bestsellers to graphic novels to YA novels to picture books to timeless classics.

Over 13,010 MP3 E-audiobooks (nearly 25,000 copies in total) that you can listen to through the OverDrive app.

Over 3,400 magazine issues – ranging from The New Yorker and The Atlantic to Us Weekly and inTouch that you can borrow anytime and flip through like you would a printed issue.

Your library card allows you to borrow up to 10 E-books or E-audiobooks at a time through Libby. They can be borrowed 24/7, not just when the library is open. E-books and E-audiobooks are loaned for 14 days at a time. After that time they are automatically removed from the Libby app without ever incurring late fees. If no one else has a "hold" on the title you can renew within three days of the due date.

Even though they are digital, each copy of an E-book or E-audiobook can only be loaned to one library cardholder at a time. If there are no copies available you can place a hold and join a wait list. Each cardholder can place up to 10 holds at a time. Once it's your turn to borrow a copy of your hold title you have up to 3 days to download it.



# The NY Taxpayers Legal Argument Against Paying for a New Buffalo Bills Stadium

A lawsuit filed by four New York state residents against the proposed taxpayer funding of a new stadium for the Buffalo Bills football team continues to move through NYS Supreme Court, in Albany County.

The cost for the \$1.4 Billion New Éra stadium's total pricetag includes \$850 Million in public funds, with the State funding \$600 Million in construction cots, and Erie County government funding \$250 Million. The NFL will give the Bills owner, Terry Pegula, a \$200 million loan, and Pegula will fund \$350 of the remainding costs.

The NY State funding for the new stadium was included in the state budget passed by the legislature and signed by the Governor in April. Hochul, who comes from Western NY, was instrumental in including the stadium funding in the budget deal.

The lawsuit against the deal, filed in State Supreme Court last month, asked the court to declare the public funding plan "null and void" based on "Article VII-Section 8.1 and Article VIII, Section 1, of the New York State Constitution." The State of NY, the defendants in the case, have filed a motion to dismiss the suit.

The latest papers, filed by New Yorkers Bob Schulz, Westchester resident Tony Futia, Joshua Trost and William James, argue that in prior case law, the courts "give deference to public funding programs essential to addressing the problems of modern life, unless such programs are patently illegal." Schulz v State of New York, 84 N.Y.2d 231, 241 (1994).

"Clearly, and without doubt, the New York State Constitution prohibits the giving or lending of State and County money "in aid of any... private corporation ... or private undertaking ...." Article VII, Section 8.1 and Article VIII, Section 1. There are no exceptions. No State or County money can be appropriated for any project or undertaking if any part of that appropriation will aid – i.e., help, a private corporation. A private corporation is, by definition, a corporation organized for the profit of its members or in which the entire interest is not held by the state," states the Memorandum of Law filed by the four New Yorkers.

The legal papers also point out that "the public funds are to be used in aid of a private corporation in the non-essential business of enterainment, including entertaining people from states other than New York."

Bob Schulz, one of the plaintiffs in the lawsuit said, "The State of New York is a Constitutional Republic. The power of elected officials is limited by the will of the People as expressed in the State Constitution. Elected officials often step outside the boundaries drawn around their power. By appropriating \$600M in state funds, and authorizing \$250M in county funds to aid the Buffalo Bills, Gov. Hochul and the Legislature have violated provisions of the Constitution that prohibit the use of public funds in aid of private undertakings. We are asking the Court to invalidate those appropriations."

Westchester resident Tony Futia said, "New York state has been deliberately not teaching generations of children civic education as required by section 801 of the NY State Education Law."

A recent Sienna Poll found 63% of New Yorkers disapprove the public spending of \$600 Million for the new stadium, and opinion columns have largely criticized the expenditure.

Opposition to the public funding of the stadium has come from both sides of the politcal aisle, with fiscal conservatives like Schulz and Futia, and progressive democrats, opposing the expenditure.

State Senate Finance Committee Chair Liz Krueger said, "I'm sorry, this is a terrible way, a terrible way to use the taxpayers' money." Assemblyman Ron Kim said that 40 years of data show that public funding of stadiums is "one giant scam in economics."

The owner of the Buffalo Bills, Terry Pegula is currently worth \$5.1 billion. The estimated cost of renovating the existing stadium was \$350 Million.

# Feds Charge Elmsford Nurse in \$10 Million Loan Fraud Scam

On June 15, US Attorney Damian Williams announced announced today the unsealing of a criminal complaint charging Catherine Seemer, 42, of Elmsford, with wire fraud, federal financial aid fraud, and aggravated identity theft in connection with a scheme that resulted in the fraudulent discharge of over \$10.5 million worth of student loans on the basis of falsified medical certifications of permanent disabilities.

U.S. Attorney Damian Williams said: "The Total and Permanent Disability Discharge Program is designed to help ease the financial burden of those who suffer from permanent physical or mental disabilities, including military veterans who endure service-related disabilities, by relieving them of their student loan obligations. As alleged, the defendant defrauded this program for her own benefit. She stole the identities of more than a dozen medical doctors and falsified the disabilities of more than 100 borrowers in order to profit from the multi-year scheme, which resulted in the fraudulent discharge of over \$10.5 million in loans. This Office, along with our law enforcement partners, will continue to vigilantly protect the integrity of critical programs that exist to help those who are most in need."

FBI Assistant Director-in-Charge Michael J. Driscoll said: "As alleged, Ms. Seemer fraudulently orchestrated the discharge of student loans in excess of \$10 million on behalf of more than 100 borrowers she led to believe were eligible for various forms of student-loan relief. She ultimately reaped more than \$1 million in ill-gotten gains by charging borrowers fees in exchange for her "services." The action we have taken today is yet another example of the FBI's commitment to protecting government programs from fraudsters who seek to undermine them for their own selfish purposes."

As alleged in the Complaint filed in White Plains federal court: From June 2017 through March 2022, Seemer orchestrated a scheme to cause the fraudulent discharge of millions of dollars' worth of student loans for borrowers who did not qualify for relief under the federal Total and Permanent Disability Discharge Program and its private analogue. As part of the scheme, SEEMER deceived over 100 borrowers into believing they qualified for various forms of student loan relief and charged them fees—often between 10% and 20% of the loan amount—to facilitate their loan discharge process.

She then used the personal identifying information of the unsuspecting borrowers to submit fraudulent applications for student loan discharge on the basis of non-existent permanent physical and mental disabilities. In support of these applications, Seemer used the stolen identities, medical license numbers, and forged signatures of over a dozen medical doctors to falsify medical diagnoses and disability certifications. The scheme resulted in the wrongful discharge of over approximately \$10.5 million in loans under the disability-based relief programs. It is estimated that Seemer earned at least approximately \$1 million as a result of the scheme.

Seemer is charged with one count of wire fraud, which carries a maximum sentence of 20 years in prison; one count of federal financial aid fraud, which carries a maximum sentence of five years in prison; and one count of aggravated identity theft, which carries a mandatory consecutive sentence of two years in prison.

The case is being prosecuted by the Office's White Plains Division. Assistant U.S. Attorney Qais Ghafary is in charge of the prosecution.

Wilson, and Andrew Giuliani are the four republicans seeking to become the first elected Governor in NY since George Pataki in 2002.

Zeldin is the endorsed candidate of the NY GOP. He has the support of most of the local GOPs across the state and should have closed the deal on a primary victory long ago. But for some reason, Zeldin has been unable to resonate, and appeal to a majority of New York republicans.

Part of the reason is that his record of serving in the NY State Senate before serving in Congress has become a major campaign issue. Harry Wilson has launched a TV ad campaign highlighting Zeldin's prior support of Andrew Cuomo, and Zeldin's own comments that Cuomo would make a good president.

We also agree with several other NY newspapers who reject Zeldin based on his vote against certifying the 2020 Presidential election of Joe Biden. Zeldin joined 146 republican members of Congress in that vote, but none of those other republicans are running for NY Governor. And in deep blue New York State, that vote, in our view disqualifies Zeldin and makes it impossible for him to win in November.

And in a year of voter anger at crime, inflation, gas prices and a lack of baby formula, a Red Wave is possible even in NY.

Rob Astorino has run another good campaign for Governor. He ran in 2014 but was stabbed in the back by his fellow republicans (including Zeldin and Chris Christie) who forged an alliance with Andrew Cuomo and did not support his campaign.

Astorino would have been the logical alternative to Zeldin for NY republicans. But Harry Wilson decided to get into the race and has taken most of the energy and republicans who don't support Zeldin.

And while Astorino has tried to distance himself from Trump and January 6, 2021, there is a playbook from 2017 that NY democrats will use against him if he wins this NY GOP primary. Westchester democrats played the Trump card against Astorino, and he lost to George Latimer in his re-election bid for Westchester County Executive by 16 points. And the photo of Astorino visiting Trump in the Oval is still out there, ready to be pounded away on TV and in the mal.

We have appreciated and respected Astorino's service to Westchester and to NY State. Andrew Giuliani has been unable to distinguish himself in any of the debates, nor present a reason why he shoud be elected governor.

We endorse Harry Wilson in the republican primary for Governor. Zeldin has tried to counterattack Wilson's effective ad campaign against him by highlighting two points; that Wilson did not vote for Trump in 2020 (he voted for SC governor Nikki Haley) and that he worked for former President Obama.

Wilson will have to win over republicans, independents and moderate democrats in order to win in November, and the two facts that Zeldin has used to try and harm Wilson will help him in November, in our view.

Wilson helped save General Motors after the financial collapse of 2008, saving millions of American jobs. That experience is a badge of honor, in our view, and is desperately needed in New York state.

Wilson is also detached from Trump, so that democrats can't use it. Wilson is not a career politician, and as an outsider, can truly reach out to every New Yorkers. And he has the resources to make the 2022 race for Governor and real contest, something we haven't seen in 20 years.

Kathy Hochul and Harry Wilson would give New York voters the best options when they vote in November.

sive values. Shimsky won a mini-convention held between the two and also has the endorsement of the Working Family Party.

Abinanti has pushed back on the anti-vax accusations and has received a number of endorsements from Unions, both in Westchester and across the state.

The two have exchanged a number of endorsements, from Greenburgh Supervisor Paul Feiner endorsing Abinanti to Shimsky's democratic colleagues on the county board supporting her campaign. Whoever turns our their supporters should win.

Another competitive race is in the 95th district, which includes Ossining, Peekskill, Cortlandt and parts of Putnam County. Longtime Assemblywoman Sandy Galef announced her retirement at the end of this term, resulting in an open seat and four democrats seeking to replace her.

They are: former Peekskill Councilmembers and activits Vanessa Agudelo, County Legisaltor Colin Smith, Ossining Supervisor Dana Levenberg and former Peekskill Mayor Andre Rainey. Rainey was knocked off the ballot for unsufficient petitions, leaving three candidates.

Agudelo has received high profile, progressive endorsements from AOC, and Cynthia Nixon. She also has the support of the Working Families Party.

Smith is looking to move up in the middle of his second term on the Westcheter unty Board. Levenberg served in Galef's office before being elected in Ossining

her as to why she was leaving and became incessant about it. When she told Patrick to leave he became enraged and threw himself on top of her."

She "stated that Patrick tried to open her legs numerous times and lay on top of her, but she prevented him from doing so. She told Patrick to stop but he never listened. She stated that ultimately, he forcibly restrained her with one arm while thrusting his penis onto her buttocks and touching the intimate areas of her body with his other hand over her shorts. Patrick ultimately ejaculated on her," according to the police report.

Four months later, the co-worker who the victim first told about the incident returned to the OPD to complain that Patierno was driving by his house and the victims house.

DA Rocah's conviction of Patierno, for Sexual Abuse in the First Degree, a felony, and Unlawful Imprisonment in the Second Degree, a misdemeanor, he faces a sentence range of a minimum of 10 years of Sex Offender probation to a maximum of seven years in state prison. He will also be required to register as a sex offender.

Patierno is scheduled to be sentenced this week by Judge Barry Warhit. We await the sentence, and hope for justice for the victim.

In a related case, DA Rocah announced on June 16 that Anthony Urena, 25, of New Castle, was sentenced to 10 years probation for sexually abusing a woman while she was sleeping. On July 21, 2019, at approximately 4 a.m., Urena sexually abused the victim while she was sleeping in the defendant's home in New Castle, according to the DA's statement.

After an investigation by the New Castle and Ossining police departments, Urena was arrested in Nov. of 2020. He was charged with Sexual Abuse in the First Degree, a Felony, and the same charge that Patierno was found guilty of by a jury.

Urena also rolled the dice and went for a trial by jury, who convicted him. According to Rocah's release, "The District Attorney's office recommended a term of state prison."

In a victim impact statement made to the court, the victim stated: "You have stolen something from me I will never get back. I felt violated. I felt scared... I felt betrayed. I felt embarrassed... No one should ever have the misfortune of blissfully thinking they can trust a friend who is not really a friend at all and would violate them given the opportunity. I hope this trial has aided in saving another girl from becoming a victim of sexual assault."

Will Patierno get probation, or jail time? He has wiped his social media accounts of all photographs, including a photo of Patierno with a dozen teen agers outside of his store. We want justice, and for the public to know that sometimes a sexual predator, or creep or whatever you want to call him, is in the middle of your downtown, making your sandwich, but also harassing your teen age daughter.


