Yonkers Girl Scout Raises Funds for Hospital Workers

An eight-year-old girl is lending a helping hand to frontline health care workers during the pandemic by delivering treats and snacks. Brianna Meegan of Yonkers wanted to support frontline and health care workers who are treating Covid-19 patients.

With her mother Fidelma Bartley Meegan's help, they launched a Facebook page in March and so far they have raised almost \$3,400. They have used the lonations to buy candy, chips and protein bars for staff at six local hospitals, ncluding Saint Joseph's Medical Center, which received a delivery last month.

"They're just amazed. They're very happy and very appreciative," said Fidelma, who explained that the distribution of treats has helped Brianna cope with being separated from all her school friends. "It really puts a smile on her face. She stays in the car with a mask during the delivery, but she can see how happy the people are."

Brianna and Fidelma are still collecting funds and their hope is to do another round of snack delivery to the six hospitals they've supported. Fidelma and the deliveries have brought some medical workers to tears.

"Our staff was very touched by Brianna's efforts," said Lorraine Horgan, vice President of External Affairs at Saint Joseph's. "Our dedicated and heroic staff have been working tirelessly providing high-quality care to the community we serve throughout this unprecedented pandemic and Brianna's loving gesture really moved them and served as a reminder of how grateful the community is for all they are doing to defeat Covid-19."

Zehy Jereis Returns in Romano Campaign for Judge

Negative Attacks Come to City Court Race

With an upcoming June 23 primary in Yonkers, in the middle of the Coronavirus, two factors have changed the dynamics of the Democratic Primary for Yonkers City Court: Negative campaigning, and the return to Yonkers politics of Zehy Jereis. And many believe that both are linked, with most Yonkers democrats we spoke to saying that negative campaigning, or lies, should have no part in politics during a pandemic and in a Judicial race.

Five candidates are running for the Democratic nomination for Yonkers City Court Judge, three of which won the Democratic City Convention and have the nomination of the party. They are: Judge Tom Daly, Judge Brendan

McGrath and attorney Verris Shako.

Two other Yonkers attorneys are also on the ballot. Dan Romano and Karen Best. Both are claiming that they were denied the right to fairly compete at the Yonkers Democratic convention, when the facts show that both did not get the votes from the party faithful: Romano got 28%, Best got 0% because she could not get a single Yonkers Democrat to nominate her

because she could not get a single Yonkers Democrat to nominate her.
Yonkers Democratic Chairman Tom Meier said, "To say that the convention was rigged and that our system is corrupt in an outright lie. These accusations against me are also against the 400 district leaders who attended the convention and voted their conscience. I twisted no arms and I can't help it if they didn't like the outcome. Democrats didn't vote for them."

Additional falsehoods and accusations have been thrown at the Democratic Party nominees by Romano and his campaign. These claims were then posted on the Yonkers Tribune website, which permits comments

below the original post.

Several of those comments concerned the wife of one of the judicial candidates, who while not running for Judge, had to endure the negative attacks while she was recovering from COVID-19. Several public figures in Yonkers have sued the Yonkers Tribune for libel, based on these same types of harmful, hateful comments which are not deleted.

Could There Be Givebacks or Furloughs, instead of Layoffs?

Still Waiting, but Budget Picture Looks Bleak

Two comments from City officials last month should raise the eyebrows of the residents, taxpayers and union employees of Yonkers. Both were honest assessments of how difficult the City of Yonkers budget for the next fiscal year will be without the help, in the form of a COVID-19 bailout, from Washington DC.

Mayor Mike Spano said during a Facebook live conference, "We have the potential for significant cuts because of the State budget and we don't have the ability to close them."

Yonkers Finance Commissioner John Liszewski. issued a similar alarm at a City Council budget committee last month when he said that a possible \$70 Million State Education Aid cut to the Yonkers Public Schools, "is what keeps me up at night," because of the severity of cuts and job losses it would entail.

What the Mayor was alluding to is that he will need help from the City's unions to close the upcoming expected budget hole, and if the unions do not agree to 'givebacks' then layoffs of municipal employees will have to happen

But givebacks in the City of Yonkers have been a rare occurance, with two reasons why the unions are not so eager for givebacks. First, Yonkers has always waited, and usually received a last minute bailout from Albany, and specifically from Governor Cuomo, or State Senate Majority Leader Andrea Stewart-Cousins, and dating back to former State Senator Nick Spano.

A last minute package of billions in State Aid, usually in the form of State Education Aid, would help close some of the budget gap, and a combination of smaller layoffs, and borrowing and not rehiring vacant positions, would close the rest.

This year is different, some will argue, because of the Coronavirus. Governor Cuomo is facing a \$13 Billion budget hole in the State budget, and this time, its Cuomo who needs help from above, that being Washngton DC.

In Congress, the House has passed a \$3 Trillion package of aid that includes funds for New York State government. If that bill were to pass, then Cuomo would have the funds to close his budget and he could then fund Yonkers, and the numbers in Mayor Spano's budget plan would work; a 2% tax increase and no layoffs.

But in Wahington, US Senate Majority Leader Mitch McConnell and President Donald Trump have both said 'no blue state bailout.'

Antibodies Testing at Westchester County Center Available to Everyone



Yonkers Rising Columnist Eric Schoen went to the Westchester-County Center To have his antibodies for COVID 19 Tested. Westchester Medical Center Health Network (WMC HEALTH) has opened antibodies testing to all residents of Westchester County free of charge by appointment only.

Call 914-326-2060 to schedule your appointment. You do not have to be a first responder or an essential worker to be tested. Testing involves the simple drawing of 1 Small test tube of blood. The whole process takes 15 minutes.

Westchester Medical Center Health Network (WMCHealth) is expanding its antibody testing program. Beginning today, COVID-19 antibody testing for the public is available by appointment at the Westchester County Center in White Plains, NY.

Members of the public interested in COVID-19 antibody testing can call 914.326.2060, Monday through Saturday from 8:30 a.m. to 6:00 p.m., for screening and to make an appointment.

After testing samples are secured, they are brought to Westchester Medical Center's Valhalla laboratories for evaluation. In most cases, results will

be shared with each tested individual within 48 hours.

Antibody testing can play an important role in the fight against COV-ID-19 by helping to identify individuals who have been infected and developed antibodies to the virus. Test results will be used to estimate the total number of people who have been exposed and/or infected nationally.

Additionally, while the presence of antibodies does not confirm current or future immunity, it allows an individual who tests positive for antibodies to donate convalescent plasma, a resource that can help others who are actively battling COVID-19

Major Drug Bust by County Police

Two Kilos of Coke Seized Durng Traffic Stop



Westchester County Police arrested a Massachusetts man on Monday evening after he was found in possession of large quantities of cocaine and marijuana as well as counterfeit prescription pills.

The incident began about 5:30 p.m. when an officer stopped a vehicle for a traffic violation on Central Park Avenue near the Cross County Parkway in Yonkers. The officer detected an odor of burnt marijuana in the vehicle and also observed a shopping bag on the rear seat containing what appeared to be marijuana in vacuum-sealed bags.

The driver was taken into custody. A satchel bag that he was wearing around his person was seized and found to contain a quantity of fraudulent Oxycodone pills.

The vehicle, a Nissan Maxima, was impounded and towed to Westchester County Police headquarters. A search warrant was obtained and more than four pounds of cocaine, or approximately two kilos, was recovered along with almost 22 pounds of marijuana. In addition, a loaded magazine for a 9 mm handgun was found in the car.

Victor Ramos, 32, of Holyoke, Mass., was charged with Criminal Possession of a Controlled Substance 1st Degree, two counts of Criminal Possession of a Controlled Substance 3rd Degree, Criminal Possession of Marijuana and Criminal Possession of a Weapon 3rd Degree. All the charges are felonies.

Ramos was held overnight at County Police headquarters in Hawthorne. He was arraigned today in Yonkers City Court and released on his own recognizance.

YPD & Law Enforcement Agencies Issue More than 100 Summonses

The Yonkers Police Department recently partnered with local law enforcement agencies once again to address numerous community complaints of drag racing, speeding, and excessive noise from motor vehicles and motorcycles on local roads, parkways, and highways.

Yonkers Police working in collaboration with members of the Westchester County Department of Public Safety and the New York State Police (Troop K and Troop T) issued a total of 112 summonses to violators for a multitude of offenses including speeding, loud exhaust, unlicensed operation and unregistered motor vehicles, failing to signal, lane violations, improper window tints, and other equipment violations. One operator was arrested by the Westchester County Department of Public Safety for aggravated unlicensed operation. Another violator was issued a speeding summons for traveling more than 120 MPH on the New York State Thruway.

"This pandemic has led to a growing number of drag racers violating the rules of our city, state and county roadways, causing an abundance of noise pollution and dangerous conditions," said Yonkers Mayor Mike Spano. "Thank you to our Yonkers Police and neighboring law enforcement agencies for cracking down on those who don't have respect for their fellow drivers or residents. No one is above the law and we will continue to ensure quality of life issues like this are fully enforced."

Minority Leader Mike Breen said, "for too long the residents surrounding Central Park Avenue, Sprain Brook, Bronx River and Saw Mill Parkways and the New York State Thruway have heard excessive noise, as have I, caused by motorcyclists and drag racers traveling at dangerously high speeds. I commend the Yonkers Police Department for working in collaboration with the Westchester County Department of Public Safety and New York State Police for hearing the concerns of the residents and silencing these offenders. With nice weather upon us I'm hopeful continued enforcement will keep our neighborhoods quiet and safe".

These enforcement details are a direct result of community feedback and law enforcement's mission to ensure the safety of our roads and preserve quality of life for our residents and will be continuing. Bankruptcy and Consumer Protection Attorney, David J. Babel, Esq., Bronx NY. "Clients are not yet calling in droves. Many people are in shock and adjusting to being self-quarantined. Others are just sitting home and waiting out their combined NYS and Federal unemployment checks. But the surge is coming in another couple of months because the Federal money of \$600 per week will be running out soon. There will be a rush of people seeking and needing a fresh start. This will be with us, unfortunately, for longer than we may realize."

Mortgage Broker, Husam F. (Sam) Hattar, Arlington Financial, Yonkers, NY. "Banks have tightened up guidelines to mitigate the risks involved. FHA has raised credit score requirements on some loan products. In the past, FHA lenders would accept a 500 credit score. Due to the economy, banks are looking for 640 and up. Delinquency rates are rising due to the pandemic, with 9% of all loans as of May being in forbearance. To mitigate the losses, banks are making it a little tougher to get a loan. On a positive note, as a broker I have the opportunity to shop around with different lenders and find a product for the borrower that works."

R.E. Broker/Owner, Eric Stein, ReMax Realty, Tuckahoe NY; "We had 5 buyers for every house prior to the virus. We still have 1-2 buyers per

How Can Absentee Ballots Get to Me If I Don't Have Reliable Mail Delivery?

Greenburgh Supervisor Paul Feiner writes, On June 23rd many residents of NYS will be casting their votes by absentee ballot in THE primary for President, Congress, State Legislators, District Attorney. I support the Governor's initiative to encourage people to vote by absentee ballot.

A significant concern - many Greenburgh residents have not received ANY mail in days. Sampling of e mails I received. At the bottom of the page the Hartsdale Postmaster acknowledges that "the entire Postal Service is experiencing some complications." I continue to receive complaints from others that

mail that should have been delivered to them went to someone else. If people vote by absentee ballot they should expect that their absentee

ballot will be delivered to the Board of Elections BEFORE VOTES ARE COUNTED so their ballot can be counted. I am reaching out to state officials suggesting that the Board of Elections notify voters by e mail that they received the ballot.

If you are experiencing similar problems please advise by e mailing me at pfeiner@greenburghny.com.

Some of the complaints received by Feiner in April included: "hi, I just

went to the post office on central ave because i have had letters sitting in my mailbox to go out for at lease 3 days. The post office is closed but I spoke to the mailman behind the door and he said that my carrier is quarantining herself and there has been no mail due to a backup at the plant with limited staff." and "Don't know if you have a line in to the US Post Office Scarsdale An-

nex but Cotswold in Edgemont has now not had any mail delivered for three days straight. I understand they must be swamped but many seniors in the neighborhood rely on checks that are mailed to them, or have ordered important supplies on-line instead of going to a store."

and "Have mail deliveries stopped ... I haven't had mail since Monday. I understand that things are difficult for these guys ...I just wondered? Thx for all you're doing.'

On This Day In Yonkers History...



Rev. Dr. Martin Luther King Jr. visited Yonkers in 1965

Monday, May 25th

May 25, 1923: Yonkers first responders rush to the Yonkers city line to rescue passengers and crew from a Putnam Division Line train wreck. The train had hit a heavy wooden plank placed across the tracks by a few pranksters. The "prank" cost the engineer his life, and injured eight passengers.

May 25, 1933: While defending Yonkers financial situation, Comptroller citizen via the United States Post Office. James Hushion informed the Democratic City Committee that our borrowing power of \$6 million was one of the best in our history. He said, "We are far from insolvent. We are just a little embarrassed." Hushion had obtained an extension to pay the \$500,000 in county taxes Yonkers owed, taxes we

May 25, 1945: William Beckman Jr., US Navy Electricians' Mate, Second Class, reported an amazing find somewhere on Luzon. The island, with an incredible amount of damage from bombing, was mostly in ruins. Beckman, who worked for Otis before enlisting, was astonished not only to find an Otis elevator in one of the damaged buildings, he found the elevator was in working condition!

Tuesday, May 26th

May 26, 1915: Mothers attending the School One Field Day decided to join in the fun; they ran a Mothers' Race as one of the events. Harriet (Mrs. Henri) Morand of Tuckahoe Road came in first!

May 26, 1931: Assistant Public Works Commissioner John Coyne received a letter from Captain John Clark of the US Volunteer Life-Saving Corps, commending the assistance he gave rescuing Anthony Fusco at the

"This effort is one of the finest we have on record," wrote and Captain Clark, "and I am sure all members of the Yonkers Station of the Corps join with me in congratulating you."

Wednesday, May 27th

May 27, 1947: Mrs. Alexander Rosenberg, wife of the spiritual leader of Congregation Ohab Zedek, told how there is no such thing as a normal work week for relief workers helping displaced persons in Germany, or their families. She told how her home had become a "hotel for transient displaced persons," including her own sister-in-law, who had been a prisoner in one of the DP camps

May 27, 1949: Joseph McCann, Secretary-Director of the Yonkers Municipal Housing Authority, responded to a state order for all municipal housing authorities to check the incomes of housing project tenants who owned television sets. He reported there were three "video sets" in Cottage Place Gardens, a state subsidized project; all TV owners were within the income limits for residency. They were more than 25 sets in Mulford Gardens, he said, but, as it was federally subsidized, it was not regulated by the State Division of Housing. However, all TV owners were within the income limits

Thursday, May 28th

May 28, 1913: Yonkers contractors James Lynch, Thomas Larkin, Frank O'Rourke, Monny Bittner, and William Colquboun attended a hearing in Albany; the group addressed Governor Sulzer to express their opposition to the Workmen's Compensation Bill under consideration by the Legislature.

May 28, 1923: After receiving questions why the chimes of St. Andrew's Memorial Episcopal Church has not sounded in several days, Reverend Frances Brown explained it was because of illness in the neighborhood.

May 28, 1965: Dr. Martin Luther King, Jr., addressed the Negro American Labor Council at their fifth annual convention held at the Westchester Townhouse on Tuckahoe Road. The convention, whose theme was "economic freedom and security for the black and white poor," was attended by labor leaders from all over the country.

Friday, May 29th

May 29, 1937: Police Chief Edward Quirk announced Yonkers residents could wear shorts on our city streets anytime they wanted during Memorial Day Weekend or at any other time; the NY Court of Appeals had killed Ninth Ward Alderman William Slater's ordinance banning them.

May 29, 1942: The Yonkers Chapter of the American Red Cross received a gift from the British and American Ambulance Corps, an air raid patrol car. Presented by Marie Deems, President of the Corps, it was gratefully excepted by Justin McCarthy, Chairman of the Yonkers Chapter.

Saturday, May 30th

May 30, 1947: Sherwood Park's Lieutenant Colonel Walter Weitner and the 102nd Light Bombardment Squadron flew over Yonkers Memorial Dday Parade to pay tribute to Yonkers war dead. World War II hero Weitner dropped a wreath while flying; the wreath was placed at the World War Monument. Also in the formation flying from Mitchell Field were Yonkers residents Captain Roderick Reid and Lieutenant Walter Dwyer.

May 30, 1947: The Glenwood Memorial Committee— The American Legion's Glenwood Post and Holy Rosary Post of the Catholic War Veterans—unveiled and dedicated a memorial in Trevor Park to Glenwood area residents killed in the war. The observance started with a parade from Union Place to Trevor Park; the ceremony included a three-volley salute, Taps, Presentation of Colors by both posts, and a keynote speech from Master Sergeant Hulon Whittington, Congressional Medal of Honor recipient. After the dedication, The Glenwood Post played the Hollow Athletic Club in a spirited baseball game. Sunday, May 31st

May 31, 1939: Harley Kenney of Ashburton Avenue, Richard Campion of Palisade Avenue and Joseph Conley of Orchard Street were presented Boy Scout Gold Life-Saving Medals for their assistance in rescuing the crew and passengers from the QED, a yacht that burned and was destroyed in the Hudson off the coast of Yonkers. These medals were the first Boy Scout Llife-

Saving Medals ever presented in Yonkers.
May 31, 1942: Fire Chief Edward Siller issued a strong warning to Yonkers residents who were "hoarding gasoline and endangering their own lives and the lives of their neighbors." He promised severe punishment for anyone

Real Estate Market-Continued from pg 4-property which is still a good thing. Inventory remains low and we will see less bidding wars with prices leveling off. I don't think we will have a major downturn as we did in 08' unless we see an increase in unemployment. If the stay-at-home order is extended, then prices could start to decline. Interest rates are low, so now is a good time to buy.

Commercial Real Estate Appraiser, Kathleen Carroll, Queens, NY. "I am finding it very difficult to ascertain specific market trends during the coronavirus period. There is some activity, but these are for properties that were already in contract just prior to the pandemic lockdown and are not new transactions. In my recent experience, it seems that everything is "on hold" and that current market activity is basically nonexistent. I believe the true market effects of the pandemic will not be evident in closed sales/ pending transactions for at least six months from now.

Anthony Sarro. My personal research indicates that pandemics tend to pause the housing market. Although there are few pandemics from which to

gather data from, this trend is historically consistent.

Real estate website traffic has decreased 40%-70%, homeowners who were considering listing their houses have decided to wait until after the smoke clears, and the few houses which are still on the market have been relegated to virtual tours with no virtual buyers. If there are no consequent closed sales, there is no statistical data, and or for those readers in or outside of the industry, no "Comps" available to determine a home's current market value.

If and when the world and economy reopen, the typical cycle will begin again and housing prices may just pick up where they left off at pre-corona levels. Due to government intervention with mortgage holders and mortgage servicing companies as well as a relatively strong stock market, I don't believe that this will be the 2008 housing market all over again. However, the future remains unknown, as the "Beast" has a mind of its own.

So right now, the battle is between House Speaker Nancy Pelosi, US Senate Minority Leader Chuck Schumer from NY, vs. McConnell and

If Trump and McConnell win, then Yonkers will likely have an additional \$10 Million hole in its budget. At least \$10 Million, or up to \$40 Million depending on how deep Cuomo will have to cut State Aid to Yonkers, which comes in two forms; Aid to Municipalities, AIM, is \$108 Million per year to Yonkers, and State Education Aid is more than \$200 Million. A 10% cut to both leave a \$30 Million hole in the Yonkers budget.

That is ontop of the budget hole that already exists in the Yonkers Public Schools budget. Mayor Spano's budget plan, and the YPS budget, with increases for salaries and benefits, leaves YPS \$22 Million short.

The Yonkers Federation of Teachers, YFT, has a contractural salary incrase of \$21 Million due this year. YPS Superintendent Dr. Edwin Quezada, speaking to the City Council at recent budget hearing, said that he would be able to close his budget hole if the teachers delayed their salary increase and the City bonded the purchase of new books.

But the YFT hasn't agreed to anything, nor has any Yonkers union. All of them want to wait to see what comes back from Washington.

One City Hall official quitely suggested a two week furlough for every Yonkers employee, which could raise close to \$40 Million. While municipal governments across the country are moving forward with furloughs, it hasn't happened in Yonkers in this reporters 20 years covering City Hall.

Some believe that it is the fairest way to spread out the budget pain, without layoffs, and employees losing their jobs. When layoffs do occur, it is the employee last hired that is first laid off.

The City Council has held two public hearings on Mayor Spano's proposed budget. But this year's budget public hearings were much diffeent that in year's past. Due to the Coronavirus, there were no speakers, and the council met through video which was available to the public, and the council answered questions which were emailed to them.

Most of the budget questions focused on Library funding. Mayor Spano has proposed a status quo budget for the library, but the emails supported expanded programs, and attempted to protect library funding if the budget

axe falls later this month or next. Councilmembers are considering voting on Mayor Spano's budget, despite all of the questions about Federal and State Aid. The budget includes a tax increase of 2.7% and if approved, the Mayor and Council would have to come back this summer and pass an amended spending plan if the money

doesn't come from Albany or DC. But four votes are needed to pass a budget on the council, and it is unclear if there are four votes in favor. Finance Commission Liszewski wants to have tax bills mailed out next month and the only way to do that is with an adopted budget.

In prior campaigns for Yonkers City Court, candidates openly and honestly ran for Judge without regard to political party. Candidates also sought the endorsement from both the democratic and republican parties, in an attempt to take politics out of a judicial race.

"I called Dan Romano and asked him to talk to Zehy and find our why he is doing this? Now that Zehy is a democrat, he wants to take over the party?," said Muro who has 48 district leaders in her 5th Ward.

Meier also made the distinction between Yonkers democrats who have served for years, and helped and supported other Yonkers democrats on the ballot, and those who have just joined the party and now want to run

"Dan Romano is a nice guy, but he hasn't been involved in the democratic party. Karen Best has also now run for judge twice but has not been involved in the democratic party.

"Verris Shako has been involved, as a district leader, and in helping other democratic candidates get elected, and she is one of our three en-

dorsed democrats for City Judge.

"Zehy Jereis has also not been involved in the democratic paty, he was involved in the republican party and now all of a sudden he is a democrat. I think we all should remember the golden rule of politics. Don't throw stone from glass houses. He (Jereis) had told me repeatedly that he is not going after me for leader, but he is slowly accumulating district leaders for

"But whoever is crafting this negative message, if they are going to start throwing mud, I'll stand on my record as democratic chairman, and stand behind the choice of Yonkers democrats at our convention, for Judge Daly, Judge McGrath and Verris Shako," said Meier.

Romano has claimed at campaign events that Jereis is not his campaign manager, but regardless of title, many democrats wanted to set the record straight, and do not want to see this type of negative, and vindictive type of campaigning, during the pandemic and for a judicial race.
