## Metered Parking Relaxed



Yonkers parking restrictions at meters will now be enforced between the hours of 10am-6pm, and alternative side of the street parking regulations will remain suspended. The changes were made as part of a compromise between Mayor Mike Spano and members of the Yonkers City Council.

Some members of the City Council, and the public, wanted the city to completely stop enforcing metered parking. But the reality of doing that, which would have added to the City's financials woes (a \$13 million loss).

## Made in Yonkers Hand Sanitizer

## **Distillery Makes Donations** to Seniors and to Public for sale

Last month, we reported on the Nahmias Distillery in Yonkers, and how they were undergoing a transformation from making alcohol to making hand sanitizer. The change in production is now completed and owners David and Dorit Nahmias are selling hand sanitizer and, with support by Yonkers businessman Sid Blauner, bottles will be donated to local nursing homes and to volunteers. Former City Council President Chuck Lesnick invested in the distillery through the Federal Opportunity Zone Program.

The first bottles of hand sanitizer, which come in 16 oz, and a gallon bottles-128 oz., are made pursuant to the World Health Organization standards, and are 80 per cent ethanol. Instead of having to layoff their employees, the Nahmias family and their employees are now working on brewing

up hand sanitizer.

They now can be purchased at Stew Leonard's, or you can visit Nahmias et Fils products web site at www.NahmiasEtFils.com, or by calling (646) 644-42.. Products can be shipped, or pickup at the Distillery can be arranged. Both bottles are reasonably priced, 16 oz for \$12.00 and one gallon for \$60—for 128 oz. The distillery is located at 1900 Saw Mill River Road in Yonkers, but call first before your arrival.

## Hanes Donates 300,000 Masks-PPE to Westchester

Hanes Brands, the makers of men's underwear for generations, joined the fight against the Coronavirus by switching their manufacturing to making masks and other PPE's. Recently, Haynes gave Westchester County 300,000 masks and PPE's, with County Executive George Latimer and County Legislators traveling across the county to hand them out.

"We are proud to be here to drop off these cloth masks thanks to the generosity of Hanes and efforts of New York State. We are happy to be in different parts of the County, with our masks on, to deliver these for com-

munities to use as needed.," said Latimer.

"This generous donation is being used to make us all a little bit safer. These deliveries are just one part of our strategy to reduce the spread here in Westchester. The masks were made possible by Hanes Brands Inc. and the work of the State of New York. All communities in Westchester will benefit from these donations. We are happy to be here to deliver in person and show the County is trying to be a good partner to our Towns, Villages

Latimer said every community will get a minimum of 3500-5000 masks with additional supplies going to larger communities like Yonkers, White Plains and Mount Vernon.

Hanes, one of the prime manufacturers of male underwear, offered to begin making PPE at the start of the crisis. The company donated 300,000 units to hard-hit Westchester trusting the county to distribute them to 43 different municipal jurisdictions.

The masks come in boxes of 3500 each, but once unpacked have a white cotton familiar look and feel. Most Westchester communities are giving out the masks to first responders, seniors, and employees who are

still at work during the Covid 19 emergency.

County Executive Latimer also accepted a donation of 30,000 masks and other PPE from the American Chines United Care Alliance, (ACUC). Latimer accepted the donation at the County Department of Emergency Services (DES) Building in Valhalla. The donation included masks, hand sanitizers and surgical gowns, from the ACUC and its membership donors. Donations are to be distributed to city organizations and hospitals that are

# When Will the Mall Open?

When will City Hall & City Council re-open?



American retailer Macy's announced that it will begin to re-open its stores across the country this week and will reopen all of its stores by the end of June. A similar announcement was made by mall operator Simon Proper-

ties, whose portfolio includes The Westchester in White Plains.

Due to the Coronavirus, the retail experience shoppers will find when Macy's opens in the Cross County Mall in Yonkers, or at the Jefferson Valley Mall in Yorktown, will be much different than before COVID-19.

All employees will be wearing the same, company issued mask. Trying on clothing will be extremely limited or stopped, and most of the retail sales portion of shocasing items behind the counter, like perfumes or jewelry, will now be done in a different way.

Macy's is expecting that only 20% of shoppers will return to its stores, and to the mall at first. Mall owners will try to enforce six feet apart social distancing, install a plastic barrier at its cash registers, and provide hand sanitizers throughout.

Access to and usage of the foodcourt and rest rooms will also include social distancing, and other parts of the old mall experience, like a kids play area and water fountains, will not return. Neither Macy's nor Simon Properties have decided whether shoppers will be required to wear a mask, but both did say that there decision to open in New York will be based on the guidelines and decisions of the Governor.

The question remains, can older retailers like Macy's survive COVID-19 when prior to the pandemic, there sales were already sinking? And will shoppers in Westchester return to their prior shopping habits, or even return to

their local mall for some window shopping?

Another question not unique to Yonkers, is when should your local government re-open their City Hall? Members of the City Council recently debated whether they should hold their budget hearing and meeting back in the council chambers, or continue to hold them online.

Yonkers Rising recently received the following letter to the editor concerning this topic.

Dear Mr. Murphy, The Hyatt Community Association has served the citizens and taxpayers of the southeast quadrant of Yonkers since 1988. Please accept the following comments.

While important decisions still have to be made in Yonkers during the social distancing phase of our National Recovery, I feel that many will be disenfranchised by the requirement that meetings be entirely virtual. The Yonkers Budget for 2021 is shaping up to be very painful for the City taxpayers and employees alike. Many seniors on fixed incomes, after surviving the pandemic, will now have to figure out how to pay anticipated higher taxes to fill gaping holes in the budget. They are the ones least likely to simply "log in" to virtual meetings and negotiate their way through the comment process.---continued on pg 7--

## **Child Care Council Receives First-**Responders Essential Workers Grant

The Child Care Council of Westchester (CCCW) has announced the creation of the CCCW First Responders and Essential Workers Child Care Scholarship Fund for Westchester first responders and essential workers who are working during this pandemic and need help paying for child care. "Westchester's first responders and essential workers shouldn't be over-burdened by child care costs as they work to serve and protect others during this emergency," said Kathy Halas, Executive Director of the Child Care Council of Westchester."

To be eligible for the CCCW First Responders and Essential Workers Scholarship, a parent must reside in Westchester County, be a first responder/essential employee working outside the home, and have a gross household income below 85% of NYS State Median Income (\$55,453 for a family of two, \$68,501 for a family of three, \$81,549 for a family of four, \$94,597 for a family of five, and \$107,645 for a family of six).

Applications are being accepted now and most are reviewed within three days. For those who are approved, payments up to the NYS Market Rates for Westchester will be made directly to child care providers, typically within a week of submitting the paperwork. The scholarship is renewable on a week-to-week basis based on availability of funds and other criteria. Every day the number of deaths at Nursing homes from the Coronavirus changes. On Tuesday it went up another 1700.

It was announced that Westchester County will be testing all nursing home patients for Covid 19. Smart move County Executive George Latimer. We are not using this facility so let's keep our older population healthy and isolated from those who are ill or have the virus in nursing homes.

Earlier this week it was announced that the daily number of deaths in the county Coronavirus related had dropped down to 20. Since the outbreak started over 1000 people have died in 2 months. # Westchester to receive \$1 Million in Nourish New York Food initiative

The New York State Department of Agriculture and Markets and Department of Health provided additional details on the distribution of the \$25 million Nourish New York initiative, as announced yesterday by Governor Cuomo.

Funding will be allocated regionally and based on need, from the State's special public health emergency fund, for food banks and emergency food providers across the state. The Nourish New York initiative, launched by the Governor on Monday, is working to quickly reroute New York's surplus agricultural products to the populations who need them most through New York's network of food banks. Instead of having upstate dairy farmers dumping their milk, which is usually sold and used in schools, the dairy products will be sent to food banks across the state.

Westchester will receive \$985,605. State Agriculture Commissioner Richard A. Ball said, "Nourish New York will be a lifeline for our families and our farmers who have been struggling with changes brought on by CO-VID-19. The agricultural industry has continued to give back to New York communities during this time; however, they have seen devastating losses financially as a result of lost markets, such as schools and restaurants. I am grateful to the Governor and to the entire Nourish New York team for launching this critical program that will help people who are food insecure to access the nourishment that they need while providing much-needed relief for our farmers."

Through Nourish New York, the State is providing funding to New York food banks so they can purchase excess products, such as fruits and vegetables, from New York farmers and surplus dairy products from New York dairy manufacturers, to distribute directly to communities. Food banks are expected to receive funding and begin purchasing this week.

Emergency food providers can spend the money allocated to them by doing any of the following: Setting up food-drive through events/give-aways (guidance available here); Distributing dairy vouchers that can be redeemed in grocery stores for products like cheese, yogurt, milk, sour cream, and butter, throughout the state, and/or; Purchasing products directly from New York dairy/food manufacturers for their feeding programs.

The majority of the funding will be used to purchase dairy products. Food banks and other emergency food providers will work with New York's dairy processing partners—Cabot Cheese, Chobani, Dairy Farmers of America, HP Hood, Upstate Niagara Cooperative Inc., and others—to purchase pre-packaged, consumer-ready products, such as milk, cheese, yogurt, sour cream, and cream cheese. The dairy cooperatives will use excess New York State milk to produce these products and are prepared to increase production to meet the rising demand.

## County Clerk's Office Keeps Real **Estate Records Moving**

The Westchester County Clerk's award winning Property records Electronic Portal (PREP) continues to pay huge dividends to the real estate community and county taxpayers during the current Covid-19 pandemic. The system, initiated in 2013 to get fanfare and heightened expectations allows those looking to record vital real estate documents in digitized for, reducing work load, expenses and the common errors the old paper system produced and led to months' long delays. Today the system can a record a document in in less than thirty minutes.

County Clerk Timothy Idoni, who led the efforts to gain state legislation allowing for this system, said, "PREP has led to a much cleaner system of recordation in this vital section of our economy. Hundreds of millions of dollars in real estate transactions, fees and taxes, are processed in record time. And during this pandemic, there's very few reasons to have to come to the office to deliver papers, reducing liabilities for the property owners and

One of the true advantages to the system is the Clerk's staff can identify problems with a submission as soon as it is received and sent back to the submitter electronically, saving time and postage fees for both parties. PREP is not a mandatory system. Those looking to record in paper may continue to do so but submitters still have to put basic information into the system prior to mailing or delivering the documents to the County Clerk's Office. The PREP system will calculate all fees and taxes required in the transaction, allowing for a smother sail through the mandatory review process in the Clerk's office. Idoni was quick to point out that seventy-six percent (76%) of all recorded documents are done so completely through the

The Clerk's office continues to work through the pandemic, with the first concern being for the safety of the staff and public, a majority of the staff is

working remotely from home. SINCE NOT

All work can be completed remotely, a skeleton crew does go to the office to handle the paper submissions received through the mail. But work has

been completed with few delays.

## On This Day In Yonkers History...

Monday, May 11th

May 11, 1931: The Directors of the Hollywood Inn voted to dissolve the corporation; they said the jump in their taxes from \$1600-\$8000 was the major factor in the financial crisis the center faced. Started in 1896, the Inn was one of the leading facilities for young men in the country, and was responsible for the success of many of Yonkers sports stars.

May 11, 1941: The City of Yonkers Common Council unanimously adopted Councilman Dennis Cooper's resolution authorizing two week vacations with pay for all sanitation workers on the payroll for one year or more.

Tuesday, May 12th

May 12, 1923: A jammed steam whistle of the National Sugar Refining Company rudely awakened residents of South Yonkers and beyond. The shrill noise continued for several hours until management managed to find an employee that knew

May 12, 1926: After reading in New York papers that Public Safety Commissioner William Van Keuren claimed his resignation was at "his own volition, without any threat or intimidation that he should resign." Mayer William Walsh was irritated. Walsh told the Herald Statesman he sent Special Deputy Louis Van Dyk to give the Commissioner the message to "resign or be fired." Apparently Van Keuren offended the mayor and others when he "promised to make men" of the Yonkers police when hired the previous December.

May 12, 1929: The accurate marksmanship of Yonkers's Motorcycle Patrolman John Yascovic was credited for his saving the life of a six-year-old! The young boy had been attacked and severely bitten by an enraged bulldog.

Wednesday, May 13th

May 13, 1923: A new brewing company, Flynn and Montalto, leased the building at 251 Hawthorne Ave. Yonkers residents Joseph Montalvo and Charles Flynn owned the company, and planned to hire seventy-five workers when production

May 13, 1943: After learning from Price Administrator Prentiss Brown that gas supplies in the Eastern states had hit an all time low, Yonkers police were put on the alert to look for violators of the pleasure driving ban. Most gas stations were out of gas, but those that had a few gallons left were instructed to only sell them for essential driving.

Thursday, May 14th

May 14, 1856: A very strange fish was caught in the Hudson River off the coast of Yonkers. Four feet long from nose to the tip of its tail, its body shape resembled a toad fish. Its mouth was filled with teeth and was extremely large. When the creature was dissected, they found five full-grown shed, some hardshell crabs and a moderate size terrier. It had two hands, each with four fingers and a thumb, and fins. Some claimed it was a lophus, a creature described by Dr. DeKay, author of The Natural History of New York, and not uncommon to the waters around New York City.

May 14, 1926: The membership of the Lincoln Heights Iimprovement Association urged a park be built in their community and named after Lewis Sayre Conor, a Yonkers man killed during World War I. Conor had lived at 54 Hancock

May 14, 1928: Saint Casimir's Church was formally dedicated by the hierarchy of the New York Archdiocese, including Patrick Cardinal Hayes, before a stand-

Dworzak.

Friday, May 15th May 15, 1940: The first day of the auction of artifacts from the collection of the late Samuel and Minnie Untermyer began at 2 PM at Greystone. French and English furniture, tapestries, oriental rugs, Chinese porcelain and jade, Indian miniatures, silver, China and other property were sold. The sale continued for three days.

ing room only crowd. All present paid tribute to the pastor, Reverend Joseph

May 15, 1942: The Herald Statesman presented Betty and Betty Fox and their sensational Dance of Death... on top of the Herald Statesman building! The couple performed 180 feet in the air on an 18 inch stage, using no railings or any type of safety equipment. Dances performed during the four shows included the waltz, foxtrot, Big Apple, rumba, tango, adagio and the "latest dance craze," the jitterbug. Ads for the event publicized the couple as "acclaimed by millions as the most Death Defying act ever preSented anywhere."

Saturday, May 16th

May 16, 1942: The Common Council gave permission to the US Shipbuilding Corporation of Brooklyn to use ten acres of city-owned land to construct buildings for a shipyard. The firm had a contract to build all-welded vessels for the war effort, and expected to hire at least 300 Yonkers workers.

May 16, 1945: Nineteen-year-old Albert Curcio of Glover Avenue was seriously wounded in Germany when he literally caught a Nazi grenade to prevent it from injuring his fellow servicemen. The device exploded, blowing off both his hands. He received a Purple Heart Medal and the Presidential Unit Citation with an Oak Leaf cluster. He also wore the Good Conduct Medal and three battle stars for action at Leipzig, the Rhine and the Ruhr. Before enlisting, he was a ship fitter for the Consolidated Shipbuilding Company of New York.

Sunday, May 17th

May 17, 1653: Adriaen Van der Do Adriaen Van der Donk nk copyrighted "A Description of the New Netherlands," the first book published by a resident of what now is New York State.

May 17, 1931: The Putnam Division of the New York Central Railroad moved into its new station in the First National Bank Building. While its new home was under construction, it had a temporary station at 116 New Main Street. The brand new terminal was in exactly the same location as when the Putnam division first

began, December 1888. May 17, 1941: Striking simultaneously in several areas of Yonkers, police and Immigration Inspectors search for more than 1000 Yonkers residents as part of a nationwide drive to round up aliens here illegally in our country. Of the more than 1000 people questioned, only FOUR WERE ARRESTED.

The Zoning Board of Appeals have doubled up their meeting schedules in May to handle a backlog of cases. Those meetings will be virtual as well. The instructions on the ZBA meeting notices simply say "Please check the website www.Yonkersny.gov the day of the meeting for log-in and additional information. This requirement will not increase the likelihood of citizen participation when it is most important. At the ZBA many cases have already been heard and have been on the roster for some time. Many have not been adequately vetted. There should be a moratorium on decisions in recently introduced cases until the public can have a real chance to weigh

As far as the Yonkers Budget Hearings go, even if they were held outdoors at say, Fleming Field, this budget has the potential to drag out many hundreds of Citizens and commenters who would be hard pressed even there, to maintain social distancing.

The stakes are too high at this time to rely on comments on from a tech savvy few on issues that are bound to lead Yonkers down a dark path. We should all try to be inventive at this critical time to give all of our people an opportunity to be heard

As part of the CCCW Scholarship application process, parents will also be required to apply for a subsidy through the Westchester Department of Social Services (DSS). For those approved, the CCCW Scholarship could help pay for care until those funds come through. The subsidy would then replace the scholarship, subject to ongoing eligibility.

In addition to its own scholarship, the Child Care Council will administer the New York State CARES scholarships announced by Governor Cuomo on April 23rd, for first responders and essential workers whose income is less than 300 percent of the federal poverty level. These scholarships are currently available through May 15th. CARES funding will also be used to purchase supplies for child care businesses statewide, including masks, gloves, diapers, baby wipes, baby formula and food. Information will be posted on www.childcarewestchester.org as it becomes available.

Any Westchester parent who needs help finding or paying for child care during the Covid-19 pandemic is encouraged to call the Child Care Council and speak to a child care specialist. And the remaining merchants who are open for business want their customers to park and then leave every half hour, so that the next customer can

The compromise solution has meters in enforcement from 10am-6pm. "We continue to adjust to the effects of COVID-19, which includes addressing the possible hardships parking meters may impose," said Mayor Spano. "Shortening the hours of the street meters is a way to provide some relief to our residents without compromising local businesses. As always, I encourage residents who need to park for extended hours to please use the garages or

The City Council recently voted 5-2, to call on the City of Yonkers to suspend parking meters. In efforts to help residents who are staying home during this crisis that live in areas with parking meters, the Majority Caucus has voted in favor of urging the City of Yonkers to suspend parking meters. Reducing the parking meter hours has become a compromise to make sure that businesses and residents are taken care of.

"I want to thank Mayor Mike Spano for making strides to accommodate the community on this citywide issue. We may not have gotten parking meters suspended completely, but I worked tirelessly to come to a compromise to make sure that the residents get some form of relief. If PAUSE is extended beyond May 15th, I am confident that this new meter regulation will abide accordingly. I also want to thank the City Council for showing support and allowing me to take the lead on this." said Councilwoman Tasha Diaz.

Assemblyman Nader Sayegh, who continuously advocated for the sus-
