

50a Repealed Is Defunding Police Next?

The New York State legislature passed, and Governor Andrew Cuomo signed into law, the repeal of 50a of the Civil Rights Law, which had provided additional protections to the personnel records of police officers, firefighters, and correction officers. This protection had been interpreted to include disciplinary records of law enforcement officers. This repeal would subject these records to FOIL, just as all other records kept by public agencies, while protecting the sensitive personal contact and health information of these officers.

In the peaceful protests across Westchester County since the killing of George Floyd, the call to repeal 50a protections had been made by many

protestors and elected officials. Last week it happened.

State Senate Majority Leader Andrea Stewart-Cousins said, "The murder of George Floyd shined a light--yet again--on the injustice that pervades our justice. system and the structural racism that has cut countless black lives short in our nation. This latest, horrific example of police brutality unleashed a torrent of grief and outrage across. America - from Minneapolis to our very own communities here in Westchester.

"It is a time for momentous change and civic participation. It is also a time for those of us in positions of power to act. Change is necessary, and

"In recent days, I was happy to stand and address hundreds of my constituents at rallies and vigils in Dobbs Ferry, Yonkers, New Rochelle, Hastings and Elmsford—and others—who want real change that has so far been denied even after the killings of Breonna Taylor, Ahmaud Arbery, Sean Reed, Tony McDade, and so many others.





Croton Gorge Park Closed Latimer Gives COVID Update



County Executive George Latimer announced last week that Croton Gorge Park will be closed on weekends up to and inlcuding the upcoming 4th of July weekend. Latimer cited an inability to control visitors at the park on the weekends, and that overflow of visitors, combined with the continued concerns over the coronavirus, made closing the park for the next three weeks the correct decision.

"We are closing Croton Gorge Park again. We must have the ability to manage the demand, and the volume at this park on the weekends have been difficult to manage. The park will remain open during the week," said Latimer, who also cited parking limitations at the park, which includes some of the most stunning views of a waterflow from the Croton Reservoir, pictured above.

Latimer made the announcement while visiting Peekskill, where, together with Mayor Andre Rainey, handed out masks for residents and Census forms. The County Executive also provided a COVID-19 update.

"More than 200,000 Westchester residents have been tested, that is 20% of the county population," said Latimer, who added that 17% of the Westchester population that has been tested, tested positive. That number is down from 34% more than a month ago. On the day of his visit to Peekskill, Latimer said that two Westchester residents died of the Coronavirus, brining the total of county residents who have died to 1,402.

After COVID, "Business as Usual" Will be Impossible

The coronavirus pandemic has triggered massive changes in consumer home fitness gear is flying off the virtual shelves. And e-commerce platforms of all types are recording unprecedented traffic. Online sales jumped about 50 percent in April following the beginning of shelter-in-place orders.

In an attempt to return to normalcy, several states across the nation are lifting shelter-in-place orders and removing social distancing requirements. But things won't ever be the same. The pandemic has profoundly altered the way we do business, and some of these behavioral changes are permanent. If businesses don't prepare for this new digital reality, they won't survive the pandemic or its aftermath.

At this point, off duty Pleasantville police officer Aaron Hess stepped in

front of Henry's vehicle, after which the details of the events that evening become confused and with conflicting versions of what happened. Hess ended up on top of the hood of Henry's vehicle, where he fired four gunshots into the windshield, striking Henry and a friend of his.

Henry was removed from the car, handcuffed and left for dead as police officers attended to officer Hess. Henry's friend, Brandon Cox, who was in the car and was also grazed with a bullet, asked the officers to help his friend.

Two Pleasantville police officers fired at Henry's car; Hess and Police Officer Ronald Beckley. But two years later, Beckley testified that he fired

his gun at Hess, not realizing that he was a police officer but because he thought that Hess was the "aggressor" in the incident.

Beckley's testimony, two years later, was different to what Mt. Pleasant Police Chief Louis Algano said happened, which was that Henry drove agreed to the said and policy regulting in numerous shots fired into gressively toward Hess and Beckley, resulting in numerous shots fired into

DJ's mother, Angella Henry, said that Beckley was the officer who told the truth. "It's a shame that Ronald Beckley, the officer who told the truth about DJ's killing, was denied pension, but Hess received his. What kind of system punishes an officer for doing what's right? These are all changes that need to be made," Angella Henry said.

"We'd welcome a reexamination into our son's case. All of the evidence is there, we just need someone with the courage to convict all those in-

Angella Henry sees a connection between her son's death ten years ago and the recent death of George Floyd. "Our son was killed by a white officer, handcuffed and left on the street to die," Angella Henry told The Enterprise, a newspaper in the Massachusetts town of Easton, where the Henry's are from. "People asked the officers to intervene, but they didn't — the same

"We relive the horrific images of our son's last moments — of him dying on the ground without help," she said. "These will never go away but are always brought to the forefront when one of these cases, and there are many,

In 2016, Henry's parents reached a \$6 million settlement with the village of Pleasantville and Hess, to resolve a civil wrongful death lawsuit the family brought against the municipality. The Town of Mt. Pleasant also made a public apology to the Henry family.

Hess' attorney, Brian S. Sokoloff, said that his client "was thrown onto the hood of a speeding car by an intoxicated driver." Hess was cleared of any criminal wrongdoing by a grand jury, and in 2015, then US Attorney

Preet Bharara said that there was not enough evidence to indict officer Hess. The attorney for the Henry family was Michael Sussman, known for his portrayal in the HBO Miniseries "Show Me a Hero." During the Civil Suit, Sussman presented evidence which included a video camera from outside the bar showing Henry's car with its break lights on and traveling at 14 miles per hour. And friends of DJ Henry said that he was not drinking at all.

DJ's sister Amber Henry wants the case re-opened, Tweeting, "The shooting death of my brother DJ Henry in Pleasantville N.Y by officer Aaron Hess should be reopened, investigated and prosecuted. He was MUR-DERED, plain and simple. The town and the police tried in vain to cover it up. Justice. NOW."

Citing a recent New York State report that details a very troubling 33% rise in domestic violence cases across New York amid COVID, U.S. Senator Charles Schumer demanded the United States Senate take up the Violence Against Women Act (VAWA), which passed the House with bipartisan support all the way back in April of 2019. Schumer demanded Leader McConnell take VAWA 'off the shelf' and rightfully pass it in the Senate. Schumer said that New York is not alone in worrisome statistics, either. Other states, like Texas and Illinois, according to the New York Times, have seen similar domestic violence surges and capital resources for many programs could dry

"The data from New York's report mirrors similar statistics across other parts of the country that are also seeing a rise in domestic violence amid the coronavirus pandemic. It's up to all of us to heed the warning in these numbers and not allow a pandemic to fuel an epidemic of domestic violence so many have devoted their lives to preventing," said U.S. Senator Charles Schumer. "Since I first helped write the Violence Against Women Act in 1994, countless individuals have been saved. Whether the funds provided were for local shelters, counseling or other critical efforts, the law has given so many a second chance and we cannot rest until the Senate acts, the law is fully reauthorized and the help New York and other states need is on the

According to New York's domestic violence task force, "...in the first few months of the COVID-19 pandemic, data reported by law enforcement and domestic violence service providers pointed to an increase in domestic violence, with the New York State Domestic & Sexual Violence Hotline recording a 33 percent increase in calls for April 2020 compared to April 2019, and shelter occupancy rates upstate rising to 78 percent in April 2020, versus 59 percent in April 2019.

"Right now, because of the uncertainty around the Violence Against Women Act's future reauthorization we have states preparing to turn over the couch cushions for this life-saving funding, and that cannot sustain," Schumer added. "Philanthropy is certainly one way to "fill in the gaps" but existing federal funding cannot be allowed to simply "fall short." That's why we need the Senate to act here, because government has a job to do and lives to save."

The original 1994 VAWA bill, which was authored by Schumer when he was a member of the House, has been reauthorized three times—in 2000, 2005 and 2013—with unanimous Senate approval the first two times. Since its enactment, the bill has reduced domestic violence by more than 50 percent. Additionally, the legislation, over the course of its history, has provided more than \$7 billion in federal funding towards reducing these types

COVID-19 in the nation for its incoming first-year students. The twocredit course is free of charge and brings together faculty from across campus to explore the pandemic and its effect on our lives through the lens of sports, arts, science and other fields and how the continued fallout may alter our communities well into the future. Classes begin in July.



warranted, prosecute any incident of a person whose death was caused by

a police officer or peace officer.

"This is not a bill that is aimed against the police, it is a bill that increases transparency with the goal to improve community and police relations, and help regain trust in police," said Senator Jamaal Bailey, Senate lead sponsor of the bill to repeal 50-a. "I would like to thank the families of victims, the advocates, and my colleagues in government for consistently and tirelessly advocating for this reform. Change is coming in New York, and I am proud that it is under the leadership of Majority Leader Andrea Stewart Cousins and Assembly Speaker Carl Heastie." Sen. Bailey, represents Mt. Vernon and the Bronx in the 36th District.

Senate Bill S.3253B: This legislation, sponsored by Senator Kevin Parker, will clarify that a person not under arrest or in the custody has the right to record police activity and to maintain custody and control of that recording, and of any property or instruments used to record police activi-

Senate Bill S.6670B: This legislation, the "Eric Garner Anti-Chokehold Act," sponsored by Senator Brian Benjamin, will prohibit the use of chokeholds by law enforcement and establish the crime of aggravated strangulation as a Class-C felony.

Senate Bill S.8493: This legislation, the New York State Police Body-Worn Cameras Program, sponsored by Senator Kevin Parker, will direct the Division of State Police to provide all State police officers with bodyworn cameras that are to be used any time an officer conducts a patrol and prescribes mandated situations when the camera is to be turned on and recording

Senate Bill S.2575B: This legislation, sponsored by Senator Jamaal Bailey, will require state and local law enforcement officers, as well as peace officers, to report, within six hours, when they discharge their weapon where a person could have been struck, whether they were on or

"The repeal of New York state's infamous police secrecy law 50-a, is an important step towards ending an era of special rights for police and the ability of police departments to hide patterns of brutality, sexual violence and other police abuses," said Communities United for Police Reform (CPR) spokesperson Carolyn Martinez-Class. "The public will no longer be blocked from seeing how prevalent police violence is, and what is or is not done in those cases.

In spite of what police unions and police departments have falsely claimed for years, the goal of repealing 50-a has never been to make addresses or phone numbers of police publicly available through release of police misconduct and discipline records.

In fact, separate from the 50-a statute, FOIL already provides police departments with the option of redacting that information, separate from the 50-a statute -- and police departments routinely redact this info in their responses to records requests.

#Repeal50a bill changes this to require law enforcement redact this personal privacy information for survivors, complainants, witnesses and family members of those who have been killed or brutalized.

"We think of Eric Garner today, as we celebrate the passage of the repeal of 50-a. We know that the full repeal of 50-a will expose the Daniel Pantaleos of the NYPD," said Adilka Pimentel, Lead Organizer at Make the Road New York. "This is a critical step toward making systems of policing more transparent and accountable to the communities they are supposed to serve."

"The obligation to admonish our brothers and sisters when they do wrong is sacred to our Jewish tradition. "Rebuke, yes, rebuke your brother lest you carry his sin." (Leviticus 19:17) The NYPD has shown itself incapable of admonition, discipline or correction when it comes to crimes committed by officers and bears responsibility for those crimes. The values of our democracy demand a transparent institution that can be held publicly accountable for its mistakes," said Leo Ferguson, Movement Building Organizer at Jews for Racial and Economic Justice.

'Sunlight is the best disinfectant, and we know that transparency is a critical first step in to change the way police interact with communities in New York,"said Tina Luongo, Attorney-in-Charge of the Criminal De-

fense Practice at The Legal Aid Society.

State Senator Shelley Mayer said during the debate, "I have decided Section 50-A of the Civil Rights Law, adopted over 40 years ago, can no longer be the standard for the release of disciplinary records of officers. Rather, law enforcement officers, like so many other public officials, must be accountable to the public in order for trust to be restored.

"In the military, there is an expectation that all officers are held "to a higher standard"; that they have an affirmative duty to speak up and stop unlawful behavior when they witness it, and that the disclosure of information about prior incidents is actually necessary to ensure fundamental trust in the military system of justice. We should take this comparison to heart as we move to change the laws that have contributed – unfortunately, but justifiably – to a fundamental distrust in our law enforcement system by black and brown Americans.

"This is a moment of a national reckoning – one that makes me optimistic and determined at the same time. Optimistic because Americans of all colors, faiths and ages are forcing us to look reality in the eye and acknowledge our system must change to confront and end racism in all its forms. Optimistic because young people are demanding us to act.

"Peaceful and loud demonstrations in the streets of my communities and yours – in New Rochelle, White Plains, Yonkers, Harrison, Mamaroneck, Bedford, Bronxville, Tuckahoe, Port Chester and elsewhere – are good. Demonstrations protected under the First Amendment; demonstrations in my communities protected by the police. However, they are not enough. They must lead to real reforms. We cannot wait for incremental change and continue to rely on the prior innocent hopes that simply the good officers would outweigh and over power the bad.

"These bills will not harm the tens of thousands of professional, compassionate and responsible officers I have supported, who have nothing to fear and with whom I will continue to stand. However, it will change the culture of secrecy, the patterns of illegality that have been allowed to fester and the legalized denial of accountability that have held us back for

too long," said Sen. Mayer.

'It is our strong hope that now that the veil that had shielded police misconduct from public view has been lifted, countless injustices, including wrongful convictions, can be prevented. This is only one ingredient of authentic accountability but it is the first, crucial step, in bringing some justice to a system that previously prevented it,"said Rebecca Brown, policy director for the Innocence Project.

"Repealing 50-a is a step in the right direction, but it is not mission accomplished. We've had to fight tooth and nail for half a decade to get here. Now, in addition to this hard won transparency, we must get justice for families who've been injured or lost loved ones, defund the police all over the state, and invest in real safety for our communities," said Monifa Bandele on behalf of Malcolm X Grassroots Movement and the Movement for Black Lives.

Mom's Demand Action on 'Gun Post'

A Facebook post last week by Yonkers small businessman and democratic political leader John Khader drew a harsh response from local gun safety ---organizations including Mom's Demand Action, and have now landed in the middle of the race for Yonkers City Court.

On June 2, John Khader posted a photo of a gun with bullets, and commented "unconfirmed reports of protestors/rioters in my hood ready for

One organization that spoke out against Khader's comments, was Mom's Demand Action, an organization founded after the Sandy Hook shootings working to pass stronger gun laws and work to close the loopholes that jeopardize the safety of our families. Their website also states, "We also work in our own communities and with business leaders to encourage a culture of responsible gun ownership."

Barry Graubart, a member of Mom's Demand Action in New York, responded to Khader's post, writing, "I was appalled to see this post on Facebook and Instagram today, threatening protesters with violence with what appears to be a short-barreled pistol-grip pump-action shotgun. These weapons are often referred to colloquially as a "zombie killer". "The photo was posted under the account "Johnny Limo", which belongs to John Khader, MPAC founder and owner of Top Class Limo in Yonkers. Gun violence may be a joke to John Khader, but to many of us in Westchester, it's a reality that has taken too many lives. And in the current environment, with people protesting for racial justice, with increasing domestic violence, gun violence is no laughing matter."

Graubart asked Westchester DA Anthony Scarpino to disavow Khader from his campaign and cancel a fundraiser scheduled with Khader. Scarpino issued a comment which read, "I became aware of a disturbing Facebook post by one of my supporters tonight. Upon learning about this post, I immediately cancelled an upcoming event that this individual had planned in support of my campaign. In no uncertain terms, I condemn this post and the message it sends, particularly in this painful time. I stand strongly in support of those protesting against systemic racism and police brutality and commit the full force of my office to fight for positive change on behalf of people of color in Westchester."

Shortly after Scarpino condemned the post, the same call was made to Yonkers City Court candidate Dan Romano to do the same. Romano, who is running in a Democratic Primary June 23, is seen photographed on Facebook with John Khader. Last week, Delfim Heusler, Editor of the online media site Yonkers Insider, posted information he found at the Board of Elections that Khader was paid \$2,500 from the Romano campaign.

Now, more than 10 days after the incident, and still no comment from

the Romano campaign.

Yonkers Democratic Chair Tom Meier, said, "We have a responsibility to be careful about what we post and what we say. I tell my friends and family that all the time. What you post online will be there forever. But it

doesn't make us bad people.

We spoke to John Khader, and reiterated what we now write in this story. He is a political figure in the City of Yonkers, not because of his family relations, but because of the fact that he founded a political organization, MPAC, the Mediterranean Political Action Committee, MPAC, which has given a voice to those who didn't have one. He is also active in Democratic politics not only in Yonkers but across Westchester. People will listen and take note of what he says, and posts.

John Khader said, "My post was in no way intended to promote violence. I overacted when I heard that there might be looting going close to my neighborhood. But I did it to protect myself and my family.

Catherine Schowalter, a member of Mom's Demand Action in Westchester, said that, "It was the wrong thing to post. The 2nd Amendment gives the right to have a licensed gun in your house, but it shouldn't be used as a threat to others."


