### Toys for Tots Westchester Needs Your Help ASAP!

Toys for Tots collects millions of toys every year to children who won't get another gift for the holidays.

Here in Westchester, Toys for Tots has been run for Steve and Kelly Turchinsky for many years. Every holiday season they lead the effort, collect the toys and gift cards and get them to those who need them.

This year, Westchester Toys for Tots has a problem. They are homeless and need a new home ASAP. "We are in dire need of a new warehouse space for Toys for Tots. Westy's withdrew use of their facilities as a warehouse & in doing so we have also lost 5 donation drop points all over Westchester. We are homeless with no location to sort & distribute toys from. Toys start getting shipped to us by November 1st. We are having to have supplies delivered to our home but last year we provided toys for over 21,000 children (50,000 toys!). You can imagine the amount of space required, at the very least 1000 + square feet of open space, enough for the toys, volunteers intake & outgoing items. With COVID we have to social distance as well.

We are looking for a donated space, we are a 501C3 charity which means it can be written off as a gift in kind. We are trying to stay on this

### **County Legislator Tubiolo Tests Positive for COVID-19**

The political arm-wing of Westchester County government was halted and thrown into serious concern after County Legislator David Tubiolo tested positive for COVID last week. Legislator Tubiolo, one of the BOL's youngest members, informed the County of his positive result on Thursday October 8.


"Since informing the Board of Legislators of my positive COVID-19 test result on Thursday morning, they have been working with the County Department of Health to trace and test all legislators and Board staff who had contact with me during the period of possible infection. We are pleased to report that all those tests have been negative for COVID-19," wrote Tubiolo in an email to his constituents.

"To date, all related tests conducted by the Department of Health on personnel – even those who had not been in direct, recent contact with me – have also been negative. We will continue to work closely with the County Health Department to pursue all additional necessary tracing, testing and isolation procedures, and I am working closely with the Health Department to trace my personal contacts as well.

"The novel coronavirus is still with us and we continue to take it seriously. We will continue to practice the precautions we put in place in March – including holding meetings with no in-person public participation, staggered in-office staffing, wearing masks and social distancing in the workplace – so that we can continue to protect the safety of the staff and the public. We will continue to use our video teleconferencing technology to do the work of the people of Westchester County," said Tubiolo, who learned

### **Absentee Ballots and the Election of 2020**

Westchester residents should prepare for, and get used to, the concept that we will not know who the President -elect will be on the evening of November 3. That is due to the millions of Americans who will cast their votes by absentee ballots because of the Coronavirus that is still spreading across the country and killing 700 every day.

In most US counties, including Westchester, the local Board of Elections will not begin counting ballots until the day after the election. Usually, there are a limited number of ballots to count, but with an astronomical number of additional ballots coming in through the mail and by hand, it could take weeks to count every ballot. Waiting a dozen or so days to see who our next President will be is the least of Americans troubles this election.

The Red Mirage: The political database company Hawkfish, now owned by Michael Bloomberg, issued a report last month which predicted, based on their data, that because more republicans will be voting in person and more democrats will be staying home and voting by mail, on election night, Trump could hold a large lead, but after more and more absentee ballots are counted Biden will take the lead.

Hawkfish CEO Josh Mendelsohn said, "We are sounding an alarm and saying that this is a very real possibility, that the data is going to show on election night an incredible victory for Donald Trump," he said. "When every legitimate vote is tallied and we get to that final day, which will be some day after Election Day, it will in fact show that what happened on election night was exactly that, a mirage," Mendelsohn said. "It looked like Donald Trump was in the lead and he fundamentally was not when every ballot gets counted."

But democrats and supporters of Biden need to beware of another fact. Many absentee ballots are not counted every election because of errors in filling out the ballot made by the voter. In New York State alone, more than 10,000 absentee ballots were tossed out this year for the June 23 primaries. Republicans and Trump supporters are hoping that hundreds of thousands of absentee ballots will be tossed out in the swing states of Pennsylvania, Wisconsin and Florida, and, as a result, hand the Presidency to Trump for four more years.

### Target to Build New Store in Yonkers



Good news for the Westchester economy and retail markets came when Target and H&M announced that they had signed new retail leases at the rebranded Cross County Center (formerly Cross County Shopping Center) in Yonkers. Target signed a 40-year retail lease to occupy over 130,000 square feet of retail space at what was once home to the most successful Sears store in the nation.

H&M signed a 10-year renewal to occupy 28,000 square feet where the retailer will incorporate its upscale SOHO concept. The news comes shortly after Marx Realty took over leasing and management of the historic shopping center earlier in the year. The firm has owned the center in partnership with Benenson Capital Partners for 65 years. Cross County is the nation's first open-air shopping center, which has benefited the center given its focus on health and wellness.

This latest leasing activity is the first step in a multi-phase plan for Cross County Center. Focused on expanding the center's uses, future phases will bring impactful changes to the iconic open-air center in the heart of West-chester county, just 12 miles from New York City. As retailers here continued to thrive after emerging from the pandemic, Marx Realty launches a forward-looking plan for growth, continuing to build on the heavy foot traffic from New York, New Jersey, and Connecticut as visitors increasingly flock to Yonkers for the Cross County Center experience with its many landscaped gardens and green open spaces.





### A Target Grows in Yonkers

When friends come to visit me in Yonkers, their first question usually is, 'Where is the Yonkers Target?' My answer embarrassingly has always been, 'Yonkers doesn't have a Target.' Their reaction is usually shock and bewilderment.

Well friends, that's all about to change. Thirty, yes thirty years after my first visit to Target in California, 'a Target Grows in Yonkers.' The old Wanamaker's and until late last year Sears store at Cross County Shopping Center in Yonkers will become the newest store in the Target chain.

The business side of why Target has decided to set up shop in the iconic Cross County Shopping Center, the first shopping center in the United States goes back to an old retail philosophy that still holds true today: Location, Location, Location! The mall is at the confluence of the New York State Thruway, Cross County Parkway, Bronx River Parkway, Sprain Parkway and close to the Saw Mill River Parkway.

Every day thousands if not tens of thousands of cars pass the mall, their owners heading north, south, East, and west. Most major bus lines in Westchester pass through or are easily connected to the mall. Parking is plentiful and no new roadways have to be completed to gain access to the mall. Who could ask for anything more!

I saw the lights on in the old Wanamaker/Sears building just last week, with workmen coming in and out of the store. I sensed something was going on. I passed by quickly but I think I saw an Asbestos Removal Notice. Asbestos was used as major insulator in buildings built through the early 1980's. It has since been found to be a cancer causing agent.

So what is a Target? Many of you have heard of it but have never actually been in one. Target is like the old store chain Caldor's many of you remember but on steroids. A high quality, trendy discount store with many individual departments in it. When you walk into the store, there is usually a Target Cafe and/or a Starbucks Cafe. Seating where you can relax before, during or after shopping.

The menus feature Starbucks drinks, pastries and snacks and Pizza Hut pizza with breadsticks and pasta. Hot dogs, chicken tenders, popcorn, fountain soda and slushy type drinks round out the menu. You won't find the 4 or 5 vegetable platter my mom use to love at Wanamaker's when the store had a restaurant on the top floor that you got to via elevator only, but plenty to eat!

One area of the store is always changing for the season. Right now it's chock full of things for Halloween, everything from candy to costumes to those gigantic blowups you have on your lawn. Christmas and Chanukah will hit next, of course with a touch of items for your Thanksgiving table. Valentine's Day, Easter and Passover along with every holiday will be featured in this area.

Seasonal also includes garden and barbecue items from chaise lounges to charcoal and paper goods to hold your hamburgers and clean up afterwords. *continued on pg 5-*

Guests will be provided with a radio station to tune into in their car for better sound. Different food trucks will be at each event. Visit crosscountycenter. com to purchase tickets.


### Bicycle Sundays to Continue Through October

Westchester's recreation tradition, Bicycle Sundays will continue for two more Sundays to end the extended 2020 season on October 18 and 25, 10 a.m. to 2 p.m. on the Bronx River Parkway. There is no Bicycle Sunday on October 11.

Westchester County Executive George Latimer said: "Bicycle Sundays have provided our community with a great physical outlet during a time where most activities have not been able to take place. I'm excited we were able to extend the program a few times this year to continue to provide this must-needed outlet to residents."

During Bicycle Sundays, a portion of the Bronx River Parkway is closed to cars from for the exclusive use of bicyclists, joggers, walkers, scooters and strollers. The course runs from the Westchester County Center in White Plains, south to Scarsdale Road in Yonkers, a round-trip of 13.1 miles. There are many points of entry and exit along the way. Parking is available at the County Center lot in White Plains for a fee of \$8. Participants are to wear masks or face coverings where social distancing cannot be maintained.

## Fair Campaign Committee Says Keegan's Actions "Unfair"

The Westchester Fair Campaign Practices Committee, the non-partisan npaign watchdog group founded by the League of Women Voters in 1991, issued a ruling this week which found Assemblyman Kevin Byrne's opponent engaged in unfair campaign practices. The Committee determined her actions were "unfair" in response to complaints from the incumbent's campaign. The Byrne campaign complained that candidate Stephanie Keegan shared and promoted an image on social media they claimed gave "a false and misleading impression the Assemblyman refused to condemn a racist attack" which occurred in Carmel earlier this year. They further complained that by promoting an image featuring Assemblyman Byrne next to an im-age of a truck with a "F\*\*\* Black Lives" sign affixed to it, again created "the false and misleading impression that the Assemblyman is somehow associated with racist behavior." Assemblyman Byrne said, "I thank the members of the Westchester Fair Campaign Practices Committee for their professionalism and for hearing our complaints. The incident in question was a disgusting display of hate and ignorance and universal condemnation of acts like this are a given. I understand our opponent is a first-time candidate, but this type of political attack only fans the flames of hate and should not be tolerated by anyone-regardless of political affiliation. I do appreciate that it appears she has since taken her post down from Facebook, even though it remains on Twitter. It is my sincere hope that other political candidates and political leaders can learn from this and avoid engaging in this type of discourse. Despite our political differences, I believe we can all agree that threats and ugliness are never the answer. Again, I thank the Committee for their findings.' In its first "unfair" finding, the Committee confirmed and agreed that Byrne condemned the Carmel incident on multiple occasions and stated in its findings that "the word 'refused' implies that there was a request to condemn that Mr. Byrne rejected. There was no evidence that Mr. Byrne 'refused' to condemn a racist incident in his district." The ruling elaborated that "the juxtaposition of Mr. Byrne's picture next to a truck with the words "F\*\*\* Black Lives" violates the following principle: 'The candidate will not use or condone any campaign material... that misleads the public.' There was no evidence provided that Mr. Byrne was in any way associated with the truck pictured" in the second finding of unfair campaign practices against Ms. Keegan. Target has clothing for all members of the family. Quite often for females they invite designers that feature clothing out of most people's price range to develop a lower cost, limited edition line so that the average person can get a taste of luxury for a lot less than they would pay at the designers studio.

Let's take a moment to talk about the Target discounting procedures. Most items when they enter the store at full price are good value. Some discounting starts at 10% but is usually starts at 30%. The next discount is at the 50% level, and items remain there for a while till they hit 70% off. 90% off, yes things like Christmas and Chanukah items, Halloween goodies and goblins, Easter candy and Passover items all hit this price level when they want to move the merchandise out and are getting ready for the next season. When things hit 90% you better get there quick because unless the item is something quite unusual stuff flys off the shelves and into shopping carts. The grocery selection at Target is quite good with even an item like WONDERBREAD discounted from its regular price. Now you are not going to find every brand and size like you would find in a supermarket. Trump advisor Steven Bannon said that 60 million to 80 million voters will cast mail-in ballots in the presidential election, which means "we need to sit there and contest every ballot."

Bannon also laid out another 2020-21 election scenario. "The mainstream media and oligarchs in Silicon Valley intend to have Facebook, YouTube and Google not declare Trump the winner. Election Week and Election Month to push through to December, and push to [Speaker Nancy] Pelosi's House of Representatives in January, when new Congress meets. It's going to be the equivalent of a civil war when they refuse to declare Trump the president [and say] under no circumstances can Biden concede."

**Phony Ballots:** Here in Westchester, and in New York State, a voter is required to request an absentee ballot from their Board of Elections. That request is signed and then dropped off or mailed to the BOE. The BOE then mails back an absentee ballot, or you can pick it up. The voter must then correctly fill out the ballot and mail it back, or return it, to the BOE.

This complicated process is also a proper level of security to avoid having voters cast more than one vote with more than one ballot.

But in other states, absentee ballots are mailed out to every voter on the BOE voter registration rolls. And many voter registration rolls still have voters who have moved or died, on them, resulting in the BOE mailing ballots to addresses where the voter no longer lives.

This gives someone the opportunity to collect those ballots and cast those votes for the candidate of their choice.

In Mamaroneck, one of the country's most conservative watchdogs is Project Veritas, led by James O'Keefe. Last month, Veritas secretly recorded interviews with democratic political workers who were "collecting ballots" from senior voters in Minnesota.

In the video, which can be found at projectveritas.com, the democratic worker says, "Just today we got 300 for Jamal Osman," says Mohamed, aka KingLiban1, in the video. "I have 300 ballots in my car right now . . . "Numbers don't lie. You can see my car is full. All these here are absentee ballots. . . . Look, all these are for Jamal Osman," he says, displaying the white envelopes. "Money is the king in this world . . . and a campaign is driven by money."

Mr. Mohamed has since explained that he was collecting ballots from homebound seniors and was making it easier for them to vote. But Minnesota law permits each individual to collect only 3 ballots at a time. Mr. Mohamed later explained that he had exaggerated how many ballots were in his car and that he had 30 and not 300. But even that amount is too many and a violation.

The Veritas video is used by the President and Attorney General Barr as proof they claim, that fraudulent ballots will be used to elect Joe Biden, and that is why they have thousands of election attorneys ready to challenge every absentee ballot. Democrats also have their army of attorneys ready to do the same. It is this type of political discord that Russia, and President Vladimir Putin, want in our country. A recent NY Times story found that internet hackers paid for by the Russian government were hard at work trying to hack into local Boards of Elections. In 2016, Russian internet agents used Facebook and social media to create "Fake News" about Hillary Clinton and attempted to get democrats not to vote for President. This year they will try the same, but with different methods and tactics. China is also said to be at work, using their technology to help Joe Biden get elected.

on October 7 that he had tested positive and has been in isolation doing well since.

The BOL offices were closed for a deep cleaning, and most non essential county employees worked from home. All legislators and staff in contact with Legislator Tubiolo begam the process of contact tracing with the County Board of Health.

County Executive George Latimer took a test after the announcement and was negative. The County Executive will continue to quarantine as required. Latimer cancelled his State of the County Address, which was to be held on October 8 out of caution after Tubiolo's announcement. "Unlike what we have seen out of officials in Washington, D.C., here in Westchester we believe in science, we believe in medicine and we believe in trusting their years of experience-based guidance," said Latimer. Tubiolo also attended an event with seven Westchester Superintendents on September 30, one week prior to his test. Anyone who attended that press conference, where masks were worn and social distancing adhered to, are not at risk, according to the County Health Department.

Health experts believe that the most contagious time for someone with COVID-19 to spread is 48-72 hours before testing positive. Tubiolo, 33, represents Yonkers and a part of Mt. Vernon on the County Board.

### Gov. Cuomo Signs Sen. Mayer Bill Banning Changes for Exits at Polling Places

Governor Andrew Cuomo signed into law a bill sponsored by Senator Shelley B. Mayer (D-Westchester) and Assemblymember Jonathan Jacobson (D-Dutchess), S.5188/A.8257, which bars changing the entrances or exits of polling places while polls are open. The new law is effective immediately. Senator Shelley B. Mayer said, "Thank you to Governor Andrew Cuomo

Senator Shelley B. Mayer said, "Thank you to Governor Andrew Cuomo for signing this important bill into law and removing another barrier to voter participation. Over the past years, voters have complained that the entrances and exits of polling places were changed throughout the day, without adequate notice to voters, causing confusion for those trying to cast a ballot. This new law ensures that entrances and exits are not changed without sufficient cause to do so. The new law also ensures that in the event a change must be made—to increase access to the polling place for those with disabilities or in the event of an emergency at the original entrance or exit—clearly marked signage must be placed to inform voters of the change."

S.5188 will:

Ban the changing of poll place entrances or exits after polls open; Allow for changes to entrances or exists to maintain public safety due to an emergency or to increase access for persons with disabilities; and In the event of a change, require clearly marked signage adjacent to the former entrance or exit informing voters of the change.

Senator Mayer continued, "I am proud of the work the State Senate Majority has spearheaded to increase voter participation in New York State. Over the past two years, the legislature has approved and apportioned funding for Early Voting, Universal Absentee Ballot access during COVID, and pre-registration of 16- and 17-year olds, among other measures. I encourage constituents to reach out to my office if they see a hurdle to voting that can be removed legislatively. We know we have more work to do. My colleagues and I are committed to doing all we can to improve access to voting for New Yorkers."

### County Police to Conduct Increased Aggressive Driving Enforcement This Month

Westchester County Police are participating in a statewide traffic enforcement campaign that aims to curb aggressive and distracted driving and reduce accidents.

The stepped-up enforcement by County Police is taking place this month on the Bronx River, Cross County, Hutchinson River and Saw Mill River parkways as well as in Cortlandt and Mount Kisco.

The enforcement campaign, sponsored by the Governor's Traffic Safety Committee, targets locations and times where data analysis shows speeding and other unsafe driving behaviors, including using a cell phone without a hands-free device, to be a leading cause of accidents.

"Aggressive driving and distracted driving are among the primary causes of crashes that cause fatalities or serious injuries," Commissioner Thomas A. Gleason said. "The goal of this increased enforcement is to reduce accidents, save lives and keep our roadways safe."

Gleason noted that the County Police enforce Vehicle & Traffic law all year round but additional officers will be assigned to the task this week. Special attention will be paid to the following violations:



### Lawrence Chiulli Won't Answer Calls, Emails

The League of Women Voters is today announcing the cancellation of the virtual Candidates Forum for NY Assembly District 95 scheduled for Monday, Oct. 12, 2020 at 7:00 p.m.

The Democratic candidate, incumbent Sandra R. Galef, formally accepted the League's invitation, extended on Aug. 30, 2020. The Republican candidate, Lawrence A. Chiulli, accepted the invitation verbally on Sept. 21, 2020. The League has received no further communication from Mr. Chiulli despite repeated requests for confirmation of his intention to participate.

Mr. Chiulli was informed by email and telephone message that his failure to respond by Oct. 5, 2020 would result in a cancellation of the forum. It is the policy of the League of Women Voters to invite all candidates, as listed on ballots, to their respective candidates forums. Should there not be at least two candidates to participate, the League must cancel the forum.

However, the League also hopes that any candidate who has declined or been unresponsive, reconsider so the League could potentially reschedule. We view the forum as if it were a job interview, so it is troubling that any candidate would not want to take this opportunity to communicate with the people they are seeking to represent."


