# **YPS In School Learning Begins**

Yonkers Public Schools Superintendent Dr. Edwin Quezada, Board of Education President Rev. Steve Lopez and elected officials welcomed students and parents back into the classroom on Monday October 5.

Students returned to their local school for the first time since March of 2020 and have been learning remotely since then. Assembly Member Nader Sayegh and City Council Member Tasha Diaz distribute COVID-19 Care Packages to the returning students.

The YPS began the transition from 100% Online Remote instruction for all students to Hybrid Instruction following NY State Education and Health Departments guidance and social distancing guidelines. The transition is designed first and foremost to ensure the health and safety of every individual in school buildings

'Children, more significantly urban children, thrive when they are in school taught by highly qualified, caring educators and supporting adults. Nothing can replace in-person teaching and learning. A recent District survey disclosed that more than two-thirds of our families want in-person instruction for their children. They want the stability provided by public schools. Our job is to ensure Yonkers students and families continue to have confidence that, despite the challenges, we will deliver the best education possible, as we have in the past," noted Superintendent Quezada. # Senator Mayer Has an Opponent: Dr. Liviu Saimovic in 37th District

While most of the elections for State Senate and Assembly in Westchester on November 3 are uncontested, with democratic candidates running

ter on November 3 are uncontested, with democratic candidates running unopposed, in the 37th Senate District, which includes almost half of the county, there are two candidates on the ballot. State Senator Shelley Mayer is seeking re-election, and her republican challenger is Dr. Liviu Saimovici. Senator Mayer has represented the 37th District for the past three years, and is currently the Chair of the powerful State Senate Education Com-mittee. After representing Yonkers in the Assembly for 6 yeras, Mayer was elected to the State Senate seat formerly held by the County Executive George Latimer and has quickly become one of the most respected elected officials in the county. officials in the county.

"During COVID, I have been very much on the ground working on constituent affairs. I have helped over 700 people receive their unemployment benefits. I have made it my business to help individuals who need assistance," said Sen. Mayer. "During the height of the pandemic here in Westchester, I was working to get PPE for our hospital staff and fire fighters. We have been working at food distributions and handing out 10,000 masks and sanitizer. There has been a need in Port Chester, and New Rochelle and all over the district."

Mayer said that as the Chair of the State Senate Education Committee, "I have been very involved with education issues locally with each school district, concerning COVID and re-opening. We have made sure that the Governor's office, and the State Education Department, have heard all voices in this discussion.'

Senator Mayer called Chairing the Education Committee "an incredible responsibility but a great opportunity to serve. I feel fortunate to be able to speak with so many parents, teachers and students, who don't always have the strongest voice. I appreciate Senator Stewart-Cousins for appointing me to this position and I always try to respect and help my republican col-leagues across the state to try to help there schools and students.

In Yonkers, Senator Mayer remains attune the the challenges facing the Yonkers Public Schools. "I am in regular touch with Superintendent Quezada and BOE President Lopez, and I am close touch with the YFT and

# Judge Daly Battling Newcomers to Stay on City Court Will Become Chief Judge if Elected

Yonkers City Court Tom Daly may have narrowly lost the democratic primary in June, but is continuing his campaign to win re-election to the City bench that he has called home for the past 20 years and if victorious, will become Chief Judge in Yonkers.

Daly, who is running on the Republican and Conservative Party lines on November 3, has received an outpouring of support from Democrats who want him to continue his service and keep the continuity in the City Court, regardless of the outcome.

Former Yonkers City Council President Chuck Lesnick, a staunch supporter of democratic candidates in Yonkers and across the state and country, wrote his support for Judge Daly.

For close to fifty years Yonkers City Court judges who have served with distinction for their full ten year term have been cross endorsed by the Democratic and Republican parties, since judicial ethics prohibit them from taking an active role in party politics except during the year in which they run. This year the Democratic, Republican, Conservative and Working Families Parties all endorsed Judge Daly who might not have had to

Attorney Dan Romano, one of the three Democratic candidates for Yonkers City Court, likes to talk about the mentors and role models that have helped shape his life as he campaigns across the city that he and his family have loved for more than 80 years.

family have loved for more than 80 years. "In Yonkers, our family really is part of the fabric of the city. We helped people, not only providing legal services, but really it's about helping small businesses, and the organizations the make Yonkers great. My dad instilled in us the importance of helping others.

Dan's father, John Romano, was a long respected attorney and community member. "He started out shining shoes in downtown Yonkers outside Sid Caesar's store. Everyone gave him a nickel for a shine, but one man gave him a quarter. My dad said, what does he do. It was Yonkers Judge Faye, and my dad said I want to be a lawyer."

Yonkers City Court Judge Martin Faye was a well known and respected judge and member of the Yonkers community. "During the depression he would take one of his paychecks and give it to the poor. He did it without notice and didn't brag about it. He was a kind man who used his public service to help others," said Romano.

"One day Judge Faye took a bunch of Yonkers kids off the streets and down to the Polo Grounds to watch a NY Giants baseball game. (Yes the Giants also had a baseball team in NYC before they moved to San Fransisco). He got the kids down to meet Willie Mays and there were dozen of stories like this about Judge Faye, from my dad, who admired him and lived his life that way.

"I aspire to be a Judge like Judge Faye. He was selfless and devoted himself to the community. He was fair and impartial and that's the Judge I want to be. "I think I could help more pepple sitting on the bench than sitting behind my desk right now," said Romano. Dan's uncle, Joe Romano, went to serve his country in World War II

Dan's uncle, Joe Romano, went to serve his country in World War II and never came back. Some of Joe's friends never forgot him, including another longtime Yonkers resident, Gabe Vitalone, who at age 97 went back to Yankee Stadium this year and sang the National Anthem in memory of Joe Romano. The two used to go to Yankee games in the 1940's before Joe went off to war. Gabe also served, with General Patton, and

Bird electric scooters have exploded in popularity over the past few weeks, and they could become a permanent Yonkers fixture.

According to Sam Cooper the Senior Manager of Government Partnerships at Bird, "Yonkers residents have taken more than 10,000 rides since the launch of the program in August."

Through an app, riders can reserve a Bird scooter for one dollar, and ride for an additional 39 cents per minute. Buses and Ubers are currently operating in Yonkers, but for those being mindful of social distancing, these options are potential unappealing.

Bird scooters notably offer minimal risk of Covid-19. Only one person rides on each scooter, so risk of infection is extremely low for riders who wear masks and sanitize their handles. Covid-19 rates are currently rising in New York City, and the second wave is expected to be hard-hitting. Unlike taking a train or bus, Bird riders do not make contact with anyone to rent a scooter, and scooters can be reserved through the Bird app at any time without having to be returned to their original location. Cooper says, "Yonkers' embrace of shared e-scooters is also another strong indication that urban transportation is rapidly evolving in response to a coronavirus pandemic that has underscored the importance of sustainable, socially distant mobility options."

Yonkers resident Hector Santiago is the admin of Facebook page Bird Scooters Yonkers, and says the scooters are "awesome!" He has noticed their popularity among teens in particular. "Some kids don't have financial means to get to one side of the city, or to the YCMA or something, so they use these scooters. It's also a good way for the parents to keep a measure on them, because the parent will rent it out on their phone and reserve it for that particular kid. So the parent kind of measures where the kid goes."

However, Santiago hopes that safety precautions such as helmets are added. Currently, riders are expected to wear their own helmets, but this rule is not enforced. Fear of scooter related injuries is the reason that Bird scooters are currently banned in Manhattan. In Yonkers where the streets are less congested, scooters are so far quite safe. They have a speed cap of 15 miles per hour. Bird is launching scooters only in west Yonkers as part of a one year long

Bird is launching scooters only in west Yonkers as part of a one year long pilot program. If the scooters continue to be a success, the scooters will likely become a permanent Yonkers fixture. The expansion of Bird seems very likely. "We're looking to expand to other areas of the city as well as other locations in Westchester," Cooper states. "Bird is invested in giving all Yonkers residents access to affordable, carbon-free transportation alternatives. We'd love to work with the city to extend the program."

Dr. Del Vecchio also graduated from the College of Mt. St. Vincent, Riverdale, NY, with a BA cum laude in Spanish and from Iona College, New Rochelle, NY with a MS in Education and Latin American Studies.

Our parents, our educators, our community leaders, our elected officials, they want to see our schools reopen for children," Quezada said, flanked by city officials on Thursday. "And you know that I want this more than anything because there's nothing more rewarding than having children in school — and we want to do it safely."

Last week, The Yonkers Federation of Teachers released an open letter to the Yonkers Public Schools community to raise awareness of ongoing issues related to the reopening of school buildings this coming Monday for hybrid instruction.

In a letter to families from the YFT Executive Board, the union says district leaders still must address a litany of outstanding concerns, ranging from incomplete ventilation and window work to a lack of clear arrival, dismissal, bathroom, lunch and cleaning protocols that are necessary to protect the safety of every student. Other issues include inadequate access to personal protective equipment and insufficient protocols for identifying COVID cases and closing buildings to go to remote instruction where cases are identified.

YFT continues to advocate for a 14-day closure of any building in which there is a confirmed positive COVID case. "Let's be honest that these are concerns that district leaders should have had in place months ago in order to safely reopen," the letter states. "To be sure, there are and will continue to be issues that pop up throughout this year that we will have to address together.

"No matter the work ahead, we want to be unequivocally clear: Not even a global pandemic could break our commitment to children. We will continue to be there for Yonkers students."

"Education in the time of COVID is nothing like any of us ever imagined we would experience in our careers. We know that a strain has been placed on many families, including our own. We want more than anything to return to normal. We miss our students, and we miss the opportunities to check in academically, socially, and emotionally with them in person.

"But even with months to plan, we believe district leaders still need to address the following

-Uncompleted ventilation and window work at the school buildings that is essential for safer circulation in confined settings. HEPA filters need to be installed in classrooms that have outdated ventilation systems and too many windows remain broken or, in the worst cases,

bolted shut at this time.

-Lack of clear arrival, dismissal, bathroom, lunch, and cleaning protocols that include measures intended to protect the safety of every student.

-Inadequate access to personal protective equipment that must be provided by the district for students and staff. That includes correctly sized masks and N95, disposable and replacement gowns, and a dedicated isolation room.

-Insufficient protocols for identifying positive COVID cases and closing buildings to go to remote instruction where cases are identified. Yonkers educators continue to advocate for a 14-day closure of any building in which there is a confirmed positive COVID case, which would help reduce community spread.


#### Letter to Editor-Once A Rising Star: This Yonkers Democrat Has Lost Her Way

# On this day in Yonkers history...



John E. Bruce

#### *By Mary Hoar, President Untermyer Performing Arts Council, Member Landmarks Preservation Board, President Emerita, Yonkers Historical Society*

#### Monday, October 12th

October 12, 1913: Mr. and Mrs. John E. Bruce were requested by Bishop Samuel Fallows of Chicago to become members of the advisory council of the Illinois Commission to conduct the half-century of African-American freedom. The Bishop was president of the commission. The Bruces accepted the appointments. Bruce, an author, journalist, publisher, orator and historian, co-founded the Negro Society for Historical Research with Arthur Schomburg at Edward's Warburton Avenue home in Yonkers. He is buried in Oakland Cemetery in Yonkers.

October 12, 1939: Despite the threat of bad weather, several thousand war veterans, civic leaders and representative of dozens of Yonkers organizations marched through the heart of Yonkers. Chairman Alderman Salvatore Cerone had organized the "America at Peace with the World" to acclaim "Americans All," Yonkers 1939 celebration of Columbus Day.

#### Tuesday, October 13th

October 13, 1976: President Gerald Ford visited Mayor Angelo Martinelli at Yonkers City Hall; while there he signed the State and Local Fiscal Assistance Amendments of 1976, while hundreds of school children and adults cheered. Besides our esteemed Mayor, other New York dignitaries witnessing the signing were Yonkers own Governor Malcolm Wilson, Senators Jacob Javits and William Buckley, Councilmembers, and children from several Yonkers schools.

October 13, 1983: Melissa Manning of Yonkers is crowned the new Miss New York State in Watertown, NY by Miss America, Vanessa Williams. Williams, previously Miss New York State, vacated her state title when she was selected to wear the national crown. Manning had been the first runner-up for the title.

#### Wednesday, October 14th

October 14, 1924: After raiding a Herriot Street basement, Yonkers police found a plot to hide Hip Sing gunmen in Yonkers prior to a Tong War in New York City.

October 14, 1930: 6,000 feet of beer pipeline was discovered running through the sewers under Columbus Avenue, Elm Street, Palisades Avenue and John Street.

#### Thursday, October 15th

October 15, 1915: Republican Yonkers Mayoral candidate Gideon Peck declared, "When women have the right to vote, the morale of the body politic will rise." His opponent, incumbent Mayor James Lennon, won.

October 15, 1932: A passerby's cigarette carelessly dropped set fire to the loading platform of the "Old Skin Shop" at 78 Elm Street. Assistant Chief Daniel Carnegie and other men from the nearby Fire Headquarters ripped up the burning boards, using chemicals to extinguish the flames.

#### Friday, October 16th

October 16, 1930: Yonkers police officers and Federal prohibition agents found 1,500 more feet of heavy 3-inch hose running through a sewer near the junction of Palisade Avenue and Elm Street; they believed this hose was used to transport beer from a local brewery or bottling plants in the city.

October 16, 1952: Ace Detective Sergeant Patrick Christopher was honored for his record setting service of twenty-five years in the Detective Division. After spending the day directing the Acropolis murder investigation, Christopher was presented a wallet with cash by the men with whom he worked. One of the most efficient and respected men in the department, he primarily trained and advised men in the division. Christopher was appointed a patrolman in 1926; just a year later—October 16, 1927—he was assigned to the Detective Division. During the inaugural of President Truman January 1949, Christopher was assigned to the Washington police at their request, the first time this honor was given to a Yonkers police officer.

#### Saturday, October 17th

October 17, 1914: Yonkers acrobat Clarence Birdsall played to a packed theater performing at the Orpheum; this was the first time he performed in his hometown in years.

October 17, 1922: Yonkers motorcycle officer John Fogarty of the Traffic Squad, on his way back from having his speedometer tested, was suddenly blocked on Broadway near 250th Street when a large baking truck pulled in front of him. After



CSEA. I also work closely with the PTA and new parents groups. I don't run the school district but I fight for the Yonekrs schools in Albany."

Together with Senate Majority Leader Andrea Stewart-Cousins, Mayer was albe to convince the Governor's office and the State Office of Budget not to make a 20% cut to State Aid for the YPS. That intervention was critical to avoid layoffs of teachers and staff.

"I view my role to focus on the state process and the impacts that it will have in Yonkers. I continue to advocate for the students, and I understand that a majority of parents and kids want the schools to be open. It's been hard for everyone."

One issue that Sen. Mayer wanted to clarify during our interview were "misrepresentations" in the public and the media, and modifications made to New York's Bail Reform law. The issue has become a hot button topic for supporters of law enforcement and the discussion over who should be incarcerated and for how long.

"When we did the bail reform bill, it was before the death of George Floyd. I had heard from police chiefs about concerns over repeat offenders committing misdemeanor offenses that were no longer eligible for bail. And people were upset.

"I pushed to get significant modifications to the law and now those who commit the same crime of damage to property or a person, the 2nd offense is now bail eligible. We also made changes to include domestic violence offenses. We acknowledged that there needed to be changes and now it is a better law. I appeared before many village boards in the middle of COVID, to have a conversation about this and we heard their concerns and made improvements," said Mayer.

Mayer said she is taking her re-election "very seriously." I never take any election for granted and I work for the people's vote every day as their Senator. Constituent services is an important part of my offices reputation and I personally handle many of those requests myself.

"I know that I have a responsibility to the people in the district to stand up and fight for them. This is a time for leadership and I know that I have more to achieve for my district, and I would be honored to have your vote. I'm not sitting back on my laurels, and I'm very comfortable having a conversation with those who disagree. This is a trying time for everyone.



being taken care of by an ambulance surgeon, Fogarty arrested the driver and brought him to the New York's 57th Precinct.

October 17, 1926: Mrs. Gordon Morris of the Women's Committee for Law Enforcement told the Yonkers branch of the National Council of Jewish Women that repeal of the Eighteenth Amendment would never happen during their lifetime. She added if the Democratic Party held to a "wet platform" it would lose badly in the 1928 election as "…three quarters of the states" were "permanently dry."

#### Sunday, October 18th

October 18, 1937: Superintendent of Schools Dr. W. W. Ankenbrand, informed the members of the Yonkers Board of Education they were required to provide soap and paper towels in the schools; the New York State Ed Department had made stricter regulations for the school health service. Several PTAs had protested the lack of facilities, stating teachers and parents had to make up the failure of the schools to provide adequate sanitary supplies. Only five elementary schools had soap and towels; one more had supplies for part of the year... two had paper towels, leaving eighteen grammar schools with neither soap nor towels. Two high schools had towels, and no soap, one had both, and two had neither.

October 18, 1943: Private Andrew Sutton, formerly Patrolman Andrew Sukowsky of YPD, while taking basic training in the Military Police School at Fort Custer MI, won a ten dollar first prize on Michigan radio program "Let's make Conversation." Formerly a Gorton High School athlete, Sutton was asked the question, "Is Marriage Complete Without Children?" He spoke so lovingly about his Yonkers wife and son, that the audience voted him first prize without hesitation. The Private later told friends he thought the audience had to be mostly married men with children, "judging by the applause" they gave him.
