YPD Officers Rally In Support of Disabled Officers Set To Be Fired



"The Mayor has decided to abandon his most vulnerable police officers, those seriously injured in the performance of their duties, taking away their health care in the midst of a pandemic,"

On November 17, members of the Yonkers Police Department gathered on the steps of Yonkers City Hall to shed light on what they call the shameful decision by Mayor Mike Spano and the Yonkers Police Department to fire four, veteran, decorated Yonkers police officers who were all seriously injured in the line of duty.

Calling it, "a false claim of fiscal responsibility, YPD PBA President Keith Olson said, "the Mayor has decided to abandon his most vulnerable police officers, those seriously injured in the performance of their duties, taking away their health care in the midst of a pandemic and trying to take away their dignity using a seldom used civil service rule. This move is being made despite the City's attorney advising not to do so."

The officers that are slated to be unfairly terminated include: Police Offi-

The officers that are slated to be unfairly terminated include: Police Officer Shavon Johnson-Acker, a 13-year veteran of the YPD and mother of two who injured her knee so seriously she suffered through five separate knee surgeries in her fight to return to fully duty as a police officer.


Police Officer John Sylvestri, a 12-year veteran and member of the elite Emergency Services Unit, who after undergoing knee surgery as a result of a line of duty injury, suffered from numerous pulmonary embolisms. Officer Sylvestri nearly lost not only his leg, but his life as well.

Police Officer Kirk Maher, a nearly 14-year veteran of the YPD who was injured so severely in an on duty car accident that he was forced to undergo dangerous spinal surgery.

Police Officer Marcos Mosqueda, a 9-year veteran of the YPD and father

Latimer: A Second COVID-19 Wave Has Arrived in Westchester

Westchester County Executive George Latimer gave a blunt and honest health assessment as COVID-19 cases in the county continue to rise at alarming rates. During a press conference this week, Latimer said that the "Second Wave" of a spike in COVID cases and hospitalizations, "that we were warned off has come true."

Two weeks ago, Westchester had just over 1,000 active cases. This week that number has tripled to over 3,700. "We just filed a countywide robocall with a public reminder of the personal steps we must take: masks, hand washing, social distancing. We're now setting up PPE giveaways at apartment complexes to get the protection down to the grassroots level. We're going to ratchet back our County department staffs to remote work as much as possible. Only virtual meetings for our Boards and Commissions immediately, no in-person gatherings.

Governor Cuomo holds executive authority to effect the hows and whens of shutdowns. We don't want to see anything shutdown per se, but if we don't turn the corner soon....choices may be limited. We expect he will work in harmony with neighboring Governors. I know all too well the terrible economic impacts of any shutdowns and it is devastating to lives. All the more reason to stop any need for shutdowns by getting 100% com-

pliance on social gatherings, masks, etc.

"We prize our personal freedom and we speak of personal responsibility. The price of doing our own thing could well be the lives of a neighbor or family member. If we step up as individuaks, then there's no need for government to step in. But lives are at stake. Arguing over death statistics, that tries to minimize the threat we face sounds more like fighting to avoid

Redevelopment of Cottage Gardens Affordable Housing Hits Milestone



One of the largest affordable housing redevelopment projects in the region reached another milestone with the closing on financing for 178 Warburton at The Ridgeway, a new \$56 million mixed-income residential complex of 81 apartment homes in Southwest Yonkers that is being developed by the Municipal Housing Authority for the City of Yonkers (MHACY) and The Community Builders (TCB).

The new eight-story building, which is under construction, will feature a unit mix of 6 studio units, 35 one-bedrooms, and 40 two-bedrooms, and are affordable to families with a mix of incomes, ranging from 30% to 90% of

Area Median Income (AMI).

The mixed-use building will also include a new Early Head Start day care center operated by Westchester Community Opportunity Program, Inc. (WestCOP), a private, not-for-profit, multipurpose social service organiza-

tion.

178 Warburton at The Ridgeway is the fifth phase of the six-phase master plan to redevelop Cottage Place Gardens, a 256-unit distressed public housing complex built in 1945, into the mixed affordable and market rate development, The Ridgeway. It replaces three outdated public housing buildings (Cottage Place Gardens Building #4, 8, and 12) and a former gasoline service station with a new, energy efficient residential building. The project also includes the remediation of a brownfield. This phase of the redevelopment will have a significant economic impact by creating approximately 200 construc-

tion jobs over a 24-month construction period.



Mayors Spano Makes **Several Appointments**

Yonkers Mayor Mike Spano this week swore in Commissioner Louis J. Albano and Deputy Commissioner Lee J. Ellman to head the City's Department of Planning & Development. The Yonkers City Council confirmed the

Mayor's appointments at its Council meeting last week.
"Collectively, Lou and Lee bring over 70 years of experience in municipal planning and community development," said Mayor Spano. "Their in-depth knowledge and expertise with urban planning, zoning, and housing in Yonkers and with our surrounding communities make for a seamless transition in continuing the City's ongoing economic development and urban

Albano has served as the City's Deputy Commissioner of Planning & Development since 2013 where he was directly responsible for coordinating and monitoring new and ongoing development projects for the Community Development Block Grant (CDBG) Program; developed plans in accordance with the U.S. Department of Housing and Urban Development; and interpreted and analyzed zoning ordinances, regulations and renewal plans. Previously, Albano served in the City of Mount Vernon's Planning and Community Development department in various roles including Commissioner, Executive Director of its' Urban Renewal Agency, and served as Director of Housing and as a Compliance Officer. Albano replaces former City Planning & Development Commissioner Wilson Kimball, who vacated her position in April 2020.

Ellman transitions into the Deputy Commissioner position after serving as Yonkers' Planning Director since 1992. During his role as Director, Ellman has overseen the City's Planning, Landmarks Preservation, Zoning Boards and Environmental reviews. He has led major Yonkers developments including the Alexander Street Master Plan, the Ravine Avenue Master Plan and Renewal Plan, the Ridge Hill Project Planning Renewal Zoning and Environmental Review and, most recently, the Ludlow Transit Oriented Development Plan. Albano's and Ellman's positions are effective immedi-

Last month, Mayor Spano today announced the reappointment of David B. Jackson as the City Assessor and his appointment of Gail Burns to the Yonkers Board of Education. David Jackson was sworn in as Assessor for another six-year term. Mayor Spano first appointed Jackson as City Asses-

"Dave's extensive experience in assessment administration allows us to continue to build on our efforts in providing Yonkers taxpayers with a fairer and more efficient assessment process," said Mayor Spano. "I am confident

he will continue to do a superb job for our city taxpayers.' Prior his tenure with the City of Yonkers, Jackson served at the West-

chester County Tax Commission, worked with the Norwalk, Connecticut Department of Finance, Washington D.C.'s Department of Finance and Revenue and the City of New York's Department of Finance. Jackson was the former President of the New York State Association of County Directors of Real Property Tax Services.

The dogs loved people food and one year we arrived as a dog was munching on the crudités platter which I believe had chopped liver on it. My gifts come in fancy reusable gift bags I would buy at Burlington Coat Factory or TJMaxx or Marshall's for a dollar each. My sister on the other hand loves to perfectly wrap gifts. She is good at it, enjoys doing it, and finishes wrapping the last few gifts as she watches the Macy's Thanksgiving Day Parade. Every gift has a matching bow and a gift

We actually haven't seen our cousins since last Thanksgiving, and even though we are in touch weekly by phone we miss the personal contact dearly. Passover, Rosh Hashanah/Yom Kippur, Thanksgiving and most likely Chanukah will be out of the picture this year.

the self sacrifice that is needed in this revived moment of the pandemic. We were warned of this. And it has come true. How we respind to this is really the only question now.

Doctors, clinics and hospitals recognize that more COVID-19 surges are likely to occur. They are working with manufacturers to stock up on equipment, and they are continuing their policies for protecting patients and staff members," said Latimer.

Port Chester continues to be the county's #1 location of positive cases and is now labeled an Orange Zone, with neighboring Rye Brook in a Yellow Zone. Other parts of the county with a large number of positive cases include Yonkers and Mt. Vernon. But with neighboring Connecticut and Putnam County to the north both with high positive rates, all part of the county and its residents should be concerned and careful.

As all of us wait and pray for a Vaccine, we agree completely with the County Executive, who admonished those who are refusing to practice CO-VID-19 precautions, such as physical distancing, hand-washing and mask-wearing. "I invite you to join us when we have refrigerator trucks of bodies with tote tags on them stacked up in a refrigerated vehicle in one location or another because we do not have the capacity to deal with the number of people that have died within a period of time," Latimer said. "And then tell me what you think your rights should be and shouldn't be when we have dead bodies stacked up like that. I lose my patience with that."

A total of 1,490 Westchester residents have died since March from CO-VID-19.

The Ridgeway redevelopment master plan calls for 500 units of housing, parking spaces, a ¾ acre central open space as well as mixed-use development in three of the six project phases. To date, 242 units across three phases have been completed, as well as the substantial renovation of an existing daycare center. Another 166 units of housing are currently under construction at 172 Warburton and 178 Warburton.

"This new phase of Cottage Garden's redevelopment points to the positive momentum happening right now in Yonkers as we revitalize our neighborhoods and improve the lives of the residents who live here," said Yonkers Mayor Mike Spano. "We are building a stronger, a more sustainable community for residents, thanks to the support of our federal, state, private and local community partners and their commitment to Yonkers. I look forward to the great improvements that will be made to this very deserving neighborhood."

"MHACY is grateful to our partners at Westchester County, the City of Yonkers and TCB for working together to provide environmentally conscious affordable housing. This is a great example of a successful public-private partnership," said MHACY President & CEO Wilson Kimball.

The total development cost for the entire multi-phase project is estimated to be \$296 million, with New York State Homes and Community Renewal is the primary source of financing. \$5 Million in funding for the project came from the Westchester County Housing Implementation Fund.

County Board Approves \$6.675 Million Renovations at Tibbetts Brook Park

This month, the County Board of Legislators unanimously approved a plan to make substantial improvements to Tibbetts Brook Park in Yonkers. The work includes major improvements to pathways as well as the entrance drive and parking lots, in addition to improved drainage along existing roads, parking lots and pathways.

The improvements come after work in recent years to renovate the pool, picnic areas, ballfields and access to the South County Trailway have led to a dramatic increase in park attendance. Legislator David Tubiolo, Chair of the Board's Parks and Recreation Committee said, "Tibbetts Brook Park is an enormously important resource to people in our community, especially now, during the COVID-19 pandemic. I'm so excited that the work we've already done to renew the park has drawn more and more people to this wonderful facility.'

Legislator Ruth Walter, Vice Chair of the Parks and Recreation Committee said, "The importance of Tibbetts Brook Park, and all our County parks, has only grown during the COVID-19 pandemic. People rely on these parks for open space and recreation, especially in a densely populated city like Yonkers. Improvements we make to these parks today -- when interest rates are low -- will not only benefit us now, during these challenging times, but also will provide an improved quality of life in Westchester for years to come.'

Legislator Jose Alvarado said, "This is a long time coming for this park in my district. Under previous administrations there had been very little done to maintain and improve Tibbetts Brook Park. But as we can see now that the County has made substantial improvements, people are excited to come out to this beautiful park. In a good year, Tibbetts Brook Park gets more than 80,000 visitors, and these improvements to parking and paths will only make it easier for even more people to enjoy."

Majority Whip Christopher Johnson said, "We have great County parks across Westchester, but Tibbetts Brook Park is special because it provides 161 acres of open space with a pool and playgrounds right in the center of Westchester's most populous city. This is a much needed, and much used resource for everyone in southern Westchester and I'm glad we're

continuing to invest in the park and the people who use it."

The County Board recently authorized an amended bond act in the amount of \$6,675,000 which includes \$575,000 of previously authorized bonds to finance the cost of design, construction and construction management of the new improvements which are expected to take 15 months to complete.

of three who suffers from debilitating spinal injuries as a result of an on

duty car accident.

Each one of the officers risked their lives protecting the people of Yonkers. Each one of these officers was seriously injured while performing their duties. Each one of these officers did everything they could do to return to duty with the Yonkers Police Department, including suffering through life altering surgeries. Each one of these officers has followed all the rules, have served their City and their police department with honor and integrity and have done nothing wrong," said Olson.

Mayor Mike Spano, through spokeswoman Christina Gilmartin, explains that the City is using Article 71 of the NYS Civil Service law to move the officers off the City payroll and onto permanent disability. Gilmartin said that the officers have been on injury leave for, on average, four years each, and that the City, and its taxpayers have paid more than \$6 Million for 10 offices on injury leave.

Olson added that the Spano adminstration did not handle the decison properly by having a conversation with all of the parties involved. But the City added that conversations about the officers on injury leave have been

ongoing for more than a year.

What is notable is that the dispute between Mayor Spano and Olson and the Yonkers PBA is the first is Spano's 10 years in office. Olson and the Yonkers PBA endorsed Spano in each of his Mayoral runs, and the YPD PBA was the first City union to come to a long term agreement on a con-



On This Day in Yonkers History ...

Monday, November 23rd:

November 23, 1943: The Dresner family of Stone Avenue received a gift from son Lieutenant Allen Dresner, USNR, mailed from Hawaii where he was recovering from malaria. Tucked into a milk chocolate can were souvenirs collected during the year Dresner spent in the South Pacific. Among the souvenirs his mother Ruth found were Japanese shell casings, a deactivated grenade and... two molars! No explanation of where he had gotten the teeth, but his mom anxiously awaited his arrival home to find out why he kept them.

November 23, 1946: Robert Weist, Legislative Assistant to the Common Council, told the Taxpayers Organization of Northeast Yonkers the city would not have the promised twice-a-week trash collection in 1947. The organization was outraged and stated increasing weekly collections not only were imperative to safeguard the health of Yonkers people, they were necessary to control the dangerous Yonkers rat

Tuesday, November 24th:

November 24, 1942: The Herald Statesman reviewed the success of the "V for Victory" warning for speeders! Because speeding wasted gas needed for the war effort, Yonkers drivers' began tapping out the special signal, "beep—beep—beep—beep beeeeep" (three short and one long beeps, Morse Code for V) whenever they saw a fast-moving driver. Most drivers immediately slowed down, not only because speeding was "dangerous, it was TREASON," in the words of the paper.

November 24, 1947: Robert Weist, Legislative Assistant to the Yonkers Common Council, spoke on the advantages of the City Manager government in Yonkers on a Scranton radio station program arranged by the Scranton Junior Chamber of Commerce. He focused on the improvements since Yonkers adopted this form of administration: lower taxes; improved city services, improved garbage collection; Yonkers higher credit standing; and repairs of schools and streets.

Wednesday November 25th:

November 24, 1936: Mayor Joseph Loehr announced, for the first time in four years 3,000 Yonkers employees would receive a full paycheck on December 31st.

November 25, 1942: When The Herald Statesman's "Town Talk" column asked the question if anyone remembered the names of the two Yonkers men awarded the Distinguished Service Cross during WWI, few were able to answer the question! The men honored with the DSC, the second highest honor our country presents, were Recreation Superintendent James McCrudden and Yonkers Savings Bank's Angus Robertson.

Thursday, November 26th:

November 26, 1922: Three radio shops, Yonkers Radio Exchange on Main Street, Felsh & Kastl on Warburton Avenue, and Knepfer's Sports Shop on Main Street, invited the public to hear Yonkers Statesman Sports Editor William Miley speak on the "Football Season of 1922." The show was broadcast over Tarrytown's Station WRW. Other Yonkers residents who owned radiophone receiver were invited to tune to 360 meters to hear the address.

November 26, 1945: McLean Heights' Edward O'Neill, National Sergeant-At-Arms of the American Legion, personally escorted General Eisenhower at their national convention in Chicago. Although a member of the American Legion's Committee on Distinguished Guests, this was the first time he had sole responsibility for an honored guest at the convention.

Friday, November 27th:

November 27, 1922: Best-selling British novelist Hugh Walpole spoke to a large audience in Philipsburgh Hall on "Books and Friendship." Although listed as a British author, Walpole was born in New Zealand; when he was five years old, his father, a minister, took an assignment at the General Theological Seminary in New York. When he was nine, he was sent to school in England.

November 27, 1943: Yonkers audiences at the Yonkers RKO Proctor's spotted Yonkers soloist and Private First Class Vance Campbell in the movie, This is the Army! Starring Ronald Reagan and Joan Leslie, all proceeds of the film went to the Army Emergency Relief Fund. Campbell portrayed an Army Chaplain in the film; when romance bloomed between the two Hollywood stars and reached the marrying stage in the film, Campbell performed the ceremony! This is the Army was the highest grossing musical film for eleven years, finally surpassed in 1954 by White Christmas. Proceeds from the movie were donated to the Army Emergency Relief.

Saturday, November 28th

November 28, 1910: Mayor James Lennon named a commission to review designs for murals for the new City Hall; Rudolf Eickemeyer, Jr., Charles Israels and Howard Chamberlin were appointed to this committee.

November 28, 1912: Yonkers own William Langford was the official referee for the Army-Navy game at Franklin Field in Philadelphia. Navy won, 6-0.

November 28, 1942: Harry Ahistedt's safety glasses were featured in Yonkers Works Digest, the company paper for Otis employees. Ahistedt, an experienced worker who performed a thousand operations a day, had a narrow escape; a bolt flew out of the machinery and hit the safety glasses he was smart enough to wear! The safety glasses, no doubt, saved his eyesight, and the incident and resulting publicity were a very important safety lesson to the men and women who worked for the company.

Carlisle-Thomas continues to volunteer in Yonkers and was an integral part of the

community's effort to feed those in need.

Sunday, November 29th

November 29, 1672: Elias Doughty, brother of Mary Van der Donck O'Neale, sold Colendonck to Thomas Delaval, Thomas Lewis and Frederick Philipse. At the time of the purchase there was a thriving business at the mill near the mouth of the Nepperhan River; Philipse found it so profitable, he bought out his partners and became sole owner in 1686. He gradually extended his holding until his lands covered all the land from the Spuyten Duyvil Creek to the Croton River.

November 29, 1943: The lack of parking facilities for employees of Habirshaw Cable and Wire Corporation, long a major issue both for employees and local residents, not only caused numerous complaints to police and City Hall, but also was a major safety concern. The company finally agreed to purchase an empty lot across from the Glenwood Gardens apartments for employee parking; the Common Council created a zoning change to permit parking in the lot. The Council asked the City Manager to make certain the site only would be used for open air parking and meet with the Habirshaw management; before any discussions could take place, the company announced it had cancelled its contract to buy the property!
