Should the Next COVID Vaccination Site in NY State Be in Yonkers?



Yonkers Mayor Mike Spano called on New York State to open a CO-VID-19 vaccine distribution center in Yonkers to handle the thousands of local residents who are eligible to receive it.

"Since Yonkers is the 4th largest city in the state and the largest in the Hudson Valley, it is imperative that we meet the vaccine needs of our region by opening an additional center in our city," said Mayor Spano. "Positivity and hospitalization rates continue to rise here while appointments to obtain a vaccine are increasingly difficult to schedule. We can't expect Westchester County Center alone to mass service most of those who live in the lower Hudson Valley. We need to expedite the vaccine to the areas where it's needed most."

Citing that Yonkers is the most densely populated area in the County and with the most cases, Mayor Spano added, "Three Yonkers zip codes were designated Yellow Zones by the State in November, proving we need to stem the tide of more cases. Our Yellow Zone mostly impacts our lower income communities, many of whom rely on public transportation, so traveling to the County Center for the vaccine comes even more burdensome. I ask our State health officials to consider Yonkers as one of the main hubs for vaccine distribution, especially as more residents become eligible for it."

"Our collective goal is for all of us to gain herd immunity as we vaccinate more and more Americans – let Yonkers be a means to that goal so we can once again open up our schools, businesses and homes as they should," stated Mayor Spano.

Suggested locations for vaccine distribution centers in Yonkers include the Yonkers Police Athletic League and Yonkers Public Libraries. Since March 2020, over 17,000 Yonkers residents have contracted COVID-19.

Westchester recently opened its first state run vaccination site at the County Center in White Plains, but reservations for vaccinations quickly filled up and Cuomo announced that while over 7 million New Yorkers are now eligible for the COVID vaccine, the state only receives 300,000 doses per week from the federal government. To date, New York's health care distribution sites have administered 75 percent of doses received from the federal government.

Due to the federal government's limited allocation, appointments have filled up quickly. New Yorkers are being urged to call your local health department, pharmacy, doctor or hospital for additional information and to schedule appointments.

Yonkers Public Schools Graduation Rates Up Again, Now at 91% on time



Congratulations to Yonkers High School students, for their academic successes through COVID-19

Data from the New York State Education Department found that 2020 graduation rates for the Yonkers Public Schools continued to grown and improve. "Yonkers achieved their highest graduation rate in decades–90.6% - and surpassed the State graduation rate of 84.8%. Most significant for an urban school district, Yonkers continues to close the achievement gaps among all race, gender and sub groups. Under extraordinary challenging circumstances, our dropout rate remained constant at 3.4%," said YPS Superintendent Dr. Edwin Quezada.

"The resilience and persistence of the Class of 2020 graduates and their families as well as the relentless commitment of Yonkers administrators and teachers resonates in the graduation data released today," stated Dr. Edwin M. Quezada, Superintendent of Schools.

Over the past ten years, the District has focused significant resources into closing the achievement gap across race, gender and sub groups including English Language Learners and Students with Disabilities. In particular, intentional efforts towards male achievement with initiatives such as Yonkers My Brother's Keeper that engage community supports for students.

Board of Education President Rev. Steve Lopez added, "Yonkers continues on a positive trajectory even under the most challenging times for our community. The first of the Large City Districts to graduate over 90%, Yonkers Class of 2020 graduation rate of 91% surpassed the State's rate of 85% and Westchester County's rate of 90%. These results dramatically demonstrate the outstanding work of Dr. Quezada, all of our employees, students and families."

Yonkers on-time graduation rate continued to climb to 90.6% in 2020, a growth of 2.6% points. The graduation rate is strong across race, gender and sub groups, with 90% of Black students, 90% Latino students, 90% Male, 91% Female, 85% Multi-Lingual Learners, and 68% Students with Disabilities graduating on time.

"New York is working around the clock to get needles in arms quickly and efficiently, but we are being constrained by the federal government – they increased eligibility, but never increased supply," Governor Cuomo said. "What they did was like opening the floodgates of eligibility. Now, 7 million New Yorkers are eligible, but we are still only receiving about 300,000 doses a week. Even worse, we actually got less doses this week at about 250,000. New York has done its part and now has one of the most expansive distribution networks to actually conduct the vaccinations and it's time for the federal government to do theirs and actually increase the supply."

Absentee Ballots are Here to Stay

The election of 2020 will be know as the COVID-19 election, but also should be remembered as the election where the ability of voters to cast their ballot by absentee was expanded and the restrictions against it relaxed.

State Senate Majority Leader Andrea Stewart-Cousins and the democratic supermajority in Albany have proposed and presented a number of voting reforms designed to modernize the vote by mail system and increase transparency and voter turnout. The legislation passed builds on the Senate Majority's historic election reforms passed during the 2019 and 2020 Legislative Session. The package of bills includes legislation to require absentee ballots be counted as they come in, requires absentee ballot drop boxes at voting locations to reduce long lines, and allows voters to track their absentee ballot.

"Elections matter, voting matters, and leadership matters. We have seen how fundamental change can be achieved when people exercise their Constitutional right to vote," Senate Majority Leader Andrea Stewart-Cousins said. "The Senate Democratic Majority has started the past two Legislative Sessions with legislative packages to empower New Yorkers and reduce barriers to voting. The bills advanced by the Senate Majority continue those efforts and will help reform and modernize our electoral system. I applaud the bill sponsors for their leadership on this foundational issue, and thank my colleagues for advancing these bills and standing up for New York voters."

The bills advanced by the Senate Majority include: Speeding Up the Absentee Ballot Counting Process: This bill, S.1027, sponsored by Deputy Majority Leader Senator Michael Gianaris, amends

County Executive Latimer Announces Re-Election Bid Why Nobody Wants To Run Against Him



Westchester County Executive George Latimer

Westchester County Executive George Latimer made it official on Jan. 11, that he will be seeking a second term. "I am announcing today that I am seeking a Second Term as County Executive with the new term limits law in place, this would be my final term if elected. We've done a lot, in a difficult time....but we have more to do. And we can accomplish these things - together," said Latimer in a short video posted online.

Latimer has served Westchester in the middle of a pandemic. This is uncharted territory, as he likes to say, and he is right, not only for county government but for all of our lives, jobs, and most important the health of our families.

So there is little time for Latimer to make a large campaign kickoff announcement, especially when the Westchester County Center becomes a COVID vaccine location and tens of thousands of county residents are ready to get their shot.

Latimer made the announcement now because the political calendar in NY State has moved all dates and deadlines up; conventions are held at the end of Jan, and candidates have to go out and get signatures in Feb. and March. The whole process is over in April and the democratic primary, which many now be the most important election in Westchester, will take place this year on June 22.

With just a few weeks left for a candidate to step forward, nobody wants to run against George Latimer. Not a progressive democrat, nor a republican.

The rumors that State Senator Alessandra Biaggi would challenge Latimer from the left are FALSE, she is not running for county executive, nor has anyone to the left of Latimer. County Clerk Tim Idoni is facing such a challenge, from Yonkers City Councilwoman Shanae Williams.

One republican had stepped forward to challenge Latimer last fall. His name is Dan Branda, a relatively unknown former staff member to the prior County Exec. Rob Astorino.

Branda, who lives in Somers, was the only republican to toss his hat out into the ring, and for several months in 2020, he had the spotlight to himself and tried to gain some traction with several press releases, (including one that backed the accuser of Gov. Andrew Cuomo for sexual assault), but nothing gained any serious media attention.

Perhaps that is why Branda is now out of the race for County Exec., accoridng to published reports, where he stated that he was pursiing "a family opportunity," and was no longer a candidate.

This leaves no republican candidate to challenge Latimer. There are only a few republicans left in Westchester that have the Gravitas to challenge Latimer. And most believe that those few republicans have watched Latimer's service as County Executive and determined that the risk and hard work required, during a pandemic to challenge him does not equal the long-shot reward of beating him on Nov. 2.

What more can I say other than, 'God Bless America, my Home Sweet Home. God Bless America, my Home Sweet Home!'


The Journal News. Your Local Newspaper?

Yonkers Police and Partner Agencies Target Fraudulent License Plates

ty Department of Public Safety, and New York State Police conducted a traffic enforcement detail in the City of Yonkers targeting fraudulent and counterfeit license plates, including many out-of-state temporary license plates, paper tags, to vaccinate everybody. Due to the COVID-19 pandemic, the Department of Motor Vehicles in New York and many other states reduced services in the interest of public health early last year, resulting in a delay with the assignment of registration plates. As services have gradually been restored, some individuals have taken advantage of the situation and produced fraudulent paper and temporary tags under the belief that enforcement was being deferred; they were mistaken. Many of these vehicles, unregistered, uninspected, and uninsured, pose a public safety risk to motorists and pedestrians. Over 100 summonses were issued and 27 vehicles were impounded, including one arrest for a stolen recovered vehicle; five individuals had suspended licenses.

NY State's COVID Fiscal Crisis **Could Mean Budget Blues for Yonkers**

NY Governor Andrew Cuomo released his proposed budget for 2021-22, which once again, relies on a Federal bailout, this time of \$15 Billion.

With President Joe Biden now in office, and NY Senator Charles Schumer, now Majority Leader Schumer, another COVID stimulus is planned and includes \$350 Billion for all 50 states and local governments.

The Governor also laid out a "worst case scenario" in which New York State were given only \$6 Billion in Federal funds. Under that scenario, the state budget would have to raise taxes and cut spending by \$9 Billion, including a \$2 Billion cut to education funding.

The Yonkers Public Schools are heavily reliant on State Education Fuding, and State Senator Shelley Mayer, from Yonkers and who is also the Senate Education Chair, said "we cannot balance a budget at the expense of our public schools."

Sen. Mayer's entire statement reads, Thank you to Governor Andrew Cuomo for his continued advocacy for New Yorkers. With so much uncertainty about federal aid for New York State, one thing is clear: our children cannot continue to bear the burden of the pandemic's economic impact. This past year, we have seen incredible sacrifice from students, parents, teachers, and administrators. We cannot balance a budget at the expense of our public schools. We should commit to increasing education funding by sharing the burden equitably with those who can afford it. We must also fortify other essential programs and services necessary for educational quality and equity. I look forward to working with my colleagues and the Governor's Office to find a path forward that recognizes the acute need for additional school funding-and does not rely on supplanting the state's obligation with the aid appropriated from the federal government to New York. Additionally, we must build back stronger from the scourge of the pandemic. The reconciliation of the COVID crisis must include the expansion of full day Pre-K for districts outside of New York City; free broadband for every student across the state; and ensure adequate resources for compensatory education initiatives to help students meet learning benchmarks, particularly for students with special needs."

"New York State is rapidly expanding our networks and capabilities to get as many New Yorkers vaccinated as fast as our supply allows," Governor Cuomo said. "The new vaccine sites across the State will expedite our distribution to get our most vulnerable New Yorkers vaccinated efficiently. Our greatest hindrance continues to be federal inaction. We have come too far to be held back in our efforts by the inadequate vaccine supply from the federal government. I encourage New Yorkers to be patient throughout this process and urge our federal government to increase the supply to states."



That action drew a harsh response from President Joe Biden's Covid Advisory Board member Dr. Celine Gounder "I think Governor Cuomo, himself, had said back in the spring that the situation around ventilators was essentially 'one big Ebay' with all of the states bidding against one another for ventilators, and I think this kind of an approach to vaccine allocation is going to result, frankly, in the same kind of situation that he, himself, was criticizing last spring," Gounder said.





On This Day in Yonkers History...



Yonkers resident Charles Steinmetz, the greatest electrical engineer of his time

January 25, 1937: Although strikers were warned they would be forcibly ejected, one lone striker resumed his post in the Federal Music Project office in the Sears, Roebuck building.

January 25, 1945: Yonkers learned the appreciation of local soldiers for a little reminder of home. Although many, many miles away, 1st Lieutenant Frank Cotter of Pondfield Road West broke out in a broad smile when he opened his K rations. Inside, a lump of sugar was wrapped in a paper bearing the name of a Pondfield Road West restaurant! Cotter, attached to the Army Amphibious Forces, wrote to his mom, that it was "a small world after all."

Tuesday, January 26th

January 26, 1916: The Flagg Building in Getty Square, touted as Yonkers most modern office building, held its grand opening.

January 26, 1936: Three Leake and Watts boys, Robert Twiford, William Pinkus and John Smith, rescued twelve-year old Tom Kavanagh who was caught on an ice floe and in danger of being carried downstream in the swift current of the Hudson River. The quick-thinking boys rescued Tom using a ladder. Twiford was a local basketball star and went on to Syracuse University to play; Coach Lew Andreas considered him to be one of the team's best offensive players

Wednesday, January 27th

January 27, 1943: Lieutenant Colonel Egbert White of Plymouth Avenue was featured in the New York Sun. While patrolling with American Forces in North Africa, the Yonkers man was caught in crossfire. White escaped by crawling across the desert on his stomach to a ditch and what he thought was safety. Just as he got there, the Italians began firing mortars. When the mortars stopped, he headed downhill to safety, machine gun fire ringing all around him. The company dispatch the next day stated, "... only one routine patrol activity on the Tunisian front." When Colonel White read the communiqué, his immediate reaction was, "Routine? Hell!" A WWI veteran, White established Yank Magazine a month after Pearl Harbor, accepting a commission as lieutenant colonel. General Osborn removed him from the Yank Staff in 1942 and ordered him overseas to create the North African/Mediterranean edition of Stars and Strips newspaper from its beginning in December 1942. He was sent home mid-1944; he wanted to run American newspaper article about the Presidential campaign, something army command "forbade."

January 29, 1943: Thousands of Alexander Smith & Sons Carpet factory workers rallied to pledge to meet the challenge "to work as hard for our boys on fronts all over the world" levied by visiting Army and Navy officers visiting the plant. The military officers viewed the workers making duck, blankets and other equipment for war.

events. Mom would turn to the sports section not to find out the scores from the previous nights Mets, Yankees, Jets or Giants games but to find out the bowling league scores as she had some friends who bowled and she took great pride on posting their accomplishments on our refrigerator,

Great columnists, Eileen Campion, Jennie Tritten and Gwen Hall to name a few. Dave Hartley, a 'Yonkers boy' served as the editor of the paper for so many years. He knew the history of Yonkers. If the Editorial on the Editorial Page had a Yonkers spin on it or information on historical Yonkers within, you knew that of the members of the Editorial Board Dave Hartley had written it.

Will David, the crime reporter kept you abreast of all things criminal in Yonkers. He would produce numerous stories each day on everything from business and home break-ins to who got arrested locally the day before. He was the kind of reporter editors loved. Always walking the courtrooms of Yonkers, gathering local police reports and chock full of police contacts who would provide him with crime news both off and on the record. He would have four, five maybe even more stories in the paper everyday.

I understand that times have to change. The Herald Statesman which itself was the combination of two Yonkers newspapers, The Herald and The Statesman became the Journal News giving the paper a regional flair. Many people stopped reading the paper because they read the Herald Statesman for Yonkers news and complained there were few Yonkers stories in the newly branded paper.

Which brings us to today. Several weeks ago I raised the question to the current Editor of the Journal News, Mary Dolan as to why there was no coverage in the print edition, still sold on newsstands and home delivered of a fire in an apartment building across the street from where I grew up. One person died. I provided her with a list of media outlets that had covered it. I obtained that list by simply using Google to see if there were any stories on the fire.

Her response: 'Thanks for reading. Covered on lohud with story, photos, gallery. Holiday deadlines required preprinting print editions. Lohud is our breaking news platform.'

I wrote back to Ms. Dolan, 'So am I to get the impression that people like my sister Who do not go online should cancel their print subscription if they want breaking news.' Or want to know what occurred yesterday around town?

Four alarm fire in Yonkers last week. The building housed a supermarket, dry

January 29, 1946: The two hundred-fortieth and final issue of the Yonkers Home News was published. Sponsored by the Alexander Smith Memorial Foundation, it was a digest of what happened in Yonkers and mailed free to every Yonkers resident in the Armed Forces, no matter where in the world he or she was serving. The first issue was published June 17, 1941, several months before Pearl Harbor; the paper was instrumental in keeping our fighting men and women in touch with their hometown, to let them know Yonkers had not forgotten about them.

Saturday, January 30th

January 30, 1932: New Yonkers resident Jerry Elario of Halstead Avenue, owner of a Second Avenue speakeasy, was shot early in the morning at McLean Avenue and McCollum Place. Shortly after leaving his "restaurant," he realized a small coupe was following him. After being forced to the curb, he ducked behind the steering while his enemies shot three bullets into his car; one struck his left arm above the elbow and embedded behind his shoulder blade.

January 30, 1932: The President Roosevelt, one of the great passenger ships of the United States Lines, was seriously damaged when it was rammed in severe fog off New York by the Roma, an Italian deluxe ocean liner. Captained by Yonkers own hero captain George Fried, the Roosevelt was anchored and sustained damaged above the water line, damage serious enough to necessitate it to head back to port for repairs. The Coast Guard sent cutters from Staten Island to assist the two ships.

Sunday, January 31st

January 31, 1906: Samuel Untermyer of Greystone, added two dogs of "unusual merit" to his kennel of high-class collies. Untermyer purchase the collies from Mr. Ainscough, one of the best-known dog-fanciers in Great Britain. He announced he would enter them in the coming show of the Westminster Kennel Club held in Madison Square Garden.

January 31, 1919: Nationally known baseball umpire William J. Klem of 610 South Broadway, declared in an interview it was only a matter of time until baseball would become "America's national game and the world's favorite sport."

Later a member of the Baseball Hall of Fame, Klem had an uncanny eye for calling balls and strikes and was known as the "Old Arbitrator."

And the words in Ms. Dolan's email 'Holiday Deadlines required preprinting editions.' What does that mean? The local newspaper will have no local news in it if it falls on a holiday?

Sad. Tells you the sad state of affairs of daily newspapers in 2021. Question what the purpose is in buying a print edition of the Journal News. The paper doesn't cost 25 cents anymore either. Maybe the answer is to stop selling print editions of local papers. What purpose do they serve with so many online resources?

One only hopes that after the pandemic pray god comes to an end and local events start happening the weekend section of the Journal News will list local happenings around town. Not that it did such a great job before the pandemic.

various provisions of the Election Law in order to allow for expedited review and canvassing of absentee ballots without compromising the integrity of elections.

• Preventing Disenfranchisement of Absentee Voters: This bill, S.253, sponsored by Senate Elections Committee Chair, Senator Zellnor Myrie, prohibits voiding absentee ballots on technicalities where intent of voters is clear and the law has been substantially complied with, including where there are stray marks or the ballot is undated but is time stamped by the Board of Elections.

• Permanently Authorizing Absentee Ballot Drop Boxes: This bill, S.492, sponsored by Senator Brad Hoylman, authorizes the Board of Elections to establish absentee ballot drop-off locations or drop-boxes to provide voters with a convenient and secure option for delivering their absentee ballots.

Increasing Transparency and Information about Absentee Ballots through a Tracking System: This bill, S.1028, sponsored by Senator Leroy Comrie, ensures that all voters in the state have access to absentee ballot tracking by requiring the New York State Board of Elections to create a statewide absentee ballot tracking system for absentee voters ensure that their vote is counted in the election while allowing counties and the New York City Board of Elections to also maintain their own absentee tracking systems.

Implementing Permanent Authorization for Applying for Absentee Ballots Online: This bill, S.632, sponsored by Senator Robert Jackson, permanently allows voters to apply for absentee ballots online and allows absentee ballots postmarked through Election Day by making permanent Chapter 91 of the Laws of 2020, which sunset on December 31, 2020. Under current Election Law, applications may only be made by mail or fax.

• Creating Accountability for Timely Receipt of Absentee Ballots: This bill, S.516, sponsored by Deputy Majority Leader Michael Gianaris, establishes a mandatory timeframes for processing of absentee ballot applications and ballots by Boards of Elections based on when the application was received.

• Enabling Earlier Applications for Absentee Ballots: This bill, S.631, sponsored by Senator Julia Salazar, permits Boards of Elections to receive absentee ballot applications earlier than thirty days before the applicable Election Day by making permanent Chapter 138 of the Laws of 2020, which sunset on December 31, 2020.

No-Excuse Absentee Voting Constitutional Amendment: This legislation, S.360, sponsored by Senator Leroy Comrie, amends the State Constitution to allow for any voter to vote by absentee without an excuse.

Ensuring Voters Timely Receipt of Absentee Ballots: This bill, S.264, sponsored by Senator Zellnor Myrie, sets deadline for absentee ballot applications sent by mail to 15 days before the election, up from 7 days, to better allow for voters timely receiving their absentee ballots.

Jennifer Wilson, Deputy Director of the League of Women Voters of NYS, said, "The reliance on absentee voting during the COVID-19 pandemic highlighted the need for several important fixes to the state's absentee voting operations. This package of bills will ensure New York State voters have adequate access to apply for, submit, and track their absentee ballot. These procedural fixes will give voters greater peace of mind when electing to vote by absentee ballot in future elections. We applaud the Senate for moving forward this package of bills and hope to see additional reforms related to the timing and transparency in reporting election results to the public." Jarret Berg, Co-Founder of VoteEarlyNY said, "The voting reform package being advanced by the Senate Majority will help modernize New York elections by expanding access, improving administration, and enshrining a series of due process safeguards to better ensure our fundamental rights are protected and respected." Dustin Czarny, Onondaga County Elections Commissioner and Chair Democratic Caucus of the NYS Elections Commissioners Association, said, "These legislative changes will go a long way towards fixing some of the byzantine process we have in New York. Improving our absentee and vote by mail system will not only give voters more options but will give clear direction to Boards of Elections across the state. I am happy to support these bills." Blair Horner, NYPIRG Executive Director, said, "Thanks to the reforms enacted over the past two years, New York has dramatically improved its voter participation rate. When it comes to voting, New York, which was once among the worst, is now getting closer to the middle of the national pack. But New York 's voting rate in 2020 was still below the national average. The package of bills being advanced this week, particularly the constitutional changes, will, if enacted, move New York closer to the national leader.' Susan Lerner, Executive Director of Common Cause/NY, said, "Common Cause/NY is pleased the New York State Senate is starting session the same way it has the past two years: putting New York voters first. Clearly, today's package is just the beginning. We look forward to working with the Senate and the Assembly to pass even more crucial election reforms, most particularly restoring voting rights for folks recently released, this year."

Crosby, Nolan Step Forward to Run for County Board

Two of Yonkers four seats on the Westchester Board of Legislators will have contested elections in 2021. Dwanita Crosby made her announcement for County Legislator in the 16th District on Martin Luther King Jr. Day.

"Following in the footsteps of Vice -President Kamala Harris, who announced her candidacy in 2019 on MLK Jr. Day, loingtime democrat and community activist Dwanita Crosby announced today that she is running for Westchester County Legislator for District 16."

Crosby introduced herself to Yonkers democrats during a candidates night with Ward and District leaders. Crosby will also attend the Yonkers Democratic Party's virtual convention on January 27.

"Giving back to my community was instilled in me at an early age. After years of working behind the scenes in government, now is the time for me to have a seat at the table and advocate for the people of my city, community, and county.

Crosby, a single mother of a son, has 15 years of experience working in government and in Yonkers City Hall. She also has more than 20 years of experience working with non-profit organizations. She touted her work forming community partnerships between the City of Yonkers and Westchester County, and her supporters have applauded her work with the homeless community in Yonkers and the City's youth population.

Crosby has two Masters Degrees, in Public Management and Leadership, and a Dual Degree in Human Resource Managment/ Management and Operation and Bachelors of Science in Psychology. She is contining her Doctoral degree in Public Managment.

She will officially launch her campaign this weekend, and if elected, would be the youngest African-American woman to serve on the County Board..

Crosby's opponent will be County Legislator Christopher Johnson, who has served for four years on the county board and six years prior to that on the Yonkers City Council. This will make an interesting democratic primary in Yonkers on June 22, where City Councilwoman Shanae Williams is already challenging Tim Idoni for County Clerk.

Another contested County Legislative race in Yonkers this year will be in the 15th District, which includes East Yonkers and Bronxville. Incumbent Democratic Legislator Ruth Walter will face a republican opponent this fall.

Who that opponent will be is unclear. Community activist James Nolan, is one republican who will also shortly that he will run for this seat. Nolan, a republican, has served Yonkers and Westchester in many different vounteerservice capacities through the Michael Nolan foundation, named after his brother, who was shot and killed in Yonkers in 2015. This would be his first run for office.

Yonkers Council Minority Leader Mike Breen will not be running against Walter. Breen told Yonkers Rising that "after serious consideration, I have decided to stay on the city council and serve the people of Yonkers. Now more than ever, bi-partisanship is needed and I want to continue the work we have accomplished."

Breen, in our view, would have given Walter her toughest challenge, but the campaign has just started, and there are other republicans interested in, and considering to run against Walter, who defeated republican Gordon Burrows in 2019, is completing her first term on the county board.

Democrats currently hold a 16-1 Super, Duper Majority on the County Board, with legislator Margaret Cunzio a conservative. There are few if any other County Board contests where republican stand a chance. "The disrict 15 race is the republican's Alamo this year," said one political analyst.

The other problem for republican candidates this year is that Democrats have George Latimer on the top of their ticket in November, while republicans currently don't have a candidate at this point. President Donald Trump has cast a dark cloud over the Westchester GOP, and the recent attacks on the Capitol have made that cloud even darker. Remember that last year, the Republican candidate for District Attorney, in the middle of a countywide election, quit.

In addition to his leadership as a "wartime consigliere" during COVID, Latimer has other notable achievements to present to the voters of Westchester. The most notable is passing two county budgets that DO NOT raise property taxes, including a 2021 budget that has a 0% tax increase after lower reveunes from 2020-COVID.

Latimer promised not to raise property taxes if the sales tax were increased two years ago. He could have gone back on that promise because of COVID, but he kept his word, and in doing so, has taken away the republicans best argument, that democrats can't control spending and will raise your taxes.

Latimer just did the opposite; county spending is down in the 2021 budget from 2020 and county property taxes will not be raised. He has taken the "Astorino' argument about property taxes off the table.

And by the way, Astorino lost his State Senate race, which was the last hope for many Westchester republicans to hold onto any viability for the GOP. I found only one political consultant in Westchester who thought that Latimer was beatable, or at least deserved an opponent. But he couldn't give me a name.

Editor's Note: We did exchange emails with Dan Branda, who told us that "to my knowledge, nobody has stated an intention to run on the republican side."

The gap in graduation rates between males and females continued to shrink, for 2020, the female to male gap is 1.5% percentage points as compared to an 8.2% percentage point gap in 2019. The dropout rate for Yonkers students remains at 3% for all students as compared to the State rate of 5%

Yonkers English Language Learners dropout rate is 9% significantly lower than the State's 25%, New York City's 23%, Buffalo's 30%, Rochester's 30% and Syracuse's 23%

Yonkers Students with Disabilities dropout rate is 5% lower than the State's 8%, New York City's 8%, Buffalo's 15%, Rochester's 20% and Syracuse's 13% Achievement outcomes for Yonkers students receiving Regents diplomas under the NYSED waivers for 2020 was an indication of the Class of 2020's preparedness 80% of the graduates did not require any Regents waivers because the students met their Regents exams requirements before March 2020.

89% of all students earned Regents Diplomas (69%) and Regents with Advanced Designation (20%)

"Once again, Yonkers Public Schools continue to excel and beat all odds, especially this year as we all face the most challenging of times, coupled with chronic underfunding by the State," said Yonkers Mayor Mike Spano. "Over the last nine years, the graduation rate has increased over 18% -- outperforming the State's and Big 5 city schools' rates. Congratulations to the dedicated Yonkers Board of Trustees, our talented Superintendent and the administration staff and teachers who commit themselves each day to the successes of our schools and who work tirelessly to ensure our students reach their fullest potential."

As Yonkers Rising celebrates the hard work of the Class of 2020, and all Yonkers High School students, next week we will turn to COVID related challengess that all school disricts, including Yonkers are facing. Noted Civil Rights attorney Michael Sussman, has penned another letter to the school district, concerning "disparities in learning and a lack of smooth transition to online learning," Questions have been raised again by parents and education groups in Yonkers concerning how many students do not have a device to learn from home with, and how many students are using their cell phones to check in for attendance but little else.

Finally, parents are also concerned with the number of substitute teachers being used in the district because of the many teachers that will not go to school to teach because of COVID fears. Some parents have called for those teachers who have taken days off to be allowed to teach from home because substitute teachers are unable to teach through Zoom or even when everyone is in the classroom.
