

Westchester is Making Progress with COVID Vaccinations

There is good news in the fight against COVID-19, and the efforts of both our health care officials and are local elected officials to set up and deliver the vaccine to county residents.

WMCHealth has taken the lead for Westchester, and the Hudson Valley to ensure the safe, equitable and efficient distribution of the COVID-19. Working with a broad group of nearly 320 hospitals, healthcare organizations and agencies, community organizations and many other stakeholders, WMCHealth is supporting the historical allocation of more than 169,000 COVID-19 vaccination doses across the region to date, including directly administering more than 55,000 vaccinations at WMCHealth campuses and the Westchester County Center Mass Vaccination Center.

"WMCHealth has managed vaccine redistribution across the Hudson Valley, in collaboration with Governor Cuomo's Vaccine Distribution and Implementation Task Force, the State Department of Health and local governments and our healthcare and community partners," said Josh Ratner, WMCHealth Executive Vice President, and Hub Lead.

Ratner said that now more than 160 pharmacies have joined the Hub's Provider Task Force, which now totals more than 210 members. Several Walgreens Pharmacies in Westchester are starting to receive and distribute the vaccine

Earlier this month, WMCHealth joined New York State and Westchester County in spearheading the operation of the Westchester County Center in White Plains as one of the first of 20 Mass Vaccine Distribution sites in New York, and is currently administering more than 2,000 vaccinations per day.

This week, Governor Andrew Cuomo announced 35 community-based pop-up vaccination sites coming online this week at churches, community

Good News for Westchester Homeowners: Rep. Jones Sponsors SALT Cap Repeal

Westchester Congressman Mondaire Jones, who represents northern Westchester and Rockland County in the 17th District, is an original cosponsor of the SALT Deductibility Act, which would remove cap on State and Local Tax Deduction instituted by Donald Trump and the republican congress in 2017 as part of a larger tax cut plan.

The State and Local Tax Deduction limits the amount of property taxes and state income taxes that Westchester residents and homeowners can deduct on their federal income taxes to \$10,000 total. Congressman Jones in introduced the bill with Long Island Congressman Tom Suozzi and Senate Majority Leader Chuck Schumer.

Residents of New York's 17th Congressional District pay the highest property taxes of any Congressional District in the country. The average property tax bill in NY-17 is \$11,389. 45% of individuals (roughly 330,000 people) in NY-17 use the SALT deduction. The average deduction taken in NY-17 prior to the cap was \$26,243.

"Donald Trump cut taxes for billionaires and big corporations and paid for it on the backs of hardworking families in Westchester and Rockland Counties, where we pay the highest property taxes in the entire nation," said Rep. Jones. "That must change. Restoring the SALT deduction is a necessary first step to creating an equitable tax system – one where we put money back in the pockets of working people."

The SALT Deductibility Act would remove the cap on the SALT deduction instituted in 2017 as part of Donald Trump's Tax Cuts and Jobs Act. It would allow New Yorkers to fully deduct their state and local taxes from their federal taxes.

Westchester County homeowners pay the highest propert taxes in the

The decision by the Yorktown Democratic Party not to run a candidate for Town Supervisor shows that the GOP in the northern Westchester community remains strong, and the current Supervisor, republican Matt Slater, is doing a good job.

Former democratic Supervisor Lanny Gilbert, who narrowly lost his re-election to Slater in 2009, will be running for Town Board in 2021. "A loving father of 5 and a 29-year resident of Yorktown, Lanny Gilbert currently serves as Administrative Law Judge for the Health Department of Westchester County and is on the NYS Board of Commissioners for the New York State Bridge Authority. He brings a long history of public service and professional experience to the Town Board, having served for two years as Yorktown Town Supervisor and five years as Yorktown Town Justice and serving 36 years as a Principal Court Attorney for the NYS Unified Court System. Lanny was recognized and commended for his long service by both the Westchester County Board of Legislators and the Bronx Supreme Court. Former Mt. Vernon Mayor Richard Thomas Attempts a Comeback

Americans love a comeback, but every great comeback starts with a setback. Tiger Woods, Bill Clinton and Apple Computers all have had successful comebacks of sorts. And we love it even more when an underdog succeeds in their comeback.

For former Mt. Vernon Mayor Richard Thomas, that setback happened in 2019, when he was force to resign his position for campaign finance violations and spending on personal items. Now two years later, the former Mayor hopes to make a political comeback by running for Mt. Vernon Comptroller in a democratic primary.

The current Comptroller, Deborah Reynolds, is involved in a scandal for a lack of cooperation with the Mayor and City Council for a laundry list of allegations, violations and withholding of financial data that has resulted in Mayor Shawyn Patterson-Howard asking for both the Westchester DA and the State Attorney General to intervene and investigate.

Thomas, 38, faces several obstacles to make his comeback.

I-First, most comebacks start with a Mea cupla. Bill Clinton appeared with Hillary on 60 Minutes and confessed (sort of) his marital infidelities. Tiger Woods did the same.

While Thomas admits to clerical errors in how he spent campaign funds, he also asserts that the criminal charges against him were part of a large political conspiracy, and claims that his democratic primary election loss, also in 2019, was based on voter suppression and voting irregularities, similar to those alleged by former President Trump.

in 2019, was based on voter suppression and voting irregularities, similar to those alleged by former President Trump. Thomas was arrested in 2018 and charged by then NY Attorney General Eric Schneiderman with felony grand larceny. He pled guilty to misdemeanor charges of misappropriating \$13,000 from his campaign committee and for taking \$2,500 in campaign funds improperly as a reimbursement. A \$2,000 Channel purse for his wife was one expense that shocked the community. He was also accused of using his inauguration committee as a slush fund or sorts, to the tune of \$83,000 in unreported donations.

We agree with Thomas on one thing: politicians are rarely, if ever, charged or convicted for campaign finance violations and he was never given the chance to make amendments or corrections before his arrest.

Part of his guilty plea was the agreement that he would not run for office for one year. That one year has expired and Thomas is running for Mt. Vernon Comptroller.

II-Thomas will receive little support from the Mt. Vernon Democratic Party, but that hasn't stopped him before. Chief Westchester Democrat Reginald LaFayette has put the kibash of Thomas receiving the endorsement of the party to run for Comptroller. But in 2015, Thomas won the democratic primary for Mayor against the same party establishment, and even today, he enjoys support from democrats outside of the party leadership. Some members of the Mt. Vernon Democratic party have considered expelling Thomas from the party and from running in a democratic primary for any office in the City.

The Hudson Oven: A Cabinet of Sourdough Loaves Coming to You



A visit to Hastings from The Hudson Oven

We are grateful to local businesses that are surviving through the pandemic,. A friend our ours on Facebook shared this great feel good story about a mysterious cabinet that travels around Westchester with great Sourdough bread.

The company is the Hudson Oven, (thehudsonoven.com). "Each batch is unique. The Hudson Oven is here to offer you the sourdough bread that your hometown was meant to have. Currently we are trying to develop a steady client base that is willing to pick up their fresh sourdough once a week. The pickup location is always changing, so Subscribe to stay up to date on when and where to pick up your bread! The flour we use is grown and milled organically by Farmer Ground Flour near Ithaca New York," writes the company on their website.

Recently, the cabinet has been found in Hastings, Peekskill and Ossining in Westchester. For some, finding out where the cabinet is this week makes it a scavenger hunt of sorts. "Awesome bread hunting experience for the whole family! One never knows where The Hudson Oven will take you to explore and seek out the "bread shed". It's like geo-cashing for amazing fresh baked sourdough bread!!" wrote one family in a Facebook review.

Here's how it works. The Hudson Oven is looking for weekly subscribers who want to know where the Sourdough express will be next. Every Sunday an email comes out from Hudson Over owner Chase Harnett of Ossining around 10am. Sign up is free.

"No loaves are spoken for. It's first come first serve. Currently we have Just one roaming cabinet. I am prepping to launch a subscription model with multiple cabinets in towns all over the Hudson valley. But there will always be one roaming unit," Harnett told us.

And the payment system is based on the honor code, with the sign reading "Leave what you think its worth to support the next bake," and a box to drop in on average \$6, although Chase said he would like to see \$8-\$10 per but doesn't set a price. Most pay cash but Venmo is also accepted. "Dough for Dough," as he likes to call it.

One problem, The Hudson Oven Sunday fun-great bread event has gotten so popular, (more than 2,000 email subscribers and 3,000 instagram followers) that once the email goes out from Harnett on Sunday morning, you usually have about three hours max. to get to the location before all of the 80 loaves are gone.

"Made my Sunday when we came across this gem at Peekskill waterfront. Please think of something fun for Xmas we all need a little Hudson oven in our lives right this very minute Love the bread!" said another reviewer.

I was trying to arrange a shot for a relative and learned the next day that all the slots were filled up at the Nodine Hill pop-up. So much for that. But the mystery still lingers as to how the people scheduled for the Covid shot got on the list. Where were these people coming from? Food Delivery Fees-Charges Under



In Yonkers, Council President Mike Khader has proposed a local law creating a new chapter of City Code conerning third party delivery services. A draft of the law states, "The City Council seeks to protect and promote

the small businesses and restaurants in the City of Yonkers. Delivery service providers have been charging very large fees to the small business and restaurants.

§ 32-2 Cap on Delivery Third Party Services. It shall be unlawful for a third-party delivery service to charge a food establishment or its customer a delivery fee or any other surcharge of more than 10%.

Many restaurants and take out establishments have been complaining for some time about the large delivery fee forced upon them.

"Did you know that when you order from Grubhub or Uber Eats they take 30% from the restaurant you are ordering from? Yes, 30%! So many of the local restaurants in Westchester & NYC work on 30% margins and less in many cases.

"These companies also tie the hands of your favorite restaurant. If a restaurant works with Grubhub or UberEats they MUST (according to a contract) offer all specials to both the in-house customer and the app customer. This means that technically, a restaurant can't provide a FREE appetizer to a frequent customer or a discounted price to someone who dines with them several times per week unless that SAME offer is made on Grubhub and UberEats to everyone.

'These two companies are spending millions of dollars in advertising to make you think they are helping local restaurants during the COVID-19 shutdown, all while they are just taking advantage of an unprecedented time in our history," wrote one unhappy restrauant owner. Take a look at your food delivery bill the next time to see how much you

are being charged.



Holocaust Remembrace Day Never Forgotten in Westchester

January 27 was Holocaust Remembrance Day, and 76 years after the liberation of Auschwitz, #WeRemember the millions of lives lost in the Holocaust and recommit to fighting hate and intolerance everywhere. We remember, with respect, the victims of the Holocaust and take the time to reflect on the depths that humanity can sink to, but also the ways that individuals and communities resisted that darkness, before, during, and after this tragedy.

Yonkers' resident and Holocaust survivor Betty Migdol, who was recognized by City Council President Mike Khader and the entire City Council in 2018, shared her story once again, with the Council President and his staff.

After the Holocaust, I was left without parents, a home, or any money. I didn't know what I was going to do. Then my cousins, who also survived, said to me that the Americans were setting up Displaced Persons Camps in Germany and they are going to it. I asked if they would take me too and they did. They supported me both emotionally and financially until we got to the Americans. Here I am in the picture of us in the DP camp. Today I have 2 daughters, 5 grandchildren, and 6 great-grandchildren. I went through an unthinkable period in my life and came out stronger than anyone should have to be. Now I'm blessed to have a beautiful family and a great life here in Yonkers."

Betty Migdol has been a Yonkers resident since 1970. Migdol was born Dec. 19,1927, the third of six children, to a religious and poor family in Ruscova, Romania, a small town in the Carpathian Mountains. In 1944, when she was 16, the Hungarians who had moved into her town rounded up all the Jews and sent them first to a ghetto and then on transport trains to the Auschwitz death camp. After six months at Auschwitz, she was sent to a slave labor camp.

When the war ended in 1945, Migdol fled from the Russian soldiers

In 1947, she was able to cross the Atlantic Ocean to come to New York, where her new life began. A few weeks later she met Harry Migdol and they married in 1949, had two daughters, and owned a business. Incredibly, she put the horrors of her teenage years behind her, and kept her love for the Jewish religion. Migdol has long been a member and supporter of Chabad of Yonkers.

"We have learned so much from Betty and continue to learn from her strong and deep respect that she has for Judaism," said Rabbi Mendy Huwitz of the Greyston Jewish Center Chabad of Yonkers. "As Betty continues to be a proud, strong Jew, we want to give this opportunity to every Jew – no matter of their level of observance – that they, too, can be victorious over the Holocaust."

LM Lions & Sedona Team to Support CRC Eviction Protection

The Larchmont Mamaroneck Lions joined with Mamaroneck's Sedona Tap House Monday's Dine Out for Charity to raise funds for the Community Resource Center's (CRC) eviction relief program

During the current Coronavirus Rent Moratorium, the CRC has been working with our communities at risk households to keep them in their homes. They identify those in need, and through partnerships provide legal counseling, negotiations with the landlords and funding direct negotiated payments to the landlords.

Every month on every Monday, Sedona donates \$2 per steak meal to a local service group or project. To encourage support at both lunch and dinner, they offer their \$18 steak meal for only \$10. The LM Lions & Sedona teamed up in January to support the CRC's eviction protection effort. The Lions agreed to match Sedona's donation, which was \$610 (305 meals served). Individual Lions have made separate donations to increase the Lions total to \$1000. Checks totaling \$1610 were presented to CRC director Jirandy Martinez.

Monday's in February, Sedona is supporting the STEM alliance Robotics program. In March Sedona & the Lions will again team in support of the Fuller Center, which builds & remodels homes to be owned by those in need. They also respond to local emergencies with food, clothing, and supplies appropriate to the need.


