Heart Health and Your Diet, During COVID

February is American Heart Month and cardiologists from the Mount Sinai Health System are sharing tips on heart disease prevention to lower the risk of heart attack, stroke, and COVID-19.

According to the American Heart Association, about one in three people with COVID-19 has cardiovascular disease, making it the most common underlying health condition. COVID-19 patients with underlying conditions are six times more likely to be hospitalized and 12 times more likely to die than patients without any chronic health problems. Nearly half of adults in the United States—more than 121 million people—have some type of cardiovascular disease. It is the leading cause of death among men and women in the United States; nearly 650,000 die from it every year. Yet heart disease is preventable 80 percent of the time.

Alon Gitig, MD, Director of Cardiology at Mount Sinai Doctors-Scarsdale and Mount Sinai Doctors-Yonkers, has agreed to share with our readers his thoughts on how to maintain a healthy heart during COVID.

This week Dr. Gitig discusses the relationship between your diet and the heart. "There are lots of fad diets out there, and many that claim that there diet will lower your risk of heart disease by lowering your weight quickly. But these studies and diets are plagued with problems because its difficult to monitory a persons diet for a long period of time and people's recall of what they eat is unpredictable.

'So the studies are all over the map, one may say that eating eggs are good for your heart health, while another says that eggs are bad. But that

My father, Mr. Dennis Richmond, Sr. came of age during the 1970s. In 1973, when my father was 18 years old, the United States president was Richard Nixon. American prisoners of war are released from Vietnam that same year. My dad told me plenty of stories about his adolescence. He remembers meeting The Godfather of Soul, James Brown, in California. There's one movement that my dad witnessed as a young man that entrances me. That movement is the iconic Black Power Movement.

Perhaps the most recognizable Black Power concept today is the powerful cultural expression of the 1960s and 1970s. People held their fists in the air as a sign of Black Power. People wore their natural hair as a sign of Black Power. People even attended HBCUs as a sign of Black Power. People followed ideologies from The Honorable Elijah Muhammad, Malcolm X, Rev. Martin Luther King, Jr., and The Black Panther Party's Huey P. Newton and Bobby Seale. With all the fashion statements, natural hair, and cultural leaders of the 1970s, I had to ask myself, "What does Black Power look like in 2021?" To answer this question, I had conversations with young adults from across the country.

Mt. Vernon Mayor Calls on NY AG & DA **Rocah to Investigate City's Finances**

Mt. Vernon Mayor Shawyn Patterson-Howard has called on State Attorney General Letitia James, and Westchester District Attorney Mimi Rocah to "investigate the city's finances."

The pleas for help come after the City faces a late budget, a budget hole, and has no idea how much money is in the City's bank accounts or fund balance. Mayor Patterson-Howard may have no choice but to make cuts to City services and employees AND raise property taxes, but she has been stymied at finding out about the true financial health of the city by Comptroller Deborah Reynolds.

In another drastic move which shows how dire the situation is, the Mayor has also called on the City Council to call for an Emergency Financial Control Board to come into Mount Vernon and take over the financial

duties of the City.

"This letter serves as a request to City council to enact legislation in the support of the New York State Legislature to advance the request for an Emergency Financial Control Board for the City of Mount Vernon. to assist with the financial duties of the City of Mount Vernon. This request does not come lightly, but as the Mayor, I've witnessed the dereliction of duty and gross fiscal malfeasance by our current Comptroller and have grave concerns about the financial state of our city.

"Financial Control Boards are not a new idea and currently there are several communities, including Yonkers, who have utilized them in the past. We can not afford to sit idly by while the financial status of our city remains in mystery while thousands of residents and our city workforce suffer from the inability of one person within our government. While this restricts Mount Vernon's fiscal sovereignty, we are in a dire situation that requires immediate intervention. Mount Vernon has reached the financial cliff, without a full investigation into the obstruction and negligent actions of the Comptroller, Mount Vernon will face some difficult decisions in our immediate and near future that will have irreparable harm on our public health

and safety," writes Mayor Patterson-Howard.

Eric DiBartolo is a longtime resident of Yorktown, my hometown. He graduated from Yorktown High School and stayed in town, rising to become the Highway Superintendent, from (1995-2013) head of the volunteer fire department and frequently seen on News 12 when a snowstorm would be coming.

DiBartolo also served as the President of the Yorktown Chamber of Commerce, and was a powerful member of the Yorktown Republican party. To say that DiBartolo was a prominent and respected member of Yorktown would be an understatement... until last week, when he was ar-

rested for a petty scheme to steal \$15,000 worth of building supplies from Home Depot. DiBartolo, who many believe is a millionaire based on his large salary for years as Highway Superintendent, his pension, and his other business ventures over the years including a local funeral home, was arrested on

Jan. 6, but the news of this did not come out until late January. He was arrested by Westchester Police because the crimes occured at the Home Depot in Cortlandt Manor. He faces charges which could put him in jail, the most serious of which are four counts of felony grand larceny, and 19 misdemeanor counts of petit larceny.

Published reports have police stating that DiBartolo worked with a

On Groundhog Day, February 2, 2021, standing inside the Activity Barn and out of the snow at Alfred B. DelBello Muscoot Farm, Curator Jonathon Benjamin lifted Cluxatawney Henrietta out of her coop and found an egg, signaling an early spring.

Benjamin said: "As you know Punxsutawney Phil is a groundhog who has predicted the weather in Pennsylvania for years and years. We don't have a groundhog on the farm, so we use the next best thing – Henrietta, our weather predicting chicken."

This was Alfred B. DelBello Muscoot Farm's third annual egg laying in honor of Groundhog Day. Cluxatawney Henrietta, a 3-year-old Ameraucana Chicken, predicted an early spring in both 2019 and 2020.

Commissioner of Parks, Recreation and Conservation Kathy O'Connor said: "Each year we await Cluxatawney Henrietta's Groundhog Day prediction. Although Winter Storm Orlena makes spring seem far away, we look forward to the days becoming longer and hope you will take some time to explore our many parks."

doesn't mean that all of the studies are useless, and there are large enough studies that show the same strengths and statistics for the reduction of risk of heart disease.

"In general, populations around the world have the lowest risk of heart disease, (heart attack and stroke) and some near 0 that share comment threads of diet. All of these groups have not been inundated with processed foods. American diets have a majority of processed food, and we need to eat more whole foods in their original form.

"Other commonalities of a good diet in people's around the world is that they eat mostly plant based foods. They are eating more vegetables, grains, beans, legumes and fish. They do eat some poultry and meat but in small amounts. The Mediterranean Diet is an example of this type of diet, and can be used in making salads and cooking vegetables in olive oil. The Japanese also eat a low risk diet, with a lot more fish. Sushi is a whole food. When eating rice, brown rice is preferred," said Dr. Gitig, who added that sugar and flour based products should also be avoided or scaled back considerably.

"We all know that sugar is not good for our heart, but what is not commonly known is that flour is also bad for our diet, and is ubiquitous in people's diet in this country. Flour is not a whole food, the grain has been pulverized and the powder that results has lost its nutrient value and creates

a rise in blood sugar."

Dr. Gitig said that all of us should examine our diets after almost one

year at home under COVID. "You have an opportunity while working from home to eat healthy. You can prepare healthy lunches at home. The other way to eat while at home that I see in my patients is to east more sandwiches and make a quick PBJ and snack all day.

"There are two different directions that you can go. But now after almost one year, its important for all of us to give what we are eating some conscious thought. Don't kick the can down the road because we don't know how long we will be at home. It's time to think not only about survival during COVID but that this is my life for now and I need to be concerned about my diet and my health," said Dr. Gitig.

Attorney General Letitia James Report

Died From COVID Than DOH Reflected"

Many of our readers, and New Yorkers, may not know the name Letitia James....until now. James, the Attorney General of New York State, issued a report on Jan 28, which found that "A larger number of nursing home residents died from COVID-19 than DOH data reflected."

In her 76-page report, AG James accused Governor Andrew Cuomo's Department of Health of "undercounting" the number of seniors in nursing homes that died from COVID. Hours after James issued the report, the State revised their number of Nursing Home COVID deaths to 12,743 up 43% from the original number of 8,914, basically admitting to the finding in the James report.

Prior to the change, Cuomo and DOH Commissioner Dr. Howard Zucker have been adamant that the number of New York nursing home residents who have died from COVID has NOT been underreported. The higher number resulted from adding in residents who caught COVID in nursing homes and then went to hospitals where they later died.

Attorney General James' office received more than 950 complaints about Nursing homes last year. The report also lays blame on the 304 nursing homes in New York and their operators. 20 of those NY Nursing homes are now under investigation by the State AG. The report found that operators failed to properly isolate COVID-positive residents; failed to adequately screen or test employees; forced sick staff to continue working and caring for residents; failed to train employees in infection control protocols; and failed to obtain, fit, and train caregivers with PPE.

Cuomo's handling of the nursing home COVID crisis has been widely reported on, most notably a directive on March 25 from the Dep. Of Health requiring nursing homes to accept COVID-19 patients if hospitals didn't have room for them anymore. The result was more than 6,000 positive patients returning to nursing homes between March and May of 2020, which accelerated the spread of COVID to others in nursing home residents.

Gov. Cuomo and Dr. Zucker have always stated that they were following federal guidelines from the CDC, Centers for Disease Control, and that the number of COVID nursing home deaths in other large states have been similar, including: Pennsylvania with 10,287 nursing home deaths (49% of their total deaths), Florida with 9,273 nursing home deaths (35% of their total deaths), Massachusetts with 7,944 nursing home deaths (56% of their total deaths) and New Jersey with 7,733 nursing home deaths (36% of their total deaths).

Many are also analyzing AG James report in the prism of politics. While Cuomo requested the investigation by the AG of the COVID nursing home deaths, many in Albany surprised that the AG would put herself in direct conflict with Gov. Cuomo, who was said to be surprised by the report.

Republicans jumped to blame Cuomo for the deaths. Upstate NY Congresswoman Elise Stefanik said, "This is now more than a nursing home scandal. This is a massive corruption and cover-up scandal."

Democrats wanted more information, and time to review the report. State Senate Majority Leader Andrea Stewart-Cousins said, "The tragic situation in our nursing homes remains a heartbreaking reminder of the toll this pandemic took on this state. Nothing will bring back our loved ones that we lost but it is crucial that information guides our responses so this will not happen again."

NY U.S. Senator Kirsten Gillibrand called for a full investigation of nursing home deaths across the country. Some have wondered why Cuomo and Zucker didn't release the information when it was available, in May 2020. Other New Yorkers are praising AG James for going where the truth lies, no matter what.

Higher Risk, HS Sports Can Return, But Up To Each School District



Will HS Championship Basketball Return to the WP County Center?

Westchester school districts now have the choice to re-open their higher-risk sports, football, wrestling, ice hockey, rugby, basketball, contact lacrosse, volleyball, martial arts, and competitive cheer/dance, on Feb 1, after six hudson valley County Executive's including Westchester County Executive George Latimer approved the decision. On Jan 22, the New York State Department of Education giving the option to local school districts.

Westchester County Executive Latimer said, "Since early March Westchester County has grappled with the realities of COVID-19. While the bodily threats of the virus are clearly documented – the mental impacts of COVID-19 are also equally devastating. Children in particular have suffered significant mental harms due to the isolation of not being in school consistently, not socializing with friends and family, and not partaking in extracurricular actives. We know there is not a quick fix, but we also know that science has shown us, time and time again, that certain actives can resume with proper precautions put in place. Today, I stand with my fellow Hudson Valley County Executives in support of sports resuming in schools. To be clear, there will be protective protocols in place, and these additional precautions are to protect the athletes. But, I am in favor of providing our children with some normalcy so that they can begin to heal from this horrific pandemic. The resumption of sports will be important for the continued development and mental well-being of our young people – we must never forget them in the decisions we make."

County Executives from the seven counties of the Hudson Valley issued the following joint statement, "The Hudson Valley region has reviewed the updated "Interim Guidance for Sports and Recreation during the COVID-19 Public Health Emergency," dated January 22, 2021 published by New York State. Following discussion with the New York State Association of County Health Officials, regional County Executives, and area public health officials, the Hudson Valley region will authorize "Higher-Risk" sports — both scholastic and non-scholastic — to proceed, effective February 1st, 2021, at the sole discretion of the governing school district or non-scholastic athletic organiza-

"These activities include, but are not limited to, football, wrestling, ice hockey, rugby, basketball, contact lacrosse, volleyball, martial arts, and competitive cheer/dance. In accordance with the state guidance, county health departments in the region will also monitor whether there has been a more-transmissible variant of COVID-19 identified in the area, as well as the percent of local residents that test positive.

"School districts and non-scholastic organizations that will be organizing sporting activities are responsible for oversight and compliance with all published state guidance, including relevant safety protocols. All requirements outlined must be followed by sports teams, recreation activities, and facilities where games and practices are held. League staff, school athletic directors, sports facility directors, coaches, and parents are strongly encouraged to review this guidance and take steps to make sure current team and league operations align with this updated guidance."

Songbook.

My parents both died very young. Dad was 59 and mom was 65. Dad died of a heart attack and mom had been ill for several years. I am sad that they died so young but grateful that neither of them had Alzheimer's. Mom was in a coma 2 days before she died, I knew I would not see her the next day as I was a cohost at the Will Library of a program featuring Mayor Koch. I held her hand and asked her if she knew who I was. She looked at me with that look only my mother could give as to say you idiot, of course I know who you are!

I am grateful neither of my parents had Alzheimer's and sympathize with those of you whose parents, relatives and friends are afflicted with this terrible disease. All we can do is pray and contribute toward Alzheimer's research. So I ask you to pray for our great crooner Tony Bennett and all of the other people who are suffering from Alzheimer's.


New Yorkers Invited to Join Community Schools Advocacy Day: Feb 8, 5-7pm



Harrison Mayor Ron Belmont Won't Seek Re-Election

Harrison Mayor-Supervisor Ron Belmont told the members of the Harrison Republican Party on Jan. 26 that he will not be seeking another term. Belmont, who served for decades at the Harrison Recreation Commissioner, defeated Mayor Joan Walsh in 2011, and has served as Mayor-Supervisor since 2012.

First let us thanks Mayor Belmont for his service to the people of Harrison. His work with so many in the recreation department gave him the experience, and interactions with so many residents and taxpayers to continue his service as Supervisor.

Belmont was a trusted and honest public servant, and he leaves office with the same admiration. The only knock on Belmont was that he had earned a pension and wanted to continue serving. The people of Harrison made the final determination on that and re-elected him five time.

Belmont is one of only three remaining local republican leaders in their Westchester communities, and his departure opens up the possibility that Harrison democrats could take control of Town Hall.

Harrison Councilman Rich Dionisio will be running for Mayor and will have two women running for town council on the ticket, along with Jackie Greer running for Town Clerk and Mike Gigardano running again for receiver of taxes.

Belmont was a registered Independent for a long time before switching to republican, where he led the ticket in Harrison, the Belmont Team for a decade

Democrat Councilman Frank Gordon, who ran against Belmont two years ago, is the leading democrat rumored to be reading to run again.

Belmont's departure from the political stage in Westchester adds to the continued decline and troubles for county republicans, who don't have a candidate for County Executive, had their candidate for DA drop out last year, and don't have 1 member on the County Board of Legislators. The 16-1 supermajority that democrats hold includes Legislator Margaret Cunzio, a conservative.

Eastchester Supervisor Tony Colavita and Yorktown Supervisor Matt Slater are the two remaining Westchester republicans leaders in office.

Alajah Whitehead, Tulleehsa Burbage, and Javonte Spencer were all my interviewees. Spencer, from Blythewood, SC, said that Black Power in 2021 is "influence." He went on to say that "other cultures copy Black culture [and] mostly Black people start everything influential on social media." While Javonte Spencer reminds us that social media plays a significant role in Black Power, Tulleesha Burbage, out of Philadelphia, PA, says Black Power in 2021 is "standing up for someone who can't stand up for themselves." She had done this financially when she paid for a stranger's tab when she was out one day.

Spencer uses social media, Burbage helps people financially and with their well-being, and Alajah Whitehead does both. A Yonkers native, a Mercy College graduate, and my oldest niece, Whitehead, is an essential worker. She works at a hospital in White Plains, NY. To her, Black Power in 2021 is "success." It's "being free to accomplish whatever you want, without people trying to hold you down," she said. Like Tulleesha Burbage, with Alajah Whitehead, Black power isn't just about individualism. Black Power is "being where we want to be in life as a collective," she said.

While the younger generation may have their views on Black Power in 2021, it's my father's view that resonates the most with me. Now, a 65-year-old Bronx resident, my dad reflected on what America saw in 2020. "People of all social-economic backgrounds, sexual orientations, genders, and religious practices came together for peaceful Black Lives Matter protests in 2020," he said. "It's no longer Black Power. It's social unity."



Home Depot clerk to steal goods from the store by having the clerk NOT scan many items, in essence, giving them to DiBartolo for free. The clerk

involved in the scam was also arrested. Tyrone Bass faces similar charges. One example, from Westchester County police spokesman Kieran O'Leary, was when DiBartolo is charged with not paying for \$1,200 worth of merchandise while being billed \$89 for a few items in his cart.

Bass is said to have received a few hundred dollars total for the 23 times that this happened, or the 23 times that Home Depot knows it happened. How many times the two worked the scheme before someboody figured it out is unknown. Both will be charged in Cortlandt Town Court this month.

Another interesting twist to DiBartolo's thefts is that it cost the taxpayers in the Town of Cortlandt, and the Lakeland School district more than \$1,300 in lost sales tax revenues. So all of us in these districts were also taken by DiBartolo, making this reporter wonder what other schemes and scandal are in DiBartolo's long history working for the taxpayers, we don't work for you sir.

Yorktown Supervisor Matt Slater said, "It is always disappointing and disturbing when a public official is accused of wrongdoing. It's now in the hands of the justice system to investigate and determine the outcome."

One of DiBartolo's campaigns for Highway Superintendent was against Stephen Gardner in 2008. Gardner who works in the construction industry called it "hard to believe," that DiBartolo would stoop this low and try to steal from Home Depot 23 times. "It sounds so ridiculous for someone like him to get involved in something so petty," said Gardner, echoing the sentiment of many in Yorktown, who are asking Why Did He

DiBartolo also has a few other "strange occurances" in his history, two of which have been reported and rehashed in the local media.

DiBartolo sued former Yorktown Supervisor Susan Siegel in 2010 for defamation, based on an off handed comment made to only one other person in the Yorktown School District. DiBartolo alleged in court that Siegels comments, (all that she said was that DiBartolo had "a relationship" with the sister of a school district employee that works in the highway department) were allegations that he was having a "sexual relationship' with the same women. No evidence was found that Supervisor Siegel, who was an honorable Town official, had alleged a "sexual relationship."

More legal battles included a laborer in the Highway Department, Kyle Gulitz, accusing DiBartolo of allowing a continuous barrage of anti-Semitic remarks. That case never made it to trial.

And another involving William LaPierre, owner of Clark Funeral Home. DiBartolo worked for Yorktown Funeral Home, a new funeral home in town directly competing with the longtime, well-known and respected Clark.

LaPierre had filed a taxpayer's lawsuit against DiBartolo based on a 2011 State Comptroller's audit which raised concerns about a \$100,000 contract between the Town and a company where two of DiBartolo's brothers worked. That case was withdrawn and never addressed in court.

Yorktown Town Board member Vishnu Patel said, "I think he'll (Di-

Bartolo) be gone once and for all," The other unknown question at this time is, how did Home Depot find

out about this?

In a letter to the Westchester District Attorney Mimi Rocah, the Mayor writes, "The City of Mount Vernon is facing a potential furlough/layoff of critical public safety, civil service and public works employees. For the last year we've documented and highlighted this issue and called on our Comptroller to provide financial information that is mandated by the charter. To this end, the Comptroller has been unwilling to come to the table and present documentation to help with the completion of the 2021 budget. The lack of cooperation from the Comptroller during this entire budget process is troubling. She continues to hide where the money of the City is being held through 39 different bank accounts that she refuses to shed light on, only allowing access to three of those accounts at Chase

"Her actions are a direct threat to the public safety of our community. Additionally, the Comptroller is spending unauthorized money on her personal attorneys outside of the view of the Board of Estimate and City Council, she has installed illegal firewalls to block outside access to the city's internal records using MUNIS, and she has entered into illegal contracts with vendors, all outside the purview of governmental oversight.

"Furthermore, the Comptroller has shown her interference to provide this access to any members of the public and continues to obstruct the day to day governance of our city. I am asking for the Westchester County District Attorney's office to utilize the Public Integrity Bureau to investigate the City of Mount Vernon's finances and to prosecute to the full extent of the law any crimes committed by the Comptroller or employees of the city in regards to corruption, fraud or any other crimes. We do so under the suspicion that our Comptroller has violated the following NY Penal Laws:

Official Misconduct, Obstructing governmental administration in the second degree, Obstructing governmental administration in the first degree, Obstructing firefighting operations, Obstructing emergency medical services, Defrauding the government

In a letter to NYS Attorney General Letitia James, Mayor Patterson-Howard writes, "Mount Vernon is under siege. For more than three years, City Comptroller Deborah Reynolds has operated above the purview of the City of Mount Vernon with impunity. As Mayor, I'm reaching out to formally request direct intervention from the Public Integrity Bureau within ways of the The fate and faters of Mayor Vernon is to take within your office. The fate and future of Mount Vernon is at stake.

"Ms. Reynolds began her abuse of power by sealing off the financial and purchasing system (MUNIS) from the executive and legislative branches with the installation of an illegal firewall in her office, illegally wire transferring money to her personal attorney, and has essentially operated as a rogue agency within City Hall. During the COVID-19 pandemic, she has refused much needed financial resources from HUD that could be allocated for re-opening Mount Vernon and ensuring public safety & health of our residents.

"Instead of operating with the transparency that befits her office, the Comptroller personally accepts, receipts, deposits and reconciles money cloaked in secrecy. For more than 35 months, she has refused to provide any financial reporting to either the legislative branch or executive branch. As a result, our City operates in financial darkness, and is unaware of the financial impact from COVID, nor are we capable of forecasting an accurate financial recovery plan. Frankly, Ms. Reynolds has failed to carry out her duties as an elected official and is instead causing Mount Vernon

"I call on your Public Integrity Bureau to look into the City of Mount Vernon's finances and to prosecute to the full extent of the law any crimes committed by the Comptroller or employees of the city in regard to corruption, fraud or any other crimes."

In both of her letters to AG James and DA Rocah, Mayor Patterson-Howard identified 25 of Reynolds most egregious actions, including:

• Failure to accept tax payments from residents for months. It takes months for these payments to be accepted and processed.

• Failed to accurately budget for health insurance in the prior years, we are now 7.2 million behind in payments to the NYS Health Insurance

 Rejected 4 million dollars in invoices that have been submitted for 2020 that have gone unpaid incurring potential lawsuits for non-payment and hampering the delivery of service.

• Failed to process step increases for CSEA and Teamsters and all of our

unions have been without a contract for 2018, 2019, 2020

• Failed to process transfer taxes, which caused NYS title companies to send a letter threatening to stop doing business in Mount Vernon. This unprecedented action endangers local homeowners, buyers and realtors.

• Failed to accept funds owed and paid to the city. Turning away hundreds of thousands of dollars from revenue generating departments, including parking tickets, a \$482,000 sewer bill in 2019 from the school district and money from PILOTS tax payments (\$183,000) and various departmental

• Failed to transfer nearly 12 million dollars of federal money from HUD

and the URA to the City for critical social needs.

• Failure to disperse millions of dollars of HUD/URA money in a timely manner, nearly 12 million dollars to the City which obstructs the delivery of critical social needs.

• Failed to process school taxes, causing the school district to take over the collection of school taxes and costing the City of Mount Vernon \$600,000+ in revenue.

Mayor Patterson-Howard also outlined the difficult budget that she is trying to pass without having the financial facts before her and the City Council. "We are on the precipice of passing a budget that will eliminate 33 positions that are vacant and layoff an additional 60 personnel at minimum. This initial group of 93 layoffs includes, 30 police officers, 25 firefighters, 19 DPW workers, and administrative staff. We believe we can utilize 8 million in our fund balance reserve, but we can't confirm this with our comptroller and local banks. It would be irresponsible to decide to eliminate critical services, raise taxes at double digit levels and layoff people because we lack financial information to make these decisions. Stop the suffering of Mount Vernon residents from the Comptroller who is incompetent, immature, and displays blatant malfeasance similar to the levels of Donald Trump, a man you stood up to vociferously."

social, physical, and emotional wellbeing and should be authorized whenever possible. However, COVID-19 transmission rates around the state and throughout the Hudson Valley region demonstrate the critical nature of proper safety precautions to limit the continued spread of the virus in our communities. The following must be taken into consideration as school districts and athletic organizations in the Hudson Valley region make their individual determinations on how to proceed:

School districts and non-scholastic organizations that will be organizing sporting activities are responsible for oversight and compliance with all published state guidance, including relevant safety protocols. All requirements outlined in the January 22, 2021 update to the Interim Guidance for Sports and Recreation must be followed by sports teams, recreation activities, and facilities where games and practices are held. League staff, school athletic directors, sports facility directors, coaches, and parents are strongly encouraged to review this guidance and take steps to make sure current team and league operations align with this updated guidance.

Parents, coaches, and athletes should be fully informed and affirmatively consent to the participate in these activities understanding the risk of
