## **Yonkers Organizations Unite To Prevent Parking Garage at JFK Marina**

A consortium of Yonkers community groups has joined forces to prevent a private developer from building a parking garage in JFK Marina, the sole remaining expanse of open public parkland along the Hudson River waterfront in Yonkers. The Marina, with its unimpeded, panoramic views of the Palisades, is considered by many to be one of Yonkers' greatest public assets. The park provides small boat access to the river, lawn at water-level with benches and grass for picnicking, lounging and ball playing, fishing piers, and a pavilion with grills and electricity that is leased for parties and which, before the pandemic, was in demand all summer long.

While the condition of the parkland has been left wanting in the past, recently the City of Yonkers gave the Marina a facelift, reinforcing the shoreline, building new piers and planting grass. "Consuming the Marina with a parking garage for a private development eliminates the possibility that it can ultimately live up to its potential as one of Yonkers's great public spaces,"

says Yonkers resident Elliot Scott.

The parking garage proposed for the Marina is a project of the Lela Goren Group (LGG), the developer planning an adaptive reuse of the long-abandoned Glenwood Power Plant, which abuts the Marina's south end. The footprint for their garage, which LGG asserts is the smallest they can possibly go to satisfy their parking needs, stretches nearly 1,100 feet long, running across a large swath of the Marina.

"Some members of the Yonkers community think the renovation and



### Letter to the Editor, Dan Murphy: Additional Concerns About COVID

I have had some concerning discussions on social media about what happens next as we hopefully move into a post COVID-19 world. This year has been tough on us emotionally and fiscally and you would think that the amazingly rapid response of pharmaceutical companies in providing us a vaccine would make everyone happy. Yet I see good people conflating articles on immunology to drive a narrative about how the onerous Covid protocols should be continued even when we are fully immunized, citing some "chance" that we could "still infect others" despite an ever-growing community with antibodies.

The idea that citizens who have dutifully followed all regulations and then navigated hours of red tape to get vaccinated, that they should want to go into society without a mask is villainized, as dangerous behavior. Even beginning a conversation with the premise that normal life is one without social distancing and masks can upset these individuals shouting on-line. This mindset is all too often reinforced by the media and it gives me pause to think about what the motivation is to be so hesitant to move forward from the pandemic.

It harkens back to a sociological experiment in the early sixties, social psychologist Stanley Milgram researched the effect of authority on obedience. He concluded people obey authority figures either out of fear or out of a desire to appear cooperative--even when acting against their own better judgment and desires. Conclusions from the Milgram experiment can be seen now embodied in shaming of friends and neighbors who want to move ahead with life

In New York we have seen businesses boarded up and people we know out of work and even experiencing food insecurity for the first time. Life is full of pitfalls but a civil society does what is can to ameliorate risk, we travel down a highway at sixty miles an hour with seat belts and a host of safety features so we can get where we need to go. With the corona virus we have been driving in the dark for a year, but our safety measure is here now, a vaccine which like a seat belt cannot be 100% effective, but what in life is?


Even during COVID, there will always be movies that you want to see on a huge screen. It's part of the American culture, and a good date night out.

#### **Off Duty YPD Sergeant Involved** In Fatal Auto Accident



On Monday, February 8th, 2021, at approximately 1:06 PM, members of the Yonkers Police Department responded to the area of Kimball Avenue at Fox Avenue on a report of a motor vehicle accident: an off-duty Yonkers Police Sergeant called 911 to report that she was involved in an accident where a pedestrian was struck. First Responders arrived at scene and immediately rendered medical aid to the 80-year-old male victim; he was transported to a local area trauma center where he later died from his injuries. Police

cordoned-off the area and initiated an investigation.

Detectives from the Major Case Squad, Crime Scene Unit, and Digital Forensics Unit, along with Accident Investigators from the Traffic Unit, responded to the scene to interview subjects and witnesses, recover surveillance video, and reconstruct the accident scene. Preliminary investigation has yielded that the off-duty Sergeant was travelling southbound on Kimball Avenue in her 2005 Toyota Corolla when she struck the elderly male pedestrian who started to cross Kimball Avenue north of Fox Avenue; the off-duty Sergeant remained at scene with the victim until First Responders arrived and is cooperating with investigators.

Detectives are in the process of recovering surveillance video from the area, and Accident Investigators are working to reconstruct the physics of the incident. At this time, no violations or criminal charges have been filed and investigators are continuing to develop information. Additional informa-

tion may be released as it becomes available.

The victim is identified as Albert Farina, a resident of Midland Avenue this City. The City of Yonkers and Yonkers Police Department offers its sincere condolences to his family and friends.


The off-duty Sergeant is a 13-year veteran of the Department and is assigned to the 2nd Precinct, but has yet to be identified.



#### **Good News for Westchester Homeowners:** Rep. Jones Sponsors SALT Cap Repeal

Westchester Congressman Mondaire Jones, who represents northern Westchester and Rockland County in the 17th District, is an original cosponsor of the SALT Deductibility Act, which would remove cap on State and Local Tax Deduction instituted by Donald Trump and the republican congress in 2017 as part of a larger tax cut plan.

The State and Local Tax Deduction limits the amount of property taxes and state income taxes that Westchester residents and homeowners can deduct on their federal income taxes to \$10,000 total. Congressman Jones in introduced the bill with Long Island Congressman Tom Suozzi and Senate Majority Leader Chuck Schumer.

Residents of New York's 17th Congressional District pay the highest property taxes of any Congressional District in the country. The average property tax bill in NY-17 is \$11,389. 45% of individuals (roughly 330,000 people) in NY-17 use the SALT deduction. The average deduction taken in NY-17 prior to the cap was \$26,243

"Donald Trump cut taxes for billionaires and big corporations and paid for it on the backs of hardworking families in Westchester and Rockland Counties, where we pay the highest property taxes in the entire nation," said Rep. Jones. "That must change. Restoring the SALT deduction is a necessary first step to creating an equitable tax system – one where we put

money back in the pockets of working people."

The SALT Deductibility Act would remove the cap on the SALT deduction instituted in 2017 as part of Donald Trump's Tax Cuts and Jobs Act. It would allow New Yorkers to fully deduct their state and local taxes from

Westchester County homeowners pay the highest propert taxes in the country, and Rockland homeowners pay the 2nd highest. "When it comes to SALT, if you think Westchester and Rockland families needed and deserved this money before the coronavirus took hold, the stakes are even higher now because the cap is costing this community tens-of-thousands of dollars they could be using amid the crisis," said U.S. Senate Majority Leader Charles Schumer.

"That is why I am proud to work with Congressman Jones to restore our full SALT deduction in this Congress. Double taxing hardworking homeowners is plainly unfair; We need to bring our federal dollars back home to the to cushion the blow this virus—and this harmful SALT caphas dealt so many homeowners and families locally.'

"I am proud to join my colleagues to introduce legislation to repeal the cap on the State and Local Tax deduction, a cynical policy passed by Republicans as a way to repay wealthy donors and lobbyists with big corporate tax cuts," said U.S. Senator Kirsten Gillibrand.

"New York needs the full SALT deduction restored to offer hard workng middle class families tax relief," said NYS Senate Majority Leader Andrea Stewart-Cousins. "Savings from deductions could mean the difference between having enough for food or medicine during this pandemic. I have called on Congressional partners and supported restoring the full SALT Deduction, and I applaud Congressman Mondaire Jones and U.S. Senate Majority Leader Chuck Schumer for taking up the bill."

"I want to thank US Congressman Mondaire Jones for his work, in con-

junction with US Senator Chuck Schumer, to restore the State and Local Tax or 'SALT' deduction," said Westchester County Executive George Latimer. "This federal tax law is not only double taxation, but it also unfairly targets communities like Westchester County – and every homeowner in this County is a victim. In Westchester, where the average home is valued at \$691,392.00, our homes are our greatest asset and this cap is a hit to our wallet.'

"I urge the federal administration to reinstate the SALT deduction in full," said State Senator Shelley Mayer. "The move to cap the SALT deduction, a longstanding principle of tax law, was politically motivated and unconscionable. Since the SALT deduction was capped in 2017, families and homeowners in my district have been suffering under an added financial burden of double taxation, penalizing them for crucial state and local investments in essential services and public schools."

Dan Welsh, Program Director, Westchester Power; Sustainable Westchester commented, "We are very happy to be teaming with Mayor Spano, the Yonkers City Council and a wonderful range of community groups to expand access to clean energy supply to the residents and small businesses of Yonkers. Sustainable Westchester's Westchester Power Program is a tool for broad-based participation in the transition to clean energy. Westchester Power is a vetted and proven community energy program, bringing zero-emissions electricity at fixed rates secured through a competitive auction and bidding process. Currently Yonkers' participation in Westchester Power is pending Yonkers City Council legislation approval. Upon approval, Yonkers will become the largest municipal member in the program that selects from qualified Energy Service Companies (ESCOs) for a renewable energy supply.

Yonkers Council Majority Leader Corazon Pineda-Isaac stated, "Yonkers continues its path to be greener, more sustainable and more energy efficient. With this Community Choice Aggregation program, Yonkers joins other leading municipalities in aggregating the purchasing power on behalf of consumers which allows for fixed-rate energy costs and increases the use of renewable energy. Environmental benefits include a reduction in our gas consumption and greenhouse emissions."

John Rubbo, Yonkers City Councilmember, 4th District, said, "This bulk, energy purchase program will allow for a fixed-rate clean energy supply that will help us move towards a more sustainable Yonkers. In speaking with many of our residents it is clear that they are proud of the great work their city is doing to protect the environment and to provide clean and competitive energy

Once the Yonkers City Council passes the enabling legislation, Sustainable Westchester and the City of Yonkers will conduct targeted educational outreach before submission of documentation to the New York State's Department of Public Service for approval. Sustainable Westchester and the City then will go to bid for energy suppliers to provide Yonkers residents with 100% New York State renewable energy at a competitive fixed rate. Yonkers residents and businesses can OPT OUT of the program at any time. The program applies only to those who receive their energy supply from Con Edison and will not apply to those already enrolled in an energy program with an Energy Service Company (ESCO). Delivery of energy, billing and support will continue to be provided by Con Edison.

Westchester Power currently serves 115,000 residents in 28 Westchester municipalities who have come together to address climate change through their electricity choice. Sustainable Westchester is a nonprofit, consortium of Westchester County local governments that facilitates effective collaboration on sustainability initiatives.



#### On This Day in Yonkers History...

Monday, February 15th

February 15, 1921: New York Giants star third baseman Frankie Frisch led his "Frisch's All Stars" to a 32-22 victory in a basketball game against the St. Peter's team at Columbus Hall on Waverly Street. Frisch, a former Fordham College star nicknamed "The Fordham Flash," played with a team composed of college players. He played for the Giants from 1919 to 1926, then joined the St. Louis Cardinals in 1927, eventually becoming the Cardinals' manager.

February 15, 1942: City Manager Raymond Whitney announced former NYU track star Curtis Giddings of Warburton Avenue would become Yonkers' first African American Firefighter.

Tuesday, February 16th

February 16, 1918: A nation-wide patriotic campaign swept into Yonkers when the local unit of the Women's Committee of the Council for National Defense organized the "Three Minute Women." The women made three-minute addresses on patriotic subjects at all "ready-made audiences," including theaters and entertainments. Their work was similar to the "Four Minute Men."

February 16, 1933: Judge Learned Hand of Palisade Avenue was one of the leaders of the New York Bar who attended the Committee on the Establishment of a Permanent Organization for the Improvement of Law conference, held in Washington. Hand was famous as an avid supporter of free speech and considered to be one of the "most influential American most influential American judges never to have served on the US Supreme Court."

Wednesday, February 17th

February 17, 1924: Future basketball star and union leader John Acropolis scored 26 points to lead Leake and Watts Basketball team to a 67 -10 victory over the Hebrew national Orphan Home; the game was played on the Leake and Watts court.

February 17, 1929: Dr. A. Newell Benedict, son-in-law of former Mayor and Congressman John E. Andrus, announced a home for the aged would be build on the North Broadway property adjoining the Julia Dyckman Andrus Memorial Home for Children.

February 17, 1941: The Navy Department of Supplies and Accounts awarded an additional \$23,622 contract for electric cable to the Habirshaw Cable and Wire Division of the Phelps Dodge Copper Product Corporation. This was the fourth contract awarded just in this month, for a total of \$1,058,462. The total contracts awarded to this Yonkers plant since June 1940, when large-scale national defense purchasing got underway, was \$3,838,297.07.

Thursday, February 18th

February 18, 1933: Riverdale Avenue resident and internationally known sculptor Isidore Konti was elected President of the Yonkers Art Association, replacing the late Rudolf Eickemeyer.

February 18, 1940: City Manager Raymond Whitney, Acting Public Safety Commissioner, ended the policy of giving special one-month leaves with pay to retiring police officers and firefighters.

February 18, 1944: Female employees of the Cameo Curtain Company were the first volunteer students for the lecture series given by the Nutri-

repurposing of the power plant will be a great boon to Yonkers," says Stephen Wagner, vice president of the Yonkers Committee for Smart Development (YCSD). "Our focus, though, is on the Marina, on the garage. We cannot accept the taking of a public benefit and turning it into a private benefit intended primarily to serve the interests of one developer." That is why, Wagner explains, YCSD has united with other community groups to prevent the developer from gaining approvals to build in the Marina. "We believe deeply that this is the right course for us as citizens and we believe it is also the necessary course for our elected representatives to adopt.'

Since December, consortium representatives have been meeting with government officials, with the developer, and have been reaching out to the public to build awareness around the developer's plans. The groups' petition has gathered more than 700 signatures from Yonkers residents since it went online on January 20.

Notably, nearly 300 who signed also took time to voice their concerns in the comments section of the petition. "This is planning at its worst," Bob Walters writes in one entry.

In community meetings on December 29 and January 21 convened by City Council District #1 Councilwoman Shanae Williams and hosted on Zoom by the Yonkers Public Library, the developer responded to the community outcry, stating that the garage, whose footprint would occupy an existing ground-level parking area in the Marina, will actually provide additional parkland by creating a deck atop the two-story garage that will be fashioned into a park. In presenting its vision, the developer extended an intention to work with Yonkers residents to find the most desirable rooftop configuration, indicating that it could include playground structures or even a soccer field. "The developer is offering a grossly unequal tradeoff," says Wendy Scheir, co-founder of the Friends of Trevor Park, another of the core groups opposing the garage. "We will not debate which amenities they should put on the deck of their garage. Our point is that a garage in the Marina will irreparably damage the intrinsic beauty and feeling of expansiveness there, spoiling the very features that make the place so special."

The one point on which all sides of the debate agree is that there is no simple solution to LGG's parking problem. The power plant sits on a site in a neighborhood of tightly-packed apartment buildings, on the west side of Metro North's Glenwood train station, making access to the plant from the east and south difficult. West of the plant lies the Hudson River. To its north lies JFK Marina. Barbara Smith, president of the Hudson River Community Association, another anchor organization opposing the Marina garage, has an answer for that: "The developer should be required to place their parking on their own land – not ours.'

Perhaps the most pressing reason for preserving the Marina's open space and unfettered public access, consortium representatives maintain, is that JFK Marina provides a critical "backyard" to hundreds of Yonkers apartment dwellers in an area where there is already a documented lack of open, green space. Area residents point to the Marina garage as "yet another instance of environmental racism." "Hey, Mayor Mike and Yonkers City Council," writes Julie Weiner on the petition. "How about showing us that green spaces and waterfront vistas in African-American and Latin-X communities matter to you?" Christine McSweeney agrees: "There are so few parks on this side of Yonkers. How unfair to the residents, especially the children who need green spaces for their mental health!"

Before setting its sights on JFK Marina, LGG had hoped to put their parking facility and to cut two long roads through the middle of Trevor Park, a popular public park just east of the Marina. A neighborhood outcry at the end of 2020 prompted the developer to abandon the Trevor Park plan. But opponents claim that the alternative, JFK Marina, is just as disastrous a

site for the garage as Trevor Park, if not more so.

While the consortium's focus is on keeping the garage out of the Marina, the group is eager to work with the developer to identify and envision such a site and have conveyed this message. "There are solutions to LGG's parking needs that would not disrupt, compromise, and privatize public land," says Mike Hertz, of the River Communities Coalition of Yonkers, another anchor group in the consortium.

On the petition, Joseph Eugenio frames the choice for Yonkers officials in starker terms: "I'm totally against this garage and will not support the

re-election of anyone who approves it."

"We are passionate about our neighborhood parklands," Wagner states. "We know that there are realistic options that leave our parks alone. And we will continue as a united community to make our opposition about this egregious development known. We intend to ensure that the JFK Marina is protected as public land for future generations."

There are several legal steps that would have to take place before the n to build a parking lot at JFK Marina becomes a reality. First the City Council would have to request "Parkland alienation," which occurs when a municipality wishes to sell, lease or discontinue the use of municipal parkland. Parkland alienation can be applicable to every municipal park1 in New York State, whether owned by a city, county, town or village.

In order to convey parkland to a non-public entity, or to use parkland for another purpose, the municipality must receive prior authorization from the New York State Office of Parks, Recreation and Historic Preservation (State Parks) in the form of legislation enacted by the New York State Legislature (Legislature) and approved by the Governor. The bill by which the Legislature grants its authorization is commonly referred to as a parkland alienation bill.

After the alienation, there is usally a trade of land so that the parkland is replaced. None of those discussions have publicly taken place, nor have they yet been discussed by the coaltion.

Advice: "You are here for a purpose... no matter who tries to tell you otherwise."

The Artist: You've probably seen her artwork somewhere across the country. Inspired by her father and many other artists, Shanequa Benitez (@SocialIcon) has had her artwork displayed everywhere from Yonkers to Harlem. A person of color who wears her city on her back, Shanequa proudly told me, "I am Yonkers." She represents Yonkers, and the town represents her. Her Yonkers representation was evident during her Art Exhibition Never Conform, a smash hit in the city. Despite her successes through art and her self-made clothing brand, Shanequa told me that she's "only scratched the surface" with her work.

Advice: "Be confident and be proud of who you are."

The Connector: Founder of the Stop & Shake Initiative, Hector Santiago (@PeoplesMayor), is one of the leading activists in Yonkers. Yonkers Voice described the initiative as one that "encourages members of the police department to avoid miscommunication with [the] community by reaching out and introducing themselves through a common greeting.' When asked who he is, without hesitation, Hector says, "before anything, I'm a dad. I'm a dad who became active for my kids." Santiago is "a mediator and a consultant for the Yonkers community."

Advice: "Save money and learn as much as possible."

**The Mentor:** He's a youth advocate and a motivational speaker. Founder and Director of 914United, Jonathan Alvarez (@Visionalre), is making a name for himself by mentoring young adults across Yonkers. Jonathan changed his life, so he could help change the lives of others. In an interview with me, he said that he wants to "help steer our youth into a promising future." Jonathan's thriving to create a full-on youth mentorship organization that supports those returning home from incarceration, amongst other things.

Advice: "Learn financial literacy to secure financial freedom."

Valley, in collaboration with Governor Cuomo's Vaccine Distribution and Implementation Task Force, the State Department of Health and local governments, and our healthcare and community partners," said Josh Ratner, WM-CHealth Executive Vice President, and Hub Lead.

Ratner said that now more than 160 pharmacies have joined the Hub's Provider Task Force, which now totals more than 210 members. Several Walgreens Pharmacies in Westchester are starting to receive and distribute the

Earlier this month, WMCHealth joined New York State and Westchester County in spearheading the operation of the Westchester County Center in White Plains as one of the first of 20 Mass Vaccine Distribution sites in New York, and is currently administering more than 2,000 vaccinations per day.

Nodine Hill Community Center will re-open in three weeks to administer second doses.

Johnson & Johnson's COVID Vaccine is expected to receive FDA emergency approval at the end of February and immediately start to deliver doses across the country, and the US Government has ordered 100 million doses of the J&J Vaccine, which the company expects to be able to deliver by June.

The J&J vaccine, created with Janssen Pharmaceutical, requires only one shot per person. The Moderna and Pfizer vaccines require two doses per person. The J&J Janseen vaccine can also stay potent for up to three months at

regular refrigerated temperatures.

By the time that J&J's 100 Million doses are delivered across the US in June, there shoud be a fourth vaccine available as Novavax continues its work

on a vaccine and could have 100 million doses available in June.

Pfizer will have delivered 200 million doses, or 100 million, two -shot vaccines by July, and Moderna's vaccine will have 100 million doses of vaccine by the end of March and an additional 100 million by June.

There is progress, and hope, that this summer, all residents of Westchester will have been able to get a vacccine. And as more Americans get the vaccine, hopefully fewer Americans will get COVID.

That is good news—read it and share it.

tion Committee of the Yonkers War Council. Designed for war workers who also had to prepare meals for their families, the series focused on how a busy war worker could prepare could "prepare a nutritious and pal-atable dinner quickly and easily." The series was repeated a few times in the Yonkers Electric Light and Power Company auditorium so all Cameo women could attend. Other demonstrations in the course were "preparing a good breakfast," "attractive and palatable foods for lunch boxes," soy beans and shopping for food."

Friday, February 19th

February 19, 1916: Ant House, a new play by Park Hill's Owen Davis and Robert H. Davis, opened at the Cort Theater in New York, with Edwin Arden and William Mack playing the leading roles. Davis later won the 1923 Pulitzer Prize for Drama for his play Icebound.

February 19, 1924: Samuel Hayward, owner of the Hayward Wholesale Paper Company, had a \$410 payroll stolen from his overcoat pocket while he was purchasing a cigar in a Getty Square store, the first payroll robbery in Yonkers in many, years. Being a caring employer, he immediately withdrew the money out of his personal account so his workers would not have to wait for their pay.

Saturday, February 20th

February 20, 1885: Tapestry workers at the Smith Carpet Factory walked out in support of female workers fired for joining the Knights of Labor; the company immediately shut the factory down. Interesting side note: At the start of the strike, only two dozen workers were union members. By the end of the strike, because the unit was so enraged the "little girls" were fired, almost 100% of the tapestry workers had joined the Knights of Labor.

February 20, 1920: George Thomas, suspected leader of the policy slip racket in Yonkers, in the Yonkers courtroom to monitor how one of his henchmen fared, Thomas was recognized by the Charles Boote, the presiding judge, who had given Thomas a suspended sentence five months earlier. The judge ordered Captain Ford to arrest the man, who promptly bolted out of the court. In the hallway, Court Interpreter Henry Friedman recognized him, grabbed him, and marched the escapee back into the court by the scruff of the neck. Boote ordered the sentence to start immediately.

Sunday, February 21st

February 21, 1908: John Philip Sousa, the famous conductor and composer, performed at Blaney's Theater. Soloists performing in the concert were soprano Lucy Allen and violinist J. Powers.

February 21, 1908: Forty guests from the Yonkers YMCA were guests of Commander Robert Peary, USN, North Pole explorer, on the "Roosevelt," the Commander's ship.

February 21, 1936: George McCann considered himself an expert shot, so much so he built a shooting gallery under the McCann storage warehouse on Mill Street. He told his secretary she should learn to shoot. Her answer? "Why don't you?" The two then went down to the gallery to "shoot it out." At the end of the match, George wished he hadn't--Anna Solberg, his versatile secretary, scored 93 out of a possible 100, much higher than George!

Westchester Congressman Mondaire Jones, who represents northern Westchester and Rockland County in the 17th District, is an original cosponsor of the SALT Deductibility Act, which would remove cap on State and Local Tax Deduction instituted by Donald Trump and the republican

congress in 2017 as part of a larger tax cut plan.

The State and Local Tax Deduction limits the amount of property taxes and state income taxes that Westchester residents and homeowners can de duct on their federal income taxes to \$10,000 total. Congressman Jones in introduced the bill with Long Island Congressman Tom Suozzi and Senate

Majority Leader Chuck Schumer.

Residents of New York's 17th Congressional District pay the highest property taxes of any Congressional District in the country. The average property tax bill in NY-17 is \$11,389. 45% of individuals (roughly 330,000 people) in NY-17 use the SALT deduction. The average deduction taken in NY-17 prior to the cap was \$26,243.

'Donald Trump cut taxes for billionaires and big corporations and paid for it on the backs of hardworking families in Westchester and Rockland Counties, where we pay the highest property taxes in the entire nation," said Rep. Jones. "That must change. Restoring the SALT deduction is a necessary first step to creating an equitable tax system – one where we put money back in the pockets of working people."

The SALT Deductibility Act would remove the cap on the SALT deduction instituted in 2017 as part of Donald Trump's Tax Cuts and Jobs Act. It would allow New Yorkers to fully deduct their state and local taxes from

their federal taxes.

Westchester County homeowners pay the highest propert taxes in the country, and Rockland homeowners pay the 2nd highest. "When it comes to SALT, if you think Westchester and Rockland families needed and deserved this money before the coronavirus took hold, the stakes are even higher now because the cap is costing this community tens-of-thousands of dollars they could be using amid the crisis," said U.S. Senate Majority Leader Charles Schumer.

"That is why I am proud to work with Congressman Jones to restore our full SALT deduction in this Congress. Double taxing hardworking homeowners is plainly unfair; We need to bring our federal dollars back home to the to cushion the blow this virus—and this harmful SALT cap has dealt so many homeowners and families locally."

"I am proud to join my colleagues to introduce legislation to repeal the cap on the State and Local Tax deduction, a cynical policy passed by Republicans as a way to repay wealthy donors and lobbyists with big corporate tax cuts," said U.S. Senator Kirsten Gillibrand.

"New York needs the full SALT deduction restored to offer hard working middle class families tax relief," said NYS Senate Majority Leader Andrea Stewart-Cousins. "Savings from deductions could mean the difference between having enough for food or medicine during this pandemic. I have called on Congressional partners and supported restoring the full SALT Deduction, and I applaud Congressman Mondaire Jones and U.S. Senate Majority Leader Chuck Schumer for taking up the bill."

"I want to thank US Congressman Mondaire Jones for his work to restore the State and Local Tax or 'SALT' deduction," said Westchester County Executive George Latimer. "This federal tax law is not only double
