"Actions Versus Rhetoric" Latimer and Bowman Engage in Heated Debate

On Monday May 13, constituents had an opportunity to witness the two candidates for Congressional District 16 participate in their first debate. The onehour debate was often contentious as incumbent Jamaal Bowman looked more like the underdog to his challenger George Latimer. The questions, which were curated from the News 12 viewership, centered around the Mideast, affordable housing, crime, immigration, and each contender's record.

After a brief introduction, the debate started with a question focused on the Hamas/Israel war. Both candidates expressed their support for a two-state solution. Mr. Latimer was adamant that peace and a two-state solution begins with the release of the hostages. Mr. Bowman conveyed that peace, and a two-state solution begins with the removal of Prime Minister Benjamin Netanyahu.

Throughout the debate Congressman Bowman tried to paint George Latimer as an anti-choice, MAGA Republican, due to his alliance with American Israel Public Affairs Committee (AIPAC). AIPAC has pledged millions of dollars to opponents of Jamaal Bowman and the Squad. Mr. Latimer correctly pointed out that AIPAC also supports Grace Meng, Greg Meeks, and Ritchie Torres. County Executive Latimer also cited his actions to protect clinic access and protect reproductive freedoms. The American Israel Public Affairs Committee is a lobbying group that advocates pro-Israel policies to the legislative and executive branches of the United States.

The conversation turned to crime where moderator Tara Rosenblum expressed that while overall crime is down, only 37% of New Yorkers feel safe in

## Beczak Center's Future Back in the News

The Beczak Environment Center, located at 35 Alexander Street on the Hudson Riverfront in Yonkers, recently got a reprieve from a letter they received instructing them to vacate their county owned building within 30 days for failure to properly maintain the building as part of their lease with Westchester County.

When told about the letter, from Westchester County Department of Public Works Commissioner Hugh Greechan, County Executive George Latimer told Yonkerstimes.com on Friday May 10 that he recinded the letter and that no action will be taken for 90 days until further review.

Beczak has a lease with the county that will expire in July of 2025. The building is currently being shared with the Sarah Lawrence College Center for the Urban River at Beczak.

The letter from Greechan, dated April 23, was recently shared with the public, so we reached out to Latimer, who immediately rescinded the letter. We wanted to share that information with anyone who may have read Greechan's letter.

At issue are repairs, or the lack thereof, being made at Beczak. Last year, Westchester County sent Beczak a letter identifying \$1.9 Million in construction work and repairs that they claim are required to properly maintain the building.

But Beczak claims that most if not all of the repairs are not required. A walk through of the building last year included all stake holders. After that walk through, there was no correspondence between the county and Beczak regard

Yonkers Mayor Spano Announces Free Compost Distribution for Residents

On May 9, Yonkers Mayor Mike Spano and the Yonkers Department of Public Works (DPW) announced free compost distribution for Yonkers residents. The distribution is part of the City of Yonkers' food scrap recycling initiative in partnership with Westchester County's Department of Environmental Facilities. The compost is a product of the Yonkers residential food scrap recycling program, which collected more than 30 tons of food scraps from Yonkers residents.

Eligible residents, showing proof of residency, can receive one, 3-5 lb. bag of compost per household, while supplies last.

"Recycling food scraps reduces greenhouse gases and food waste in landfills and incineration facilities. It's a simple way to help protect our environment," said Mayor Spano. "Properly composted food scraps reduces pollution and improves overall quality of life. Thanks to our partnership with the County, Yonkers can continue to do its part in reducing our carbon footprint and continue to be leaders in creating a cleaner, greener, more sustainable Yonkers."

In April 2022, the City of Yonkers initiated a food scrap recycling drop-off program at the Yonkers Recycling Center and became the largest municipality to join Westchester's Residential Food Scrap Transportation and Disposal (RF-STAD) program. Last May, the City expanded the program to include curbside collection for 200 households at 1085 Warburton Avenue, which served as a model for expanding to other buildings and households. The City is currently working with the Municipal Housing Authority of the City of Yonkers (MHA-CY) to bring food scrap recycling to MHA buildings.

Since the start of the program, there has been a reduction of approximately 571 tons in the City's solid waste stream.

Yonkers Department of Public Works Commissioner Thomas G. Meier said, "Food scrap collection has become a critical part of the recycling services offer

## WCLA Rates DA Candidate Adeel Mirza Anti-Choice



The WCLA, Westchester Coalition for Legal Abortion, recently sent out this email blast about the upcoming democratic primary for Westchester District Attorney. There are three candidates running for the office of Westchester County District Attorney in the Democratic Primary. Choice Matters interviewed each of them in depth and reviewed their individual questionnaires.

Choice Matters has rated two of the candidates — William Wagstaff and Susan Cacace — 100% PRO-CHOICE. Choice Matters has rated the third candidate, Adeel Mirza, — ANTI-CHOICE.

Whereas Wagstaff and Cacace present different visions for the office they are seeking, seeing their responsibilities and the people they would represent differently, there is no question that both candidates grasp the dramatic role the District Attorney's office will be called upon to play in this horrific time of every-increasing violence against providers, staff, patients and reproductive healthcare facilities.

LWVW will be hosting moderated candidate forums for the countywide contested races in the June Primary.



104 -Year- Old Westchester Veteran Honored by Majority Leader Andrea Stewart-Cousins



In a room filled with American veterans, New York State Senate Majority Leader Andrea Stewart-Cousins announced two Senate District 35 residents whom she will induct to the New York State Senate Veterans Hall of Fame Class of 2024.

"I am so excited to recognize the amazing Jean Wallace Otto Macintosh, who at 104 is still going strong. Jean served as an air traffic controller in the Navy during World War II, training fighter pilots to use radar for night missions. She has been a pillar of the community in Irvington for nearly 80 years, launching the Irvington Meals on Wheels Program, and even playing curling up to the age of 94. To be able to recognize Jean while she is surrounded by family and other veterans, and see them give her a standing ovation, was truly special." Sen. Stewart-Cousins said.

Sen. Stewart-Cousins also selected Hugh McAuley, long-time veterans advocate and Chairman of the Greenburgh Veterans Advisory Committee. McAuley was deliberately not notified in advance of his selection, so that Sen. Stewart-Cousins could surprise him.

"Everyone who knows Hugh McAuley, knows he embodies the meaning of commitment to others, beginning with his time in the Navy where he served aboard the USS Saratoga as an aircraft mechanic during the Vietnam War. offered by the Department of Public Works. The program is resulting in a significant reduction in solid waste and we're excited to extend the benefit of nutrient-rich compost to Yonkers residents."

The Yonkers Department of Public Works Home Food Scrap Bins are available for purchase (\$20) at the Yonkers Recycling Center (735 Saw Mill River Road). Kits include one 1.9-gallon countertop pail, one six-gallon home storage and transportation bin, and a roll of 25 compostable bags. Filled bags can be dropped off at the Recycling Center.

Food scraps are one of the largest components of trash sent to landfills and incinerators. In a landfill, food scraps create methane, which is a potent greenhouse gas that traps CO2 and contributes to global warming. When sent to an incinerator, food scraps reduce the efficiency of the incinerator because they contain water and therefore do not burn well. Instead of wasting energy trying to hum food an exercise from landfilling it as a section food scraps.

to burn food, or creating methane from landfilling it, composting food scraps produces a useful and valuable product that gives back to the nutrient life cycle resulting in cleaner soil, water, and air.

**On This Day in Yonkers History...** 

#### Monday, May 20th

May 20, 1948: Former Vice-Mayor James Sullivan, found guilty on three accounts of forgery, learned County Judge Elbert Gallagher would not sentence him for at least ten more days. Sullivan had been in County Jail since the trial began a month earlier.

May 20, 1959: Four hundred residents left Yonkers, heading to the non-violent Poor Peoples March on Washington. The group, advocates of the late Dr. Martin Luther King Jr. and religious leaders of all faiths, joined in togetherness to show concern for the poor, and were from from groups as diverse as St. Peter's and Messiah Baptist's Head Start to St. Mark's Episcopal Church to our Human Rights Commission.

#### Tuesday, May 21st


May 21, 1933: By a margin of eighteen to one, Yonkers voted to elect delegates to the State Prohibition Repeal Convention in Albany. The actual vote was 26,100 for the repeal ticket and 1,424 for the dry ticket.

May 21, 1947: Dr. Irving Blumenfeld of Bajart Place was the only Yonkers resident to exhibit a stamp collection at the Centenary International Philatelic Exhibition in Grand Central Palace in New York. Collectors from all over the world exhibited their stamps to celebrate the 100th anniversary of the United States issuing postage stamps.

#### Wednesday, May 22nd

May 22, 1923: Drawing on the experience and memorabilia owned by Valentine Lane's Carl Lachmund, an outstanding musician who studied with Franz Liszt, an article in the June issue of Shadowland magazine featured Lachmund's work while he was both a student and friend of the composer, including several anecdotes. The Yonkers man owned one of the most valuable collections of Liszt historical documents and photos of Liszt in the United States!

May 22, 1946: The Municipal Civil Service Commission finally released its decision on Yonkers Fire Department's Lieutenant Thomas Barden's appeal on his test rating. The test, held almost a year earlier, originally did not include his name on the promotion eligibility list; he immediately appealed, stating some of his answers were not graded properly. The appeal was successful; not only was he on the list, but he should have been first! Unfortunately, since the appeal took so long, the job that should have been his was given to the person now known to rank second.

#### Thursday, May 23rd

May 23, 1940: American Red Cross first aid instructor and YPD Officer Alexander Rusinko was given a testimonial dinner at the State Armory by members of the Police Department who successfully completed a first aid course under his direction. PO Bernard Wagner presented him with a gift as a token of their appreciation.

May 23, 1950: Yonkers Common Council ordered reopening of Yonkers' swimming pools, closed because of a water emergency. Third Ward Councilman Mike Nugent introduced the resolution, saying our pools recirculated water and not lose water. City Manager Wagner pointed out if the pools did not reopen, our residents might be tempted to swim in the polluted waters of the Hudson, with no lifeguards or supervision.

Corporation Counsel John Galloway informed the councilmen a notice would have to be published in Yonkers' official newspapers before it could become effective.

#### Friday, May 24th

May 24, 1944: Eleven-year-old Matthew O'Brien of Knowles Street, sitting on the Ludlow Dock and dangling his feet over the side, got a bad surprise. A Coast Guard cutter moored at the dock suddenly lurched and caught his foot! Emergency treatment was given by the cutter crew, and the boy was taken to St. Joseph's Hospital, where he was diagnosed with possible multiple fractures of his left foot and leg and admitted to the hospital.

May 24, 1950: Lifelong Yonkers resident and Coach of the NY Knickerbockers Joe Lapchick signed the first African American basketball player to play in the NBA, Nat "Sweetwater" Clifton. He became the second Black player to play in the NBA, playing his first game on November 4. This was four days after the debut of Washington Capitols player Earl Lloyd, the first black player to appear in an NBA game.

#### Saturday, May 25th

May 25, 1931: The Directors of the Hollywood Inn, a Yonkers stellar institution since opening in 1896, carefully studied their finances. They had a debt of \$43,000 and operated at an annual loss of \$18,000. They unanimously affirmed their decision to break up the organization and return their property to the Cochran heirs. Although its 250 members wanted to save it, they were unable to put together the necessary financial package to keep it open. Members of the Directors committee to oversee its dissolution were John Dickinson, Richard Edie, Jr., E. Wetmore Kinsley, James Lynch, Edwin Palmer, Robert Neville, E. William Poole, Gus Stahl, William Tomlinson, and William Wallin.

May 25, 1941: Two Yonkers women, determined to make Yonkers the best in the country, formed a coalition of women under the name of "Clean Up Yonkers." Lena Wilson and Beatrice Benn were the organizers planning the first rally.

#### Sunday, May 26th

May 26, 1652: Yonkers officially became a Dutch colony; Adriaen van der Donck was granted power to bequeath his lands.

May 26, 1950: Water Superintendent James Fitzgibbon announced Yonkers would once again tap our Grassy Sprain Reservoir to augment our water supply and save thousands of dollars. The filter beds at Tube Well had been cleaned, and its newly installed Tube Well pumps were taking water from the Saw Mill River. The Grassy Sprain and Fortfield reservoirs were being cleaned and repaired. At the time, Yonkers was purchasing NYC water at \$105 per million gallons.




## Enrico Fermi Educational Fund of Yonkers Celebrates 61st Year Awarding \$45,000 to 8 Students

Jotto enables people to share feedback instantly by turning diverse forms of feedback—video, audio, and text—into actionable insights. This feedback enables organizations to deeply understand and effectively respond to their community's needs while encouraging stakeholder expression and participation.

"With any new platform, user adoption is critical. The WIN program allowed us to expand our user base by putting us in front of potential users so that we can show them our technology's benefits," said Jotto founder and CEO Jason Van Anden.

A GENERAL ORDINANCE AMENDING PART IV: BUSINESS REG-ULATIONS, LICENSING AND CONSUMER PROTECTION OF THE CODE BY ADDING CHAPTER 40 TO THE CODE, ENTITLED "REGIS-TRATION REQUIREMENTS FOR EXPEDITORS"

Notice is hereby given that the City Council of the City of Yonkers has adopted the abovementioned legislation that amends the City Code to create a registration requirement for persons who act as expeditors in various City departments. A registration requirement for expeditors will allow for greater transparency and efficiency throughout the permitting process in various City departments. Furthermore, this registration requirement will also allow the City of Yonkers to hold expeditors accountable and suspend or revoke the registration of expediters where there is a finding of misconduct as defined in the legislation.

The penalties for violation of this ordinance are as follows:

A violation of any provision of this chapter shall constitute a Class II offense. Any person who provides expediting services without first obtaining a registration certificate from the City of Yonkers or who shall continue to provide expediting services after having had his/her registration suspended or revoked shall be deemed to have violated the provisions of this chapter. Each expediting service performed by a person without a valid registration certificate shall be deemed a separate offense.

We must combat this rise in anti-Semitism by supporting a constructive path to peace through education by organizations such as the HHREC. I'm thrilled that we have been able to help fund the HHREC's programs so that they can continue their great work of education and awareness to ensure that atrocities such as those of the Holocaust never happen again."

HHREC is a nonprofit based in White Plains that serves schools, synagogues, colleges, churches and civic centers in Westchester and the Hudson Valley. The

HHREC's mission is to enhance the teaching and learning of the lessons of the Holocaust and the right of all people to be treated with dignity and respect. HHREC works with teachers and students to help schools fulfill the New York State mandate that the Holocaust and other human rights violations be included in their curriculum. Since 1994, the HHREC has brought the lessons of the Holocaust, genocide and human rights violations to more than 3,000 teachers, and through them to thousands of students.

HHREC provides educational opportunities for students and educators, as well as community events such as the annual Westchester County Yom HaShoah (Day of Remembrance) Commemoration at the Garden of Remembrance, and Kristallnacht (Night of Broken Glass) commemoration with Iona University. HHREC also has a Holocaust survivor speakers bureau which reaches over 50,000 students each year."

"As a lifelong educator, it is imperative that we support initiatives to teach our youth about human rights abuses," said State Assemblyman Nader Sayegh. "It is now more important than ever to address the growing polarization and tension that exists in our communities, nation, and world because of misinformation, misunderstanding, and unfortunately hate. We will continue to work diligently for respect of diversity and making knowledge available to all."

Mr. Bowman supported a public health approach to public safety. He called for investments in mental health, education, and workforce development. George Latimer rebutted that the incumbent failed to acknowledge that funding the police is part of the solution to drive down crime.

On affordable housing George Latimer cited his record of producing 2,500 units of affordable housing in the county. Jamaal Bowman accused County Executive Latimer of falling short. Latimer rebutted this by demonstrating the ways in which the incumbent could have lobbied for more housing funding. During this exchange, Bowman's lack of self-control became evident, as he continued to interrupt and interject, when he did not have the floor.

Before the first commercial break it was the rhetoric of the incumbent vs the actions of the challenger. George Latimer was armed with facts and actions amassed over a 35-year career, while the incumbent demonstrated the same type of behavior that has often put him at odds with his congressional colleagues.

The topic turned to migrants where Congressman Bowman blamed corporate America for destroying the ecosystem of the migrant's home countries, which forced them to come here. He stated that his office was working in partnership with Pace University, Neighbors Link and Westhab to get our new arrivals settled with their paperwork.

Mr. Latimer expressed the need to overhaul the system, including increased border security, but he stated that it needs to be a bipartisan effort. He called for a reform of the asylum system, by setting up an asylum court in Westchester. As County Executive, he arranged for the Westchester County Department of Health to give full exams and medical care to the newly arrived migrants.

During the remainder of the debate Mr. Bowman continued to interrupt. At one point he claimed to bring one billion dollars to the City of Mount Vernon. George Latimer called that a lie, by stating that Hakeem Jefferies only brought \$22 million to his entire district. Additionally, Latimer pointed out that no piece of legislation authored by Congressman Bowman became a law serving the 16th Congressional District. Latimer accused Bowman of wanting to be in the office to feel special, rather than actually doing the work of legislation and funding. At one point Latimer said, "It's about being local, not vocal."

The debate was plagued by the inability of Congressman Bowman to control his impulses. This was the same lack of impulse control that likely led to the incumbent pulling a fire alarm in the House office building. His behavior was that of a petulant child who couldn't justify his actions, or in this case his inactions.

The debate was between two progressive politicians. George Latimer demonstrated his 35-year record of working across party lines to produce change. Jamaal Bowman demonstrated his ability to be a lightning rod to bring attention to a cause. It will be the voters who decide which candidate has the demeanor and experience to serve all of the constituents of Congressional District 16.

1-The debate made national news, with Politico calling it a "Snark Fest" between the two, and The Hill highlighting Bowman pushing the "angry black man stereotype."

Latimer called Bowman an "ineffecitve Congressman" adding, "You need to talk to them as normal people — you can't preach and scream at them on the steps of the Capitol. That's the difference between being local, and being vocal,"

Bowman responded with "The angry Black man, the angry Black man," Bowman said. "It's the southern strategy in the north."

Throughout the debate, Bowman returned to his central theme, of trying to tie Latimer to the MAGA movement. "We've got to deal with the issue of ra cial justice, inequality, voting rights, climate justice and all of the issues that MAGA Republicans — who my opponent is working with — are trying to take away from us." That is a difficult accusation to stick to Latimer, who has served Westchester as a progressive democrat for 30 years. "I have devoted my whole life to public service, to public policy, to substance — not just to style, While not many democratic voters in the district will be swayed by the debate, the debate offered insight, and the different way that both men serve the public. After the debate both sides declared victory. The Working Families Party called it for Bowman."Democrats shouldn't be normalizing the politics of extremists like Marjorie Taylor Greene, or trying to meet them halfway. In fact, we need leaders with the moral clarity to call out their dangerous rhetoric, which already incited an attack on the Capitol on January 6th." MFI PAC Chairman Mark Mellman said, "Whether it was standing with President Biden, supporting Israel or vowing to deliver for the district, George Latimer made clear tonight that he's the best choice for Democrats in the NY-16 primary. There's a clear reason Jamaal Bowman is trailing in this race: mainstream Democrats are rejecting Bowman's opposition to President Biden's infrastructure law, George Latimer showed time and again he brings people together to produce progressive results." News 12 moderator Tara Rosenblum did a good job. No knockout in this debate.

## **Brothers Sentenced to a Combined 28 Years** in Prison for Attempted Murder in Yonkers

Defendants, who have prior convictions, attacked and pistol whipped the

Westchester County District Attorney Miriam E. Rocah announced today that two Yonkers men were sentenced on Thursday to a combined 28 years in state prison for the attempted murder of a Yonkers resident outside of his home.

DA Rocah said: "Gun violence inflicts enormous fear and stress in our communities and drivers of this epidemic must be held accountable. Thankfully, the victim survived this violent attack and shooting, and the defendants now face the consequences for their actions."

Appearing before Judge George Fufidio in Westchester County Court, Daquann Johnson, 34, was sentenced to 16 years in state prison, with five years of post-release supervision, and his brother Dieandre Phillips, 32, was sentenced to 12 years in state prison, with five years of post-release supervision.

Following a four-week trial, a jury on March 30 found the defendants guilty of Attempted Murder in the Second Degree, Attempted Assault in the First Degree, Criminal Possession of a Weapon in the Second Degree, Assault in the Second Degree, and Criminal Possession of a Weapon in the Third Degree, all felonies.

On Jan. 20, 2023, at approximately 12:26 p.m., the defendants, who were not known to the victim, repeatedly kicked and punched the victim following a verbal dispute outside the victim's home in Yonkers. The defendants struck the victim with a gun before shooting him in the back as he attempted to run into his home. The victim was transported to a local hospital and treated for his injuries.

The Yonkers Police Department arrested Johnson on Jan. 21, 2023, and Phillips on Jan. 24, 2023, following an investigation utilizing surveillance video and license plate readers. Police also recovered a 9mm shell casing at the scene.

The District Attorney thanked the Yonkers Police Department for their assistance on this case.

The case was prosecuted by Major Case Bureau Chief Nadine Nagler and Assistant District Attorney Rachel Ehrhardt, both of the Trials and Investigations Division, with assistance from the Violent Criminal Enterprise Unit of the DA's Criminal Investigators Squad.

Sophia has been ranked #1 since her junior year. "I wasn't aiming for Valedictorian, but I have been aware of the rankings."

Advice to hopeful valedictorians? "Balance is the key to success and happiness. You are allowed to say no to things you don't want to do, but don't deny yourself the opportunity to grow and learn."

Lincoln High School Salutatorian Kyle Macancela will graduate with a 96% GPA. One of his favorite teachers is Science Research Teacher Mrs. Howard. "She has been my teacher since middle school. She has always been like a second mother to me and gives good advice. She has always been there for me."

Kyle's favorite subject is Physics. "We have a lot of labs and the interaction with other people builds relationships."

One of Kyle's extra-curricular activities was in the National Science Honors Society, English Honors Society, and serving as vice-president of Lincoln High School's Rho Kappa. "I was able to get scholarships and boosted my growth."

Kyle will be attending Manhattan College in the fall. "I got a full scholarship, and my dad pushed me to this idea, to have an impact on society. It's kind of a service to him for being a great dad."

"When we came back from COVID, I began to look at my rankings, and I pushed myself to be #2."

### Yonkers' Contribution to the Space Race

Sixty-three years ago, the morning of May 5th 1961, millions of Americans were glued to their televisions and radios... scared and praying.

Early that morning, Navy Commander Alan B. Shepard, Jr., wearing a specially designed pressurized space suit, climbed into the one-person Mercury spacecraft Freedom 7.

Yonkers accompanied Shepard into space that day. Spartan Hydraulics on Saw Mill River Road, a McDonnell Aircraft subcontractor, designed and manufactured the eight check valves on the Freedom 7 space capsule right here in Yonkers! These valves automatically controlled the flow of hydrogen peroxide through the chamber controlling the yaw, pitch and roll of the capsule; if needed, Shepard manually could control the valves.

Piloting Mercury spacecraft Freedom 7, he flew 116 miles into the air, then headed back to earth, a 302-mile suborbital flight. Shepard reported during the flight he was able to function, and everything was "OK."

At the end of the flight, the capsule parachuted into the Atlantic 15 minutes 22 seconds after take-off, an eternity to those waiting for his safe return.

Picked up by a Marine helicopter at 10:53 am, Shepherd was brought to the Naval pickup operation primary recovery ship, the USS Lake Champlain. Four Yonkers sailors were on the Champlain to cheer this American achievement: Signalman Third Class Edward Delapp of William Street; Seaman Robert France of Walnut Street; Seaman Neil Graner of Corley Street; and Shipfitter Third Class Paul Savage of Hudson Street. The Lake Champlain crewmen were told not to speak to the Shepard, as the medical staff didn't want his report influenced by any thought the men had.

Five weeks later, the City Council voted 7-6 to honor this amazing hero; they changed the name of two-block-long Tibbetts Place to Alan B. Shepard, Jr. Place, keeping him forever in the heart of Yonkers.

## President Biden Imposes Tariffs on Chinese Imports-100% on EV's; 50% on Solar Panels



President Biden's economic plan is supporting investments and creating good jobs in key sectors that are vital for America's economic future and national security. China's unfair trade practices concerning technology transfer, intellectual property, and innovation are threatening American businesses and workers. China is also flooding global markets with artificially low-priced exports. In response to China's unfair trade practices and to counteract the resulting harms, today, President Biden is directing his Trade Representative to increase tariffs under Section 301 of the Trade Act of 1974 on \$18 billion of imports from China to protect American workers and businesses.

As President Biden says, American workers and businesses can outcompete anyone—as long as they have fair competition. But for too long, China's government has used unfair, non-market practices. China's forced technology transfers and intellectual property theft have contributed to its control of 70, 80, and even 90 percent of global production for the critical inputs necessary for our technologies, infrastructure, energy, and health care—creating unacceptable risks to America's supply chains and economic security. Furthermore, these same non-market policies and practices contribute to China's growing overcapacity and export surges that threaten to significantly harm American workers, businesses, and communities.

Today's actions to counter China's unfair trade practices are carefully targeted at strategic sectors—the same sectors where the United States is making historic investments under President Biden to create and sustain good-paying jobs—unlike recent proposals by Congressional Republicans that would threaten jobs and raise costs across the board. The previous administration's trade deal with China failed to increase American exports or boost American manufacturing as it had promised. Under President Biden's Investing in America agenda, nearly 800,000 manufacturing jobs have been created and new factory construction has doubled after both fell under the previous administration, and the trade deficit with China is the lowest in a decade—lower than any year under the last administration.

The tariff rate on certain steel and aluminum products under Section 301 will increase from 0-7.5% to 25% in 2024.

The tariff rate on semiconductors will increase from 25% to 50% by 2025. The tariff rate on electric vehicles under Section 301 will increase from 25% to 100% in 2024.

The tariff rate on lithium-ion EV batteries will increase from 7.5%% to 25% in 2024,

The tariff rate on solar cells (whether or not assembled into modules) will increase from 25% to 50% in 2024.

The tariff rates on syringes and needles will increase from 0% to 50% in 2024. For certain personal protective equipment (PPE), including certain respirators and face masks, the tariff rates will increase from 0-7.5% to 25% in 2024. Tariffs on rubber medical and surgical gloves will increase from 7.5% to 25% in 2026.

#### ing the requested repairs.

Architect Stephen Tilly reviewed the list of required repairs and wrote that most were not necessary and could be completed in other ways.

Several community groups are now using the building through Beczak. They include the Yonkers NAACP, the Black Women's Political Caucus, and HRCA, the Hudson River Community Association. The recent troubles with the Nepperhan Community Center have resulted in these and other groups looking for other places to hold their meetings.

We spoke to Marcia Cooper, the President of the Beczak Center, "I would like to sit down once and for all, and hash this out. I would also ask that our lease be honored, through July of next year, and then we can work on a license agreement."

Latimer said that he is hopeful that all parties can come together and reach an agreement on the repairs and the sharing of the building between Beczak and Sarah Lawrence.

Currently, there are negotiations between the County Attorney and the attorney for Beczak over a license agreement referenced by Cooper above. The license agreement would replace the existing lease that Beczak has with the county.

The county is looking to move forward with the license agreement before the lease expires, and in exchange the county would pay for the maintenance -repairs.

Those negotiations continue.
