

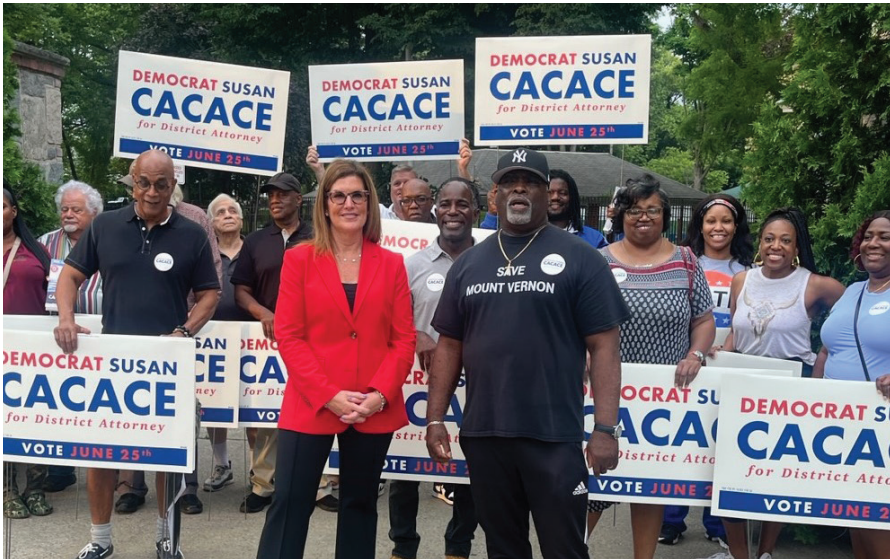

We Endorse: Susan Cacace for District Attorney Democratic Primary; June 25 Early Voting Begins June 15

Westchester Democrats will be asked to cast their vote, by absentee ballot, early voting or on primary day June 25 to determine who their party's candidate for District Attorney will be.

Incumbent District Attorney Mimi Rocah is not running for reelection. Three candidates are running in the democratic primary: Susan Cacace, William Wagstaff and Adeel Mirza.

After careful weighing the candidates, their experience, their platforms and their vision, we've decided to endorse Susan Cacace in the democratic primary on June 25 and in early voting starting June 15.

Cacace has the perfect combination, in our view, of experience, and new ideas to move the office of DA forward.

Cacace has served as a County Court Judge for 14 years. At the time of her retirement, December 7, 2023, Cacace was the longest tenured County Court Judge of Westchester County, having been elected in 2005 and re-elected in 2015. She gave up her County Court seat to run for DA, which is a testament to her desire to serve the people of Westchester as DA.

Shortly after she took the bench, Judge Cacace's unique qualifications and expertise in the areas of crimes against children and sex offenses committed against the most vulnerable victims, our children and our elderly, lead to her assignment to preside over the Sex Offense Part in 2010 - a position that she has continued to hold for the ensuing 14-years. In this capacity, Judge Cacace was responsible for handling all felony sex crimes throughout all phases of their prosecution in the County Court.

Man Charged with Attempted Murder After Beating Social Worker Now on Life Support

A Westchester County Department of Social Service social worker remains in critical condition one month after she was attacked in Peekskill. Maria Coto, 56, knocked on the wrong door during a home visit and was beaten nearly to death by Hasseem Jenkins, 31.

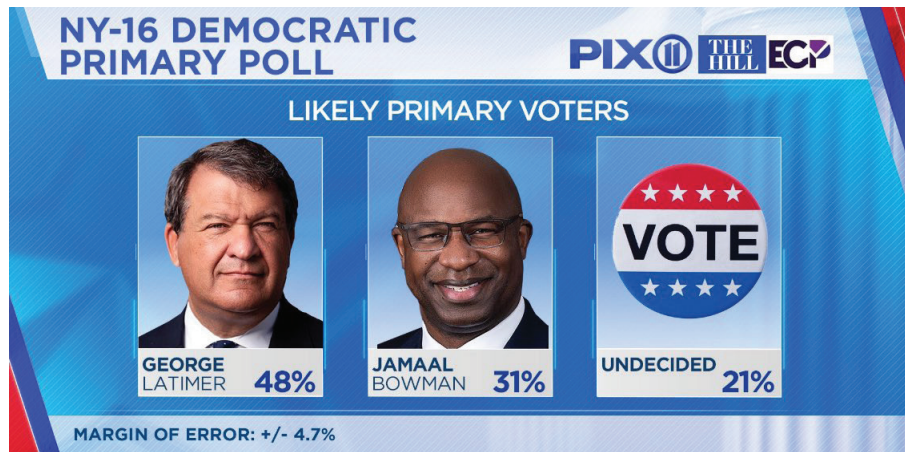
The incident occurred at 3pm on May 14, at apartments in the rear of 900 South Street, Peekskill. According to the criminal complaint, on May 14, Hasseem Jenkins, "... repeatedly punch[ed] [Maria] Coto with his fists and did repeatedly kick Ms. Coto with heavy boots ... above the head and body causing Ms. Coto to sustain severe brain bleed, swelling of the brain, and multiple facial fractures ..."

Neighbors in the apartments said that Jenkins grabbed Soto after she ran away from his apartment, threw her to the ground, repeatedly yelling "I'm going to kill you bitch."

Peekskill police quickly arrived after 911 calls were made and arrested Jen

As Bowman Makes Final Push, Latimer Up by 17 in Latest Poll

As Westchester Congressman Jamaal Bowman and his progressive supporters make a final push to try and help win his reelection, a new Emerson College Polling/PIX11/The Hill survey of the New York 16th Congressional District Democratic Primary finds 48% of voters support Westchester County Executive George Latimer, while 31% support incumbent Representative Jamaal Bowman. Twenty-one percent are undecided.

"Voters under 40 break for Bowman: 44% to 35%, while voters over 40 break for Latimer," Spencer Kimball, executive director of Emerson College Polling, said. "Democratic primary voters ages 40-59 break for Latimer 53% to 31%, while voters in their 60s break for Latimer 46% to 29%, and voters over 70 break for Latimer 53% to 22%."

Black voters break for Bowman, 48% to 34%, and white voters for Latimer, 62% to 20%. Hispanic voters are split evenly, with 36% supporting Bowman and Latimer respectively.

Fifty-one percent have a favorable view of the incumbent congressman, while 43% have an unfavorable view of him. Six percent are not familiar with Bowman. Sixty-five percent of voters have a favorable view of Latimer, while 23% have an unfavorable view. Twelve percent are undecided.

President Joe Biden holds a 69% job approval among Democratic primary voters, while 23% disapprove of the job he is doing. Governor Kathy Hochul has a 55% job approval, while 26% disapprove of the job she is doing in office.

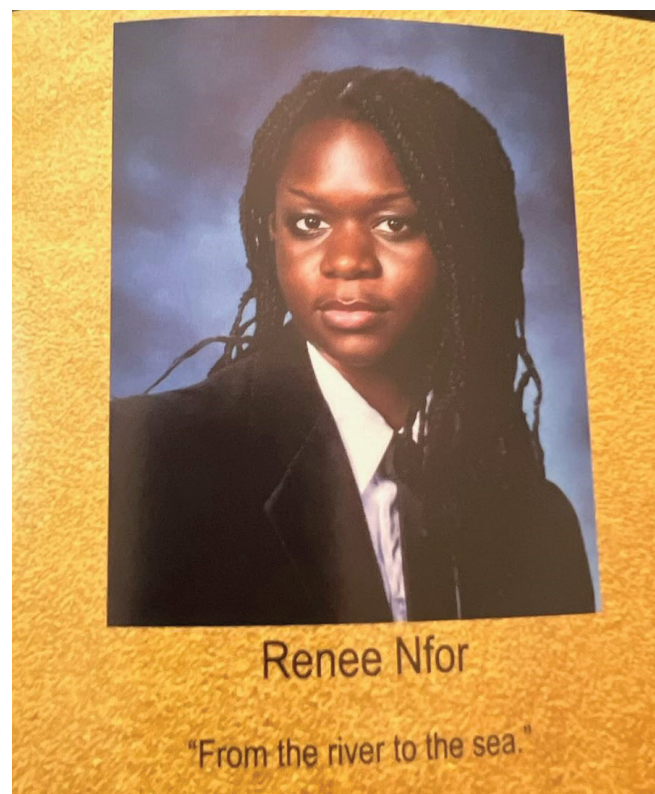
The economy (22%) and housing affordability (21%) are the top issues for Democratic primary voters in the district, followed by threats to democracy (14%), healthcare (13%), crime (12%), and immigration (6%).

Forty-five percent of voters align more with George Latimer on the war between Israel and Hamas, 29% align more with Bowman, and 26% are unsure.

Voters under 40 align more with Bowman than Latimer on the war, 54% to 32%, while voters 40-59 align with Latimer 43% to 28%, in their 60s, 52% to

Majority Leader Stewart-Cousins Leads Passage of First-in-Nation Legislation to Regulate Social Media Algorithms for Children

New Regulations Require Parental Consent for Curated Feeds for Users Under 18

Under the leadership of New York State Senate Majority Leader Andrea Stewart-Cousins, the Senate has passed groundbreaking legislation to prevent social media companies from showing harmful and addictive content to children under the age of 18, and limit the collection and use of children’s personal information.

“As we navigate the threats social media poses to our youth in today’s ever-evolving technological landscape, I’m proud that, under my leadership, the Senate is the first in the nation to pass legislation that would prohibit how social media companies can target children,” said Senate Majority Leader Andrea Stewart-Cousins. “These bills place the power back in the hands of parents and protect our children from addictive and exploitative practices. Together, we will continue to take all necessary actions to protect the mental well-being of New York’s children.”

The Stop Addictive Feeds Exploitation (SAFE) for Kids Act would prevent social media companies from showing addictive feeds – with content designed to keep children “glued” to devices – for users under 18, unless they have parental consent. It would also prohibit social media platforms from sending overnight push notifications, so that addictive notifications will no longer wake children in the middle of the night.

The Child Data Protection Act will limit media companies from collecting, using, sharing or selling personal information and data of anyone under the age of 18. Both pieces of legislation aim to protect children’s well-being and privacy.

“Our results suggest that gun buyback programs, have been inefficient use of tax payers dollars in the United States,” the authors conclude.”

“Perhaps deterring gun violence as alternate firearm-related policies, such as safe storage laws or stricter background checks would be more effective at deterring gun violence. Our findings also suggest that prior city (gun buyback programs) have been poorly designed to achieve their policy objectives.”

In my estimation, the ”Cash Bail Reform Law has been a dismal failure, releasing convicted felons back onto the streets to commit more violence.

Also, in a case where a felon kills an innocent person-the punishment should be “You take a life-you forfeit your own”-the verdict-- Life without parole.

The old adage applies here-“If you can’t do the time-don’t do the crime.”

Two Westchester Accountants Plead Guilty to Tax Fraud Conspiracy

Damian Williams, the United States Attorney for the Southern District of New York, and Thomas M. Fattorusso, the Special Agent in Charge of the New York Field Office of the Internal Revenue Service, Criminal Investigation ("IRS-CI"), announced that GEORGE SANOSSIAN and JACK N. SARDIS pled guilty to conspiracy to defraud the IRS, on May 29 and June 5, 2024, respectively, in White Plains federal court. Sentencing for both is scheduled for September.

U.S. ATTORNEY DAMIAN WILLIAMS SAID: "AS THEY ADMITTED IN COURT, THE DEFENDANTS, BOTH CERTIFIED PUBLIC ACCOUNTANTS, CONSPIRED TO FRAUDULENTLY REDUCE THE TAX LIABILITY OF CLIENTS OF THEIR ACCOUNTING FIRM. THIS CASE SERVES AS A REMINDER TO ALL AMERICANS THAT THEY ARE REQUIRED TO TRUTHFULLY REPORT THEIR EARNINGS AND THAT CRIMINAL PENALTIES COULD AWAIT THOSE WHO FRAUDULENTLY DECEIVE THE IRS, AS GEORGE SANOSSIAN AND JACK SARDIS HAVE LEARNED."

IRS-CI Special Agent in Charge Thomas M. Fattorusso said: "Schemes to conceal and reduce federal income and payroll tax liability, such as those utilized by Sardis and Sanossian, are unfair to every taxpayer who obeys the law and pays their fair share. These guilty pleas place the defendants a step closer to realizing the consequences of their actions."

According to the Informations, to which SARDIS and SANOSSIAN pled guilty, and statements made court: SARDIS and SANOSSIAN were certified public accountants and partners in an accounting firm in Scarsdale, New York, that provided accounting and income and payroll tax services to clients, including nine businesses in the construction industry (the "Clients"). From in or about 2012 through at least on or about April 15, 2018, SARDIS and SANOSSIAN agreed with Clients to scheme to: (i) fraudulently reduce the income tax liability of the Clients; (ii) conceal wages paid to employees by the Clients and, thereby, fraudulently reduce the Clients' payroll tax liability; and (iii) conceal personal income of the Clients. The defendants advised the Clients to participate in a scheme to reduce their federal income and payroll tax liability, pursuant to which the Clients issued checks made payable to a shell company and gave the checks to SARDIS and SANOSSIAN, who then caused the checks to be cashed at a check cashing service and returned the cash, minus a fee, to the Clients. Some Clients used the cash to pay employees without reporting the cash wages on their IRS Forms 941, thereby evading both their employer contributions to Social Security and Medicare and their obligation to withhold income tax on those wages, which permitted the employees to evade federal and state income tax. The owners and managers of some Clients took the cash for personal use without reporting the income on their personal federal and state tax returns. SARDIS and SANOSSIAN caused checks to be cashed in this manner for Clients in a total amount exceeding \$2 million.

SARDIS, 66, of Englewood Cliffs, New Jersey, and SANOSSIAN, 70, of

Former George Latimer Supporters Launch Westchester Progressives

New Grassroots Group Steps in With #LatimerLostUs Campaign to Support True Progressive Values in Heated NY-16 Primary

A group of volunteers and supporters that were behind George Latimer's County Executive run have come together to launch a new progressive, grassroots group opposing the 30-year politicians' controversial run for NY-16's congressional seat.

The group, called Westchester Progressives, is made up of progressive Democrats from across the county who say that while Congressman Jamaal Bowman champions the district's progressive values, Latimer has sold them out in both rhetoric and record.

Said Farah Kathwari, (George Latimer Transition Team member & Westchester County Human Rights Commission board member) "I voted for George Latimer because I thought we needed somebody who would stop trying to divide us along ethnic lines. Instead, he's spreading hateful rhetoric about Muslims and accusing people of being 'Hamas' supporters just for wanting peace. I remember what it was like after 9/11--I don't want that to happen to my children."

Brook Packard, a resident of George Latimer's hometown, Rye NY said, "We elected George to get MAGA Republicans out of Westchester. Now he's win-ing and dining with top Trump Donors, taking a million dollars from a Republican-funded PAC. They even registered thousands of Republicans as Democrats to vote for him. All to run against one of the most important progressive champions in Congress. He wasn't uplifting our values; he was uplifting himself."

The campaign's supporters cite Latimer's extensive support from Republicans, both through the AIPAC right wing lobby group which recruited Latimer to run and is spending over \$25 million to support him in what could be the most expensive primary ever, and directly from Trump fundraisers [he attended].

Said Sandra Bernabei (Founder, Antiracist Alliance, National Association of Social Workers President 2014-16) "We worked to build the Democratic party so we could keep unseating Republicans. We were ready to spend this year going all-in on helping Democrats, just like we went all-in on helping George beat Rob Astorino in 2017. Instead, we're now defending one of the most vital young Black progressives in Congress... from George! Running against Jamaal Bowman is dividing the party at the time we should be uniting."

Westchester Progressives are announcing their launch with the #Latimer-LostUs social media campaign. Members are asking like-minded progressives, who previously supported Latimer, to use the hashtag #LatimerLostUs to share their reasons why they are not endorsing George Latimer to represent them in the U.S. Congress.

Scarsdale, New York, pled guilty to one count of conspiracy to defraud the IRS, which carries a maximum sentence of five years in prison. SARDIS and SANOSSIAN have agreed to pay restitution to the IRS and New York State, representing the additional tax due and owing as a result of their conduct, in the total amount of \$652,883.60.

The maximum potential sentence in these cases is prescribed by Congress and is provided here for informational purposes only, as any sentencing of the defendants will be determined by a judge.

Mr. Williams praised the outstanding investigative work of the IRS-CI in this case.

The case is being prosecuted by the Office's White Plains Division. Assistant U.S. Attorneys Jeffrey C. Coffman and James McMahon are in charge of the prosecution.

Letter to the Editor: Reelect Congressman Jamaal Bowman on June 25th

To the Editor: I write to support the re-election of Representative Jamaal Bowman, in the upcoming Democratic Congressional primary on June 25th. In his two terms in office, Congressman Bowman has been a strong advocate for our community, and our district. He has brought in over \$1 billion in investments in education, child care, affordable housing, workforce development, as well as gun violence prevention – all solid investments that have immensely benefited his constituents.

Congressman Bowman's primary opponent, County Executive George Latimer, is campaigning on the slogan -- "Results, not Rhetoric" – to try and paint Mr. Bowman as a show horse, not a work horse. Elect me, says Mr. Latimer, and I will bring home the bacon since my opponent has not. This gimmicky catchphrase is transparently false, starting with the illogical premise that results and rhetoric are mutually exclusive. They are not, of course, and there's nothing inherently wrong about rhetoric either. We should always applaud solid results (which Jamaal has demonstrated), and captivating rhetoric (which he is a master of!). What's wrong with getting stuff done, as the Congressman has manifestly shown, AND speaking out for a more humane, equitable and inclusive multiracial society?

In stark contrast to his opponent, let's not forget that Congressman Bowman has also been a forceful spokesman for climate justice, having been an early champion of the "Green New Deal" (GND). He's also not afraid to take on the big polluters (i.e., fossil fuel power plants), and the fracking industry. He has also fought for a GND for Public Schools that would address the crumbling state of far too many public schools in underserved neighborhoods that suffer disproportionately from polluting infrastructure. Meanwhile, his opponent blithely vows that if elected "There is not going to be a George Latimer climate change bill." No surprise there from a pay to play County Executive whose "green" agenda includes keeping the Peekskill Wheelbrator, Westchester county's number one polluter, operating through 2029.

Jamaal has also demonstrated courageous and moral leadership in drawing attention to the plight of Palestinians and the need for both a permanent ceasefire in Gaza and a change in Israeli leadership. His opponent, meanwhile, fueled by millions in donations from right wing groups like AIPAC, has studiously avoided taking any concrete positions on Gaza, and in effect has validated the annexationist aims and ethnic cleansing of the extremist Netanyahu coalition.

Furthermore, during his televised debate last month with Congressman Bowman, Mr. Latimer infamously remarked "I'm not worried about who is giving me donations." I believe Mr. Latimer should be worried because many of us are (worried). We have learned of late that he has failed to file – as required by election law – a candidate financial disclosure statement. That failure does not install confidence.

Finally, let me express (and I'm certain I'm not alone in my sentiments) how fatigued and disgusted I am at the relentless deluge of flyers and attack ads that have saturated my e-mail inbox, TV screen, radio, etc. during this seemingly interminable primary contest. It is true that both candidates have engaged in this war of attrition. However, the sheer volume of Latimer's mailings and ad spots – enabled by over \$7 million in outside spending from reactionary groups such as AIPAC and MAGA donors --has been overwhelming. Win or lose, this does not speak well for the Latimer "brand," such as it is, and suggests a degree of desperation that his message has not been winning over any new voters.

On or before June 25th, (early voting begins on June 15), please vote to reelect Jamaal Bowman to Congress. I believe he is the superior candidate to deliver progress, and moral leadership to our district.

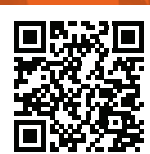

Major Organizations & Community Leaders Applaud Legislation to Protect Children Online

Unions, Community Groups, and Advocates Praise Legislation Advanced by AG James That Will Limit Social Media Features Harmful to Teen Mental Health, Prevent Collection of Children's Personal Data

After two bills that will help protect children online and which were advanced by New York Attorney General James, sponsored by Senator Gounardes and Assemblymember Rozic, and supported by Governor Hochul passed in the State Legislature, prominent unions, community groups, and advocates issued statements of support for the legislation. The bills, when signed into law, will help protect children by prohibiting online sites from collecting and sharing their personal data and limiting addictive features of social media platforms that are known to harm their mental health and development.

"The legislation that was announced here by Governor Hochul, Attorney General James, Senator Gounardes, and Assemblymember Rozic in October 2023, are set to become law, and our children will be safer as a result," said Michael Mulgrew, President of the United Federation of Teachers. "Bottom line: this legislation will help protect our students. As educators, we know the impact social media can have on our students' emotional health and well-being. Hopefully, other states will follow New York's lead."

"Educators see the harmful effects of social media on our kids every day, and this legislation is a tremendous first step toward ensuring these influences remain in their proper places," said New York State United Teachers (NYSUT) President Melinda Person. "We are grateful to the Legislature, the Attorney General and the governor for championing the mental health of our students as they navigate our rapidly changing world online. These platforms have potential to enhance teaching, learning and connectivity in our classrooms, but should never risk our children's health or safety. New York can lead the nation in creating protections for the mental and physical wellness of the future generation, and this is just the beginning."

"Hats off to New York's leaders who have made the safety and well-being of children and teens online a top priority," said James P. Steyer, Founder and CEO of Common Sense Media, the leading organization in the coalition to protect New York kids online. "From the start, Attorney General James, along with the Governor and their allies in the legislature, put together carefully crafted legislation that gets at the heart of what harms kids and their families online — the dangerous algorithms and constant notifications and the vacuuming up of kids' data that is all used to make more money for social media companies. Once these bills are implemented, that will change for kids and teens in New York. Instead, kids' data will be more secure, and the social media experience for young users will be healthier. That's really important. We are proud to have played a key role in this campaign, and we are deeply grateful to the Attorney General and other state leaders who got this done."

"We are grateful that New York has taken the lead in keeping children safer from the harms of social media," said Kathleen Spence, Middle School Teacher, Mother of Alexis Spence. "We appreciate that these bipartisan bills were passed so swiftly by Attorney General James, Governor Hochul, Senator Andrew Gounardes, and Assemblymember Rozic. Although both of our children are older now, we feel reassured knowing these laws are in place to protect students and future generations."

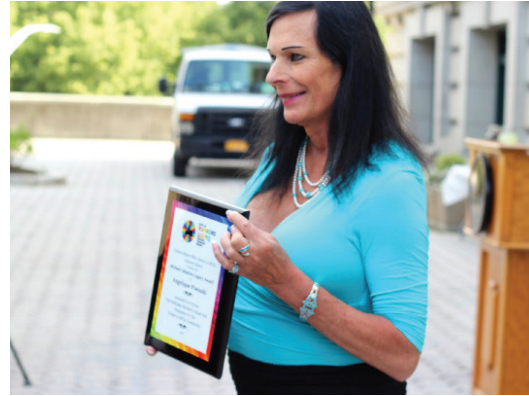

"Asian American girls are particularly vulnerable, with studies showing that they are both more likely to experience symptoms of depression and less likely to seek help from a school counselor. CACF congratulates Governor Hochul, Attorney General James, Senator Gounardes, and Assemblymember Nily Rozic for the passing of critical legislation that would protect the mental health of our young people and ensure that their personal data is safeguarded. The addictive nature of social media apps along with the lack of age-appropriate internet safeguards often create a perfect storm when it comes to anxiety, depression, body image, and mental health."

the sea,” as her yearbook quote.

The phrase “from the river to the sea,” has become more popular by Palestinian protestors after the October 7 attacks by Hamas on Israel.

According to the Anti-Defamation League, ADL, “From the river to the sea, Palestine will be free” is an antisemitic slogan commonly featured in anti-Israel campaigns and chanted at demonstrations. This rallying cry has long been used by anti-Israel voices, including supporters of terrorist organizations such as Hamas and the PFLP, which seek Israel’s destruction through violent means. It is fundamentally a call for a Palestinian state extending from the Jordan River to the Mediterranean Sea, territory that includes the State of Israel, which would mean the dismantling of the Jewish state. It is an antisemitic charge denying the Jewish right to self-determination, including through the removal of Jews from their ancestral homeland. Usage of this phrase has the effect of making members of the Jewish and pro-Israel community feel unsafe and ostracized. It is important to note that demanding justice for Palestinians, or calling for a Palestinian state, should not mean, as this hateful phrase posits, denying the right of the State of Israel to exist.”

In an email to the Yorktown High School families, Superintendent Ron Hattar wrote, “This afternoon we learned that one of the quotes in the 2024 YHS yearbook included language that is hurtful to members of our school community. We always strive to promote an inclusive environment for all students, and this quote runs contrary to our values. This was an oversight and we have already begun planning additional measures to include in our yearbook review process moving forward.”

Some parents and students are asking for more information about how this phrase was allowed to be printed in the yearbook, and who had the oversight for the yearbook before it went to press?

“Was the yearbook advisor aware of this message, and did they let it go through? Or were they unaware of it?” posted one parent on social media.

One parent of a Yorktown High School student, Rabbi Robbie Weiner, of Temple Beth Am in Yorktown, told News 12, “The students are told that they shouldn’t use words of hatred, political statements and things of this sort, this is absolutely hate speech.”

One YHS student added, “From the river to the sea to me, means, I hear that and that’s the land of Israel so I think no Israel. I was personally very upset that it was in the yearbook, and I wish they would address it a little bit more,” said Tailia Pierson.

A second letter that went out to the YHS community offered students a reprinted Yearbook without the quote, or they can be provided with a sticker to cover up the quote.

Others have called for this unfortunate incident to be used as an opportunity to educate Ms. Nfor and all students on how hateful this phrase is.

Governor Hochul Announces Overhaul at NYS Office of Cannabis Management

Appointees to Lead Operational Overhaul at OCM and Implement Recommendations from Task Force Report

Governor Kathy Hochul today announced three new leadership appointments at the Office of Cannabis Management, part of a sweeping operational overhaul of the agency launched last month. These appointments, including Felicia A. B. Reid as Executive Deputy Director and Acting Executive Director, put in place a leadership team that will implement changes to end the bottleneck of license applicants, improve communication with applicants and licensees, and reaffirm the agency’s commitment to the social equity goals codified in the Marihuana Regulation and Taxation Act.

“I’m committed to ensuring New York’s nation-leading cannabis market continues to thrive,” Governor Hochul said. “With these new appointees, the Office of Cannabis Management will continue to focus on expanding the most equitable adult-use market in the nation while cracking down on illicit storefronts.”

The Governor also announced a nationwide search for a permanent Executive Director of OCM to lead the agency as it works to grow and support the nation’s most diverse and equitable legal cannabis marketplace. The Governor’s Appointments Office will work with an experienced recruitment firm to identify qualified candidates from across the state and the country.

Felicia A. B. Reid has been appointed Executive Deputy Director and Acting Executive Director. In this role, Felicia will oversee major operational and regulatory functions of the office including licensing, compliance and enforcement. She will manage the implementation of the OCM Assessment Team’s recommendations in partnership with OCM leadership and staff.

Felicia has over a decade of experience in State government and spent the last six years at the Office of Children and Family Services, including overseeing statewide juvenile justice operations as Deputy Commissioner. She is admitted to the New York State Bar Association and earned her law degree from New York Law School. She also has a Bachelor of Arts from Fordham University.

Office of Cannabis Management Executive Deputy Director and Acting Executive Director Felicia A. B. Reid said, “I am excited to work with everyone at OCM and our partners statewide to expand upon the agency’s work, build best internal and external practices, and focus on making New York’s cannabis industry one that meets the needs of small businesses and consumers. Cannabis is an enormous opportunity for our state, and OCM is obligated to ensure that its work makes those opportunities accessible, transparent, and responsive to the industry’s movement and trends. I want to thank Governor Hochul for this opportunity and look forward to doing the work with equity as the central-most focus of OCM’s way forward.”

Susan Filburn has been appointed Chief Administrative Officer. This new position will focus on stabilizing and formalizing administrative functions of the agency to support licensing, compliance and enforcement operations. She will also work closely with the licensing and technology teams to implement process improvements to streamline the license review process and improve responsiveness.

Susan has more than 20 years of experience in State government, including the last four years as Deputy Commissioner of Employment Security at the Department of Labor. Susan is a U.S. Army Veteran who served in numerous locations as an Aviation Officer. Jessica Woolford has been promoted to the position of Director of External Affairs. kins, charging him with second-degree attempted murder, a Class A-1 felony, and first-degree assault. Soto was taken by ambulance to Westchester Medical Center and put on a ventilator.

In the complaint, the District Attorney's office states that the victim required immediate surgery at Westchester Medical Center and requires a ventilator in order to breathe.

The Peekskill Herald reported that Jenkins has a violent criminal history that includes disorderly conduct for fighting and violent behavior in 2023, and in 2011 he was charged with 2nd degree assault, a Class D felony, for punching a 16 year old boy in the face leaving a party.

Westchester County Executive George Latimer said, "This unforeseen and tragic incident has prompted us to take immediate action to protect our personnel from further harm while they perform their duties on behalf of the County of Westchester. DSS staff perform essential work within the community, we respect them and we want to do all we can to keep them safe."

Westchester County has announced additional safety measures for its staff. Effective immediately, DSS will offer enhanced security escorts for staff during community and home visits. While DSS has long provided escort services, the new initiative expands their availability to cover more visits and programs.

Century Protective Services, Inc. will provide escorts on a case-by-case basis to assist DSS staff.

DSS Commissioner Leonard Townes said: "Due to the urgent nature of this situation, DSS has determined that an immediate contract with a security services provider is necessary. Our employees perform the most selfless work, and we want to ensure their safety every step of the way."

We join Latimer in saying, "Our thoughts are with Marie Coto and her family during this difficult time." Jenkins faces 25 year in prison.

Letter to the Editor:

I'm a mother who is angry about the lack of action on climate.

I am writing to ask you to cover the story of the medical dangers inherent in the use of gas stoves in people's homes.

Right now, mounting evidence suggests deleterious harms associated with gas stove use. (1)

In fact, New York State, as well as Illinois and California are considering legislation to promote informed consumer choice by requiring warning labels to be attached to new gas stoves. The California bill just passed the Assembly and is headed to the Senate.

The gas industry and appliance manufacturers are, of course, disputing the science and trying to cast doubt on it. This strategy echoes the way the tobacco industry tried to fight against public education regarding the harmful effects of smoking. That similarity of strategy is not just coincidence. The gas industry has fought against public understanding of the health harms since the 1970's often partnering with the same strategists and PR people who worked with the tobacco industry. (2)

The industry has recently been getting called to task for allegedly hiding the facts regarding the hazards to human health. Last year three separate class-action lawsuits were filed regarding allegations that the industry was obfuscating the truth about the harms from worsening indoor air quality. Another case was brought in May of 2024 in the District of Columbia Supreme Court accusing a manufacturer of GE appliances of breaking the Consumer Protection Procedures Act by failing to inform the public of indoor pollution risks. In addition, Judge Cacace served as the first presiding judge of the DWI Part of Westchester County, where she spearheaded the crafting of consistent dispositions of all felony-level DWI cases throughout Westchester County from its creation in 2014-2023.

And during this campaign, Cacace announced her support for new legislation to aid sexual assault victims and vigorous prosecution of sex crimes in Westchester. Legislation introduced by Senator Michael Gianaris and Assemblywoman Amy Paulin would allow New York State Courts to make evidence of prior sexual offenses admissible at trial. This legislative move follows the reversal of Harvey Weinstein's 2020 rape conviction by New York's highest court.

"Evidence of other sexual assaults by the abuser should be admissible in court as long as it doesn't create an unfair bias. Victims should not be silenced.

"If elected DA, I will do everything in my power to make sure that sex crimes are vigorously prosecuted and that survivors of these heinous crimes get the justice they deserve."

We have confidence in Cacace's ability as DA to balance the needs of victims with the rights of the accused.

We find Susan Cacace to be the most experienced and qualified candidate running for Westchester District Attorney. William Wagstaff's campaign claims that the criminal justice system needs re-imagining. While crime is steady in Westchester at large, we are wondering how an attorney with only 7 years of experience, none of which we are told has ever been prosecutorial, expects to run an office that processes approximately 20,000 cases a year. Aside from his lack of experience, how can the DA effectively prosecute cases without a strong, respectful, collaborative relationship with local law enforcement? As per the wagstafforda.com website, we could not find any endorsements from local law enforcement groups before our publication.

And Wagstaff did not pay his Federal Income Taxes over a six-year period, totaling more than \$189,000, and he did not find his tax troubles worthy of mention to Westchester democratic leaders we spoke to, who were concerned and disappointment and had no knowledge of this before the story broke.

Wagstaff recently earned \$726,000 from the City of Mount Vernon as a "Special Prosecutor" but did not use his earnings to pay his taxes on time, resulting in several democratic leaders asking the question, if you can handle your personal finances, how can we trust you to run the office of Westchester District Attorney?

DINAPOLI AUDIT FINDS AS MUCH AS \$1.5 BILLION IN "QUESTIONABLE, IMPROPER" MEDICAID SPENDING

An audit released by New York State Comptroller Thomas P. DiNapoli found Medicaid managed care organizations made as much as \$1.5 billion in improper and questionable payments to providers who did not appear to be enrolled in Medicaid. Generally, under federal and state law providers are supposed to be enrolled, a process that gives DOH assurance that they are equipped and eligible to deliver services.

"The deadline for managed care organizations and their providers to comply with enrollment requirements was over five years ago, yet our audit shows payments to providers that are still not enrolled in Medicaid or have been denied," DiNapoli said. "Medicaid is vital to millions of New Yorkers in need of quality health care and the Department of Health must do a better job ensuring the program's integrity."

DOH pays for Medicaid in two ways — fee-for-service and managed care. Under fee-for-service, DOH pays Medicaid enrolled providers directly for health care services. Under managed care, DOH pays monthly premiums to Managed Care Organizations (MCOs) for each enrolled Medicaid recipient and in exchange MCOs arrange for services with providers.

Under the federal 21st Century Cures Act, in-network managed care providers were required to be enrolled in Medicaid by January 1, 2018. Enrollment informs DOH that the providers are licensed, credentialed, and able to provide Medicaid services. MCOs are supposed to terminate providers from their networks who do not enroll in the state's Medicaid program.

After services are provided and paid by MCOs, they then submit claims that report the services to DOH. Auditors reviewed claims from January 2018 through June 2022 and found \$1.5 billion in improper and questionable claims:

Five MCOs paid \$916 million in claims for services by in-network providers whose IDs did not match with a Medicaid enrolled provider on the date of service.

\$832.5 million in claims were for services by providers whose Medicaid application was denied or had been withdrawn by DOH either because they failed to meet Medicaid program standards or were automatically withdrawn because the application was missing information. For example, one pharmacy was denied enrollment by OMIG due to unclean conditions, lack of proper supporting documentation, and expired medications on pharmacy shelves, yet received over \$57 million in MCO payments. (\$212 million of the \$832.5 million was included in the \$916 million referenced above).

\$9.6 million in improper MCO payments went to in-network and out-of-network providers who were excluded from or otherwise ineligible for the Medicaid program. (\$548,184 of the \$9.6 million was included in the \$916 million referenced above.)

MCOs are supposed to maintain a network of providers that can deliver comprehensive care to their enrolled population. They submit their contracted providers to DOH's Provider Network Data System (PNDS) at least quarterly. The data system helps DOH ensure MCOs are meeting requirements of federal and state regulations and the providers are entered into the NYS Provider and Health Plan Look-up website. DOH also uses PNDS to create error reports for MCOs to identify unenrolled in-network providers.

DiNapoli's audit found PNDS error reports were flawed and did not capture all unenrolled in-network providers. Even when providers were identified on error reports, auditors found MCOs often did not make timely fixes to their submissions to DOH. For example, one physician was flagged on 12 consecutive error reports for one MCO that indicated the physician was not enrolled. The audit concluded that the MCOs' lack of response could be attributed at least in part to inadequate DOH oversight and communication.

DiNapoli's audit recommended that DOH improve its oversight of MCO claim payments, ensure MCOs are following the requirements under the Act, and review the payments and providers the audit identified and take appropriate action, including recovering money where appropriate.

DOH generally agreed with most of the audit's recommendations, and said it is examining the audit findings to determine how to best address the issues raised. 17%, and over 70 49% to 22%.

A plurality of Democratic primary voters (43%) are less inclined to support a member of Congress who opposes a ceasefire in Gaza, while 37% are more inclined to support a candidate who opposes a ceasefire. Twenty percent say it has no impact on their support.

Male voters are more inclined to support a candidate that opposes a ceasefire in Gaza, 41% to 36%. Female voters are less inclined to support a candidate that opposes a ceasefire, 47% to 35%.

Half (50%) of Democratic primary voters think the U.S. government is spending too much on aid to Israel in the war with Hamas, a third (33%) think the U.S. is spending the right amount, and 17% think the U.S. is spending too little. Regarding humanitarian relief to Palestinians in Gaza, 46% think the U.S. is spending too little, 34% the right amount, and 21% too much.

A majority of voters (55%) think there is about the same amount of crime in their area as there was a year ago, while 28% think there is more crime, and 17% find there is less crime.

Sixty-four percent of Democratic primary voters approve of President Biden's executive order that prevents migrants from seeking asylum at the U.S.-Mexico border once the average number of daily encounters hits 2,500 between ports of entry, while 23% disapprove, and 13% are unsure.

The polls comes after the last debate between Bowman and Latimer was held on June 9 by the League of Women Voters of Westchester. The debate was held online on Zoom, and did not include any "knockouts" on either side.

Bowman's supporters tried to highlight a comment Latimer made about Bowman not paying enough attention to the Westchester communities in his district. "You get as much money as you can from outside the district. Your constituency is Dearborn Michigan, your constituency is San Francisco," said Latimer.

Jasmine Gripper, Co-Director of the New York Working Families Party, has issued the following statement. "George Latimer has traded in his dog-whistle for a bullhorn. The diversity of NY-16 is one of its strengths, but you wouldn't know it from Latimer's campaign. His bigoted comments against Arab-Americans is the latest in a series of racist appeals that have only served to divide the community. Voters in NY-16 deserve leadership that will treat all constituents with decency and respect. That's not George Latimer."

Latimer's campaign responded with, "another day another lie from Jamaal Bowman. George's comments were taken out of context, because in the same breath he also mentioned San Francisco. The reality is the incumbent has failed the district and has lackluster support. The majority of the incumbents donations come from thousands of miles away."

Bowman recently received the endorsement from more than a dozen clergy members citing his strong moral leadership and steadfast commitment to uplifting the needs of working families as key reasons for their support. Rev. James Duckett, Rev. Dr. Stephen Pogue, Rev. Patrick Goodman, Rev. Louis, Rev. Carlton Spruill, Rev. Gene Girtman, Rev. Verlin Williams, Bishop Angelo, Rev. Debra Jenkins, Bishop Leslie Rawlings, Elder Diane Berry, Rev. James Robinson, Rev. Stephen Green, Rev. Mark Thompson, Rev. Veron House, Rev. Willie Spencer, Rev. Robert Williams, Rev. Nancy Rosario, Rev. Donna Modeste.

"Congressman Bowman is the champion we need in Congress," said Pastor Mike McBride, founding member of Black Church PAC. "His commitment to peace and justice at home and abroad is consistent with our values and we are excited to endorse his campaign to continue to serve in Congress. Now more than ever, we need moral and principled leadership on issues impacting the most vulnerable."

Bowman also commented on the recent poll, stating "The voters of our district have been flooded with polls and attack ads for months, dividing our community and distorting my record. AIPAC's Republican megadonors have spent a record setting \$13 million dollars to sow disillusionment and depress turnout. But this election is about the many versus the money. Our volunteers are talking to tens of thousands of voters across the district every week, and our data shows consistently that through direct conversations, voters see through the lies and are energized to reject AIPAC's attempt to buy this seat. On June 25th, we decide." A poll in April also had Latimer with a 17 point lead.

A recent NY Times story has Bowman stating that "I'm still a member," of the Democratic Socialists of America, (DSA) and "I didn't let my dues lapse."

The story continues, "Pressed by members to explain why his office had publicly stated otherwise, he added: "Media has a tendency to talk about B.S., and not focus on the race. And we wanted to make sure we were focusing on our race at that time and getting re-elected."

Bowman was endorsed by DSA in 2020, not endorsed by DSA in 2022, and has now been endorsed for the democratic primary this year.

DSA was criticized for posting this on Twitter-X after the October 7 attacks by Hamas on Israel. 'One could (and should) very well argue that in a settler colonial context there are no such things as "civilians", but disregarding that even, it's total folly to honestly compare settlers perpetrating pogroms to resistance groups deploying violence to liberate themselves.'

DMFI PAC Chairman Mark Mellman said, "That Congressman Bowman admits to having lied to get re-elected is a sad commentary on his character. His hostility to the truth is only matched by his hostility toward his own constituents — all of them — and President Biden. Bowman falsely attacked 'everyone in [his] district,' as well as President Biden, for dehumanizing an entire people. It's hard to imagine why anyone would vote for a candidate who lies to them and then attacks them all."
