

Yonkers Police Warning: Beward of Card Skimming Devices at Local ATM Machines

State Supreme Court Judge George Fufidio ruled on April 21 that changes made to the City of Yonkers Term Limits law in November 2022 by a vote from the Yonkers City Council, and signed into law by Mayor Mike Spano are lawful. The vote changed the number of terms that the Mayor and Councilmembers from 3, four-year terms, to 4 four-year terms.

Yonkers and the term limits for each City Council office was unlawful. Though it is not entirely

Judge Fufidio ruled on a motion to dismiss by attorneys for Mayor Spano and the Council on April 21. While Fufidio denied the motion to dismiss, he went on to rule that "there were no ethical violations committed by the Yonkers City Council by increasing their own and the Mayor's term limits."

In addition to finding no ethical violations in the vote to extend term limits, Judge Fufidio ruled "this Court does not find that the increase in term limits for the City of Yonkers Mayor and the Yonkers City Councilmembers violates the Yonkers City Charter."

"The Court agrees with the Respondents that this case is, factually and legally, almost identical to the Molinari case (Molinari v Bloomberg in which the Federal Eastern District and Second Circuit courts found that the increase in term limit for the New York City Mayor, City Councilmembers and other city officials was lawful. "

"More specifically, using the same analysis as the Molinari court did, this Court does not find that the increase in term limits for the City of Yonkers Mayor and the Yonkers City Councilmembers violates the Yonkers City Charter section C1A-6 ethical standards. Section CIA-6 prohibits a city employee from using their official position in a manner that they either know or have reason to know may

Tips When Using an ATM or POS Terminal

- Inspect card readers before using. Look for anything loose, crooked, damaged, or scratched.
- Cover the keypad when you enter your PIN and beware of false keypad overlays.
- Use ATMs in a well-lit, indoor location, which are less vulnerable targets.
- Be alert for skimming devices in tourist areas, which are popular targets.
- Contact your financial institution if the ATM doesn't return your card after you end or cancel a transaction.

The Yonkers Police is presently investigating two incidents of card skimming devices having been found installed on the Webster Bank ATM machine located at 760 McLean Avenue. These devices are utilized to steal people's bank card information and often leads to fraudulent account charges. Customers who used this ATM in the past month should check their accounts for suspicious activity and report the same to their financial institutions.

Skimming devices can be present at ATM machines, gas station fuel pumps, and outdoor point of sale locations; they can sometimes be installed at indoor locations as well. Consumers must be vigilant and check their accounts frequently, even daily, to protect against electronic fraud and theft.



At this event he praised the work of the Daughters of the American Revolution (DAR) for their efforts to maintain and preserve historic sites like Philipse Manor Hall.

Yonkers Educators Rally For Fair Contract at Board of Education Meeting



The Yonkers Federation of Teachers rallied at Saunders Trades and Technical High School Wednesday to demand a fair contract that protects students amid nine months of minimal progress with the city school district. The union's last contract expired June 30, 2022.

YFT was joined by New York State United Teachers, the American Federation of Teachers, educators from neighboring districts, other local unions and community members as they marched into the Board of Education meeting and put pressure on the Board and superintendent to come to an agreement by the end of this school year.

For nearly a year, the union has been fighting for a contract that addresses what students need including smaller class sizes so they are more in line with the state average; adequate staffing to meet students' social-emotional needs; support staff caseload caps; and incentives to recruit and retain educators, especially those who are bilingual, amid a national teacher shortage.

those who are bilingual, amid a national teacher shortage. "We love our students and we love to teach," said YFT President Samantha Rosado-Ciriello. "Our children deserve quality education in a safe environment conducive to learning. That all starts by giving teachers the support and respect they deserve as professionals. It is time for the school district to do the right thing and work with us to ensure a bright future for Yonkers students."

YFT represents 3,600 in-service and retiree members including classroom teachers, teaching assistants, substitute teachers, school counselors, psychologists, social workers and other certificated personnel.



On This Day in Yonkers History...



Lou Gehrig visited Yonkers Boys Week in 1928

Monday, May 1st

May 1, 1929: After being interrogated all night by Yonkers Police, Earle Peacox confessed to the torch murder of his twenty-year-old wife Dorothy. Peacox. YPD believed Earle became jealous after reading a letter friend Eugene Bussey wrote to her and killed her. Bussey regretted writing the letter and planned to help the Peacox defense.

May 1, 1939: Several Park Hill property owners were dismayed to learn the deed for the former Valle Mansion on Park Hill Avenue in Lowerre Summit (original map showed not technically Park Hill) was filed with County Clerk Harold Mercer; this confirmed the rumor the mansion would be used as a "heaven," or a residence for Father Divine's followers. A few neighbors were upset, but their soon-to-be next door neighbor Maurice Blinken said he was not. He stated, "If Father Devine has taken the house, I might observe he is a neighbor, also, of President Roosevelt. I feel honored to be placed in the same class as the President."

Blinken, grandfather of Secretary of State Antony Blinken, was former President of the Yonkers Board of Education and Chairman of the Yonkers Public Library Board.

Tuesday May 2nd

May 2, 1939: Earle Peacox was brought back to Police Headquarters to identify a dress mailed to the police station allegedly belonging to his wife; he couldn't.

May 2, 1961: Yonkers City Clerk William Gray testified before the State Investigations Committee (SIC) studying bingo licensing. While being questioned by the Commission's Chief Counsel Carl Vergari, Gray stated he asked for a \$500 loan from bingo games operator William Buckner. Gray became distraught while repeatedly denying he had taken any money and claimed not to remember when asked questions about Buckner. A Commission investigator took the stand after Gray and testified Gray received \$500. State Lottery Control Commission investigators admitted accepting money from Buckner.

Wednesday, May 3rd

May 3, 1929: District Attorney Frank Coyne announced Eugene Bussey would not be useful to the prosecution of Earle Peacox as Bussey sold both his story and the letters he received from murder victim Dorothy Peacox. Bussey was held as a material witness.

May 3, 1961: Acting Mayor Michael Nugent asked First Corporation Counsel John Trainor to acquire a transcript of City Clerk William Gray's testimony before the State Investigation Commission (SIC) inquiry on bingo licensing in Yonkers; the investigation focused on William Buckner.

While being questioned as a witness when called before the SIC, Buckner refused to answer on constitutional grounds 55 times during questioning, including whether he knew several high-level known members of organized crime.

The Brewster, N.Y.—based Siscas are longtime developers in the Hudson Valley. They built the CSEE's \$27 million new high school at 220 Warburton Ave., which opened in 2021. The Sisca Organization's other noteworthy Yonkers work includes Schoolhouse Terrace, 121 affordable housing apartments at 33 Ashburton Ave., and the outdoor water park at Tibbets Brook Park.

The Hospital for Special Surgery has a longtime sports medicine outreach program with the CSEE, helping to reduce the incidence of injury among the school's sports teams. Mercy College partners with the CSEE to help its students prepare for college, while Deputy County Executive Jenkins has tirelessly supported public education in Yonkers in all its forms.

The CSEE's new high school will graduate its first senior class in June. Some of the graduating seniors received acceptances from Cornell University, Fordham University, the Rochester Institute of Technology and Seton Hall University. The most popular schools with the CSEE's Class of 2023 are Mercy College, Pace University and Manhattanville College.

City of Yonkers Dedicates Martin Ginsburg Park

In Greystone Neighborhood Liking Warburton Ave. to Old Croton Aqueduct Trail

Yonkers Mayor Mike Spano joined Ginsburg Development Companies and city officials to celebrate the dedication of the Martin Ginsburg Park in the Greystone neighborhood that links Warburton Avenue to the Old Croton Aqueduct State Trail.

Among those joining Mayor Spano and Martin and Irene Ginsburg were Steve Sansone, Commissioner, Department of Parks and Recreation; Council President Lakisha Collins-Bellamy; Council Majority Leader Tasha Diaz; Council Minority Leader Mike Breen; Council Member Shanae Williams and Deputy Mayor Anthony Landi. "Working with GDC, Yonkers is repurposing underutilized land, reimaging our public, green spaces and reconnecting communities," said Yonkers Mayor Mike Spano. Aviation Defense School in the old School Ten; this ten-week intensive course would qualify them for vital war industry skilled labor jobs. Most women signed up for the 7:30 am to 4 pm shift, but others wanted the 4:00-11:30 pm or the 11:30 pm to 7 am section. Assistant Principal Earl Carroll said the women were "keenly interested" and were fully aware the course work was "not a child's play or game but a serious thing." The course was an eight-hour-a day, five-days-a-week commitment. And yes, there was homework!

result in afinancial benefit for themselves or enumerated others (Yonkers City Charter sec. CIA6). Financial benefits are defined by the Yonkers City Charter as a pecuniary or material benefit that is not available to the general public (Yonkers City Charter sec. CIA-4(I)).

"Simply put, the term limit increase and the concomitant salary is not the kind of "financial benefit" contemplated by such rules. First, it is a benefit which is not guaranteed to Mayor or any of the Councilmembers. Each still needs to win their seat in a general election, which leads to the second point, that is the seat, salary and term limited office is potentially available to anyone who is eligible to run for office in the City of Yonkers.

"Third, the Yonkers City Charter authorizes the City Council to vote on, among other things, their own and the Mayor's salary increases without that being considered a "financial benefit". That they are able to do so is entirely consistent with the New York City Conflicts ofInterest Board's (COIB) advisory opinion that was heavily relied upon in Molinari and which also cited to New York State case law, Golden v New York City Council, 305 AD2d 598 [2nd Dept. 2003]).

"The COIB held that the New York City Council had the authority to enact laws regarding term limits. Critically, the COIB concluded, and the Molinari court agreed, that a reading of the New York City ethics regulations, which are arguably more restrictive than the Yonkers equivalent, prohibiting sitting Councilmembers from voting on increasing their own term limits would effectively deprive them of authority granted to them by State and local laws and afortiori would prohibit them from voting on anything affecting their office, such as salary increases and, ironically, ethics regulations; resulting in governmental standstill (Molinari II, 564 F3d at 616).

"Here, the Court sees no difference between the authority the New York City Council had to increase the Mayoral and City Council term limits and the authority that the Yonkers City Council has to do the same and thereby declares that there were no ethical violations committed by the Yonkers City Council by increasing their own and the Mayor's term limits.

"Next, although Municipal Horne Rule Law sec. 23 requires that changes to the laws of succession of certain offices (MHRL sec. 23(2)(d)) and changes to the term of an elected office (MHRL sec. 23(2)(e)) be put to the people in the form of a referendum, New York State decisional law has held that a change to the length of term limits that does not change the length of a term of office does not need to be enacted by a referendum."

"Finally, although the City of Yonkers voters have twice in the recent past, in 1994 and 2001, voted directly on the establishment of term limits, there is no requirement that the referendum process be applied to future term limit modifications and it is recognized that, "laws proposed and enacted by the people under an initiative provision ... are entitled no greater sanctity or dignity" that those passed by the legislature

"As the Molinari court explained using Caruso as its rationale, neither the Municipal Home Rule Law nor the New York City Charter restrict the legislature's ability to modify laws passed by referendum. Here, again, this Court does not find that the Petitioners have shown the law in the Yonkers City Charter to be otherwise and thus declares that the City was not required to hold a referendum vote on whether to raise the term limits in question despite having done so in the past.

"Accordingly, the Respondents motion to dismiss is denied, however the Petitioners victory is pyrrhic because the court ultimately finds that the petition must be denied as well," wrote Judge Fufidio.

May 5, 1961: After an absence of two days following testimony before the Yonkers bingo inquiry by State Investigation Commission, City Clerk William Gray reported to his office in City Hall. No one had any idea as to where he was or how to reach him during his absence.

Saturday May 6th

May 6, 1914: Mayor James Lennon gave Yonkers resident William Mangels an official Yonkers welcome at City Hall; Mangels had been wounded in the fighting at Vera Cruz.

May 6, 1929: Defense attorney Sidney Syme accused Captain Silverstein of beating client Earle Peacox during questioning and causing a toothache. The charge was "vigor-ously denied" by DA Coyne and Silverstein. Several pieces of furniture were smashed during questioning, but, according to the DA, the damage was caused by Peacox. Coyne said Peacox threw a chair across the room and ripped up notes the stenographer was taking.

Sunday, May 7th

May 7, 1919: The three hundred soldiers camping at Van Cortlandt Park were given free privileges to the Yonkers YMCA and its swimming pool to get relief from the May heat wave.

May 7, 1928: More than 3,000 people came to greet New York Yankees star Lou Gehrig at Glen Field as Yonkers closed the 1928 Boys Week with athletic games.

BOL Chair Borgia Won't Resign After Dems on County Board Ask, Due to Anand Singh Scandal

The fallout from the scandal involving Anand Singh, former staff member at the Westchester County Board of Legislators who was caught in an online, undercover underage sex sting, continues after 14 democrats on the Westchester County Board of Legislators have called on Board Chair Catherine Borgia to resign.

BOL Chair Borgia, in a statement on April 25, refused to resign. "During my time on the Westchester County Board of Legislators, and more recently as Chair, we have indeed passed historic and life-changing pieces of legislation. Make no mistake about it – my record is indeed unprecedented. Additionally, during my time on the Board, I have faced numerous challenges, but none more troubling than the situation in which we find ourselves today.

"Instead of the facts of the situation, some of my colleagues have been distracted by politics and personal advancement. They believe a political witch hunt against me will advance them individually.

"We all agree that the staffer who was fired displayed conduct that was deeply disturbing, that is clear. We have the opportunity to use this situation to make our institution stronger and more resilient, instead it is being weaponized for personal benefit.

"Targeting me is an example of pervasive misogyny and political hubris that will destroy this institution. This is not just about one incident or one individual – it is about a culture of disrespect and disregard for women's contributions and voices.

"I have followed the law. I have upheld the County Charter. I have followed the ethics laws and Rules that govern this body. I am proud of my unparalleled record of legislative accomplishment and leadership in the service of the people of Westchester. I will not resign."

On April 24, the statement from the democratic legislators on the BOL reads," "We, members of the Westchester County Board of Legislators, are asking Chairwoman Catherine Borgia to resign from her position as Chair. While she has been a leader that has guided us through historic and life-changing pieces of legislation, we have lost confidence in her ability to lead this body and the staff that supports it. Government's job is to protect people and ensure those ideals are clear in our words and actions."

Also prior to Borgia's statement, a story from The Yonkers Ledger claims that Westchester County Police Commissioner Terrance Raynor recommended that Singh be fired. The story reads, "Being unable to secure the video evidence he sought, even from Ramy, Raynor still made a recommendation to Chairwoman Borgia. Commissioner Raynor told Borgia that while not able to fully corroborate the claims, that she should still terminate the employment of Anand Singh. He even assured her that he would handle it personally saying, "I'll come up there and escort him out myself." https://www.theyonkersledger.com/news/police-advice-to-legislators-chair-borgia-on-accused-sex-predator-fire-him/3258/.

The FBI and Westchester DA Mimi Rocah are investigating the Singh matter. Singh has yet to be charged with a crime or arrested.

Food Insecure Westchester Families: "This is Not Enough"

Tens of thousands of Westchester residents and families are "Food Insecure," which means that they are unsure where their next meal will come from?

We recently received a message from Feeding Westchester and their distribution manager

NO LIGHT AT THE END OF THE TUNNEL...

We were at a distribution in Shrub Oak. It was a drive-thru, and we asked each vehicle, "How many families do you have?" We often need to measure ourselves because the line keeps on getting longer as time passes. One particular SUV had five families. We couldn't give them what they needed.

The gentleman driving was very frustrated. He said, "This is not enough."

People are already frustrated because they can't make ends meet. Now, they come to a distribution where they think they'll get enough food and there's not always enough. And they need it. It was upsetting. It's hard to say, "No."

The lines are getting longer, by about 30%. Some places a little bit more. The SNAP benefits have been cut and this lady was receiving almost \$300 per month. Now she's receiving \$66. What can you buy with that? It's a sad situation. No light at the end of the tunnel as of now. This is not something that everybody sees. It's unfortunate. Hopefully we can get more people to support us," writes Pozo.

Every Sunday, on our way to church, my wife and I drive by the Peekskill-Cortlandt 7th Day Adventist Church in Cortland Manor. This Feeding Westchester mobile food pantry gives away a food bag every week, and we have noticed the lines of cars starting earlier and stretching longer.

And food insecurity for many Westchester families is expected to increase now that emergency SNAP benefits has now come to an end, after two years of additional benefits during and after COVID.

Westchester families, seniors, and individuals receiving Supplemental Nutrition Assistance Program (SNAP) benefits will experience a minimum reduction of \$95.00 in their monthly benefit amount, with some households experiencing a much higher reduction, up to \$250 a month, beginning in March.

This will be a significant loss of food assistance for the over 74,000 people in Westchester who participate in SNAP, leaving many to struggle to afford nutritious food and pay other bills. This devastating loss is coming on top of a sharp yearover-year increase in the cost of food and utilities, which has already led to more people seeking emergency food from Feeding Westchester and our partners than this time last year.

A senior in Westchester County who is receiving SNAP benefits expressed her concern over this significant negative impact on her ability to buy food: "How [can they] expect me to live on \$23? What can I buy for a whole month?"

Since March 2020, Congress temporarily increased SNAP benefits because of the COVID-19 public health emergency to address food insecurity challenges exacerbated by the pandemic. These increased benefits will end after February 2023 and return to pre-pandemic levels in March. The reduction in SNAP benefits is a result of a federal policy change (due to cuts in the 2023 Omnibus spending bill), not because of changes to individual SNAP cases. Older adults, who are typically part of smaller households and receive the minimum benefit level, will likely feel these cuts the hardest. The national anti-hunger organization, Food Research and Action Center (FRAC), estimates that seniors will see their allotments fall from \$281 to pre-pandemic levels, just \$23 per month. These extra benefits have been a lifeline for families who are already struggling with high costs of food and increased utility bills. With this dramatic decrease in benefits, there will be more pressure on Feeding Westchester and their partners when they are already dealing with long lines and higher fuel and food prices due to inflation. In fact, 80% of Feeding Westchester's partners said they are already feeding more people and serving more food this year than last year. Feeding Westchester along with their partners are doing everything they can to prepare SNAP recipients for the decrease in benefits, alert them to emergency food resources in their communities, and connect them to other services to help them meet their basic needs.
