Yonkers Times.com has acquired a poll circulated among democrats in Yonkers and Westchester asking Who Would You Support to be Our Next Mayor? The poll was conducted last month (Dec. 2021). We have been unable to determine who paid for the poll, or which political operative or consulting firm oversaw it. "This poll is being conducted by a Yonkers Democrat. Your response in anonymous," states the poll, which is pictured above, and which we received from a notable Yonkers and Westchester democrat.

There are 8 names on the poll, but opinions were mixed as to whether the next Mayor would come from this list of 8, or whether someone else will lead New York State's third largest city on Jan. 1, 2024.

In fact, some democrats thought that it was way too early to start thinking about Mayoral candidates in 2023. "Two years are an eternity in politics," said one of several Yonkers and Westchester democrats we spoke to. "Why anyone is polling Yonkers democrats the week before Christmas and two years before the next Mayor's race is nuts."

But once we were able to verify that the poll was sent to several Yonkers democrats, opinions and predictions started coming in. "That's a pretty accurate list of the 8 Yonkers democrats, one of who will be our next Mayor. I also think that there are two tiers of candidates on this list, with several running for Mayor if one of the top tier candiates decides not to run. And I think most of this comes down to whether Mayor Spano will run for a 4th term. If he does, then many of these 8 candidates bows out," said one Yonkers Democratic Party leader. But if you are not on this list of 8, then you are not going to be our next Mayor."

Yonkers Mayor Mike Spano has just completed his 10th year in office. After being elected twice, supporters of the Mayor changed the City's term limits law to permit him to run for a third term, which he won, easily defeating republican Mario

The City would have to amend its term limits law once again, this year (2022) to permit Spano to run for a fourth term, if he decides to run. All the talk about a fourth term for Mayor Spano has been rejected by those close to him, saying that he, and his family, are ready to move on to another part of their future.

But lately, the buzz has returned to Yonkers City Hall that while still unlikely,

don't rule out completely, a Spano for Mayor part 4.

"I think that Mayor Spano clears most of the names off this list if he decides to run for a fourth term," said a Yonkers democrat and a supporter of Mayor Spano. "There's a reason why he was elected three times. The voters are satisfied with the job he has done, and that gives him a chance to run again. The office of Yonkers

When he was first elected Mayor ten years ago, Mayor Mike Spano vowed to take the drama out of Yonkers politics. Since then, we have seen very little drama, with the affairs of the City being conducted without much controversy.

That was until the City Council re-organizational meeting of Jan. 3. As a reporter, this was my 10th Council re-org meeting, which occur every two years. They usually are conducted quickly in public, with much of the negotiations going on in the council chambers, off camera, as councilmembers seek consensus on leadership positions for the next two years.

This year, the same negotiations occurred in the council chambers, but the conversation continued on the council floor, on Live TV before the people of Yonkers. Two councilmembers Corazon Pineda-Isaac and Shanae Williams, would not accept the results wheih made Councilmember Tasha Diaz the next Majority Leader. While I can understand the disappointment of both councilmembers at not being chosen or re-elected Majority Leader, the way in which they publicly criticized and attacked Diaz was a first for this reporter in 20 years

The announcement was made today by Great Point Studios Founder and CEO,

Robert Halmi, who called upon decades of experience as founder of the Hallmark Channel and a producer of more than 400 film & television projects to create a facility that fits the needs of these cutting-edge companies. "We have a shared vision for the future of the entertainment industry, and it's reflected in every detail we put into this complex," Halmi said.

"Given the expected rise in studio production post-Covid, we are confident that expanding our Yonkers studio will attract quality tenants. We are proud that Lionsgate, Mediapro and Syracuse University share our vision and are strongly supporting our project."

Owned and operated by Great Point Studios, Lionsgate Studios was created to satisfy the overwhelming demand for large studio space in the New York City area. This campus — approximately 11 miles from midtown Manhattan —will feature state-of-the-art film stages, post-production facilities, screening rooms, office space and support space. It will offer a full set of production services on site, including grip and electric, equipment, props, set building, restaurants, location catering, cleaning service, and security.

Dr. Nirav Patel, Director of the Wound Care Center at St. John's Riverside Hospital in Yonkers, kicked off the new year by discussing with Yonkers Rising the stateof-the-art services he helps provide to the community in wound care treatment and management.

Dr. Patel said that many diabetic patients, or those with pre-existing conditions need to be watchful for wounds that are taking longer than usual to heal.

"The Wound Care Center at St. John's is the premier wound care center available to patients in Westchester and the Bronx. We treat all types of wounds that are slow to heal, and check for vascular disease, podiatric conditions, and wounds that may not be healing properly from surgery. When you come to St. John's, you get a complete circle of care," said Dr. Patel,

"The Physicians at St. John's are the best in Westchester, but what also makes our wound care center elite is the nursing care. I hear from my patients how satisfied they are with the care they receive from our nurses. 

Public Health Professional Replaces Lakisha Collins-Bellamy



On Jan. 5, Mayor Mike Spano swore in longtime public health professional Rosemarie P. Linton, MPH to the Yonkers Board of Education. As trustee of the Yonkers Board of Education, Linton is part of a nine member Board, which is the official policy making body of the School District.

"As we continue to provide our students with the best education possible, I am proud to appoint Rose to the Board of Education as she brings unique perspectives as a dedicated public health professional. Rose joins the Board during a critical time for our schools as so many Districts across the country face challenges due to the COVID-19 pandemic. Her in-depth knowledge and expertise in public health will be a guiding hand in steering our Board during these uncertain times. I am confident her experiences will be a valuable asset to our students," said Mayor

Working in healthcare for over 30 years, Linton currently serves as a Senior Data Scientist for Krasnoff Quality Management Institute at Northwell Health. There, Linton is the lead statistician for Infection Prevention and manages hospital acquired infection and antibiotic surveillance data for 17 Northwell facilities entered into the CDC's National Healthcare Safety Network, which is the nation's most widely used healthcare-associated infection tracking system. Previously, Linton was a Research Analyst for the Westchester County Department of Health, where she analyzed weights of children in Yonkers Public Schools (YPS) and other schools in the County. This analysis brought attention to the severity of the obesity crisis, previously unknown, among children in the County, which was determined to be approximately 33%. Linton holds a Master of Public Health from Columbia University and a Bachelor of Science in Business Administration from Fordham University.

"It is with great honor that I accept the appointment of Mayor Mike Spano as a Yonkers Board of Education Trustee for the Yonkers School District. 

# Firefighters are Our Heroes!

I was sitting having my coffee at Panera at Cross County when the fire alarm went off earlier this week. Staff evacuated the patrons in the cafe and team members, out into the cold without their jackets. The Yonkers Fire Department, strategically located throughout Yonkers so they can reach most points in the city within 4 minutes were there in less than that.

If you don't know where the entrances to Panera are located at Cross County, you would have a hard time finding them. The sign for the cafe faces the parking lot, but one needs to go around the corner to enter the restaurant. The back door that faces the parking lot leads to Applebee's kitchen area. Their is no sign that says that the Panera entrance is around the corner. There should be! In big letters not only for the firemen to see but for the public.

The firefighters tried to get into the Applebee's door which was locked. They quickly went around the building to the cafe, did their checks and as I pulled my car out of the parking lot I saw the firemen leaving. Thank god it was a false

you feel for the poor people who have their families, memories, place to live destroyed. I don't like space heaters. Now you'll probably say hey Eric, you live in an apartment building that provides good heat. You don't need a space heater like so many do who are not as fortunate as you. In some closet in my apartment I have a radiator type device that I can pull out if it ever gets that cold in the apart-

Made me think about the terrible fire in the Bronx. 17 lives lost, many injured,

Frankly if it ever got that chilly I would pile on an extra blanket or extra layer of clothes before I would use the radiator type heater that has sat in my closet buried for at least 20 years. Who knows if it works? A friend of mine who is a firefighter years ago told me not to use space heaters. And never ever use your oven to warm up your apartment if the heat is down.

The apartment house I grew up in had those big heavy fire safety doors in the hallways. They were always supposed to be closed, but people would wedge them open. With fires in apartment buildings in the neighborhood over the years we learned to keep the fire doors closed and god forbid you have a fire in your apartment to close the door behind you.

How many of us have at least 1 frayed extension cord in our house or apartment. Or an overloaded extension cord out in the open someone can trip on and cause a fire. Or a smoke detector where the batteries have run out or that simply does not work. When we change the clocks we are supposed to check that the batteries in our smoke detectors and carbon monoxide detectors are working. Be honest, do you really do it?

Fire departments across this country have great resources to help you make your house or apartment fire safe. Most will visit your apartment or house and offer suggestions that at little or no cost can keep you safe. Take advantage of all the resources that are out there. Invite the fire engine to your child's school, or the fire department to your civic meeting. Firefighters are our friends. Yet for some reason if a child is in a fire statistics show they don't know what to do and they hide under the bed thinking they will be safe. They must learn that is not the case.

A professional Fire Department is not cheap. But it is like health insurance or insurance for your car. You hope you never have to use your local Fire Department but it is there when you need their services.

Don't be surprised if you have a medical emergency and a fire engine shows up before the ambulance. In a city like Yonkers with the excellent Empress Ambulance service serving our city there may be 2 or 3 ambulances on duty serving the entire city but we have fire companies with trained paramedics and EMT's that can reach most points in the city within 4 minutes. Minutes count in many medical emergencies. And don't let any politician tell you it's not needed. And if the fire crew comes out on a medical call and does wonderful work, send a letter to this newspaper or the Journal News sharing your positive experience. And make sure to let the Mayor and City Council who allocate the funds for fire service know it

The poor people who lost their lives or lost their possessions will never get them back. We have to pray for those involved in the tragic fire in the Bronx and if your pocketbook permits, donate to legitimate charities providing for their needs. Young kids in the prime of their lives dying. People overcome with smoke still being treating in area hospitals.

But remember who you see carrying people out of burning buildings, providing treatment for those who need it and risking their lives as occurred last weekend, oxygen tanks depleted still running in to the fire to get people out.

#### Statement from the NYS Office of Temporary & Disability

#### **Assistance on the Emergency Rental Assistant Program**

"After reviewing the Court's order, the New York State Office of Temporary Disability Assistance will reopen the Emergency Rental Assistance Program application portal today (Jan. 11)at 10 p.m. However, as in other states with large tenant populations, the demand for rental relief in New York State far exceeds the federal funding at our disposal.

From day one, Governor Kathy Hochul has worked aggressively to streamline and accelerate the delivery of New York State's ERAP funds — eliminating bureaucratic red tape to quintuple payments between late August and mid-November. With more than \$2 billion now paid or obligated, Governor Hochul has propelled New York from last to among the top states in rental relief funding paid or obligated.

After fully exhausting our initial funds for this program, New York State requested nearly \$1 billion in reallocation funds from the U.S. Treasury — but received only \$27 million, a sliver of what would be needed to cover existing applications, let alone new ones.

Today, New York will be joining other states in sending a joint letter to U.S. Treasury Secretary Janet Yellen to request additional federal funding and ensure highneed states are prioritized.

Reopening the application portal without additional funding to support the backlog of existing and future applications runs the risk of giving struggling New Yorkers false hope for critical financial relief that — without federal intervention — simply doesn't exist.

Our appeal to the Treasury represents the latest in our continued and vigorous advocacy for tenants and landlords still reeling from the financial impact of the pandemic. In addition to getting \$2 billion in ERAP funds out the door, Governor Hochul has made \$100 million in state-funded rent supplements available for localities, committed \$125 million to households previously ineligible for ERAP based on income, authorized \$125 million to help landlords with tenants who have declined to participate in ERAP or vacated with arrears, signed an increase in rental voucher amounts into law, invested \$25 million for free legal services for tenants, and unveiled a sweeping, five-year, \$25 billion plan to address housing affordability in her State of the State address.

We will continue to work with our partners in the federal government and designated community-based organizations to keep ERAP applicants apprised of the situation, so that they are not provided an unrealistic expectation of relief, absent additional federal funding."

The now-expanding, one million-square-foot complex will cost over \$500 million and boast more 20,000 square foot stages on one campus than any other facility in the Northeast. The campus will include a total of eleven (11) soundstages: eight 20,000-square-foot stages, two 10,000-square-foot stages, and a gigantic, 30,000 square-foot stage. It will also include parking for more than 750 cars and 100 trucks.

Three of the large stages and 500,000 square feet of office and support space are now open for business, while Great Point has also purchased approximately eight acres of additional land around the originally announced studio site. The expansion of additional stages and office space are already under construction and are scheduled to be completed in phases starting in September 2022 with total completion slated for December 2023.

Lionsgate has expanded its role as anchor tenant, and will occupy seven of the complex's eleven stages, along with office and support space. Besides its prominent theatrical film presence, Lionsgate is producing over 40 television shows for various broadcast outlets, including its own Starz platform.

"With demand for new content greater than ever and prime studio space at a premium, we're pleased to partner with Great Point on the opportunity to become an anchor tenant of the Yonkers Studios," says Lionsgate CEO Jon Feltheimer. "They will give our television and film productions state-of-the-art East Coast sound stages with great proximity to New York City, and we look forward to them becoming an important hub for our global production activities."

Mediapro, a leading group in the global audiovisual sector, unique in content integration, production and audiovisual distribution, has also inked a long-term deal to be a key tenant on the site. Mediapro will take occupancy of its first stage later this year and they have options on two more of the planned expansion stages. Their first stage is expected to be completed this winter.

"Mediapro recently expanded its operations in the US with two new production centers in great locations, and our aim through this partnership is to continue our growth in the country and globally," stated Mediapro US CEO Irantzu Diez Gamboa. "We are very pleased with the partnership with Great Point Studios and are very excited to form part of the largest film and television production complex in the Northeast. # Saint Joseph's Conducts Lottery to Select Residents for Landy's Court Apartments

Officials of Saint Joseph's Medical Center today conducted a lottery for the selection of residents for the 32 affordable units at Landy's Court, a modern new apartment building featuring 80 units housing in downtown Yonkers.

The project is named after James J. Landy, long-time Chairman of the Saint Joseph's Medical Center's Board of Directors and an advocate for those in the community who seek a safe environment with support services to call home. As an expert in Housing, Mr. Landy is involved in many organizations. He is the Chairman of the Board of Commissioners of Municipal Housing Authority of the City of Yonkers, Vice Chair of the Sisters of Charity Housing Corporation, President of the Sacred Heart Housing Group, and President of the St. Joseph's Housing Group.

Located at 10 School Street, the five-story building features 32 efficiency oneand two-bedroom affordable housing units for individuals and families who meet the affordable housing guidelines. There are also 48 efficiency units for individuals with a diagnosis of mental illness who are in need of supportive housing.

Referrals for the 48 supportive housing units will come from the Westchester County Single Point of Access program which is coordinated through Westchester County's Department of Community Mental Health with preference for Yonkers residents and military service veterans. Clinical criteria will include assessment of ability to live independently. All of the affordable housing units will be occupied by individuals or families earning less than 60% of the Area Median Income.

"Saint Joseph's affordable and supportive housing meets a significant need in our community. The affordable housing provides an attractive, new permanent place to live for local individuals and families who meet the guidelines. The 48 supportive apartments will meet the needs of those individuals who have demonstrated the ability to live independently in the community with on-site support services. This program is designed to offer support and assistance to help individuals maintain skills of daily living and foster successful integration in the community," said Saint Joseph's Medical Center President and CEO Michael Spicer.

Landy's Court will provide support services that will be geared towards meeting the individual needs of tenants through a flexible array of support. The services, which will be made available to both the special needs tenants as well as the affordable housing tenants, will enable residents to live independently in the community, maintain physical and psychiatric health, and pursue employment, educational or other productive activities which will all contribute towards sustaining healthy relationships and improving the quality of their lives. Residents will also benefit from Saint Joseph's extensive organizational network of mental health and medical treatment programs. All apartments are fully furnished by Saint Joseph's and will be move-in ready upon a resident's admission to the program. Landy's Court is operated by the Department of Residential Services of St. Vincent's Hospital, Westchester Division of Saint Joseph's Medical Center.

covering the Yonkers City Council and was clearly evidence of the poltical drama that Mayor Spano has worked to try and avoid. What appeared to be happening was that the two councilmembers were trying to get Diaz to blow her stack in public. That did not happen, and after the vote, Diaz spoke to Ru Ros of the Yonkers Voice and pointed out that she had the support of the new Council President, Lakisha Collins-Bellamy.

Why did Diaz point out the support from the new Council President? Because the Council President is the 2nd most powerful elected official in the City of Yonkers, and besides Mayor Spano, she is the only elected official in City government elected Citywide. Her political victory should also provide her with the respect due her election as the first woman of color to be City Council President.

With that respect comes her ability to pick who the next Council Majority Leader should be. And Council President Collins-Bellamy chose Tasha Diaz. To us the case is closed, and there should now be a period of time where both the Council President and the Majority Leader be provided a grace period where they can both get used to their new positions and show the people of Yonkers what they can do, and what their priorities are. Let's give them a chance to lead and succeed please!

Yonkers Rising featured a letter that we received from several prominent women of color in Yonkers, including former elected officials. The letter, titled Four Black Councilmembers, asked the City Council to select one of the four women on the council, Collins-Bellamy, Diaz, Pineda-Issac, and Williams, to become the next Majority Leader.

And on Jan. 3, their wishes were granted when Diaz was named Majority Leader. But two councilmembers objected to Diaz. If that was the original reason for the letter, they should have removed Diaz from the four women of color that should be Majority Leader. We agree with the letter, and that is why we featured it on the front page, but again, when one of those four women of color was selected Majority Leader, there should have been no opposition.

The disrespect given to Majority Leader Diaz has continued since her vote against increase the City's Affordable Housing Ordinance from 10% to 20% last year. That vote has earned her the wrath of many progressive democrats in Yonkers, and was mentioned by both councilmembers as a reason why Diaz should not be the Majority Leadeer. But Diaz's decision not to support a 20% affordable housing requirement for new development should not be a dealbreaker to be a leader in the democratic party in Yonkers. Mayor Mike Spano is opposed to a 20% affordable housing ordinance and is negotiating a compromise between 10% and 20%.

At one event last year, in which Diaz was given out food to the hungry, one of her opponents, and a supporter of the 20% affordable housing ordinance, threw a pair of flip flops at her with the words, "don't flip flop," and "override the veto" on them. The Yonkers Police were called, and an event that was supposed to feed the hungry became, you guessed it, political drama.

Elections have consequences, and both Councilwoman Diaz and Council President Collins-Bellamy won their elections, and Diaz won a majority of the voters of her colleagues. Let's move on and let them get to work for the people of Yonkers.


Several members of the City Council could become the next Mayor of Yonkers. There behavior on Jan. 3 did not look like behavior from a future Mayor.

# On This Day in Yonkers History...

Monday January 17th

January 17, 1904: Ludlow Park resident (Heinrich aka Harry) Kellar the Magician performed for President Roosevelt and his family at the Lafayette Theatre in Washington. Kellar lived at 75 Sunnyside Drive.

January 17, 1929: Yonkers High graduate Lieutenant Frederick Hopkins of Riverdale Avenue, a professor of military science and tactics at NYU's Guggenheim Aeronautics School, addressed the Yonkers Citizens Military Training Camp Club at the new North Broadway Armory. While addressing the crowd, he predicted one day airplanes would replace artillery. Previously an Air Corps instructor at San Antonio's Kelly Field, Hopkins told of amusing incidents that happened to soonto-be famous aviators during their training at Kelly. Lieutenant Lester Maitland, considered an aviation pioneer, was given the "Dumbbell Trophy;" instead of flying north, he ended up fifty miles south of his assigned landing point. Hopkins also shared Colonel Charles Lindbergh would not have been memorable during his student days at Kelly, except for a serious mid-air collision eight days before his graduation; Lindbergh bailed out to save his life.

Hopkins transferred to the Air Force in 1947 when it became a separate branch of the service; he retired a few years later in 1951 holding the rank of Major General. Among awards he received were the Distinguished Service Medal and the Legion of Merit.

Tuesday January 18th

January 18, 1911: William Port East of Nepperhan Avenue became the oldest man in Yonkers; in his 99th year, he had lived in Yonkers for more than half a century. He passed away the following December.

January 18, 1938: Mayor Joseph Loehr indicated he was ready to work with the Council Republican majority to break the deadlocked city budget. While discussing this, he revealed he had met with Republican Majority Leader Alderman Fred Storay a few hours before the Council vote and reached an agreement to reduce the budget \$328,000. Loehr, denying he had "packed the 1938 budget with political jobs," released a list of the jobs in the original budget, including police officers and laborers previously paid to do city jobs by WPA. Storay later denied a meeting took place after the vote, ignoring Loehr's assertion it happened before the vote.

Wednesday, January 19th

January 19, 1938: Mayor Joseph Loehr appointed songwriter Bud David Green of Lee Avenue a Commissioner of the Board of the Yonkers Museum of Science and Arts. Green, who previously worked in the movie industry in California, moved to Yonkers after selling his company to Warner Brothers. Green wrote many well-known songs such as "Once In A While," "Sentimental Journey," "I'll Always Be In Love With You," and "Flat Foot Floogie (with a Floy Floy)."

January 19, 1938: Yonkers Corporation Counsel advised City Clerk Heafy that the 1938 budget was "not passed within the time prescribed by law and was furthermore vetoed by the Mayor and never properly passed over his veto." The Republicans would have needed 9 votes to overturn the veto; they had seven. Hence, Heafy was not able to compute property taxes to send property tax bills.

Thursday January 20th

January 20, 1923: Patrolman William Comey saw a woman fall onto the trolley tracks; he rushed over to grab and pull her to safety just as a trolley car was about to reach here.

January 20, 1938: Civic leader James Moseley volunteered to act as a mediator in the City Hall budget deadlock; he sent telegrams to Mayor Loehr and Republican Majority Leader Fred Storay offering his services. Moseley was VP of the American and Foreign Power Company, former president of the Ludlow Home Owners' Association and the Council of Yonkers Civic Associations.

Friday, January 21st

January 21, 1945: Dr. Edward Jones, whose dental office was at 45 Warburton Avenue, attended President Franklin Roosevelt's inauguration. Dr. Jones, Cochairman of the New York State Campaign for President Roosevelt; had recruited African American voters for the president.

January 21, 1987: Show business Columnist Earl Wilson of Marshall Road passed away at St. Joseph's Hospital.

Saturday, January 22nd

January 22, 1937: More than 100 drivers got new license plates at the first Yonkers office of the County Automobile Bureau office, opened at Tibbetts Brook Park.

January 22, 1938: City Comptroller James Hushion filed for a State Supreme Court hearing to kill the Common Council's economy budget and force the Republican Aldermen to approve the budget submitted by the Board of Estimate. Although the Comptroller was trying to get the Loehr administration budget approved, Mayor Loehr was named as one of the 15 defendants. Others named in the suit were Council President Fiorillo, City Clerk Heafy, and all 12 Yonkers Aldermen. Supreme Court Justice Gerald Nolan signed the papers at 9 pm; all defendants immediately were served copies. Former Corporation Counsel Harry Laragh would defend the Republicans named in the legal action.

Sunday, January 23rd

January 23, 1931: Ending its longest season in the history of the ferry service, the Yonkers-Alpine ferry announced they would close until March 1st The severe cold weather created dangerous ice floes in the river, making it necessary to stop service.

January 23, 1945: The Yonkers Common Council unanimously approved a zoning change on 22-acres of the Grassy Sprain Golf Course to permit the Celanese Corporation to build a \$1 million scientific research laboratory on the site.

January 23, 1951; After discovering fire in her apartment at the Coyne Park veter-

ans' housing, June Casey rushed through the smoke-charged rooms to get her three

children. She carried the children to a window where Joseph Magariello was waiting to take them. Magariello, who lived in the next building, spotted the fire and tried unsuccessfully to kick down the door.

Mayor does burn you out, and after 12 years i'm sure that he is tired, and that his wife and kids would like see him ease into an easier job. But if he wants it, I would put Mike Spano at the top of the list."

Some other democrats felt exactly the opposite about a Mayor Spano part 4. "This is taking what Mayor Bloomberg did in New York City to another level. I think that many Yonkers democrats are feeling a bit of Spano fatigue, and I believe that is why this poll was taken, to see if there is any desire or willingness for Mayor Spano to run again. And if this poll comes back with a lot of Yonkers Democrats saying no, then you have other candidates that Mayor Spano could support to suceed him, including his brother Vinny Spano, Yonkers Democratic chair Tom Meier, and Councilman John Rubbo," said a Yonkers progressive

State Senator Shelley Mayer had the support of many Yonkers democrats we spoke to about this poll, and if she decided to run, would be the one other elected official that could be elected Mayor, regardless of whether Spano decides to run again.

"Shelly Mayer would clear the field of most democrats on this list, and some others that aren't on this list. She is widely respected and one of Yonkers most popular democrats. I think a lot of Yonkers democrats want someone to serve as the next Mayor who can take the city to the next level, on many different fronts. The people of the third largest City in NY deserve the best," said one Yonkers democrat.

But while most believe that Sen. Mayer would make the most logical candiate for Mayor next to Spano, most also believe that she won't run for Mayor in 2023. "I would love to see Mayer for Mayor in Yonkers in two years, but I think that Shelley is happy doing what she is doing and she understands what a challenge it is to get elected and then having to serve. The question is, how do we get Shelley to drop her political career in Albany and come to Yonkers and fix the ills of our city. I can't answer that," said another Yonkers Democratic party leader.

"I think Shelley Mayer is the Spano's worst nightmare, but I don't think she has the desire to take it on, especially if Mayor Mike decides to run again," said a Westchester

Assemblyman Nader Sayegh also had the support of several democrats we spoke to. "I think Assemblyman Sayegh would make a great candidate, and would be a great Mayor of Yonkers. He has built a lot of bridges over his career in the Yonkers schools, and has the respect and admiration of teachers and stafff and unions in the Yonkers Public Schools. And those interest groups mean a lot in a democratic primary," said one Yonkers democrat.

A few Yonkers democrats who are not in the poll were also mentioned by the dozen democrats we spoke to from Yonkers and Westchester. They include, Deputy County Executive Ken Jenkins, Councilmember Shanae Williams, and former Council President Chuck Lesnick.

"Ken Jenkins is the one democrat not on this list who is very qualified to serve as Yonkers Mayor and would be a great candidate. But most of us in the Yonkers Democratic Party believe that Ken will be running as the democratic candidate for County Executive at some point, so we don't plan on him running for Mayor," said a leader in the Yonkers Democratic Party.

"Don't overlook Chuck Lesnick," said a Westchester Democrat. "He still wants to be Mayor and will have the support of many progressive democrats. Throw his name into the mix."

"I think many democrats in Yonkers, and across Westchester County, were impressed by how good Shanae Williams did in her democratic primary against Tim Idoni for County Clerk last year. And because of her vote totals in that race, I think she has a chance to run and win for Mayor of Yonkers," said a yonkers and county democrat.

Other Yonkers democrats thought that Tom Meier, John Rubbo, and Vinny Spano, all have a chance at the democratic nomination in two years, if Mayor Mike doesn't run. And other Yonkers democrats believed that a woman of color, either Council President Lakisha Collins-Bellamy, or Councilmember Corazon Pineda-Isaac, would be the next Mayor of

Yonkers. "Council President Collins-Bellamy is the only other Yonkers democrat to have been elected citywide. She has done it once and could do it again." Supporters of Councilwoman Pineda-Isaac said, "Her recent defeat as Majority Leader should light a fire under her to go out and prove them wrong, run for Mayor and win," said

a Yonkers Dem. Party leader. "I still think Corazon is the strongest candidate for Mayor in

Yonkers."

that goal. We are full of compassion, and we are unparalleled to any other wound program in the tri state area."

Dr. Patel explained that diabetic patients are at most risk for having a wound that does not heal properly. Common diabetic wounds include foot ulcers, located on the bottom of the foot. "The majority of our patients are diabetic prevalent, and we can provide good treatment and state of the art technology to treat diabetic, non-healing wounds."

"When a diabetic patient comes in for treatment, we check their blood sugars, and make sure that they are being monitored and controlled. Diabetes closes small vessels in your foot and in those cases, we treat diabetic foot ulcers. We can also use vascular surgery to bring more circulation to the patients' feet.

'We also have a lot of patients that are not diabetic but are experiencing trauma with non-healing surgical wounds. We work to determine why the wound is not healing, through ultrasound and tests to diagnose circulation. We have vascular surgeons and nurses who can correctly diagnose the reason for your slow healing wound and provide treatment on site," said Dr. Patel.

The hyperbaric chamber at St. John's Wound Care Center is state-of-the-art and unique to the region. "For patients that qualify for our hyperbaric therapy, we have 4 monoplace chambers, where each patient has their own chamber, and can watch TV during their treatment and experience more privacy," said Dr. Patel. Most hyperbaric chambers in the area have one multi-place chamber, where patients are required to sit together.

Dr. Patel is also using new skin care products to help heal wounds. "We are using skin substitutes and skin products, if a wound is deficient in basic nutrients, these products can help conjure up cells to get impregnated into the wound and help speed up the healing."

St. John's Riverside Hospital has created a comprehensive outpatient wound management program dedicated to treating adult patients with non-healing wounds and wound prone conditions. "We can help to provide visiting nurses if you need help changing your dressing, and make sure your medicines are ordered. That is what is usually missing from other wound care locations where patients are told what to do and go home. But some patients can't do it by themselves. We understand that and work to make sure they get the care at home that you would want for your own family member," said Dr. Patel.

Advice for all of us regarding a recent wound? "If you are diabetic and have a wound that hasn't been healing for 3 or 4 weeks, come in and get an x-ray. It could be an infection or not enough circulation. Make sure to have an expert look at it and tell you how to treat it to get your wound healed. That is what we are here for, to get you healed so you can go back to living your life," said Dr. Patel, who is proud of the fact that St. John's and the Wound Care Center, stayed open throughout COVID.

"In 2020, during the height of the pandemic, we stayed open and served the entire community, and were busier than ever. Many patients couldn't get in to see their doctor and had telemedicine appointments. But for some patients that isn't enough to help a wound. We were happy to serve those patients who came in to get their wounds cleaned and advise them, or where necessary, get them into our hospital for an operation. Our nurses and doctors stayed open, and did so safely, to provide a service that continues to be of great need. Many patients with wounds that weren't treated during COVID ended up getting infections and losing their
