Yonkers Man Indicted for Alleged Arson and Insurance Fraud Scheme



Defendant allegedly enlisted a man to burn down his own house in attempt to claim more than \$1.3 million from his home insurance policy

On Dec. 19, Westchester County District Attorney Miriam E. Rocah announced that a Yonkers man was arrested and arraigned on an indictment charging him with conspiracy, arson and insurance fraud in connection with a scheme where he enlisted a man to set fire to his Yonkers home and attempted to obtain more than \$1.3 million from his home insurance policy.

DA Rocah said: "This defendant allegedly provided a co-conspirator with a detailed plan to burn down his house so he could unlawfully obtain insurance money. The fire and explosion at the defendant's home put lives at risk. We take these cases very seriously and will continue to work to hold this defendant accountable for his alleged conduct."

The defendant, Majid Haddad, aka Peter Haddad, 69 of Yonkers, was arrested Tuesday by the Yonkers Police Department and arraigned Wednesday before Westchester County Supreme Court Justice Larry J. Schwartz on a six-count indictment charging him with conspiracy in the fourth degree, arson in the third degree, reckless endangerment in the first degree, insurance fraud in the first degree, insurance fraud in the third degree and intimidating a victim or witness in the third degree.

Bail was set at \$25,000 cash, \$100,000 bond and \$200,000 partially-secured bond, and the defendant is ordered to return to court on Jan. 10, 2025.

It is alleged that between Feb. 20 and 28, 2021, the defendant enlisted a man and instructed him to apply gasoline to the inside of the defendant's home with the intent to ignite a fire that would destroy the property. It is further alleged that days before the fire, the defendant drove the man to a Lowe's Home Improvement store, giving him money to purchase gasoline canisters, and to a gas station to purchase gasoline, then demonstrated how to ignite the fire using a cigarette and a pack of matches and provided money for transportation after completing the job.

The Yonkers Fire Department responded just before 1:00 a.m. on Feb. 28, 2021 to the single-family home on Odell Avenue that was fully engulfed in flames. Firefighters were able to contain the fire, which had caused an explosion, and was approximately 20 and 30 feet from the two neighboring homes. Based on the rapid pace and spread of the fire, the house collapsed and was deemed a total loss.

The defendant then allegedly filed a home insurance claim with Adirondack Insurance Exchange and attempted to obtain at least \$1.3 million for the loss of the home and its purported contents.

After an investigation by the Yonkers Police Department and the Yonkers Fire Department's Fire Investigation Unit, the investigation was referred to the Westchester County District Attorney's Office.

The case is being prosecuted by Assistant District Attorney John Waszak of the Trials & Investigations Division.

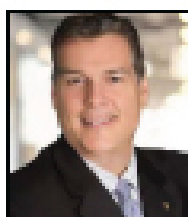

Assemblyman Nader Sayegh Enters Crowded Democratic Field for Westchester County Clerk

On Dec. 13, Assemblyman Nader Sayegh announced that he will seek the democratic nomination for Westchester County Clerk. Sayegh, who has served in the Assembly since 2018 representing Yonkers, joins an already crowded field of democrats seeking to replace the current County Clerk Tim Idoni, who after serving 16 years decided not to seek reelection.

Prior to the Assembly, Sayegh was an educator and school administrator for the Yonkers Public Schools including serving as the President of the Board of Education. Sayegh is also an attorney with a law practice focusing on Personal Injury, Real Estate, and Immigration.

"I am proud to announce that I will be seeking the Democratic Nomination for Westchester County Clerk", said Nader Sayegh. "I thank County Clerk Timothy Idoni for his years of service improving the Clerk's Office. I look forward to bringing my unique skill set to build on the amazing work Tim has done and to continue moving the County Clerk's office forward."

Sayegh has already been unanimously endorsed by the Yonkers Democratic City Committee.

"I look forward to campaigning strongly in every corner of our great County. The County Clerk's office plays such a crucial in providing services to the residents including legal records, passports, and land records. My experience as an attorney, State Legislator, and School Administrator makes me uniquely qualified to lead the County Clerk's office," stated Nader Sayegh.

Mt. Vernon democrat Crystal Collins also formally announced that she is running the County Clerk in a Facebook video. "As a dedicated district leader in Mt. Vernon for the past decade, I understand the commitment involved. I am fully committed to the democratic process and working for democratic candidates in Westchester.

"For the past 7 years I have worked under our esteemed County Executive (Latimer). Before this role, I served on the executive team of our current County Clerk (Idoni), where I focused on enhancing visibility and engagement in communities across Westchester County," said Collins.

On This Day in Yonkers History...

Monday, January 6th

January 6, 1880: Western Union opened Yonkers' first telephone exchange.

January 6, 1944: Dr. Lawrence Ashley, Director of Vocational Training for War Industries in Yonkers, announced fifty-four WWII Veterans received jobs through the US Employment Service after completing an intensive two-month training in the Yonkers School of Aeronautical Manufacturing. All 54 men either were discharged for disability, or aged out of the service, being more than 38 years old. In addition to regular students, the Defense School trained 100 returning veterans and placed them in jobs.

School Staff were flexible, creating new training as changes occurred. This new coursework was designed to meet the needs of returning servicemen, to place them immediately in available jobs.

Tuesday, January 7th:

January 7, 1933: Twenty-five-year-old Wolfe Street resident Hemsley Winfield performed the role of Witch Doctor in the premiere of the new American opera, "Emperor Jones." Based on Eugene O'Neill's play about an African American conman, the lead role was played by Lawrence Tibbett in black makeup.

Although the Met wanted to stage the production with all white dancers, Tibbett threatened to quit the production unless Winfield and members of Winfield's New Negro Art Theater performed the dance roles. Because of Tibbett's stand, Winfield was the first African American under contract to the Metropolitan Opera.

January 7, 1959: City Clerk William Gray issued Yonkers first Bingo license to the Monastery Church of the Sacred Heart, making Sacred Heart the first organization to legally conduct bingo games in Yonkers. The church paid \$70, or \$10 per night, to run weekly games for two months at 110 Shonnard Place. Our law limited the number of games an organization could run to six per month.

Before applying for a license, sponsoring organizations had to get identification numbers from Yonkers Lottery Commission, who also approved game locations. St. Peter's Church and the Monastery Post, Catholic War Veterans, had identification numbers. The Post planned to hold its games in the former School Ten on Clinton Street.

Congressman Lawler: Cooperation is Needed from New York to Deport Criminal Aliens out of US

Turning These 7 New Year's Resolutions Into Healthful Habits That Stick

Every January, millions of people enthusiastically make New Year's resolutions, brimming with hope and determination—only to watch those well-intentioned goals fizzle out by February. Studies show that nearly 80% of resolutions fail within the first few months, with many people abandoning their health and fitness commitments before they can become lasting changes. The cycle of setting ambitious goals and quickly falling back into old habits is so common that it's become a familiar joke, leaving many feeling frustrated and discouraged.

Dr. Daren Wu, Chief Medical Officer at Open Door Family Medical Center, understands that sustainable health changes can truly reshape lives. He shares these insights on New Year's resolutions that go beyond mere wishful thinking and into the realm of real, achievable wellness by taking small steps:

Weight management. Without fail, weight loss is one of the top three New Year's Resolutions each year. But it's important to realize there is no such thing as a perfect weight. Being a healthy weight does not need to be complicated, but it does require a plan. Talking to a dietician or a clinician can help you understand what a healthy weight would be for you. And being more mindful of your eating habits combined with moving around more, and getting enough sleep will often lead to healthy weight loss throughout the year. These simple steps help to avoid the trap of unrealistic expectations and yo-yo dieting.

Exercise and movement. Every January, gyms fill up with people eager to get fit, but by February most of those crowds disappear. The good news is that getting healthier doesn't require an expensive gym membership or complicated workout routine. Movement is the most powerful way to improve your health, and it can be simple and accessible. The key is finding ways to move that fit your life. Take the stairs instead of the elevator. Go for a short walk during your lunch break. Dance in your living room. Do quick bodyweight exercises at home or even at your workplace. The most important thing isn't how long you exercise, but that you actually do it. Can't find 15 minutes? Try 10. Can't do 10? Do 5. Something is always better than nothing. The goal is to make movement a regular part of your daily routine, not a dreaded chore. Start small, be consistent, and gradually build momentum.

Healthy eating. At Open Door, clinicians believe "food is medicine" – meaning what you eat and how much you eat truly matters. Be mindful. Before you eat, pause and ask yourself: "Am I actually hungry, or am I eating for another reason?" When you do eat, make it a deliberate experience. Enjoy your food's flavors, textures, and colors. Eat slowly, chew thoroughly, and avoid distractions like phones or television. The goal is to eat for nourishment and pleasure, not out of habit or emotion. This year, turn mindful eating from a New Year's resolution into a lasting habit that transforms your relationship with food and nourishes your body and mind.

Reduce stress. Stress is a common health concern, making stress reduction a popular New Year's resolution. The good news is that managing stress doesn't have to be complicated or expensive. Try the 4-7-8 – or box breathing – method by breathing in through your nose for 4 seconds, holding your breath for 7 seconds, and exhaling forcefully through your mouth for 8 seconds. Breathing exercises like this take just a few minutes and can quickly calm your mind. Focusing on being present in the moment instead of dwelling on the past or worrying about the future can also help reduce stress. Other small actions that can make a big difference: taking a short walk, doing some quick stretches at your desk, or simply pausing to take a few deep breaths. The most important factor in building a healthy habit is finding a method that fits easily into your daily routine and practicing it consistently over time.

Quit smoking. Quitting tobacco or vaping is one of the best things you can do for your health. While the ideal is to never start, it's never too late to quit or reduce your habit. The good news is that your body begins healing quickly after you stop smoking. Even cutting back on the number of cigarettes you smoke each day can improve your health and set you on the path to completely quitting. If you're finding it challenging to quit on your own, consider joining a smoking cessation class. These supportive groups can provide the guidance and motivation you need to turn your resolution into a habit.

Get the right amount of sleep. Over the past decade, we have gained a deeper understanding of the importance of sleep. While occasionally missing a night's rest is common, chronic sleep deprivation can be harmful. In addition to causing irritability and fatigue the following day, insufficient sleep is linked to a higher risk of mental health disorders, obesity, and even increased all-cause mortality. To create a good sleep routine, start by setting a consistent bedtime and wake-up time each day, which helps regulate your body's internal clock. Establish a relaxing pre-sleep routine, such as reading or meditating, to signal to your brain that it's time to wind down. Limit screen time at least an hour before bed, as the blue light from phones and computers can interfere with your sleep cycle. Be mindful of caffeine and alcohol, as both can disrupt your ability to fall and stay asleep—avoid consuming them in the hours leading up to bedtime. Finally, optimize your sleep environment by keeping your bedroom cool, dark, and quiet.

Improve one's work/life balance. As a society, we really can benefit from having a more balanced approach to work and life. Regardless of how stimulating or fulfilling your work is, you are much more than your work! Spending quality time with family, good friends, and finding grounding in spirituality (which is different from being religious, although being religious can be a powerful expression of spirituality) are the other important domains of life. And don't forget that we often can make our time at work more meaningful and fulfilling, which helps to improve one's sense of well-being. Engagement with colleagues, clients, and customers – and taking pride in the work you do, regardless of what work you are engaged in – can help anyone adopt a healthier relationship with their work responsibilities.

According to Dr. Wu, turning New Year's resolutions into lasting, healthful habits doesn't require making drastic life changes that are difficult to maintain over time. Often, it's the small, sustainable changes that have the biggest impact. By focusing on one or two manageable adjustments—such as prioritizing sleep or incorporating a short daily workout—you can build consistency and make gradual progress.

Westchester DA Rocah Vacates 1983 Conviction of Jeffrey Koonce

Improper photo identification methods, false testimony and adverse credibility of Mount Vernon detectives among new evidence cited in Conviction Review Unit investigation

Westchester County District Attorney Miriam E. Rocah today announced that following her Conviction Review Unit's investigation into a 1981 armed robbery at a Mount Vernon social club and newly-discovered evidence, she has supported a defense motion to vacate the conviction of 67-year-old Jeffrey Koonce, who was incarcerated for eight years some thirty years ago and has always maintained his innocence. The District Attorney did not oppose the defense motion for vacatur based on their position that Mr. Koonce's constitutional rights were violated due to false testimony by one of the Mount Vernon Police Department (MVPD) Robbery Unit's lead detectives on the case, Daniel Salottolo, and improper photo identification methods used by Salottolo and Detective James Garcia. Garcia and another investigator on the case, Lt. Robert Astorino, were subsequently convicted of federal corruption charges in 1994. The CRU investigation also revealed inconsistencies between the testimony by the single victim-witness in the case and statements made to CRU investigators.

DA Rocah said: "From the highly suggestive photo array and identification procedures used by MVPD detectives to the totality of new evidence found by the CRU investigation, we agree with defense counsel that Jeffrey Koonce's 1983 conviction was tainted by such questionable investigatory processes and procedures and therefore can no longer stand by the integrity of this conviction."

Mr. Koonce and his attorney Karen Newirth appeared before New York State Supreme Court Justice James McCarty to request that the court vacate the conviction and dismiss the underlying indictment, which charged Mr. Koonce with robbery and weapons possession in connection with the June 20, 1981 shooting at Vernon Stars Rod and Gun Club, where patrons were robbed at gunpoint of jewelry, cash and other valuables.

Following a jury trial in May 1983, Mr. Koonce's brother Paul, who was in the 10th grade at the time of the crime and also indicted, was acquitted on all charges, while Mr. Koonce was convicted on all charges and sentenced to an indeterminate term of seven-and-a-half to 15 years. He served eight years in prison and was released on parole in August 1992.

MVPD detectives presented witnesses a highly suggestive and improper photo array that contained photos of several individuals implicated in similar crimes that did not match Jeffrey Koonce's likeness. Mr. Koonce's photo was

the former School Ten on Clinton Street.

Wednesday, January 8th

January 8, 1933: Eluding a police cordon throughout the heart of the Getty Square business section, a daring thief escaped after attempting to steal a stack of bills from a teller's cage at Westchester Trust Company.

January 8, 1935: The Yonkers Board of Education purchased insurance for every Yonkers school from 37 local agencies.

January 8, 1954: G. B. Caldwell, Yonkers manager of the New York Telephone Company, announced Yonkers people averaged 128,400 phone calls daily, representing three calls a day from every one of the 44,500 Yonkers phones.

Thursday, January 9th

January 9, 1945: Responding to reports of an animal floating down the Hudson on an ice floe, the Yonkers Coast Guard sprang into action and picked up a dog from the floe! A few hours later, our Coast Guard received a call from YPD, with a second report of an animal floating down the Hudson on ice! Our Coast Guard cutter headed towards the animal, a deer, but had difficulty getting the animal on board. Instead, the deer thought the shore was close enough, so jumped off the ice and swam to shore. When last seen, it was galloping through nearby woods.

January 9, 1945: Because of the many complaints about no trash collection, Vice Mayor James Sullivan suggested DPW begin a six-day-a-week pickup schedule until May, with the hope trash sitting outside for days would be picked up. In some areas, Yonkers trash wasn't collected for 12 days.

Friday, January 10th

January 10, 1923: At the request of Ludlow residents, the Common Council unanimously adopted Alderman O'Mara's resolution suggesting the Yonkers Board of Education name the new junior high school being built at Culver Street and Hawthorne Avenue after James B. Ludlow, the one-time owner of most of Southwest Yonkers.

The school was named after Nathaniel Hawthorne.

January 10, 1926: Public Safety Commissioner William H. Van Keuren announced he would establish an annual "Medal of Honor" award, as well as other honors for police bravery. This new recognition would give added weight to the Civil Service promotion lists.

January 10, 1937: Four major dairy companies began daylight delivery of milk to 41,000 Yonkers customers.

Saturday, January 11th

January 11, 1927: Chief of Police Edward Quirk announced news dealers continuing to sell "so-called art literature" banned in Yonkers would lose their newsstand privileges.

January 11, 1933: Otis Elevator announced it had won a \$270,000 contract to install 17 freight and passenger signal control elevators, the most modern skyscraper elevators, in the Cleveland Post Office.

Sunday, January 12th

January 12, 1930: The State Commission for the Blind asked permission to establish a tobacco stand in City Hall; they planned to have Spencer Traub of McLean Avenue in charge.

January 12, 1947: Mrs. George Blackwell was installed as the first woman president of the Nepperhan Community Center, at the time an agency of the Yonkers Community Chest. She succeeded community activist and Center co-founder Ivan McRae Sr., who had served as its president from the time it opened.

January 12, 1954: Former OSS agent Dr. Arie Bestebreurtje discussed "Miraculous Escapes of a Secret Agent" at the first joint meeting of the Asbury Men's Club and the Woman's Society of Christian Service of the Asbury Methodist Church in Crestwood. Bestebreurtje escaped the Nazis in 1941 and went to Great Britain to join the Netherlands army-in-exile. He was wounded twice while on missions behind enemy lines and was decorated with 18 medals from four nations for his exploits, the second most decorated person in WWII. Only General Eisenhower had more awards!

here, I found St. John's to be the perfect place to grow my practice. I love this community so much."

Part of Dr. Mehta's orthopedic training before coming to St. John's was a fellowship at Georgetown Hospital, where he obtained "a super-specialization in sports medicine and joint replacement." This experience included treating professional athletes and members of the NFL's Baltimore Ravens, the NBA's Washington Wizards, and the NHL's Washington Capitals.

"During my fellowship, I had the great opportunity to work with both professional and college teams. This allowed me to learn how to treat all types of patients, but it also put things into perspective."

"Now I treat a lot of patients who want to get back to playing basketball on the weekend with their friends. As an athlete, I can relate and understand what their goals are."

While Dr. Mehta's orthopedic specialty includes joint replacement of the knee or hip and sports medicine, "my philosophy on sports medicine is that nonoperative treatment always comes first. the only one that was enlarged.
A witness, who was inside the club and shot during the time of the robbery, was in ninth grade at the time, and the only one who identified Mr. Koonce as the shooter after being shown the photo array; other witnesses told investigators it was too dark inside the club to identify faces of the armed men other than that they were young black males.

Detectives brought Mr. Koonce to appear for a “show up” identification at the hospital where the wounded witness was being treated. The witness subsequently testified at a pre-trial hearing that he was feeling pressured to quickly identify the man police brought to the hospital. The trial judge called the show up “impermissibly suggestive.”

The witness told CRU investigators that he did not remember seeing any faces in the dark bar on the night of the incident, and that patrons immediately covered him after the shooting, which further obscured his ability to see the perpetrators.

The photo array was never shown to the defense until the pre-trial hearing.

Detective Salottolo provided ostensibly false and misleading testimony at pre-trial hearings and at trial about the composition of the photo arrays.

MVPD did not interview all of the alibi witnesses provided by Mr. Koonce, including an alibi witness, who is now a retired NYPD detective, and had testified that Mr. Koonce was with him in the city the night of the crime. Mr. Koonce maintains this alibi today.

After a 1991 trial for a different case involving Detective Garcia, the judge in his oral decision noted that Detective Garcia had lied during his testimony, and the Court “did not believe it could rely on almost anything Detective Garcia had to say.”

During a 1993 prosecution of a bank robbery in Mount Vernon investigated by Detective Garcia, the Court ordered a new photo identification procedure after determining that the process was unduly suggestive. Case files included a note about FBI agents telling the prosecution that Detective Garcia had “helped” witnesses select photographs.

MVPD detectives Garcia, Astorino and Frank Lauria were arrested in May 1994 for stealing \$10,000 during an FBI sting operation and convicted of federal corruption charges. Garcia, a 21-year veteran of the MVPD, and Astorino, MVPD Chief of Detectives, each were sentenced to one year and a day in jail. Lauria, who was hired by MVPD while facing NYPD charges, was sentenced to nine months in jail.

Jeffrey and Paul Koonce have always maintained their innocence.

The CRU investigation was conducted by former CRU Chief Anastasia Heeger, former Senior Assistant District Attorney Alexandra Keeling, and DA's Office criminal investigators dedicated to the CRU.

Since the District Attorney launched the unit in 2021, CRU investigations have led to the county's first two, separate large-scale vacatur involving a former Yonkers detective convicted of perjury and secret recordings by a whistleblower alleging misconduct inside the MVPD

In 2023, CRU's review led to the exoneration of a man who served more than seven years in prison for a 1975 rape he did not commit. CRU investigators found the actual perpetrator who confessed to the crime. It is the longest-known wrongful conviction in U.S. history to be overturned by DNA evidence.

Jeffrey Koonce is the father of NFL defensive end Malcolm Koonce, (Las Vegas Raiders).

Yonkers Charter School Opens New Fitness Center



The Charter School of Educational Excellence (CSEE) recently inaugurated a new fitness center on at its high school. 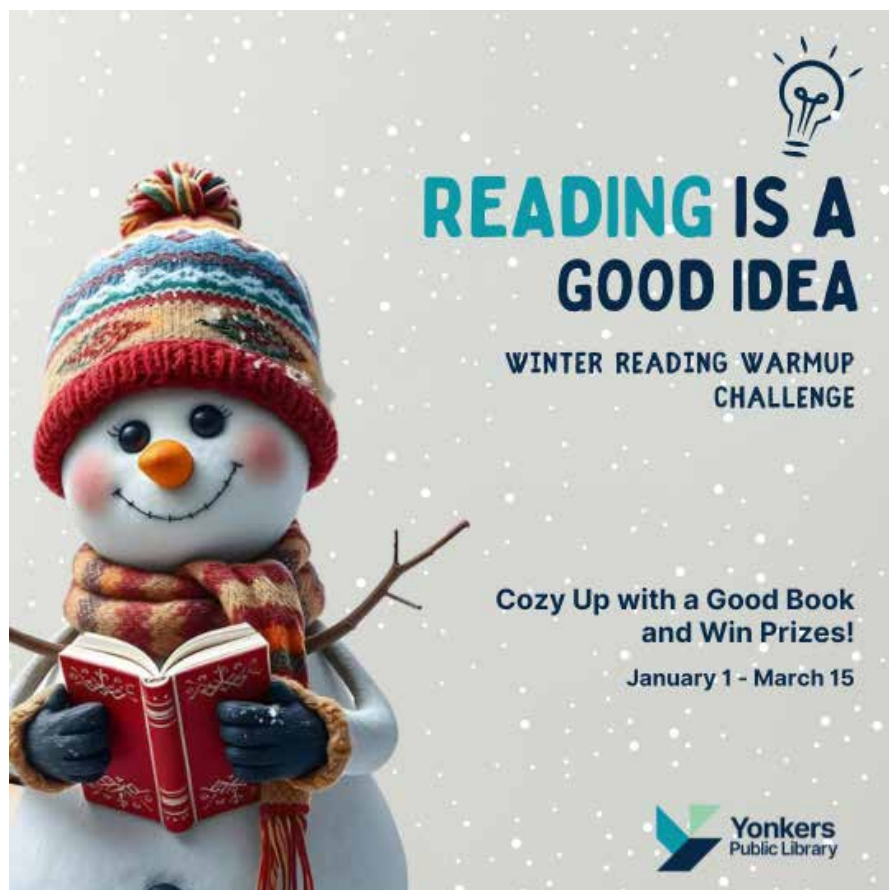

A CSEE partner, Dr. Joseph Durney, CEO of STEER for Student Athletes, said that schools cannot decouple physical and mental wellness of a child from their academic excellence. “We’re trying to get young people to understand that through sports they can leverage skills development that will help them: the ability to communicate, collaborate, think critically, be a creative problem solver, be a leader,” said Durney.

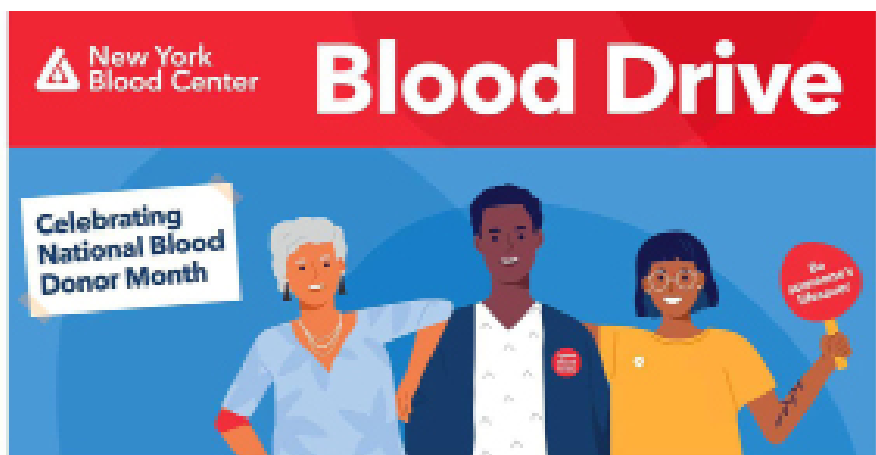

Americans Fight for their Rights:

The Bill of Rights and the Boston Tea Party

Sunday December 15th was Bill of Rights Day! Did you see any mention of it in the media? How many politicians had their photos taken with a copy of the Bill of Rights and spoke about how important it was? (The first Bill of Rights day was celebrated on its 150th anniversary—just eight days after the Japanese attack on Pearl Harbor.)

The Bill of Rights does not grant rights to American citizens—our rights are God-given and preceded government. Many founders, including George Mason. “Give me liberty or give me death,” Patrick Henry, Samuel Adams and others feared that the Constitution delegated too much power. In response to their concerns and a promise made to the Anti-Federalists, James Madison wrote the Bill of Rights which was ratified on December 15, 1791.

The Bill of Rights says “Yo—government, we can’t list them all but here, in your face, is a legal reminder to keep your power and money-grubbing hands and perverse ideologies off these rights—period. The people are sovereign. You may only operate such powers which are specifically delegated (temporarily allowed) to a branch of government, so don’t get any ideas about trying to snatch more for yourself.”

Early Americans understood the place of government—as a servant, not a tyrannical master. The anti-Federalists were concerned about the lack of terms limits, excessive federal power, judicial tyranny and the federal government having direct taxation. Thomas Jefferson felt that these all violated the spirit of the American Revolution.

Look especially at Amendments 9 and 10. In essence, these say: “just in case you try to weasel and stick your nose in our lives—if we did not specifically authorize you to do it—keep out. All rights not mentioned as delegated (temporarily allowed) to you belong to the states and the people.”

Amendment IX The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people.

Amendment X The powers not delegated to the United States by the Constitution, nor prohibited by it to the states, are reserved to the states respectively, or to the people.

Read the Constitution; start listing what the Constitution does not authorize that government has stuck its nose and paws in, and take your power back. A few examples: the Constitution does not authorize taxpayers’ money being spent on the Kennedy Center, abortions, baby sitting, promoting LGBT etc, etc. especially not in other countries, shrimp on treadmills, drunken monkeys, congressional junkets to the Great Barrier Reef and hundreds, perhaps thousands of other ways politicians find to waste the money they have taken from us.

Monday, December 16th was the 251st anniversary of the Boston Tea Party—an action taken because the British government had imposed a tax on tea whether the colonists bought it or not. (Sounds like ObamaTAXnotCare and other massive cost laws.) The unjust tax was to be imposed as soon as the tea was offloaded on to the dock. So the colonists took initiative. Their strategy was specific and neither harmed anyone nor damaged anything else. A lock broken in the action was replaced. Another foundational American event ignored because the lust for power, recognition and incessant validation has overshadowed the call to service. Of the Boston Tea Party, John Adams wrote in his diary the next day: “The people should never rise without doing something to be remembered—something notable and striking. This destruction of the tea is so bold, so daring, so firm, intrepid and inflexible, and it must have so important consequences, and so lasting, that I can’t but consider it as an Epocha in history.”

The Boston Tea Party united American colonists, inspiring tea parties in at least ten cities as the British used force to enforce their hold on power. It was a signal that here was a people who would fight for their rights and freedom.

So, do you want to be a slave to the politicians? Use those cell phones, I-pads, and laptops, and the internet and contact our government officials at all levels (frequently—be an overseer giving them regular check-ups) and demand that they cut regulations (instead of imposing more) and cut their salaries and perks, take less of our money, mind their own business instead of attempting to nanomanage everything we do from how we heat our homes, what we drive, where we drive, what we can say or where we can pray.

Our 250th anniversary as the freest and most prosperous nation in human history, which is to be ruled by the people and the standard of God’s natural laws and the Constitution, is in a year and half. But the revolution was in the hearts and minds of the American people long before the war began on April 19, 1775. It’s long past time to restore Americanism. Start with Mark Levin’s Restoring Americanism, The Founder’s Constitution, and a frequent re-reading of the Declaration of Independence.

"Magic" Taxman from Cortland Manor Pleads Guilty to \$145 Million Tax Fraud; Faces 8 Years

Perpetrated and Oversaw One of the Largest Ever Tax Frauds by a Return Preparer

On Dec. 18, Edward Y. Kim, the Acting United States Attorney for the Southern District of New York, announced the guilty plea of RAFAEL ALVAREZ, a/k/a "the Magician," to a two-count Superseding Information charging ALVAREZ with one count of conspiracy to defraud the U.S. and steal government funds and one count of aiding and assisting in

the preparation of a false and fraudulent U.S. individual income tax return. The charges arise from ALVAREZ's orchestration of a decade-long, \$145 million tax fraud scheme to file tens of thousands of federal individual income tax returns that included false information designed to fraudulently reduce the individuals' tax burden. As part of today's guilty plea, Alvarez agreed to pay the Internal Revenue Service ("IRS") \$145 million in restitution and forfeit over \$11.84 million in fraudulent proceeds he received from his criminal conduct. ALVAREZ pled guilty today before U.S. District Judge J. Paul Oetken.

Acting U.S. Attorney Edward Y. Kim said: "Rafael Alvarez became known as 'the Magician' by his customers for his supposed ability to make their tax burden disappear. But, as today's guilty plea shows, there was no magic to what Alvarez was doing - he was committing a serious federal crime by falsifying tens of thousands of tax returns and, in the process, depriving the IRS of \$145 million in tax revenue. Today's guilty plea, in one of the largest ever tax frauds by a return preparer, should serve as an important reminder to tax professionals that this Office will vigorously investigate and prosecute tax offenses."

As alleged in the Indictment and Superseding Information and statements made in public filings and court proceedings:

From at least in or about 2010, up to and including in or about 2020, ALVAREZ was the CEO, owner, and manager of ATAX New York, LLC, also doing business as ATAX New York-Marble Hill, ATAX Marble Hill, ATAX Marble Hill NY, and ATAX Corporation (together, "ATAX"). ATAX was a high-volume tax preparation company located in the Bronx, New York, which prepared approximately 90,000 federal income tax returns for its customers during this period. ALVAREZ both prepared tax returns for ATAX customers and recruited, supervised, and directed other ATAX personnel who in turn prepared tax returns for customers. During this period, ALVAREZ oversaw a sweeping fraudulent scheme, whereby he and his employees submitted false information to the IRS in ATAX customers' tax returns. This false information, which included, among other things, bogus itemized tax deductions, made-up capital losses, phony business expenses, and fraudulent tax credits, served to fraudulently reduce the customers' tax liability and increase the customers' tax refunds from the IRS.

In total, ALVAREZ oversaw ATAX's fraudulent submission of tax returns on behalf of customers that deprived the IRS of \$145 million in tax revenue. ALVAREZ was so consistent at falsifying ATAX customer tax returns that he became known to ATAX's customers as "the Magician." Additionally, ALVAREZ agreed as part of his plea agreement that he was a leader of the scheme and attempted to obstruct or impede the administration of justice with respect to the investigation of the tax fraud scheme when he and an ATAX employee made false statements to an IRS Revenue Agent. ALVAREZ's operation of ATAX helped the company generate approximately \$12 million in fraudulent proceeds over the duration of the fraud.

ALVAREZ, 61, of Cortland Manor, New York, pled guilty to one count of conspiracy to defraud the U.S. and steal government funds, which carries a maximum sentence of five years in prison, and one count of aiding and assisting in the preparation of a false and fraudulent U.S. individual income tax return, which carries a maximum sentence of three years in prison. ALVAREZ is scheduled to be sentenced by Judge Oetken on April 11, 2025.

For the First Time in Five Decades, New Yorkers Had No Third Party Choice for President in 2024

When New Yorkers cast their ballots on Nov. 5, 2024, they had only two presidential choices: Kamala Harris or Donald Trump. Biden appeared on the Democratic and Working Families party lines, while Trump appeared on the Republican and Conservative party lines.

As someone who has grown disaffected with both major political parties and someone who voted third party in both 2016 and 2020 (Libertarian), I decided to look back to see when was the last time that New Yorkers had only two choices for President.

In 2020, the Libertarian Party (Jo Jorgenson) and the Green Party (Howie Hawkins), were on the Presidential ballot in New York.

In 2016, the Libertarian Party (Gary Johnson) and the Green Party (Jill Stein) appeared on the ballot.

In 2012, Johnson, Libertarian, and Stein, Green appeared on the Presidential ballot.

In 2008 and in 2004, Ralph Nader ran and was on the ballot in NY for President. Nader ran as the Populist Party candidate in 2008 and as a Green Party candidate in 2004. Bob Barr ran as the Libertarian candidate for President in 2008.

In 2000, the Green Party, (Nader) the Right to Life Party (Pat Buchanan), and the Independence Party (John Hagelin) were on the Presidential ballot in NY. Nader got 3.58%.

In 1996, Ross Perot got 8% of the vote in NY on the Independence Party line, while Nader got 1.2% on the Green Party line. Howard Philips ran as the RTL party and was also on the ballot in NY.

In 1992, Perot got 15.75% in NY as the Presidential candidate of the Independent Party.

In 1988, only the Right to Life Party, and Presidential candidate William Marra, were the third party option in NY.

In 1984, New Yorkers had only two choices for President; Walter Mondale, democrat, or Ronald Reagan, republican.

In 1980, John Anderson appeared on the ballot in NY and got 5.8% of the vote.

So why were there no third party options for the xxx New Yorkers who do not indentify with any political party in NY?

Former Governor Andrew Cuomo is the reason. In 2018, Cuomo was challenged for re-election for Governor by Sex in the City actress Cynthia Nixon. The Working Families Party endorsed Nixon, but Cuomo won both the Democratic and WFP primaries. But Cuomo never forgot the political noise that the WFP and Nixon made in the summer of 2018, and in 2020, he changed the rules and raised the obstacles for minor political parties to get on the ballot and stay on the ballot.

Cuomo included the changes in the 2020 State budget. Legislators had no choice but to vote on both the budget and the ballot changes in one bill. The changes included increasing the number of votes that minor party candidate for President must get from 50,000 to 130,000 to stay on the ballot. He also tripled the number of signatures a candidate or minor party are required to get to 45,000 in a 45 day window.

Since these changes, no third-party candidate for President has been on the ballot in NY, despite efforts by the Green Party and the Libertarian Party to do so.

“The US has the most restrictive ballot access requirements of any electoral democracy in the world. The ballot should be available to all serious candidates. It is anti-democratic for the Democrats and Republicans to keep their competition off the ballot, especially when combined independent and third-party enrollment is 27% of the active New York electorate,” said Green Party candidate for Governor and President Howie Hawkins.

There are 3.4 Million voters in New York State who are not registered to the democrat, republican, conservative or working families parties. Those voters were forced to choose between Harris, Trump or don't cast a vote for President.

There is no political motivation in Albany to change this. All of the state legislators are Ds or Rs. One candidate, Robert F. Kennedy Jr., did make a concerted effort to get on the ballot for President in NY in 2024. I was hoping to cast my vote for RFK Jr., but while his name was on the ballot in several other states, he was not on the ballot in NY.

Other notable third party Presidential candidates in New York were:

George Wallace, 1968, Courage Party, 5.29%.

Henry Wallace, 1948, American Labor Party, 8.25%.

Teddy Roosevelt, National Progressive Party, 24.5%

during Killoran's many years with Habitat for Humanity.

I first met Jimmy and Rosalyn Carter in Los Angeles, during a build blitz. We built 21 houses in LA in one week. President Carter was diligent, a hard worker, who was committed to getting the job done. He pushed all of us.”

“I don't think I agreed with all of his priorities, but his faith should be a witness to us all. A mustard seed can take any person and change the world,”

The man who got Jimmy and Rosalyn Carter to build houses through Habitat for Humanity was Millard Fuller. Fuller founded Habitat and Killoran worked under Fuller.

In 2008, a disagreement resulted in Millard and Linda Fuller being removed from the Board of Habitat. Shortly after that the Fuller's founded The Fuller Center for Housing, the group that Killoran joined in 2018.

Killoran met President Carter at a Bible study in Georgia with Fuller and two more times at the funeral for Fuller and the 10th anniversary of his passing.

“I have been to the Carter center in Georgia and to his childhood home in Plains Georgia. He was a graduate of the Naval Academy.”

“Especially during this time of Christmas and Chanukah, we should take President Carter's example as a Clarion call to build houses. Here in Westchester, the dream of owning a home is slipping away from too many young people who are leaving.

“I'm still here building houses for Veterans with interest free loans and repairing houses for our older residents who also need help. That would be the best way to honor President Carter, put on some gloves and help us build,” said Killoran, whose work in Westchester building affordable houses can be found at <https://www.facebook.com/fullercenterny>.

The Fuller Center wrote a wonderful remembrance of President Carter. Titled, Former President Jimmy Carter "was a Christian in the best sense of the word" <https://fullercenter.org/former-president-jimmy-carter/>

Here are some excerpts, “When former President Jimmy Carter and wife Rosalynn returned to their hometown of Plains, Georgia in 1981 after losing the White House to Ronald Reagan, their intention was to decompress, get their post-campaign finances in order and for the newest ex-president to write a book.

“He also returned to teaching Sunday school at Plains' Maranatha Baptist Church, where a steady stream of people associated with a then-fledgling affordable housing nonprofit called Habitat for Humanity — headquartered about 10 miles away in Americus, Georgia — began showing up to hear him teach.

The leader of that nonprofit was a man named Millard Fuller.

“The first time we heard about Millard, I was still in the White House, and he wrote a very ugly editorial about Rosalynn and me not helping with Habitat,” Carter recalled with a laugh in 2019 at Koinonia Farm during an event marking the 10th anniversary of Fuller's homegoing.

Carter decided it was time to hear Millard and Linda Fuller out, so he and Rosalynn invited to their Plains home to hear more about the movement. The now former president, though, warned his wife that this was just a listening session — nothing more.

“I told Rosalynn ahead of time, ‘Don't agree to anything! We've got all we can do already,’” Carter recalled in 2009 at The Fuller Center for Housing's inaugural Millard Fuller Legacy Build in Lanett, Alabama.

Sure enough, Millard came armed with a long list of things he wanted the Carters to do. It was vintage Millard Fuller — convinced that he could accomplish anything if only he could get in front of people who cared and people who could appreciate his passion and his vision. Like most others whom Millard got in front of, the Carters were roped completely into the mission — and they agreed to every single item on Millard's list.

“They came into our house, and in half an hour we'd agreed to work for Millard Fuller,” Carter said with a laugh. “I thought it was the worst thing that could happen, but it turned out to be the best thing. ... From then on, our life was changed. It changed my and Rosalynn's life for the better.”

Carter said Millard Fuller's “Theology of the Hammer” led to an epiphany for him — one that changed the course of his life.

“That bridging from going to church and taking somebody and demonstrating what Christ told us to do, it's a very difficult thing to tie together,” Carter once said. “But Millard Fuller taught me how it could be done, and, for that, I am very grateful to him.”

“Millard and I are grateful to have had the opportunity to work with him and witness his unwavering commitment by being the ‘hands and feet’ of Jesus Christ in our needy world,” said Linda Fuller, who co-founded both Habitat for Humanity and The Fuller Center for Housing. “President Carter's stellar leadership and passion have made a lasting impact on both Habitat and The Fuller Center for Housing and the partnering families. His dedication to building homes for families and communities in need continues to inspire us to this day. We are grateful for his partnership, his friendship, and his example of selfless service to others.”

It is nearly impossible to overstate the impact that the Carters' involvement had in turning Habitat for Humanity into a household name and lifting the affordable housing movement to new heights. While Millard Fuller preached the Theology of the Hammer as a way to spread the Gospel by putting faith into action, President Carter put one of the world's most recognizable faces upon that philosophy and literally illustrated it — hammer in hand well into his 90s, even after undergoing brain surgery.

“It's always been his faith that impressed me most,” said Chris Fuller, the first-born son of Millard and Linda who took many groups to hear the president teach Sunday school at Maranatha over the years, especially during his time as a campus minister. “Whatever he did or said, it was his relationship to God that guided everything. And he never let up. He was a Christian in the best sense of the word. Jimmy denied himself, picked up cross daily and followed Jesus just like it commands in Luke 9:23. What a witness and what a life!”

“I saw first-hand how he put his faith in action, got muddy and sweaty just like everyone else, and sparked those projects to success,” Fuller said,” end of Fuller story.

Most of the media mention Habitat for Humanity in President Carter's obituary, and rightfully so. But the story continued with the Fuller Center for Housing and the man who pushed Jimmy and Rosalyn Carter to service, Millard Fillmore.

In our view, the chain of service extends from President Jimmy Carter to Millard Fillmore to Jim Killoran, who is still serving others by building houses and giving home ownership in the most expensive county in the USA. God Bless Jimmy Carter and consider volunteering or donating to Killoran and the Fuller Center for Housing. In addition to the foregoing Tax Sale Notice and Statutes therein described, the further or additional notice is given setting forth the lots and parcels of land, including the street address thereof, on which the tax lien is to be sold together with the aggregate amount of tax lien thereon, and the assessed valuation of every said lot and parcel as described in the 2023 Tax Rolls as approved by the Department of Assessment and Taxation and confirmed by the City Council.

The name set forth is that of the person, corporation or legal entity appearing on the tax rolls as the owner or occupant of the lot or parcel of land upon which the tax lien is to be sold.

The first item is the Comptroller's Tax Lien Number; the second is that of the person appearing on the tax rolls as the owner or occupant of the property; the third is the location of the property as described on the tax rolls which includes the Section, Block and Lot Numbers as shown on the Official City Map; the fourth is the assessed valuation unimproved as shown on the tax rolls; the fifth is the total assessed valuation as shown on the tax rolls; the last group of figures is the total amount of the lien which is to be sold.

of NY State and Cuomo whose allegations forced Cuomo to resign.

Bennett had a history of working for women's rights organizations in Westchester, including Hope's Door in Pleasantville. Bennett worked in three capacities for Cuomo from 2019 to 2020 as his special assistant, executive assistant, and policy advisor.

Bennett told NY Times reporter Jesse McKinley that on June 5, 2020, she was alone with Cuomo in Albany when he asked her whether age was a factor in a relationship. He added that he was open to a relationship with a woman in her 20s. Bennett said that while Cuomo never touched her, "I understood that the governor wanted to sleep with me, and felt uncomfortable and scared," Bennett told the Times. "And I was wondering how I would get out of it and assumed it was the end of my job."

Bennett's attorney, Debra Katz, issued the following statement. "Since Ms. Bennett filed suit in federal court in September 2022, former Governor Cuomo has used every opportunity to harass our client with an astonishing number of invasive discovery requests and outrageous statements in pleadings to embarrass and humiliate her. These include requests for medical records for unrelated specialists, including gynecologists, optometrists, and others, and medical records dating back more than ten years from when she was a minor.

"This fishing expedition was designed to dig up material to smear our client and distract from the fact that Mr. Cuomo did, as the New York Attorney General's Office concluded after a lengthy investigation, sexually harass Ms. Bennett and at least 11 other women. It is also important not to lose sight of the fact that before engaging in his multi-year, multi-million dollar legal war against Ms. Bennett—funded by N.Y. State taxpayers—Mr. Cuomo apologized for his behavior.

"At a March 2021 press conference, he apologized for "making anyone feel uncomfortable" and for "whatever pain I caused anyone"[1] and said, "I acknowledge some of the things I have said have been misinterpreted as an unwanted flirtation. To the extent anyone felt that way, I am truly sorry." [2] His apologies were empty.

"From the beginning, this litigation has been about securing justice for Ms. Bennett. For years since she dared to come forward with allegations against Mr. Cuomo, Ms. Bennett has bravely withstood inflammatory and false assertions about her character and conduct. She has been forced to fend off increasingly invasive documents and deposition subpoenas sent to her parents, family, close friends, and college. Mr. Cuomo has used these legal proceedings to punish Ms. Bennett and others who reported his sexual harassment and to cause more harm to her, all at the expense of New York taxpayers.

"On behalf of Ms. Bennett and in support of all who have faced sexual harassment by powerful men like former Governor Cuomo, we will continue to seek justice in our action against the State of New York. We are currently engaged in settlement discussions with the State of New York and former Governor Cuomo, who threatened to interfere with that process in his most recent letter to the federal court. In dismissing the federal case, we thus hope that our client will be able to resolve this dispute and finally be made whole for all the damage Mr. Cuomo and his agents caused her."

A Statement from Charlotte Bennett reads: "Former Governor Andrew Cuomo can no longer use this lawsuit to harass me and my family. His abusive filings and invasive subpoenas are meant to humiliate and retaliate against me and those who have supported me over the last five years of this living nightmare. Mr. Cuomo's letter to the Court last week is another example of this, and I have had enough.

"Throughout this harrowing two-year case, I've many times believed that I'd be better off dead than endure more of his litigation abuse, which has caused extraordinary pain and expense to my family and friends. I desperately need to live my life. That's the choice I am making today." Ms. Bennett's case in State court against the State of New York, which was her employer, will proceed.

Cuomo's attorneys, Rita Glavin, and Theresa Trzaskoma, stated, "Ms. Bennett's decision to drop her baseless lawsuit should be viewed as a complete capitulation and a desperate attempt to avoid being confronted with the mountains of exculpatory discovery—including contemporaneous texts and videos that the AG's office never obtained—that completely refute her claims against Governor Cuomo," reads a statement from Cuomo's legal team.

"After falsely smearing Governor Cuomo for years, Ms. Bennett suddenly withdrew her federal lawsuit on the eve of her deposition to avoid having to admit under oath that her allegations were false and her claims had no merit. If New York State does give in to her public pressure campaign and settles, it will not be on the merits. It should require the public release of all the evidence so that New Yorkers finally know the truth: Governor Cuomo never sexually harassed anyone."

Days after Bennett announced that she was withdrawing her suit against Cuomo, Cuomo filed legal papers that indicate he is moving forward with a defamation lawsuit against Bennett. "The nature of this action is to recover compensatory and punitive damages for the serious injuries and losses that Governor Cuomo has suffered and will continue to suffer as a result of the December 9, 2024, false statement by Bennett and her agents that Governor Cuomo "sexually harassed" Bennett (the "December 9 Defamatory Statement").

"Bennett's agents tweeted this statement on December 9, 2024, with the headline: "Debra Katz and Charlotte Bennett issued statements on news that Bennett voluntarily dismissed her lawsuit in the U.S. District Court in the SDNY against Andrew Cuomo, who sexually harassed her."

"Bennett reposted her agents' tweet, which has garnered over 90,000 views. The December 9 Defamatory Statement—which was intended to be and was widely disseminated and which was made in the wake of Bennett and her agents' numerous prior public accusations against Governor Cuomo—was false and defamatory, and Bennett made it knowing full well that it was false and intended to harm Governor Cuomo," states the lawsuit.

Katz called Cuomo's actions, "shameful that Mr. Cuomo has now chosen to go down that path." Many New York Democrats feel the same way and do not find the former Governor's actions to be an offer of peace with the many in the party who don't want Cuomo to make a political comeback. Cuomo is rumored to be preparing a run for NYC Mayor.

"If Andrew wants to mend fences, this isn't how. It's an indication that he plans to operate in the same way as he did when he was Governor. Take it or leave it and play hardball," said one Westchester democrat.

Many Westchester Democrats called for Cuomo to resign after the allegations of Bennett and others came out. An independent report made for NYS Attorney General Letitia James found that Cuomo sexually harassed 11 women. The US Department of Justice conducted a federal investigation which found that Cuomo harassed 13 women. Cuomo has disputed both reports and has never been charged with a crime. Some democrats wonder how he can run and win as a democrat, with so many still not willing to forgive and forget. Cuomo recently changed his voter registration last year from Westchester County, Purchase, to New York City.

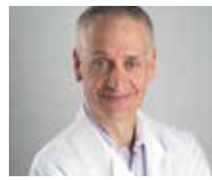
