Hugh Fox is Destroying the Conservative Party and This is Why

"Republicans and Conservatives in Westchester can't win elections if we are divided. There aren't enough of us left." This comment, from a Westchester republican, echo the thoughts of several republican elected officials and leaders who have had negative political interactions with Hugh Fox, Chairman of the Westchester County Conservative Party.

Fox, who has been County Conservative Chairman since 2011, has been withholding the Conservative Party line from republican candidates since 2019. Last year, he gave the Conservative line to Five Democratic, progressive pro-abortion candidates for State Supreme Court from Westchester.

That unprecedented move gave all five candidates, Judges Anne Minihan, David Zuckerman, David Squirrell, Elena Goldberg-Velazquez and Sherri Eisenpress help in their victories and enraged Westchester Republicans who had the same working arrangement with the Conservative Party for decades in judicial races. Some say the reason for this is that Fox's wife works in the Westchester County Courthouse, where many of these same judges preside.

This year, Fox has withheld the Conservative line from republican candidates in Eastchester, Tuckahoe, New Rochelle, Harrison, and Yonkers, and some have had enough.

In Eastchester, Fox sent out a letter to Conservative Party members in Town, alleging that "Republicans have decided not to run on the Conservative line." Actually,

Groundwork Hudson Valley Awarded \$100k to Lead Air Quality Monitoring in Yonkers



The New York State Department of Environmental Conservation's Office of Environmental Justice awards Groundwork Hudson Valley \$100,000 to participate in its Community Air Monitoring Capacity Building Program. The "Southwest Yonkers Air Quality Education Campaign and Planning Project" under the program will enable Groundwork to expand its efforts to inform environmental justice areas in Yonkers about the critical relationship between climate change, air pollutants, and individual and community health risks, and to create a community-based air quality monitoring plan.

The NYS DEC is undertaking community air quality monitoring in 10 disadvantaged communities with the highest air pollution burdens. Southwest Yonkers has been historically negatively affected by widespread environmental hazards which are now being exacerbated by climate change. It's among the 10 disadvantaged communities due to its limited green spaces, fewer trees, less availability to air conditioning, and many heat reflecting surfaces.

"We are thrilled to receive this grant from the NYS DEC Office of Environmental Justice," said Brigitte Griswold, Executive Director of Groundwork Hudson Valley. "This funding will enable us to empower communities to take action on air quality issues and advocate for their right to clean air."

"This program has the potential to be a game-changer for communities across Yonkers," said William Serratore, Yonkers Office of Sustainability Director. "Under the leadership of Mayor Mike Spano we are able to provide tools and knowledge to community members, and we can advocate for better air quality and overall healthier living conditions."

The continuous wildfires in Canada have covered parts of New York State with smoke and smog contributing to poor air quality over the past month. In early June, New York City ranked first among major cities for the worst air quality worldwide due the wildfires in Canada. Schools and outdoor activities in Yonkers were canceled due to the poor air quality.

This grant and initiative comes at a crucial moment and is an important step forward for Groundwork and Yonkers to continue its work around climate resilience and to increase the wider community's awareness and understanding of

growing climate-related health risks.



Yonkers Real Estate Sales and Prices Lower



The real estate market in Westchester, Putnam, and Dutchess faced heightened challenges during the second quarter of 2023, characterized by low inventory levels and the impact of an abrupt increase in mortgage interest rates, according to the Houlihan Lawrence Westchester-Putnam-Dutchess Q2 Market Report released today.

The report noted that a significant majority of homeowners with mortgages are currently paying below the historical average rate of 6.7%, the highest observed in 20 years. This has thwarted the trade up, trade down activity in all our markets and further exacerbated the already low levels of properties for sale. The limited inventory of homes, including luxury properties, has intensified competition among buyers and led to upward pressure on prices in most areas.

"This environment has resulted in a beneficial situation for homeowners who decide to sell, and with mortgage rates currently stabilizing, they are becoming more inclined to make a move. At all price points, sellers are often able to realize top dollar for their properties, when properly priced, and achieve significant returns on their real estate investments," said Liz Nunan, President and CEO of Houlihan Lawrence. Overall, the Westchester-Putnam-Dutchess market showed double-digit declines in home sales in all submarkets. Median sale prices were lower as well in most submarkets, with Westchester County Homes Sold: Down 24.4%, Median Sale Price: Down 4.1%; NYC Gateway (Mount Vernon, New Rochelle, Pelham and Yonkers)-Homes Sold: Down 18%, Median Sale Price: Down 4%. As Johnson Searches for Apartment in District, BOL Dems Remove Him as Majority Leader

Alvarado Named New Majority Leader; First Latino in History

Last week, Yonkerstimes.com learned that Westchester County Legislator Christopher Johnson was feverishly searching for an apartment in the 16th district in Yonkers that he represents, but no longer lives in. Johnson was caught living in a \$770,000 home with his wife and child for the past 12 months outside the district, while he illegally rented out an affordable housing condo that he used to live in that is in the district.

On Monday, July 10, democratic members of the Westchester Board of Legislators removed Johnson as Majority Leader. But they did not take action on whether to remove Johnson from his Legislator post.

There is a divide on the county board between democrats who want to see Johnson removed from office for violating the County Charter and residency requirements for legislators, and a few remaining supporters of Johnson.

Among those who are throwing Johnson a lifeline quietly, behind the scenes, are Deputy County Executive Ken Jenkins and Legislator David Imamura, based on the belief that it will look bad if another democratic county legislator is removed. Former BOL Chair Catherine Borgia stepped down from her leadership post earlier this year.

Other top democrats are worried that if the Board doesn't remove Johnson as Legislator, it will look worse for democrats. "He just can't admit that he made a mistake and was wrong-and got caught. Democrats need to enforce our own, and if you have a bad egg, then crack the egg," said one Westchester democrat.

Yonkers Councilwoman Shanae Williams, who defeated Johnson in the demo-

cratic primary for BOL-in District 16 said, "I have called on Legislator Johnson to resign, based on the fact that he didn't live in the district for 12 months. And if he doesn't resign, I am calling on the Board of Legislators to remove him from his seat, based on the County Charter. This sets a bad precedent if they do nothing and let him stay in office."

Another County Legislator from Yonkers, Jose Alvarado, who represents the 17th District, Southwest Yonkers, was named Majority Leader.

The Westchester County Board of Legislators announces the successful election of former Majority Whip José Alvarado as the new Majority Leader. Mr. Alvarado becomes the Board's first Latino Majority Leader in its history. Additionally, Legislator Tyrae Woodson-Samuels has been elected to succeed Alvarado as Majority Whip. These leadership changes reflect the Board's commitment to effective governance and the pursuit of the county's best interests.

Legislator Alvarado brings a wealth of legislative experience and a profound understanding of the needs and aspirations of Westchester County residents to his new role as Majority Leader. 5,000+ Term Limits Referendum **Petitions Filed**

City Clerk Spano Recuses; Deputy Clerks Pena and Ramondelli to review

On July 10, 2023, a term limits petition was filed before the Office of the City Clerk. Any public referendum sought in the City of Yonkers requires 4,723 valid signatures from residents. It falls within the duties of the Office of the City Clerk to review petitions calling

"In the interests of having a transparent and fair review of the petition filed, I have decided to remove myself from the review of the petition. The bipartisan team of Deputy City Clerks will review the petition and make the determination they see fit", stated City Clerk Vincent Spano. "As City Clerk, it has been my goal to have a Clerks Office that operates with transparency and fairness to serve every resident of Yonkers."

A number of Yonkers residents called Yonkers Voters for Term Limits, circualted the petition. The petition asks voters to approve a change in the term limits law allowing the Mayor and Councilmembers to serve a maximum of three, four-year terms. Last November, the City Council voted to extend term limits from three term to four terms. This referendum will ask the voters if they wish to return the number of allowable terms back to three.

If the signatures are deemed valid by the City Clerk, the matter goes to the Yonkers City Council. The Council will then vote to accept the petition and allow the question to be placed on the ballot November 7, or reject the petition. If the petition is rejected, Yonkers Voters for Term Limits must go out and collect another 2,500 valid signatures, and resub-

it was Fox who denied one republican candidate for Town Board, Anthony Giacobbe, from also running on the Conservative Party line, and then ran a conservative candidate against Giacobbe and Councilwoman Sheila Marcotte (also up for reelection) without telling the republicans. That dispute resulted in Supervisor Tony Colavita and the entire republican ticket in Eastchester to side with Giacobbe in refusing to take the conservative line without their running mate. So, the two Eastchester republican candidates for Town Board are now opposed by a Conservative candidate who is totally unelectable.

In the letter that Fox mailed out to Eastchester residents, he explains that Giacobee's political sin is that he is a supporter of Rob Astorino. "Anthony Giacobbe and Scooter Scott (2021 GOP County Clerk candidate and candidate this year for Tuckahoe Mayor) were not endorsed due to their misguided and ambitious associations with incompetent and ethically lapsed politicians, particularly the last Westchester County Executive, and his greedy political operatives.

"Giacobbe backed the same, failed former politician against Lee Zeldin last year.... We find Mr. Giacobbe to be disloyal. He is a man in a hurry.... We are endorsing Bob Fois for this

The question that many are asking is why does Fox have such political hatred for Astorino? Fox became County Conservative Chair in 2011. When Astorino became County Exec., he gave Fox a six-figure county job with a car. In 2014, Fox crashed the county car and got arrested for DWI in White Plains. He resigned his county job the next day, but quickly was given a private job at Westchester County Airport.

But Fox is said to hold a grudge against Astorino for "not going to bat for him with the DWI," said one Westchester Republican. "What did want Astorino to do, squash the arrest for DWI after he crashed a county car?" Since 2018, Fox has publicly bashed Astorino and anyone who supports him.

We find Anthony Giacobbe to be a young, republican-conservative whose political future is bright. In 2021 he almost upset Damon Maher for County Legislator. His wife Laurie serves on the Eastchester School Board. We find the Giacobbe family to be true conservatives, and do not believe that Giacobbe's support for Astorino to be a lifetime ban on public service in

"Hugh Fox declined to endorse a republican slate of candidates in Eastchester, one of the last republican-conservative strongholds in Westchester. Good luck with that Chairman Fox, for shooting your party in the foot," said an Eastchester republican.

Fox has circulated petitions for Bob Fois, Eastchester Conservative Party Chair, to run for Town Board. Fois has the same employment history as Fox. Both were given county jobs by Astorino, but now both are actively working against the former two-term County Executive who still has the respect of a super-majority of republicans across the county. And Fois still has his job in county government, 6 years under the new democratic administration of County Executive George Latimer, making some wonder how this conservative leader in Eastchester still has his job. Prior to 2017, Latimer's election as County Executive, it was a rare occurrence for republicans in Westchester NOT to get the Conservative Party line. "Now it's happening all over the county," said one county conservative not affiliated with Fox and Fois.

Several years ago, Fois ran for Westchester County Board against Vito Pinto, and lost badly, despite having both the republican and conservative party lines.

Fois recently sent out a letter to Eastchester residents that we have obtained. He writes,

"My candidacy leaves us with an election between a Conservative and a Republican-two parties who share common principles.... Our party embraces the sanctity of life. We support Judges who support your Second Amendment rights." But Fois' words do not match the actions of Fox and the Westchester Conservative Party, who endorsed five democratic candidates for State Supreme Court just last year. Many see this as an inherent double standard, and the smell of backroom politics rampant in the Westchester Conservative Party

"If you are asking me to choose between Rob Astorino and Hugh Fox, it's no contest. Astorino all the way. And the odd thing about it is that Rob is a true conservative, based on his principles and beliefs, and the way he ran the county as County Executive. This is getting ridiculous," said one Westchester republican leader.

Republican candidates in Harrison and Yonkers and other municipalities are having the same problems with the Westchester conservative party. In Yonkers, Councilman Anthony Merante, the republican candidate for Yonkers Mayor, did not get the Conservative Party line this year. "You are not going to get more Conservative in Yonkers than Anthony Merante. And this year, you never know with the term limits debate and Mayor Spano seeking a fourth term. Merante could be close enough to win."

And in Harrison. Fox denied the republicans and gave the conservative line to the entire slate of democratic candidates in the upcoming Town elections.

Other Westchester communities where Republican candidates did not get the Conserva-

tive line in 2023 (some did not seek due to the toxicity of the party): include: Bedford, Bronxville, Cortlandt, Tarrytown, Pelham, New Rochelle, Rye City and White Plains

And in the most recent county-wide race, Republican County Executive candidate Christine Sculti had the same thing done to her by the Conservative party in Westchester, denying her their line, as well as the republican candidates for County Clerk and for District Attorney

One registered Conservative from Cortlandt remined us that back in 2011, at a County Board of Legislators meeting, Fox "disrupted the proceedings and was led out of the Chamber by a Westchester County Public Safety officer...Fox then began acting inappropriately in the Rotunda, with witnesses watching him first standing on a table and then attempting to vandalize one of the framed portraits on the wall. The portrait came off the wall and Fox quickly re-hung the portrait back up before scrambling off the table," according to the Albany Times Union.

"When is it enough? Every year, there are fewer and fewer registered conservative in Westchester. And Hugh Fox is going to tell the republican party what to do? Isn't this the tail telling the dog what to do?"

NY's Highest Court to Determine Outcome of Term Limits Lawsuit

Twelve Yonkers residents and their attorney Michael Sussman have filed a final appeal with the NY Court of Appeals regarding their suit alleging that the change in the Yonkers Term Limits law last year was not legal. Sussman has also filed a motion to move the matter forward in time for this year's November election.

So far, the 12 Yonkers plaintiffs Anne Marie McArdle, Carolyn Solieri, Michael Represa, Christine Peters, Eric Johnson, Frank Coleman Jr., George Mcanama, Joan Gronowski, Joe Pinion, Kisha Skipper, Mark Parolis and Ron Matten, have lost their legal argument.

In April, State Supreme Court Judge George Fufidio ruled that the vote by the council to modify the number of terms that councilmembers and the Mayor can run from 3-four year terms to 4-four year terms was lawful, writing, "there were no ethical violations committed by the Yonkers City Council by increasing their own and the Mayor's term limits," and "this Court does not find that the increase in term limits for the City of Yonkers Mayor and the Yonkers City Councilmembers violates the Yonkers City Charter."

Last month, a NYS Appeals Court in a unanimous vote, ruled that the vote by the Yonkers City Council last year was illegal was without merit. In a unanimous decision, the Appeals Cour Judges found that the Council and Mayor Spano did not violate the Yonkers Charter and did not commit an ethics offense simply by voting for a signing the term limits

The one unknown question is can this suit have an impact on the November election for Mayor. Most believe that it would be legally and practically impossible to remove a person from the November ballot, or postpone an election without d disenfranchising Yonkers voters. The City of Yonkers has argued that the vote was legal, and that the remedy, as always in elections, is to vote the person serving many terms out of office.

On This Day in Yonkers History...



Saunders Trades HS opened in 1936 to help find jobs for the unemployed

Monday, July 17th

July 17, 1939: Yonkers Comptroller James Hushion released the 1938 annual Saunders Trades School Fund financial report. Although its net income was \$3,310 from bonds, mortgage interest and rents, Yonkers drew an additional \$15,000 for previous years' expenses. The fund, set up by the late Ervin Saunders to maintain and improve the Trades School, had assets of \$434,126.68. Its assets were: real estate valued at \$234,399; City of Yonkers and Home Owners Loan bonds; mortgages totaling \$142,950; and cash.

July 17, 1939: Ninth Ward Alderman William Slater issued an ultimatum to City Engineer Chris Sheridan: release information on Yonkers' WPA road projects or Slater would demand a state investigation. This was the culmination of a running dispute between the two men; Slater felt his ward was neglected when it came to road repair and wanted a lot more work done in his ward.

Tuesday, July 18th

July 18, 1921: Yonkers police were called to Sandy Beach at the end of Valentine Lane when residents phoned to complain young women attired in "one-piece bathing suits" were "dancing while wearing wet bathing suits," doing the "new-fangled numbers, the Chicago and Shimmy." Police investigated and left without chasing the girls off.

July 18, 1928: The new Alexander Street City Jail had it first "prisoner" locked up. DPW employee Raymond Reynolds was in the process of cleaning when the door slammed, instantly locking him in a cell. None of the employees had the key, including Deputy DPW Commissioner Arthur Miller. Police Headquarters didn't have one, so they had to get the key from Commissioner of Public Safety Frank Devlin. Miller rushed to City Hall, burst into the Commissioner's office, and stated it was a case of life or death! He got the key.

July 18, 1939: The City Manager League announced it would present its own line of political candidates for Yonkers' first City Manager Council, but they had not selected their candidates yet. The announcement dashed the hopes of Democrats and Republicans, who had hoped to get League endorsement of their candidates.

Wednesday, July 19th

July 19, 1939: Disbarred lawyer J. Richard "Dixie" Davis, "Kid Mouthpiece" of Dutch Schultz's gang, appeared in Supreme Court, brought there under guard. He was called to testify in the Frances Flegenheimer lawsuit for compensation for her husband's hidden ownership of Yonkers Brewery; her late husband was known as "Dutch Schultz!"

Davis stated Yonkers political leader Thomas Brogan was the "front man" who got the permit for the Yonkers Brewery. According to Davis, Brogan was paid \$200 per week to cover up the Brewery's true owner, Arthur Flegenheimer (Dutch Schultz), and pretend he was "owner" of the Yonkers plant.

Thursday, July 20th

July 20, 1939: Real Estate agent Alfred O. Hudson claimed Alderman William Slater, who ran the Suburban Bus Company, deliberately created a Suburban Bus Company bus stop in front of the new Kimball Avenue home he was selling. Slater and Hudson had a long-term feud; Slater had attempted to create a "limited parking" area in front of Hudson's office on McLean Avenue a few months earlier.

Hudson's partner Evan Gold went to City Hall to complain and met with YPD Captain Dennis Cooper; he learned Public Safety Commissioner Morrissey opened the new stop for the "convenience" of the bus company's Tibbetts line. Gold informed the Captain a Suburban bus had parked in the offending bus stop for several hours the day before, preventing people from attending its open house because they were unable to park.

July 20, 1939: After cutting salaries 7% in September, management of Alexander Smith and Sons Carpet Factory offered to restore 5% of the cut. Officers of Local 122, Textile Workers Union, requested the company restore the full 7% since the emergency necessitating the reduction had passed.

The company replied they really hadn't cut 7%, but "only" cut salaries 6.2%.

Friday, July 21st

July 21, 1937: Otis Elevator Company, the second biggest industry in Yonkers, announced it would start a five day forty-hour week for the 1,600+ employees of its Yonkers plant

July 21, 1939: Fifteen-year-old Adriane Richards, daughter of former national tennis champion and Yonkers native Vincent Richards and living on Adele Lane in Cedar Knolls, was presented as the "Sweetheart of the Future" by artist Russell Patterson. Adriane inspired a new character Patterson was creating for the national magazine series he was launching in the Fall.

Vincent Richards still holds the record as the youngest male to win a major championship; he was 15!

"Interventional procedures are not surgeries. They are small, through-the-skin or percutaneous injections or procedures to provide medications around effective nerves, joints, and areas in and around the spine to help control chronic pain," explains Dr. Erosa, who has a passion for offering other options to provide patients with pain relief.

Once Dr. Erosa and his colleagues diagnose where a patient's pain is coming from, they determine the appropriate treatment modality. For example, with neck pain, long-term management may involve radio frequency ablation.

"This is where we place a special needle right next to those nerves and use radio waves to shut down those nerves for nine months to a year, providing sustained pain relief for that period of time," states Dr. Erosa.

But the Pain Management Center at St. John's Medical Group offers treatments for all types of pain. "We do have several procedures for joint pains—knee, foot, hip, upper extremities, wrist, elbow, shoulders—that are specific to those areas as well."

Other Treatments (or Therapies) offered at SIMG's Pain Management Center include:

Other Treatments (or Therapies) offered at SJMG's Pain Management Center include: Minimally Invasive Lumbar Decompression (MILD) is used to treat spinal stenosis, which arises when the joints of the back become arthritic, and the nerves are squeezed, limiting the flow of blood to the spine (spinal area).

"You may have seen family members walking flexed forward, hunched over as we age. That is part of the body's mechanism to decrease some of the symptoms. When we flex our back forward, we open the canal. When we stand upright, we make the canal smaller. So, as a protective mechanism, the aging spine tends to bend forward," said Dr. Erosa, who added that in many cases, conservative therapies like physical therapy and medications produce undesirable side effects such as dizziness or drowsiness.

"When you're already having difficulty ambulating and walking, sometimes these added effects are not helpful and can actually impede your overall functioning," notes Dr. Erosa. Steroid injections are another available therapy, but they can only be administered safe-

Steroid injections are another available therapy, but they can only be administered safely three times a year. The good news is, before individuals need to undergo major surgery, there's another option: minimally invasive lumbar decompression (MILD).

How Does MILD Work? With MILD, physicians focus on one part of the spinal stenosis: the ligamentum flavum. "Through a small stab incision, a small poke in the skin the size of the baby aspirin, we slide a little trocar and shave a little bit of the bone along with a little bit of that ligament to open up the space," explains Dr. Erosa. "Everything is done through this small incision. It can open the space and allow for blood flow to restore to those nerves and decrease symptoms of leg pain when ambulating or standing for long periods of time."

This is a same-day procedure, so patients can return home immediately and resume normal activity 24 hours later. There are no stitches, either. Instead, the incision is closed with a medical glue called Dermabond. Another benefit is that no implants are left behind. Even better is that the MILD procedure is as safe as a steroid injection.

What Can Patients Expect? Once the procedure is complete, patients see more functional gains as time progresses over a six-month period with therapy and exercise. Patients who have benefited from the MILD procedure can get around and stand approximately seven times longer than they did in previous clinical trials—and walk 16 times farther.

"The procedure is very good at improving functional outcomes, as well as decreasing pain by at least 50%. It gets even better with some of the results," shares Dr. Erosa. "What they found at a five-year data study, 88% of the patients who had this procedure had sustained benefit and only a small percentage of patients went on to needing further surgery."

St. John's Medical Group's Pain Management Center's Peripheral Nerve Stimulation therapy, which electronically stimulates specific nerves to reprogram and override the pain to potentially provide long-term relief, is "the first of its kind in Yonkers and in lower West-

chester."

"We place a small wire next to the nerve. It stays in for two months and is then removed. We have found this treatment provides sustained relief without medications or per-

While the SJMG's Interventional Spine & Pain Management Center has only been open for two months, "the word is getting out in the community. We are already treating hundreds of patients. It's a big deal."

manent implants," said Dr. Erosa.

"We have something else to offer patients with chronic pain, other than opioids. We do something different, and it is especially satisfying to help someone who has exhausted all their treatments and other options," said Dr. Erosa, who stresses that after treatment, patients need to complete their rehabilitation and home exercises.

With new treatments for pain management under review by the FDA, seeking treatment at SJMG's Pain Management Center's ensures that patients will get the most advanced and revolutioners one.

"We are living in exciting times. There are a lot of options for patients. And I just want to let them know we're here to help. We're here to offer them the best state-of-the-art treatments and get them the best outcomes possible," assures Dr. Erosa.

July 22, 1937: The Board of Alderman voted into law Alderman Slater's ordinance banning "bathing suits, shorts, halters or any other costume which indecently exposes any part of the wearer's person" from Yonkers roadways and sidewalks as they were improper "wearing apparel." The passage was aimed at New Yorkers walking to Tibbetts on the Aqueduct in "scanty attire."

July 22, 1939: Although attempts were made to reach Alderman William Slater to discuss his bus company's stop in front of rival Alfred Hudson's house up for sale, Slater remained "out of reach on vacation."

July 23, 1926: Former Mayor Wiesendanger and Charles Lowa had to appear before City Judge Broderick to answer summonses for violating the 30-minute parking ordinance on South Broadway. Both men stated they were parked in front of their businesses and "no one was injured by such an action." Broderick told them the law was valid... they needed to get special permits for the "special privilege."

July 23, 1936: Saunders Trades School was home to the Summer Session of Yonkers College; it opened with 40 students enrolled.


