TMZ and Styles P Get Yonkers Police Video Wrong: Officers Did Nothing Wrong or Improper

A controversy erupted on social media after TMZ posted a story about an incident involving two Yonkers Police Officers and a individual who was driving an unregistered moped on July 12.

Here is the statement from the YPD. "The Yonkers Police Department is aware of a video that surfaced on social media regarding an interaction between Yonkers Police Officers and members of the community. The incident itself revolved around the arrest of an individual who fled from Officers while she was being detained during an investigation into her reckless driving of an unregistered moped on a busy city sidewalk. Unregistered and uninsured moped operation on Yonkers streets and sidewalks is one of the most frequent complaints from community groups in recent months. After the individual attempted to flee, the Officers caught up to her and attempted to restrain her. The individual continued to refuse to comply, at which point an Officer utilized a standard take-down to bring her to the ground to be handcuffed. Subsequent to her arrest, a knife was recovered from an easily accessible front compartment on the moped.

"An internal investigation was immediately commenced at the scene, even before any videos of the incident were published to social media. The Yonkers Police Department routinely conducts full investigations into ALL uses of force by our Officers. This investigation includes the review of all video surveillance footage including Body-Worn Cameras as well as interviews of all involved. The early stages of this investigation reveal that no strikes were used at any time during the incident and no force was used after handcuffs were applied. The investigation is ongoing. The attached video is the full and un-edited Body-Worn Camera footage from a primary Officer involved. The Yonkers Police Department is committed to transparency and serving the Yonkers community with service, integrity, and respect. More information regarding this interaction may be released as it becomes available."

NPR Releases Four Part Podcast on Yonkers Police Department

NPR, National Public Radio, released its first episode in a four part series titled Embedded, "Changing the Police," which follows hosts Kelly McEvers and Dan Girma during the year they spent reporting on the Yonkers Police Department.

Episode one, "Changing the Police: The John Mueller Show," was released on July 14. According to NPR, Episode 1 takes listeners to Yonkers, New York, a city with a long and ugly history of bad policing. The Justice Department has demanded an overhaul of the department and has been monitoring it for more than a decade. The commissioner in Yonkers has promised to do what the feds want and more. He has promised to "reform" policing in Yonkers and turn his officers into guardians of the community, accountable to its citizens. Can it be done and what does this kind of reform even look like?

Future episodes will be released every thursday, and while there is no idea of what NPR will come out with on the YPD, law enforcement we spoke to said, "we aren't expecting a rosy portayal if its NPR, but let's see what happens."

The teaser from NPR on episode one above, and there other characterization of the YPD, "with its history of misconduct and chief eager to change policing from within."

"In this first episode, we will meet the man who, for the year we were reporting on Yonkers, was the main driver of the reform (Mueller). And we'll meet someone who's not so sure that this department is able to reform until it reckons with its past."

Mueller has since moved onto become the Chief of the MTA police, and is featured favorably in the first episode. "Commissioner Mueller is a cop's cop. He speaks like a blue-collar white guy. He curses. But if you dig deeper, he's actually somewhat of a progressive. He seems to really care and really wants to make a difference."

Mueller is portrayed as a reformer in the Yonkers Police Department. But Mueller was a member of the YPD during the same time that NPR kept referring to as "the long and ugly history of bad policing."

Westchester Real Estate Market Finally Cools Down



**Greenwich, Ct home for sale at \$13 Million
Lack of Inventory Continues to Impact the Market**

After two years of eye-popping increases in luxury home sales, the market appears to be stabilizing with luxury home sales in New York and Connecticut posting mixed results in the second quarter, according to the Houlihan Lawrence Q2 Luxury Market Report released today.

Homes sold in Westchester (\$2M and higher) rose 12.2 % in the second quarter while the Putnam-Dutchess market (\$1M and higher) registered robust gains of 51.6 %. The highest priced luxury home sold in Westchester in Q2 was \$24,150,000 in Bedford. For Putnam the highest home sale was \$5,720,000 in Haldane while in Dutchess it was \$5,600,000 in Clinton.

In Connecticut, the Greenwich market (\$3M and higher) showed a sales decline of 34.5%. Greenwich saw the highest price sold for a luxury home at \$17,616,666. Darien and New Canaan (\$2M and higher) posted declines of 48.3% and 44.1%, respectively. The highest price home sold in Darien was \$6,150,000. The top selling price in New Canaan was \$7,100,000. The Rowayton market (\$2M and higher) experienced a 36.4% decline in luxury sales.

The median sale price in Westchester was down 0.9% while the median sale price in the Putnam-Dutchess market was down 9.1%. In Greenwich, the median sale price was up a slight 3%, while Darien and New Canaan showed modest declines of 0.6% and 1.1%, respectively. The median sale price in Rowayton was down 3.7%.

According to the report, the pace of increases in New York is slowing, and the declines in Connecticut are likely driven by a lack of inventory, not a lack of demand. The urgent need for more space and amenities in less dense areas that fueled our booming market the past two years has eased. Buyers remain motivated to purchase homes that are priced and presented to meet the market.

The lack of inventory continues to impact the market north of NYC. As supply declines, so too do pended sales, which are those scheduled to close within 60 to 90 days and ultimately closed sales. Most buyers are sellers first, and the market is in favor of sellers. However, a confluence of events has convinced many luxury homeowners to stay put.

“Rising mortgage rates impact the decision to stay or move. The luxury buyer has the resources to absorb higher payments, however many would-be buyers who recently refinanced or purchased at a 3% mortgage are reluctant to trade their existing home and assume a significantly higher mortgage on a new purchase. Should their desire for a new home be stronger than practical implications, many don’t want to compete in such a supply-constrained market,” said Anthony P. Cutugno, Sr. Vice President, Director of Private Brokerage for Houlihan Lawrence.

Cutugno said the buyer’s inertia mounts when they consider the hurdles to overcome once they purchase a new home. “Most new buyers want to put their personal mark on a new home, but material delays, supply chain issues and labor shortages keep homeowners out of the market,” he noted, adding, “Low supply translates into competition, and sellers still have the upper hand. However, a sense of discipline has returned to the market as buyers contend with rising interest rates, stock market volatility and record high inflation.”

18 Reported Cases of Monkeypox in Westchester, but Risk Still Low

As of July 19 2022, New York State reported a total of 679 confirmed orthopoxvirus/monkeypox cases - a designation established by the Centers for Disease Control and Prevention (CDC) - have been identified with 639 in New York City, and 18 in Westchester County.

Monkeypox is a rare, viral infection that does not usually cause serious illness. However, it can result in hospitalization or death. That’s why health officials in New York, the U.S., and around the world are monitoring cases of monkeypox in areas that do not usually report monkeypox infections, including in New York State.

While New Yorkers should not be alarmed, everyone should stay informed about monkeypox. This means understanding the symptoms, how it spreads, and what to do if you are exposed.

Who is at risk for contracting monkeypox?

Monkeypox spreads through close, physical contact between people. This means anyone can get monkeypox. However, based on the current outbreak, certain populations are being affected by monkeypox more than others, including men who have sex with men (MSM).

Based on previous outbreaks of monkeypox around the world, some groups may also be at heightened risk for severe outcomes if they contract monkeypox. This includes people with weakened immune systems, elderly New Yorkers, young children under 8 years of age, and pregnant people.

On July 15, Westchester County Executive George Latimer County Executive George Latimer and Health Commissioner Dr. Sherlita Amler confirmed there are active cases in Westchester and provided an update on vaccinations available. The County is focused on getting the symptomatic tested, vaccinating those exposed

Latimer said: “While the risk for Monkeypox remains low for Westchester County residents, we want everyone to be aware that this virus can spread from person to person. Monkeypox can be transferred from the time symptoms begin, until the rash has fully healed and a new layer of skin has formed. If you feel you are exhibiting symptoms of the virus, we encourage you get vaccinated as soon as possible.”

Amler said: “We should not be alarmed, but we should stay informed about the symptoms and how the virus is spread. Residents should seek care immediately if they present symptoms consistent with Monkeypox, such as rashes or lesions. This will help us to prevent a further spread of the virus in the County.”

Testing for Monkeypox is done by swabbing a lesion. To be tested a lesion must be present, or an individual must have had an exposure in 14 days or fewer. Testing is now being processed at commercial labs in New York State, and results are returned within 48 hours.

The Monkeypox vaccine is a two dose vaccine with 28 days between doses for adults 18+. Westchester County received 450 doses of MPX vaccine from New York State in the first batch, and 520 doses in the second batch. The County Health Department is working with New York State to obtain more vaccine.

Several hospitals and health centers in Westchester have been provided with a limited number of vaccines. The Westchester County Health Department will hold clinics on Mondays from 12-3 p.m., and Wednesdays from 4-7 p.m. at 134 Court Street, White Plains. This is by appointment only, and individuals must attest that they meet the criteria. To make an appointment, visit the Health Department Website or call 914-995-5800.

All positive cases of a County resident are required to be reported to the Westchester County Health Department, who will conduct contact tracing. If the contact meets the criteria, they should reach out to the Health Department or one of the other locations listed above to be vaccinated.

Tax Cap Set at 2% Again for 2023

Property tax levy growth will again be capped at 2% for 2023 for local governments that operate on a calendar-based fiscal year, according to data released today by State Comptroller Thomas P. DiNapoli. This figure affects tax cap calculations for all counties, towns, and fire districts, as well as 44 cities and 13 villages.

"Allowable tax levy growth will be limited to two percent for a second consecutive year," DiNapoli said. "Just as local governments are receiving their final round of federal funding under the American Rescue Plan Act, they are facing economic challenges that will likely drive costs higher than expected or planned, making it harder to adhere to the tax cap as they prepare their budgets for 2023."

DiNapoli said given this year's inflation factor calculation of 7.17%, a majority of New York's counties, towns and calendar year cities and villages could see cost increases that exceed the amounts they are set to receive in their final round of American Rescue Plan Act (ARPA) funds.

The tax cap, which first applied to local governments and school districts in 2012, limits annual tax levy increases to the lesser of the rate of inflation or 2% with certain exceptions. The tax cap also includes a provision that allows municipalities to override the tax cap. This is the fourth time since 2019 that municipalities with a calendar-based fiscal year (Jan. 1 through Dec. 31) had their levy growth capped at 2%. The 7.17% inflation rate that DiNapoli calculated is the highest the inflation factor has been since the tax cap was first implemented and more than triple the 2.3% inflation factor from the prior year.

He wants his cops to focus only on people they know are committing crimes, not do random stops and searches.

Precision policing is based on the position that the overwhelming majority of people don’t commit crime. And the idea he’s obsessed with is this approach to get cops to be less aggressive with people.

MUELLER: I really believe in procedural justice, procedural justice training. I use procedural justice, procedural justice, procedural justice. Procedural justice – are you familiar with that?

MCEVERS: Procedural justice started as a theory. It was developed by professors at Yale Law School and by Chicago police trainers.

MUELLER: The whole point of procedural justice, for me, is just developing a better relationship with the community. Most people probably have a personal interaction with the police less than five times in their entire life. So we got to make all five of those count. You know, for us, it has to do with, what is the day-to-day interaction? It’s those very minor...

MUELLER: The people are our clients. Let’s make sure that they walk away being satisfied. I am satisfied with the way I was treated. I am satisfied with the outcome. I may not agree with it, but I am satisfied with the outcome. And if you can do that, you’re going to make friends and you’re going to add credibility for the policing profession in general.

As we were reporting this story, John Mueller’s reform plan seemed to be working, at least in ways we could measure. The number of times cops have reported using force has gone down since Mueller took over, and the crime rate is down, too. And that’s better than similar-sized cities in the state.

NPR went out with officers from the 3rd precinct and did not find anything unusual. One call had a woman who was trying to set fire to the gas station. The incident ended without incident. The only objection from NPR was that several officers showed up as back up, and many of those officers were white. The two officers who initially responded were black.

NPR interviewed a Yonkers resident named Maddie who said, “The last police commissioner wasn’t as nice as this. He wasn’t someone who really cared about the community. A lot of people got beat in our community – a lot of people. That’s not happening under Mueller.”

Former Yonkers NAACP President KAREN EDMONSON said, “I had problems with him (Mueller) in the beginning ’cause I thought, well, you’re a part of this whole thing. That past – you – how do I separate you now from the club that I knew existed, and, you know, how?”

When asked what would happen if Mueller left, Edmonson said, “No, it won’t. It won’t be fine when John Mueller leaves. It could go back. Yonkers – there’s a tendency, right? No one’s watching the store. You really need to monitor to make sure it’s being maintained.”

NPR did speak to Danny Sullivan, who has been arrested many times by the YPD and has alleged abuse and mistreatment by the YPD over a period of 20 years.

SULLIVAN: I have. Have you ever been taken into a hallway and told to pull down your pants and have a cop shine his flashlight on your rectum looking for drugs? I have.

MCEVERS: After this list of questions and answers, Danny Sullivan told the story of how he says he was mistreated by Yonkers cops several times starting back in the early 2000s.

SULLIVAN: I was wrongfully arrested. I was assaulted. I made a complaint. And by doing so, that led to me being wrongfully convicted.

MCEVERS: And then Danny said this thing that really struck us. Basically, it’s all fine and good to talk about police reform going forward. But what if you haven’t fully dealt with the wrongdoing of the past?

SULLIVAN: Before you try to fix what is wrong today, you have to travel back in time and fix what happened then. Thank you very much for your time. God bless you. Love is love. Thank you.

The episode ends with NPR researching some of the cases of abuse and mistreatment by YPD officers more than a decade ago. The inference was that Mueller was hiding this information. “And I found it interesting that we uncovered this ourselves by connecting the dots. And I was like, in all our conversations about what you’re doing to change the department, why didn’t this come up?”

Opinions are mixed in the YPD as to whether NPR should have been welcomed in by Mueller as they were. And the podcast was completed before Mueller left Yonkers, for the MTA.

The podcast represents a partnership between NPR and The Marshall Project, which covers criminal justice across the United States.

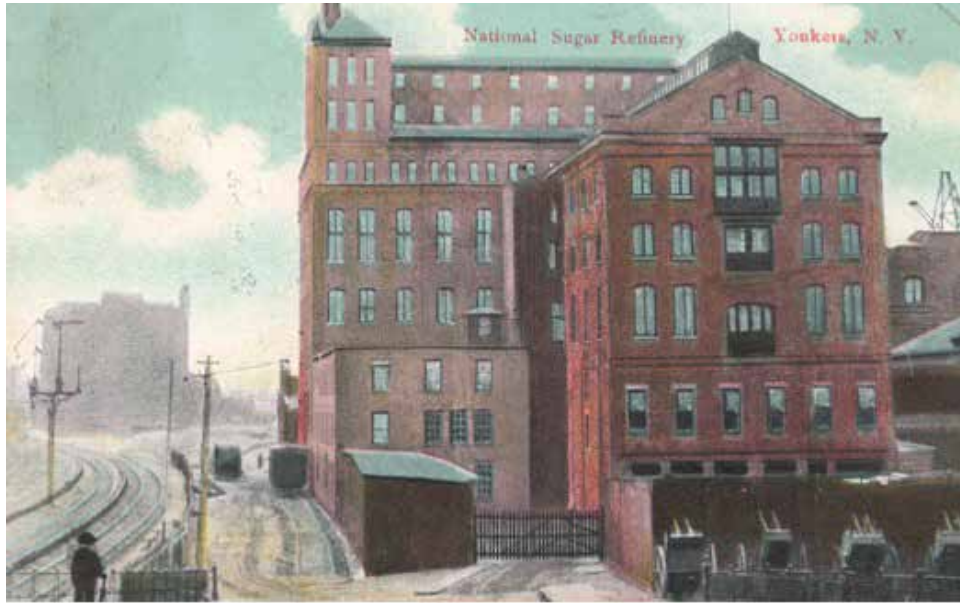

On This Day in Yonkers History...

Mary Hoar, President Emerita Yonkers Historical Society and President Untermyer Performing Arts Council

Monday, July 25th
July 25, 1903: In less than 24 hours, more than 50,000 bags of raw sugar arrived at the National Sugar Refinery wharf. Two ships from Cuba brought the cargo; The freighter Straits of Dover brought 20,000 bags and the freighter Dania arrived with 32,000 bags.

July 25, 1912: A fire at the Dunwoodie County Club caused more than \$2,000 damage.

July 25, 1930: John Law of Yonkers, Coach of the Manhattan College Football team, announced Manhattan College and Atlanta's Oglethorpe University would play the metropolitan district's first night college football game at the Polo Grounds. Powerful lights were used to illuminate the field to daytime brilliance. A former Notre Dame football captain, he later became the head football and baseball coach at Sing Sing Prison.

Tuesday, July 26th
July 26, 1907: The Common Council came to a dead halt because of "Fisticuffs at Manor Hall," then our City Hall. While the Aldermen were meeting, a loud argument took place in the hallway, then cursing... and then blows! Contractor James Kearns and Wakefield Park Realty Company President John O'Connor were going at it! By the time the aldermen rushed out, they saw people try to separate the men; O'Connor had a badly swollen eye, walked into the chamber while the men were holding back Kearns, who was yelling "Let me at him." The officials condemned the actions of the contractor; O'Connor said he was talking to an Alderman, when Kearns "buted in" to the conversation, then hit him in the eye and knocked him to the ground. O'Connor claimed it was because he refused to join a local contractor's trust; Kearns yelled, "You're a liar!" also stating O'Connor called him a loafer. O'Connor said he would swear out a warrant against Kearns; Alderman Cashin advised the courts were open, and he should do it immediately. Meeting attendees said they never had seen such a disgraceful affair.

Wednesday, July 27th
July 27, 1930: Workers began filling the newly cleaned section of the Fortfield Reservoir on Palmer Avenue; the had removed a huge amount of debris and hundreds of fish. As soon as that was completed, they began cleaning the other half.

July 27, 1947: Deputy Public Safety Commissioner William Comey launched a gambling investigation on moonlight cruises from the Yonkers pier on an excursion steamer!

July 27, 1950: Yonkers people pooled together and contributed the largest municipal donation to the Lou Gehrig Memorial Fund at the ceremony held Mel Allen Day at Yonkers Stadium. Our generous citizens donated \$1000 to the cause!

Thursday, July 28th
July 28, 1852: The Henry Clay steamboat caught on fire; although there were close to 500 passengers on board, only two lifeboats had been provided and dozens of the passengers perished.

Neptune, a Newfoundland dog, lived in South Yonkers. After seeing the disaster, he swam into the Hudson River and grabbed a drowning young girl by her dress, carrying her to safety on the Yonkers shore.

July 28, 1936: Yonkers College opened its summer session at Saunders Trade School with 40 students. Yonkers College had courses in languages, mathematics, economics, public speaking, philosophy, and psychology. One class studied modern advances in biology, visiting scientific institutions throughout Yonkers. Dr. Crocker, Director of the Boyce Thompson Institute for Plant Research, offered its facilities. Another course was the historical background of modern society, comparing democracies and dictatorships of today and the past. Courses were no credit, but successful students received certificates.

Approximate 150 high school student enrolled for entrance in the Fall, when the College of the City of New York took up sponsorship of the center and accredited courses.

Friday, July 29th
July 29, 1905: The Yonkers League of the Colored Cooperators of America formally opened five new building on its property at Riverdale Avenue and Culver

LEGAL NOTICE- GENERAL ORDINANCE NO.8-2022

A GENERAL ORDINANCE AMENDING CHAPTER 109 OF THE CITY CODE OF THE CITY OF YONKERS ENTITLED "VEHICLES AND TRAFFIC" TO INCLUDE NEW LIMITATIONS ON THE PARKING OF COMMERCIAL VEHICLES AND AMEND FINES

The City of Yonkers, in City Council convened, hereby ordains and enacts: Section 1. Part X of the Code of the City of Yonkers, entitled "Vehicles and Traffic" is amended by amending Section 109-79, entitled "Commercial vehicles, buses, school buses, trailer, semitrailer, house-on wheels," to read as follows:

§109-79. Commercial vehicles, buses, school buses, tractor, trailer, tractor-trailer semi-trailer, house-on wheels.

A. No person shall park a commercial vehicle, trailer, tractor, tractor-trailer, semitrailer, house-on-wheels, bus or school bus, on any street other than for the expeditious unloading and delivery or pickup and loading of materials or people, or while providing a commercial service.

B. In addition to any applicable sanctions, fees, or remedies provided by law or regulation, any vehicle parked in violation of subdivision (A) of this section may be subject to impoundment by the City of Yonkers. Any vehicle impounded pursuant to this provisional shall not be released until all applicable towing and storage fees have been paid.

Section 2. Part X of the Code of the City of Yonkers, entitled "Vehicles and Traffic" is amended by amending Section 109-160 entitled "Penalties for offenses; towing and storage fees" to read as follows:

§ 109-160. Penalties for offenses; towing and storage fees.

A. Except for violations of this chapter which are within the jurisdiction of the Parking Violations Bureau, and in the event that a penalty is not established for a given violation of this chapter, then such violation shall be punished by a fine not exceeding \$250 or confinement in jail not exceeding 10 days, or both.

C. In the event that a respondent does not enter a plea or remit the fine due for a parking, standing or stopping violation as and when required by this chapter, then he or she they shall pay a late payment penalty equal and in addition to the scheduled fine for the violation charged.

D. In the event that a vehicle is towed pursuant to this chapter, the owner or person entitled to possession of the vehicle shall pay a towing charge and a storage charge as set by the rules and regulations of the Parking Violations Bureau. These charges shall be in addition to any fines or penalties for illegal stopping, standing, parking, abandonment or any other offense under this chapter. Towing and storage charges shall be paid to the Parking Violations Bureau. No vehicle shall be released unless all towing and storage fees, outstanding parking violations and related penalties are paid in full.

Section 3. This General Ordinance shall take effect upon compliance with §C4-6 of the Charter of the City of Yonkers and the provisions of the Municipal Home Rule Law of the State of New York

“I don’t want to see the cops fired, I don’t want to see the cops lose their job, lose their lifeline. I want to see them be able to delegate where they at, I don’t actually blame them so much. I gotta blame the system.”

Street. Welcome speeches were made by Mayor John Andrus, The Rev. Henry Booker, Rev. F. J. Moultrie, and Rev. J. J. Smyer.

July 29, 1936: Alderman Bill Slater, known nationally for his crusade against women’s shorts, was running a boat ride for local Democrats. He became quite upset when the orchestra leader announced, “shorts were being shown on the upper deck.” Slater rushed upstairs, only to find movie shorts being shown.

Saturday, July 30th

July 30, 1931: Health Commissioner Clarence Buckmaster renewed his warning against swimming in the Hudson River, stating it was “virtually an open sewer off Yonkers.

July 30, 1943: Detective Sergeant Patrick Christopher took a lot of kidding because of current events. Christopher took over the Detective Division when his boss Captain Herman Schall went on vacation. Just fifteen minutes after Christopher officially was in charge, Benito Mussolini resigned! The men ribbed him “on getting such speedy results” minutes after taking the reins. Not one to miss a beat, the good Sergeant informed those kidding him that he had just “sent a squad of detectives out to get Hitler!” His terms? Unconditional Surrender!

Sunday, July 31st

July 31, 1942: Suspicions aroused by a foreign man with an accent attempting to sign up for a library card, a woman patron of the Yonkers Public Library touched off an extensive FBI investigation here for the man, suspected of being one of the three German saboteurs the government was searching for.

July 31, 1962: Well known recording artist and musician Victor Arden, known non-professionally as Lewis Fuiks, passed away. He had been a long-term resident of Franklin Avenue before moving to New York a few years earlier. Arden, discovered by George Gershwin, was well known to millions of Americans who danced and sang to his records, radio programs, and musical motion pictures during the 1930s and 1940s. Among his many Broadway musicals were “Lady Be Good,” “Tip-Toes,” “Funny Face,” and “Spring Is Here.” He recorded for the Victor, Brunswick, Vocalion and Okey labels and also played at the Palace,

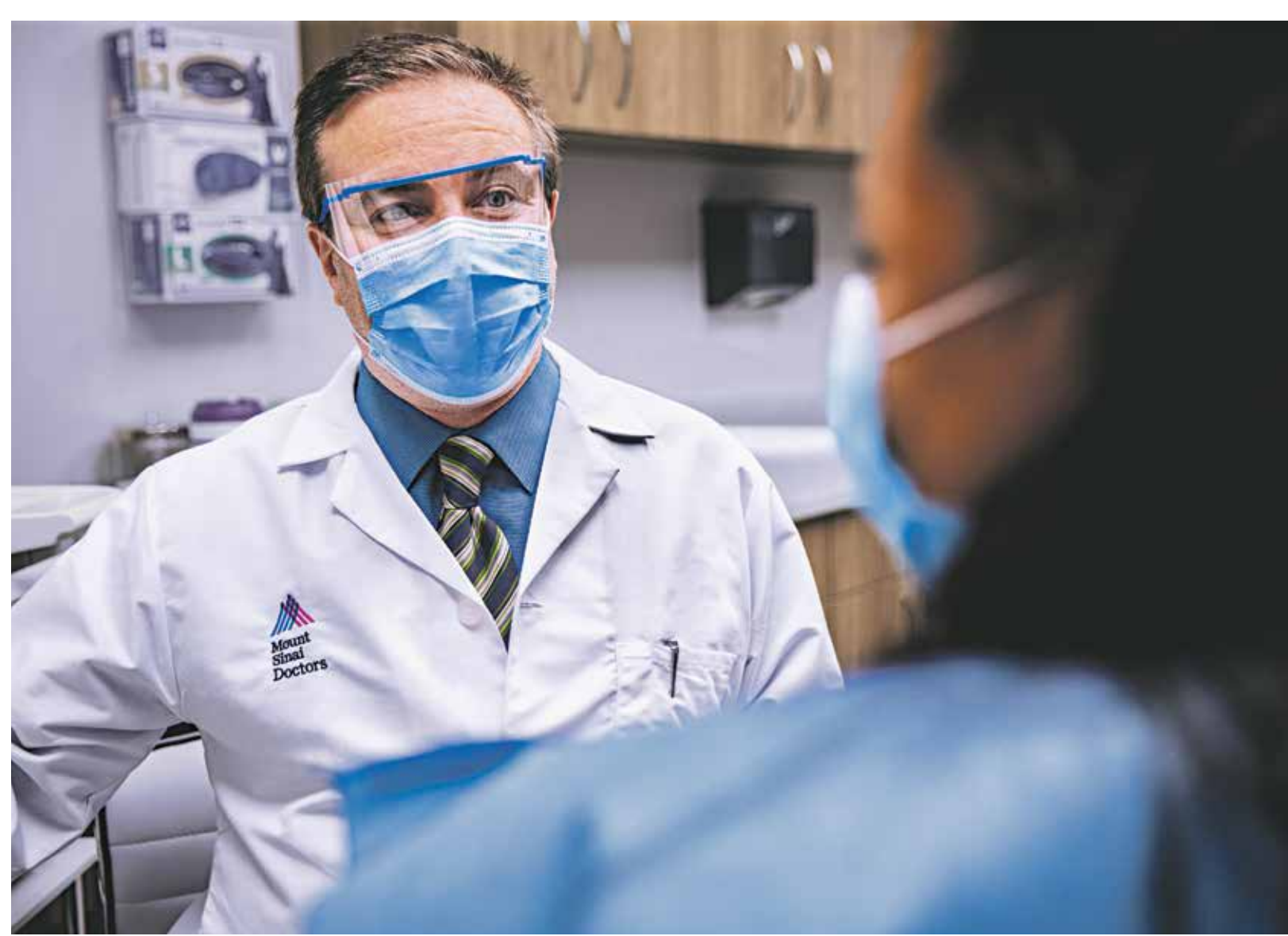

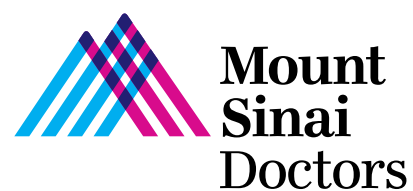
