Yonkers Fire Department Enhances Safety with State of the Art Thermal Imaging Cameras



On July 19, Mayor Mike Spano announced the successful completion of a strategic plan to equip all Yonkers Firefighters with state-of-the-art handheld thermal imaging cameras (TICs). The Yonkers Fire Department is the first municipality in Westchester County to fully equip all members with this technology that can be utilized in any aspect of firefighting or rescue operations.

“This is a significant step toward enhancing safety for both our Firefighters and community,” said Mayor Spano. “These cameras allow our Firefighters another set of eyes in dangerous conditions where visibility can be impaired and will no doubt save lives.”

“This initiative represents a substantial investment in Yonkers’ safety and underscores the Mayor’s pledge to keep the City safe through careful planning and support,” said City of Yonkers Fire Department Commissioner William Fitzpatrick. “Thank you to Mayor Spano for consistently demonstrating the importance of the safety and well-being of our Firefighters.”

These advanced devices are essential tools for firefighters and offer numerous benefits including the ability to see through darkness and smoke, provide critical incident information, and enhance rapid response and safety.

All Officers, Truck Firefighters, and Engine Company Firefighters are utilizing various models of the TICs.

Rescue 1, Squad 11, and All Officers: These units use FLIR models, which are decision-making cameras used for search, rescue, temperature range, and tactical purposes.

Truck Firefighters: ARGUS cameras support tactical operations and search missions.

Engine Company Firefighters: SEEK cameras have recently been issued to all engine company members. These compact and lightweight cameras help quickly locate fires and serve as personal escape tools if necessary.

The legend from McLean Needs a Kidney Transplant

A man who gave so much to the Yonkers community he and his family called home for generations is now asking for our help. RJ Puma, who was a fixture in the McLean Avenue community for decades- as the owner operator of his family’s bakery, Anna Artuso Pastry Shop on McLean, as President of the McLean Avenue Merchants Association, and Co-Chair of the Yonkers Saint Patrick’s Day Parade, needs a kidney transplant and is searching for matching donors. He also has a GoFundMe Page, (gofund.me/edb06f93) to raise much-needed funds to offset medical costs and an extended leave from work.

RJ headed to Florida a few years ago, to take a position with Disney. His Yonkers family pastry shop is now closed, but for the thousands of customers and community members both he and his family touched over many decades this is a chance to reciprocate kindness and generosity and say -”God Bless”.

On May 8, Puma posted on Facebook, “Dear friends and family, I’ve been dreading making this post for some time now. Main reason is, I don’t like asking for help, unless I really need it. Well, I need it.”

“For those friends on here who don’t know, I’ve been living with Chronic Kidney Disease for some time now. I was born with only one kidney, and the one that I have has declined rapidly over the past few years. Even though I’m at stage 5 CKD. Thankfully I haven’t needed dialysis just yet, but it’s coming, sooner rather than later.”

“The ultimate goal here is to survive and continue living, and the only way that happens is with a kidney transplant. I’m now on donor lists in a few hospitals here in Florida.”

“However, it could take up to 2-6 years to receive one and with me being at stage 5 with only 12% of my one kidney functioning, the odds aren’t great.”

“Which brings me to my ask, the big favor. If you are at all interested in seeing if you are a good match as a living donor to help expedite this process and get me on the road to healing faster and living longer, here is the link.” (<https://ufhealth.org/conditions-and-treatments/living-kidney-donation?>)

“What does being a donor entail? Tons of paperwork, cancer screenings, other tests and visits with your PHP and then of course, major surgery. From what I’ve looked at, my health insurance would cover the donor.”

“Please note, UPDATE: any blood type is fine (they will be able to match multiple donors and patients), you need to be in good health, a non-smoker, heart healthy and even age is taken into consideration. They are able to match multiple patients at a time if you’re not a perfect match for me. Meaning your kidney would go to another patient, whose donor is a perfect match for me. Hope that makes sense.”

“I am keeping very optimistic and continuing doing the things I love. While I do have my moments of weakness, they don’t last too long. For those of you who truly know me, I welcome new adventures and change. I got this, just need a little help.”


“If it wasn’t as bad as it is, I would not be putting this out on social media. I appreciate those of you who took the time to read this all the way through and those of you who are interested in testing to be a donor. There is no pressure here at all, just covering all my bases. Thank you all. Also, if you could please share this post. You never know where a miracle will come from. If interested, please follow the link, it answers most questions.”


RJ updated all of us with a post last week. “Just got the letter: I’ve been approved for a kidney transplant!”

“Your support and kind messages have been amazing and overwhelming. To Today, a coworker I’ve known for years, made me tear up over the beautiful words she spoke about me. I know how blessed I am to have all of you supporting and praying for me.

“If you can, anything at all, help with bills and life expenses, which are coming up faster than expected, the GoFundMe is below. I appreciate everything you’ve done, and your prayers mean a lot to me.”



On This Day in Yonkers History...

Monday July 29th

July 29, 1905: The Yonkers League of the Colored Cooperators of America formally opened five new buildings on its property at Riverdale Avenue and Culver Street. Welcoming speeches were made by Mayor John Andrus, The Rev. Henry Booker, Rev. F. J. Moultrie, and Rev. J. J. Smyer. Reverend Moultrie was the driving force behind the League.

July 29, 1934: Mary Urban announced the Urban Studios on South Waverly Street would be transformed into a sports mecca memorializing her late husband, architect, illustrator and scenic designer Joseph Urban. Before Urban bought the studio, it was home to three Yonkers movie companies: All Star Feature Corporation, Standard Filmprint Corporation, and Terris Feature Film Company.

Tuesday July 30th

July 30, 1943: Employees at the Cameo Curtain plant at 45 John Street, with 90% of its work being war production, posted large signs in their workrooms. What did the signs read? "We will be closed the day of Hitler's funeral."

July 30, 1943: Accordionist and sailor Frank Alfid had a happy reunion with movie star Carole Landis, right here in Yonkers at the Shangri-La Rally in Getty Square! He had played during the entertainment tour of North Africa Landis did in 1942.

Hundreds of fans crowded the star; she signed autograph books, pictures, and scraps of papers, just about anything bond and stamp buyers wanted signed. A Marine standing at a distance was invited to the platform. When asked if he wanted an autograph, he said yes... but on his shirt! He got it!

The War Bond and Stamp Committee presented Landis with a beautiful rose corsage, but it did not last long. A young fan shyly asked if she could have a flower from the corsage. Then another... and another, until none were left.

Wednesday, July 31st

July 31, 1934: Welfare Commissioner Nicholas Ebbitt announced maps of local cemeteries showing graves of veterans of all wars would be made by a special crew of work relief men.

July 31, 1962: Well-known recording artist and musician Victor Arden, born

Join the Fight Against Hunger: Hillside Food Outreach Seeks Volunteers for Food Delivery

Hillside Food Outreach, a nonprofit dedicated to delivering high-quality, nutritious food to low-income and limited mobility families, seniors, and the chronically ill in Westchester, Putnam, and Fairfield Counties, is calling on the community to join its mission. The organization, which provides food deliveries free of charge to over 2,000 individuals twice per month, is in urgent need of volunteers to help meet the rising demand.

Hillside Food Outreach relies on a dedicated network of more than 350 volunteers to deliver nutrient-dense groceries to those in need. The organization is seeking additional delivery volunteers to ensure that no household on its waitlist of over 100 families goes hungry. Volunteers typically deliver to up to six households, fostering trust and long-term relationships with the clients they serve.

“Hillside volunteers are a lifeline for many in our community,” said Kathy Purdy, CEO and Founder of Hillside Food Outreach. “They play a critical role in providing not only food, but also companionship and hope to those who are often isolated and struggling.” Clients include elderly residents who lack transportation and who are unable to carry heavy grocery bags, veterans, people who are housebound due to disability, and patients suffering from chronic illnesses who require healthy diets.

A recent study by the New York State Department of Health indicates that food insecurity is on the rise, with nearly one in four adults (24.9%) facing the threat of hunger. This alarming trend is part of a national issue, with more than 17 million American households experiencing food insecurity in 2022, the largest increase since the 2008 economic crisis. Hillside Food Outreach is witnessing this surge firsthand and is struggling to meet the increased demand for its services.

“Food insecurity rarely exists alone,” noted Purdy. “It can cause significant emotional and psychological distress, contributing to a deeper sense of isolation. Our mission is to combat these issues by providing nutritious food and human connection.”

Community members have several options to support Hillside Food Outreach: Become a Delivery Volunteer: Help deliver food directly to those in need.

Volunteer at the Warehouse: Assist in stocking shelves and preparing deliveries.

Make a Donation: Financial contributions are crucial for sustaining Hillside’s operations. Consider a one-time donation or join the Hunger Heroes program with a monthly contribution.

Advocate for Change: Raise awareness about food insecurity with elected officials and push for policies that improve access to healthy food.

“Working to reduce food insecurity is a challenging task, but it’s incredibly uplifting when clients share how our food deliveries have positively impacted their health and overall quality of life,” Purdy said. “Even a few hours a month can make a significant difference. In our latest survey, 98 percent of Hillside clients reported feeling more food-secure, and 97 percent of parents said their children are eating more fruits and vegetables.”

New Yonkers Cop Charged with DWI

Yonkers police officer Shannon McAuley, pictured above, was arrested in Croton on July 5 and charged with Driving While Intoxicated. McAuley, 28, was a probationary Yonkers cop and was hired in January. She then completed her training at the Westchester Police Academy.

Reports have McAuley driving in Croton at 3am on Route 9, when she was pulled over for erratic driving. Her license was suspended and as a result she was temporarily placed on suspension by the YPD.

McAuley refused to take a breathalyzer test, which is the same as admitting guilt.

Her suspension is now completed, and she is placed on modified duty, pending a review and a criminal outcome of her DWI case.

McAuley comes from a police family, with her father serving in the YPD as a Lieutenant. He is now retired.

The people of Yonkers, and in law enforcement, are disappointing in McAuley’s arrest. Police officers should be role models for the community they seek to serve. “There are too many options today to driving drunk. Take an Uber,” said one former Westchester police officer.

The 100th Birthday of the Honorable Mr James Baldwin

August 2, 2024 would have been the 100th Birthday of James Baldwin. He was born in Harlem near 125th not to far from where I was raised in Wagner houses 37 years later. He is buried at Ferncliff Cemetery in Hartsdale near his friend Malcolm X who he debated about Americas history of racism in 1963.

He was one of the greatest writers and novelists that I have ever had the privilege of reading. "The Fire Next Time" and "Notes of a Native Sun" Baldwin was able to speak to the pathological violence and racism of white America."He was a gay black man that was a trail blazer in the LGBTQ plus community. Long before stonewall there was James Baldwin. His book "Giovanni's Room" touched on and talked about what gay men dealt with socially and internally as far as their rejection in a dominant heterosexual society. He grew up with a father who was very strict from a religious standpoint.

He had 5 other brothers and sisters who were younger than him. Being the oldest with an inchoate sense of duty growing up in American Apartheid in the 1920s and 30's made him grow up faster than most. He went through unspeakable treatment as a black man in America including being physically assaulted by white police officers when he was 10 years old in Harlem. He was there in 1943 when the infamous "Harlem riot" occurred precipitated by police violence in the community.

In 1948 he went to France and met his future partner and lover Lucien Harpersberger who was by his side when Baldwin died in France in 1987. Baldwin said "when I went to France in 1948 nothing worse could happen me to me there that had not already happened to me living in the United States". Baldwin said "American History is the history of the Negro and it is not a pretty one". He was friends with Malcolm X and said regarding Malcolm X's Firebrand condemnation of how evil white America was "What black people find in Malcolm X is a truth that has been so long denied in this racist society, he corroborates their reality!". He appeared at the March on Washington along with Harry Belafonte, Sidney Poitier, Marlon Brando and Charleton Heston. When Heston was on the right side of history before his perversion of his legacy later with the NRA. There

Was a round table discussion including all of these gentlemen after the March on Washington that was headed and hosted by Joseph Mankiewicz that I suggest everyone see, it is quite historically informative. Brando's friendship with Baldwin at that time led to Brando's support of the Black Panthers financially supporting them for years as well as Brando speaking and eulogizing at the funeral of 17 year old black panther member Bobby Hutton who was slaughtered by Oakland Police in 1968. Baldwin marched with Dr. King and the March against American apartheid in Selma in 1965 and faced the brutality and savage behavior of the Alabama state police.

He also faced homophobia from some black nationalists leaders who were just as ignorant as their white counterparts. James Baldwin, Bayard Rustin and Lorraine Hansberry were all part of the LGBTQ Community and were all human rights heroes. Notwithstanding Rustin's support of Israel which certainly tarnished his legacy. Baldwin debated William F. Buckley at the Oxford Union in England on the question of "Has the American Dream been at the expense of the American Negro on February 18th 1965 three days before Malcolm X's assassination. Baldwin said "Black people built this country working and bringing the goods to market for nothing, for nothing for 400 years". James Baldwin was my HERO and was the best of humanity and he rejected the pathologically depraved sickness of white America and like Malcolm X, Dr. King and Medgar Evers said "I AM NOT YOUR NEGRO!".

Yonkers resident Pa Quinn, diagnosed with ALS in 2013 at age 29, co-founded the global phenomenon event in 2014, which generated hundreds of millions of dollars in private donations for ALS research & medical advances to extend the lives of ALS patients. Quinn died in 2020 at the age of 37

Yonkers Mayor Mike Spano, Empire City Casino by MGM Resorts, and the family of ALS Ice Bucket Challenge co-founder and late Yonkers Native Pat Quinn announced the date of the 2024 ALS Ice Bucket Challenge set for Saturday, August 3 (see video announcement here). The annual event will once again take place trackside at the historic Yonkers Raceway located at Empire City Casino by MGM Resorts in Westchester, New York.

Festivities will begin at 1:00 p.m. with the ice bucket dump scheduled for 2:00 p.m. Participants should pre-register online at YonkersNY.gov/IBC. The event, co-founded by Quinn after his diagnosis of Amyotrophic Lateral Sclerosis (ALS) in 2013 at the age of 29, became a global phenomenon as more than 17 million people around the world participated in the challenge via social media by dumping buckets of ice water on their heads. The event continues to remain a catalyst for raising funds to support research to identify a cure for the debilitating disease and raise awareness of the need for more research funding. It is reported that an ALS patient dies in the U.S. every ninety minutes.

ALS, often referred to as “Lou Gehrig’s Disease”, is a progressive neurodegenerative disease that affects nerve cells in the brain and spinal cord. Quinn lost his battle with ALS in November 2020, yet his drive and determination live on through his family, friends, community, and beyond to raise awareness and find a cure for the approximately hundreds of thousands of Americans suffering from ALS. While the prognosis for ALS patients 80 years after Lou Gehrig was diagnosed remains the same, technology now exists to keep those living with

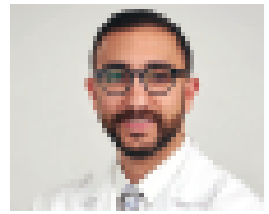

ALS alive longer. According to the Center for Disease Control and Prevention, approximately 5,000 individuals are newly diagnosed with ALS across the U.S. annually.

Leading the ALS Ice Bucket Challenge for another year is Quinn's father, Patrick Quinn, Sr., who continues to pay tribute to his son and ensure his mission continues. Hosting a variety of fundraising events throughout the year, Quinn's nonprofit organization, Quinn for the Win Find Your Smile Foundation ("Quinn for the Win"), continues to have significant impact at both local and national levels.

Locally, Quinn for the Win provides cash grants to local ALS patients and their families to offset expenses not covered by medical insurance, including wheelchair adjustments needed as patients' physical limitations change as the disease progresses and home renovations to accommodate wheelchairs, as well as providing financial support for organizations that serve families of ALS patients. Quinn For The Win also supports sleep studies at St. John's Riverside Hospital to help find solutions for sleep difficulties faced by ALS patients.

In the ten years since it was founded, ALS Ice Bucket Challenges have also significantly increased the awareness of this deadly disease globally. As one example, ten years ago only 80 multidisciplinary clinics for ALS were open around the country. Now, more than 240 are open nationally where ALS patients can see a pathologist and all the medical disciplines they need all in one place. Technology is also much more advanced with Pat Quinn Jr. using an expanded CPAP machine, one of the first prototypes, to help expand his lungs and make it easier to breathe. Social media also allows patients to connect from all around the world, including Pat Quinn Jr. while he was alive, engaging with patients across the globe.

And according to the ALS Association, more than \$2 million has been invested into the development of a new drug, Relyvrio, that was recently approved by the U.S. Food and Drug Administration to help slow down the effects of ALS. In the last six years, three ALS drugs have been approved by the FDA with several others in clinical trials. Also, approximately 130 research projects are being funded in twelve countries around the world thanks to Quinn's efforts.

"I'm so grateful for the continued support of Mayor Mike Spano, Empire City Casino by MGM Resorts, and community members from Yonkers and far beyond who continue to fight onwards toward a cure through keeping the ice bucket challenge going each and every year," said Patrick Quinn, Sr. "ALS ruins families... I've seen it. The Yonkers community has been the champion of our family and ALS patients nationwide, especially in the last few years without Pat. My son built such a strong system of support and his Quinn for the Win - Find Your Smile Foundation is nothing short of remarkable. Pat laid the groundwork to find a cure, and now it's our job to finish his mission to defeat ALS once and for all. I look forward to seeing everyone on August 3."

Where's My Package? Ossining Man Arrested for

Threatening to Kill USPS Workers and Blow Up Facility



SDNY US Attorney Damian Williams, announced on July 19 that

Anthony Alfano, left, was arrested after he made a series of graphic and violent threats to kill U.S. Postal Service ("USPS") employees and burn down U.S. post offices in Ossining, New York. ALFANO was arrested in Yorktown Heights, New York, this morning and is expected to appear this afternoon in White Plains federal court before U.S. Magistrate Judge Victoria Reznik.

U.S. ATTORNEY DAMIAN WILLIAMS SAID: "THE CHARGES AGAINST THE DEFENDANT UN-

DERSCORE THIS OFFICE'S UNWAVERING COMMITMENT TO SWIFTLY COLLABORATE WITH OUR LAW ENFORCEMENT PARTNERS TO NEUTRALIZE THREATS AGAINST THE U.S. MAIL SYSTEM. ANY INDIVIDUAL WHO DARES TO CROSS THE LINE AND THREATEN OUR POSTAL EMPLOYEES AND FACILITIES WITH VIOLENCE AND DESTRUCTION WILL BE STOPPED IN THEIR TRACKS, AND WE WILL ENSURE THEY ARE HELD ACCOUNTABLE FOR THEIR ACTIONS."

USPIS Inspector in Charge Daniel B. Brubaker said: "The U.S. Postal Inspection Service does not take lightly any threats of violence against USPS employees. This behavior will never be tolerated, and we will work with our local and federal law enforcement partners to maintain a safe working environment for the postal employees we protect. That is our mission, and that is our unwavering commitment to the people we serve."

As alleged in the Complaint:[1]

On Saturday, June 22, 2024, ANTHONY ALFANO was awaiting the delivery of a parcel that had been mailed out via USPS from Florida the evening before. According to ALFANO, the parcel contained cremated remains. In a series of phone calls with USPS call center representatives before the package was scheduled to arrive, ALFANO threatened to kill USPS employees and burn down U.S. post offices because he apparently believed the parcel was not going to arrive when he wanted it to. ALFANO's threats included the following:

ALFANO threatened, "I am gonna start killing you guys one by one." He also said, "people are going to die," and that there would be "a lot of dead bodies," "hurt people," and people who would "not be returning home." ALFANO also swore to kill his local mail carrier, stating that he would "walk up to him" and "blow his brains out." Referencing a notorious "massacre," ALFANO warned that it would not "have shit on what I'm about to do" and that his actions would go down "in history."

ALFANO also made threats to kill members of the postal police by using incendiary ammunition, as well as threats to burn down U.S. post offices. For example, he welcomed the arrival of the postal police and said, "as soon as they show up at my door they're gonna catch a hot one," referring to shooting them with a "napalm round" from his 12-gauge shotgun. "I'm going to kill every one of those motherfuckers," he said. He further threatened, "I'm gonna burn all the post offices down to the ground" and said he would go to his local post office and "burn it down to the fucking ground."

Underscoring his commitment to carry out his threats, ALFANO said several times, "I don't make threats, I make promises." He also expressly swore to carry out his threats and said, "I really don't care if I go to jail or not."

On Monday, June 24, 2024, ALFANO received his parcel on the next business day after it had been mailed out on the Friday before.

ALFANO has a history of encounters with law enforcement because of prior threats he has made against others, including local police officers, delivery persons, and customer service representatives.

ANTHONY ALFANO, 46, of Ossining, New York, is charged with threatening interstate communications, which carries a maximum sentence of five years in prison, and willfully making a threat involving fire, which carries a maximum sentence of 10 years in prison.

The maximum potential sentences in this case are prescribed by Congress and are provided here for informational purposes only, as any sentencing of the defendant will be determined by a judge.

Mr. Williams praised the outstanding work of the USPIS in investigating the threats charged in the Complaint and undertaking security measures to protect USPS employees and facilities. Mr. Williams also thanked the Village of Ossining Police Department and City of Peekskill Police Department for their assistance in this case.

This case is being handled by the Office's White Plains Division. Assistant U.S. Attorney Reyhan Watson is in charge of the prosecution.

The charges contained in the Complaint are merely accusations, and the defendant is presumed innocent unless and until proven guilty.

The United States has four Breakers at the Olympics competing for the Gold Medal. They are:

- I- Victor Montavlo (B-Boy Victor) “His parents came from Mexico, and he is living the American dream. Now he is going to represent us in the Olympics and could bring home the gold,” said Reyes.
- II- Sunny Choi (B-Girl Sunny). “She is a phenomenal dancer and a former gymnast. She is going to go out there and kill it,” said Reyes.
- III- Jeff Lewis aka Bboy Jeffro. “He is-another incredible dancer that’s going out there and setting the world on fire,” said Reyes.
- IV- Logan Edra (B-Girl Logistx) “She is young and fun and energetic –she is going to surprise a lot of people,” said Reyes.

The breaking competition in Paris will be divided into two events — one for women and one for men, with the woman performing on Aug. 9 and the men on Aug. 10, at La Concorde Urban Park. 16 B-boys or 16 B-girls will “go face to face in spectacular solo battles.”

Nine Judges will then vote, based on six categories: Creativity, personality, technique, variety, performativity and musicality—with creativity and performativity counting for 60 percent of the score. Three men and three women will be awarded medals.

Reyes explained that the judging, “will be a little subjective, it’s not like basketball and who scores the most points.”

Breaking coincided with Rap music as it broke on the New York City music and dance scene in the late 1970’s and early 1980’s. “In the early years, breakers would break at parties, in clubs and on the street, practicing at home and in the hallways of buildings or in community centers. By the early 1980’s, breaking had begun to catch the attention of the mainstream media in the United States and the dance became increasingly popular, spreading out quickly across the United States and overseas. Breaking crews like the Rock Steady Crew, Dynamic Rockers, and New York City Breakers helped spearhead breaking initiatives and activations in the 80’s mainstream media boom.

The 1983 hit movie Flashdance introduced breaking to the mainstream public, featuring some short breaking scenes. Two breaking featured movies, Breaking and Beat Street, followed. Beat Street featured one of the most famous breaking scenes ever shown on film, the battle between Rock Steady Crew and the New York City Breakers. It was filmed at the Roxy, which was a popular lower West Side nightclub in Manhattan and the stomping ground for the breaking scene, where crews from each of the New York area would come to break and battle one another.

“Keep in mind we were kids that were trying to find our way through the South Bronx during a time of violence and drugs. The path that we chose was to get away from that through breaking,” said Reyes.

In 1983, the NYC Breakers performed at the Kennedy Center before President Ronald Reagan.

Today, he is training the next generation of Breaking Olympic hopefuls in Yonkers. Reyes has used the resurgence of Breaking to educate younger rappers and dancers to what is now an Olympic sport. He also wants to promote and highlight up and coming breakers, known as b-boys and b-girls, who are taking Breaking to new heights.

Last month, Reyes and the City and Yonkers Public Schools hosted a battle of the boroughs breaking event, and this month he held a webinar to educate teachers about Breaking.

Last week, Reyes partnered with YonkersArts to form a Breakdancing League, which focuses on the education, practice, and competitive sport of the art of ‘Breaking’, marking a significant milestone in the cultural and artistic landscape of Yonkers. The league will span four months of intensive instruction and exhilarating competition.

Reyes, who is co-founder of the AAA All Stars, a non-profit that helps young people focus on academics, athletics and the arts, is excited for the next chapter of breaking. “This is history, this is something special, and the NYC Breakers are happy to be a part of history.”

Editor’s Note: We also learned from this interview that the term “Break-dancing” is not the preferred word to use. Reyes explained that Breakdancing was invented in the media in the 1980’s as an easy way to categorize Breaking. Breaking is the proper term to use for what is now an Olympic sport.

Lewis Fuiks, passed away. A long-term resident of Franklin Avenue, Arden was discovered by George Gershwin. He was well known to millions of Americans who danced and sang to his records, radio programs, and musical motion pictures during the 1930s and 1940s. Among his many Broadway musicals were “Lady Be Good,” “Tip-Toes,” “Funny Face,” and “Spring Is Here.” He recorded for the Victor, Brunswick, Vocalion and Okey labels.

Thursday, August 1st

August 1, 1924: North Yonkers resident Alan Helffrich won gold! The graduate of School 16 and Yonkers High School was one of America’s greatest middle-distance runners in the 1920s. He was an alternate for the 1920 Olympics, he won AAU titles for 880 yards in 1921, 1922 and 1925. While attending Penn State, he won NCAA championships in 880 yards in 1922 and 1923 and IC4A championships in 880 yards in 1923 and in 440 yards in 1924.

At the Paris Olympics, Helffrich ran anchor on the American 4x400 meter relay team. The team won gold, with Helffrich breaking the tape for the team, setting a world record of 3:16.

Helffrich was the only runner to defeat Paavo Nurmi when the Finn toured the United States in 1925, scoring victory in the half-mile run at Yankee Stadium, ending Nurmi’s 121-race win streak that started in 1921.

After his running career, Helffrich officiated at New York athletic meets for 25 years. He served as president of the New York Chapter of the United States Olympians until his death at age 93.

August 1, 1949: The Love Dress Company, one of the largest children’s clothing manufacturers in the world, sold its 151 Ludlow Street plant to glove, sweater and sporting goods manufacturer Louis Maiss; Love moved its operation into a large, leased garage on Warburton Avenue.

Friday, August 2nd

August 2, 1893: Fire destroyed more than 20 buildings on the east side of Warburton Avenue and Mill Street, buildings built on piles over the Nepperhan River. The fire was discovered early morning in Barbour’s Grocery, 6 Warburton Avenue, and spread quickly. The Volunteer Fire Department thought the flames were extinguished, but they spread to Acker’s Hardware at 8 Warburton Avenue. A few hours later, fire broke out behind the stores, working its way through John Copcutt’s one-story frame buildings. McManus’ Meat Market, Davis’ Glass & Picture Frame, Gale’s Hardware, Walsh’s Printing, Tompkin’s Coal, Hick’s Candy Store, MacFall’s furniture and Yet Sing’s Laundry soon went up in flames. James McCann lost seven stables on Mill Street; the Peake storehouse on Mill Street was gutted, but its solid brick walls saved the buildings behind it.

Saturday, August 3rd

August 3, 1639: Three Weckquaskeek chiefs who owned Keskeskich-- Fecquemeck, Rechgawae, and Packanniens-- sold the tract of land called “Nepperhaem,” site of present-day Yonkers, to the West India Company.

August 3, 1954: Horn and Hardart opened its first waitress-service restaurant in Westchester in the new Cross County Shopping Center! The company’s first step of its plan to expand into New York suburbs, it had table seating for 300, and room at the counter for 60 people.

Sunday, August 4th

August 4, 1886: Samuel J. Tilden died at his Graystone estate in Yonkers. Tilden purchased the estate in 1879, three years after his run for the presidency. He loved living in Yonkers, making it his main home; he only returned to his Manhattan home in the winter.

August 4, 1927: A continued rise in the level of the Nepperhan brought another overflow from the construction work on the new Plaza. The river flooded the cellars and basements of industries and stores fronting on Nepperhan Street.

Westchester's First Woman Owned Cannabis Dispensary to Open in New Rochelle Aug 3

Over the past few months, several licensed Cannabis dispensaries have opened in Westchester County. One county dispensary that is hoping to open its doors on Aug. 3 is High Life Health, LLC, owned by Jennifer Gierum.

High Life Health LLC will be one of the few female owned Cannabis dispensaries in New York State, and the only women owned in Westchester.

High Life Health will offer both medical and adult-use cannabis products to customers, including a wide array of whole flower products, vaporizers, concentrates, edibles, pre-rolled, beverages, topical, accessories and specialized items for pets.

Their location, at 19 Huguenot Street, New Rochelle, NY 10801, will include curbside services, enabling customers to have a more convenient experience.

"It is a privilege to establish Highlife Health LLC in my hometown and also setting a precedent for our community that women can thrive and carve their own path in any industry," said Jennifer Gierum, President/CEO of Highlife Health LLC. "Embracing this challenge entails more than just introducing safe products to the marketplace; it involves leading the charge in alternative medicine, catalyzing a transformative era of wellness and empowerment."

Gierum explained that the planned opening is for Aug 3. "However that depends on final licensure with the state. They have to inspect us first. We are awaiting our CO, so we can call the state in to inspect. Then they will issue our final certificate to operate. We hope to be one of the first 150 licensed dispensaries to open in the entire state"

The dispensary will include a number of sales terminals to ensure efficient service and minimal wait times for patients, and spacious parking.

Jennifer Gierum brings an interesting life story and professional background to her new role. She combines a diverse background in acting, modeling, and entrepreneurship with a keen sense of business acumen. While raising her two young sons, she managed employment/contracts with major corporations like PepsiCo, Ethan Allen, and News Corp in financial roles. After her children embarked to college, Jennifer returned to her acting roots, achieving success with appearances in numerous television and film productions.

Now, Jennifer is leveraging her passion for holistic living and alternative medicine to pioneer a new venture. She has secured a coveted adult-use cannabis license in the state of New York, aiming to introduce these healing alternatives to her community at large.

Recently the state task force closed down 6 illegal dispensaries in New Rochelle. "This opportunity is in uncharted territory and has come with a ton of struggles in order to get to this point," said Gierum.

What is the mission of High Life Health LLC?

"To start to normalize talking about the effects that cannabis can have on every individuals well being. To educate our customers as to the actual benefits of cannabinoids, and to direct them appropriately to products that will truly make a difference. I truly have a personal mission to let others know that when used appropriately, this can be safer alternative to medicating young adults with prescription medicine that they eventually stop taking because the side effects are too harsh, leaving them untreated, or allowing them continuous use of alcohol because you do not know what to do. I feel that this is my mission because if I was afforded this opportunity when my own children were in school, I would have not been able to own this type of business. The stigma attached in high school would have been too much for my own children to take. My own mother called me a "dope dealer", when I told her that I received a license. Now, she is starting to educate herself, and allowing conversation.

Why did you decide to get into the Cannabis business?

"My friend came to me for my opinion on the Social and Economic Equality Application. In reviewing the application, I realized that I could qualify as a SEE applicant, as a solely woman owned and financed entity. The opportunity was extremely enticing, because I had just started looking into and accepting cannabis as a holistic medicine in my own son's anxiety treatment. I was able to see with my own eyes what the proper uses of cannabis can aid. I am now passionate about educating others about this holistic approach to living."

What role can cannabis, THC, and CBD have on improving a customer's health?

"THC is primarily responsible for the psychoactive effects of cannabis, which can include relaxation, euphoria, and pain relief. It may also stimulate appetite and reduce nausea.

CBD is non-psychoactive and has been associated with various potential therapeutic effects. It may have anti-inflammatory properties, help alleviate pain, reduce anxiety and depression symptoms, and even have antipsychotic effects.

CBN (cannabinol) is often cited for its potential sedative effects. Some research suggests that CBN may have mild sedative properties and could potentially help in promoting sleep. It may be particularly effective when combined with other cannabinoids like THC or CBD.

What are the impacts of illegal cannabis stores?

Products sold in illegal cannabis stores are not subject to regulatory oversight or quality control measures enforced by legal frameworks. This lack of regulation can lead to products being contaminated with pesticides, molds, or other harmful substances. Ingesting such products can pose serious health risks to consumers. Illegal dispensaries may operate in ways that compromise public safety. This can include issues such as selling cannabis to minors, operating in unsafe locations, or attracting criminal activity due to cash transactions and the presence of valuable inventory. The presence of illegal cannabis stores can impact the character and safety of neighborhoods. Concerns may arise regarding increased traffic, loitering, and a perceived decrease in property values

Are you concerned about an overflow of legal Cannabis stores? Are you worried about competition?

I am not concerned that there will be an overflow of legal stores. The Office of Cannabis Management has clear outlines as to limits based on population data. I have to trust that they will continue to act in everyone's best interest and keep current proximity protections in place.

What makes your dispensary appealing to customers?

We are woman owned and family run. Our focus is on educating our customers about the products that will help them best and help them to navigate this ever changing field of alternative medicine. Our staff is knowledgeable and our space inviting.

What would you tell someone who has never tried, cannabis, THC, or CBD?

It is important for the first time cannabis user to take it slow. Many go overboard the first time, and never want to touch it again. It is important to communicate to your bud tender exactly the effect that you are looking for. This way they can select the appropriate product and instruct you as to the way to start off taking the product.

What products are among your most popular?

We are not open yet, however I have met with tons of cultivators and brand owners. They are seeing a rise in disposable vape cartridges, edibles. They attribute the rise in edibles due to a new "fast acting" component, and disposable cartridges for the convenience.

What is popular among older customers? Or Younger Customers?

From what I have heard everyone either wants energy or sleep. It doesn't matter the age. However, I intend to educate our customers as to what they really should be using to address their specific concern.

What are the financial challenges that come with opening a cannabis business in NY?

We have had so many challenges, however financially it has not been as bad as one would think. I was able to receive a reduced rate for all licensing fees due to the fact that I am a woman entity. The toughest challenge was having to lease a space prior to submitting the initial application. The state review process at the time was flawed, and horribly slow. I had to secure the space from October of 2023, when my application was submitted. If we pass our final inspection as planned, we will open in August. That means that I have had to pay a lease on our space for a total of 10 months, without being able to open. Some who aren't licensed yet are still paying their leases, however the state has proximity protected them. The build-out has been way more expensive than planned. I have had to invest a ton of money into high-tech security systems, and safety to assure that my family, employees and I are safe. We have also endured extensive costs associated with building our website, and online ordering features.

Legislation S.9839/A.10540 Expands the Number of Family and Civil Court Judges.

Governor Kathy Hochul today signed legislation to reduce case backlog in family and civil courts by expanding the number of judges appointed and elected statewide.

“Civil and family courts adjudicate some of the most sensitive issues New Yorkers face, and for too long, backlogs and delays have inhibited their ability to function effectively,” Governor Hochul said. “This legislation gives our courts the tools to tackle the case backlog and carry out the fair and efficient justice system New Yorkers deserve.”

Legislation S.9839/A.10540 increases the number of family and civil court judges throughout New York State by 28. Two will be assigned to Nassau County, two will be assigned to Suffolk County, and one additional judge will be assigned in each of the following counties: Cayuga, Chenango, Cortland, Erie, Jefferson, Rensselaer, Rockland and Westchester counties. The legislation will also add 16 judges for New York City, including citywide positions that will be distributed across the five boroughs at the discretion of the Mayor of the City of New York. These reforms will help address well-documented backlogs and delays throughout the family court process and expedite proceedings. OCA is constantly monitoring where judges are needed throughout the state and will address individual communities’ needs to ensure a balanced and efficient distribution of judicial resources.

New York State Court of Appeals Chief Judge Rowan Wilson said, “Addressing the needs of families in distress is one of the highest priorities of the New York State Unified Court System, and we applaud Governor Hochul and the Legislature for their leadership on this issue. Creating these new judgeships across the State, together with the augmentation of resources required to serve our families, will greatly enhance our ongoing efforts to improve the lives of children and families and to ensure that individuals appearing in Family Court receive the fair, thoughtful and expeditious delivery of justice that they deserve.”

Pelham Swimmer Kate Douglass Goes for the Gold at Paris Olympics

Westchester Olympic watchers can include Pelham super swimmer Kate Douglass as someone to root for as she embarks on her quest for gold in Paris.

At the age of 15, Kate qualified for the 2016 U.S. Olympic Team Trails in the 50 free, 100 and 200 breast, and 200 IM.

In 2020, Kate competed in the Olympic Games in Tokyo, winning the bronze medal in the 200m Individual Medley – Women.

Now Douglass is ready to swim for the Gold.

Katherine Cadwallader Douglass (born November 17, 2001) is an American competitive swimmer. A versatile swimmer who competes in many events, Douglass won her first major international medal at the 2020 Olympic Games with a bronze in the 200 m individual medley. She won three medals at the 2022 World Championships. Douglass then won six medals, including two golds, at the 2023 World Championships. At the 2024 World Championships, she won five medals, including two golds.

Douglass was born on November 17, 2001, in Pelham, New York, as the daughter of Allison and William Douglass. She has a younger sister, Abby, and a younger brother, Will. She attended Pelham Memorial High School and graduated in 2019. Douglass first swam for the Westchester Aquatic Club in New York, before moving to the Chelsea Piers Aquatic Club in Connecticut in 2017.

Douglass competed for the University of Virginia during her NCAA career, which lasted from 2019 to 2023. She is considered one of the greatest swimmers in NCAA history. In her three NCAA Division I Championship meets in 2021, 2022, and 2023, she helped Virginia win the team competition. At the 2021 NCAA Championships, she won one gold medal and six silver medals. At the 2022 NCAA Championships, she won seven gold medals. At the 2023 NCAA Championships, she won seven gold medals. Douglass won the Honda Sports Award as the best college female swimmer in 2022 and 2023.

Armonk Man Indicted for Attempted Murder of North Castle Police Sergeant

Defendant allegedly attempted to stab the sergeant multiple times as police were taking him into custody; Second officer fired duty pistol twice to stop defendant

On July 16, Westchester County District Attorney Miriam E. Rocah announced today that an Armonk man was indicted for the attempted murder of a North Castle police sergeant in May.

DA Rocah said: "We are seeking to hold this defendant accountable for his alleged attempt to kill a police sergeant who was simply trying to do his job. We are grateful that the officer was not seriously injured or killed during this unprovoked attack."

The defendant, Joseph Spennato, 38, was arraigned today before New York State Supreme Court Justice Anne E. Minihan in Westchester County Court on an indictment by a Westchester County Grand Jury for Attempted Aggravated Murder and Attempted Aggravated Assault Upon a Police Officer, both felonies, and Criminal Possession of a Weapon in the Fourth Degree, a misdemeanor.

The defendant remains remanded to Westchester County Jail. His next court date is Aug. 6

At approximately 12:26 p.m. on May 20, two North Castle police officers responded to a 911 emergency call on Hallock Place in Armonk to assist a 78-year-old woman who needed medical care. At the scene, officers became aware that the defendant, who had two outstanding bench warrants in North Castle Town Court, was also in the home. When officers attempted to arrest the defendant, he allegedly used a knife attempting to stab Sgt. William McClure multiple times in the back, striking the sergeant's ballistic vest, before Police Officer Chris Costa used his duty pistol to fire two shots, striking the defendant twice. The incident was captured on police-worn body cameras.

The defendant and both officers were transported to local hospitals for treatment and evaluation; the officers were uninjured.

The defendant was arrested in the hospital on May 28 following an investigation conducted by the Westchester County Department of Public Safety and the Westchester County District Attorney's Office.

The case is being prosecuted by Bureau Chief Jonathan Strongin and Assistant District Attorney Alexander B. Shapiro, both of the Trials & Investigations Division, with assistance from the Rye Bureau.

The charges against the defendant are merely accusations, and the defendant is presumed innocent unless and until proven guilty.

County Executive George Latimer is quoted, "I expect him to be the Democratic nominee for county executive...I don't know that I've heard anybody thinking of challenging him within the party."

"Nobody has called me up and said 'I'm definitely in'" said Westchester County Democratic Committee Chair Suzanne Berger. Many Westchester Democrats have questioned both the timing of the story, and the need to anoint Jenkins the democratic nominee, in the middle of July.

The political calendar to see who will replace Latimer has moved up after Latimer's win in the democratic primary for congress against Rep. Jamaal Bowman. But Latimer still has to win the general election in November. His term as county executive ends at the end of next year, 2025.

But, if he beats the republican candidate for congress, Dr. Miriam Levitt Flisser, he will be sworn in as a member of the House in January. At that point Latimer will have to vacate the office of County Executive, or he could do that earlier to prepare for his new job in DC.

In the spring of 2025, there will have to be a special election for County Executive. That will include both the democrat and republican nominees. The winner of the special election will serve until November of 2025, when another county executive election will take place for a full, four-year term.

At this point, Ken Jenkins is the front runner to be the next Westchester County Executive. He has served as Latimer's deputy for 7 years. He also served as the Vice-Chair of the New York State Independent Redistricting Commission.

But when Westchester democrats read the story, several that we spoke to wondered, why now and what is the rush? The story ran on July 1, in the middle of the summer, when most are away or aren't paying attention to local politics. And Westchester democrats just got through a draining Latimer-Bowman democratic primary.

Specifically, Westchester democrats that we spoke to see the City & State story as a slight to the Yonkers Mayor Mike Spano. Mike Spano was the first Democrat to hold the Mayor's office in Yonkers in 16 years when he was elected in 2011. When he first took office as Yonkers Mayor, the Yonkers City Council had a Republican majority, a Republican County Executive, and a Republican majority on the County Board of Legislators. The leadership of Mike Spano as the face of the Democratic Party has powered the victories that led to those legislative bodies and positions becoming Democratically controlled.

Mike Spano has a track record as mayor of delivering balanced budgets, smart development, and a booming workforce in Yonkers. Mike Spano also has an incredible track record of electability. In a special election potentially in the month of March, Westchester County Democrats need a candidate with universal appeal like Mike Spano.

So, based on this record, should Mayor Spano be given a chance to think it over, and determine if he wants to run for County Executive? And we hear that there are other elected Westchester democrats interested in at least testing the waters for a County Executive run.

"I like Ken, but to crown him as the next County Executive is premature," said Yonkers Democratic Chair Tom Meier. "I think the mayor of the third largest City in New York, who is popular with all groups, should be allowed to consider a run. We don't know what his next political move is."

"There are democrats out there who have political ambition equal to Ken and have political dreams of their own. There might be some other Mayors who are interested. It might be someone we don't even know.

"It's extremely early. A lot of people need to consider it and talk to their supporters and their family," said Meier.

Harrison democrat Mark Jaffe, who ran for Harrison Supervisor last year said, "Anybody can run in a primary, and I don't know if Mayor Spano wants to run. But he would make a fine candidate for County Executive, no doubt. He is doing a great job running the city and is immensely popular. I think Ken is happy with the story, but it guarantees nothing. And I do think that someone will challenge him if its Mike or someone else."

A Yorktown democrat said, "This special election for County Executive is a very important for the future of our county. We need a candidate that people from every corner of the county can support- that person could very well be Mike Spano. We must have an open process in electing our next County Executive. I truly hope that Mike Spano considers a run for County Executive. His position as moderate Democrat is something that voters are embracing more than ever."

A Hastings-on-Hudson democrat said, "Mike Spano has transformed Yonkers and brought the best out of the city. He can do the same thing for our county. As a proud member of the LGBTQ+ community, I have seen Mayor Spano unite communities and make inclusion the hallmark of his time thus far as Mayor. Mayor Mike Spano should be an option for County Executive or even higher office considering the way he transformed Yonkers."

Other Yonkers democrats see a "growing discontent" between Yonkers democrats and the county democrats. "We get no credit for all the wins we have had here in Yonkers. Whether it's getting out the vote, organizing volunteers or raising money, that's not coming from the county democrats," said one Yonkers Democrat. "There is a growing number of people who think that Mayor Spano should consider running for County Executive."

Recent victories by Yonkers democrats include City Council President Lakisha Collins-Bellamy's win over then Council President Mike Khader, and Mayor Spano's recent reelection primary victory over councilwoman Corazon Pineda-Isaac, are two examples used by Westchester Democrats we spoke to.

The caveat to all of this is that Spano has not made up his mind and loves his job as Yonkers Mayor. But his supporters and those around him have tossed out the possibility.

"When we want to be organized, we can do it. This is nothing against Ken Jenkins, but more to the county organization. Sometimes, the county has no respect for the Yonkers democrats and as a result, we are uneasy, so we asked the mayor to consider it.

Mayor Spano's brother, Nick Spano, recently held a fund raiser for Governor Kathy Hochul at his Yonkers home, raising six figures. "There's a lot of Spano democrats in Yonkers, and we have been winning a lot of elections, even outside of Yonkers," said one Eastchester democrat.

One Yonkers democrat who likes both Jenkins and Spano, did say, "George still has to win in November. Why not wait until then? It's way too early to do anything, or make any democrat commit. But I also know that Mayor Spano loves being mayor and it would take a lot to pry him out."

Yonkers power in the Westchester democratic committee has declined over the past 20 years, from holding 25% of the county committee weighted voters to now around 18%. Some of the smaller democratic committees in northern Westchester have come together and formed an alliance, combining their share of the weighted vote.

"Sometimes, it's a misunderstanding of cities. Yonkers has a lot of great democratic candidates, starting with Mayor Spano and Ken Jenkins. We helped elect Susan Cacace, who comes from Yonkers. And Yonkers democrats have helped their candidates. You can't ask for our help without respecting our achievements and importance. Four Yonkers democrats are thinking about running for County Clerk. When you have qualified candidates who can win countywide, location shouldn't matter," said another Yonkers democrat.

Meier added, "Ken and I are good friends and the mayor, and I are good friends—but we could have a big showdown next year."
