

Days before the Yonkers St. Patrick's Day Parade, the FBI arrested Ridon Kola, a resident of Yonkers, for making threats against the Yonkers police and Yonkers Mayor Mike Spano. According the US Attorney Damian Williams, the threats, to kill Yonkers Police and Mayor Spano, while expressing his support for radical islamic extremism and terrorist attacks, were serious enough to warrant his arrest.

"RIDON KOLA was arrested on (March 17), based on a criminal Complaint filed in White Plains federal court charging KOLA with making threatening interstate communications, in which KOLA threatened to kill officers of the YPD and the Mayor of Yonkers. U.S. Attorney Damian Williams said: "As alleged, Ridon Kola posted threats on social media against law enforcement, stating his support for ISIS and his intention to murder numerous police officers. Undeterred after questioning from law enforcement, Kola's conduct escalated, as he continued to assure police his threats would be carried out. Threatening violence against police or to undermine public safety will not be tolerated, as Kola now stands charged and faces prison time for his threats against our dedicated law enforcement partners tasked with keeping us safe."

FBI Assistant Director Michael J. Driscoll said: "As we allege today, Kola, who has demonstrated support for radical Islamic extremism and terrorist attacks, made a series of threats to the lives of law enforcement and others, and now he will be forced to face the consequences of his actions. Counterterrorism remains the FBI's top priority, and through our NY JTTF, we remain committed to keeping all New Yorkers safe from acts of terror."

YPD Commissioner Christopher Sapienza said: "The safety of our residents, our community, and the members of our Police Department is paramount; every threat is investigated to the fullest extent possible. Thankfully, due to the outstanding collaborative efforts of the FBI's New York Joint Terrorism Task Force and our Yonkers Police Intelligence Division, our City will enjoy a safe Saint Patrick's Day parade tomorrow free from intimidation by bad actors."

The three major democratic candidates for Mayor of Yonkers are out collecting signatures to get on the ballot for a June democratic primary. Mayor Mike Spano is running for a fourth-term. Councilwoman Corazon Pineda-Isaac is also running for Mayor, as is Margaret Fountain-Coleman. One thousand valid democratic voters are required on a petition for Mayor. Mayor Spano's campaign has already collected several thousand signatures. Pineda-Isaac's campaign quickly got to 1,000 and are now working on another 1,000 to withstand a challenge to their petitions. Margaret Fountain-Coleman's campaign has close to the 1,000 required and is working on collecting at least another 500.

The current deadline to collect and file petitions is April 5, but that deadline might be extended to April 11. Two other democratic candidates, comedian Prince Robinson, and Blogger Freddy Vazquez are also said to be out there trying to get on the ballot. If they can get to 1,000 welcome to the race.

Waiting on the republican side is Councilman Anthony Merante, who is making his first run for Yonkers Mayor. Merante is not expected to have a republican opponent in a GOP Primary for Mayor.

### Assemblyman Sayegh Supports Law to Crack Down on Criminals Who Assault Retail Workers

Video footage of criminals assaulting retail workers is now a staple of nightly television newscasts. To crack down on criminals assaulting store owners and workers, Assemblyman Nader Sayegh is co-sponsoring new laws to stiffen penalties for those convicted of these assaults.

"New York State needs to approve the Protect Our Retail Stores and Workers Legislation to hold individuals, especially repeat offenders, accountable for their crimes. I call upon my Assembly and State Senate colleagues to pass the Protect Our Stores Legislation and send it to the Governor for approval."

Assemblyman Sayegh is co-sponsoring the Protect Our Retail Stores and Workers Legislation, a package of three bills.

Assembly Bill A5260 will make assaulting a retail employee or owner a class D felony. The proposal would put retail workers in the same protected category as police, firefighters, paramedics and other front-line workers. The legislation would allow judges to set bail for those accused. Currently, most are charged with second-degree assault, a crime not bail eligible. Additionally, this would bring a stiffer jail sentance upon conviction.

Assembly Bill A1504 creates a new crime, fostering the sale of stolen goods. This would make it a crime to run an online marketplace where the operator knows or should know that the goods offered for sale were stolen. These marketplaces have made it easy for criminals to sell stolen goods.

Assembly Bill A4121 goes after repeat offenders as it provides that a prior conviction within the past two years for petit larceny shall raise a subsequent offense to grand larceny in the fourth degree.

Assemblyman Sayegh has also advocated for State funding to assist store owners in installing and updating security cameras & systems to fight crime.

### YPS Employee Arrested for Public Lewdness, then Fired Same Day

Members of the Yonkers Police Department were notified by the Yonkers Public Schools administration of a complaint of inappropriate conduct involving an employee of the Yonkers Public Schools system. The Yonkers Police Intelligence Unit initiated a criminal investigation.

Investigation yielded that on Tuesday, February 28th, 2023, at approximately 11 AM, the subject of the investigation allegedly exposed his intimate parts in a lewd manner to a 58-year-old female. The incident occurred in a rented private office located in the Yonkers PAL at 127 North Broadway. No other people were present in the office nor was the incident visible outside the office.

Arrested earlier today was Rafael PENA, a 57-year-old resident of Yonkers. PENA was a Program Specialist for the Yonkers Public Schools; he was separated from employment on February 28th. PENA began working for the district in 2014. PENA is being charged with one count of Public Lewdness, a Class B Misdemeanor in the New York State Penal Law. The case is being prosecuted by the Westchester County District Attorney's Office.

### May I See Your Resume?

A lot of little goodies coming out of the County Legislature and County Executive lately. Now they are working on the George Santos legislation. Saving Electricity via Efficient Light Bulbs

I visited a friend recently who complained his electric bill was \$800 a month and and except for short visits by his kids and grandkids he was the only one in the house. I checked to see if he was using energy efficient light bulbs and he was not. So I did a little research for him. Mind you I have been using the energy efficient light build since before my mother passed over 30 years ago.

When mom was alive the energy efficient bulbs were bulky things, did not fit into all light fixtures and they gave off a weird light not perfect for reading. They for the most part gave off 60 watts and could not be used in a fixture that was rated for a light bulb above 60 watts.

These many years later the bulbs use 14Watts of energy and the most powerful of the bulbs gives off 100 watts, high enough for most lamps and sockets. What this means is that if your appliance is rated at a maximum 60 watts bulb these bulbs can be used in fixture as long as it is lower than 60 watts which is 99% of lamps and light sockets.

And the light coming off of the bulb is much brighter and clearer, avoiding the problems mom use to have 30 years ago. Next question is where do you get these energy efficient bulbs. I went on the Con Edison website and they recommended the Dollar Tree store, yes the store where with inflation everything is now \$1.25. Not only do these bulbs use that much electricity but they also last a long times so no need to pull out the bulbs and replace them with a new bulb quite as often. Quite often on your bill Con Edison runs specials on the bulbs making them changes.

Now you don't have to worry about safety as the bulbs are as safe as regular light bulbs. Let's say your replace 10 bulbs in your house with energy saving bulbs. If you save \$30 a month which is realistic you have made your \$12.50 investment back in a month and then some.

Con Edison has many different types of bulbs to fit everything from your regular lamps to spotlights. The list on the website will tell you various places to go to get the bulbs that you need. This is a no brainer ,you have nothing to lose and your Savings are clear as a whistle on your electricity bill as long as you don't have a major power increase.

We haven't got the numbers from Sustainable Westchester yet as to how much savings each household. Is receiving using their services. I would like to see that number and I would like to see the organization sell lightbulbs and do a 6 month comparison to see how much the energy bill goes down. That would be a suitable comparison for me as to how well we and they are doing.

### Cold Case Closed: Florida Man Sentenced to 20 Years for 2005 Murder of Angel Serbay

On March 17, Westchester County District Attorney Miriam E. Rocah announced that a Florida man was sentenced to 20 years to life in state prison for the 2005 murder of Yonkers resident Angel Serbay.

DA Rocah said: "Angel Serbay was murdered and inhumanely left on the side of the road, and now 18 years later we have gotten justice for her family, friends and community. Today's sentence holds this defendant accountable for his heinous crime. Our Cold Case Bureau remains committed to solving the hundreds of open homicides in Westchester County."

On September 3, 2005, Christopher Gonzalez, 41, strangled the 25-year-old victim to death and disposed of the victim's body in a sheet on the shoulder of the Sprain Brook Parkway in Greenburgh, where she was discovered by a passerby who contacted the New York State Police.

An investigation conducted jointly by the New York State Police and the New York City Police Department (NYPD) forensically linked the victim's death to a 2000 Bronx cold case, and the defendant's DNA ultimately connected him to both murders. The defendant was located in Florida by the NYPD and New York State Police and extradited to the Bronx on December 8, 2017. The defendant, who was in the custody of the NYC Department of Corrections, was arrested on his charges in Westchester County on May 16, 2019.

On January 18, 2023, the defendant pleaded guilty to Murder in the Second Degree.

In a statement read in court, the victim's mother said: "While I am grateful that her murderer, Christopher Gonzalez, was eventually caught and am thankful that law enforcement never gave up on catching him, the years of waiting have taken a toll on me and have been excruciating...I do not forgive Christopher Gonzalez. I believe him to be an evil, ruthless, soulless man."

The District Attorney thanked the New York State Police, the NYPD, the Collier County Sheriff's Office and the Bronx District Attorney's Office for their assistance in this case. The case was before Judge Robert Neary in Westchester County Court, and was prosecuted by Major Crimes Bureau Chief Nadine Nagler and Bureau Chief James Bavero, both of the Trials and Investigations Division..

### Westchester Mourns Hutch Midnight Car Crash That Killed Five Kids; Driver Had No License

Calling it "One of the worst days of my tenure," Westchester County executive George Latimer shared the news with Westchester residents that five children were killed in an auto accident on the Hutchinson Parkway on March 19.

"This was a horrific accident, and accident site. We do not believe that speed was a factor. It is believed that the driver was distracted or fell asleep. There were no other vehicles involved. We don't know answers to certain questions, but right now we mourn the loss and pray for the family," said Latimer.

The five members of the car that were killed were identified as: Malik Smith, 16, who was the driver of the car; Anthony Billips Jr., 17; Zahnyiah Cross, 12; Shawnell Cross, 11; Andrew Billips, 8.

One passenger in the car, 9-year-old Abraham Billips, was in the rear of the SUV and survived, exciting through a shattered rear window.

The driver Malik Smith, did not have a drivers license or a permit. Smith was a

student at a school in Brooklyn, and was driving his cousins to their new home in Derby Ct. The car was traveling northbound on the Hutchinson Parkway when it swerved off the road and struck a large rock and then a tree, causing the car to go up into flames.

Further reporting found that the car was a rental, and that Smith did not have permission to drive it. The accident occurred after midnight in the early hours of Sunday.

Latimer called for residents asking questions to be patient, as toxicology reports and a determination on whether all of the passengers were wearing a seat-belt, are determined.

"Hi, my name is Da'Shawna Cross I am making a fundraiser to help bury our children we lost, we as parents lost 5 of our children in a very tragic accident and need help deeply with giving them a great home going service, please anything will help we just want to put our babies to rest," writes Cross on the GoFundMe page.

All of the young persons in the car were related and were close, according to Malik Smith Sr. "I told him, his mother told him, his older brothers told him: Stop driving without a license, without a permit. Anything happens, you get pulled over, you get in trouble for these things. Stop doing this," he told the Daily News

### Councilmember Pineda-Isaac Calls on Mayor Spano to Approve Paid Family Leave Expansion

Introduces Resolution to Increase Access and Coverage of Paid Family Leave Benefits for City Employees

On March 22, Yonkers City Councilmember Corazon Pineda-Isaac (D-2) announced the introduction of a resolution which aims to expand paid family leave benefits for City employees. Currently, the City of Yonkers offers a limited number of paid days off for City employees not represented by a union, and the Federal Family Medical Leave Act (FMLA) only provides for unpaid leave. The Councilmember's Resolution is aimed at extending the duration of fully paid leave as well as expanding eligibility to more City employees.

"Like many working people, our city's employees feel the stress of trying to meet their work and family responsibilities, and face financial hardships when their only option is to take unpaid family leave," said Councilmember Pineda-Isaac.

"The City of Yonkers has made few accommodations for the impact this has on families and it's long overdue for the Mayor to act. Yonkers is behind the times and we need to catch up."

Earlier this year, Governor Kathy Hochul launched an initiative to offer fully paid parental leave benefits to New York State employees that would result in 10,000 unrepresented State employees becoming eligible to receive 12 weeks of fully paid leave to use for bonding with a newborn, fostered, or adopted child. The City of Yonkers has not followed suit, leaving its non- unionized employees without the same parental leave benefits that will now be offered at the State level.

"Life's conflicting demands are even more acute at the birth or adoption of a child, or when a child, spouse, or domestic partner or parent has a serious illness," said Councilmember Pineda-Isaac. "Women frequently are the primary caretakers within their immediate and extended families in addition to their participation in the paid labor force. Those who keep our city running each day should not be put in a position where they have to choose between a paycheck and caring for their family."

"Paid parental leave is long overdue for employees of the City of Yonkers. Allowing paid time off to care for a newborn or a loved one is a fundamental best practice for employers in this day and age. I commend Councilmember Pineda-Isaac for championing this cause and bringing employment practices in the City of Yonkers into the 21st century", said Eileen O'Connor, cofounder of NYCD16-Indivisible.

The City will investigate the costs and benefits associated with the implementation of such a policy, which may prove modest if funded through insurance as outline in the FMLA. Many employers already offer up to 12 weeks of paid family leave as a standard benefit to their employees. The City of Yonkers now has the opportunity to catch up with the times and reverse its backwards approach to paid family leave benefits for its employees. The City Council's Resolution calls upon Mayor Spano and his Administration to review and consider increasing and expanding paid family leave for employees of the City, so that they can finally be afforded the same basic paid leave benefits provided by many other employers.

### On This Day in Yonkers History..



Assemblyman from Yonkers, Malcolm Wilson. He later became the only NY Governor from Yonkers

Monday, March 27th

March 27, 1927: Our New York State Champions returned home! Although the Terrace City did not have much time to arrange a welcome, team members John Acropolis, Dave Smith, Al Smith, Mike Mikuliak, Cony DeSalvo, Frank Kosky, George Alotrico, Coach Ira Huber and Manager Fred Palmer were met at the Yonkers Train Station by more than 2,000 people. Blaring horns and cheers led them on a triumphant march to Yonkers High. Official welcomes by Mayor William Walsh and Board of Ed trustees were swept away by the excitement of students rushing to celebrate the champs! Captain Acropolis attributed the win to the "hearty support of the Yonkers people and the efforts of Coach Huber," adding, team members said "We got to win this game for the folks back home." Coach Huber credited John Acropolis, saying ,"We had to play the two hardest teams in the tournament, but we came through and it was due to Acropolis and his teammates." The evening closed with a snake dance, truly making a stellar event in Yonkers High's history.

Tuesday, March 28th

March 28, 1932: Although the Yonkers counsel objected strenuously, the Yonkers "dump suit" trial started. Former Children's Court Judge Benjamin Moore, former City Treasurer Frederick Breithack and contractor George T. Kelly sought a \$289,000 damage award from Yonkers for the deterioration of property on Nepperhan Avenue, north of Lake Avenue. Plaintiffs claimed city dumping caused the alleged damage, and wanted an injunction to stop all future dumping. First witness was former DPW Commissioner George Herzog of Pier Street, questioned about dumping on the site while he was in office. He testified Yonkers issued permits for dumping by private interests, such as Alexander Smith, Yonkers Lighting, and several contractors. He stated about 50,000 cubic yards of trash would have to be removed to restore the property by the river.

Special Counsel for Yonkers Albert Jordan objected to the entire proceeding, and wanted the complaint dismissed on grounds this type of litigation must be started within three months of the date of the offense; Justice Morschauser reserved decision. A second Jordan objection was DPW acts were not "binding upon the city;" he was overruled.

Wednesday, March 29th

March 29, 1927: The de Merveaux flogging law suit against former Yonkers resident J. Stuart Blackton went to the jury. Blackton lost but the jury awarded the plaintiff only \$500 instead of the \$25,000 asked. Blackton's attorney said the jury had not taken the allegations very seriously.

March 29, 1932: Yonkers Special Counsel Albert Jordan for the "dump suit" was hit with a severe reprimand from Supreme Court Justice Morschauser, hearing the case without a jury. Morschauser reprimanded Jordan for alleging discrimination against our city, adding, he had "not been insulted in this way in a long time." Jordan complained he made "more than 50 objections" that were not sustained. Morschauser pulled the previous days record and read out a large number of Jordan's objections that were sustained.

Thursday, March 30th

March 30, 1941: The efforts of Assemblyman Malcolm Wilson resulted in the elimination of the 25-cent charge for all adult visitors to Yonkers' historic Manor Hall

March 30, 1946: After a heated argument with Cyrus Lewis, Counsel for the operators of Grassy Sprain Golf Club who leased the club from Yonkers, Mayor Frank told Lewis to tell his clients to "stop trespassing" on property on the eastern border of the course. At the time it was dedicated as a city park. Even though it officially was a city park, the course managers were charging golfers to use that portion of the course. Lewis strongly protested Yonkers leasing the 15th and 16th holes to the veterans without consulting his clients, the house managers, and felt Yonkers was giving them the runaround.

ing threats of violence against, among others, law enforcement, culminating in recent online threats against the YPD in connection with the Yonkers St. Patrick's Day parade scheduled for Saturday, March 18. KOLA's posts demonstrate support for radical Islamic extremism and terrorist attacks. In a recent threatening post, KOLA displayed himself with an axe.

On November 19, 2021, KOLA posted to a YPD official social media account a message in Albanian that translated to the following: "I am going to slaughter you little girls."

On December 5, 2021, KOLA posted to the same YPD social media account a message stating that: "Starting tomorrow I will start killing your officers just so u know who is doing it, Ridon Kola Albanian blood," and that he would also kill the Mayor of Yonkers.

Following those threats, in December 2021, YPD detectives interviewed KOLA at his residence. KOLA admitted to making the threatening posts but claimed he had no plans to harm YPD officers or the Mayor. Based on his demeanor, YPD subsequently issued a warning to officers to exercise diligence and caution in any encounters with KOLA. Beginning in early 2023, and continuing in the days leading up to the planned St. Patrick's Day parade, KOLA has escalated his threats against the YPD and other government officials and has expressed his support for violent Islamic extremism and terrorist attacks.

In January 2023, KOLA posted multiple statements expressing support for "jihad," or "to war against non-Muslims," and the establishment of a "caliphate," and depicting the raised index finger gesture used by jihadist groups, including the terrorist organization the Islamic State of Iraq and al-Sham ("ISIS").

On March 6, 2023, appearing to reference YPD's prior interview of KOLA, KOLA sent a direct message to the YPD social media account stating: "I'm looking for that officer that came to my house and threatened me and my family to kill us. I'm going to burn the world until I find him Vallahi [by God], no matter what happens to me there will never be peace in this country anymore! Allahu Ekberr." The phrase "Allahu Ekberr" is one form of an Arabic phrase meaning "God is great," which radical Islamic extremists have proclaimed in connection with the commission of terrorist attacks.

The next day, March 7, 2023, KOLA posted a statement praising Sayfullo Saipov, the recently convicted perpetrator of a terrorist attack for ISIS in which Saipov used a truck on Halloween in 2017 to murder eight victims and injure many more on a bike bath in lower Manhattan. KOLA referred to Saipov as "my BROTHER.'

As of March 9, 2023, KOLA's social media account profile included the statement, "Now is personal America and the world!!!" and a threat to burn "cia fbi nsa police jud[g]es alive w their families too!"

Also on March 9, KOLA sent two direct messages to the YPD social media account stating: "First people to be crucified will be the Yonkers rats Vallahi. Allahu Ekberr"; and "I will crucify Yonkers cops and their bosses all along McLean ave. It will be a horror scene . . . Allahu Ekberr." McLean Avenue in Yonkers is part of the route for the Yonkers St. Patrick's Day Parade taking place on March 18, and numerous YPD officers will be posted to the parade route along that street. KOLA's residence is in the area of the parade route.

Three days later, on March 12, 2023, KOLA posted to his social media feed a photograph of himself holding an axe with a statement in Albanian, translated to the following: "Come on Judas, I'm waiting for you."

KOLA, 32, of Yonkers, New York, is charged with making threatening interstate communications, which carries a maximum sentence of five years in prison.

Mayor Mike Spano said, "I want to commend our Yonkers Police Department, FBI, NYPD, Joint Terrorism Task Force, and all agencies involved in thwarting this threat. We rely on their expertise, skill, and knowledge to ensure our safety. Yonkers is proud to host one of New York's largest St. Patrick's Day parades and threats like this will not intimidate us from celebrating the many contributions of our Irish American community. I look forward to proudly leading the parade tomorrow and ask all to meet me on McLean for the festive celebration.'

Friday, March 31st

March 31, 1927: Although Blackton's attorney took out an insanity warrant against fencing master Gerard De Merveaux after the trial, he couldn't be served; process servers couldn't find him.

March 31, 1943: At a City Hall conference, City Manager William Walsh told Habirshaw Plant Superintendent Earle Michell his employees must stop all-night and all-day parking near the plant; Mitchell asked ten days to work out a suitable plan. Residents near the plant complained for months about the hazards of longterm employee parking; they parked on both sides of the narrow streets, making it difficult for emergency vehicles like firetrucks to pass.

Saturday, April 1st

April 1, 1933: More than a year later, the Nepperhan Avenue "dump suit" was decided against Yonkers in a ruling handed down by the Appellate Division. The decision awarded the owner \$45,000 for damages caused by illegal use of their land for dumping.

April 1, 1955: Fayette S. Dunn, Secretary of Otis Elevator Company, reassured the members of the Yonkers Rotary Club, the thought of "immediately leaving Yonkers has been put aside."

Sunday, April 2nd

April 2, 1923: Noted song writer and theatrical producer George M. Cohan sang and danced to benefit St. Joseph's Hospital; not only did he address the audience, he sang songs from "Little Nellie Kelly," his production on Broadway, and gave a dance exhibition!

April 2, 1939: Gustave Segschneider of Belmont Avenue turned 90 and shared a few of his tips for a long life. He loved dancing and strong cigars, and staying up late was his "fountain of youth!

He particularly enjoyed the company of young people, and had many neighborhood children for friends. He was not a fan of beer, but thought a glass of whiskey every now and then was a very good thing!



The We The People Congress is a nationwide, non-partisan, not-for-profit membership organization of constitutional activists committed to "institutionalizing" citizen vigilance through civic education, monitoring of governments, and organizing grassroots programs of civic resistance to confront and repel tyranny. It is legally and institutionally separate from the We The People Foundation for Constitutional Education, but closely connected by a mutuality of purpose and coordinated operations plans.

### GENERAL OBJECTIVES

To develop a nation-wide network of informed and responsible citizens capable of holding government accountable by compelling government officials - at all levels - to obey our federal and state constitutions, with full reliance on the rights of the people and obligations of the government under the Petition Clause of the First Amendment.

### 2028 OBJECTIVES

Establish an affiliate of the WTPC Congress in each State, including a Board of Directors. Establish a web site and a bank account for each State affiliate. Select a site for the Citizen Vigilance Center in each State. Each Citizen Vigilance Center is to look like Thomas Jefferson's home in Virginia (See photo above). Begin the process of securing an army of supporting members in each State, say 2-3 percent of the State's population over the age of 18. Designate a State Coordinator, Regional Coordinators and County Coordinators and begin choosing and training the State's Constitution Monitors.
