

Philipse Manor Hall Hosts Virtual Talk on Slavery May 10



Philipse Manor Hall State Historic Site is pleased to present "Spaces of Enslavement and Resistance in Dutch New York" a virtual lecture by Andrea Mosterman, on Wednesday, May 10, 2023 at 7:00 p.m.

In her presentation, Andrea Mosterman will explore the history of slavery and resistance in Dutch New York. Through examination of Dutch American homes, Dutch Reformed churches, and public spaces in these predominantly Dutch American communities, she shows how Dutch American enslavers increasingly used their dominance over these spaces to control the people they enslaved, while enslaved people resisted such control by escaping or modifying these spaces and expanding their mobility and activities within them. Such close analysis of enslavement in these spaces reveals that by the mideighteenth-century slavery in New York was an advanced system of control.

Andrea Mosterman is associate professor in Atlantic History and Joseph Tregle Professor in Early American History at the University of New Orleans. In her work, she researches slavery and the slave trade in the Dutch Atlantic world with an emphasis on early New York. Her research has been published in various academic and public-facing publications. Her book Spaces of Enslavement: A History of Slavery and Resistance in Dutch New York (Cornell University Press, 2021), which won the 2020 Hendricks Award for best book-length manuscript relating to New Netherland and the Dutch colonial experience, uses spatial analysis to examine enslavement and resistance in New York's Dutch communities. She is currently researching the voyage of the Dutch slave ship the Gideon and the seventeenth-century Dutch Atlantic slave trade with North America.

Mayor Mike Spano and Police Commissioner Christopher Sapienza recently announced a series of initiatives for the month of May to improve the quality-of-life of community members and residents as the weather warms and people spend more time outside. Operation: Spring Ahead will focus police resources on those issues that generate the overwhelming amount of community complaints and were the top concerns of recent survey respondents, including:

Vehicle and Traffic Law Moving Violations:

Speeding, Disobeying Stop Signs, Aggressive and reckless driving, Double-Parking

Vehicle and Traffic Law Equipment Violations

Loud Mufflers, Fraudulent Paper License Plates, Safety violations, ATVs, Dirt bikes, and illegal scooters

Property Crimes

Shoplifting, Catalytic Converter theft, Larceny from Autos, Package theft

Neighborhoods and Public Spaces

Disorderly Groups, Noise pollution, Dog Waste, Smoke shops

Community Policing



The Spano's....They, Too are Yonkers

The Spano's: Every few years when a Spano runs for office, you can count on the Journal News or it's Predecessor, the Herald Statesman to run a story on how many Spano relatives are in public service. This goes back to Leonard Spano, the patriarch of the family right up to his son Mike, current Mayor of the City of Yon-

Do you have 16 brothers and sisters? If they play by the rules would you have a problem with your relatives working for the city of Yonkers, Westchester County or New York State? Should they be denied the right to public service just because they are related to you?

Of course the answer is no. No one told you you couldn't have a big family. And if they play by the rules no one says they can't have a career in public service. Jobs in the Fire Department and Police Department are appointed off of Civil Service lists. You take a test, sometimes with 100's of other people. The top scorers if they can meet the physical agility and other tests are appointed to good paying jobs.

Environmental Maintenance Workers which could be garbage men or work in one of the city maintenance departments initially are appointed at the discretion of the Mayor but receive their promotions just like Police and Fireman by taking civil service tests. You do well you move up, you have special skills you move up, and your overtime is not assigned by the Mayor but by your Department Head.

Now let's take a moment to be clear. You are elected Mayor, President or to any office and you want to get re-elected? You surround yourself with people you trust. People that will take their job responsibilities seriously, do a good job and help you get re-elected. The President of the United States doesn't surround himself with people who are not loyal to him, and neither does the Mayor of the City of Yonkers when he is selecting his top officials to help him run the government.

If you want a job working in City Hall in Yonkers and it's not an exam appointed off a Civil Service list, there is nothing to stop you from putting in an application and talking to the Mayor or other appointed officials about the possibilities of appointment. You know the old phrase, 'It's not what you know but who you know!' I would say the vast number of people, all hard workers obtained their city government jobs by putting the word out that they want a job in government. Or someone told them there was a position open in government they should apply for. This again goes from Mayor of Yonkers to President of the United States.

And don't just think this is the way that things work in the public sector. When you are applying for a job in the private sector your knowledge of those involved in hiring or connections you may have help you get your foot in the door. It's been that way for years.

David Wilson, the scribe of this year's Journal News article on 'Spano Foothold' is a long time employee of the paper. I am sure he has written articles like the one about 'nepotism' and particularly about the Spano's many times before. The articles for the most part are generated by the opponent to the elected official. If this was something new or a new official with all these relatives on the payroll I could see the big deal. And some will read Wilson's article and say, 'Gee, he forgot

Corazon Pineda Isaac is running against Spano in a primary for the Democratic nomination for Mayor. I'm sure if she was in government as long as the Spano family and had as many brothers and sisters as Mike has, many of them would be working for the City of Yonkers. She just happens to be the one to bring up the issue this year. Believe me, it's been brought up many times before by candidates running against the Spano's.

The solution to the 'problem.' Stay on top of Civil Service lists and apply for jobs you know you are qualified for. Between Covid and retirements there will be many jobs open over the next 3-5 years. Apply for them. Take the tests, and good luck to you!

On the issue of Spano relatives serving as paid lobbyists for city unions and companies doing business before the City of Yonkers, I would surely hope that the Board of Ethics and Inspector General have been consulted for legality of this. And remember, if you see something you think is illegal or unethical, you as a citizen have every right to file a formal complaint with these agencies or the governing bodies of the commissions or agencies involved.

Remember, our door is always open here at Rising Newspapers to publish *legitimate complaints from taxpayers or organizations.* That's what we are here for together with providing news about your community and neighbors.

Good Luck Ms. Pineda Isaac. This column is not meant to discourage you from bringing up issues where you disagree with the current Mayor (like the extension of term limits again which I think is terrible.)

What floors me is that reporter Wilson was unable to get comments from Anthony Merante, the Republican candidate for Mayor or Margaret Fountain Coleman, another Democrat seeking the nomination on the Spano's family involvement in city public affairs. Attorney General James Takes Action to Protect New Yorkers Homes and Combat Deed Theft

On April 28, New York Attorney General Letitia James, State Senator Brian Kavanagh, State Senator Zellnor Myrie, and Assemblymember Helene Weinstein announced new legislation to strengthen protections and remedies for victims of deed theft and bolster the Office of the Attorney General's (OAG) ability to prosecute these crimes. Deed theft is a growing problem that predominantly targets Black and Brown homeowners, and under New York's current laws, opportunities for prosecutors to hold deed thieves accountable are limited. The two bills — one addressing criminal challenges and the other focused on changes to civil laws — would establish a crime of deed theft and help keep New Yorkers in their homes.

"No one's home should be stolen by a scammer without warning or reason," said Attorney General James. "Victims of deed theft are often older adults and people of color who are asset rich but cash poor. Homeownership is a stabilizing economic force for their families and loved ones, and deed theft robs them not just of their family home, but of their most significant financial asset and the community they have known for their entire lives. This legislation will provide real and necessary changes to our civil and criminal laws to stop the perpetrators of these crimes and provide the protections and remedies needed to keep people in their homes. I want to thank State Senator Kavanagh, State Senator Myrie, and Assemblymember Weinstein for their partnership in these critical efforts to keep New Yorkers in their homes."

Deed theft occurs when someone takes the title, or deed, to another person's home without the homeowner's knowledge or approval. It has become a popular tactic used by scammers to illegally obtain ownership of a property, and disproportionately impacts elderly homeowners and homeowners of color, especially Black and Brown homeowners in gentrifying neighborhoods. From 2014 to the present, the New York City Sheriff's Office counted nearly 3,500 complaints of deed theft throughout New York City, with more than 1,500 complaints in Brooklyn and 1,000 from Queens. Deed theft scams are not just limited to New York City. Throughout the state, District Attorneys in Albany, Erie, Monroe, and Onondaga Counties have reported recent active deed theft complaints. As part of the legislation, the New York State Department of Criminal Justice Services would collect statewide data on deed theft crimes, which will further aid efforts to combat this scam.

The most common ways scammers steal deeds are through forgery or through fraud. In cases that involve forgery, scammers fake the real homeowner's signature on a deed and file it with the county clerk to make it look like they bought the property. In cases that involve fraud, homeowners are tricked into unknowingly signing over their homes to a scammer. These thieves then often evict the homeowner and sell the property at a significant profit. Under current law in New York state, deed theft itself is not a crime, and there are not adequate protections in place to slow down or stop a deed theft in process. Today Attorney General James, State Senator Myrie, State Senator Kavanaugh, and Assemblymember Weinstein are introducing two pieces of legislation that would address these issues by creating new criminal and civil legal provisions to increase enforcement opportunities and help keep New Yorkers in their homes. They would Establish a Crime of Deed Theft, Grant OAG Criminal Jurisdiction, Extend the Statute of Limitations, Void Good Faith Purchaser Protections, Stay Eviction Proceedings, and Expand Existing Protections. 

Yonkers School Street Gunman Gets 10 Years for 2022 Shooting

Injured Three, Fled to Georgia

On April 20, Westchester County District Attorney Miriam E. Rocah announced that a Yonkers man was sentenced to 10 years in state prison, with three years of postrelease supervision, for a July 2022 shooting in Yonkers that injured three.

DA Rocah said: "This defendant unleashed a torrent of gunfire on a crowd of people

enjoying a summer night last year, and terrorized a community that had endured another shooting just hours before, and multiple other shootings earlier that week. We are thankful that a dangerous gunman has been removed from our streets and justice has been served."

On March 2, 2023, the defendant, Jaquan Henderson, 23, pleaded guilty to Assault in

On March 2, 2023, the defendant, Jaquan Henderson, 23, pleaded guilty to Assault in the First Degree, a felony, for shooting three individuals after firing 11 rounds of a 9mm pistol at a group of people on School Street in Yonkers at approximately 10:45 p.m. on July 16, 2022. The shooting was captured on surveillance video.

The three victims sustained gunshot wounds and received emergency treatment at Westchester Medical Center in Valhalla.

After fleeing the state, the defendant was apprehended in Lithonia, Georgia, on August 3, 2022, by the FBI's Atlanta Metro Major Offender Task Force, following a joint investigation by the Yonkers Police Department, the District Attorney's Office and the FBI's Westchester Safe Streets Task Force. The Westchester County Department of Public Safety assisted Yonkers police with the arrest.

The case was before Judge George Fufidio in Westchester County Court, and was prosecuted by the Violent Criminal Enterprise Bureau of the Trials and Investigations Division.

Westchester Household Recyling Day May 6 at Sprain Ridge Park Yonkers

Household recycling day Westchester County's Department of Environmental Facilities (DEF) will be conducting a Household Recycling Day (HRD) Event on Saturday, May 6, from 9a.m. to 3p.m. at Sprain Ridge Park, 149 Jackson Avenue, Yonkers. The upcoming HRD event in Yonkers will be the second HRD event of 2023 and gives residents across the County an opportunity to conveniently and safely dispose of their household waste.

In 2022, DEF hosted six HRD events for over 3,800 County residents and accepted nearly 400,000 pounds of household waste. The first HRD event of 2023, held at FDR State Park, in Yorktown Heights, attracted almost 1,000 households.

In addition to properly labelled household chemicals, tires, scrap metal, electronics, appliances, and other special wastes found in a typical household, residents can bring documents for shredding and expired or unwanted medications for disposal to the May 6HRD Event.

Generally, the following items are accepted for safe disposal or recycling:

Properly labelled household chemicals, such as:

Household cleaning products

Most automotive fluids (antifreeze, brake fluid, gasoline, but not motor oil)

Flammable liquids (kerosene, butane, lighter fluid, turpentine)

Metal, jewelry, and furniture polishes and waxes; wood preservatives

Fertilizers, pesticides, insecticides, herbicides

Photographic and swimming pool chemicals

Batteries – only vehicle, rechargeable, or button cell batteries


Textiles- footwear, clothing, linens, leather, small area rugs, handbags

Latex and oil-based paint with labels visible, wood stains, Fluorescent light bulbs & CFLs,, Fire extinguishers, BBQ propane tanks (up to 20 lbs.), Mercury containing devices (thermometers and thermostats), Electronic waste (TVs, computer monitors and towers), Expired or unwanted medications, both OTC and prescription, Personal documents for shredding, limit of four boxes, Tires with or without rims, up to four (4),

Items that will not be accepted and should not be brought to the Household Recycling Day include non-rechargeable alkaline and carbon zinc batteries (they can be safely discarded in the trash), motor oil, smoke detectors, cell phones, explosives (flares, fireworks, ammunition), construction debris and hypodermic needles. Also, waste from businesses, schools, or other institutions will not be accepted.

To avoid waiting in line, you can dispose of your hard-to-get-rid-of household waste by making a convenient appointment for the County's Household-Material Recycling Facility (H-MRF), 15 Woods Road, Valhalla. The H-MRF is open Tuesday through Saturday from 10 a.m. to 3 p.m. by appointment, and accepts the same items that are accepted at the HRD events. On This Day in Yonkers History...

Monday, May 8th

May 8, 1945: Yonkers learned a Yonkers guy was responsible for the Headquarters Company of the 75th Division in Germany eating three times a day on clean tablecloths! PFC Joseph Danisher of Clinton Street, former Smith Carpet Factory employee, believed GIs would appreciate Army Food more if served in a homey environment. Danisher made it his business to wash tablecloths and put them on the tables every meal.

May 8, 1954: Thruway construction by the Saw Mill River dumped 50 gallons of muddy water into the river hourly, polluting Yonkers water supply system. This forced closure of the Tube Wells filtration station on Saw Mill River Road; it couldn't handle the huge increase of contamination. City Manager Charles Curran sent a telegram to Thruway Authority Chairman Tallamy, demanding "immediate steps to alleviate this condition." Yonkers had to purchase water from NYC to the tune of \$1000 daily, and Curran stated the situation would worsen as construction proceeded.

Tuesday, May 9th

May 9, 1929: DA Frank Coyne avoided the question whether the boday of Dorothy Peacox's would be exhumed to determine if she was before being murdered.

May 9, 1945: Steve Shiani, Honolulu Advertiser columnist, featured Yonkers' Captain Sol Friedman in an article. Friedman was Claims Officer, Special Service Officer, Public Relations Officer, and Legal Advisor at the Jungle Training Center, where troops received final training for Pacific warfare. On top of that, Friedman organized top entertainment such as Bob Hope and Carole Landis for the 250,000+ men serving in the area. With all Friedman did, Shiani felt our Yonkers guy should be triplets!

Wednesday, May 10th

May 10, 1904: The American Real Estate Company began remodeling the old Getty homestead on South Broadway into a hotel. The building, to be called the Park Hill Inn, would have two three-story extensions, and was expected to open in four months.

May 10, 1954: City Manager Charles Curran asked the Thruway Authority to reimburse Yonkers for the cost of buying water from New York City, since their construction caused the problem with our water supply. Curran said, "I cannot impress upon you the severity of the health hazard... an immediate and positive solution (must) be found for this problem" causing pollution and increased turbidity in the Saw Mill River.

At a conference with the contractor, Thruway Authority and local officials, Curran was told there was no solution; it would continue for two to three years. Curran demanded immediate action and a definitive written agreement remediating the situation.

Thursday, May 11th

May 11, 1929: Sydney Syme, attorney for accused murderer Earle Peacox, claimed Peacox was beaten and "third-degreed" into confessing after nine hours of questioning. Both the prosecution and the defense wanted the trial delayed until the Fall.

May 11, 1954: C. H. Lang of the Albany office of the State Thruway Authority sent a letter assuring City Manager Curran it was investigating his complaint and would cooperate in alleviating the condition. BUT. He said there was no way to stop mud and clay from washing into the river, and the situation would continue throughout construction. Even worse, it further would be complicated by a contractor moving the river from Tarrytown to Tuckahoe Road section to a new channel 50 feet west.

Friday, May 12th

May 12, 1961: City Clerk William Gray of Glenwood Gardens turned in his resignation, effective immediately. His two-sentence resignation stated: "Owing to ill health, I find it impossible to physically carry on the duties of the office of City Clerk of the City of Yonkers NY. Therefore, on the advice of my physician, I hereby tender my resignation effective immediately." He was in the position for more than nine years.

A transcript of his testimony before the State Investigation Commission probing bingo operations in Yonkers and New York City had arrived in City Hall that afternoon; his resignation stopped a Common Council inquiry into his testimony scheduled for the next day.

Saturday, May 13th:

May 13, 1922: Against a background of golden draperies in the Grecian theater at Greystone, Minnie and Samuel Untermyer's guests enjoyed an afternoon performance of Mozart's comic opera "The Impresario," performed by the Society of American Singers. Percy Hemus, bass soloist at St. Patrick's Cathedral, sang the lead part of the Impresario, and was interrupted several times by bursts of applause. The performance had a surprise performer, a bird perched in one of the trees near the theater; inspired by Franko's orchestra, the feathered singer joined with the soprano hitting the highest notes.

May 13, 1944: Private Grace Hill of Lamartine Terrace landed in Sydney, Australia, part of a large unit of WACs; the women arrived to relieve men to serve in the front lines. They disembarked from a transport, dressed in trench coats and steel helmets with packs on their backs; greeted by Brigadier General Thomas Rilea, American officers presented each woman a bouquet of flowers with the inscription, "Welcome Wacs."

Sunday, May 1 May 14, 1926: Mrs. Emmons Bryant, president of the Big Sister Organization, asked Mayor Walsh to appoint a policewoman to the Yonkers Police Department. She wanted

the policewoman to investigate "dance halls, theater and parks" in Yonkers. May 14, 1946: Coronet Magazine published a story about the Yonkers man responsible for making Hoagy Carmichael's classic song "Star Dust" a success! According to the story, its sheet music languished in music publisher Jack Mills' collection until Jimmy Dale of Kimball Terrace, an arranger for Mills, found it in 1929 and gave it a new tempo.

Rally to Save the River May 6 "It's time for Governor Hochul to get off the sidelines."

The Town of Cortlandt Manor and Supervisor Dr. Richard Becker will host a rally to save the Hudson River from a planned dumping of 1 million gallons of nuclear waste by Holtec on May 6, at Cortlandt Waterfront Park in Verplank.

Supervisor Becker writes, "As the Supervisor of The Town of Cortlandt, the host community for Indian Point, I am writing to inform you of a major rally against Holtec on May 6, at The Cortlandt Waterfront Park in Verplanck, at 2 PM. This site is a Town owned park, adjacent to Indian Point and the perfect venue: beautiful views of the Hudson. The Town Board is sponsoring this event.

"As you may be aware, Holtec International is planning to discharge 1 million gallons of radioactive water into the Hudson River as part of its decommissioning process. Their argument is that this is a low level of radiation, that they have been doing it continuously since the plant opened, and that there are no other viable options. The Town of Cortlandt, as well as multiple local other municipalities and agencies, strongly objects. Since the decommissioning process began, The Town has been working with the State's Decommissioning Oversight Board. Disappointingly, this Oversight Board has taken no action on this issue and has stated that it is really a Federal (NRC) and State (DEC) decision. The Town Board feels this is unacceptable, and we are prepared to fight vehemently against this happening. We anticipate this to be a major rally with thousands in attendance.

Holtec delayed a planned dump this month, but still plans on dumping in the fall. Several environmental groups have provded viable alternatives to Holtec which do not include dumping in the Hudson. Holtec is also planning to dump nuclear waste from Massachusetts power plant into Cape Cod Bay this year.

On April 27, the Indian Point Decommissioning Board held its regularly scheduled meeting in Westchester, which was attended by hundreds calling out Holtec for its plans. Assemblymember Dana Levenberg said, "After last night's discussion, there remain open questions that need answering. We still don't have satisfactory answers about the potential impacts of this radiation in the context of all the other pollutants to which we are exposed. Arguments like "we've been doing this for years" and "we are all exposed to lots of radiation" are offensive to people who have lost loved ones to cancer, or are dealing with
