#### Yonkers Police Commissioner Mueller, Mayor Mike Spano Ask for Changes to Bail Reform & Raise the Age Legislation

Several Yonkers elected officials, including Mayor Mike Spano, and members of law enforcement, including Yonkers Police Commissioner John Mueller, have asked for changes to the criminal justice reforms and bail reforms laws in New York State. Specifically, they are asking for modifications to bail reform and raise the age legislation.

Yonkers Police Commissioner John Mueller said, "in Yonkers, bail reform is affecting property crimes (car breaks ins and shoplifting). Raise the age legislation is impacting our violent crime."

Mueller said that state legislators worked last summer to make some changes to the criminal justice reform set of laws recently passed, but that a few, additional changes are still needed. "There is a small subset of repeat offenders that commit most of the crimes. We can say that if we made some minor changes to bail reform it would help with property crime. Just give us the tools to deal with that small group.

Mueller said that there is more gun violence from young teenagers, 15, 16 and 17 years old, that are affected by Raise the Age legislation., Many of these cases go to Family Court and the records are sealed. That means the next time they come before a judge, the judge will not know about their prior crimes because their records are sealed. We are asking that the judge be allowed to see the prior criminal history of anyone before the court. Don't seal the records for the public, but for the judge.

"We respect the reforms but we see a few areas that need improvement. We hope that they will sit down and listen to our concerns, which are based upon the crime data. We have the information, please let use talk to you about it," said Mueller

Keith Olson, the President of the Yonkers PBA, and President of the Affiliated Police Associatons of Westchester said, "The huge uptick in violent crime

"Shut up and listen to those who did it before you," Crystal Renee said. To move forward in the Hip-Hop/Rap culture, we must pay homage to those who came before us. "Respect the knowledge." Crystal Renee, 28, is a battle rapper from Yonkers, New York. No stranger to hard work, when outside of the ring, she's either catering with her catering business or working as a nanny. Crystal is a "go-getter, going for her dreams."

Crystal's love of music goes back close to 20 years. At nine years old, she performed a song during a competition in her Foxfire Elementary School 5th grade class. The song was a remake that she made of a Missy Elliot song. Her group performed the song and won. The rest is history. Missy Elliot is one of the people that inspire Renee. Elliot grew up in an active church choir family. The Black church is a vital part of Black music.

For centuries, Black Americans used the church to express themselves. Clapping hands, stomping feet, and shouting are some of the ways of self-expression in the church. Gospel music plays a role in Black America to this day. Without the Black church, there would be no Crystal Renee.

Missy Elliott is Renee's famous inspiration. Her more local inspiration is a young man named Phillip. Phillip "P Bills" Wells introduced Crystal to her first league to have her first battle competition. Afterward, the head of O.T.M known as ChopNGo Ty, scouted her out. Through her lyricism, she was able to earn the nod of many Yonkers folks. P. Bills, QwanDaRebel, Taj\_Milli, and Whitted, always pushed and supported her.

What makes Crystal different is that she isn't afraid to network with her competition. "I try to connect with other local rappers," she said. A trait like this will put her ahead of the pack. Nicki Minaj once said, "I lead the pack, so my back's to them." Renee is still a competitor, though. She will wake up at 3 or 4 a.m. to write lyrics. "Music is my outlet," she said.

Many young people across the country use music as an escape from reality. Home lives are sometimes in ruin, but music is there to help. Bus rides and train rides are long, but music is there to help. Sometimes you feel upset or down, but music is always there to assist you with whatever you need.

Crystal wants to leave readers with one takeaway. "You could do anything you put your mind to." She's determined to live her wildest dreams by any means necessary. With no children and a supporting family, the only thing that can get in the way of Crystal is Crystal. My "family gives props," she told me. Her uncle tells her, "it's all on you."

# Calling it a "Republican National Coordinated Fear Campaign," Sen. Majority Leader Stewart-Cousins Says No Changes to Bail Reform



Republicans "want to link the fear with democrats being in charge. Our reforms on bail was about misdemeanors and non-violent felonies. Shooting people is still a bailable offense, but no matter what the crime is they blame bail reform,"

At the February 6, 2022 monthly meeting of NYCD16-Indivisible, Senate Majority Leader Andrea Stewart-Cousins pushed back on critics of the criminal justice, police and bail reforms passed by the democratic majorities in Albany two years ago, and categorized the loud calls for changes to bail reform as a "Republican nationally coordinated campaign of fear." Sen. Stewart-Cousins also condemned Yonkers Mayor Mike Spano's remarks about Congressman Jamaal Bowman and that he should be "arrested" for voting against the bipartisan infrastructure bill, and added that Spano was already "running for Congress" and "making calls to donors."

This was Stewart-Cousins ready to stand up to the attacks made against her leadership and willing to fight to keep the criminal justice and bail reforms made, and explain them to the voters. "It's very alarming when we find ourselves in a situation when we are echoing the talking points of republicans and finding us at a loss for a rebuttal. It's clear to me-listen to this-it is very clear to me that this is a republican national coordinated campaign of fear. What happened after George Floyd was the people around the world understood the importance of reforming the police and criminal justice system. People understood we can have justice and maintain peace in our community without brutality."

Stewart-Cousins used the interview as a call to action for democrats and progressives to stand up to what she called untrue claims from republicans that blame increases in crime, and gun violence, not only in New York but across the country, on the criminal justice reforms passed in NY.

"Bail reform was done before the George Floyd murder and police reform happened after. They were pissed off that it happened at all, and now we have this backlash and a republican national campaign of fear"

"The are linking crime to bail reform. Crime is going up in some places but not in Westchester, according to the County Executive. Gun violence is a national issue that is not linked at all to bail reform. But the

#### Westchester PC Users Group Warns of Growing Computer Malware Virus Threats

A Westchester community computer non-profit is warning the public that while home computer virus threats are on the upswing, there are easy, protective measures that all of us can take. The Westchester PC Users Group (WPCUG) alerts that scammers, hackers and other bad actors increasingly employ fake emails, fake alerts that pop up when viewing legitimate websites, telephone scams and anti-virus marketers peppering cyberspace with hard-sell sales messages

All these literally touch all the homes in the region—and particularly try to trick untrained senior citizens into downloading malicious software. WPCUG president and former career IBMer Pierre Darmon, who is a computer consultant based in White Plains, senses a false sense of security by home users who think that computer viruses are aimed only at big companies and big industry.

Darmon said that all home computer users on websites can encounter a takeover of their web browser software by scammers with large-size messages such as "your computer may be infected" and other chilling warnings.

"This is scary because it makes you think that you've lost control of your computer since it is a full-screen message," says Darmon. "And there's a worry that the scammers may have done some more serious damage in the background."

In reality, the scammers have only put the user's browser in full screen mode that makes it difficult to close the page. WPCUG advises that users can make a safe exit most of the time by pressing on their keyboards Alt-F4 (on Windows) and Cmd-Q (on macOS). That closes the browser altogether and lets users regain control of their computer; after such force-closing, the browser can then be represented.

Browsers are software to surf the internet such as Google Chrome, Mozilla Firefox and Microsoft Edge for Windows, and Apple Safari for macOS. Malware (a contraction of the phrase "malicious software") is software that is harmful. One type of malware is a virus, self-replicating software designed to spread from

#### Latimer Announces Yonkers Joint Bulkhead Rehabilitation for Wastewater Treatment Plant

Westchester County Executive George Latimer is pleased to announce his Administration's continued efforts to rehabilitate or rebuild Westchester's aging infrastructure. These efforts create jobs, save the taxpayer money in the long term and create safer, more resilient & better working infrastructure for Westchester's residents.

To this end, Latimer is announcing that a \$6.6M project to rehabilitate and repair a cellular bulkhead at the Yonkers Wastewater Treatment Plant is well under-

Latimer said: "Piece by piece, we are working to create a more storm resilient County. This project is another sign of our progress. We know that our climate is changing, we know that Westchester residents thrive when quality construction jobs are bountiful and we know fixing infrastructure saves both lives and resources – all of which is accomplished through this endeavor."

The bulkhead, which is a steel sheeting wall that separates the plant from the Hudson River, was an expansion of the Yonkers Joint facility. The expansion was built in 1972 and was constructed on piles directly into the Hudson River. Rehabilitation and repair of the wall is periodically required due to age, weathering, and corrosion due to the salinity of the river water.

DEF Commissioner Vincent Kopicki said: "Under the leadership of County Executive Latimer, we are constantly hard at work to improve our facilities for the betterment of the entire County. This is truly exciting work in our field and the progress we are making is phenomenal."

The work includes the installation of tension rods, anchors, and steel plates,

prepping and coating of the steel surfaces, concrete repair, and backfilling of eroded areas. Most of the work is performed on the water facing side of the wall which makes access and working conditions complex. Nevertheless, the work is already approximately 20% complete.

#### Palisades Prep Boys Basketball Finish Strong, Winning Last 6



The Palisade Prep Boys Basketball team got hot at just the right time. As the team entered February they stood at 7-7 and had to play their final six games in 12 days. Due to covid cancellations from other teams the Phoenix ended up playing five games in the final seven days of the regular season. On February 2nd the boys faced cross-town & league rival YMA. The team got out to an early lead and cruised to a 72-49 win. Louis Martinez had 17 points, while Jalen Brown and Xavier Merrill each added 7. All nine players on the roster scored in the game.

On February 7th the boys were back in action, this time traveling to Lincoln High School in Yonkers in a non-league crossover. The team started slow but was able to gain momentum and win the game 60-42. Louis Martinez led all scorers with 25 points, sophomore Miguel Gonzalez added 13 points and junior forward Yashua Martin added 12 points and 10 rebounds. The very next day the Phoenix were at home to host Children's Village of Dobbs Ferry in a league match-up.

The boys cruised to a 60-34 win, Louis Martinez led all scorers with 15 points, junior forward Jalen Brown had a double-double scoring 13 points and grabbing 13 rebounds. Xavier Merrill added 13 points and 5 assists and point guard Miguel Gonzalez chipped in with 9 points. After a day off the boys traveled to Children's Village for a rematch of league opponents. The Phoenix prevailed again, this time winning 84-52. Junior guard Louis Martinez led all scorers with 26 points while junior forward Xavier Merrill added 21 points. Miguel Gonzalez and Yashua Martin each contributed 12 points in the win.

Then on Saturday February 12th the Phoenix traveled to Dobbs Ferry to face the Greenburgh North Castle Knights. The Phoenix won the first match-up in January but the Knights had won the rest of their league games. Setting up this Saturday afternoon game as a battle for the league championship. The Phoenix had a goal of finishing the league slate undefeated and not sharing the league with the Knights.

In a back and forth game that saw multiple lead changes the Phoenix were able to hold a fourth quarter lead and win 50-46. Two free throws from Louis Martinez with fewer than 20 seconds left in the game helped seal the league championship for Palisade Prep. Martinez finished with 20 points, while teammate Xavier Merrill added 13. The league title is the first for the Phoenix since the 2014-2015 season.

However, the craziest week of the season was not done yet. The boys had to wake up early on Super Bowl Sunday to get in their final game of the season before the deadline to play passed on Monday. Since Gorton HS was scheduled to play Monday, the teams had no other options but play on Sunday. The Phoenix again were in another very tight game, some early adjustments led to an 8 point half time lead. The boys were able to keep that lead for the rest of the game and win 57-47 over the Wolves. Louis Martinez had 19 points to lead the way, Miguel Gonzalez added 15 points and 3 assists. Junior Xavier Merrill added 14 points and 9 rebounds, fellow junior Jalen Brown added 6 points and 13 rebounds and on his birthday Yashua Martin added 3 points and game high 19 rebounds.

The Phoenix finish their regular season at 13-7. Winning their final six games to get way above .500 winning percentage. They wait to hear their playoff opponent but a 13-7 record should ensure a first round home game on Saturday February 19th. The regular season had many highlights, as the team won the Port Chester Tournament, a league title and made it to the Yonkers City Championship game. The team hopes their tough non-league schedule has prepared them for the Class B Sectional Playoffs.

#### PBA Attorney: Anti-Police Rhetoric Doesn't Help Police in the War on Illegal Guns

Editor's Note: A Westchester attorney who represents PBA's has written an Op-Ed that points the finger at comments made by New Rochelle Mayor Noam Bramson and Congressmember Jamaal Bowman, based on their own words concerning the death of Kamal Flowers by New Rochelle Police Officer Alec McKenna.

Quinn, from The Quinn Law Firm in White Plains writes, "This may be the most painful morning that I can recall in my time of service and one of the most painful that I can recall in my life": New Rochelle Mayor Noam Bramson on June 6, 2020, the morning after the shooting death of convicted felon Kamal Flowers and before any investigation was begun.

'I'm so upset about another horrific incident in our community. We are going through so much already. There needs to be an immediate state investigation into this police killing of a Black man, Kamal Flowers, in New Rochelle": Candidate Jamaal Bowman on June 6, 2020, also before any investigation into the shooting of Kamal Flowers was conducted.

These were the words of our local elected leaders on the morning after Police Officer Alec McKenna came within a trigger pull of losing his life trying to keep illegal guns off the streets of New Rochelle. If Flowers succeeded in killing Officer McKenna, these same politicians would have been tripping over themselves to get in front of a camera to call him a "hero" who bravely died in the service of

On June 5, 2020, Officer McKenna chased Flowers – a convicted violent felon in possession of an illegal weapon - placing himself at extraordinary risk of death with every step. During the pursuit, Flowers – a parolee released from a lengthy prison stint three months earlier for a gunpoint carjacking – pulled his gun from his waist band and, as his later actions show, would have tried to shoot Officer McKenna with it. Instead, he dropped it to the ground. Rather than shoot, Officer McKenna deployed his taser, with no effect. Flowers grabbed the illegal gun and pointed it directly at Officer McKenna for a second time and fired: later tests confirmed Flowers' his DNA on the trigger. By the Grace of God, the bullet did not discharge and Officer McKenna was spared. Undeterred, Flowers adjusted the cartridge of the weapon and again pointed it directly at Officer McKenna, who was shouting at Flowers "don't do it". Left with no choice, Officer McKenna fired, killing Flowers and saving his own life. Notably, he also took an illegal gun off the streets of New Rochelle: a gun that could have resulted in many more senseless, tragic deaths, like the one that happened recently in New Rochelle's

At a press conference attended by virtually every local elected official in New Rochelle, Mayor Bramson labeled the morning of Flowers' death "one of the most painful that I can recall in my life". Mayor Bramson never once mentioned the extraordinary risk Officer McKenna faced to rid his city of the scourge of illegal guns. No elected leader commended Officer McKenna for the exceptional restraint and bravery he displayed, firing his weapon only after Flowers made it clear that he was intent on carrying out his plan of escaping at any cost – including taking the life of a uniformed police officer. To this day, neither Mayor Bramson nor Congressman Bowman has ever acknowledged that Flowers' illegal 9 mm semiautomatic handgun was recovered at the scene along with several 9mm bullets recovered in his pocket.

We mourn the death of two New York City police officers killed by gunfire last month, once again rightly lauding each of them as a "hero". Yet to this day, not a single elected official in Westchester County has acknowledged Officer McKenna for the bravery he displayed in getting yet another urban weapon of war off the streets. To this day, not one local leader has thanked Officer McKenna for removing another gun from our community. Nor has a single New Rochelle official expressed relief or gratitude that Officer McKenna did not die in the process, though he very nearly did.

Instead, following the horrific shooting death of a 17-year old in New Rochelle, our local elected officials have expressed outrage over the proliferation of guns in Westchester – guns that become available to teenagers who use them to shoot and kill each other. Not surprisingly, news reports indicate that the New Rochelle shooter fired a 9mm semiautomatic handgun – the same gun which nearly

Mayor Bramson and Congressman Bowman, predictably riding the waves of the shifting political tides, are now lamenting their inability to stem the flow of illegal guns into the hands of teenagers:

"The tragic death of the 16-year-old New Rochelle boy is only made worse by the fact that he was killed by a 16-year-old who was able to get his hands on a gun. The system is failing our youth at every level. We need to do everything in our power to support our youth and their families, address the mental health crisis, and put an end to the influx of guns coming from outside of our state and into the hands of our teenagers. This is unacceptable and cannot be normalized". Congressman Jamaal Bowman on January 27, 2020 commenting on the shooting death of a 16 year old in New Rochelle.

"More broadly, this incident highlights yet again the destructive impact of our nation's lax gun regulations, which flood firearms into the wrong hands and can transform any dispute into a heartbreaking loss". Mayor Noam Bramson on January 27, 2020.

Getting guns off the streets of Westchester is extraordinarily dangerous work. It requires a profound level of bravery, yet is so often overlooked or worse, taken for granted. Since the death of Kamal Flowers, New Rochelle police officers have made forty gun arrests, each time risking their own life in the process. Each time a police officer takes a gun illegally possessed by another from the community, he or she faces the very real risk that they too will be placed in Officer McKenna's dangerous position. Police officers should not be forced to consider whether they want to die a "hero" or live as a "defendant".

It is long past time to once again allow Westchester County police officers to use the tools they already have to stop the violence that is plaguing our communities. The progressive policies of frighteningly liberal District Attorneys who believe that police officers are the problem and not the solution must be soundly and loudly denounced. The citizens who truly care about the safety of all of our county's neighborhoods must come forward and be heard. We must, as law abiding residents who seek to protect all children in all communities, elect leaders who understand that police officers are our greatest weapon in the war on gun violence, who deserve support rather than contempt. We must reject the anti-police rhetoric that is demoralizing police officers and curtailing recruitment.

#### Indivisible NYCD 16 Supports Stewart-Cousins and Keeping Bail-Criminal Justice Reforms As Is

Editor's Note: Members of Indivsible NYCD-16 recently wrote a letter criticizing the comments made by Yonkers Mayor Mike Spano about Congressman Jamaal Bowman. Included in that letter were comments about bail reform. Below are that portions of the letter, which can be found in its entirety at Yonkers Times.com

"Bail Reform is about creating an equitable criminal justice system. #JusticenotFear! Bail Reform only applies to nonviolent felonies and misdemeanors. Historically, poor people who were disproportionately black and brown, were kept in jail because they couldn't afford to pay bail. Our state legislators consulted extensively with district attorneys and judges before putting forth this historic bail reform legislation. It has kept hundreds of thousands of people out of jail who cannot afford to pay bail.

"Ninety eight percent show up for their court hearings. There is NO connection between bail reform and crime rates. There IS a connection between gun violence and crime rates, however. We would love to hear more from our Mayor about getting guns off our streets and engaging in thoughtful conversation with gang members who are associated with most of the shootings in our city. Rep Bowman knows that people want a fair criminal justice system, a living wage, affordable housing, food to eat, public safety & access to good health care during this pandemic.

"It is troubling to hear Mayor Spano make such provocative statements. Remarks from him about putting our Black Congressman in jail stoke fear and anger in certain communities. We have yet to understand what he means by "changing bail reform."

"Most constituents look to our democratically elected officials for reasoned and calm governance in these troubling times. Dog whistle statements from Yonkers Mayor Spano don't reflect the type of leadership that we need from him," writed Indivisible CDNY16.

#### March 1 Deadline to Upgrade to Enhanced STAR

March 1 Deadline to Upgrade to the Enhanced STAR Property Tax Exemption For seniors turning 65 this year, the deadline to apply is March 1

The New York State Department of Taxation and Finance today reminded seniors that, for most localities, the deadline to apply for greater property tax savings through the Enhanced STAR property tax exemption is March 1.

To be eligible for the 2022 Enhanced STAR property tax exemption, seniors must: currently receive the Basic STAR property tax exemption; have one owner of the property who will be at least 65 years of age by December 31, 2022; and have had 2020 income equal to or below \$92,000.

"We want every eligible senior to receive the increased property tax benefit," said Acting Commissioner Amanda Hiller. "To help ensure that seniors don't miss out on this valuable benefit, we recently sent letters to 27,000 seniors who may be eligible for additional savings."

Eligible seniors should apply to their assessor's office by the application due date, which is March 1 in most towns and some cities, but there are exceptions. Seniors should verify their exact due date with their local assessor.

To apply, seniors must provide the following to the assessor: Form RP-425-E, Application for Enhanced STAR Exemption

Form RP-425-IVP, Supplement to Form RP-425-E Proof of income: 2020 New York State or federal income tax forms. (If the senior wasn't required to file an income tax return, the assessor can guide them on how to provide proof of income.)

In 2021, 577,000 seniors received a total of more than \$800 million in savings from the Enhanced STAR property tax exemption.

Seniors who receive the STAR credit instead of the STAR exemption don't need to apply or take any other action. The Tax Department will automatically upgrade them to Enhanced STAR if they qualify.





#### On This Day in Yonkers History...

Lawrence Ferlinghetti

Monday, February 21st

February 21, 1928: Local officials assured Yonkers drivers that there would be no increase of gasoline prices in our city. Yonkers drivers were paying 20 cents a gallon; Standard Oil had just raised New York City prices from 18 to 19 cents a gallon.

February 21, 1945: Young Men's Chamber of Commerce President John E. Flynn presented details of the City-wide School of Civic Service the organization planned to run. Thirty sessions would be held Thursday evenings at City Hall; city officials would speak about functions of city departments to give attendees a closer look at how Yonkers is governed.

Tuesday, February 22nd

February 22, 1931: Mayor John Fogarty entertained Baroness Helene Nostitz Von Hindenberg, the niece of German President Paul Von Hindenberg, at Yonkers City Hall. Two years later, she was one of 87 authors who signed an Oath of Loyal Support for Adolf Hitler.

February 22, 2021: American poet, painter, social activist, and Yonkers native Lawrence Ferlinghetti passed away. Born on Caroline Avenue, the publisher and owner of the renowned City Lights Bookstore in San Francisco was the first Poet Laureate of San Francisco.

Wednesday, February 23rd

February 23, 1945: After months of red tape delay, State Supreme Court Justice Gerald Nolan ruled former Mayor Benjamin Barnes acted legally appointing Abraham Rosenblum and Dr. William Crocker as Yonkers School Board trustees in 1943, without getting "advice and consent of the Common Council." He said since Yonkers' population was less than 400,000, State Education Law governed the action. Former School Trustee Theodore Kiendl expected to bring the case to a higher court.

February 23, 1946: A letter from former Yonkers newspaper woman Rheta Glueck of Bayley Avenue, Red Cross staff assistant in Germany, arrived in Yonkers. Her biggest concern was the fraternization of the American troops with German woman, mostly because the morale among occupation troops was so low, so the Red Cross was providing as many activities and as much entertainment as possible. She closed her letter with the hope that Yonkers would put the Yonkers Red Cross Fund Campaign "over the top."

Thursday, February 24th

February 24, 1933: Women of the Yonkers Chapter of the Mooseheart Legion held a George Washington Pajama Party.

February 24, 1947 The Regional Plan Association for the tri-state area, predicting approximate 20,000 privately owned planes would be in use in the area, proposed two new airports to serve Yonkers residents. One airport would be in the Town of Greenburgh because of the unavailability of appropriate land in Yonkers. A second smaller field would be in Yonkers on County owned property, on a site such as the Sprain Brook Golf Course.

Friday, February 25th

February 25, 1925: After Federal Prohibition Agents Charles Bench and Michael Sassi raided a saloon and restaurant, they arrested seven men on charges of "possession of intoxicating liquor." A mob of 50 people gathered on Washington Street tried release one of the prisoners and knock evidence to the ground, forcing the agents to draw their guns to get the crowd to back away. Arrested for "interfering with a Federal officer," two women fought agents like "wildcats," tried to smash liquor jugs on the agents while clawing and biting them on their faces and hands.

February 25, 1935: The trial of the Newark men caught at Roosevelt High School with liquor in their truck was suddenly interrupted. The men's attorney Maurice Chachkes had conceded the liquids were alcohol to speed the trial; after hearing testimony from arresting officer Frank Jordon, Chachkes revoked his concession. The liquor had to be taken back to our City Laboratories to be analyzed.

Saturday, February 26th

February 26, 1937: Assistant Corporation Counsel Harold Garrity, who represented Yonkers interests prosecuting Yonkers' anti-shorts ordinance, the blue law that brought international attention to our city, announced Yonkers received formal notice of the tentative date for argument for the case filed against Yonkers on behalf of two New York Daily News reporters, Rose O'Gorman and William Matthias, to test the validity of the ordinance. Yonkers' anti-shorts ordinance was scheduled to be argued before the Court of Appeals on April 15th.

February 26, 1940: The Westchester Grand Jury, under the direction of Westchester DA Walter Ferris, opened an investigation into the operations administrations of the Loehr administration in Yonkers and investigate the findings of the Department of Audit and Control that unearthed illegalities and irregularities. Of the twenty-three Grand Jurors, three were from Yonkers: broker Ludwig Funke, architect Milton McGuire; and H. Armour Smith, Director of the Hudson River Museum. Smith, as Director of the Yonkers Museum, was on the city payroll.

Sunday, February 27th

February 27, 1945: To celebrate their "distinguished service to our country through the patriotic and inspiring use of music to aid the national effort," Benny Goodman, the "King of Swing," presented citations from the Music War Council of America to student musicians at four Yonkers schools! The schools recognized were Gorton High School, the High School of Commerce, Hawthorne Junior High School and Franklin Junior High School. Besides the certificates, each school's music teacher received a signed photograph of Mr. Goodman. These school bands played at war bond drives, scrap paper drives, scrap metal drives, ceremonies honoring men leaving for the service, and other patriotic ceremonies. Goodman spoke about the importance of music in every day lives, how it can be a "spiritual uplifting influence." He continued that he hoped the people of Yonkers realized "what it means to have fine school musical organizations like these student bands."

computer to computer. Viruses typically infect computers through "phishing" (think of "fishing") whereby users accept a computer prompt ostensibly from reputable sources that really is from scammers; scammers seek unauthorized access to digital devices such as a home computer, often with the aim of hijacking online banking or credit information to make purchases.

"Once you let someone with bad intentions into your machine, it's usually downhill from there," says Jonathan Hauff, a computer consultant based in Larchmont NY who is a former WPCUG president and current WPCUG workshop moderator. Regarding telephone calls from scammers, "these are not nice people, though they try to sound nice on the phone. It's a con game to them. They really are heartless criminals out to take advantage of people, especially older people" who are often too trusting.

On Jan. 27, the Federal Trade Commission (FTC) issued an alert that scams involving online social media climbed a staggering 18-fold from 2017 to 2021. Here are a few tips to avoid the growing threats of malware and viruses:

When in doubt about a phone or computer message for a bank transaction or online purchase such as with Amazon, don't use links or phone numbers provided. If from scammers, those connections are not legitimate. Instead, independently dial or connect to a bank/retailer website to check the real status of an account.

Beware of popups messages when browsing websites urging software updates, which are sometimes legitimate but also can be phishing disguised to download malware.

Some computer security firms say that they can remove ransomware, which may be true; but once a ransomware executes a computer takeover, just removing some of the core malware software may not unlock computers and data.

Sometimes legitimate antivirus companies blast hard-sell messages online to

push consumers into buying high-price protection. WPCUG recommends simple anti-virus software from reputable companies that typically is offered in a free version to home users or upgraded "premium" version at modest cost.

In what is a rare scam from the most sophisticated hackers, computers infected by malware can be used as listening devices to literally picking up sounds keystrokes from other devices within audio range. These aim to capture pass-

words being typed and are referred to as an "air gap," a reference to two computers that are not directly connected.

It's advised to check with professionals if encountering persistent malware on personal devices, because simply making malware disappear from screens

The bad actors are active in several areas, says George Hauss, a Yonkers resident who teaches computer classes at Westchester Community College. They "are basically trying to get information from you such as banking and other financial passwords so they can transfer money out of your accounts. Some are trying to get your personal information for marketing purposes and are more benign so you'll just get more targeted emails, although those can drive you crazy. Others are hackers who are trying to get into your computer without your consent to extract information or install encryption programs to make the computer inaccessible, and then hold the access for ransom," said Hauss, a WPCUG member and semi-retired chemist and computer programmer.

Hauff, when speaking to consumer groups about tech, frequently asks the audience by show of hands to see who is doing full backups frequently and also who has ever suffered important data loss. He finds the same hands go up for both questions. "Unfortunately, few people do proper backups on a regular basis unless they have experienced a major data loss themselves," Hauff observes.

He recommends making backups of personal data as insurance in the event of data loss; this creates a copy of data as of that moment. A full backup, when installing software and external hardware storage devices, can be complicated. But just duplicating personal data is a simple with online subscription backup services and free cloud storage offered by software companies. Having a duplicate of personal photos, Word files and an address book is a blessing in the event of a data loss.

Other safety measures include:

doesn't necessary mean it's really gone.

Stay up-to-date on software updates, which will include patches to block the latest viruses.

Realize that ALL software on a home computer needs to be updated, not just the core Microsoft or Apple operating systems. For example, hackers are known to target browsers and their extensions, and specialized home management software (controlling household lights, door cameras, etc.) on smart phones.

If one does get on a phone call or computer connection that raises suspicion, immediately terminate the phone call or the online connection, which means hanging up or shutting down the computer. If challenged by a victim becoming suspicious in a phone conversation, the scammer will simply accelerate installation of malware.

It's usually better not to respond to suspicious emails and calls ("This is Amazon notifying you that a \$990 purchase billed to your account will be shipped momentarily...") because doing so confirms to the scammer that contact information is valid. Simply disconnect. Contact Amazon to check without using links or phone numbers provided in the alarming messages.

Don't use short, easy-to-guess passwords for online accounts, and especially don't employ identical passwords across multiple accounts, because these are easy to hack. Multi-word phrases that are easy-to-remember (peppered with a few obscure characters) are one way can help keep track of different passwords

few obscure characters) are one way can help keep track of different passwords. Take the time to set up two-factor authentication (2FA)—security questions—on any account that offers, because that can defeat hackers.

"The fact is the State has led us into an energy crisis that is creating a financial emergency for families, seniors on fixed incomes and small businesses," said Supervisor Matt Slater. "We are facing record inflation and for the State to even consider a rate hike, coming off of a three-year rate hike, during these times just proves how out of touch and insane New York State has become."

Utilities have argued that normal winter demand for power and fuel, combined with supply chain disruptions, have caused the price spikes in natural gas, which is used to create most of the electricity in New York."

In a letter, NYS Public Service Commission Chair Rory Christian recommended

Mitigate the recent high customer bills by providing the full values of its hedged

commodity procurements to customers in the next billing cycle.

Reassess its approach of forecasting its hedge value in billing cycle updates to reduce the likelihood of dramatic and sudden price volatility.

Improve communication to electric and gas customers to better explain fore-

casted commodity price changes.

On Feb. 10, State Senate Majority Leader Andrea Stewart-Cousins and State Senator Shelley B. Mayer sent a joint letter on Feb. to Consolidated Edison and the Public Service Commission demanding that recent rate increases be suspended and other measures be taken to mitigate the impact of the dramatic jump seen in Con Edison ratepayers' bills.

"We have grave concerns about the financial shock these high costs will have for our constituents and others across New York State," said the Senators in their letter. "The rise in charges will result in serious challenges for many New Yorkers, particularly those already struggling to make ends meet."

Recent spikes in energy prices coinciding with a planned rate increase approved by the Public Service Commission have resulted in some ratepayers' bills more than doubling between December 2021 and January 2022. Both Senators had opposed the planned rate increase.

In the letter, which is attached to this press release, the Senators said the "situation is unacceptable" and called on the Public Service Commission and Con Edison to take immediate action to provide relief to ratepayers.

"Both the Public Service Commission and Con Edison have a responsibility to ratepayers, and such dramatic and unexpected cost increases demand action on your part in order to fulfill that responsibility," the Senators wrote.

Congressman Jamaal Bowman stated on Feb. 11,

"Just in the last three days, I have heard from many of our neighbors who are calling and writing in about Con Ed's outrageous price hikes that have led to New Yorkers receiving energy bills that have doubled or even tripled in price," said Congressman Jamaal Bowman, Ed.D. (NY-16). "To drop these kinds of increases on families at any time is unacceptable, but to do so during a pandemic and in the middle of winter when families are using heaters to stay warm is unconscionable. Con Ed has made record profits while our neighbors, even before the rate increase, were forced to choose between staying warm and paying more or battling the cold to avoid a higher energy bill. While Con Ed points to a rise in fuel prices and jumps to pass this cost onto consumers, this is caused by one thing and one thing only:

corporate greed that puts profits before people."

"Calling out this blatant show of corporate greed is not enough though "I support our community in calling for an investigation into Con Ed's decision to raise prices on our neighbors and will continue working with the Biden Administration to stop companies like Con Ed from using the increased cost of fuel to implement unfair rate increases on consumers. I am calling on the Federal Energy Regulatory Commission to protect consumers from high energy costs this winter, and am urging my colleagues to immediately pass my Heating and Cooling Relief Act that will provide millions of people with assistance to pay their energy bills. We also need to have a deeper conversation about access to clean, affordable energy as a human right — not an opportunity for profit — which I believe can be facilitated by public ownership of utilities. I will keep fighting for our neighbors every step of the way."

The question for Yonkers residents is they have the option of chosing Westchester Power as their energy provder. Currently, the rates offered by Westchester Power

are lower than Con Edison. See the graphic on pg 8.

Residents can lock in at a renewable energy rate that is lower than Con Ed, and Con Ed is requesting a rate increase.

While there has been some concern about the fact that residents have to opt out of the new Westchester Power program or they will automatically be opted in, this newspaper has been writing stories for more than a month informing the people of Yonkers about this program.

national republians are saying don't look at the pandemic and the proliferation of guns. Let's look at progressive democrats who wanted to change the criminal justice system. They want to take the focus off guns and stoke fear and create a republican backlash. And democrats in NY State and nationally are in danger of losing their majorities if we don't respond head on to this effort."

"They want to link the fear with democrats being in charge. Our reforms on bail was about misdemeanors and non-violent felonies. Shooting people is still a bailable offense, but no matter what the crime is they blame bail reform," said Stewart-Cousins, who contrasted two criminal cases that most New Yorkers know

about. Kalief Browder and Kyle Rittenhouse. "Kalief Browder was held in jail for three years at Rikers Island because he was accused of stealing a backpack and didn't have money (for bail). He ultimately killed himself. We will not criminalize poverty for non-violent misdemeanor offenses. Kyle Rittenhouse shot at three people and killed two people and he was out

on bail. ' "It is clear that the police are not happy, but if we can't beat back this effort, and allow people who are accused of non-violent offenses and misdemeanors to keep their jobs and keep their homes and keep their families while they await their court date, then we won't be able to start having other conversations, if we can't

step up now." "The reality is that black and brown kids have been suspended from school and put on a pipeline to prison over the years. Black people are disproportionally overcharged and oversentenced. We can't have justice and equality without changes in the system," said Stewart-Cousins.

'I will sit down with any clear minded person to help make things better, but I will not respond to the republican coordinated campaign that refuses to understand the impact of the pandemic and guns, and refuses to pass a voting rights act, and is taking back women's rights. We are not the problem, they are supressing our votes and it has to stop."

"Do not be fooled by this coordinated republican campaign of fear. Crime is up nationally, not because of bail reform in New York. They refuse to recognize the proliferation of guns.

"You know who the vigilanites are (in the police department) now. Your mad that we did the 50a reform that put police records out there, but if they would weed out there own bad apples, i wouldn't have to do it. But there is no willingness to do it. They don't want to change it from inside, and they are mad when its changed from the outside," said Stewart-Cousins.

"I don't think there is any kind of national democratic strategy, but there are people like me who have a national voice. I will try to hammer the message. It needs to be crystalized on a grass roots level. We have to be clear that this is a national republican coordinated effort of fear, and they want to get us out of office.

"Joe Biden hasn't been able to figure out his message. We (democrats) are all over the place. If we don't correct this nothing else is going to happen. We are the only people who are going to destroy our ability to lead. Push back hard, because right now we could get wiped out nationallly and in terms of the senate, here in New York," said Stewart-Cousins.

seen in most of New York and throughout the nation is a very real and extremely complicated problem. There are many factors to be considered when finding a real solution to solving this dilemma. Certainly, the proliferation of guns and the pandemic are among those factors. Other factors include the recently instituted criminal justice reforms including bail reform, raise the age and changes to the discovery laws. But let's be clear. This should not be portrayed as a partisan problem.

"In a recent interview with NYCD-16 Indivisible, NY Senate Majority Leader Andrea Stewart-Cousins stated over and over again that any implication that criminal justice, police and bail reform has led to a rise in crime is nothing more than a "Republican nationally coordinated campaign of fear." The outrage to a proposed 17% Con Edison rate hike has spread across West-chester and New York State, at the same time as residents in Yonkers are being offered a renewable energy rate from Westchester Powser that is less than Con Ed's rate, even before the new rate increase goes into effect.

Governor Kathy Hochul urged Con Edison to review their billing practices and better communicate with New Yorkers after the recent surge in energy costs in New York State left many already struggling New Yorkers surprised, through a letter from Public Service Commission (PSC), and also announced increased relief efforts to reach low-income New Yorkers about millions of dollars in aid available

"The extreme utility bill increases we are seeing across the state come at a time when New Yorkers are already struggling financially following the CO-VID-19 pandemic," Governor Hochul said. "Even though the spike we are seeing in electricity, natural gas and fuel prices were predicted and are due to severe winter weather, I am calling on Con Ed to review their billing practices because we must take unified action to provide relief for New Yorkers, especially our most vulnerable residents."

This winter the cost of natural gas, which is used to heat homes and generate electricity, has risen sharply resulting in a significant increase — sometimes more than doubling – of the supply component of customer electric and/or natural gas bills as compared to prior months. 
